described.

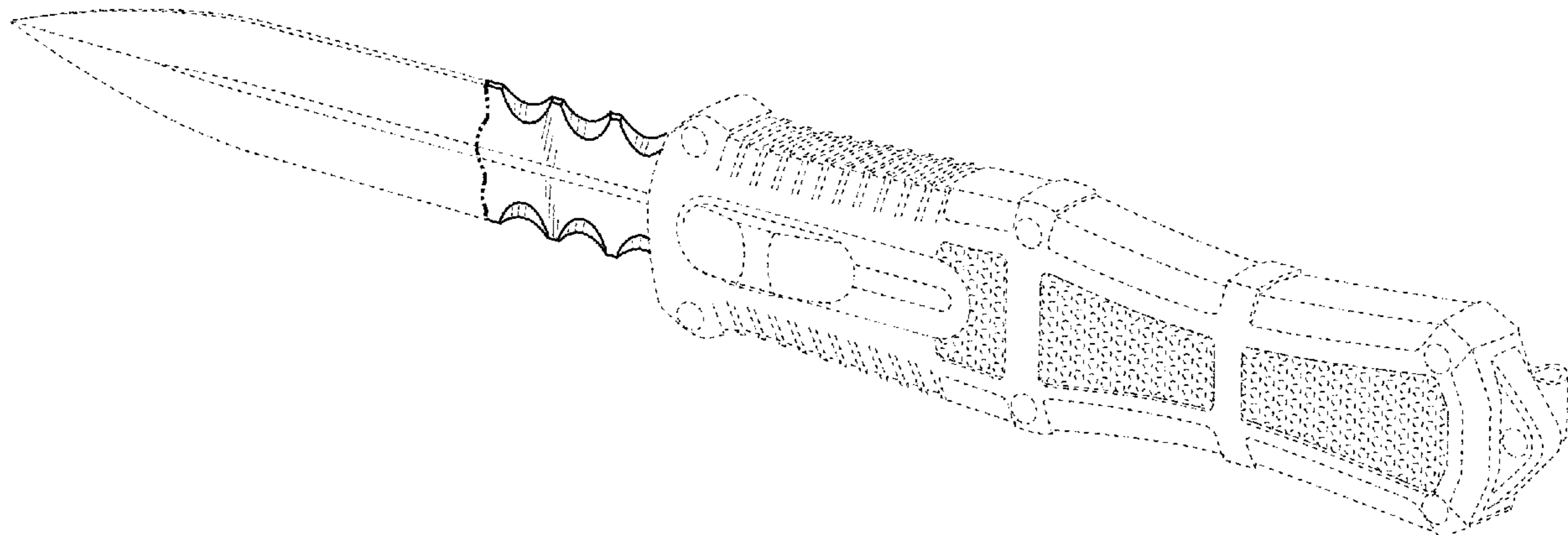
DESCRIPTION

FIG. 1 is a perspective view of a knife, showing our new
design;
FIG. 2 is a right side view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a front view thereof; and,
FIG. 7 is a back view thereof.

The dot-dot-dash broken lines represent an unclaimed
boundary of the claimed design. The remainder of the
broken lines depict portions of a knife handle, or the knife
blade in which the design is embodied that form no part of
the claimed design.

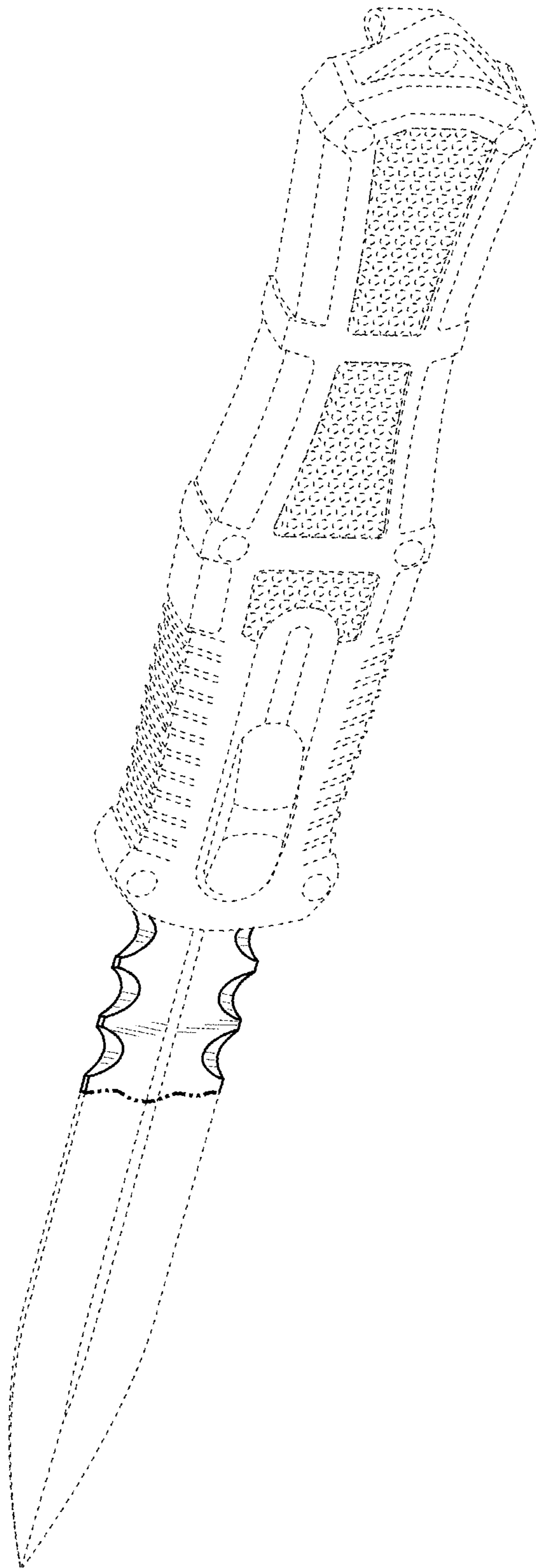

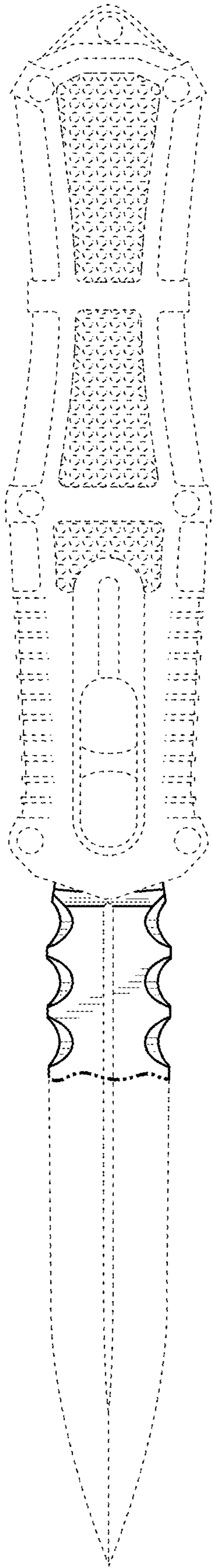

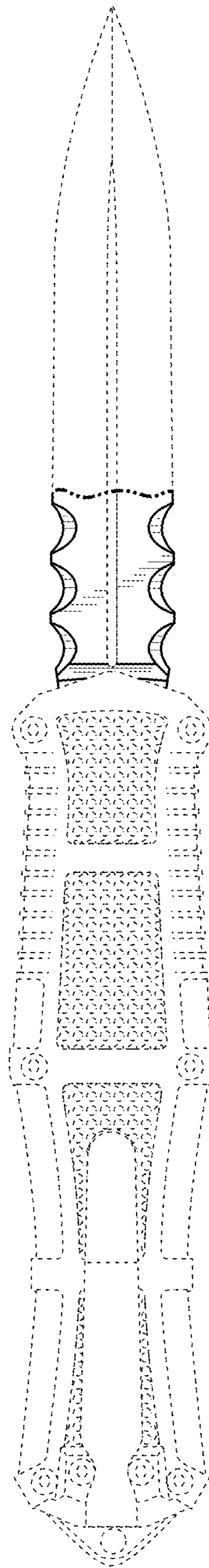

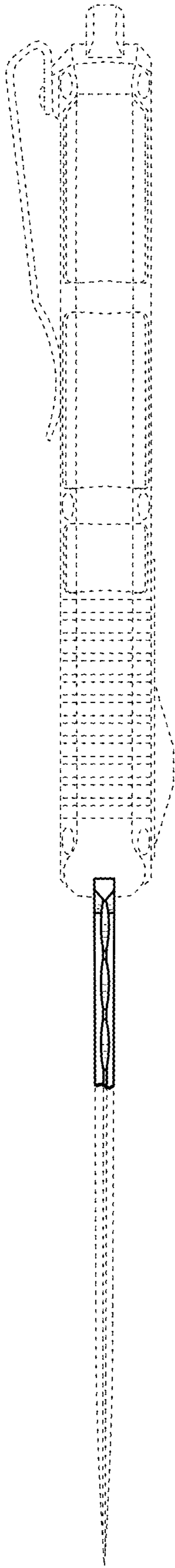

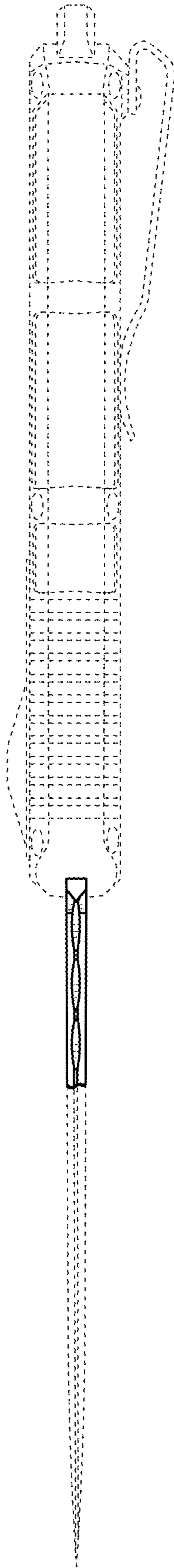

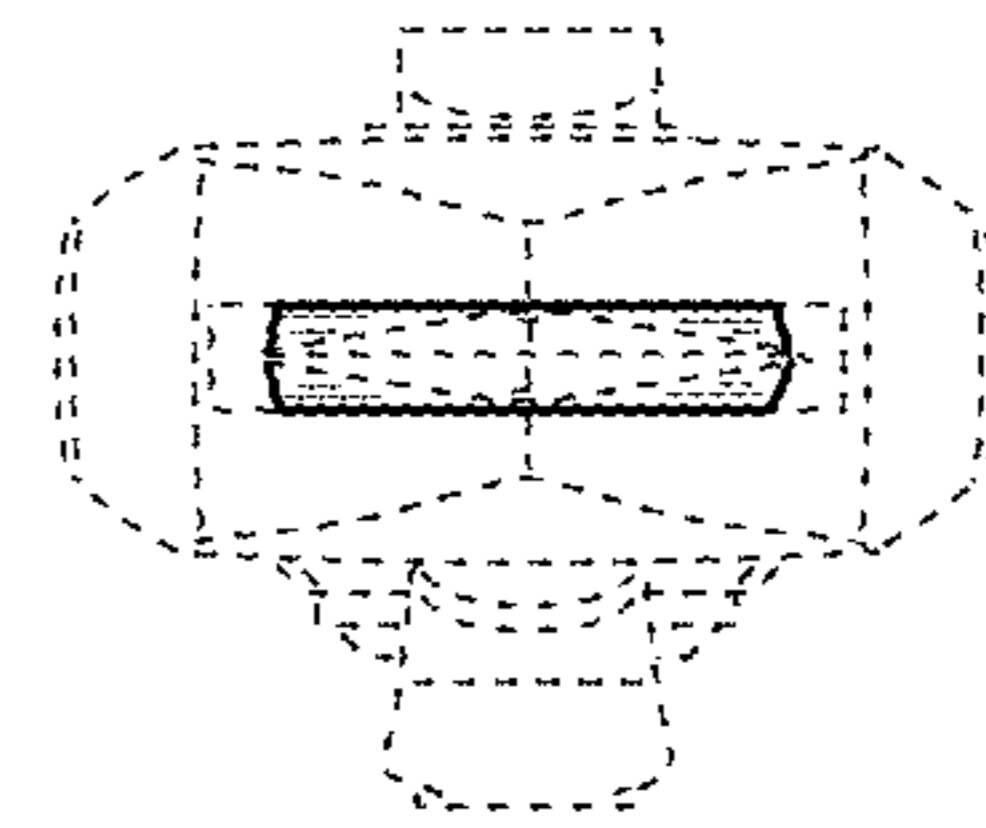

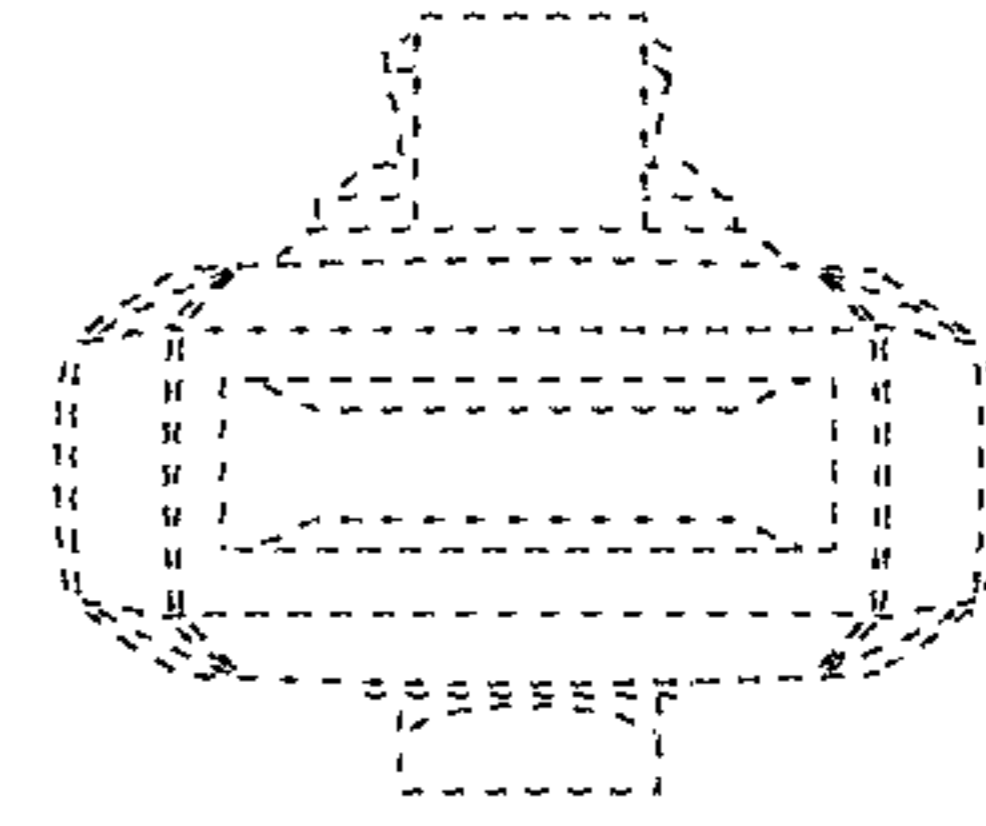
