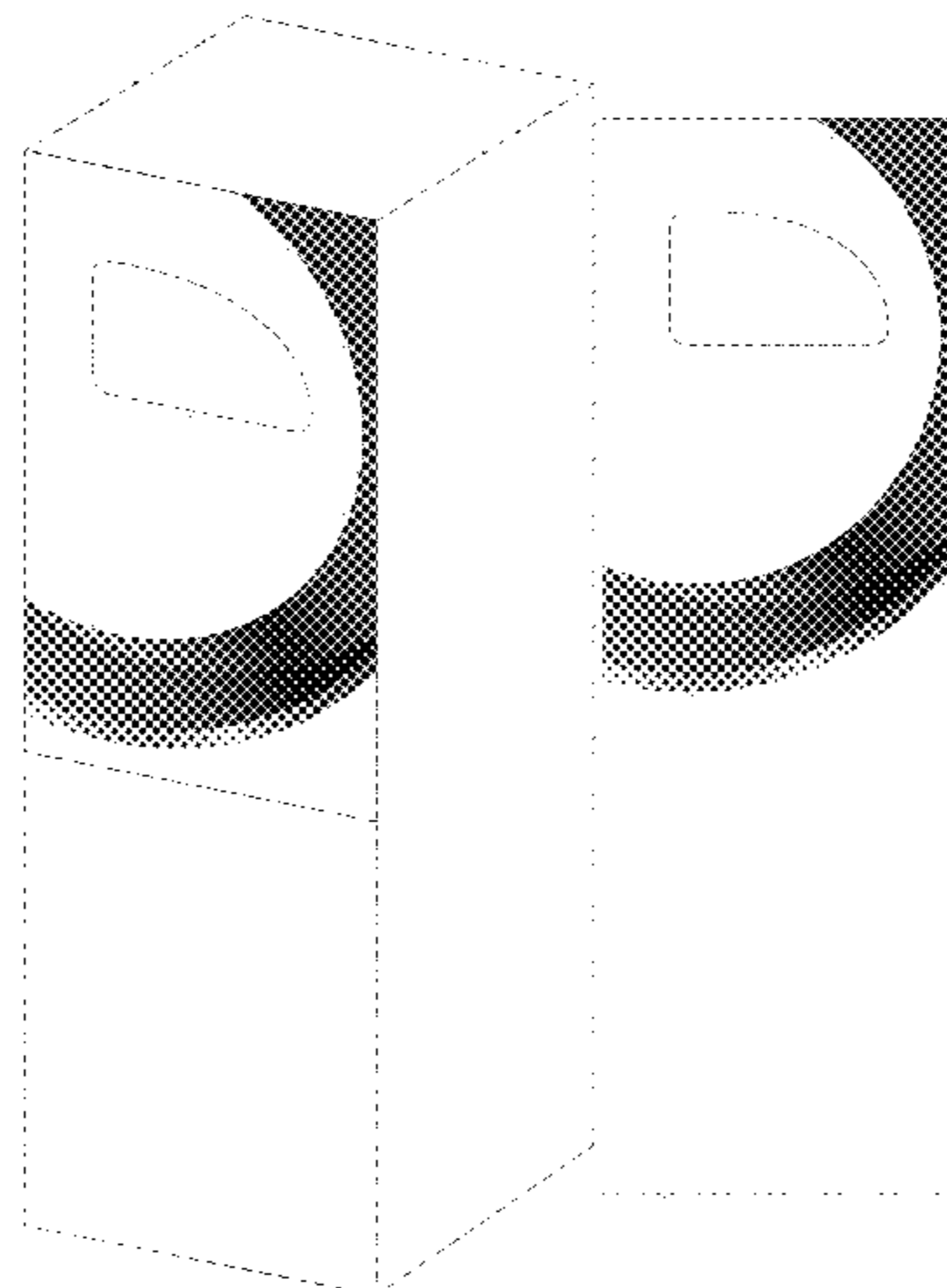


FIG. 20 is a top view thereof; and

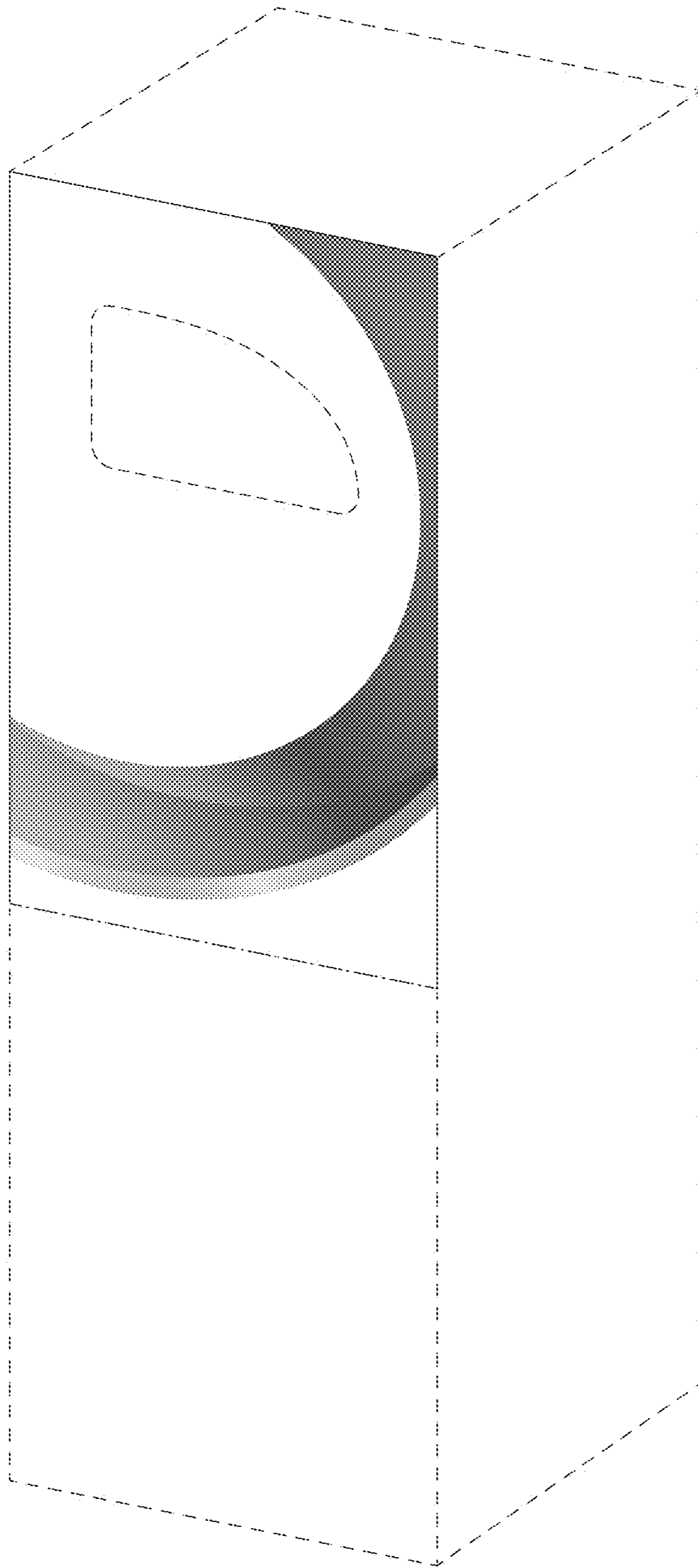

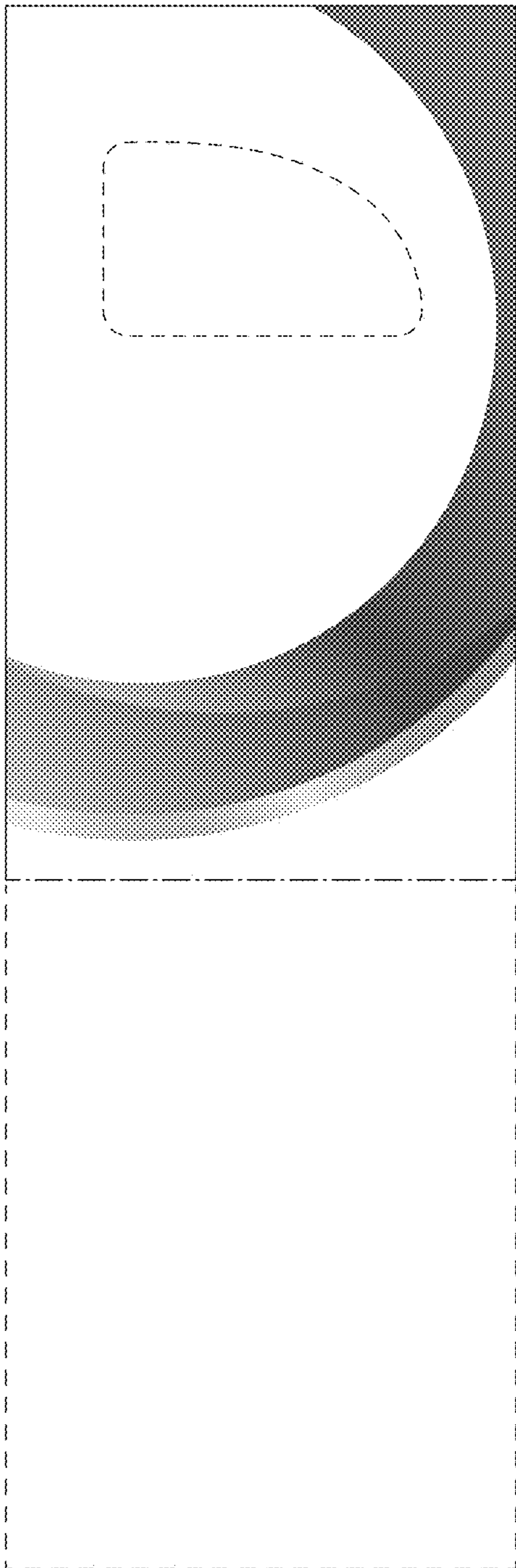

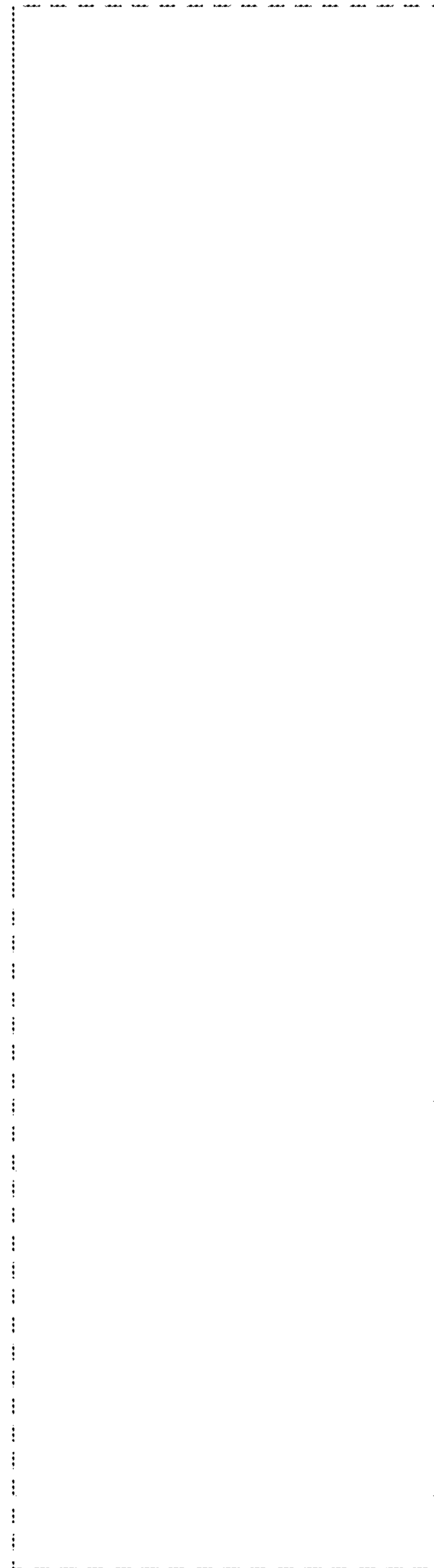

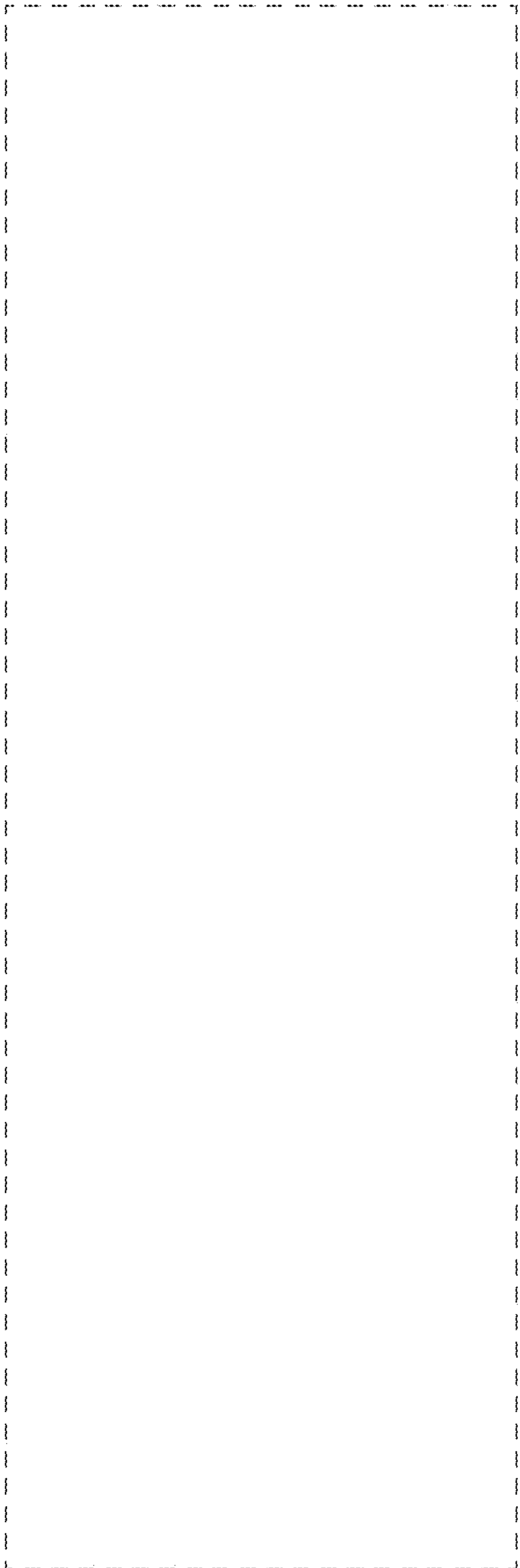

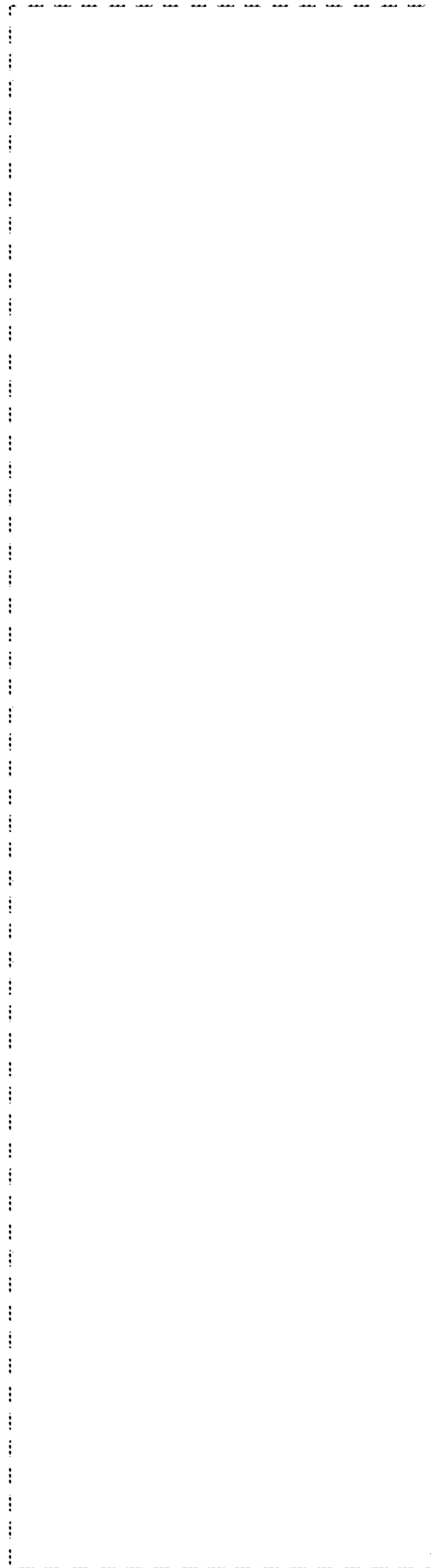

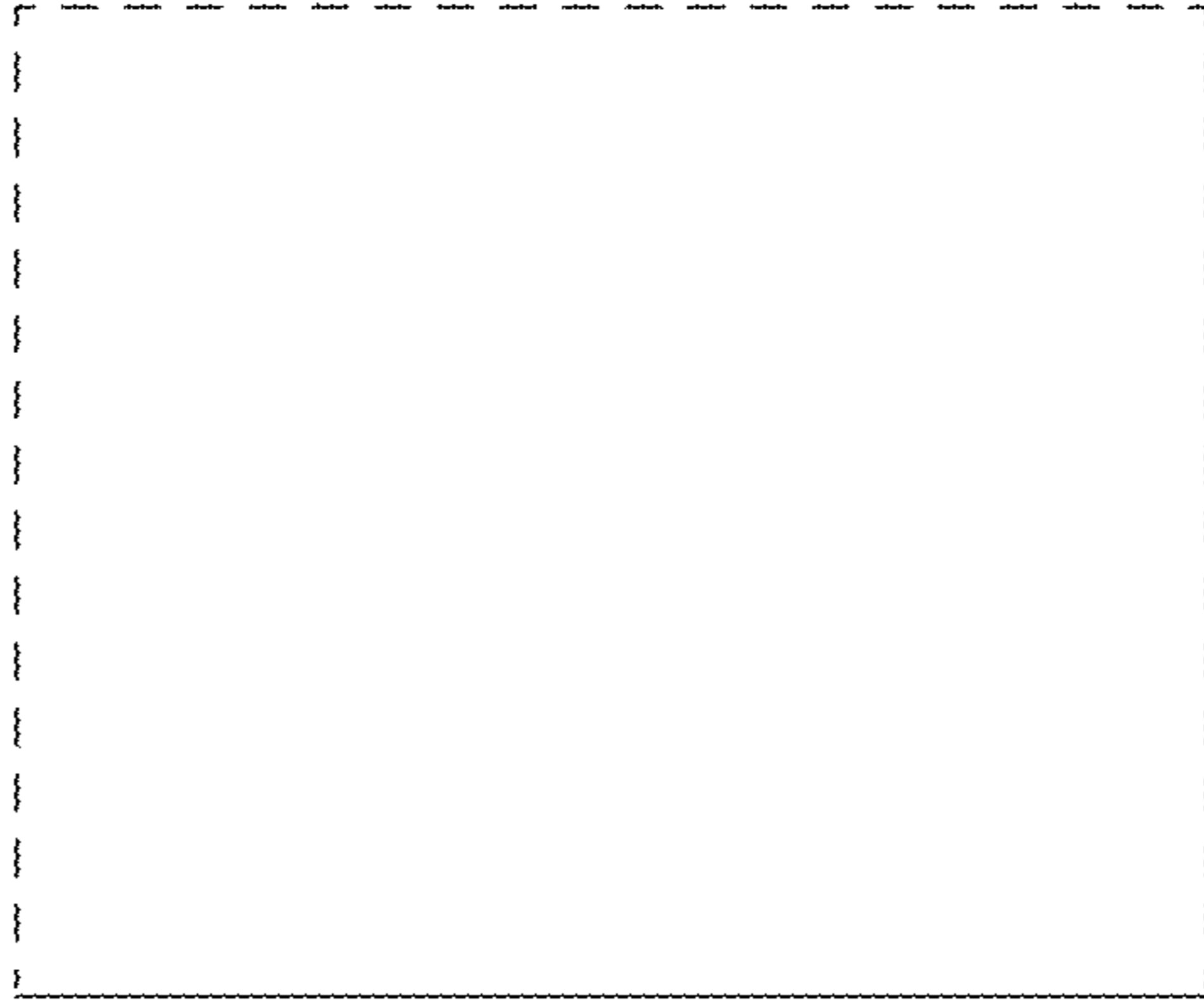

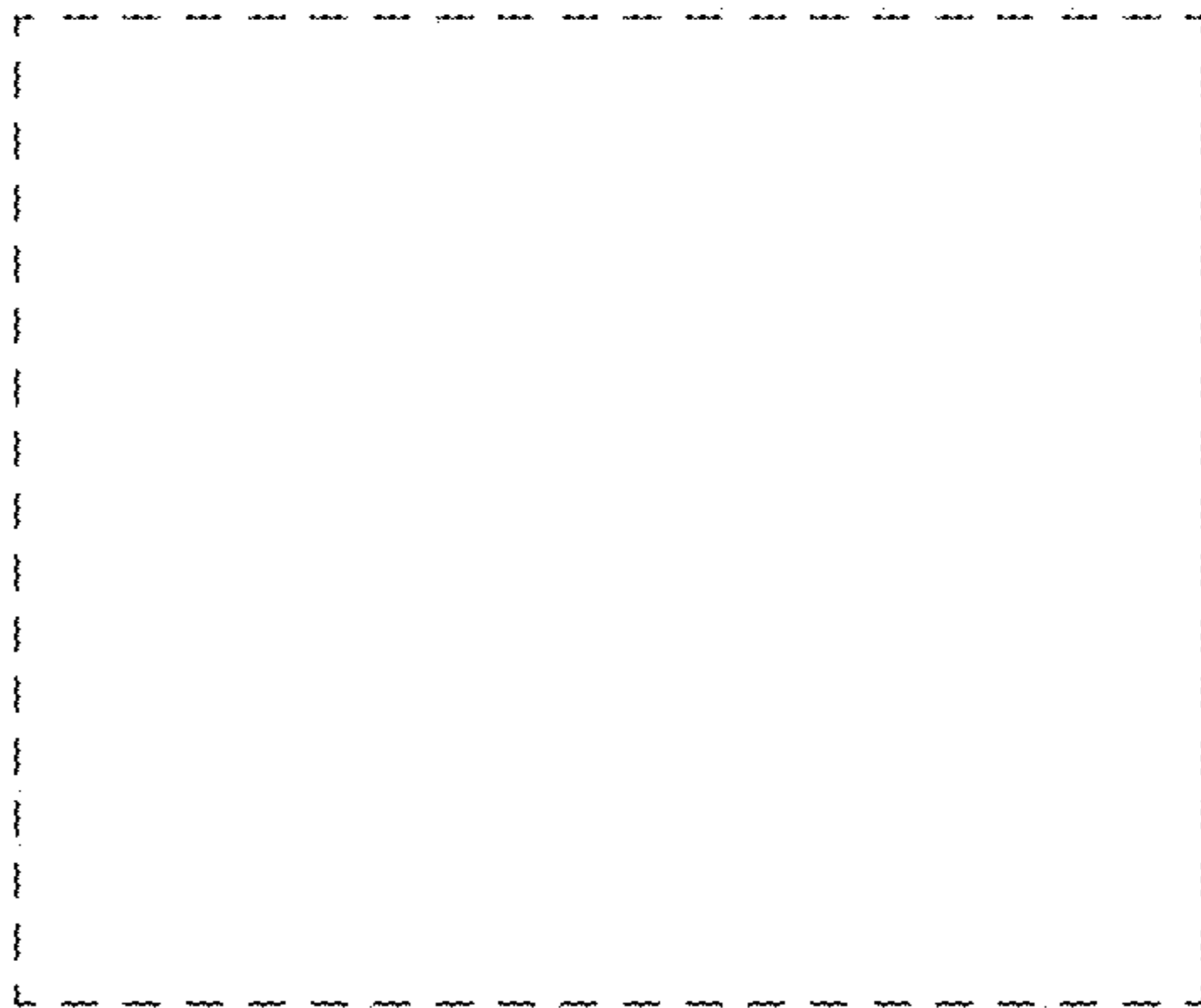

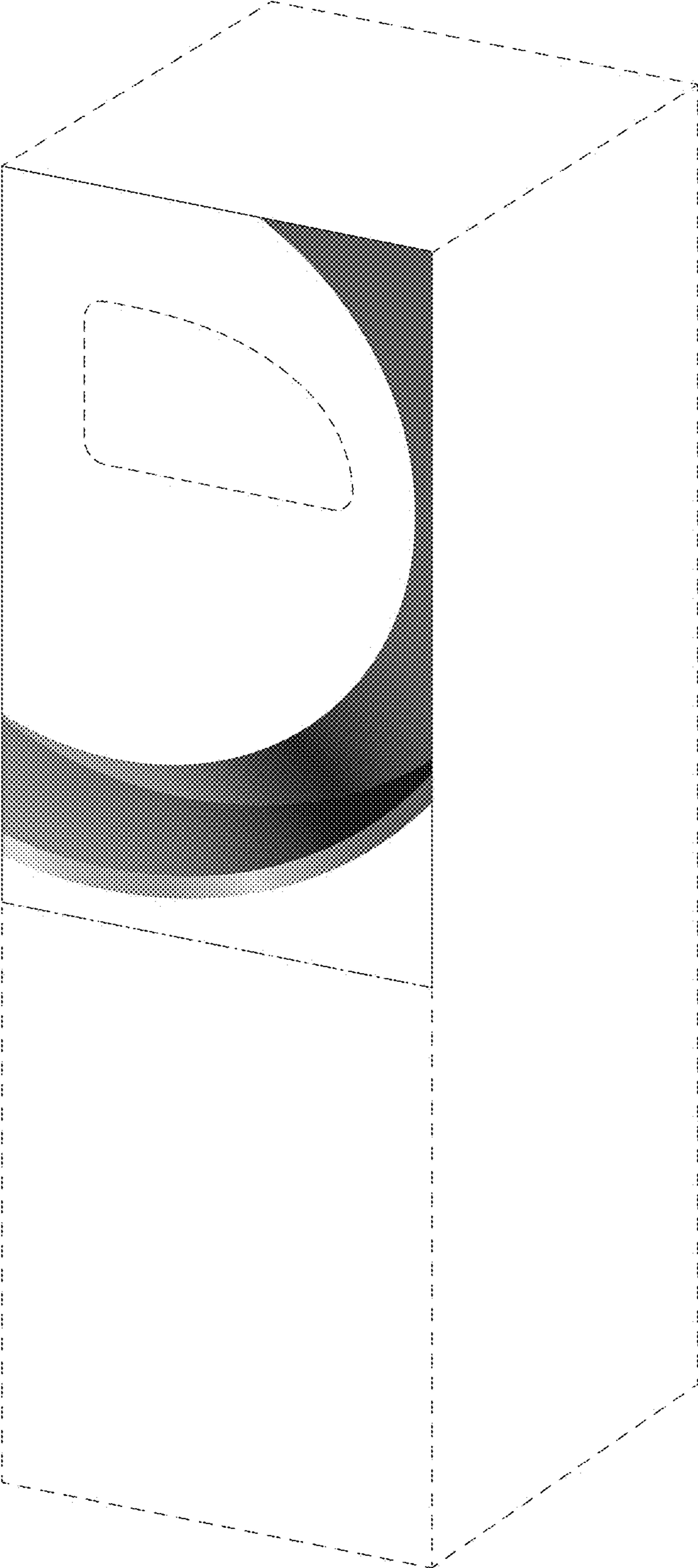

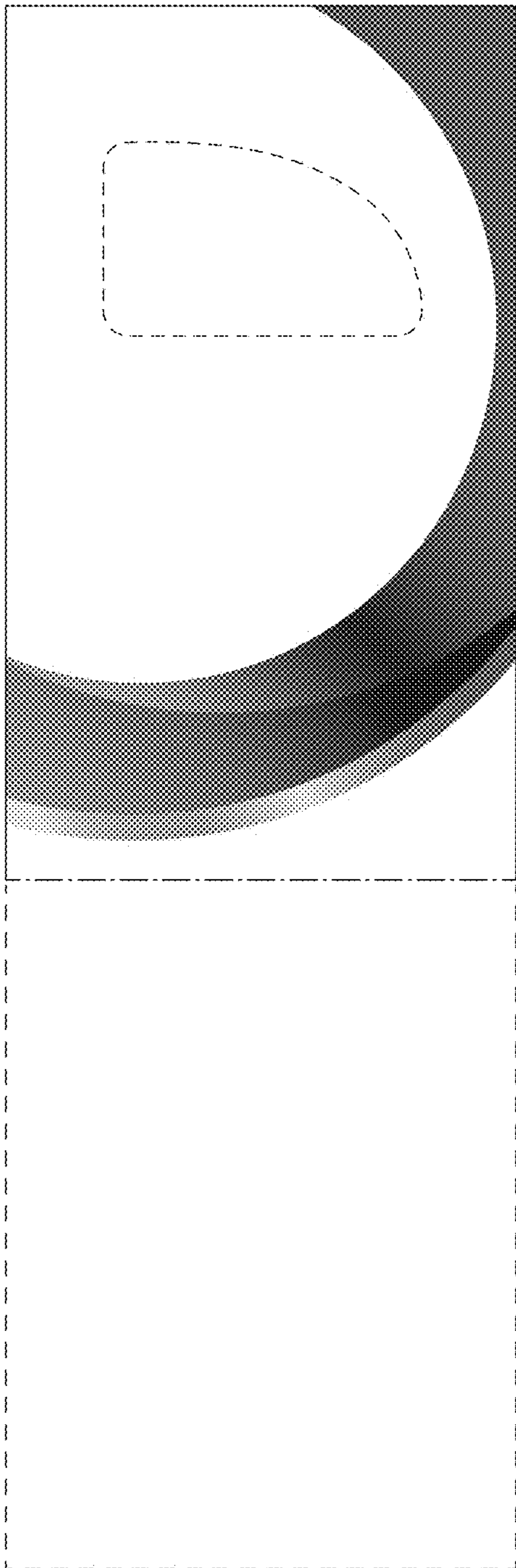

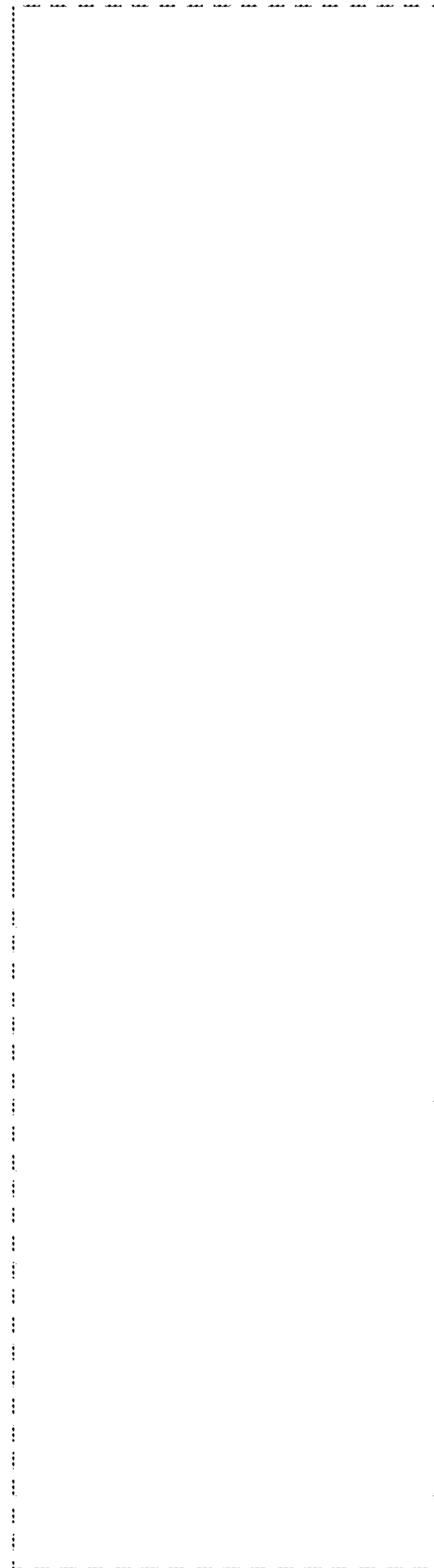

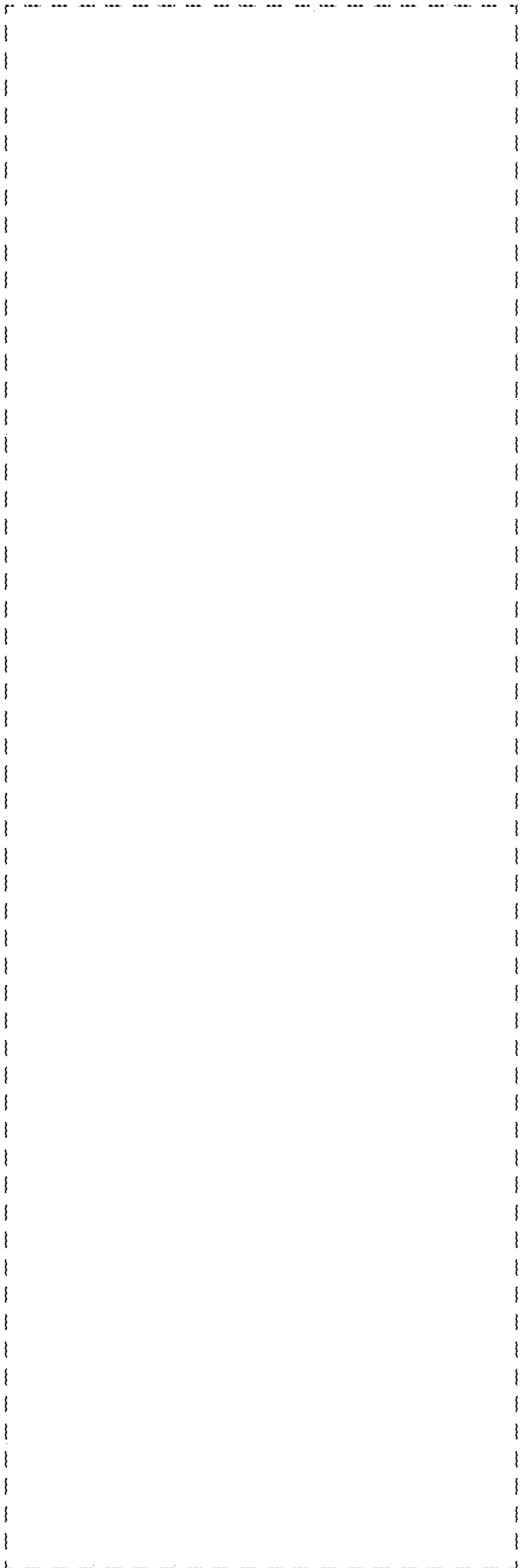

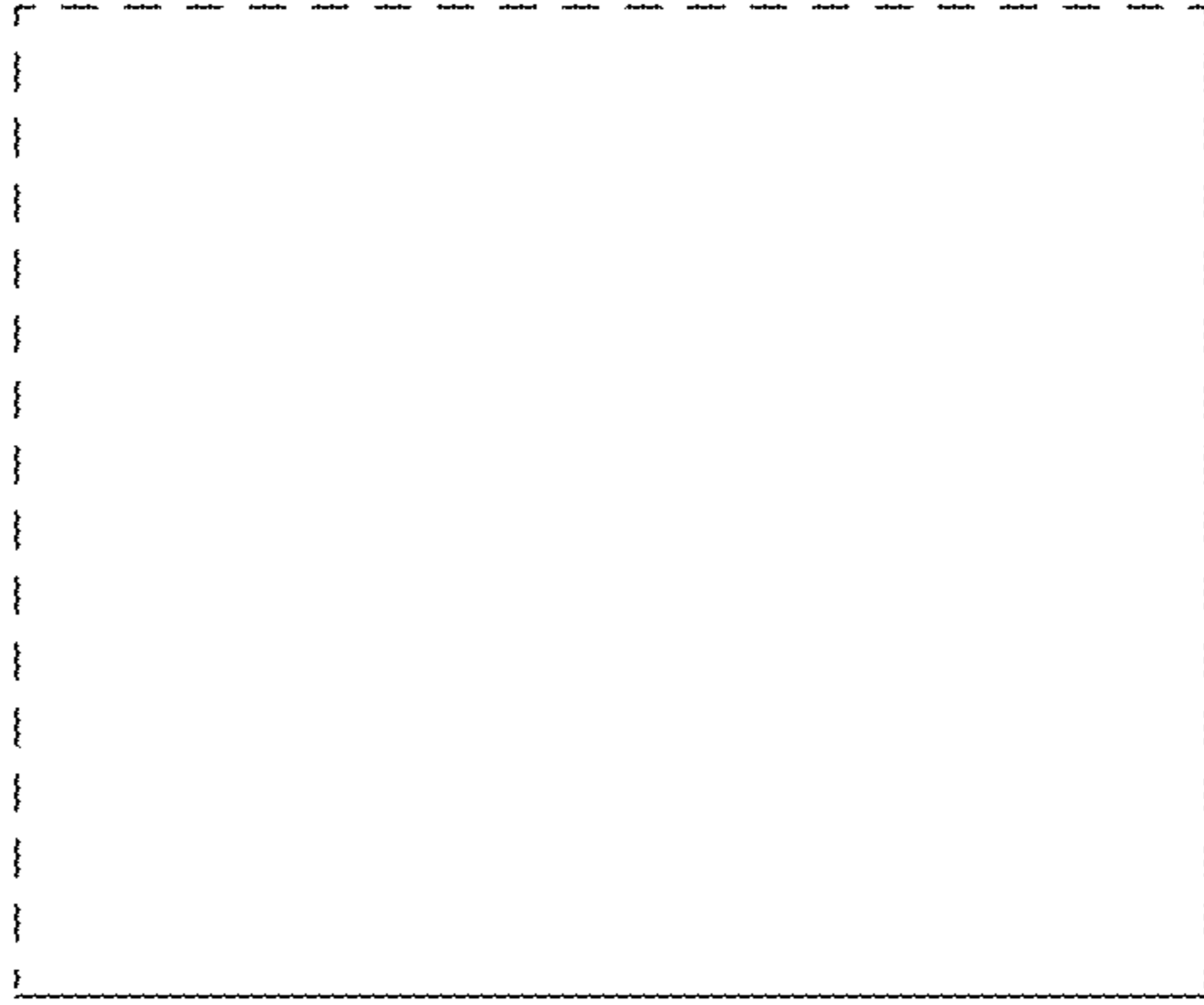

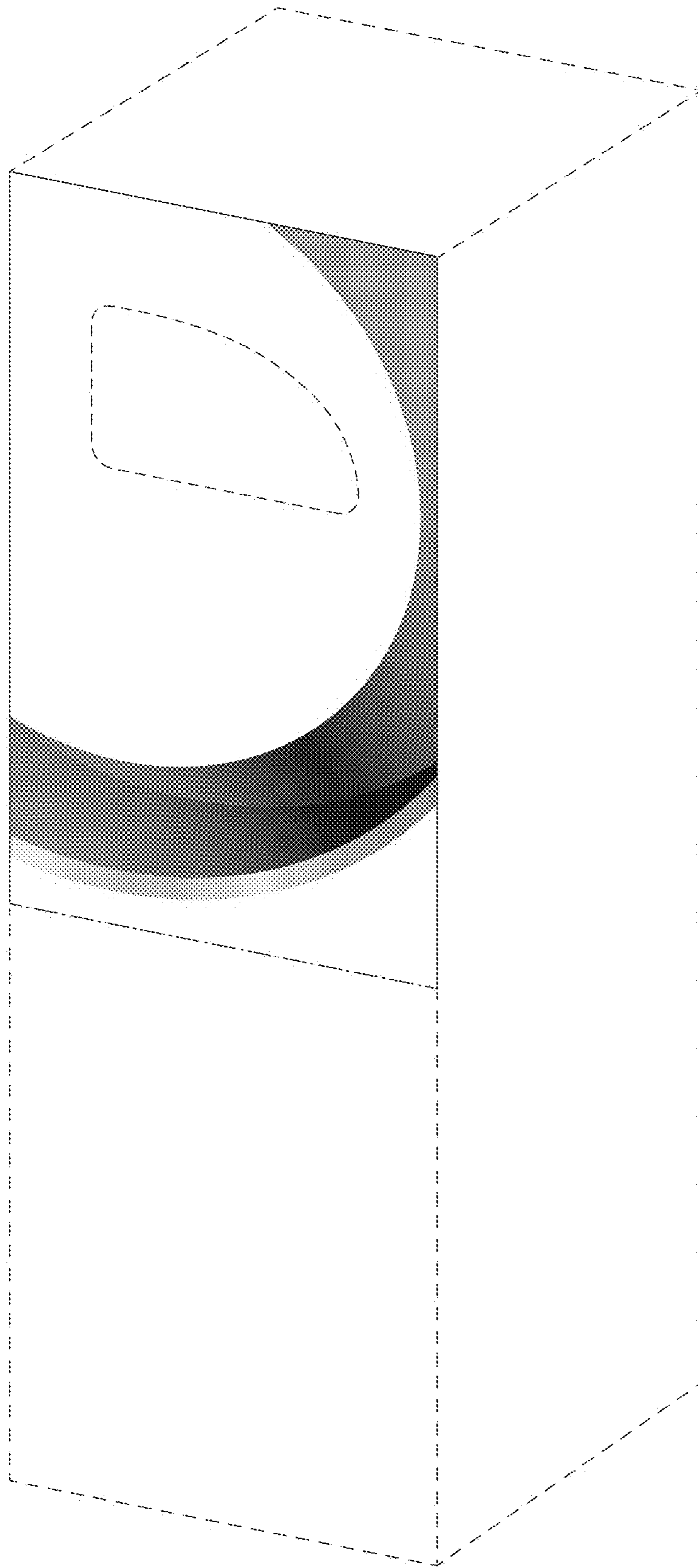

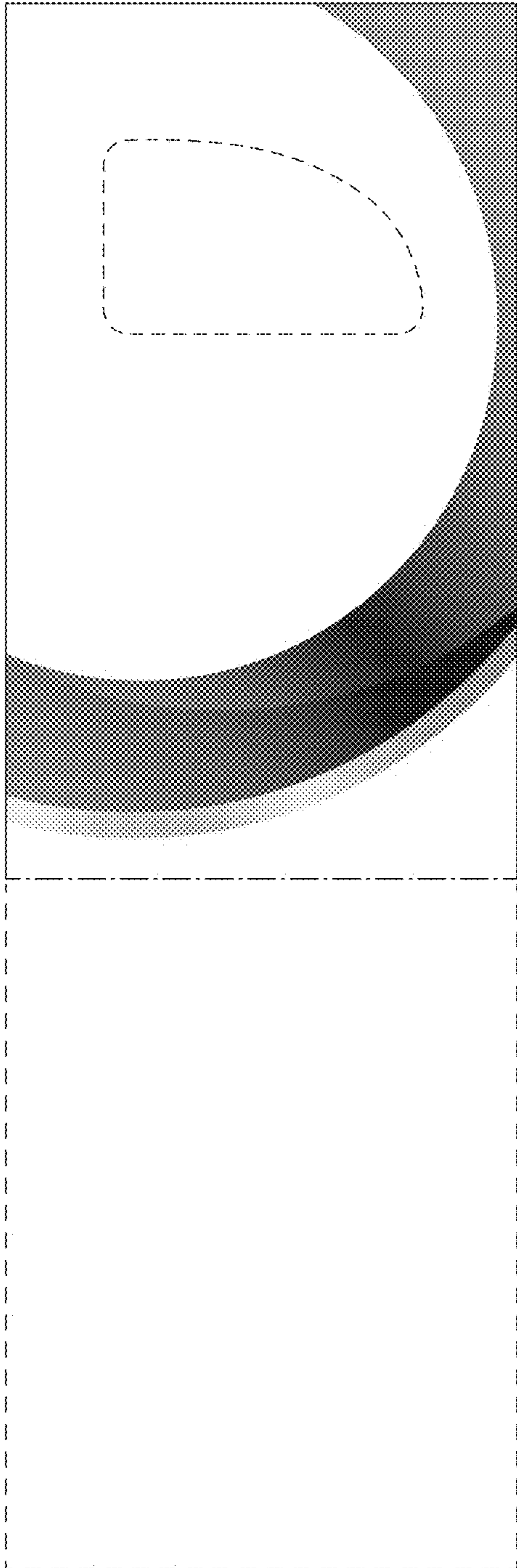

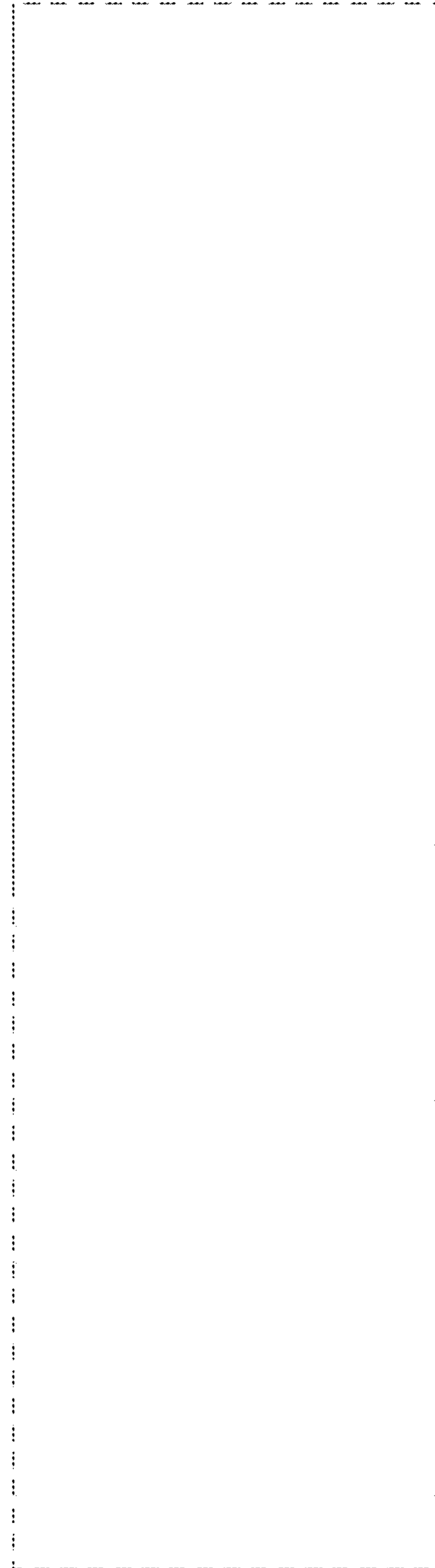

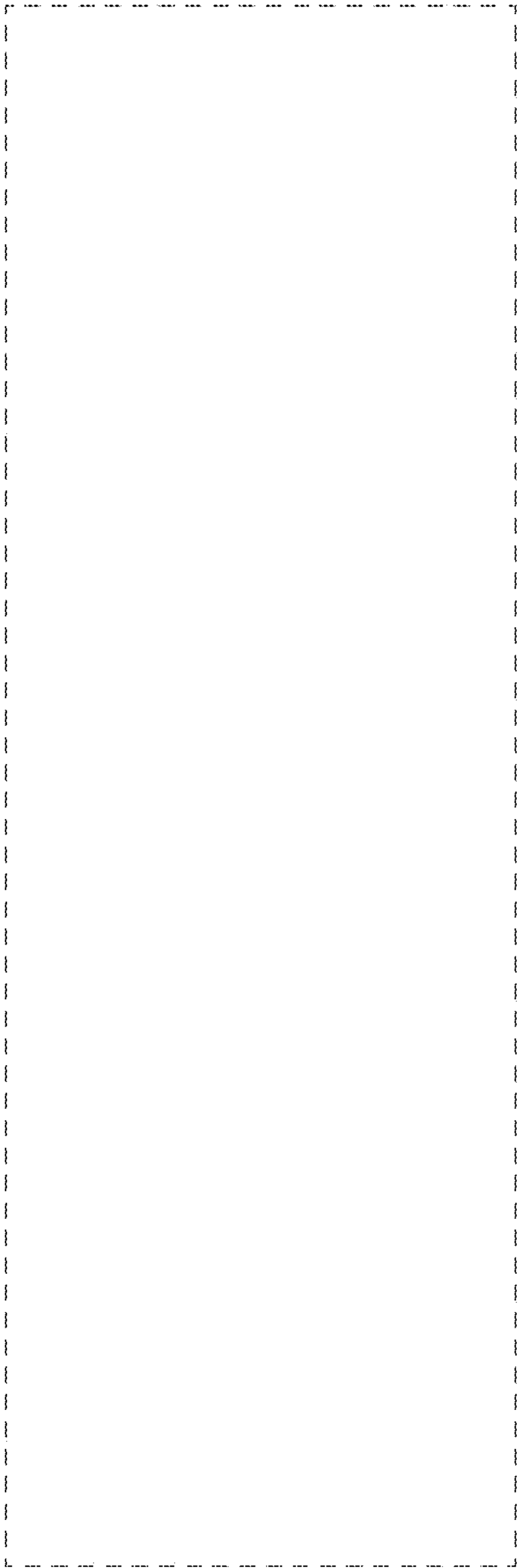

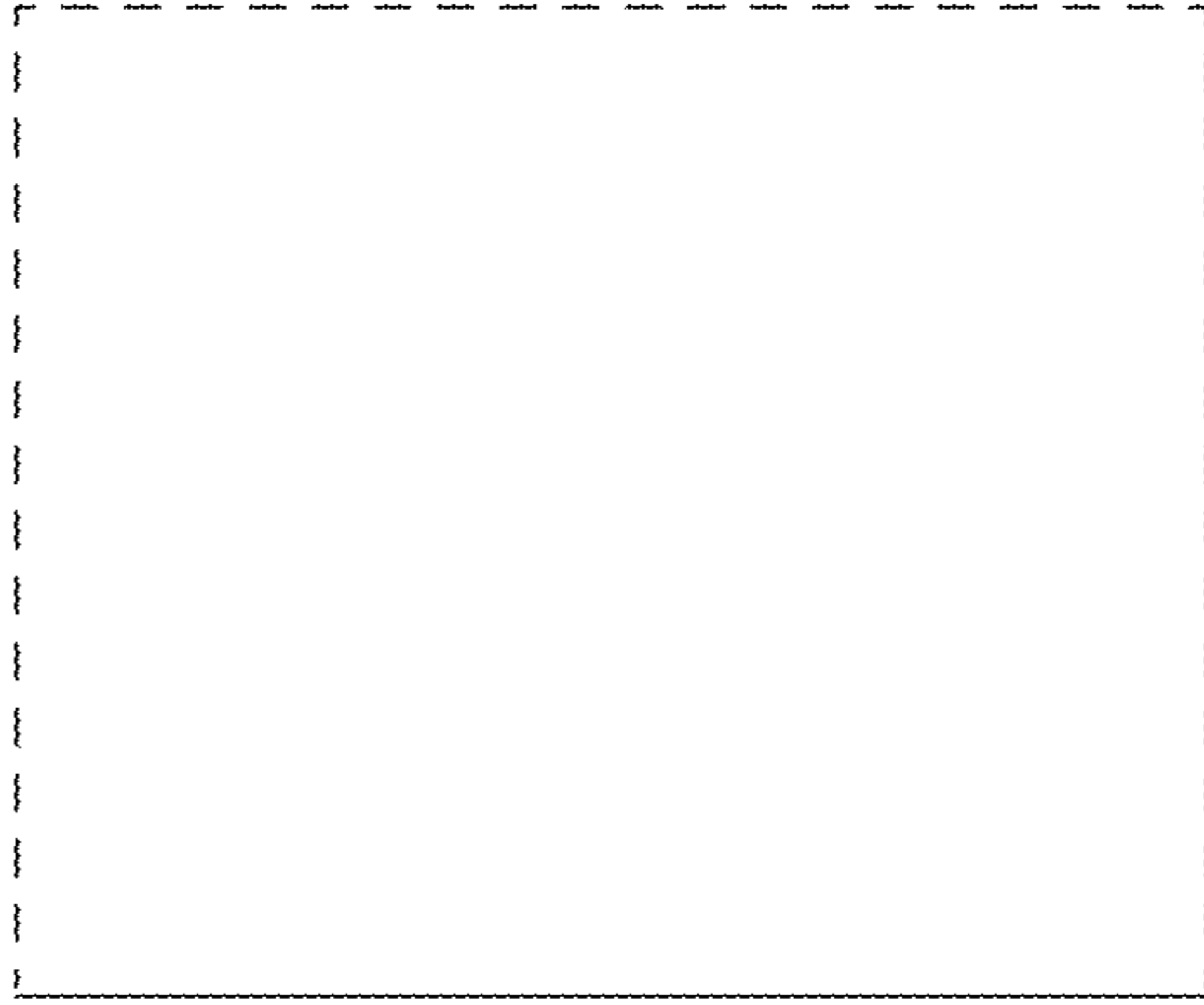

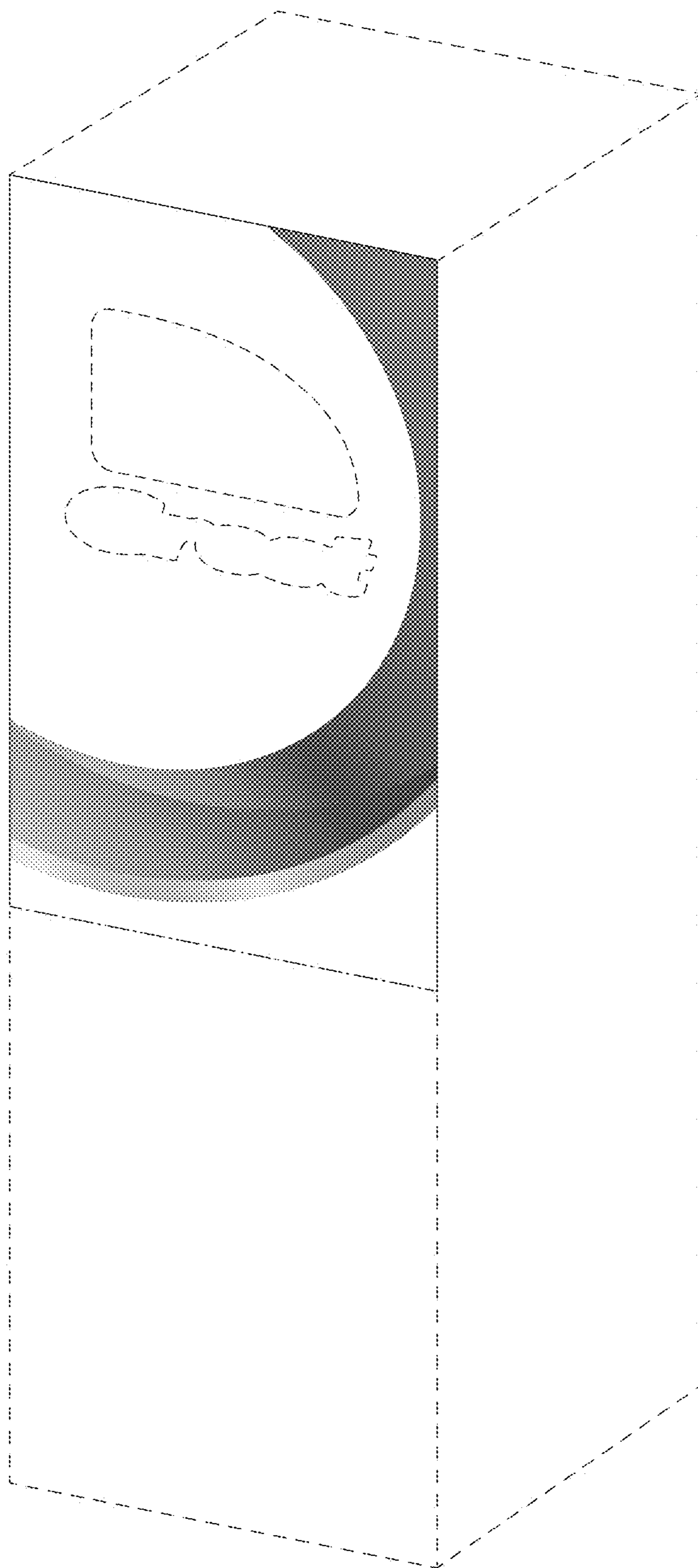

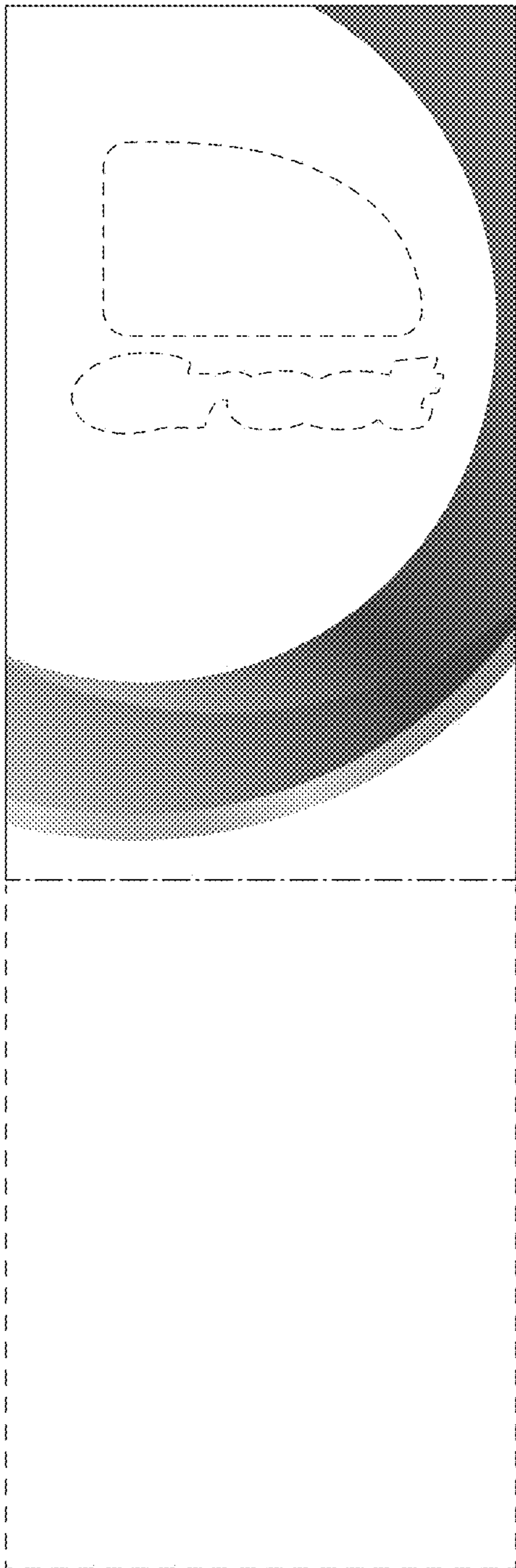

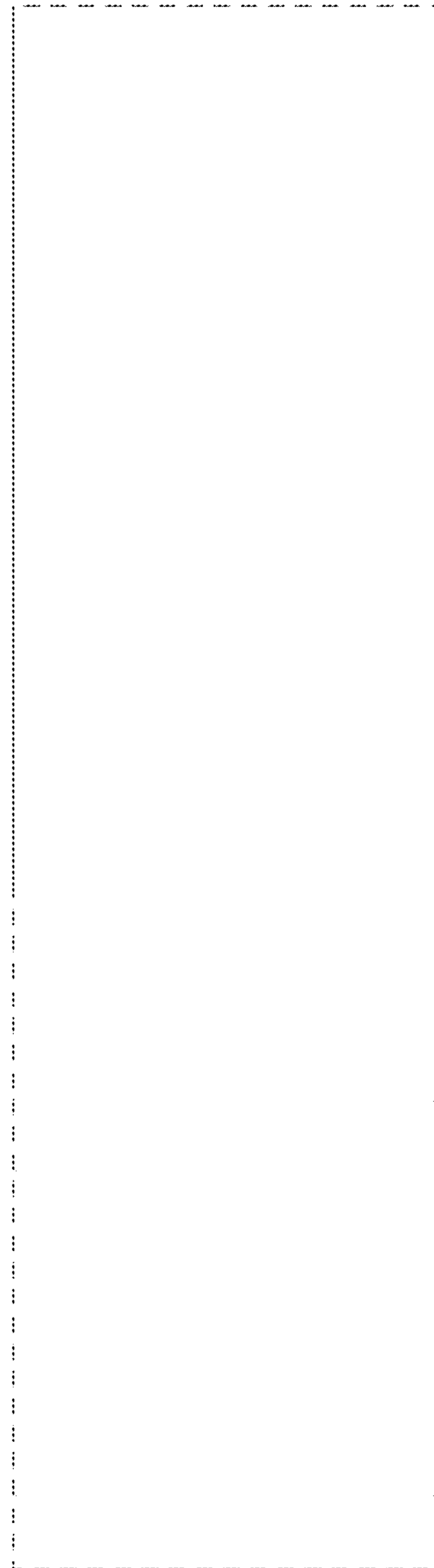

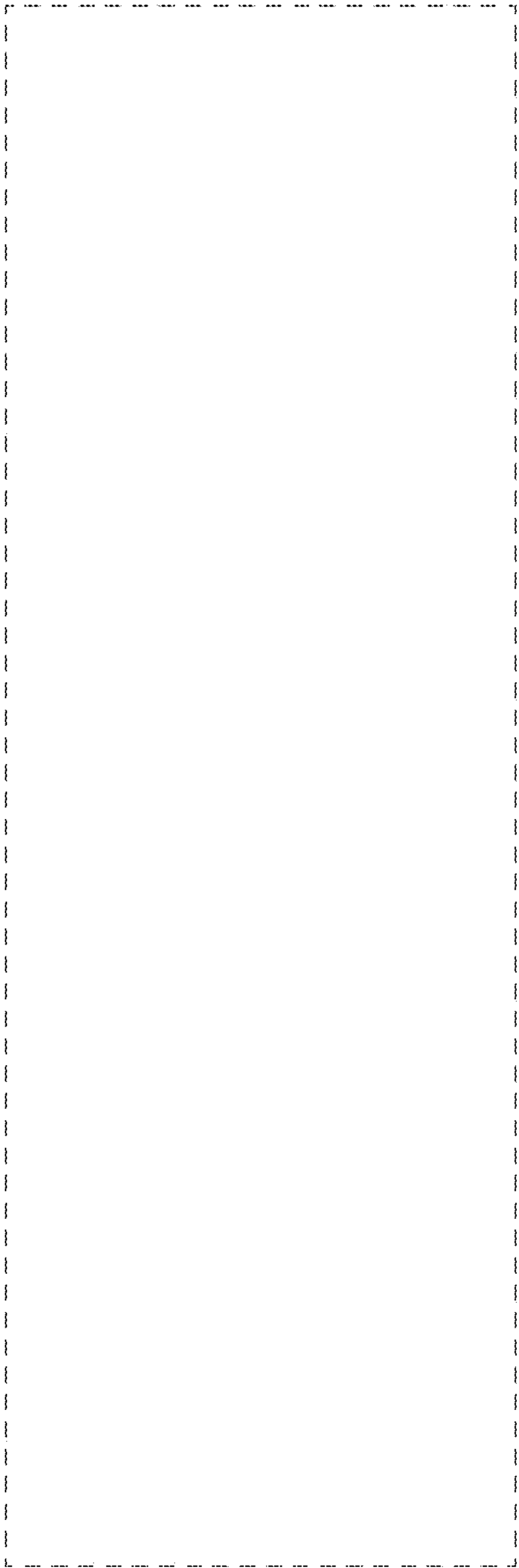

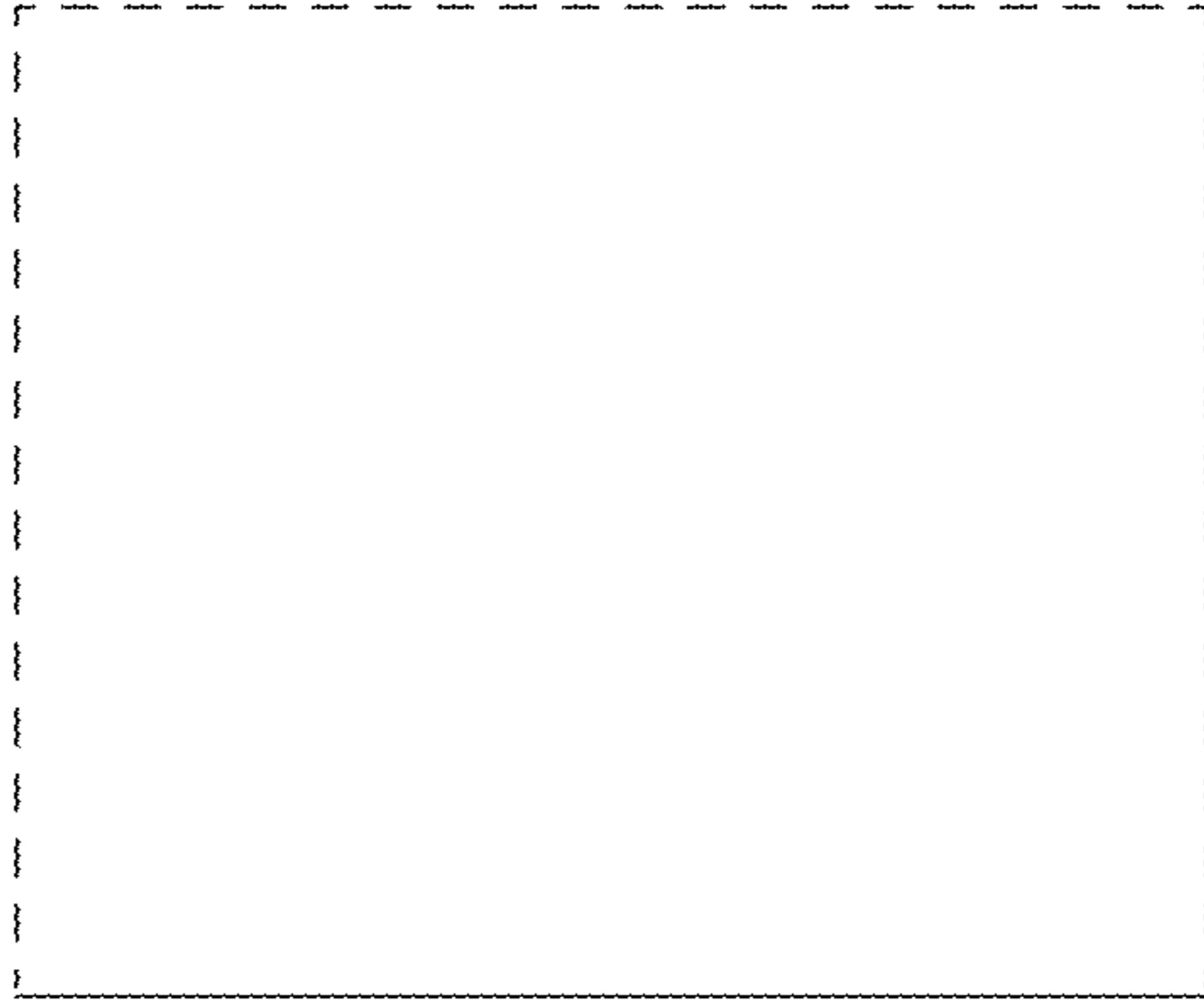
