(57) **CLAIM**

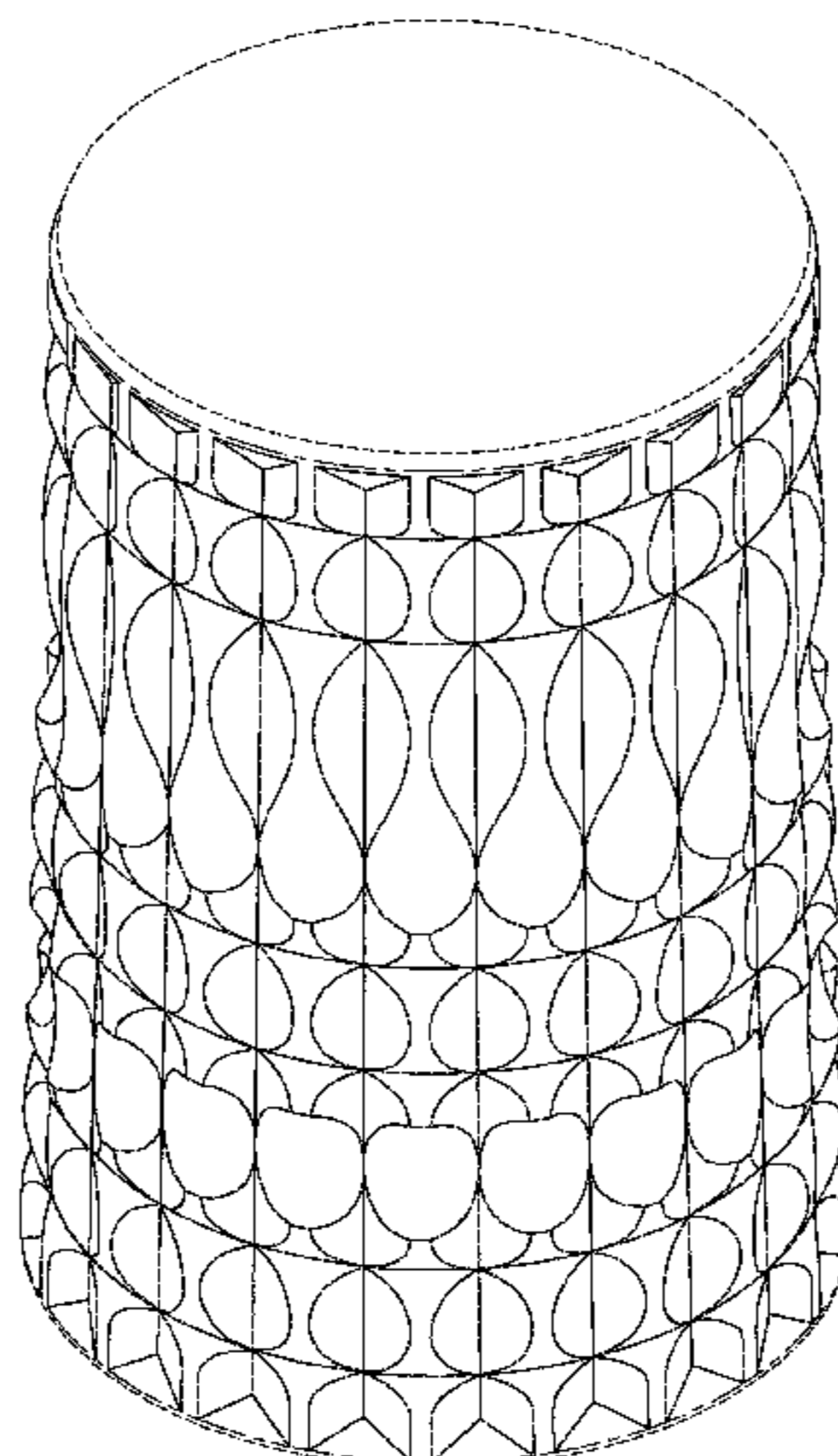
The ornamental design for a cap for packaging container, as shown and described.

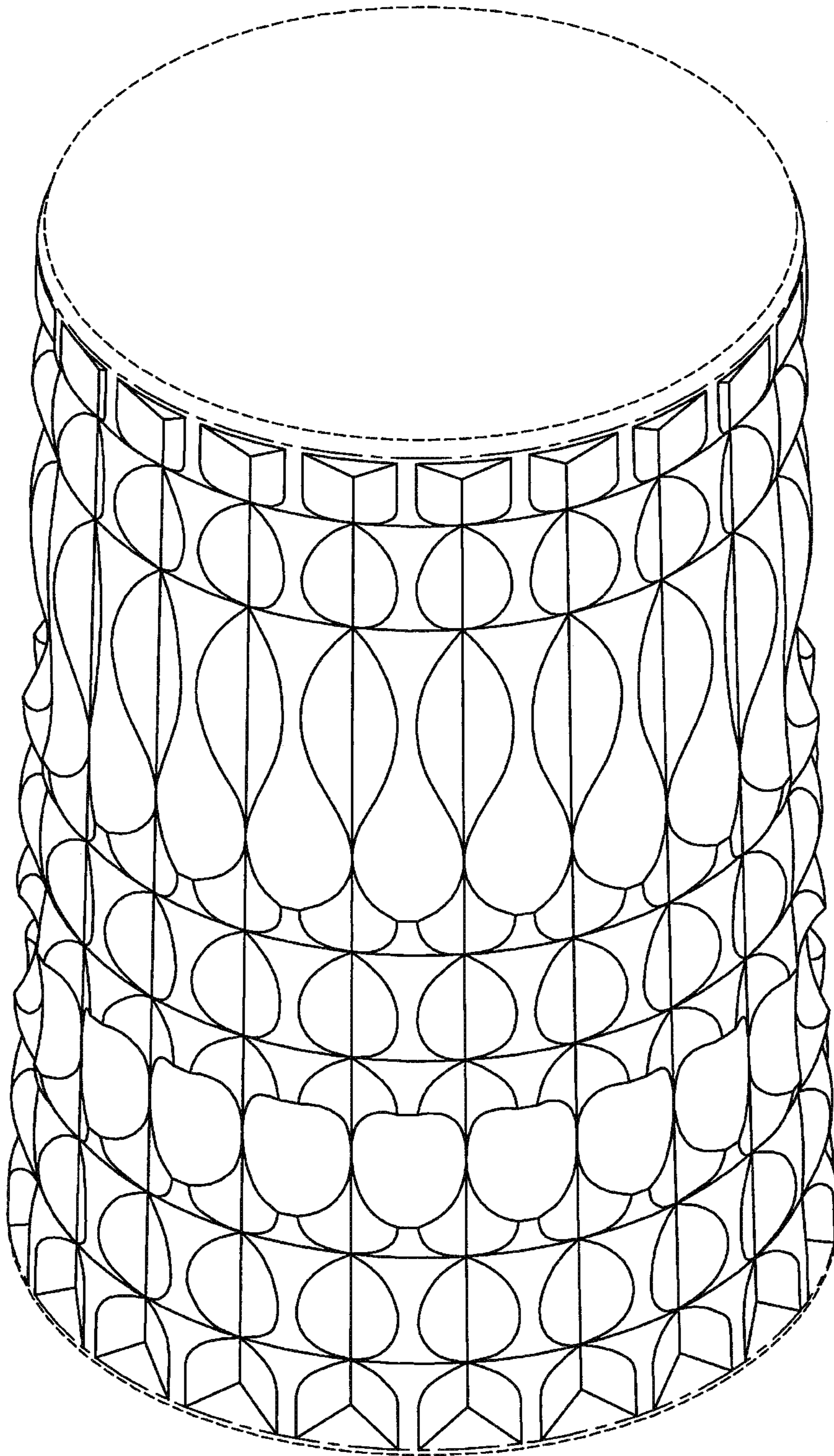

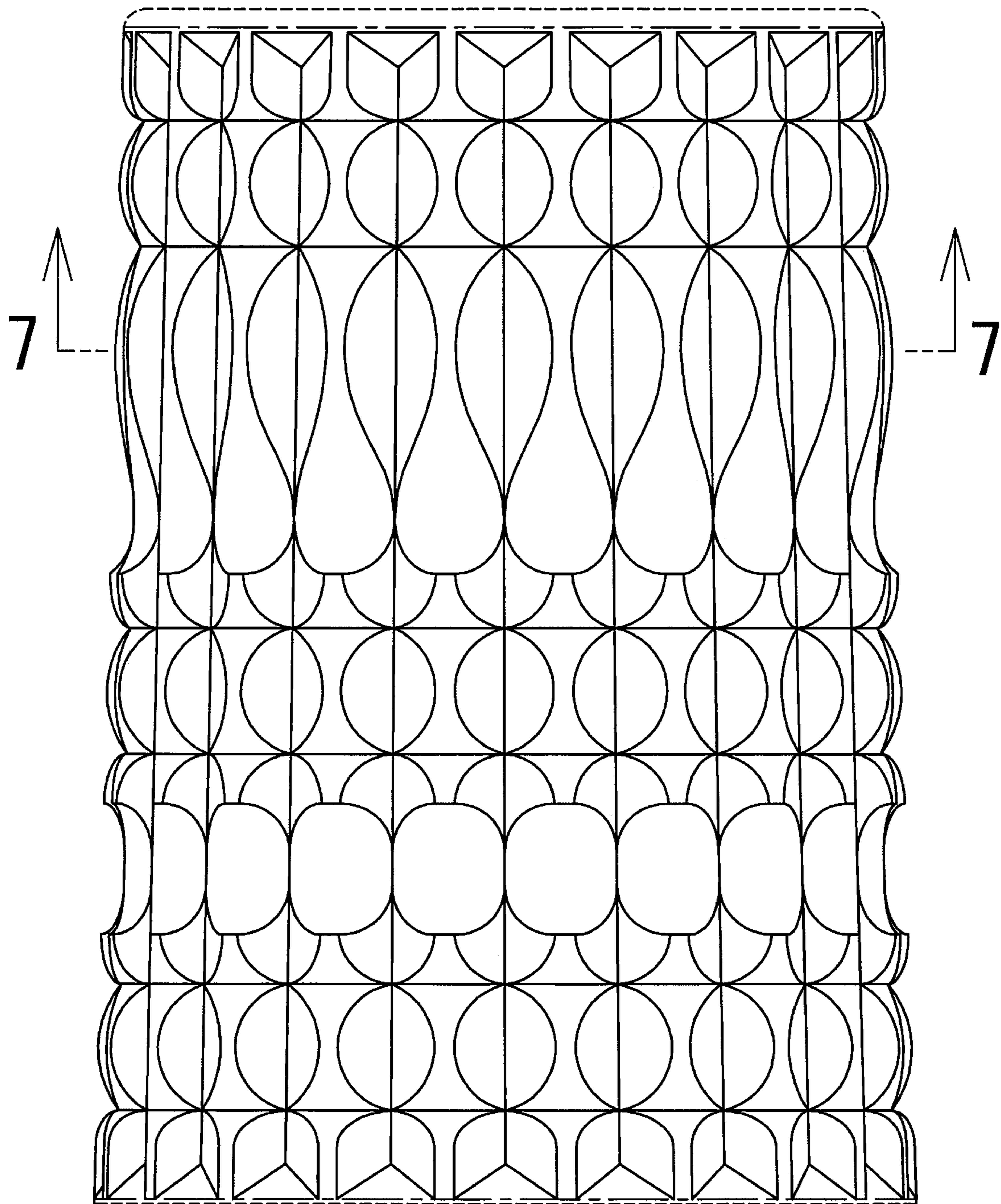

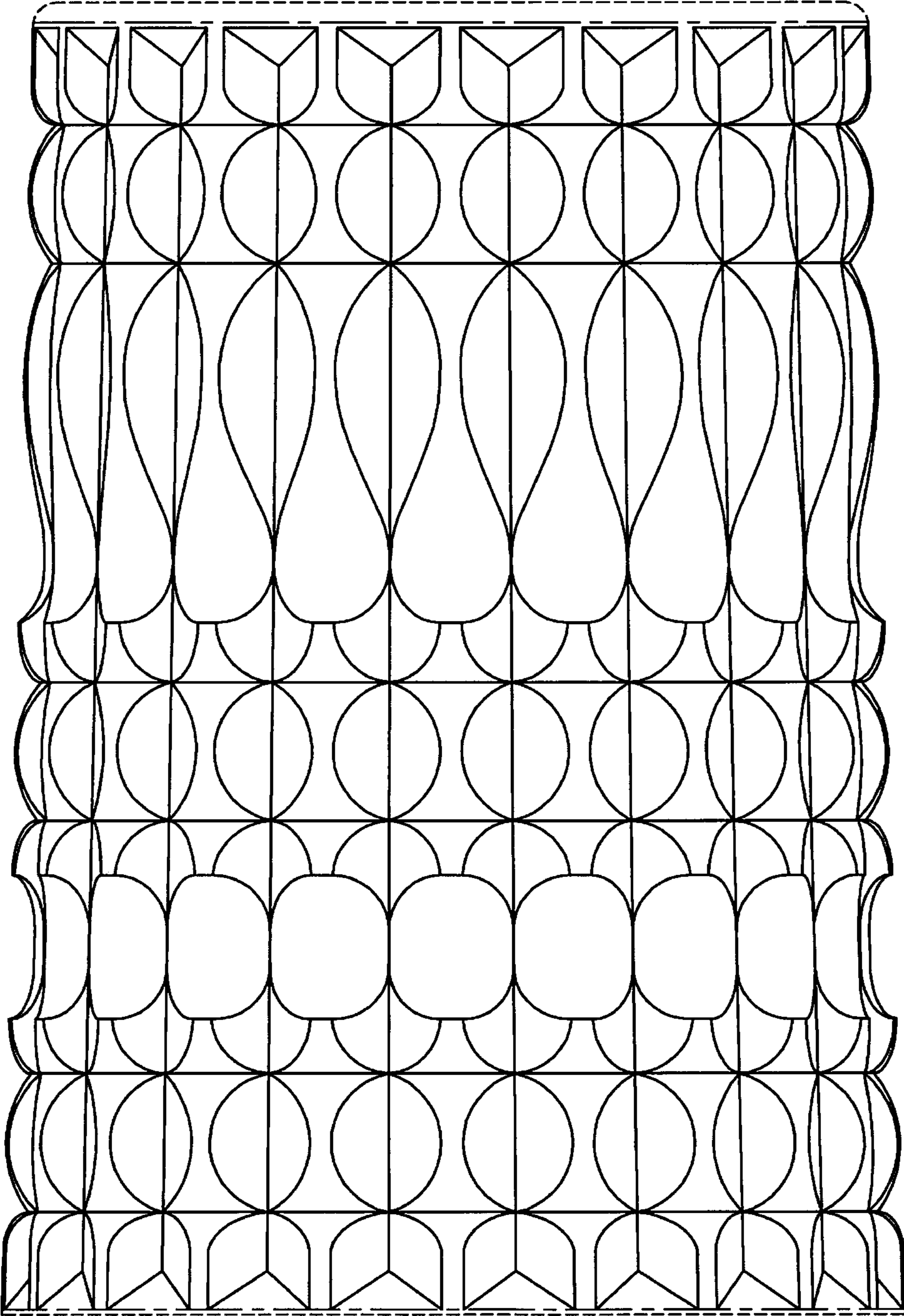

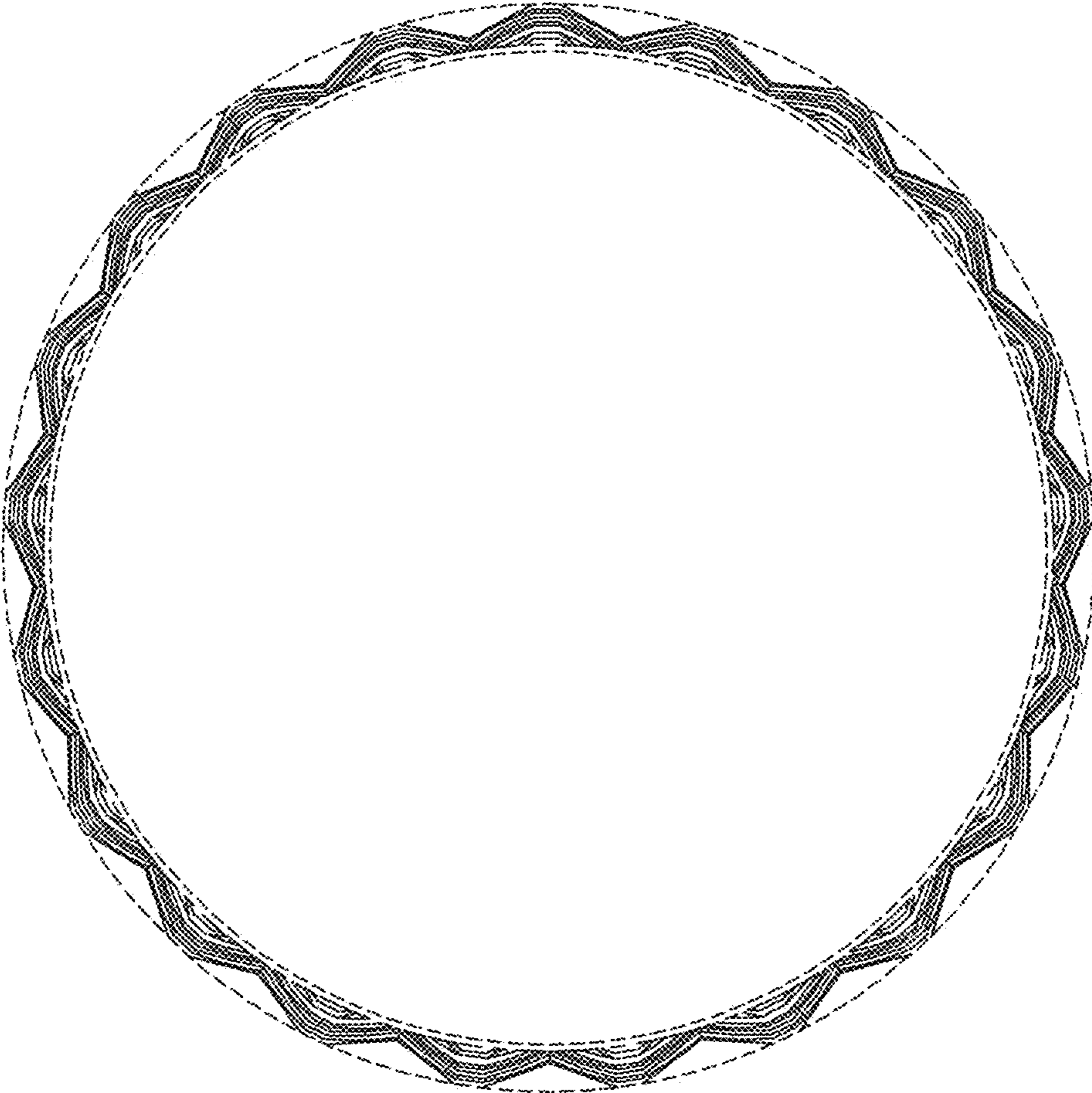

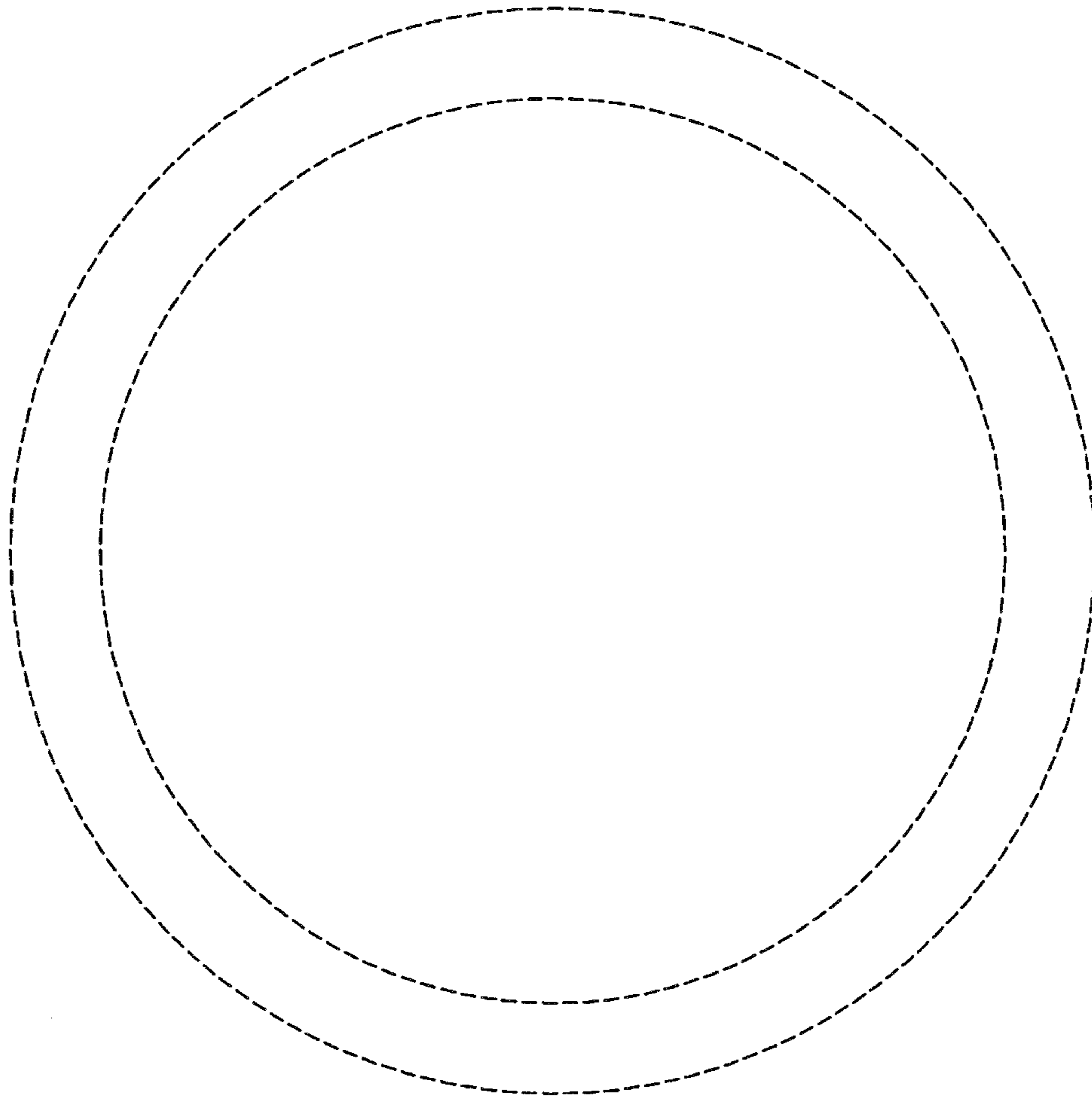

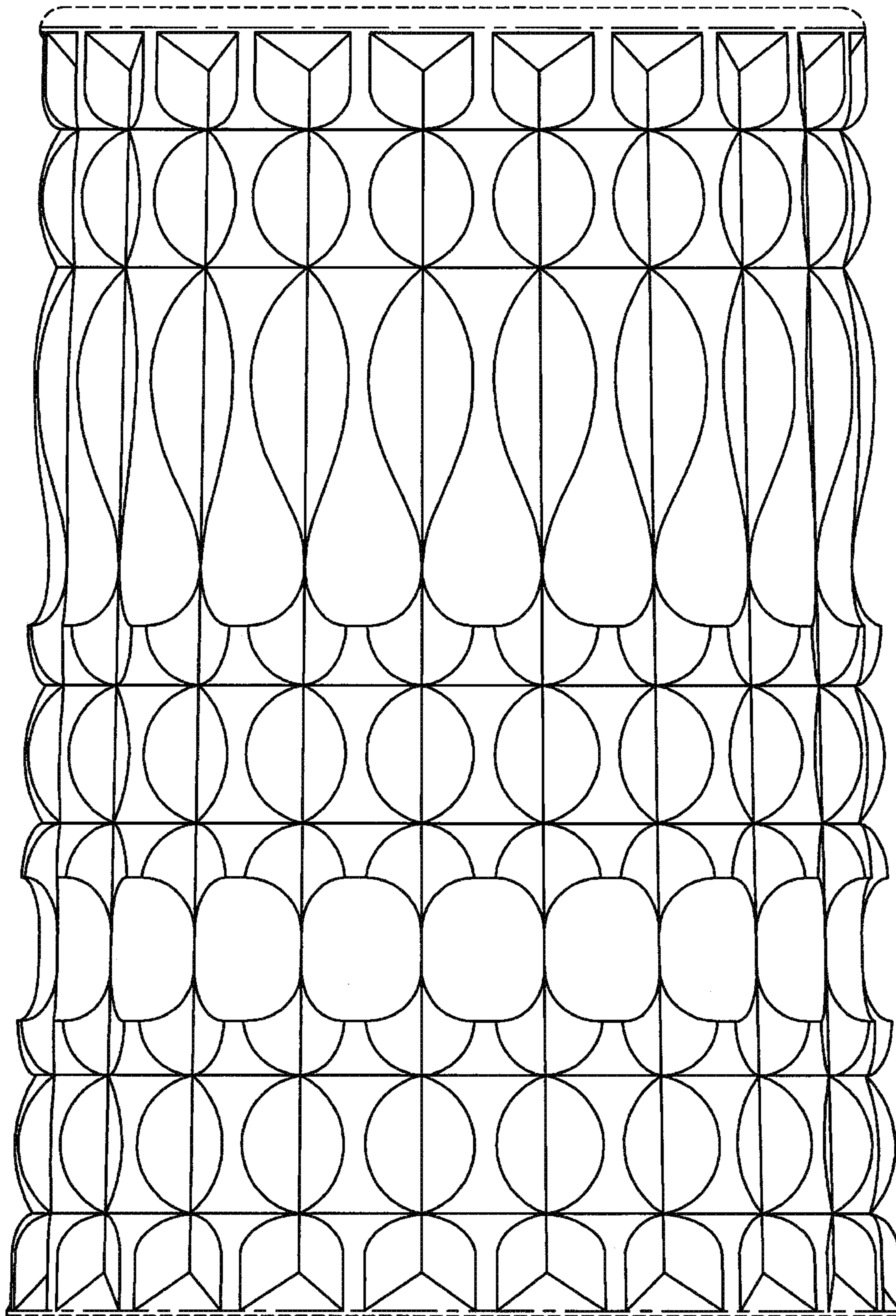
