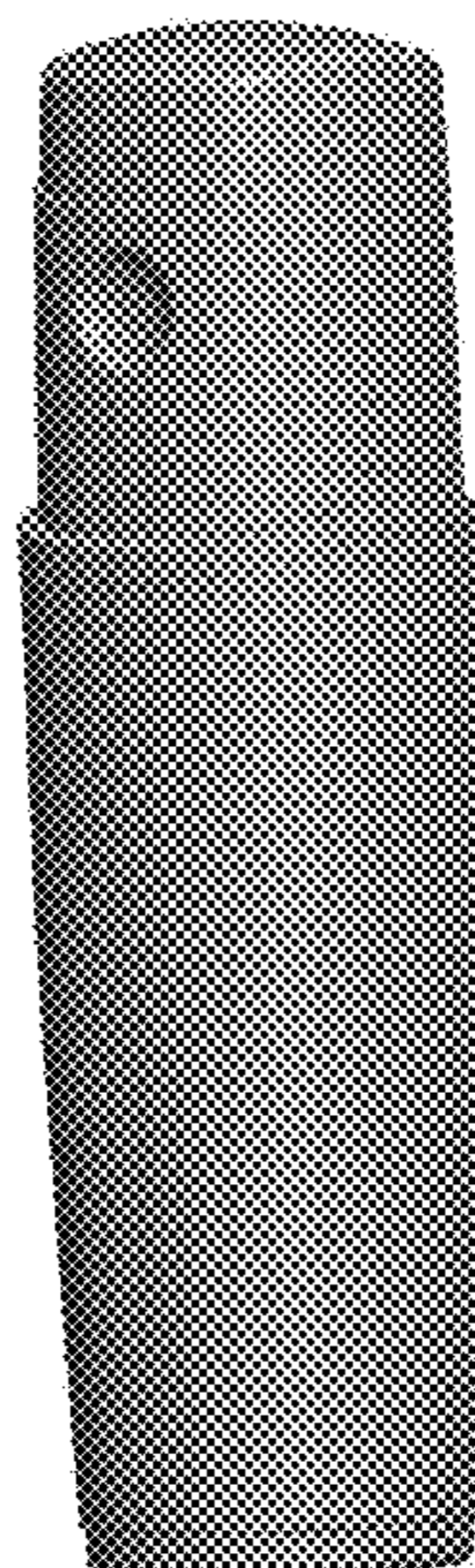

The ornamental design for spray tanning applicator, as shown and described.

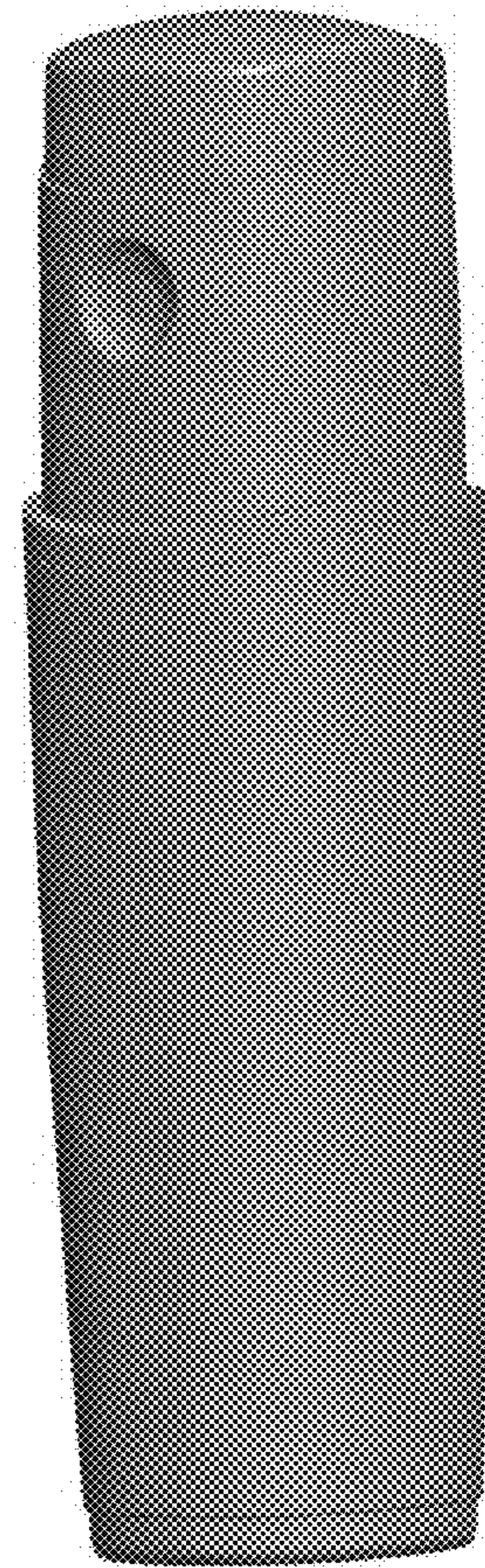
DESCRIPTION

FIG. 1.5 is a top plan view thereof.

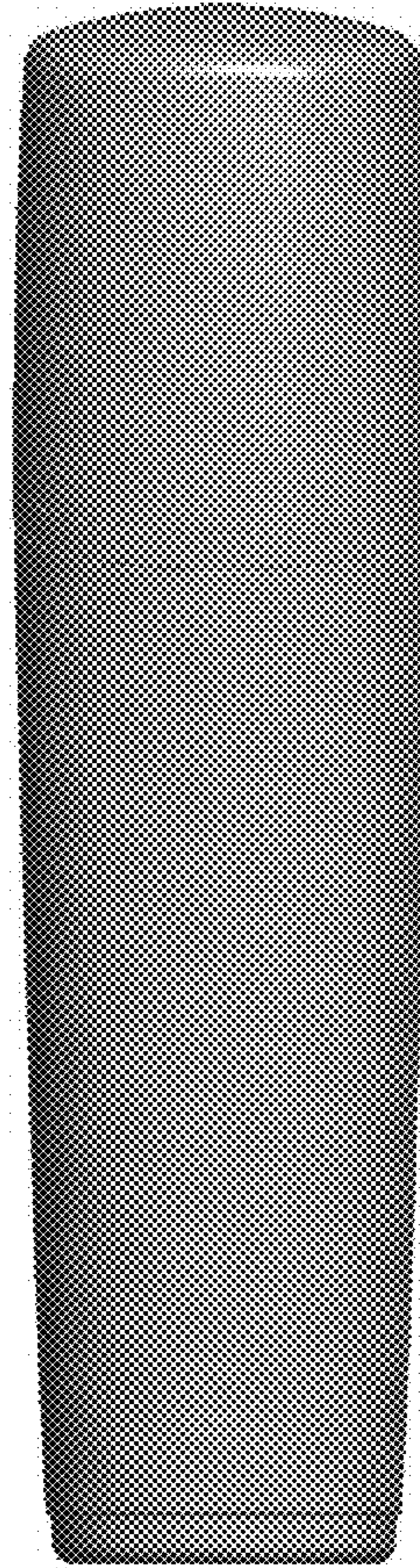

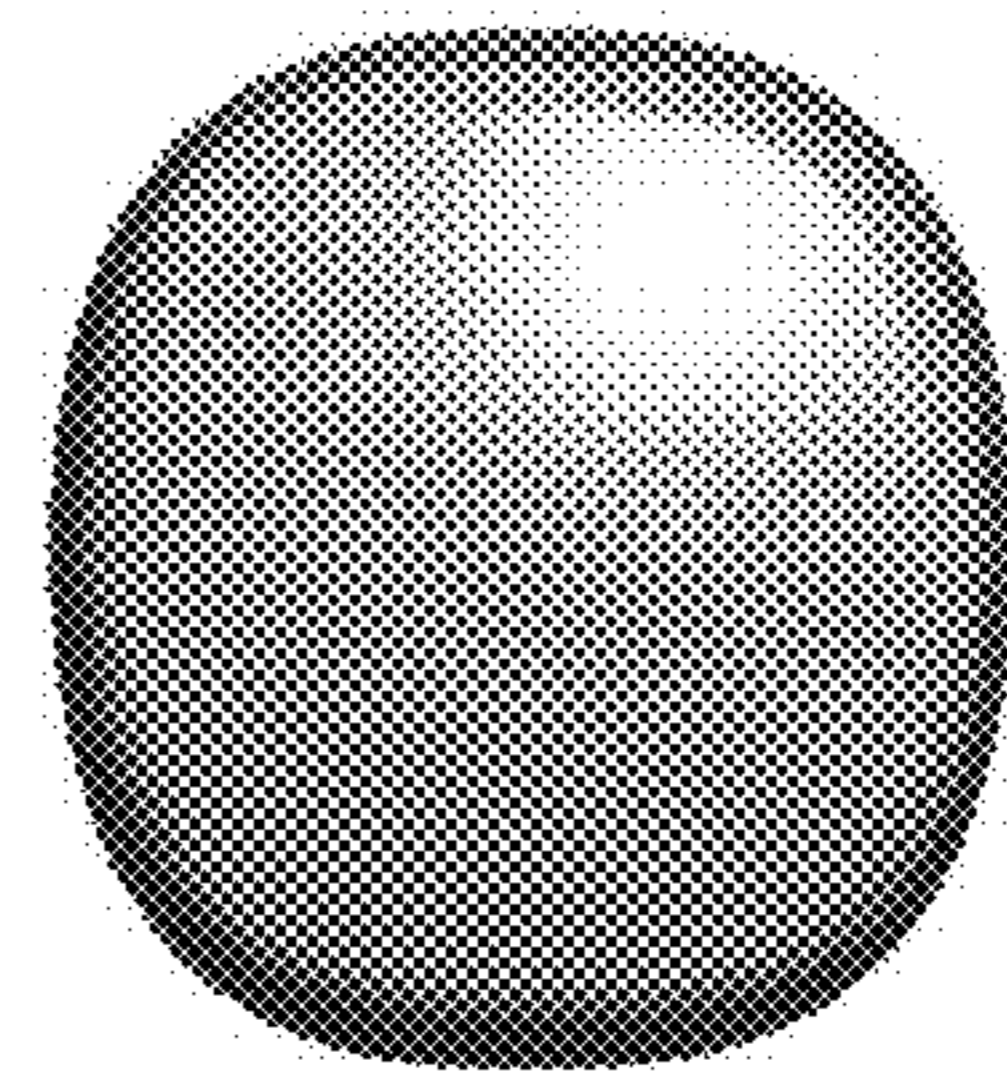

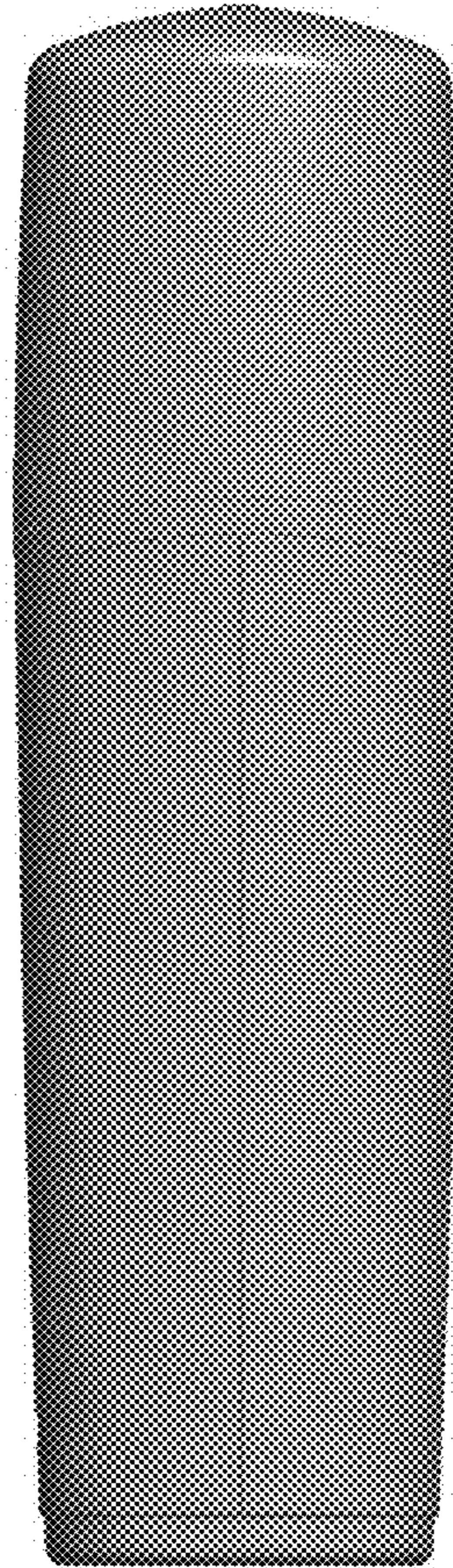
