**DESCRIPTION**

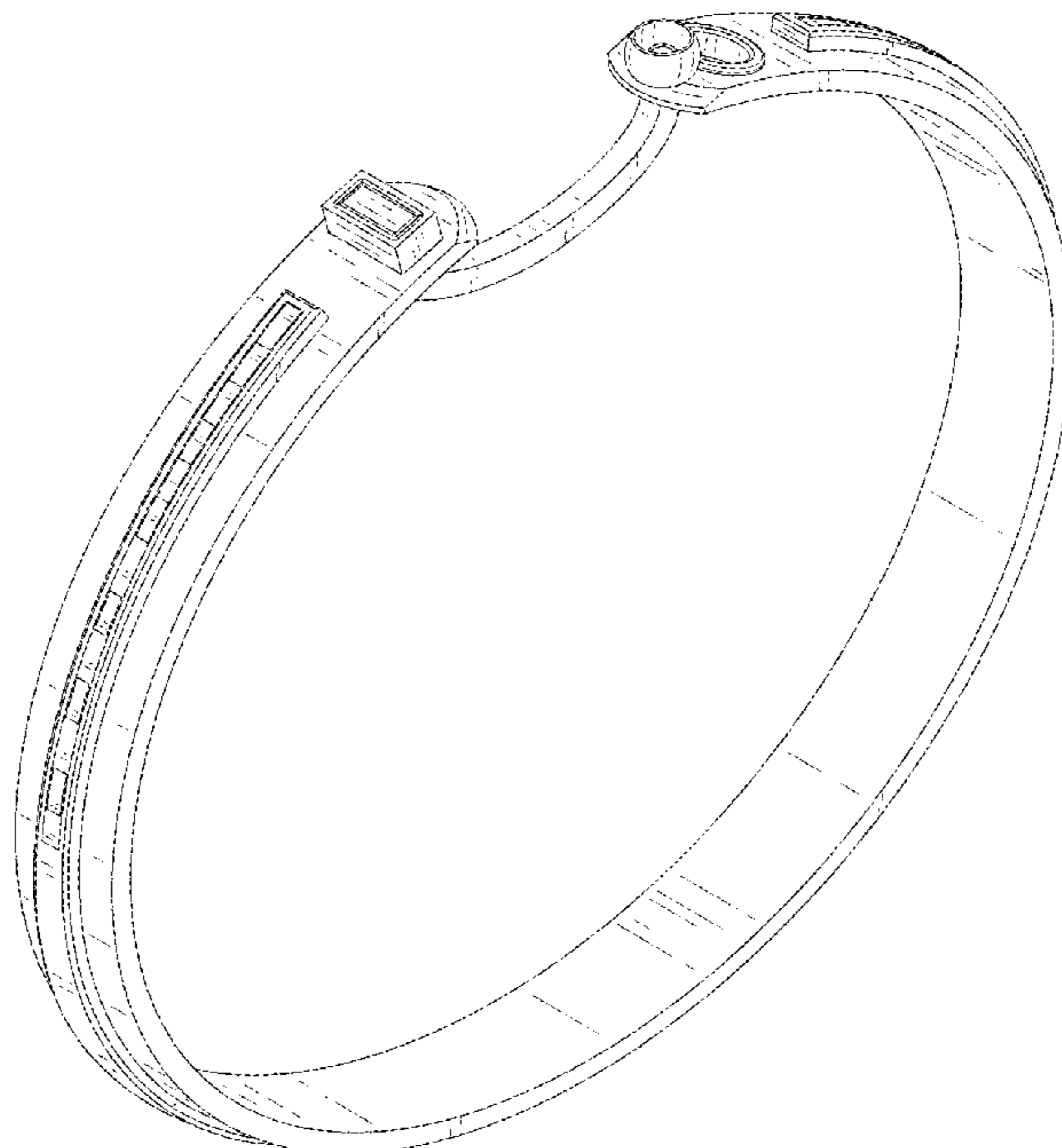
FIG. 1 is a perspective view of the bangle.

FIG. 7 is a bottom view of the bangle.

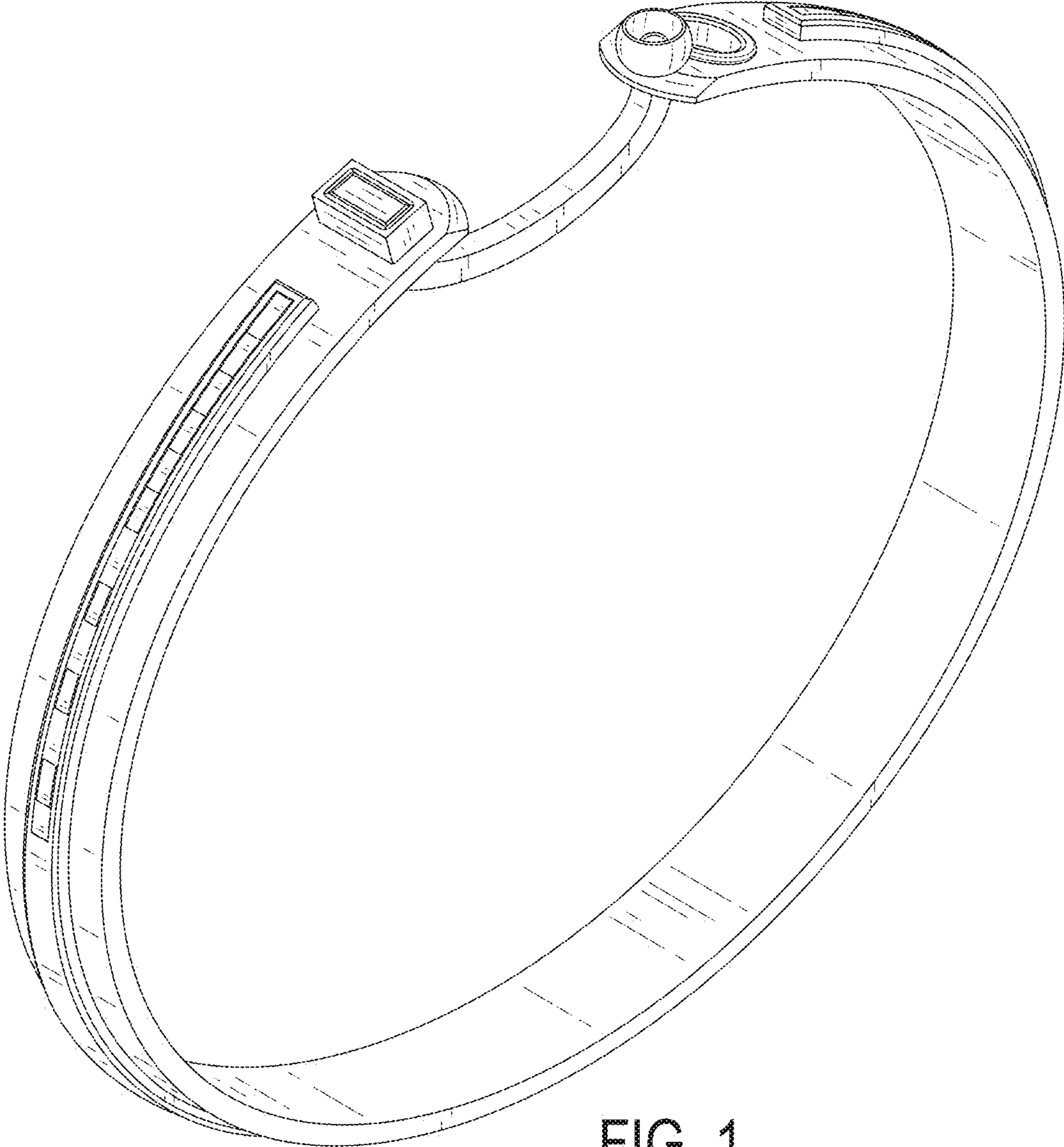

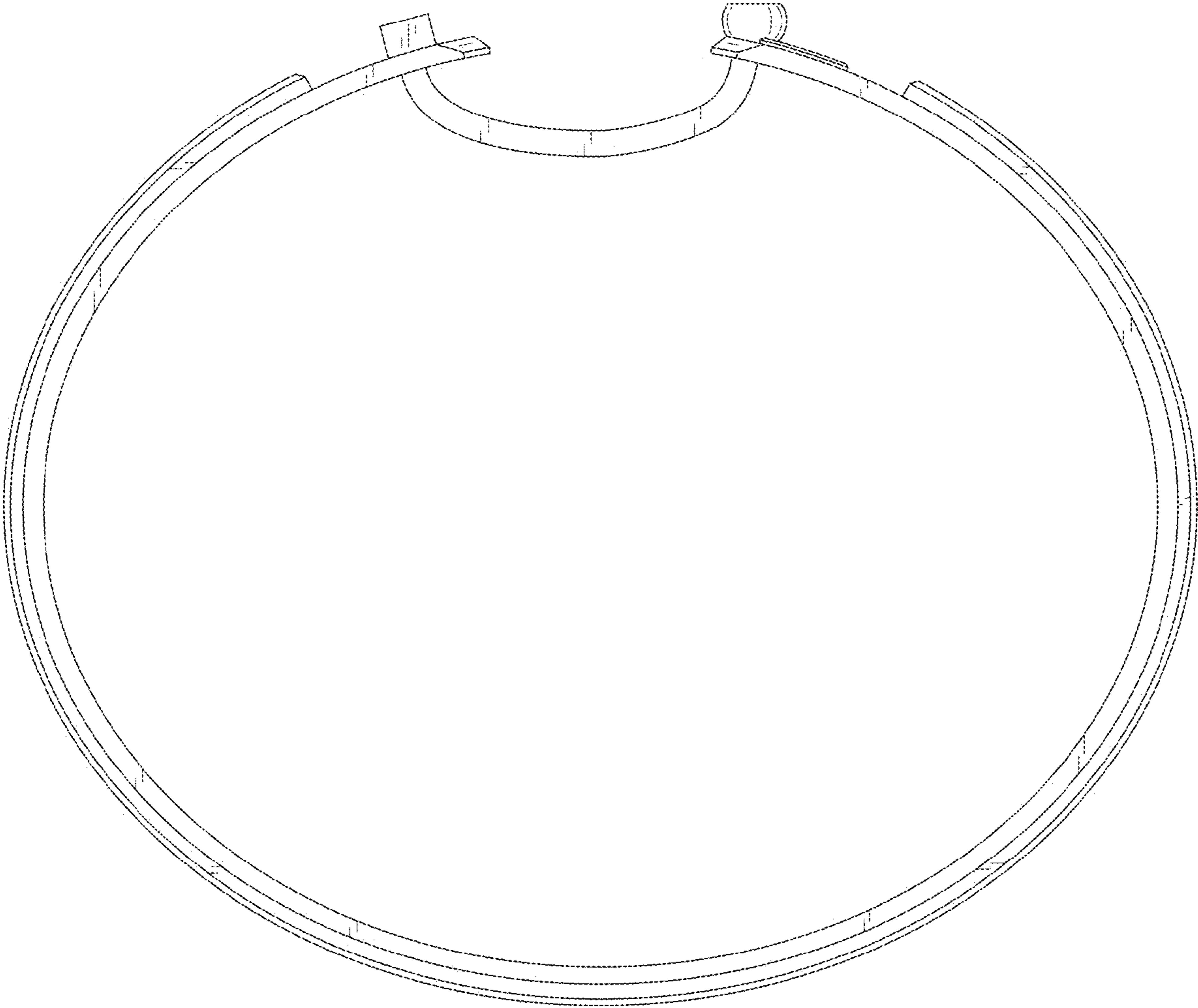

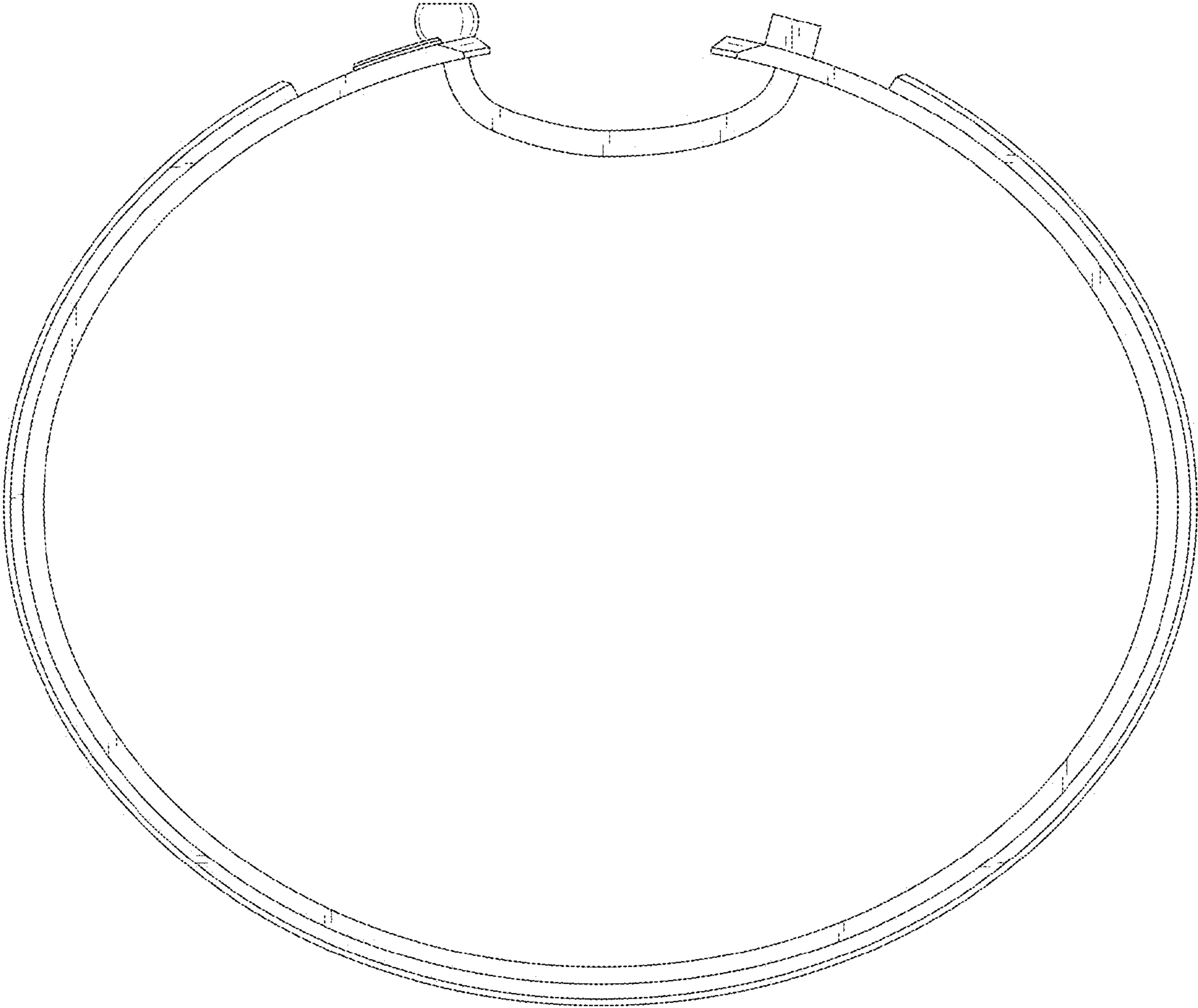

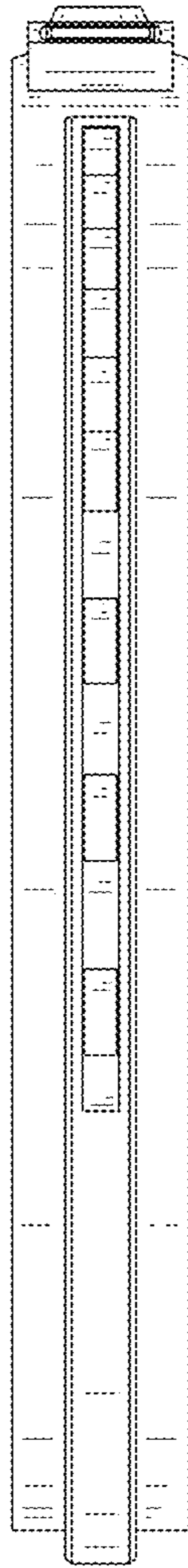

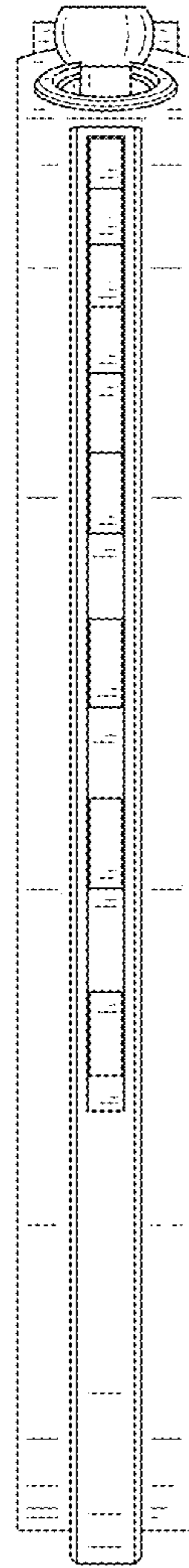

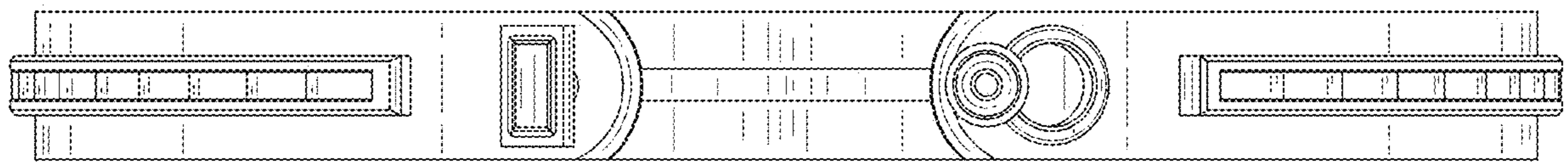

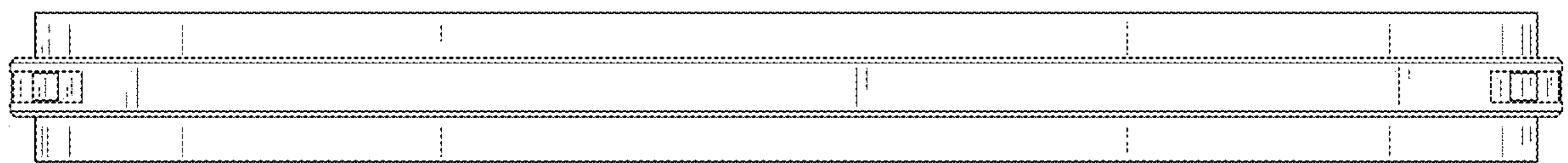
