The ornamental design for a display screen having a graphical user interface or portion thereof, as shown and described.

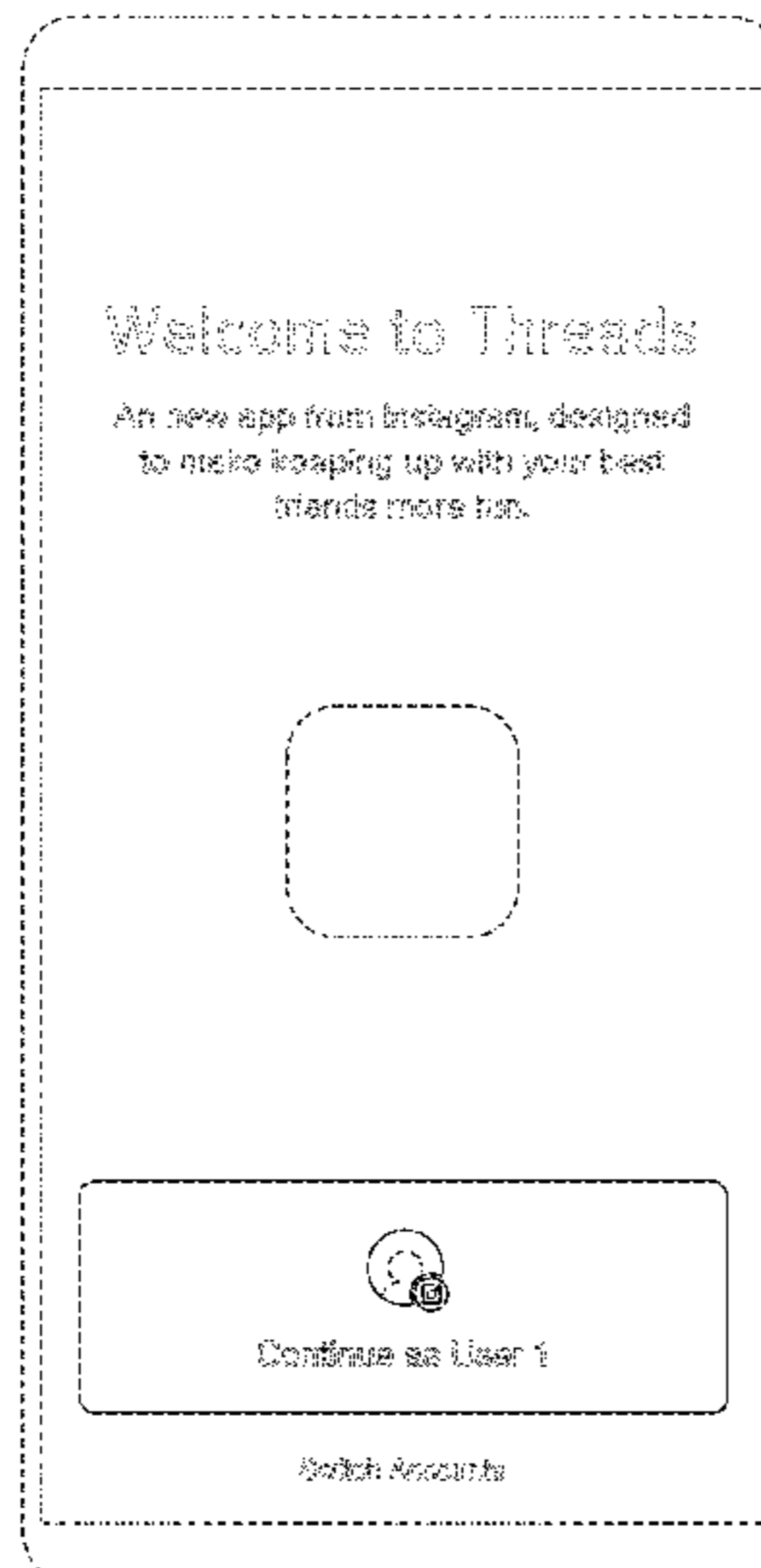
DESCRIPTION
