(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface for an investment tool, as shown and described.

**DESCRIPTION**

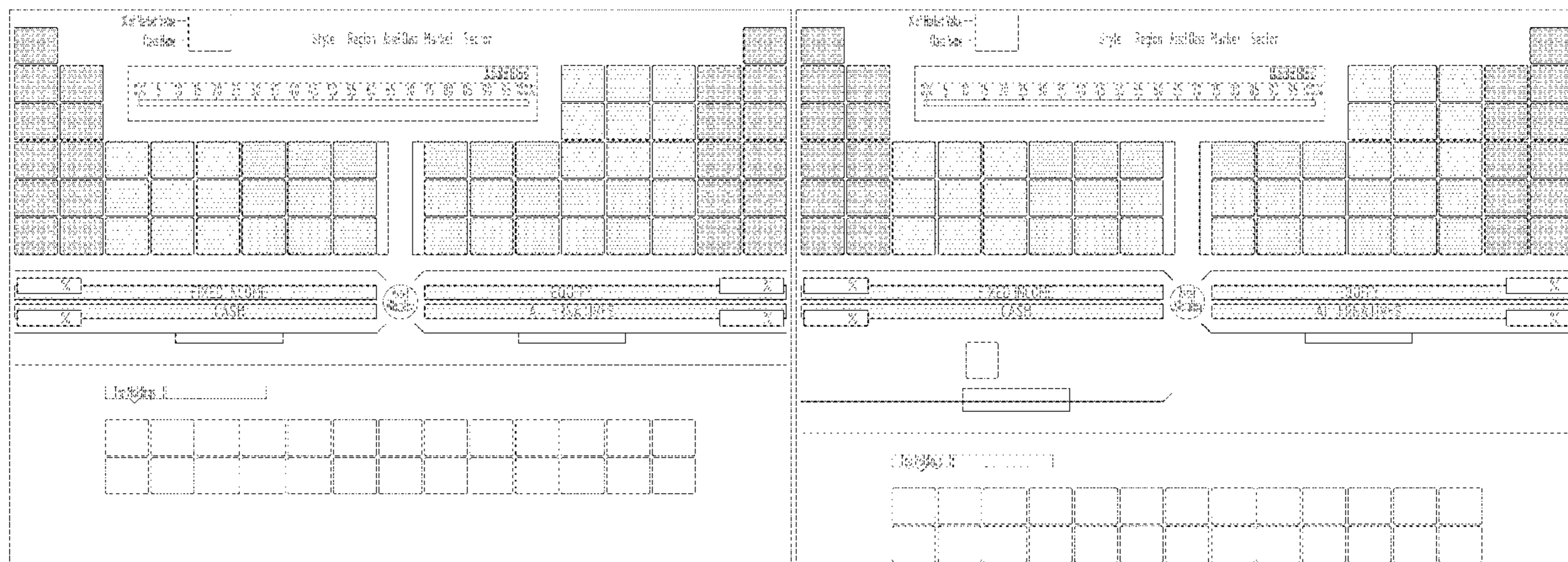
FIG. 1 is a front view of a display screen or portion thereof with animated graphical user interface for an investment tool, showing a first image in a sequence, in accordance with a first embodiment of the claimed design; FIG. 2 is the second image thereof; and FIG. 3 is the third image thereof.

FIG. 4 is a front view of a display screen or portion thereof with animated graphical user interface for an investment tool, showing a first image in a sequence, in accordance with a second embodiment of the claimed design; FIG. 5 is the second image thereof; and, FIG. 6 is the third image thereof.

The broken line portions are included to show environment or disclaimed portions only, and form no part of the claimed design. More particularly, the outermost broken lines in the figures show a display screen or portion thereof, and form no part of the claimed design. The other broken lines in the figures show portions of the animated graphical user interface that form no part of the claimed design.

The appearance of the animated images sequentially transitions between the images shown in FIGS. 1-3 and 4-6, respectively. The process or period in which one image transitions to another forms no part of the claimed design.

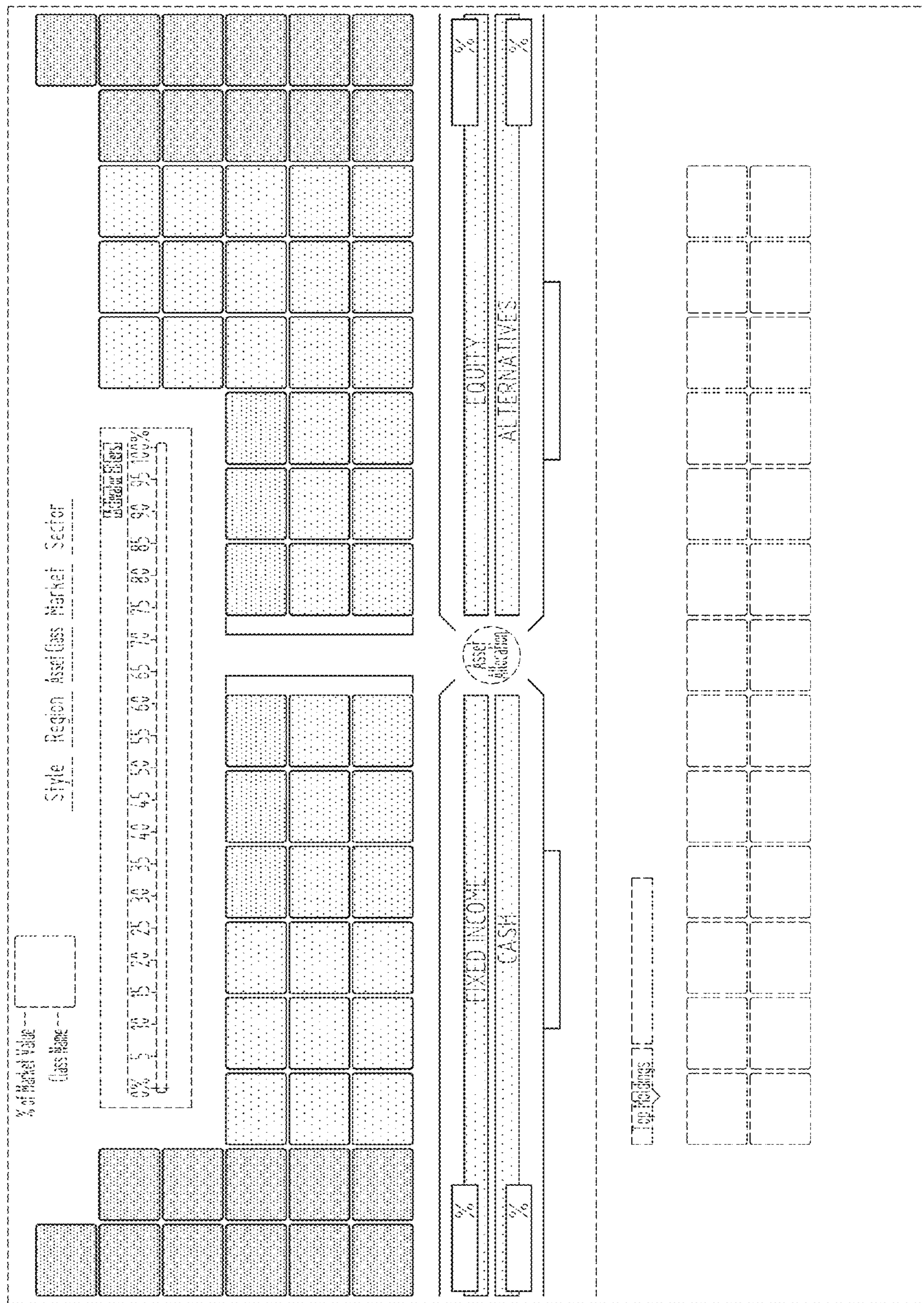

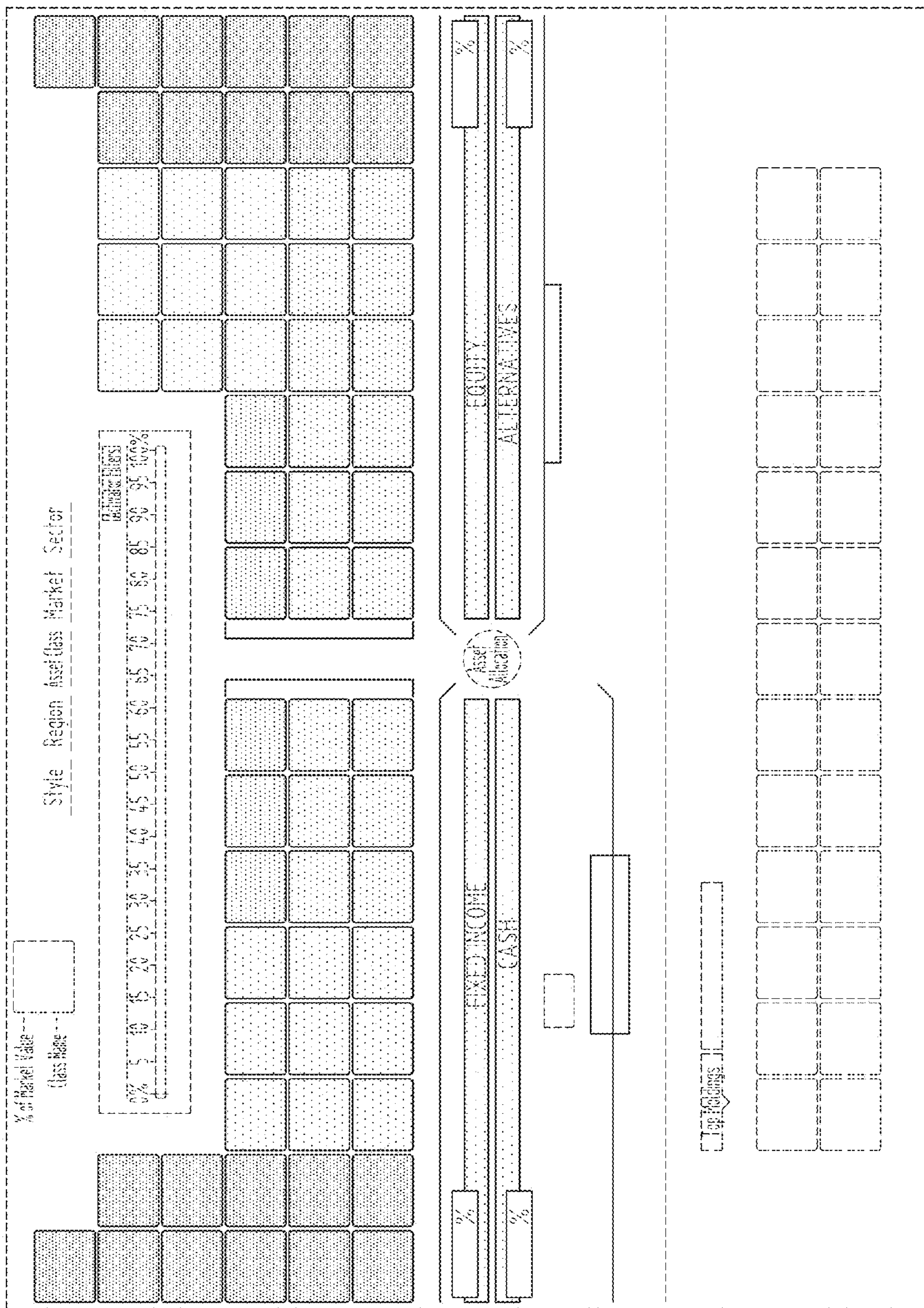

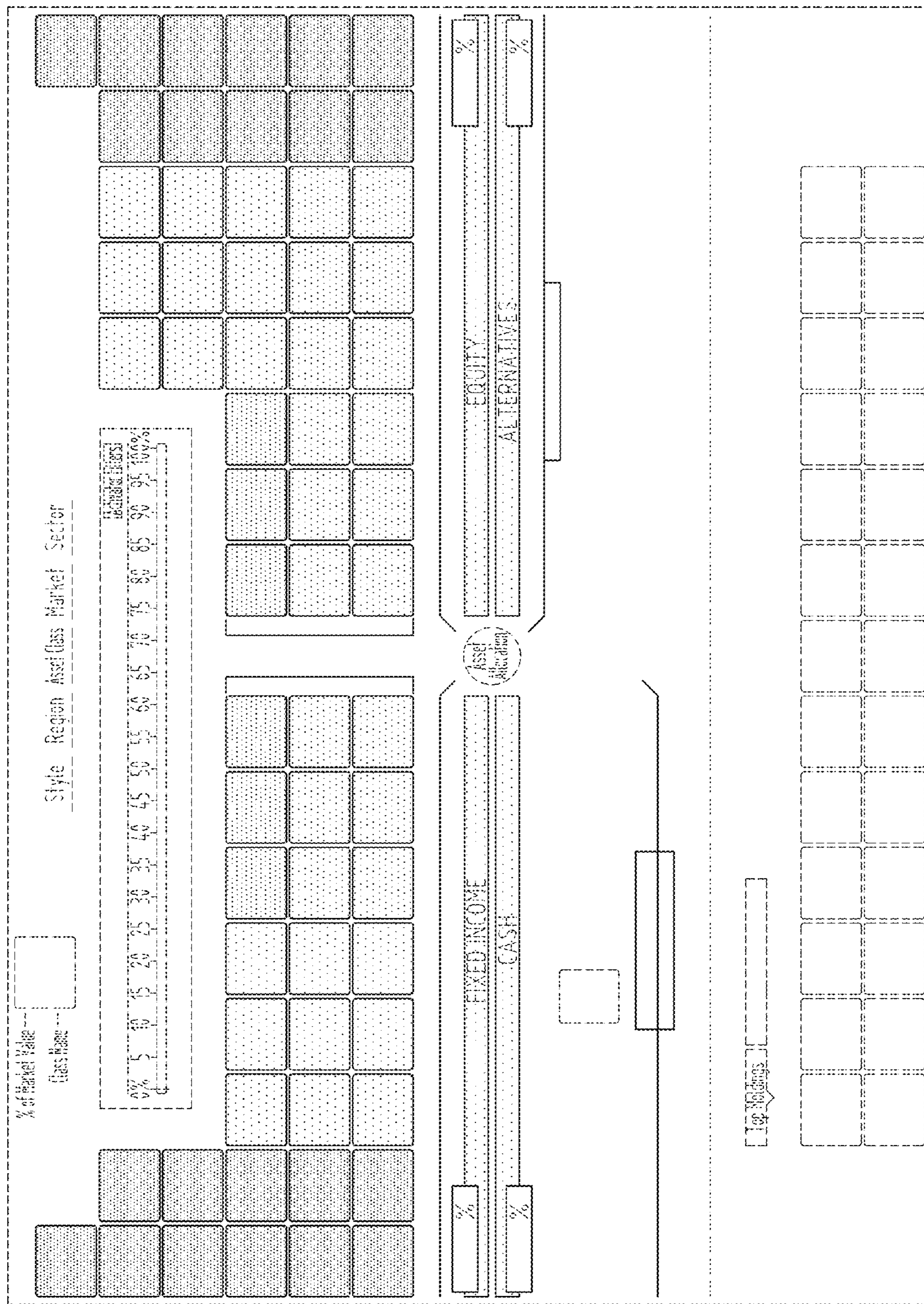

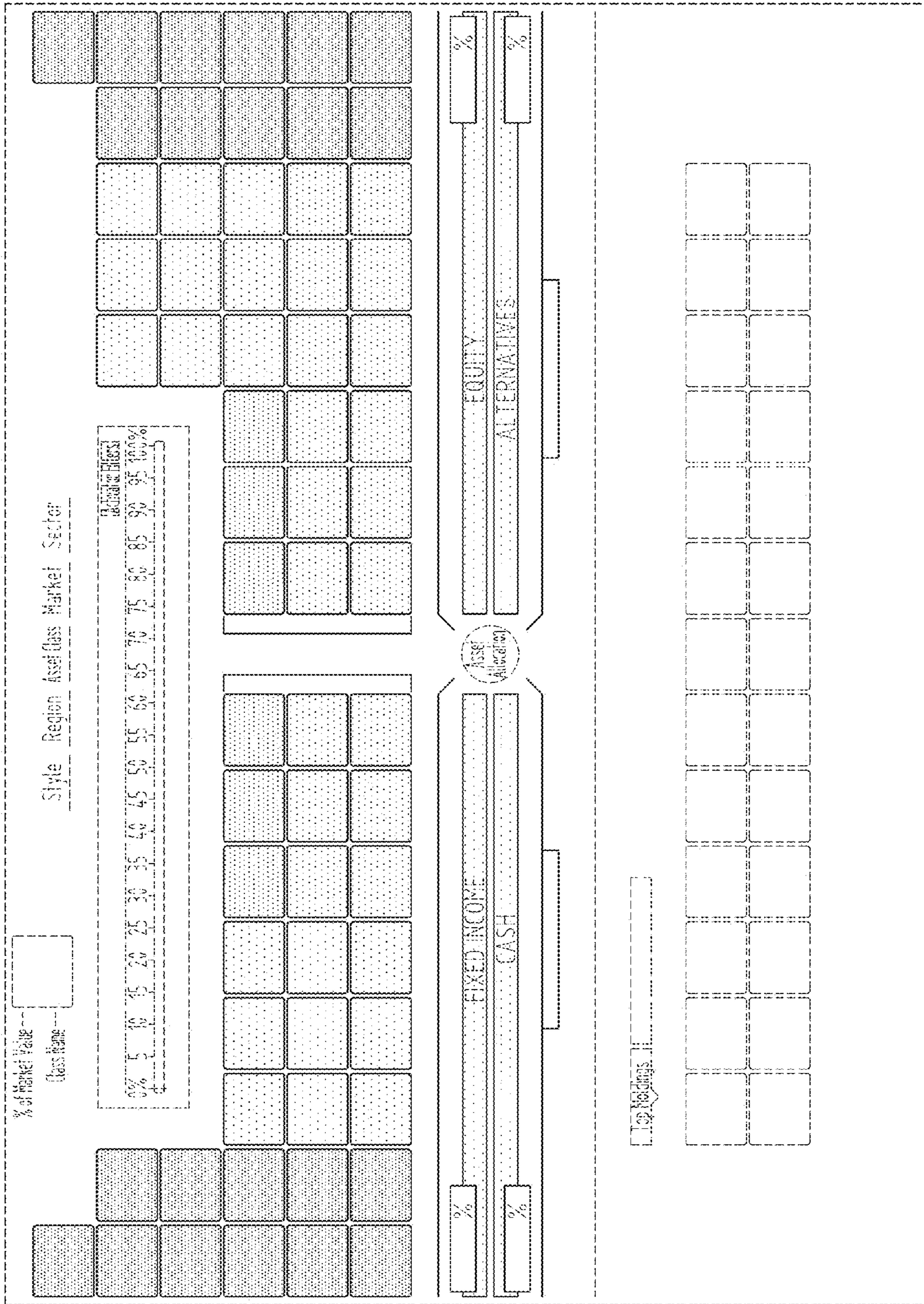

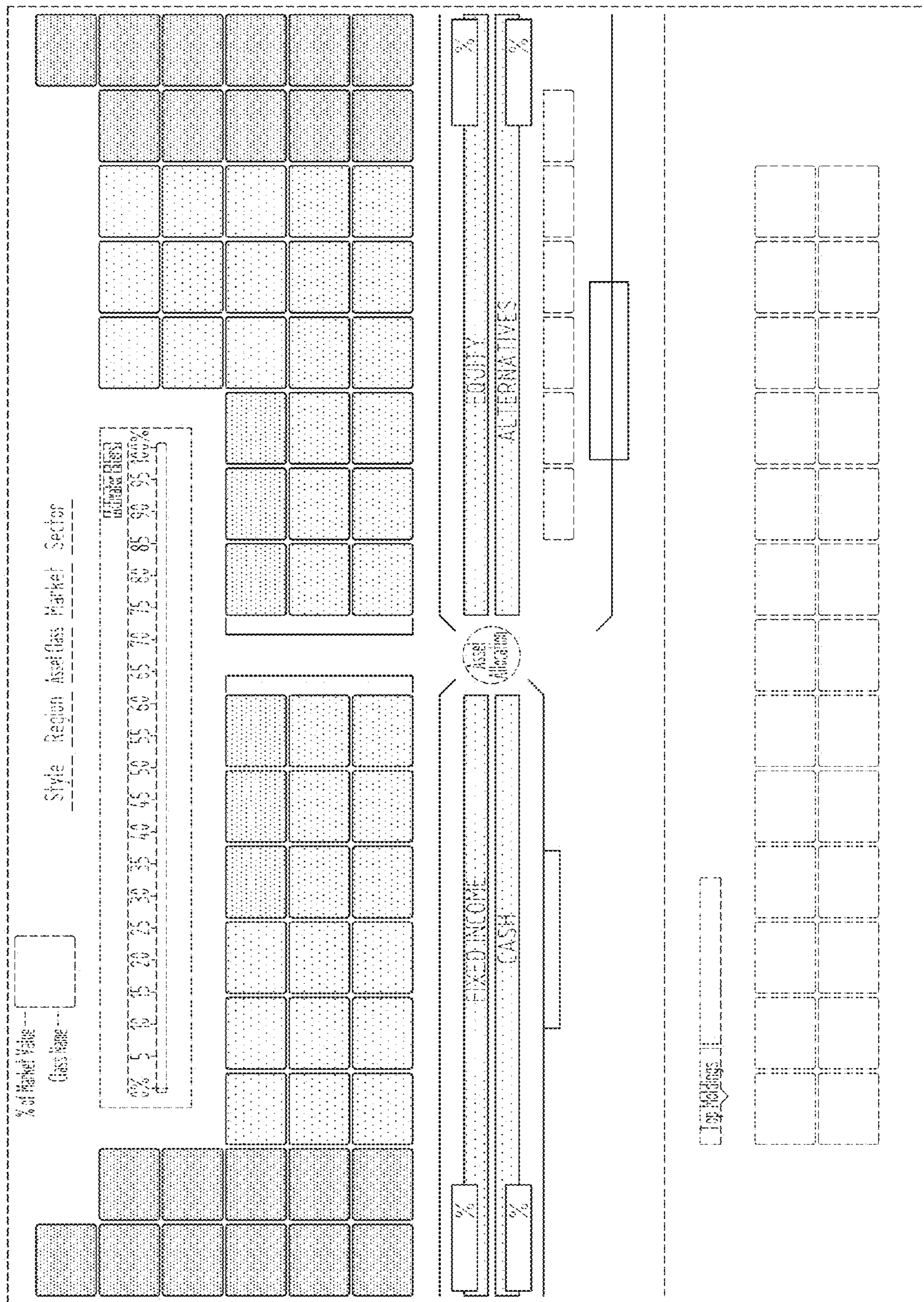

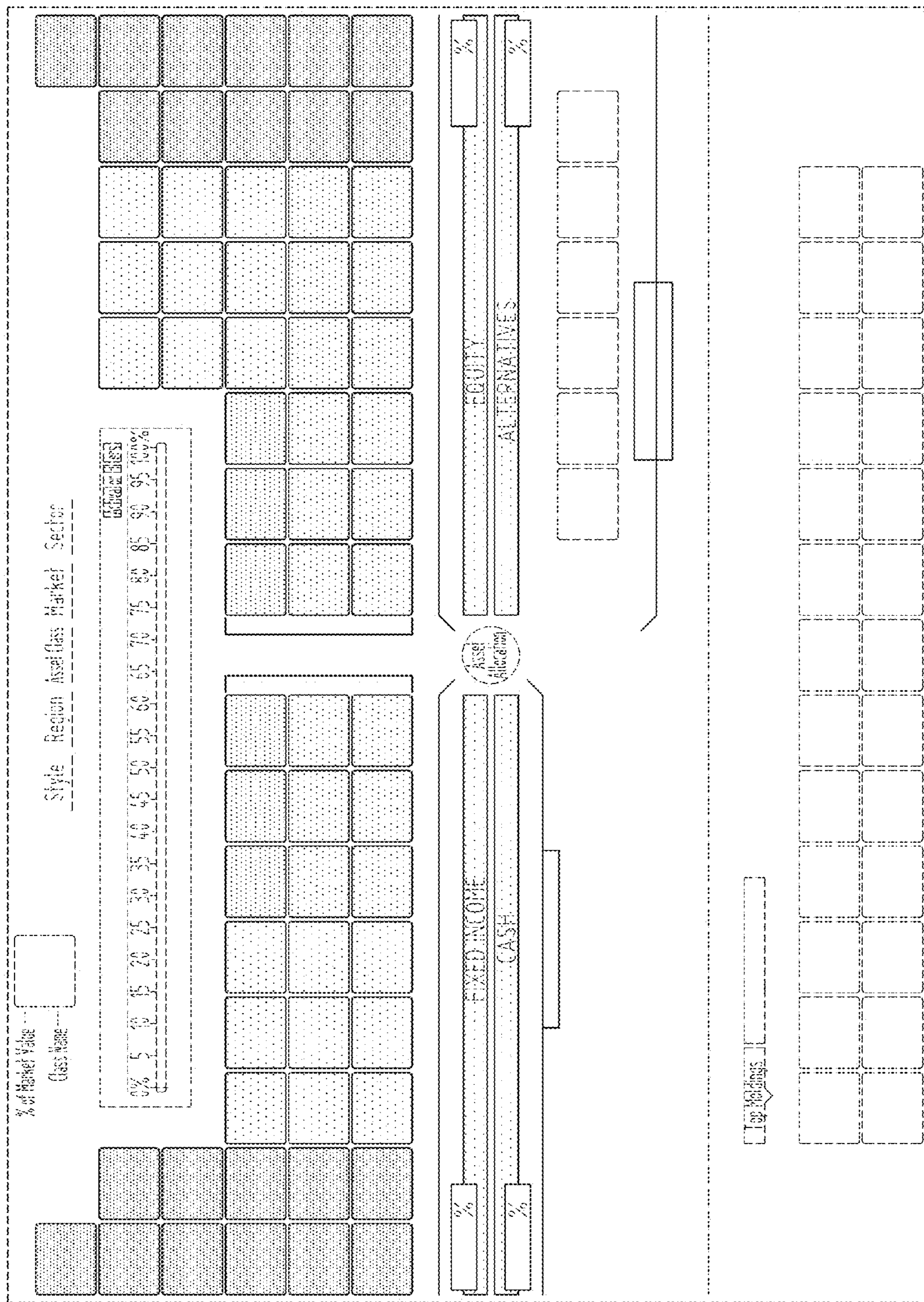
