(57) **CLAIM**

The ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 6 is the second image thereof;

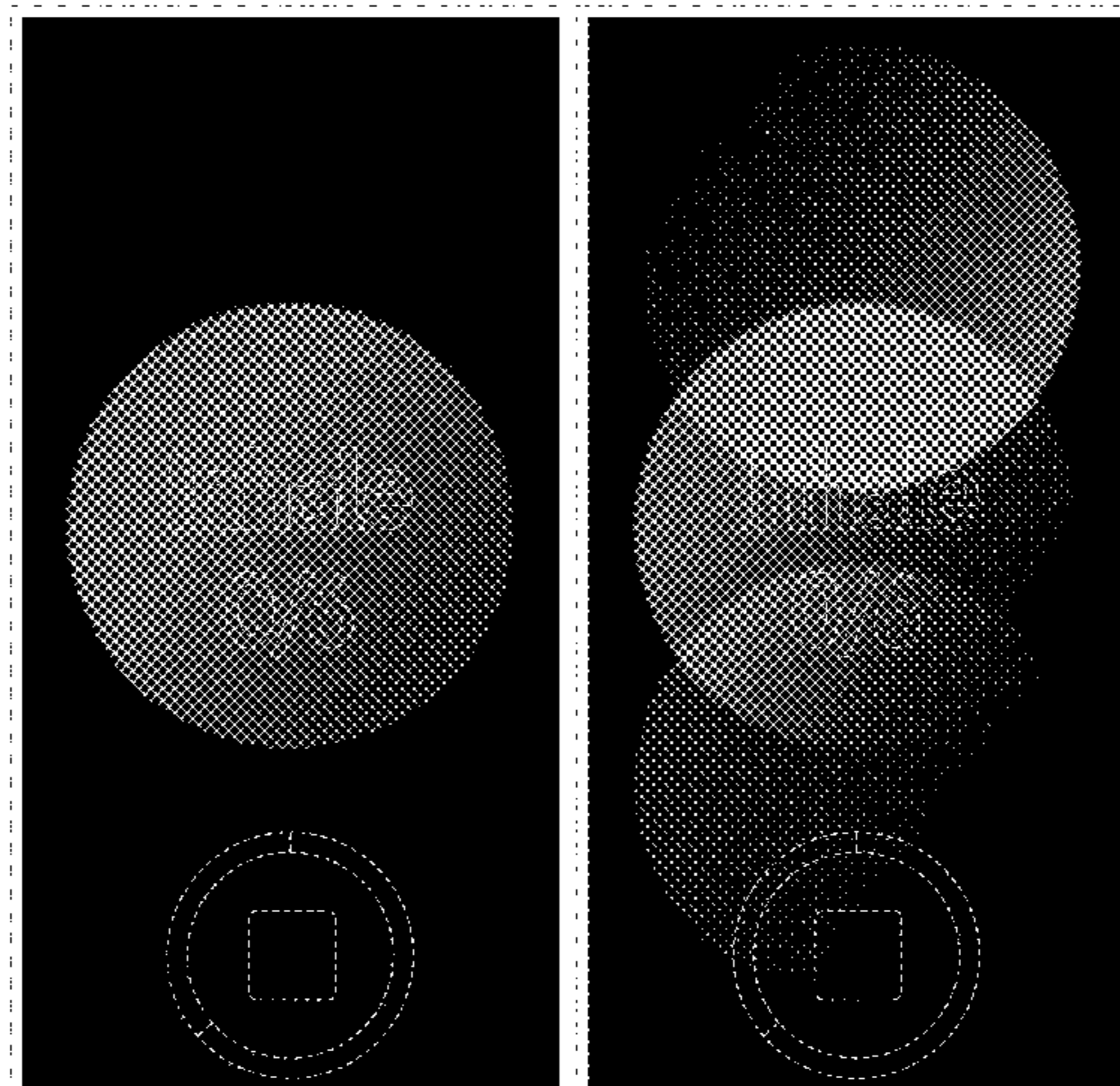
FIG. 7 is the third image thereof; and,

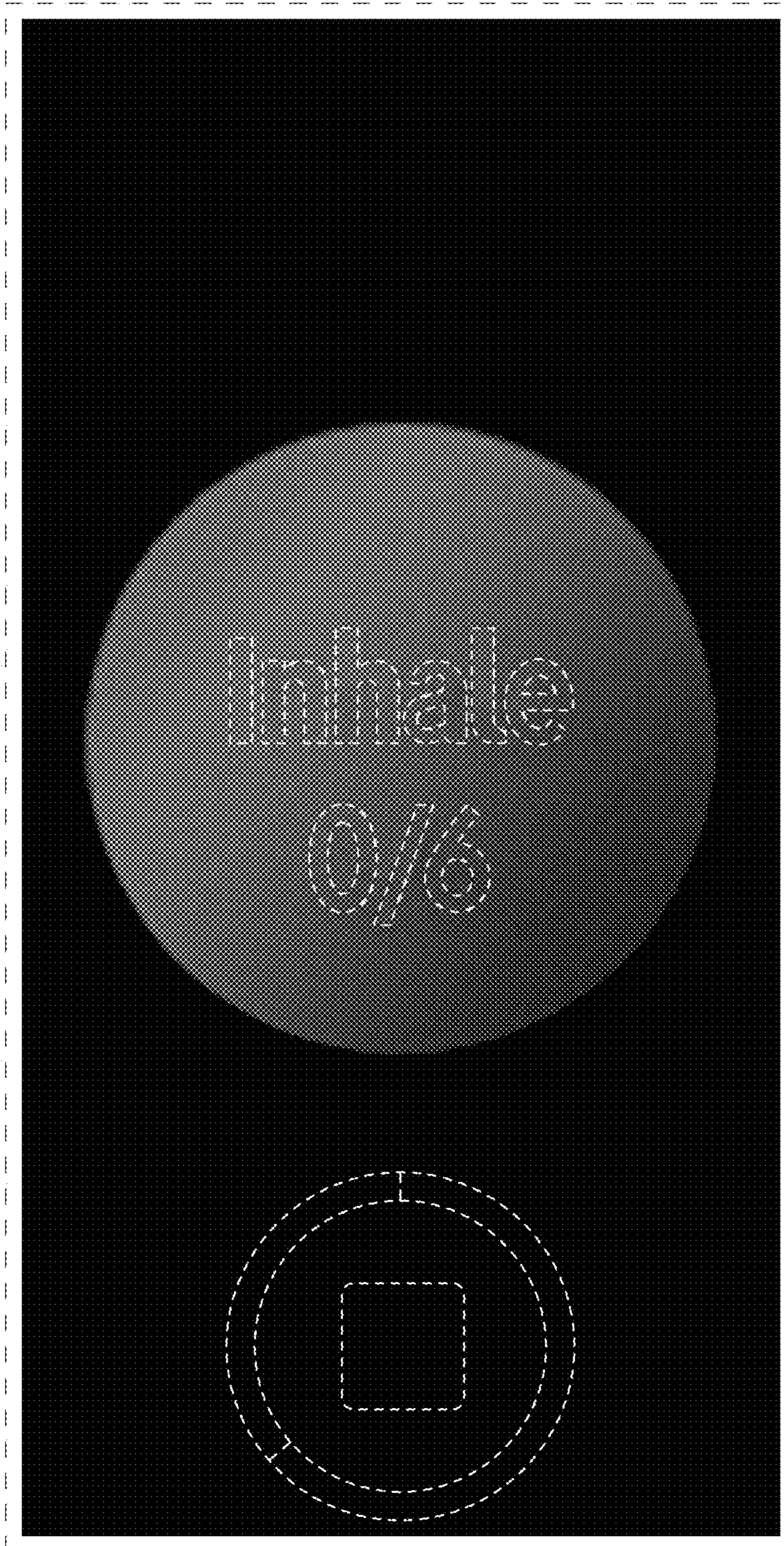

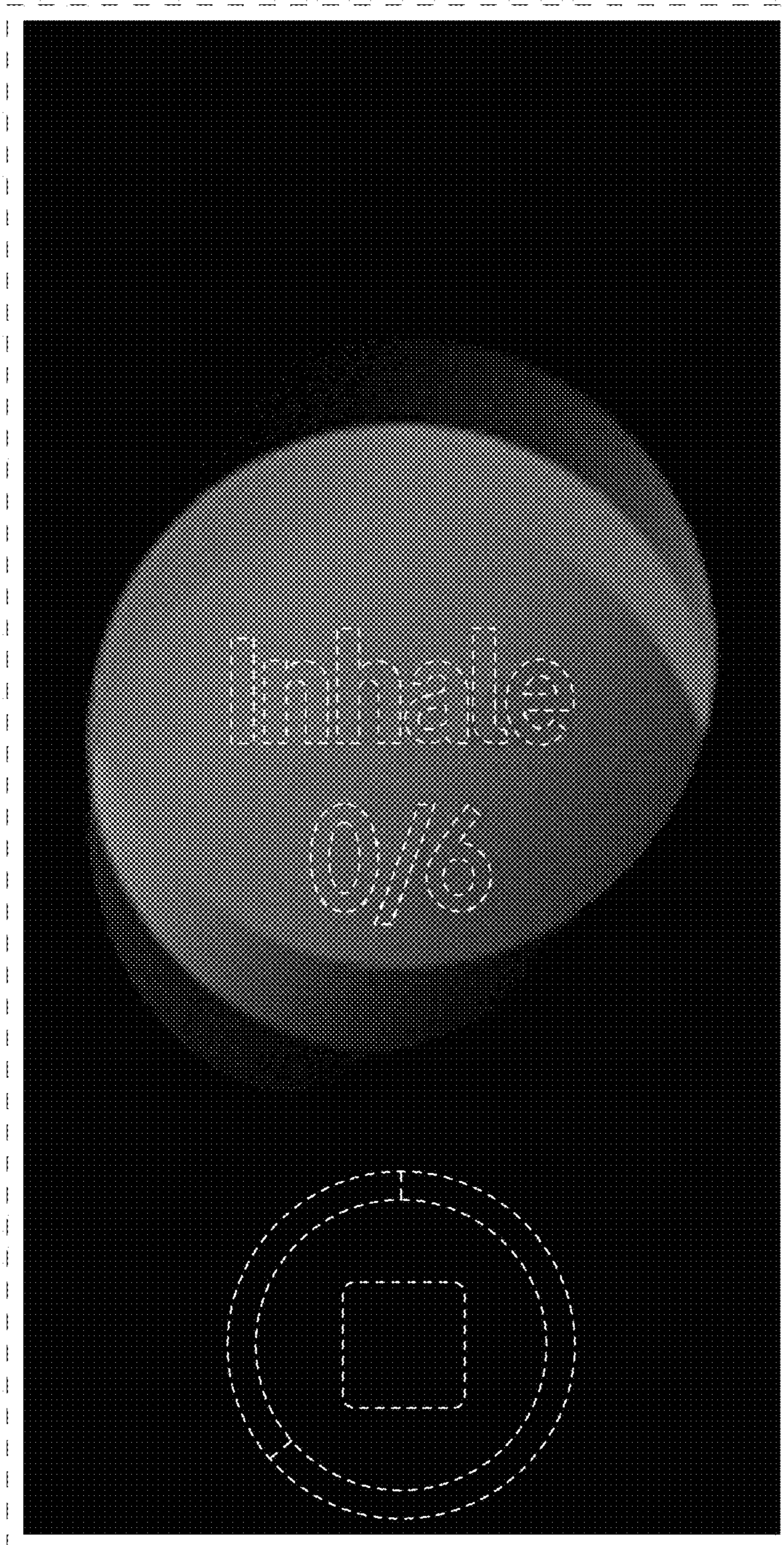

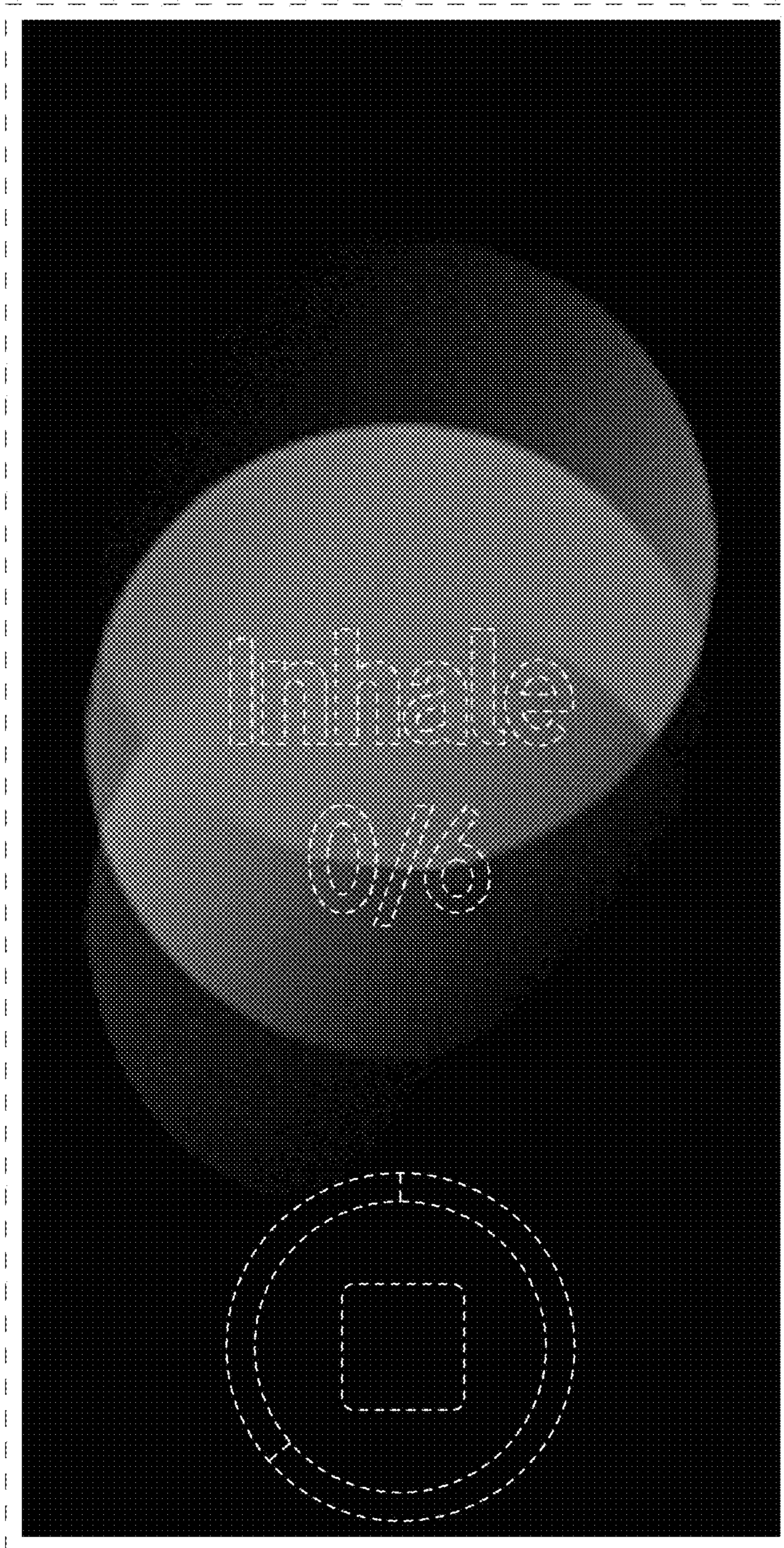

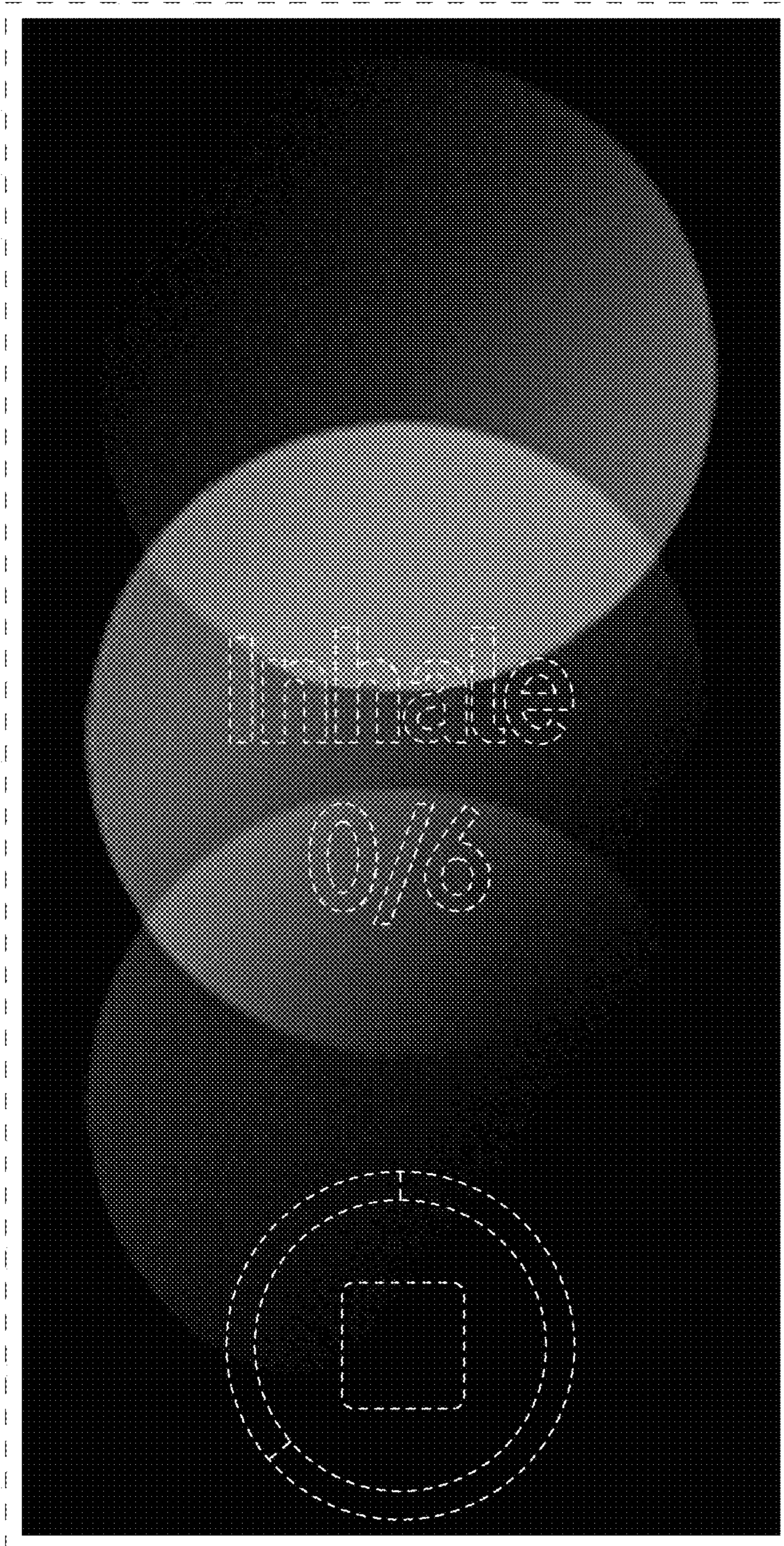

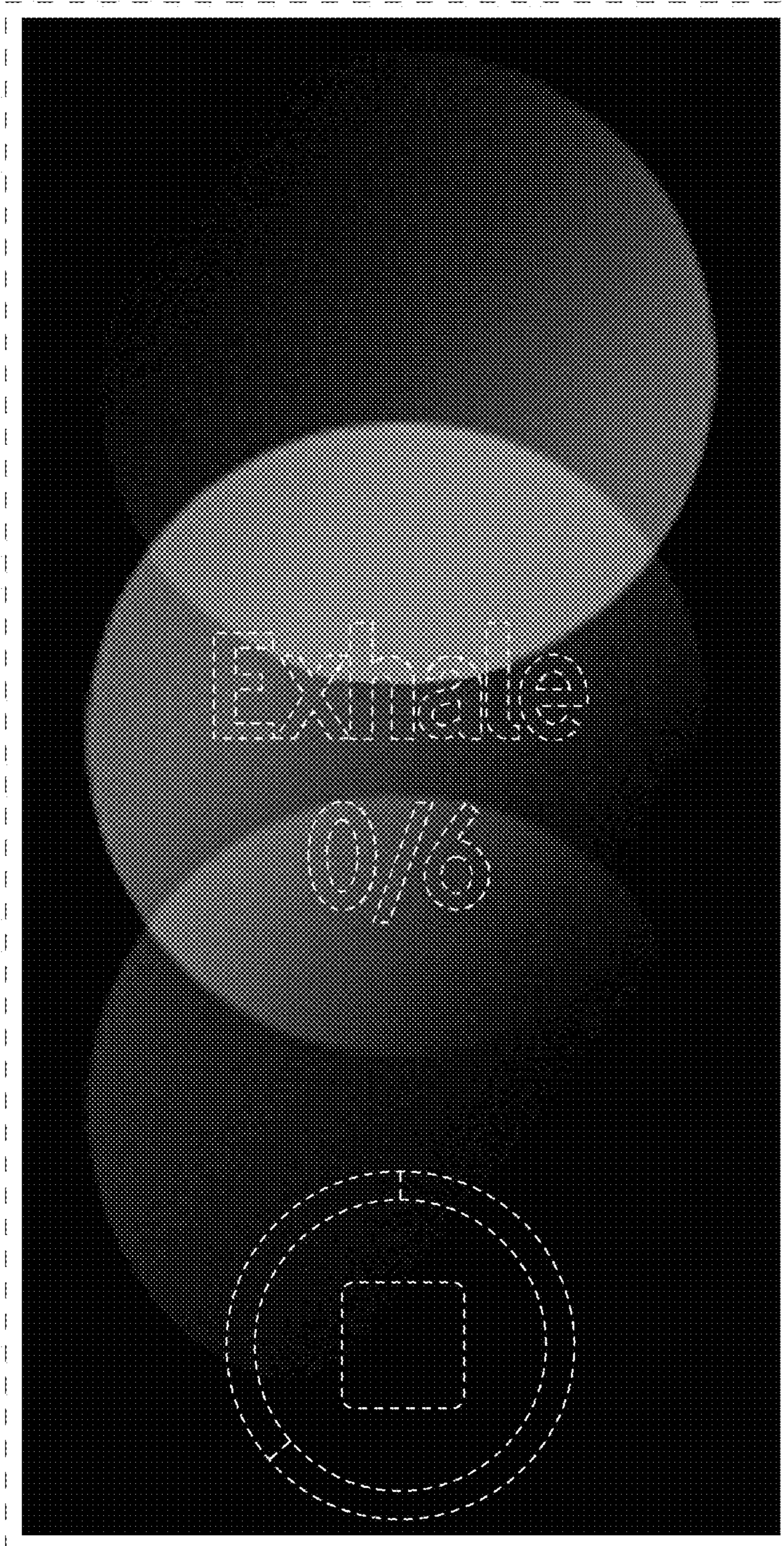

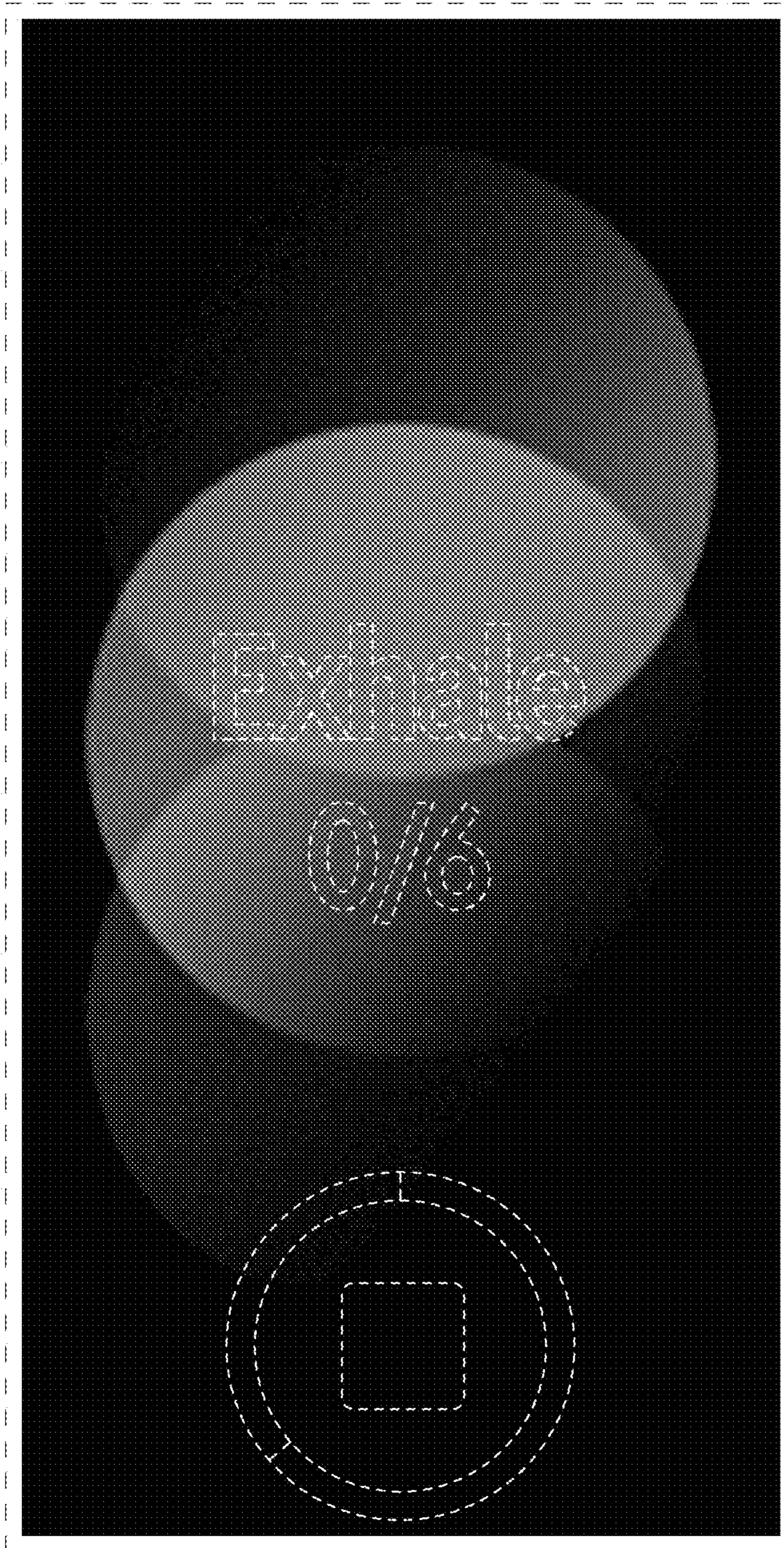

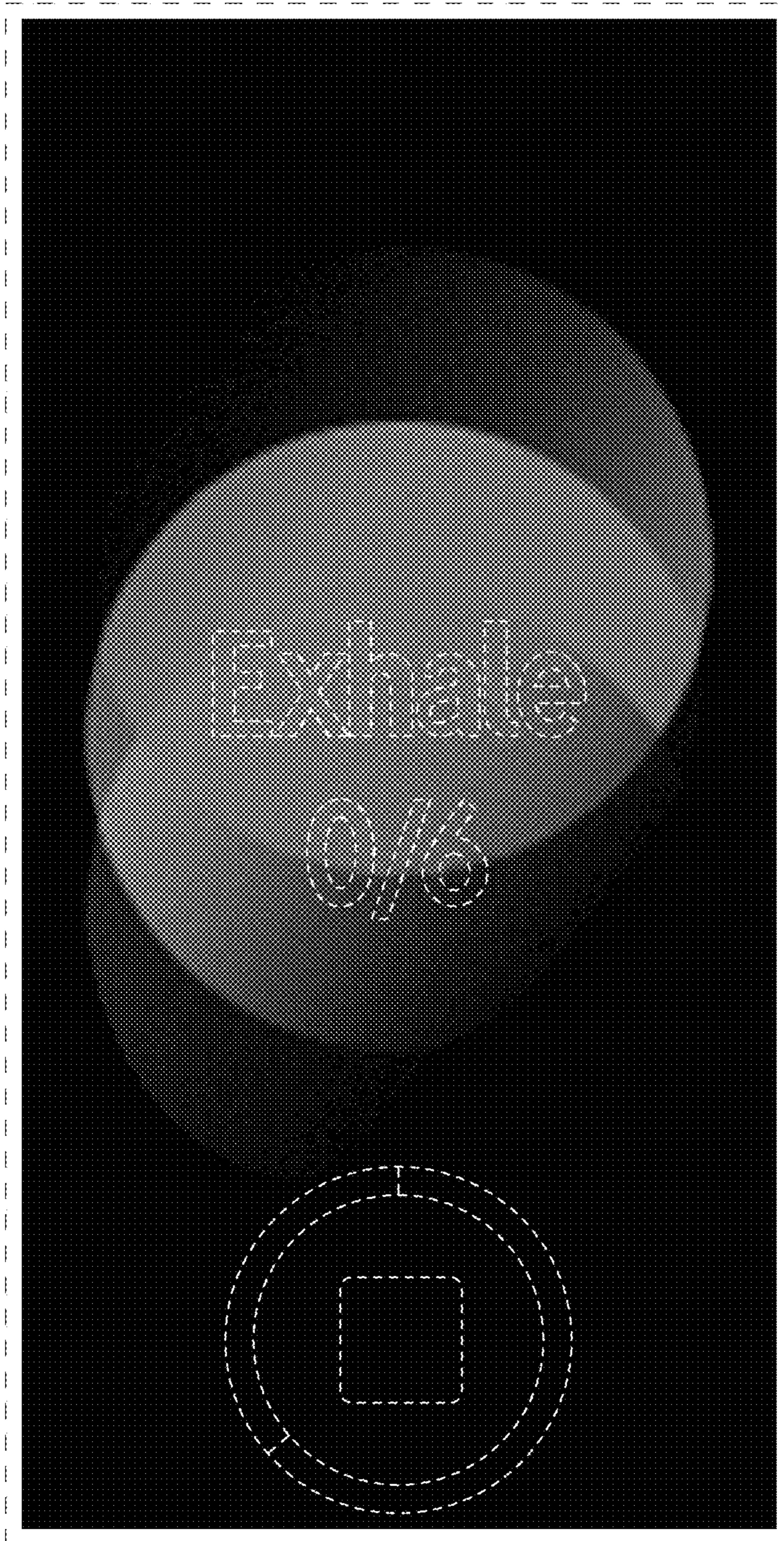
