FIG. 1 is a front view of a first embodiment of a design for a display screen or portion thereof with graphical user interface;

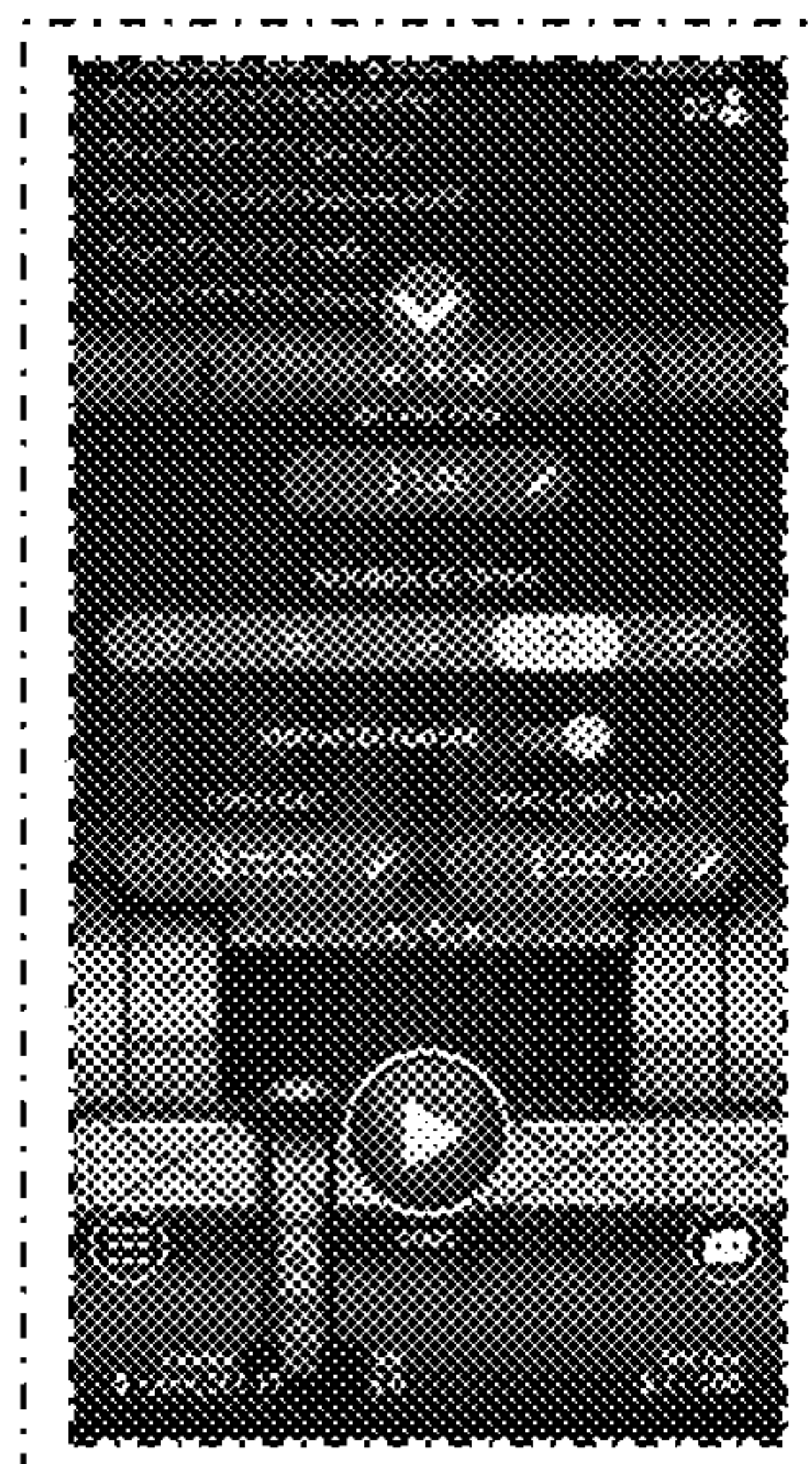
FIG. 2 is a front view of a second embodiment of a design for a display screen or portion thereof with graphical user interface;

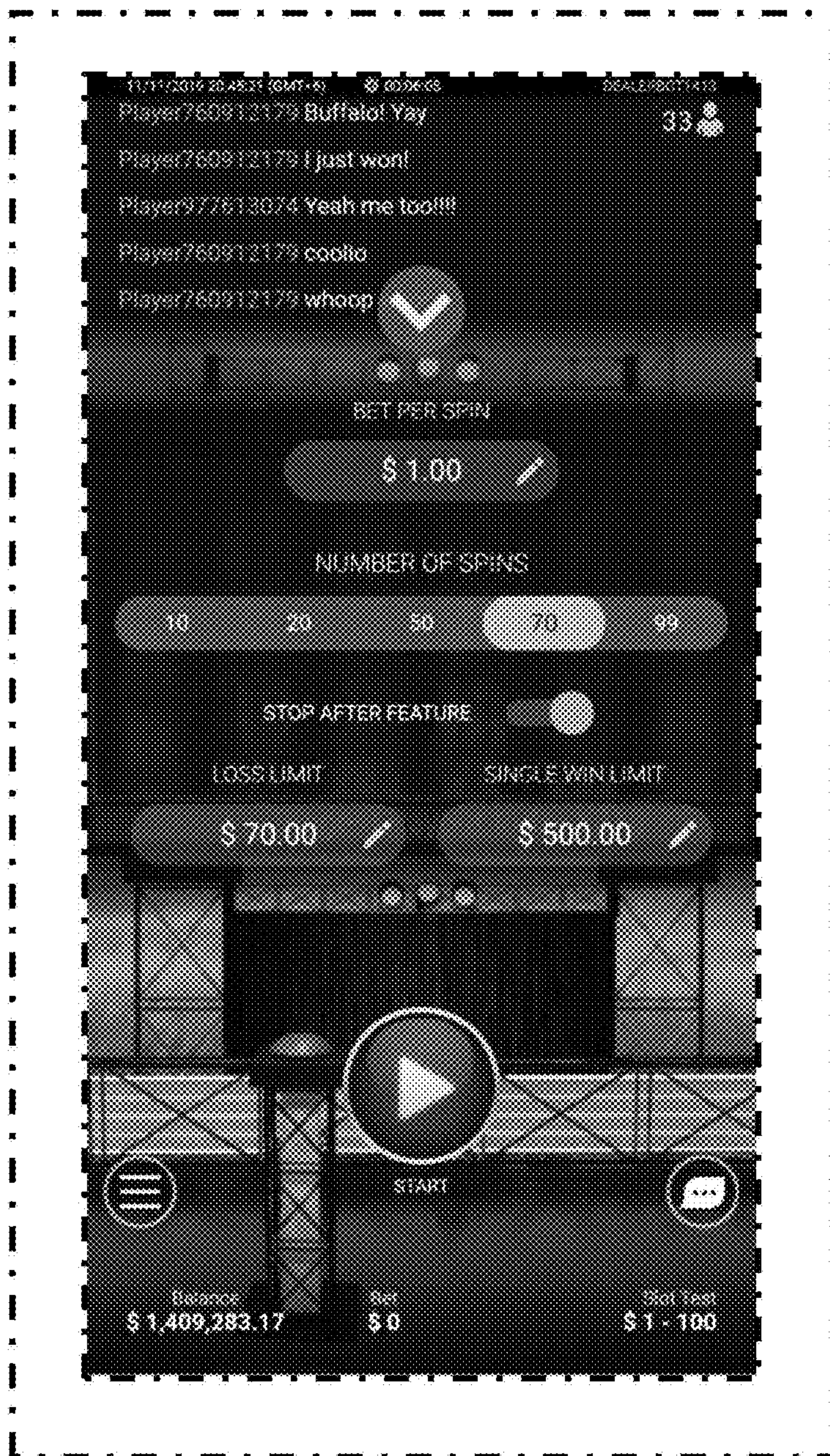

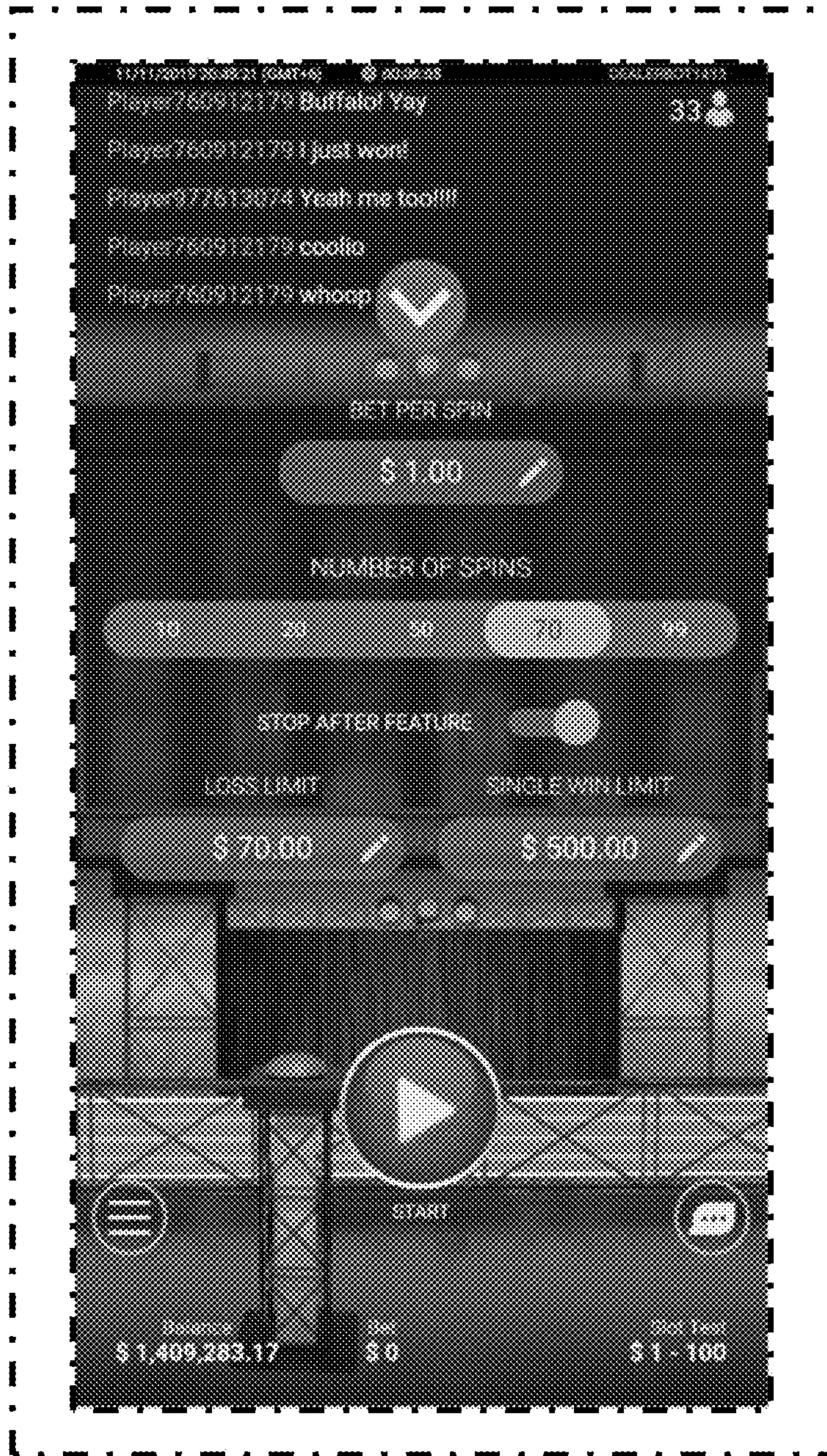

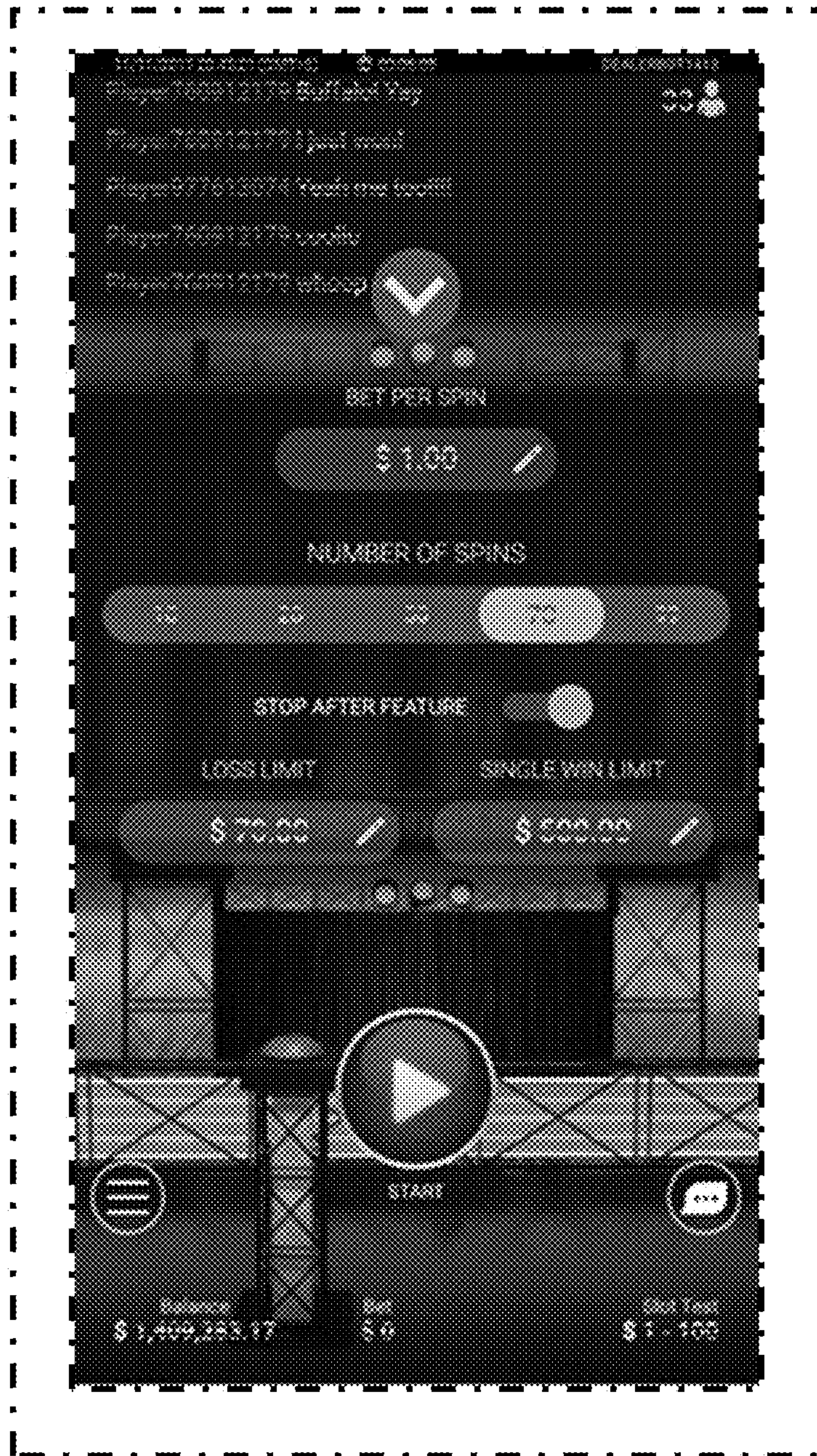

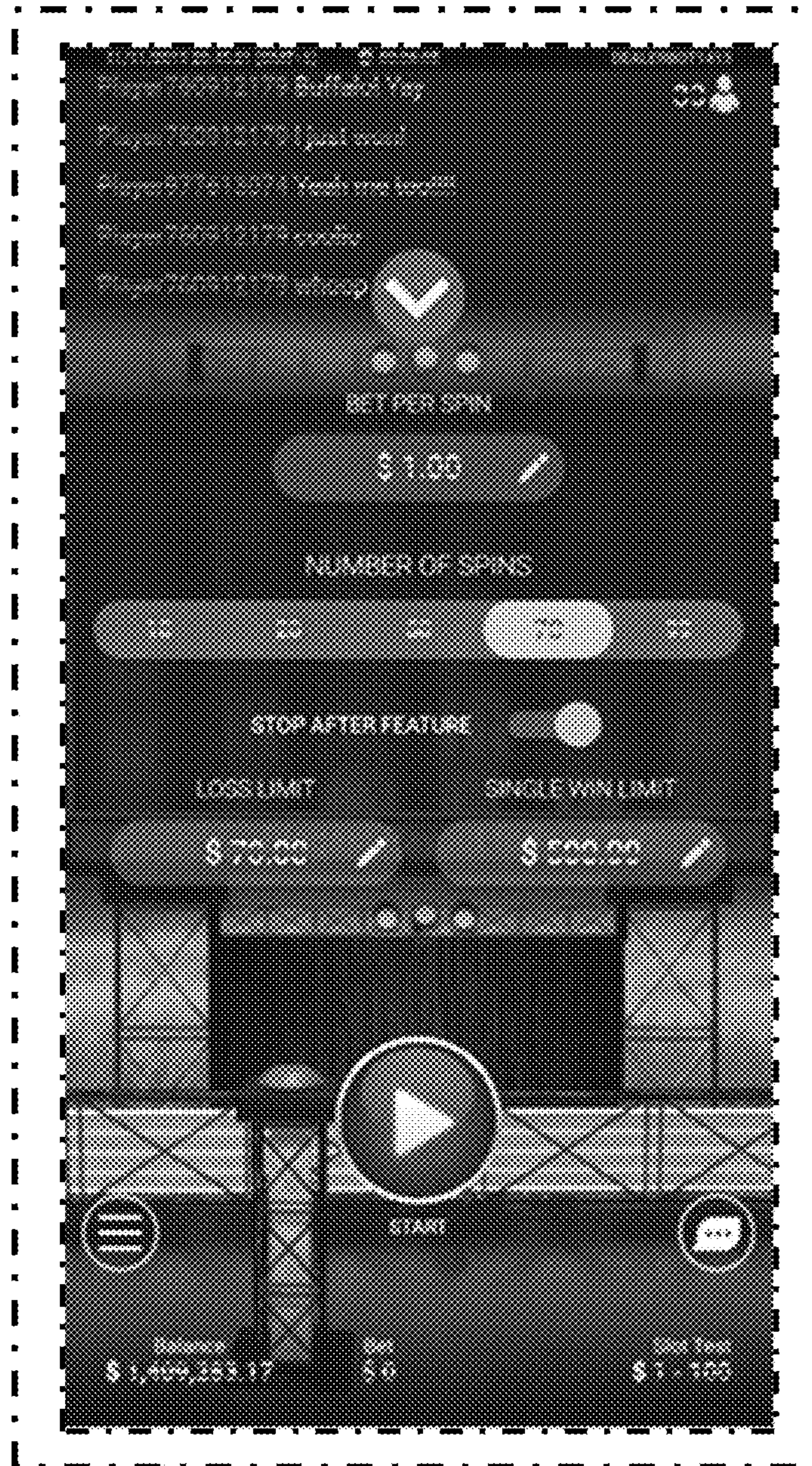
