The ornamental design for a display screen or portion thereof with icon set, as shown and described.

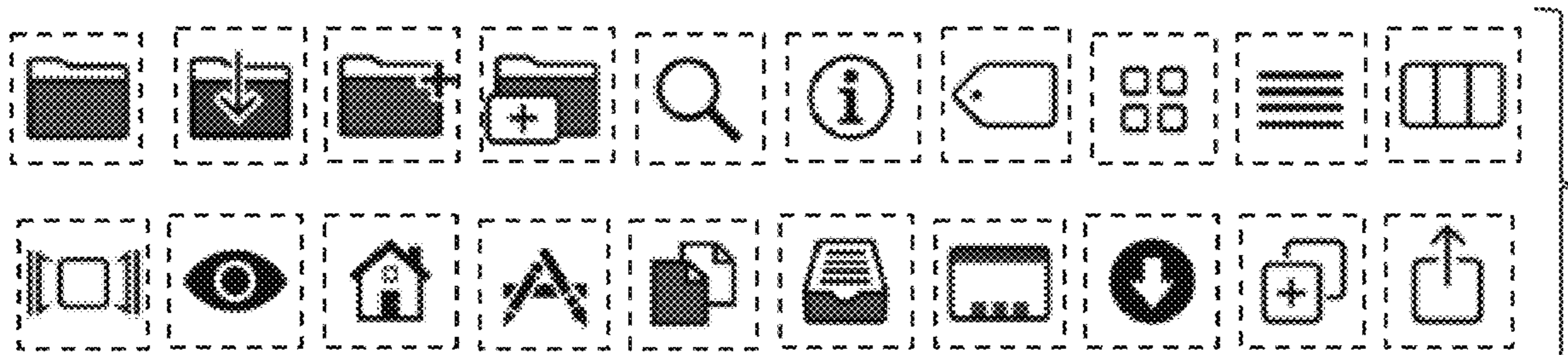
DESCRIPTION
