(57) **CLAIM**

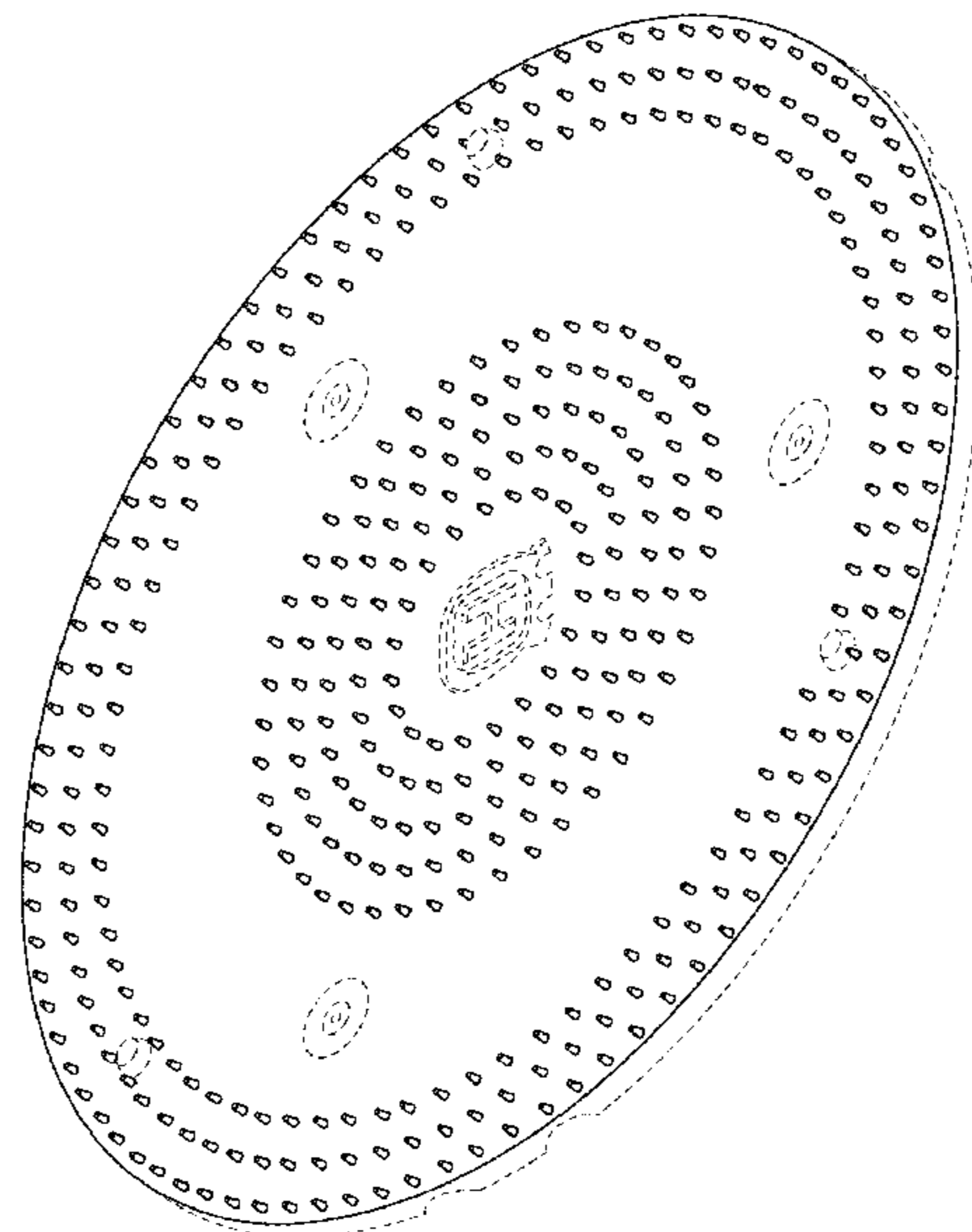
The ornamental design for a power trowel tool attachment, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a power trowel tool attachment embodying our new design;
 FIG. 2 is a top plan view thereof;
 FIG. 3 is a bottom plan view thereof; and
 FIG. 4 is a side elevation view thereof; and,
 FIG. 5 is an enlarged perspective view of a portion of FIG. 1.

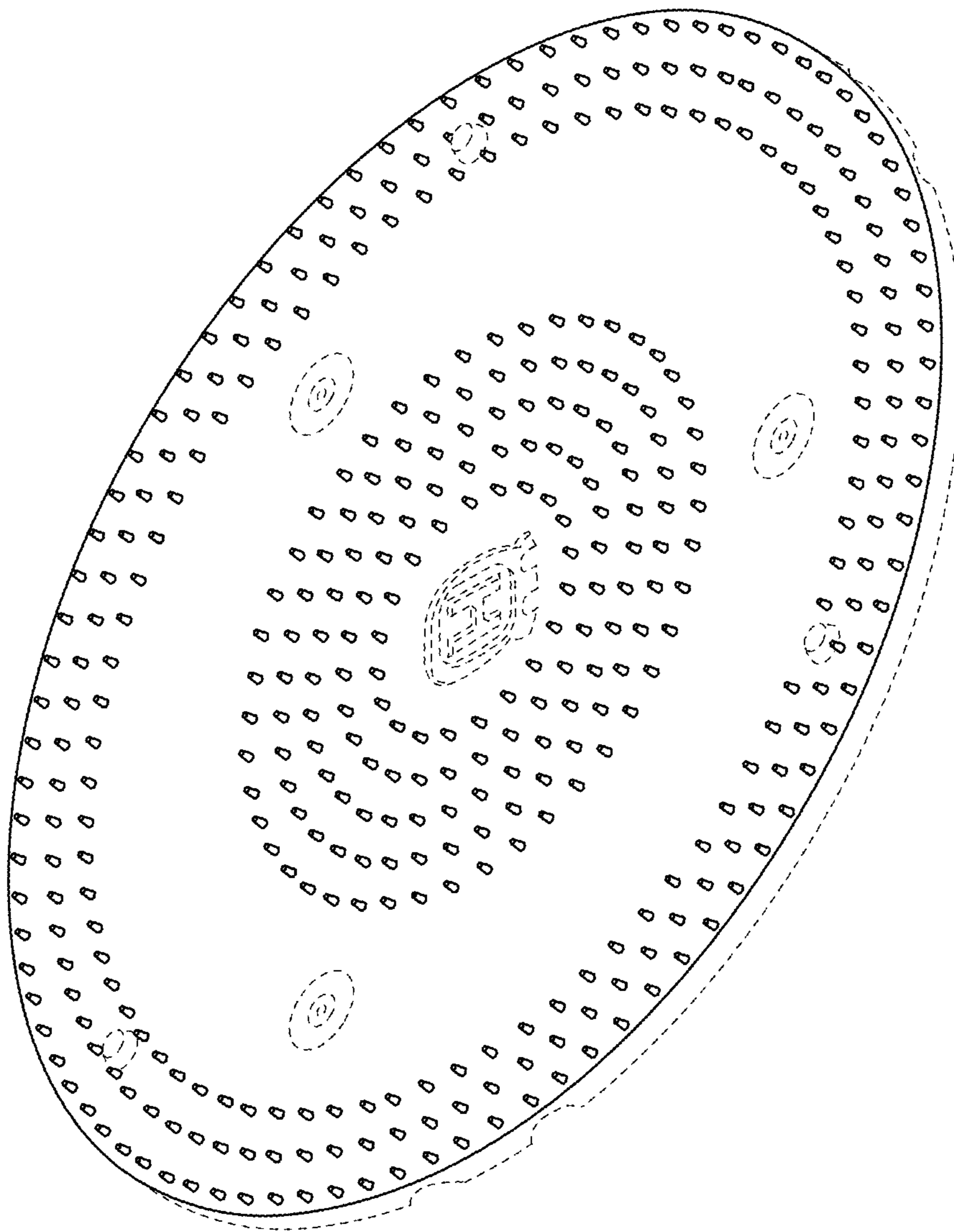

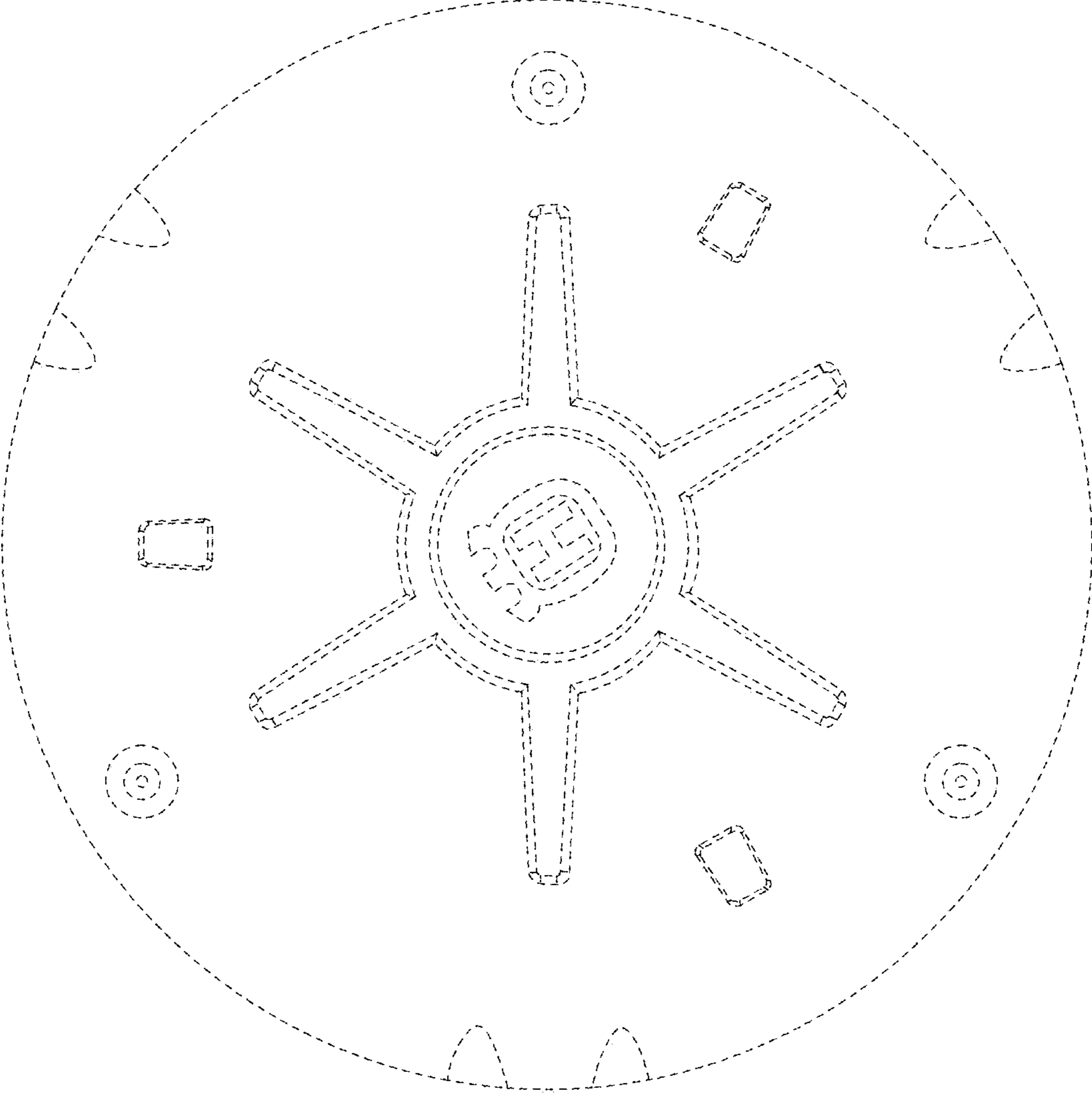

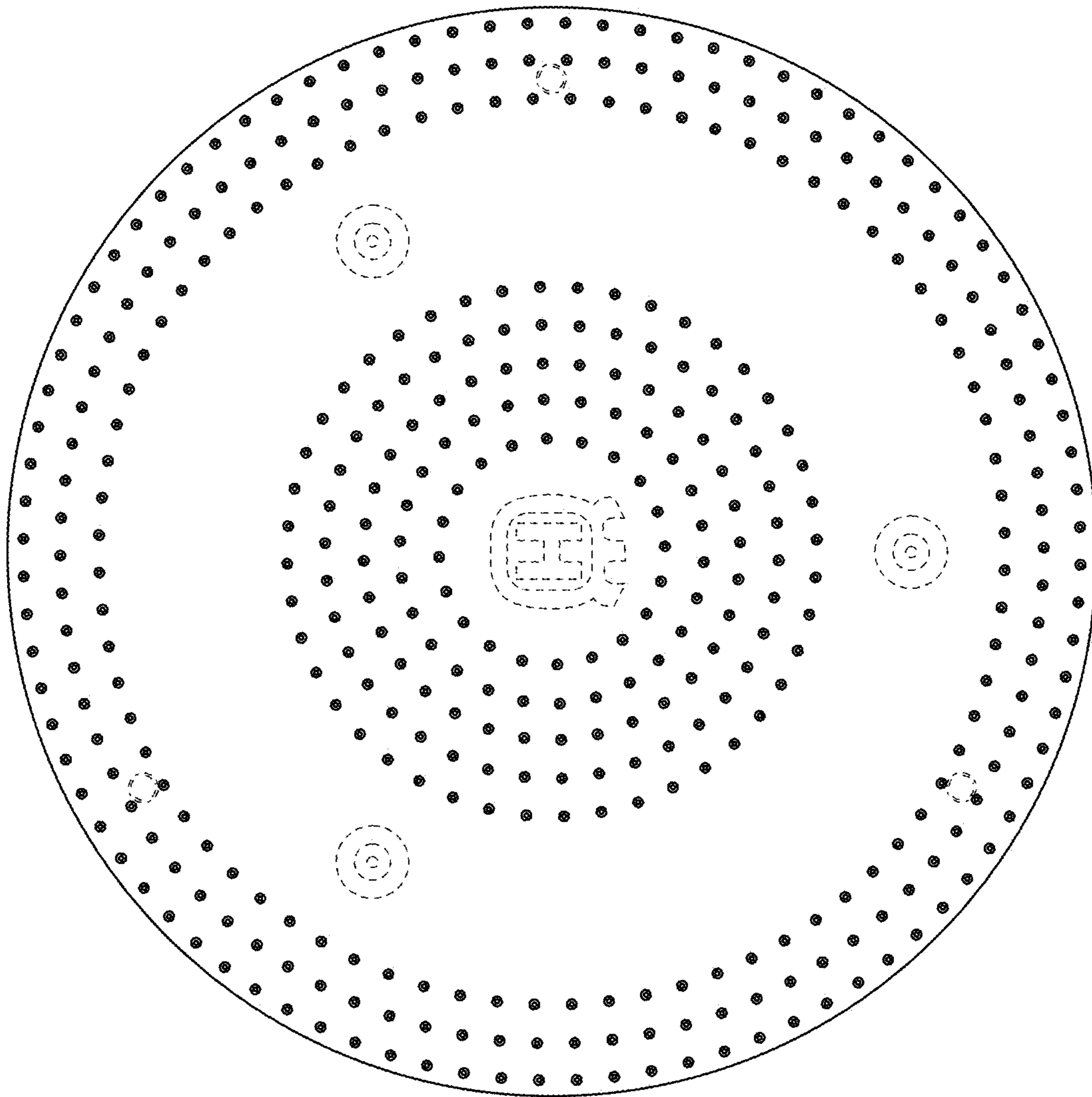

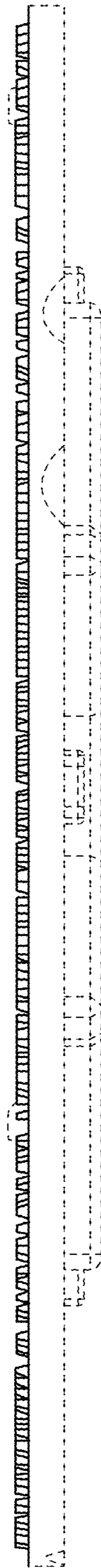

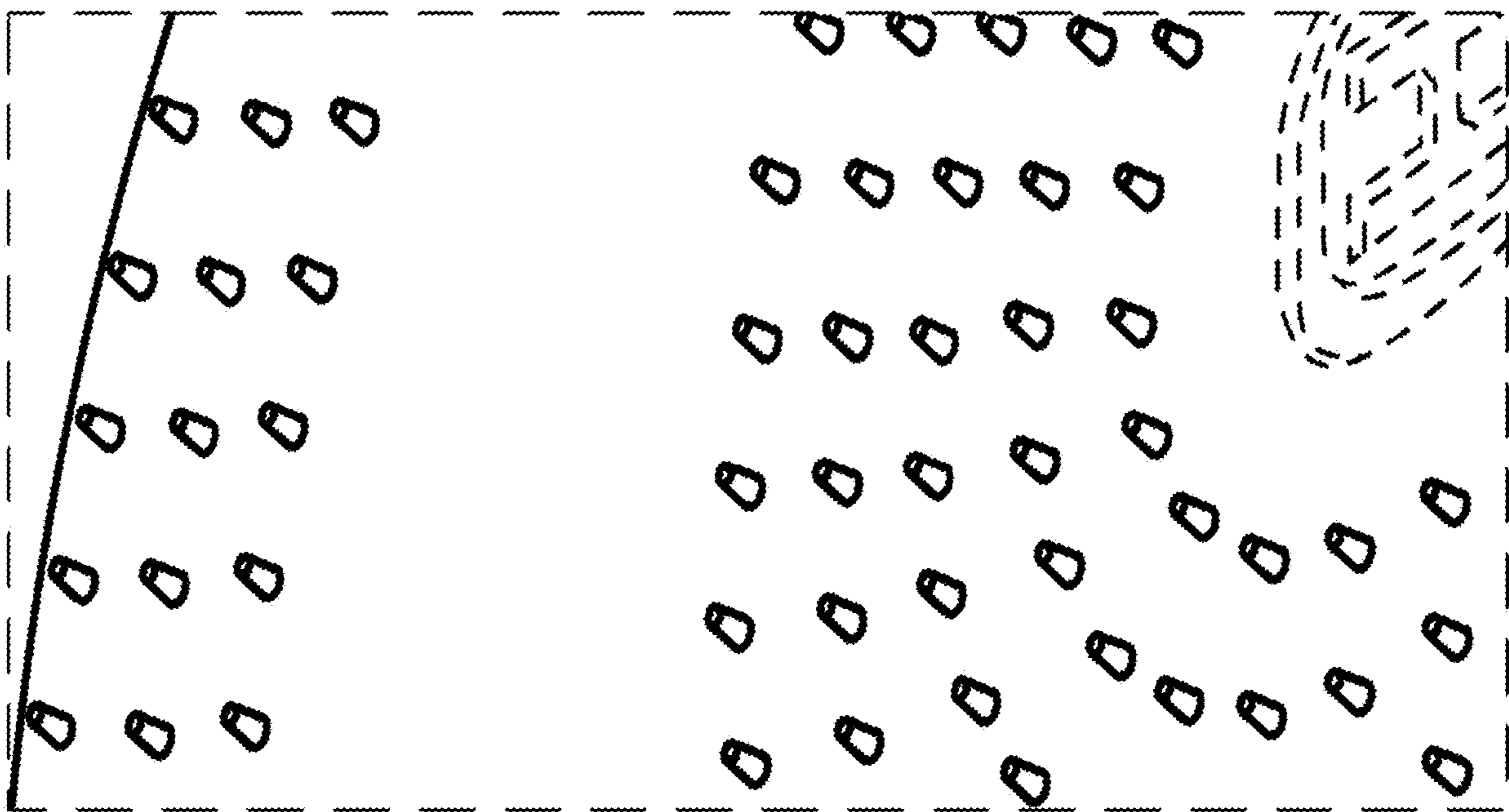
