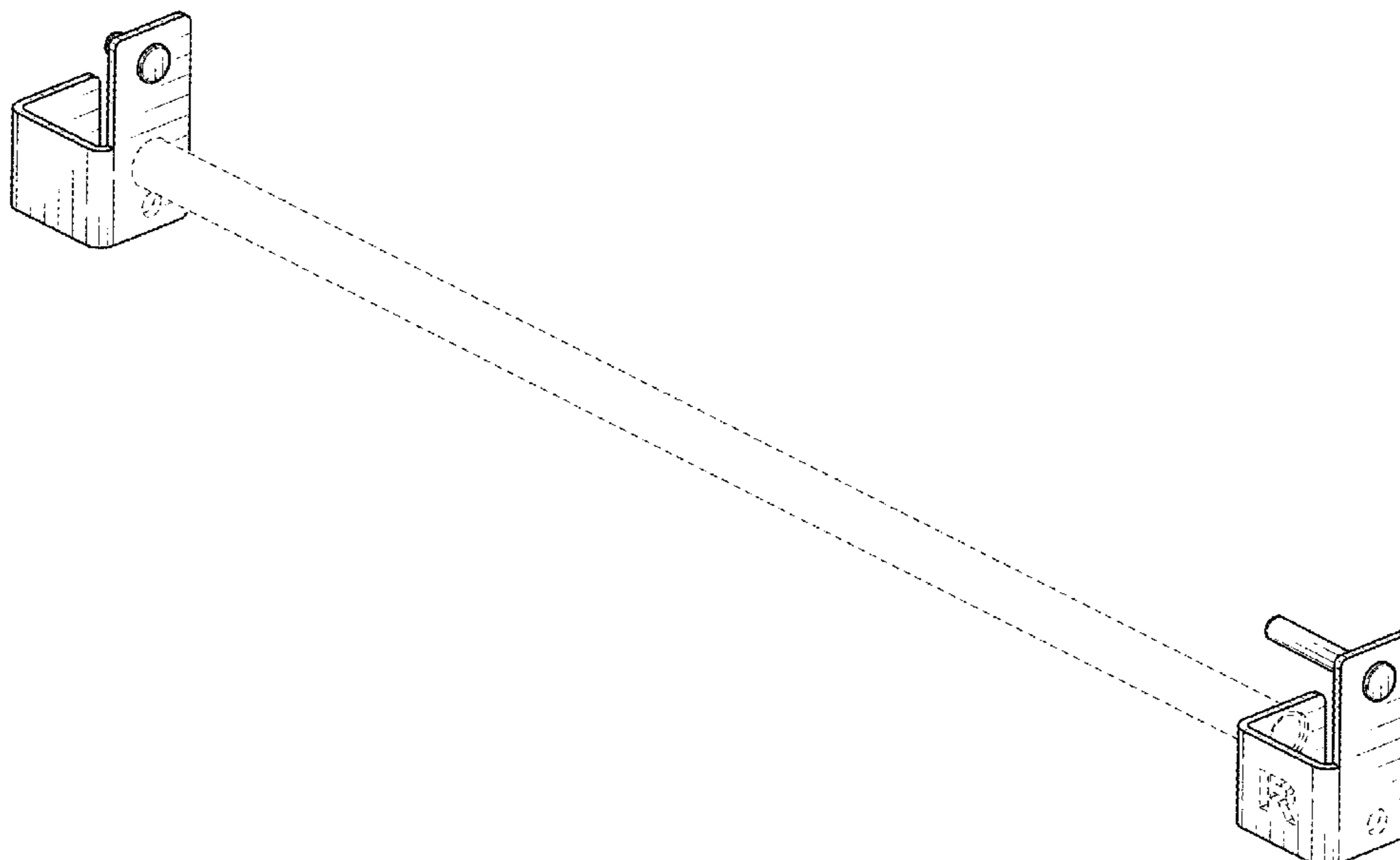
(57) **CLAIM**

The ornamental design for a pull up bar attachment, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, left perspective view of a pull up bar attachment showing our new design;
FIG. 2 is a top, rear, right perspective view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a top view thereof; and,
FIG. 8 is a bottom view thereof.
The broken lines in the drawings show portions of the pull up bar attachment that form no part of the claimed design.

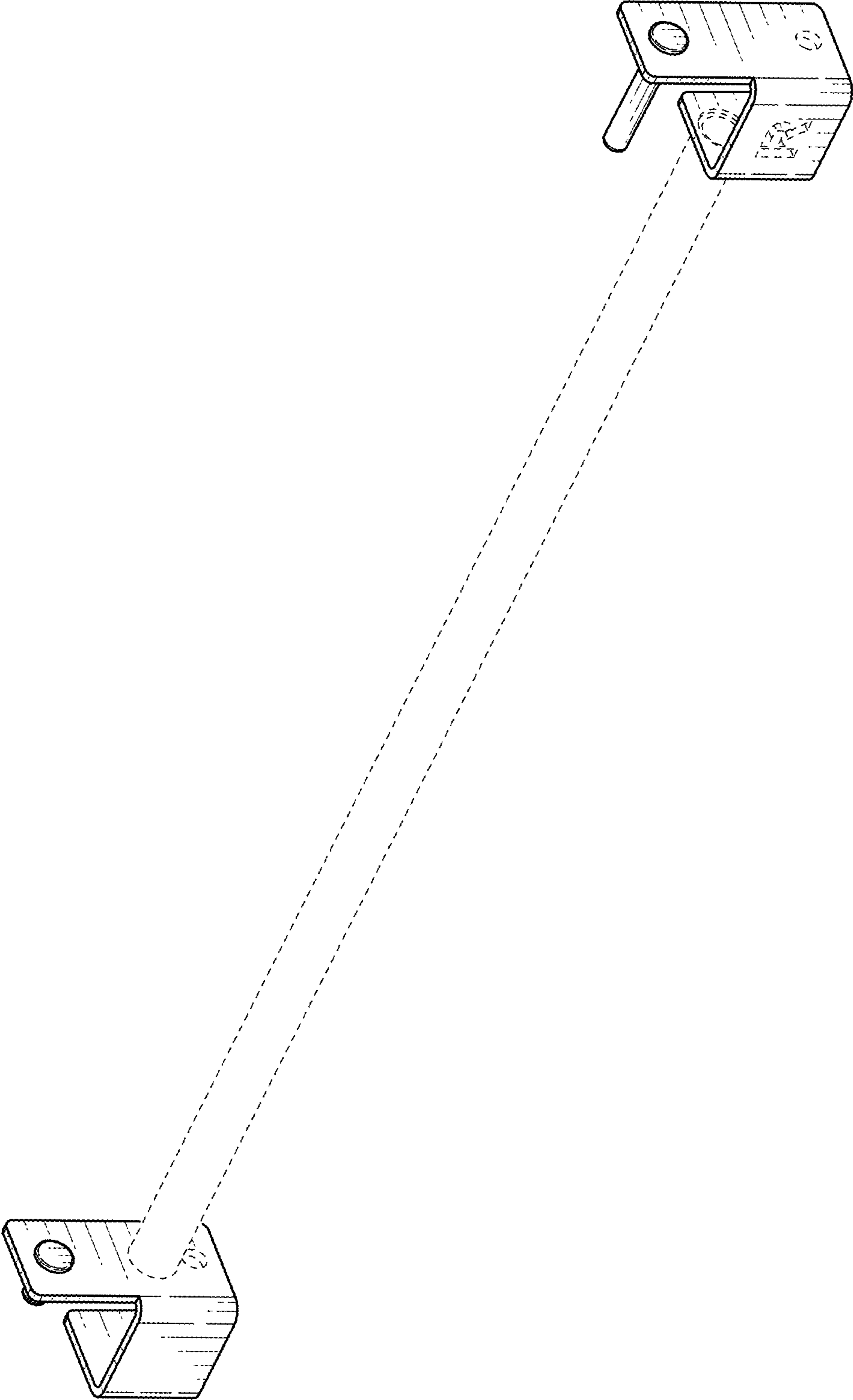

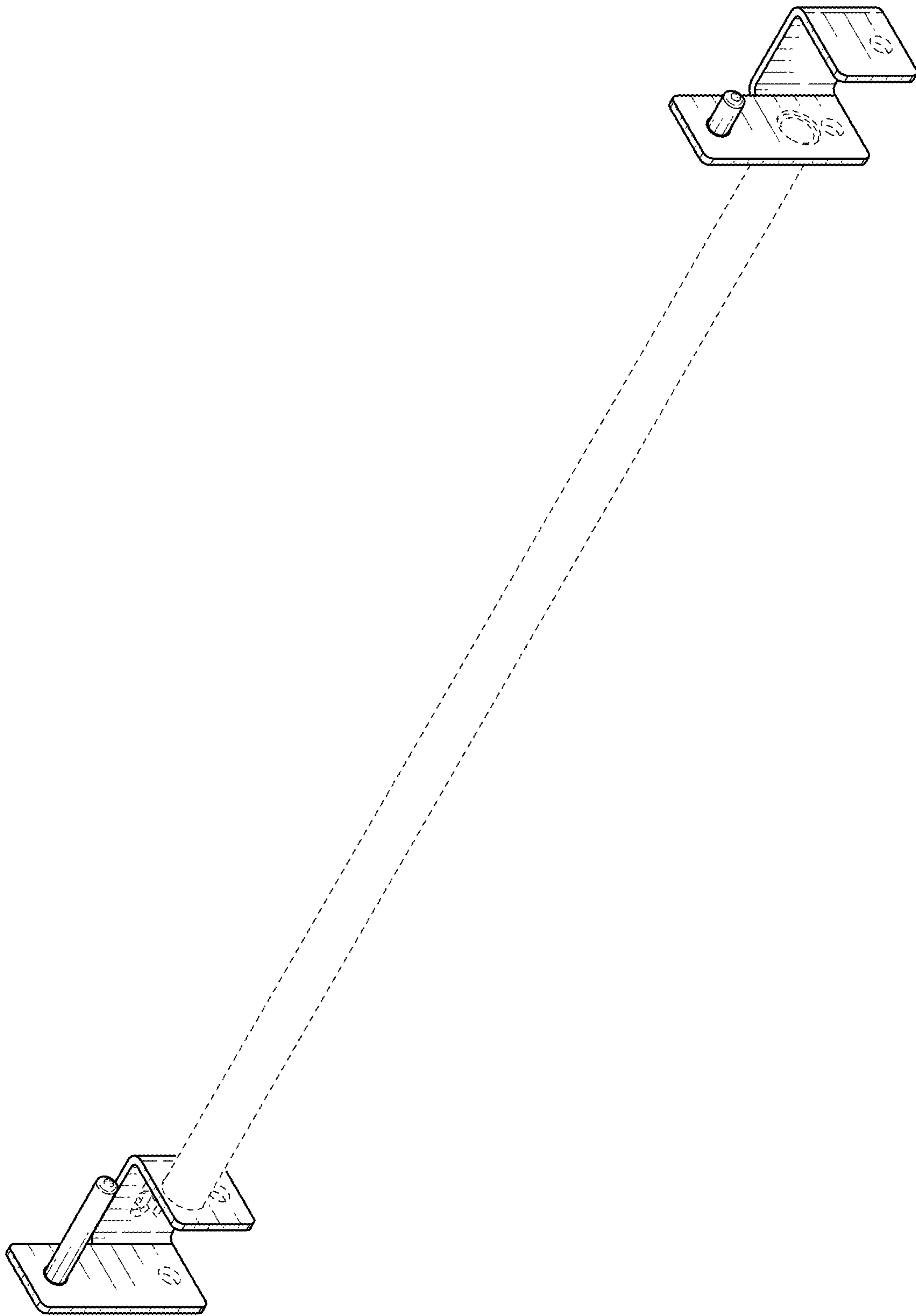

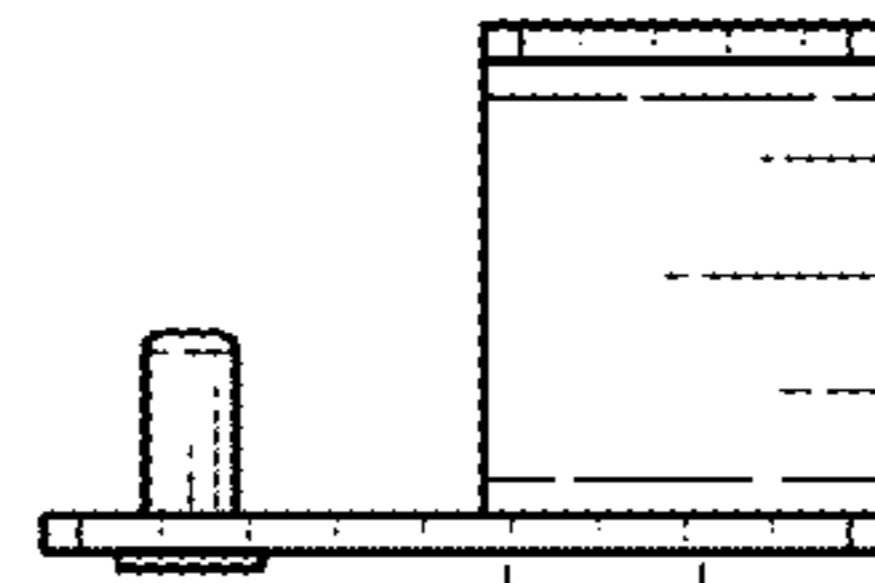
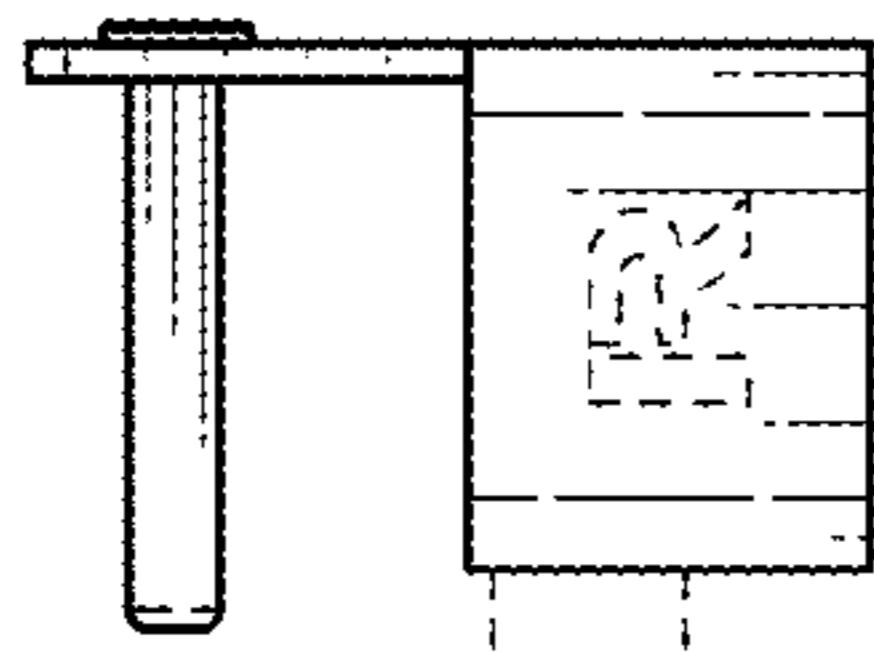
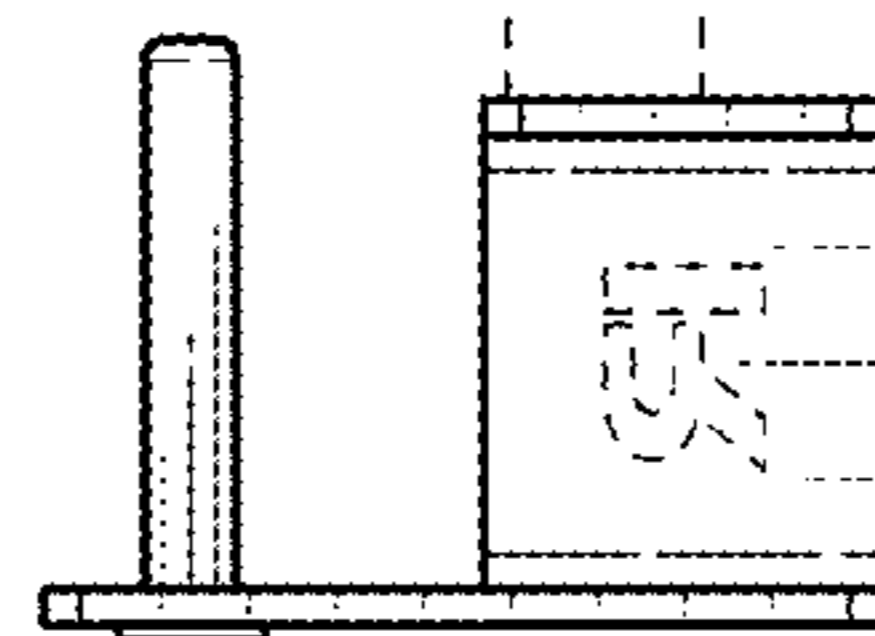
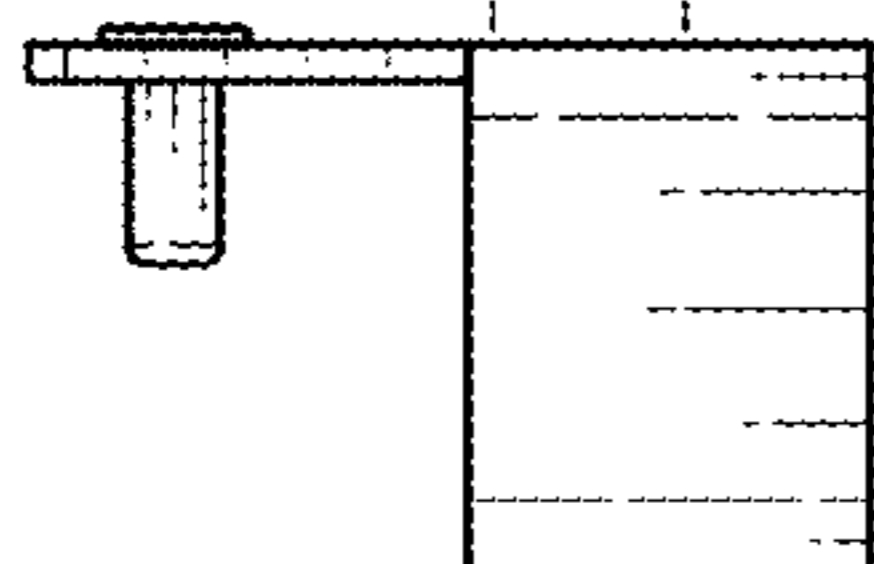

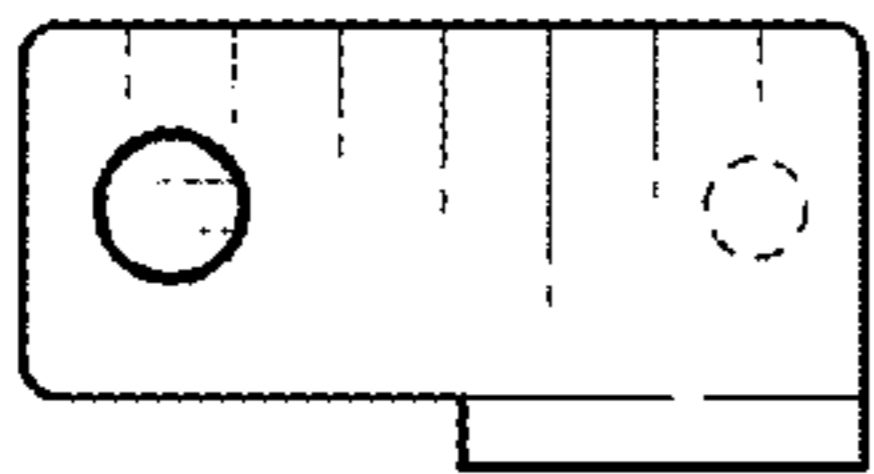

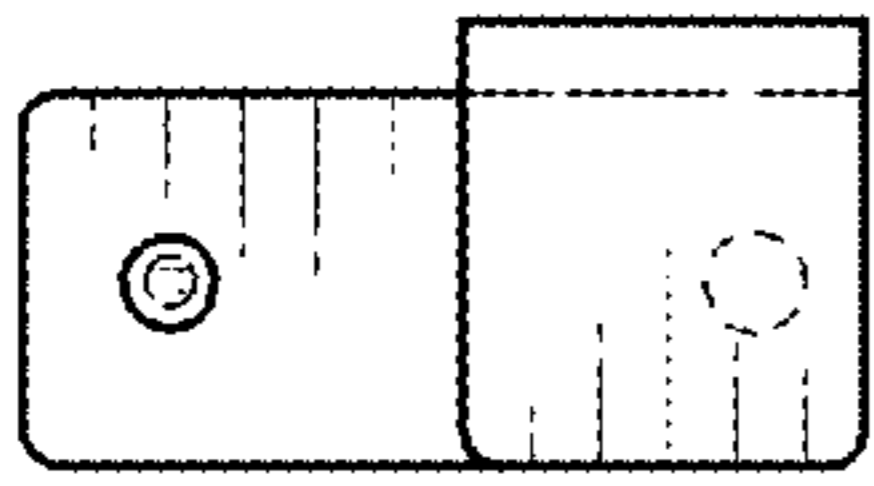

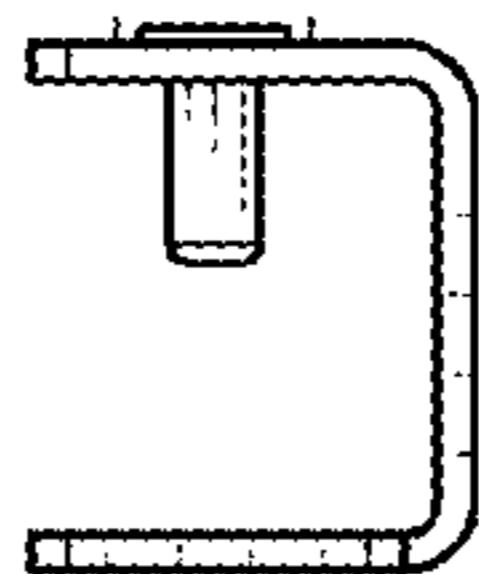

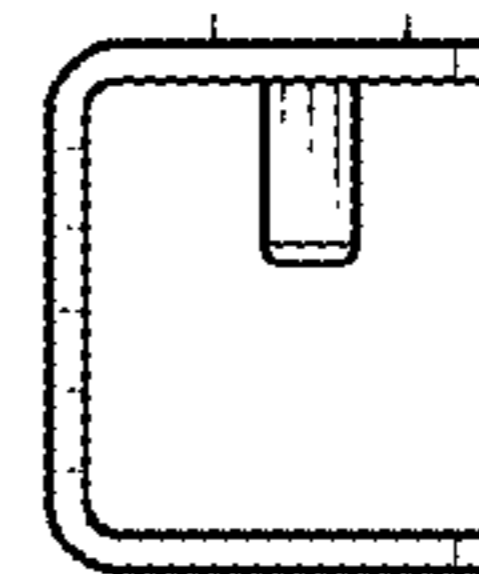
