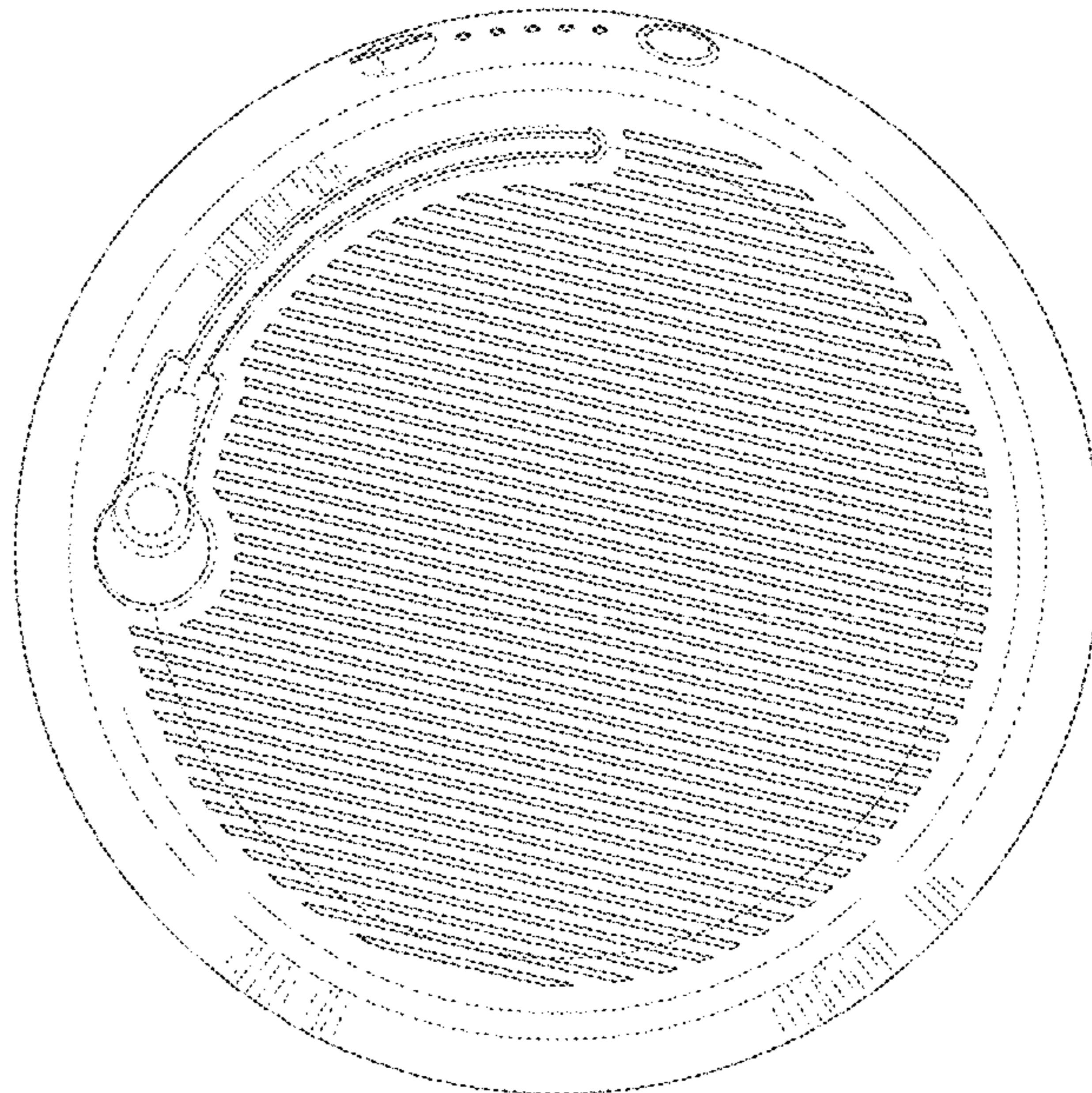
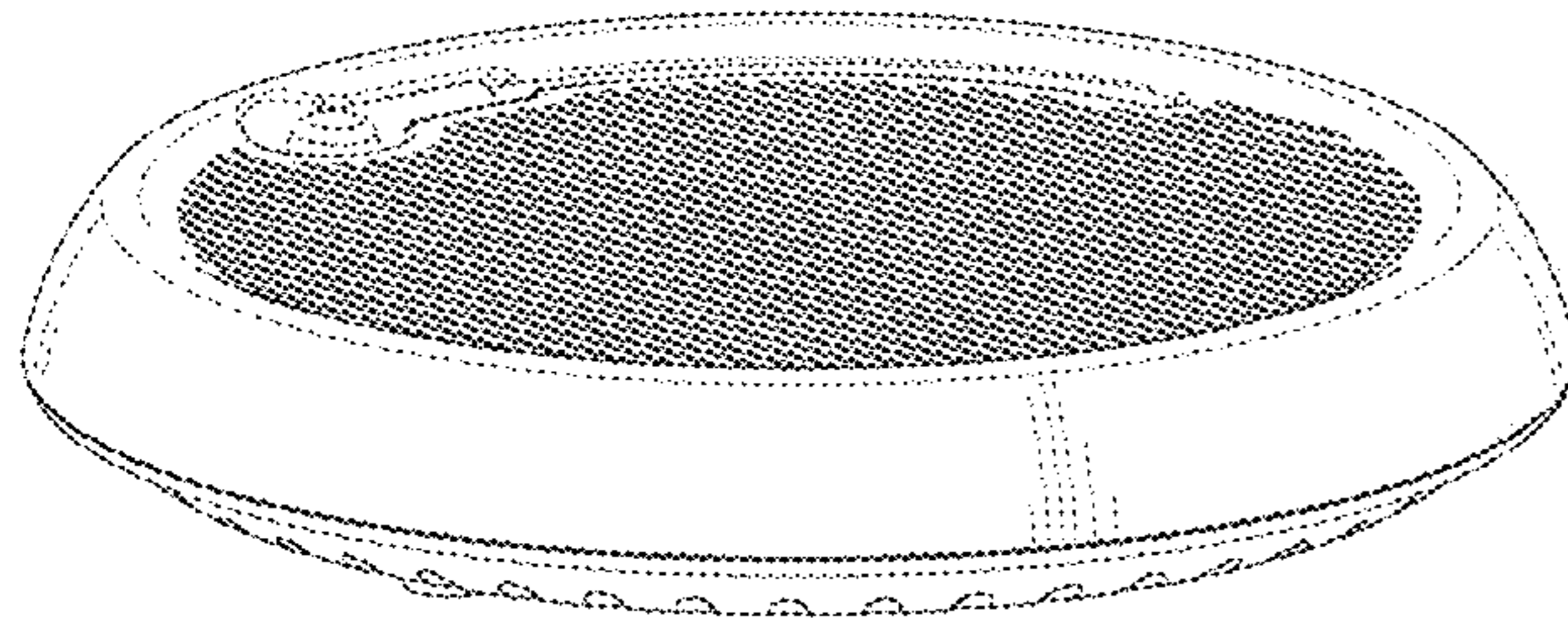
The ornamental design for an essential oil diffuser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an essential oil diffuser showing my new design;

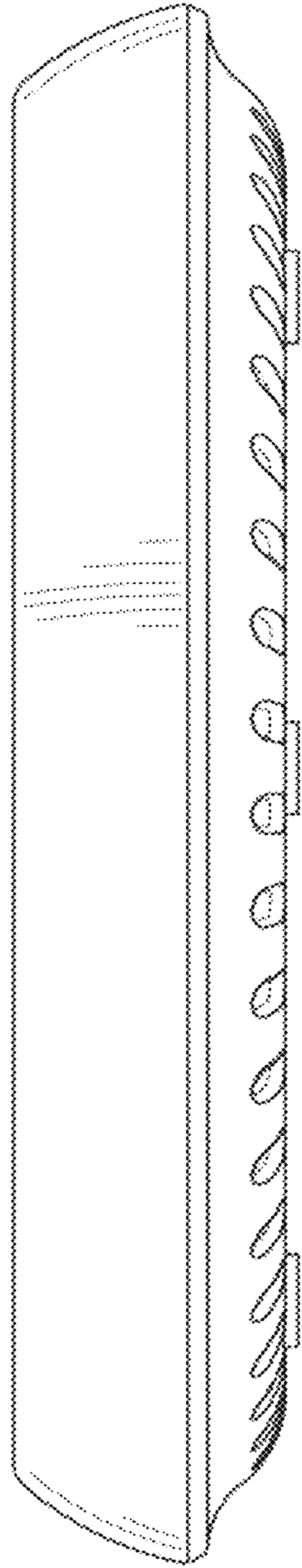

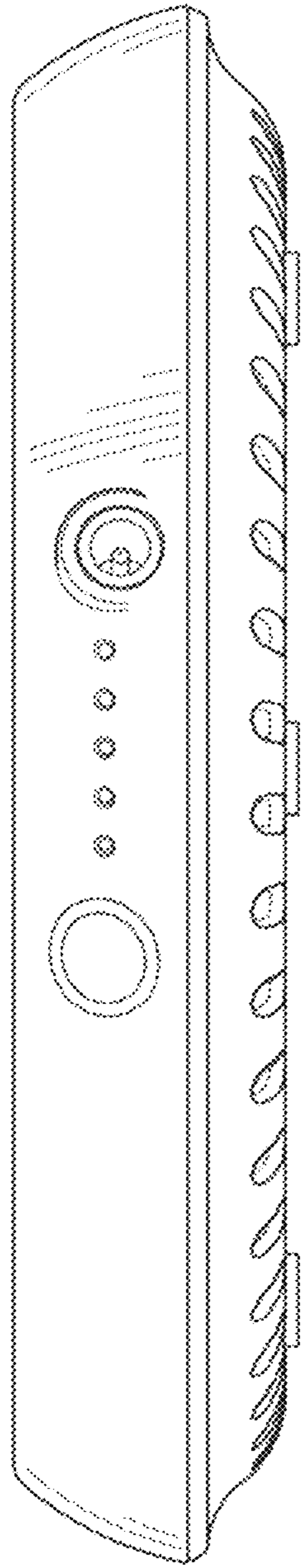

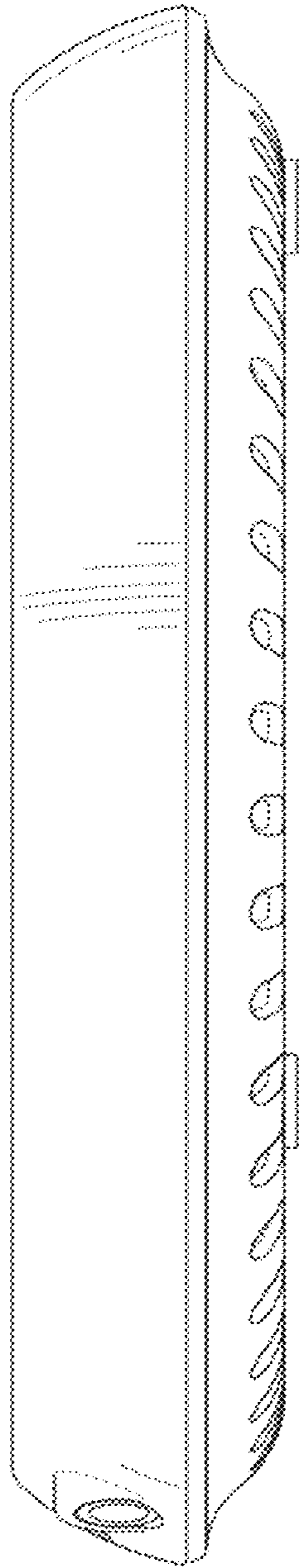

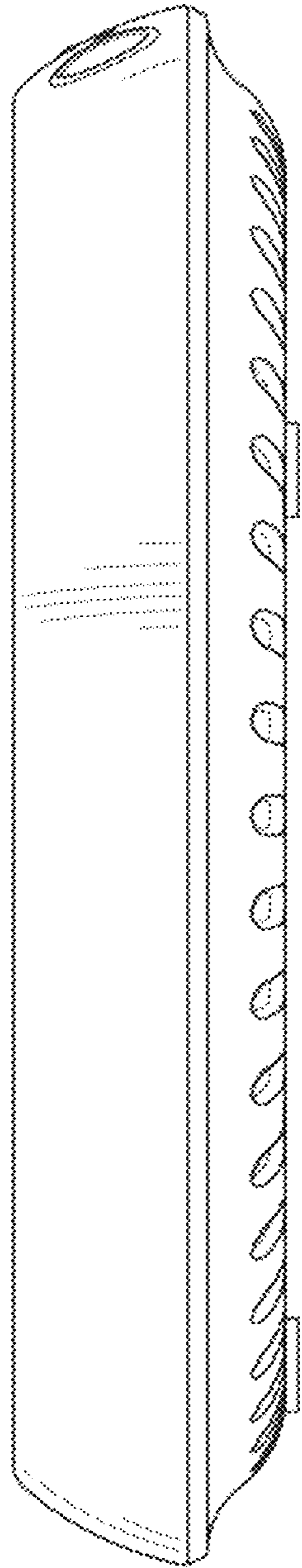

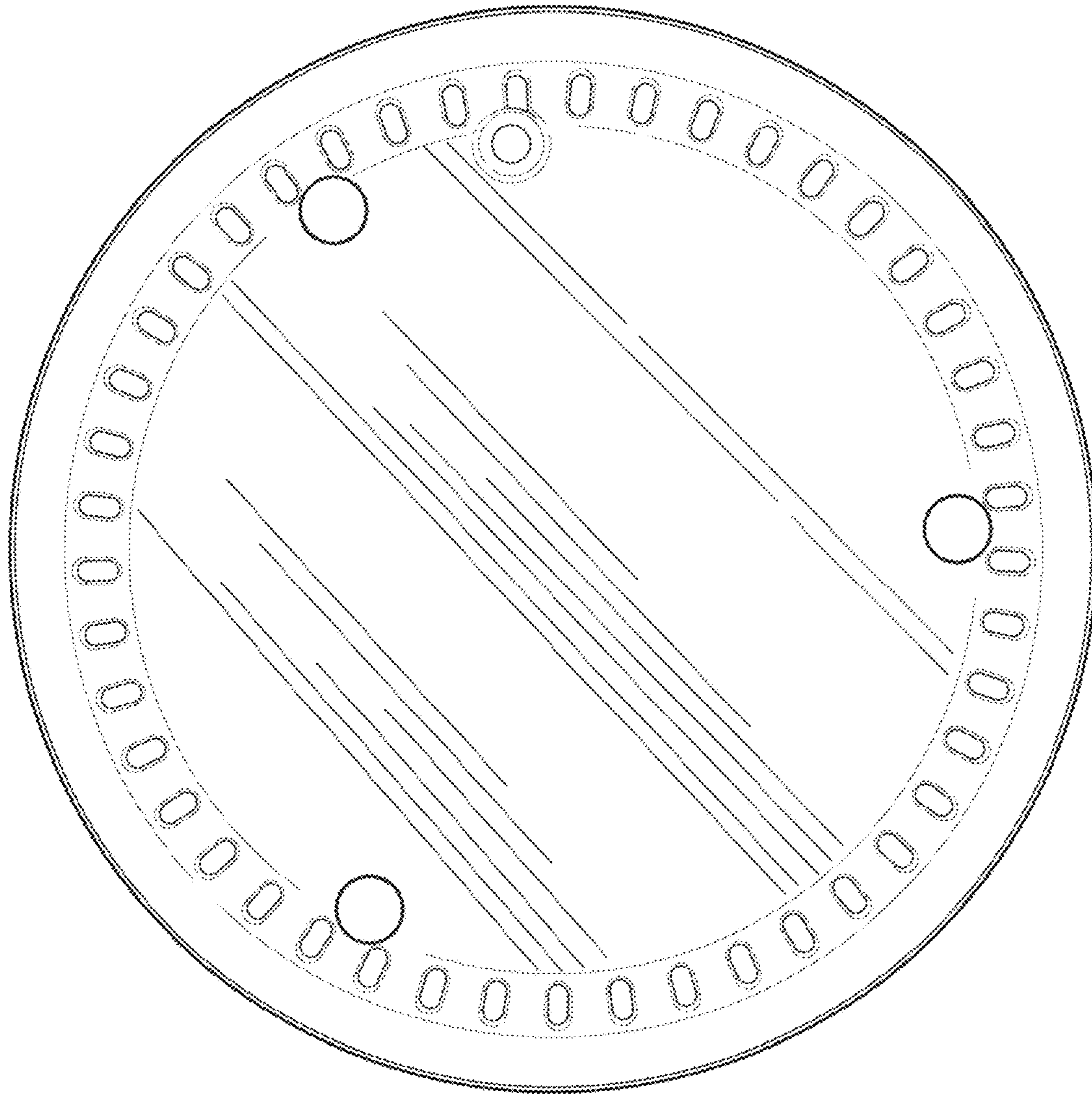

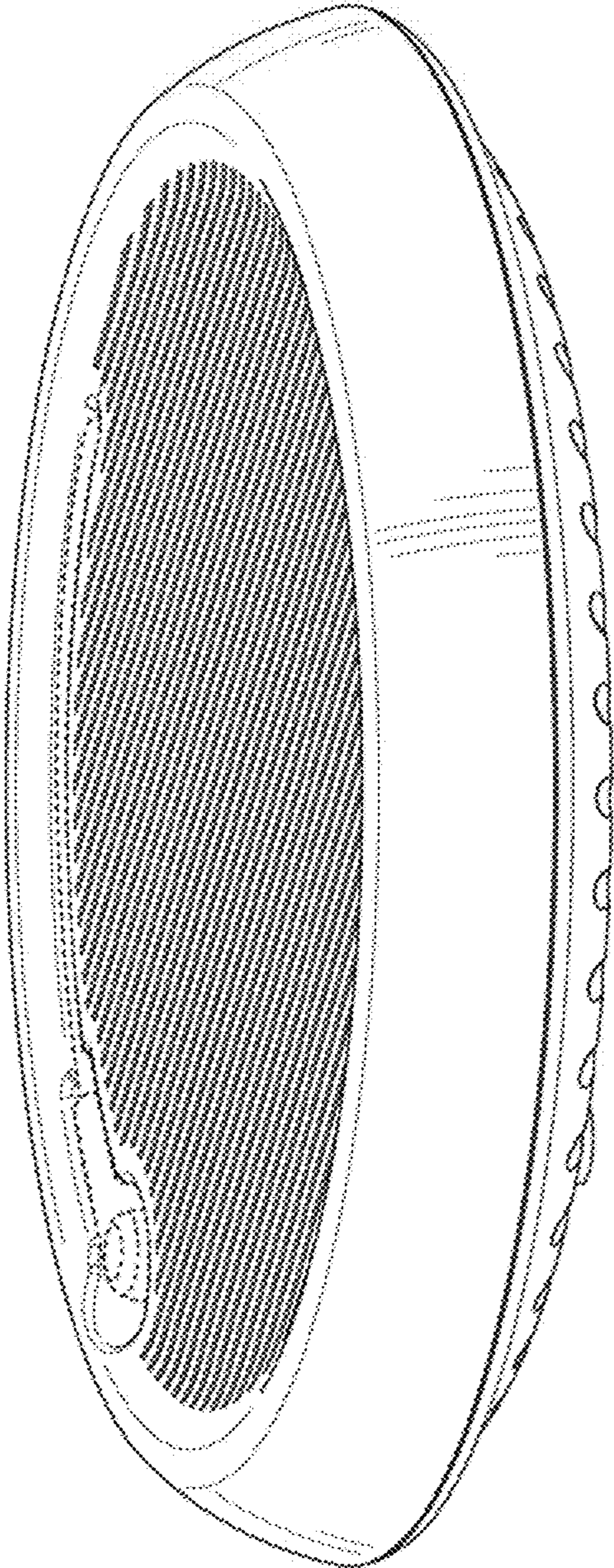

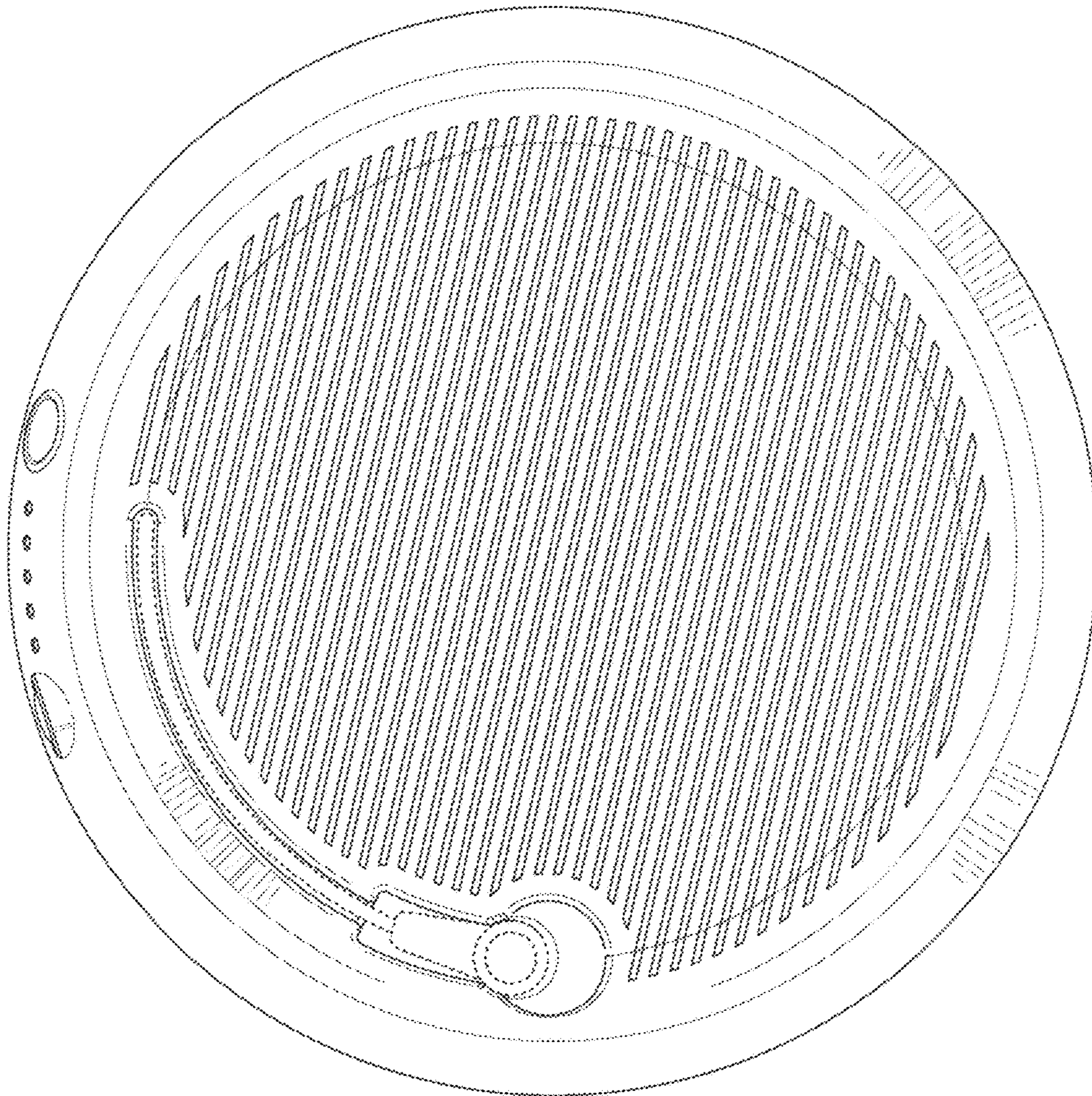
