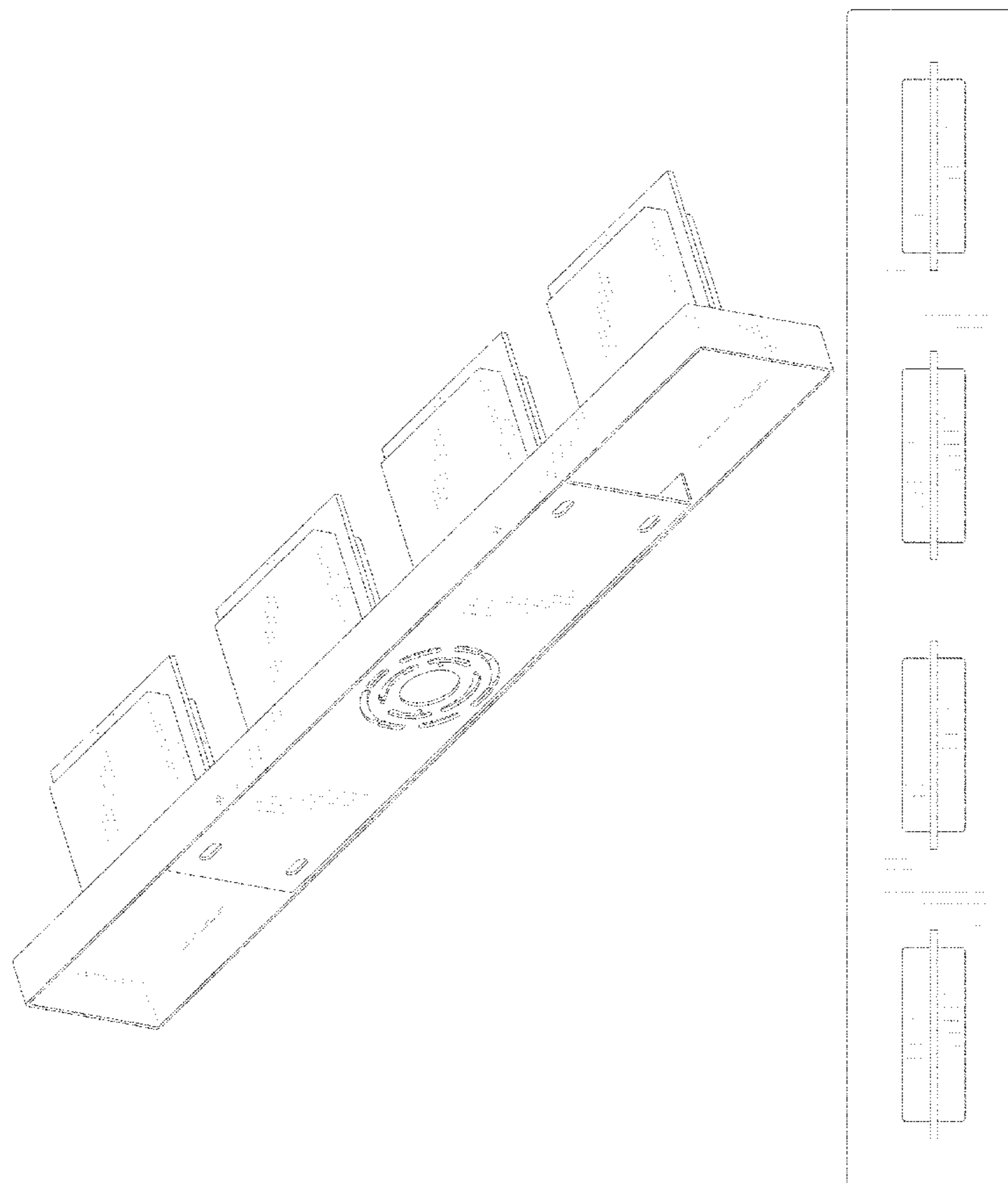
(57) **CLAIM**

The ornamental design for a bathroom vanity light, as shown and described.

**DESCRIPTION**

FIG. 1 is a rear perspective view of a bathroom vanity light showing my new design;

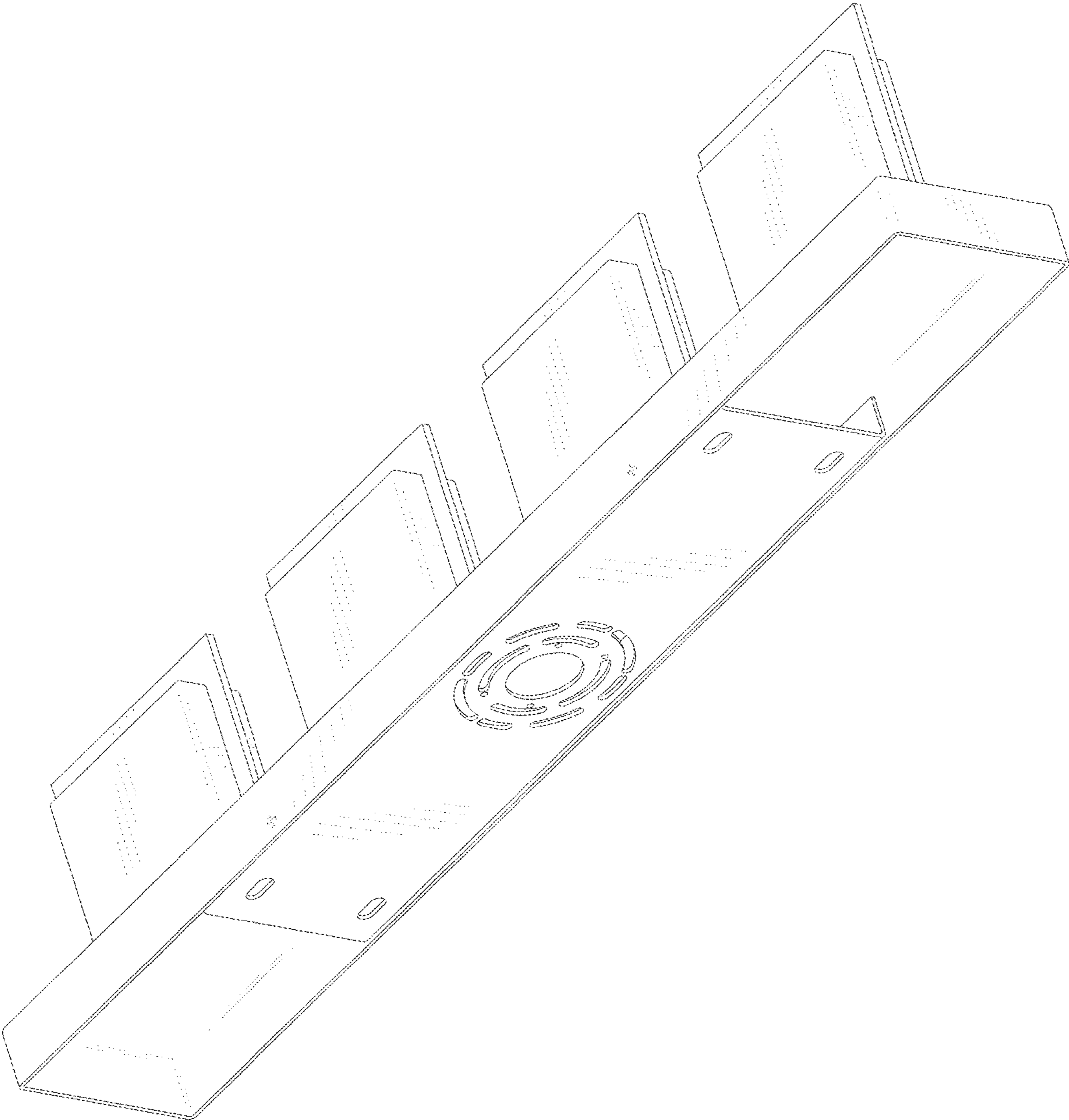

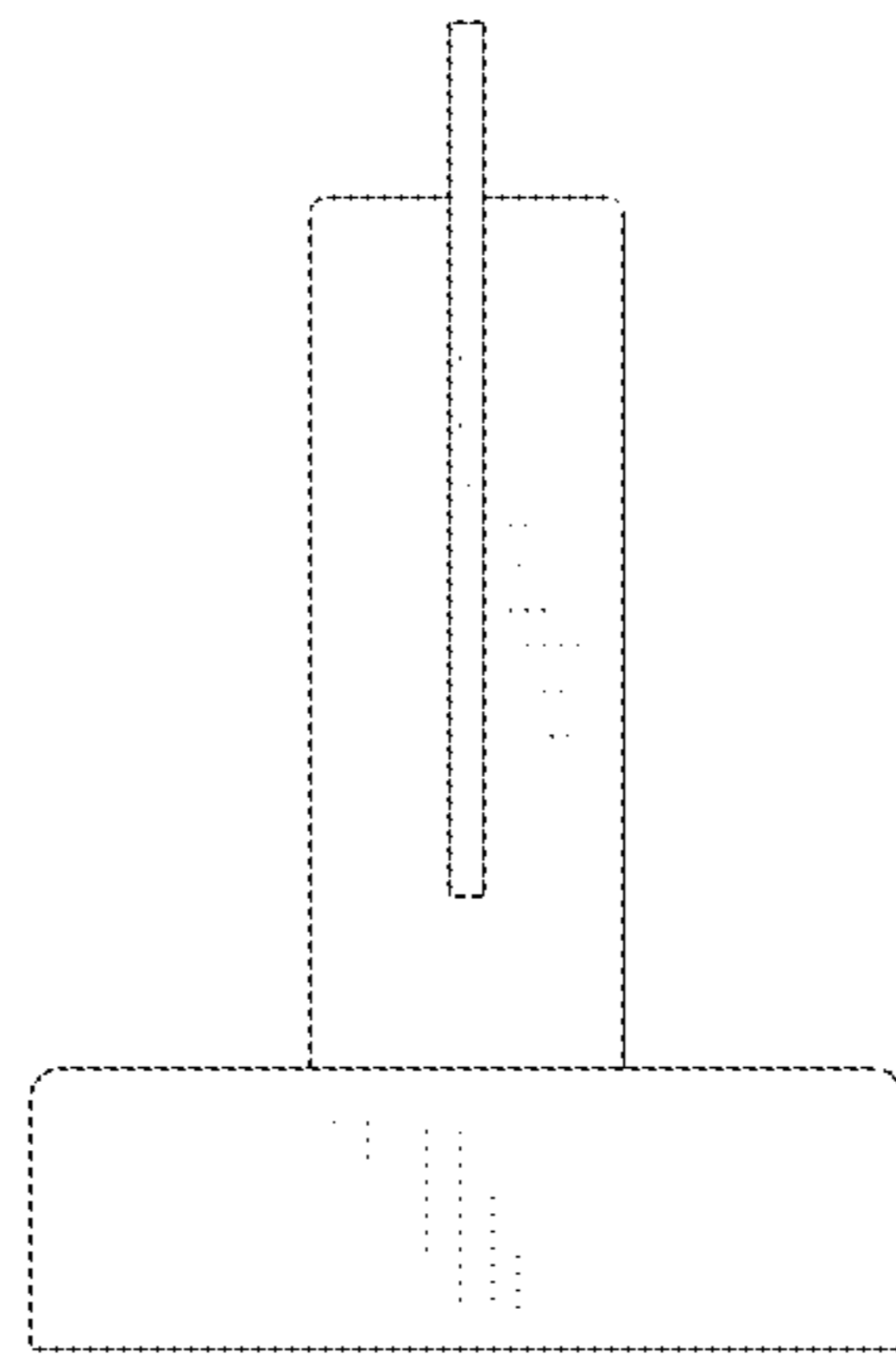

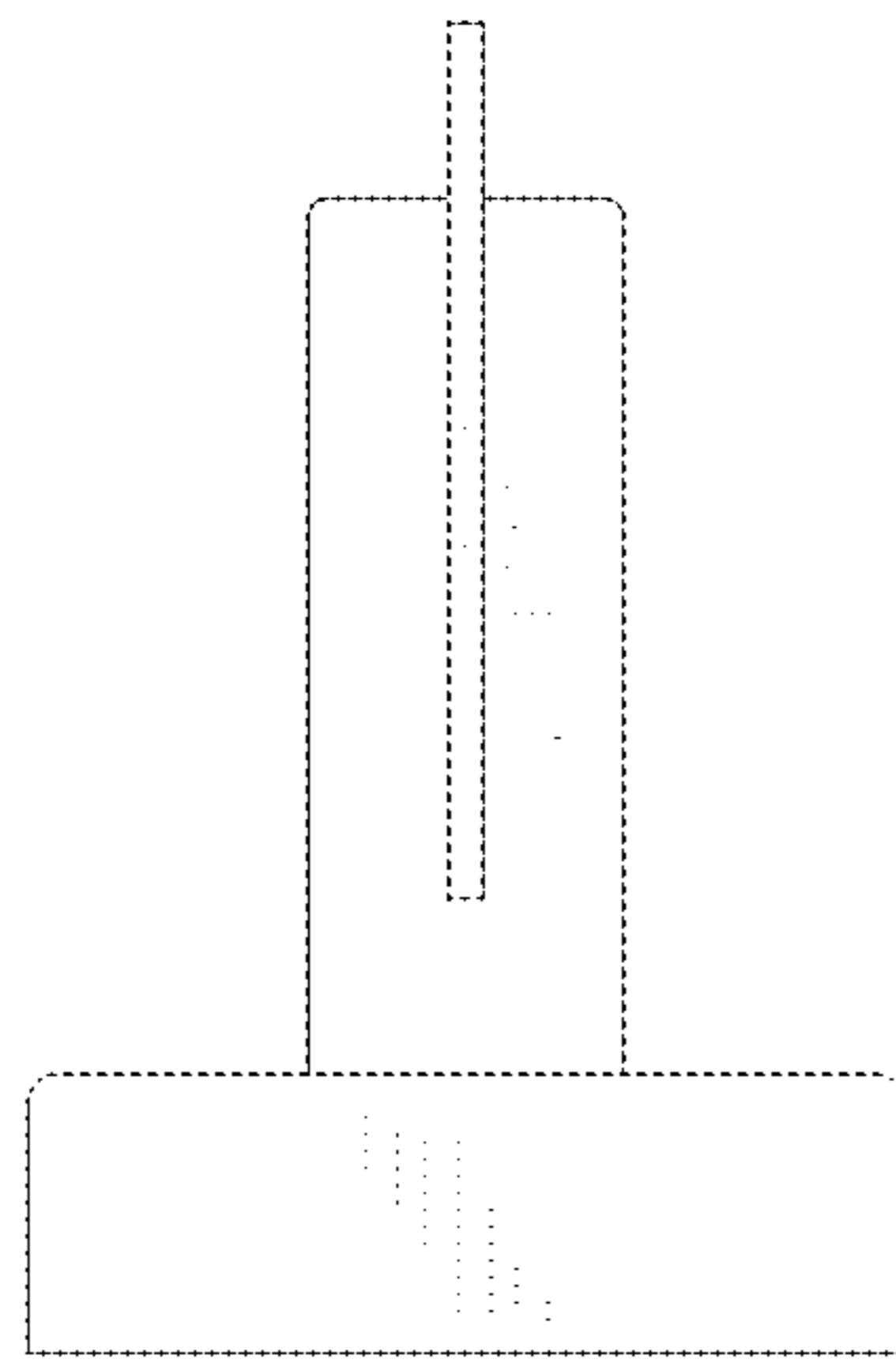

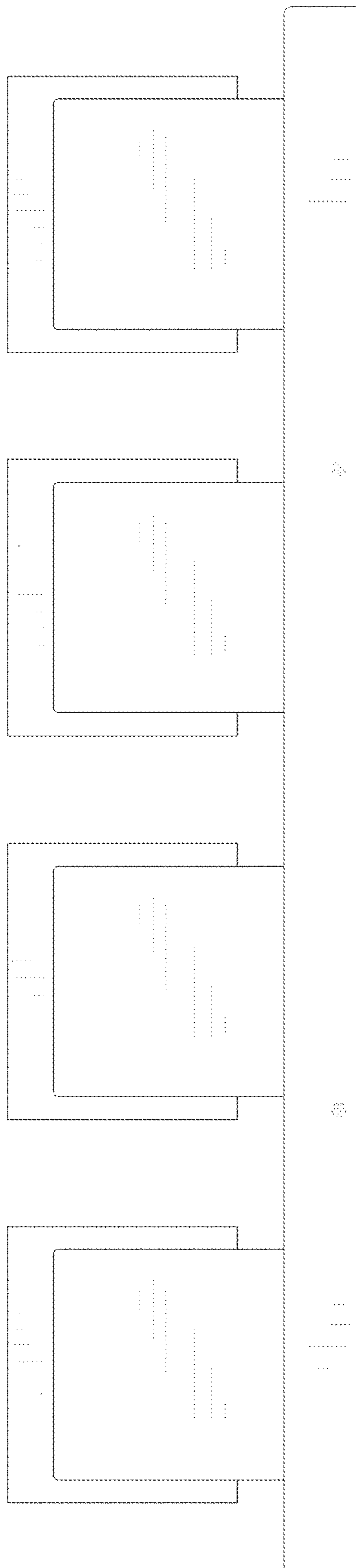

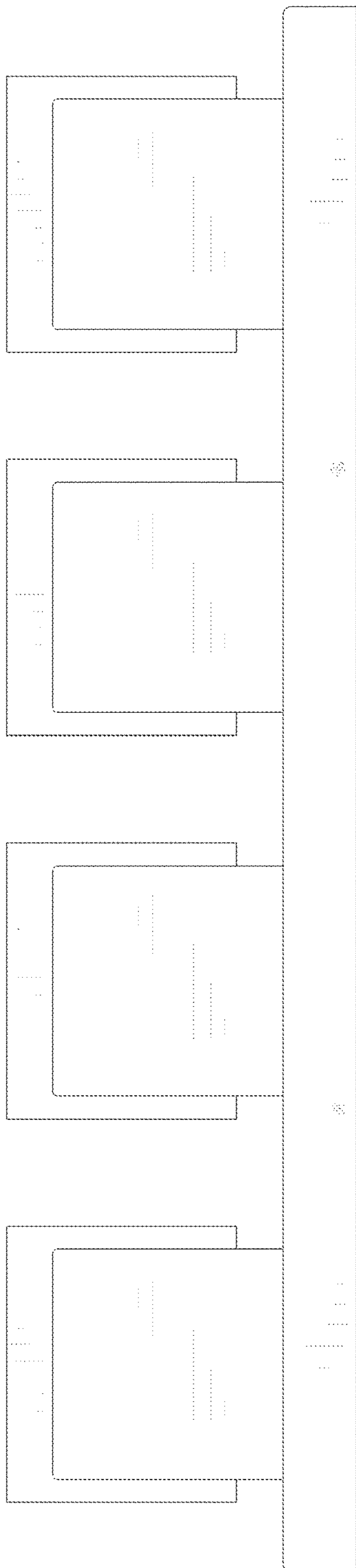

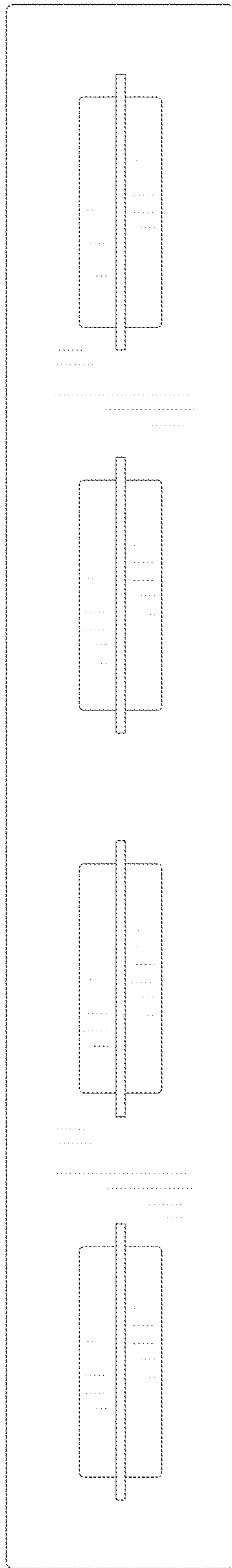

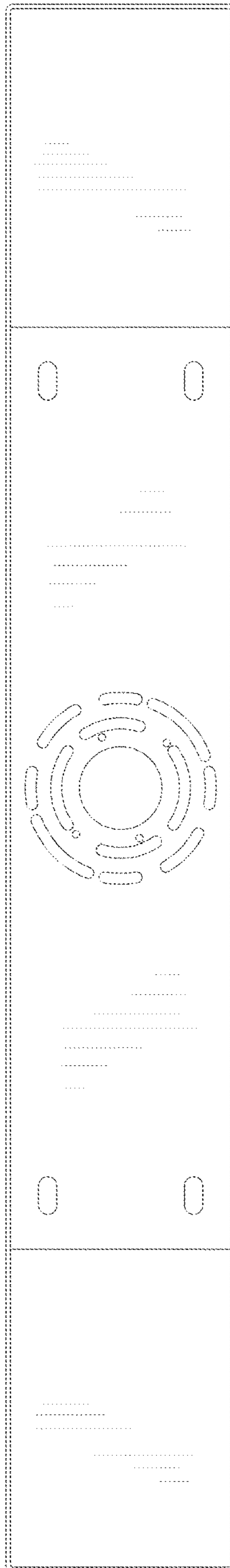
