(57) **CLAIM**

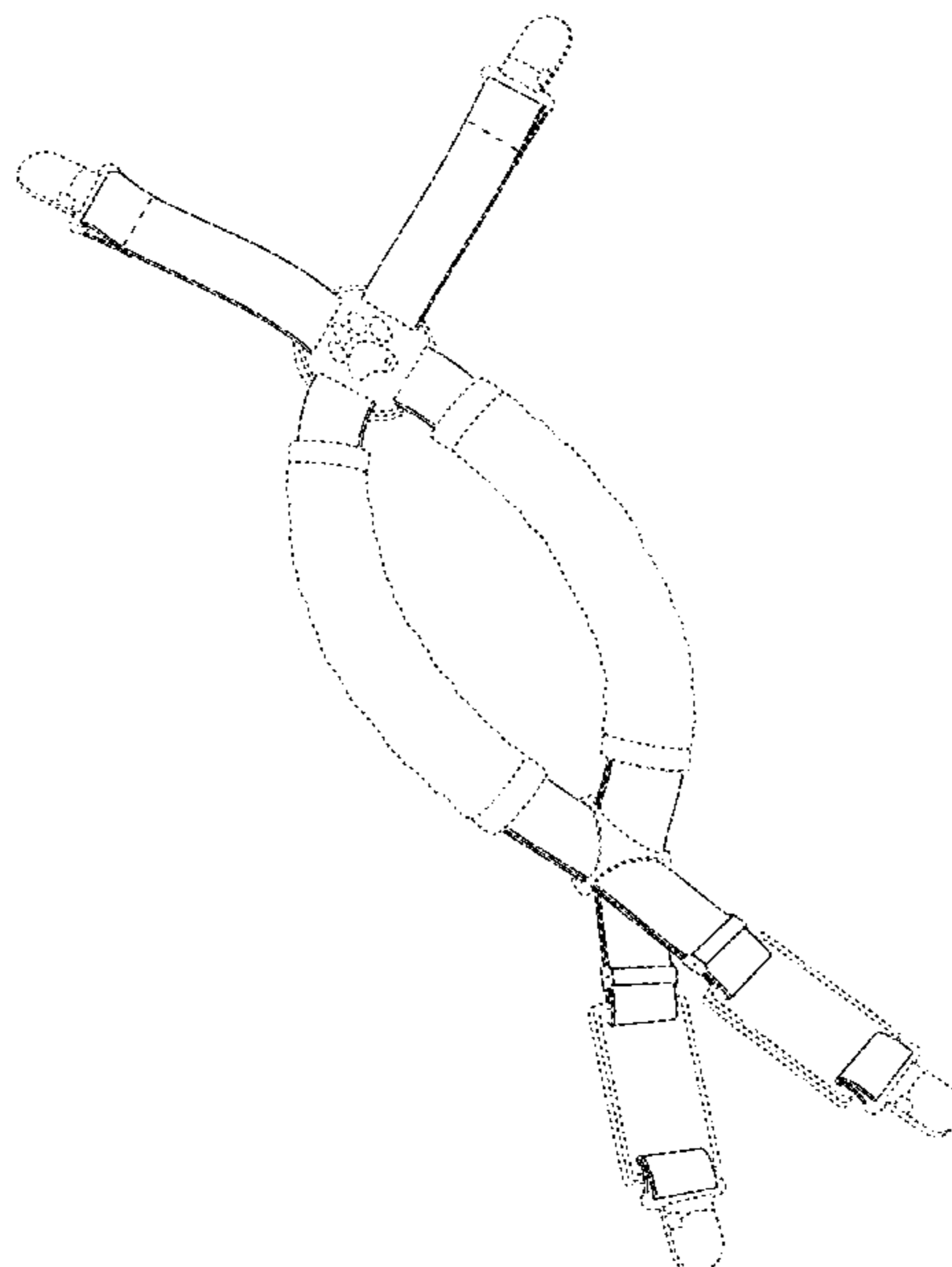
The ornamental design for a pet suspender, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pet suspender in accordance with the new design;

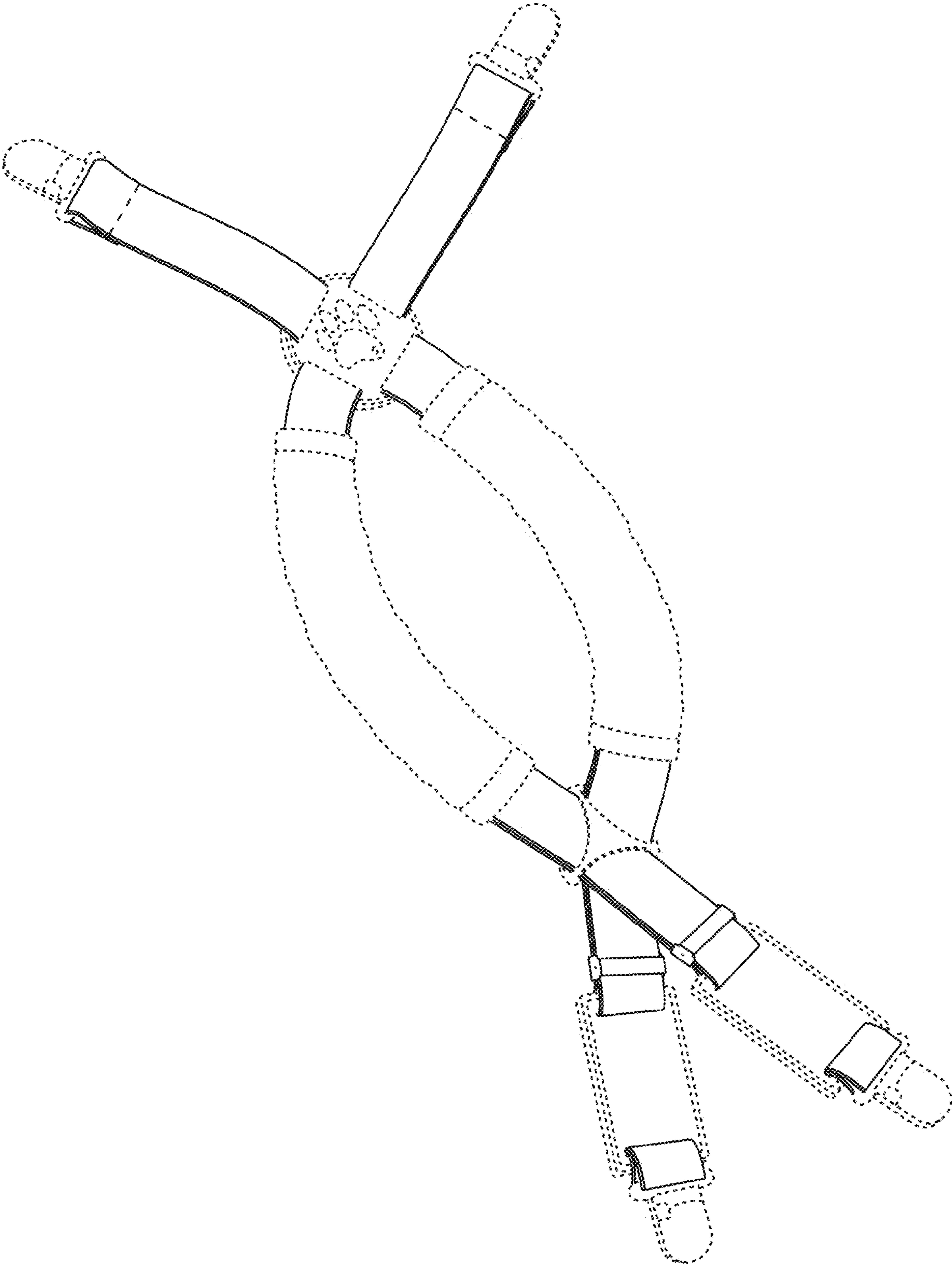

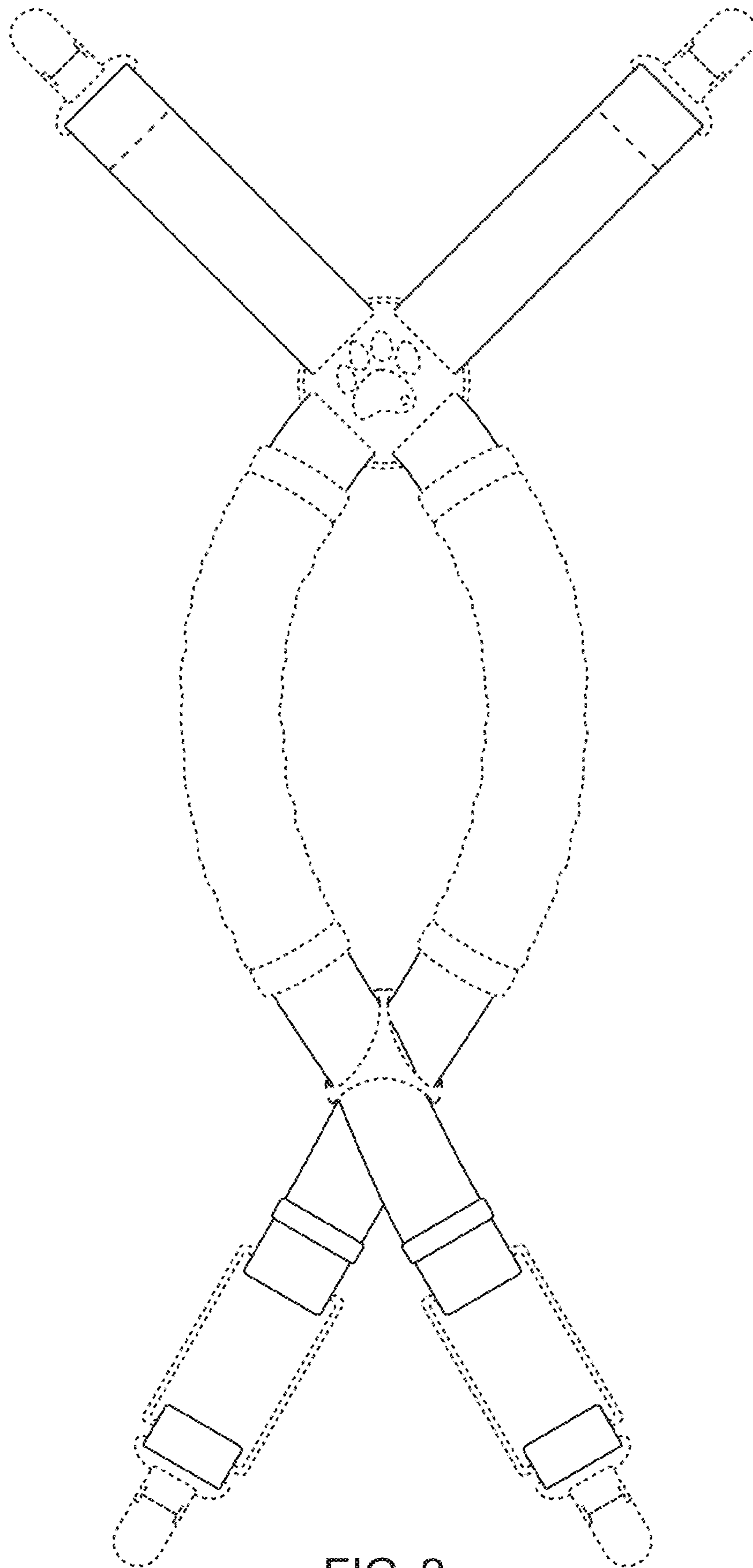

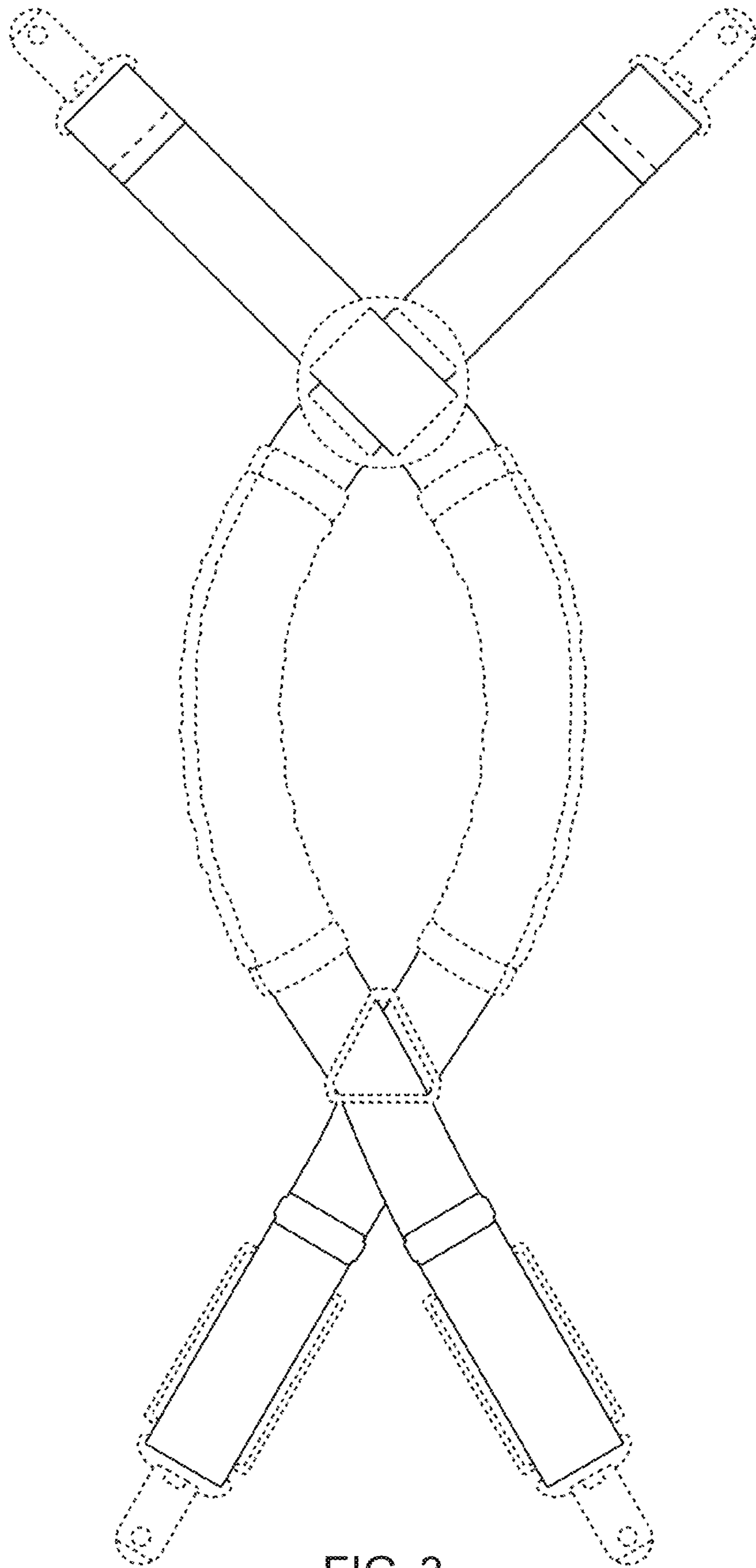

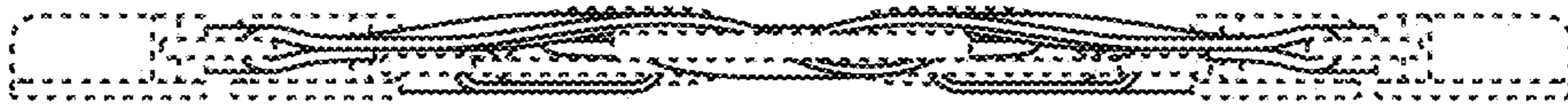

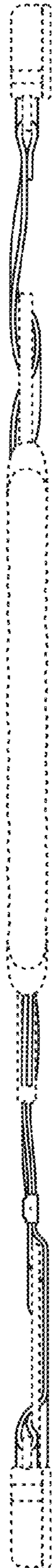

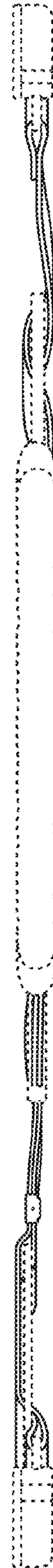
