(57) **CLAIM**

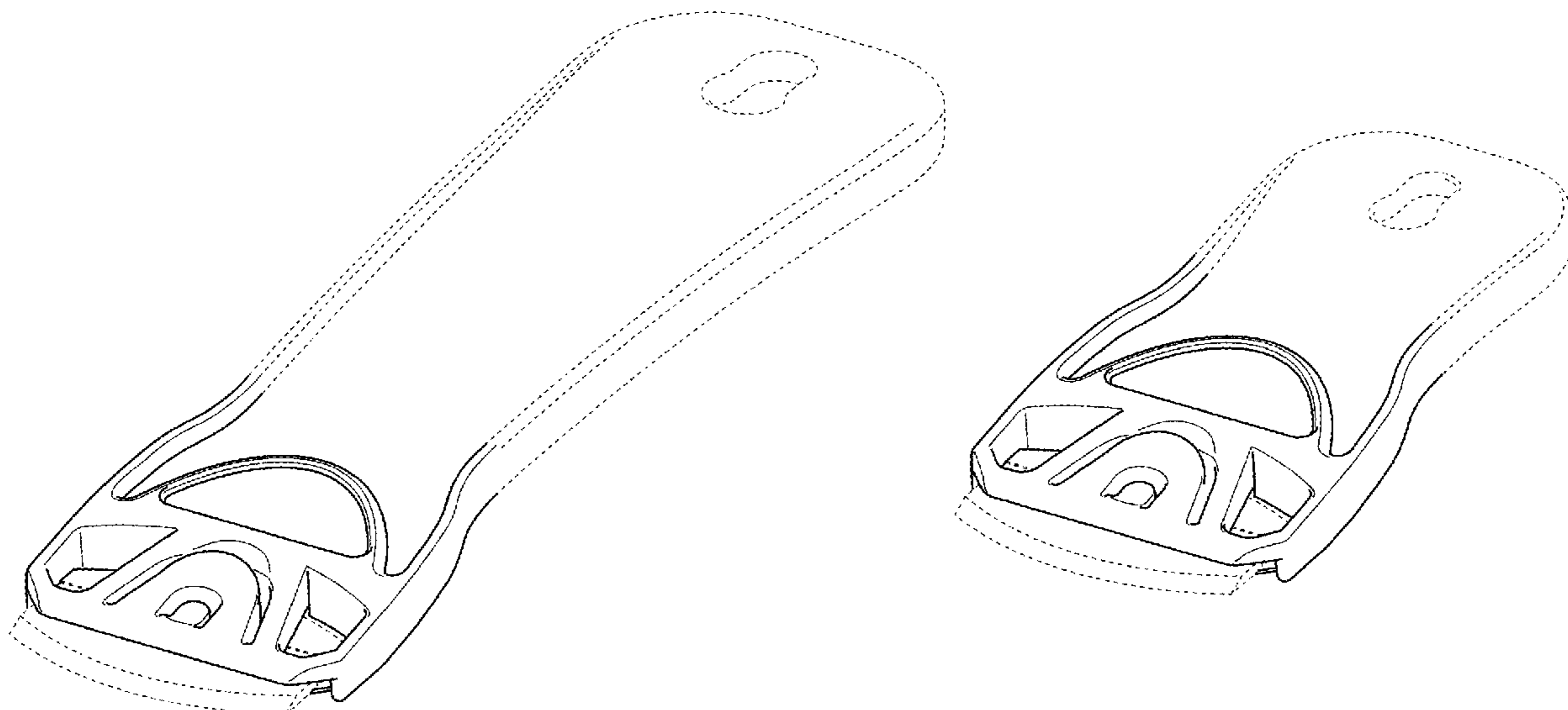
The ornamental design for a holder for a plastic blade scraper, as shown and described.

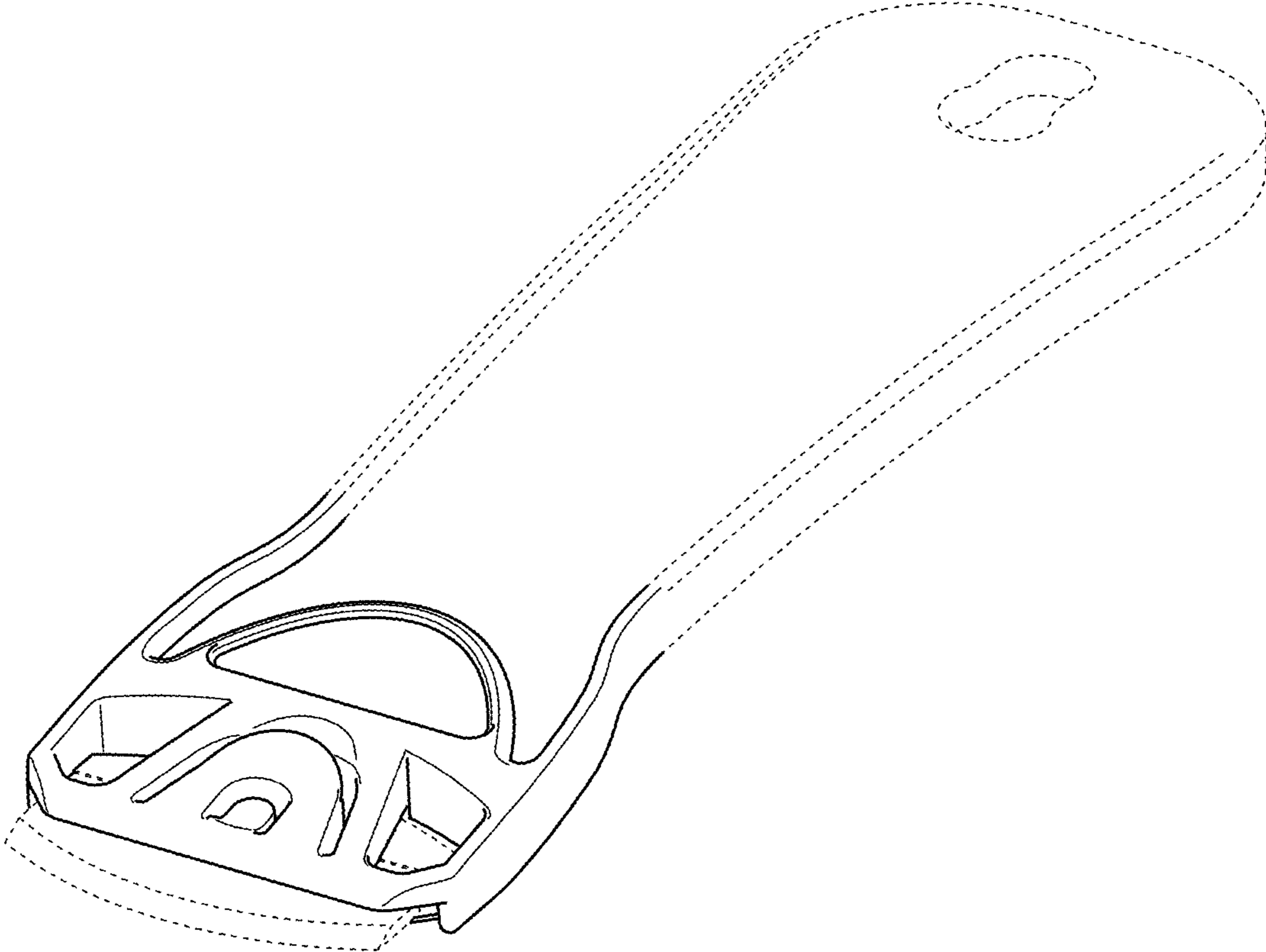

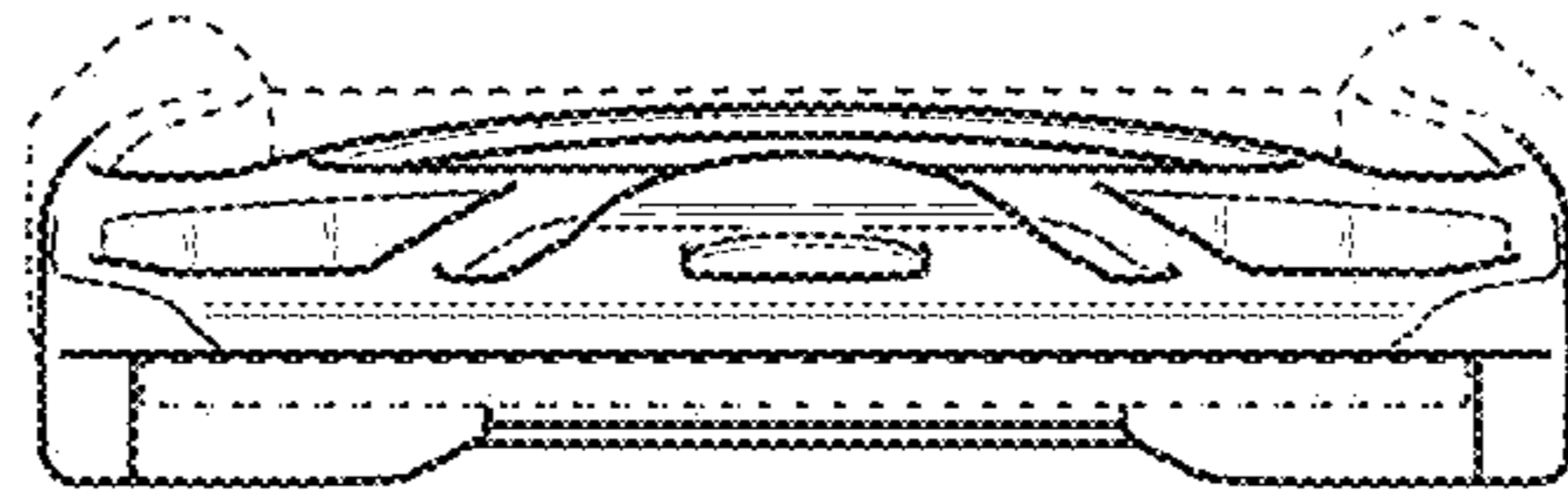

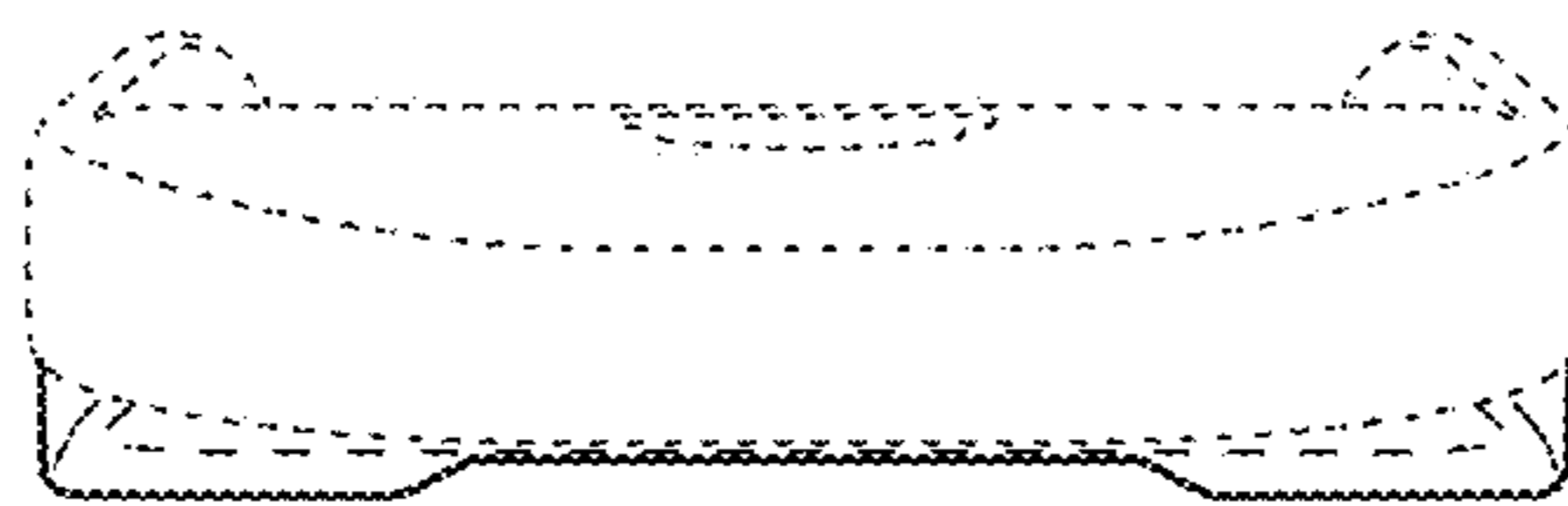

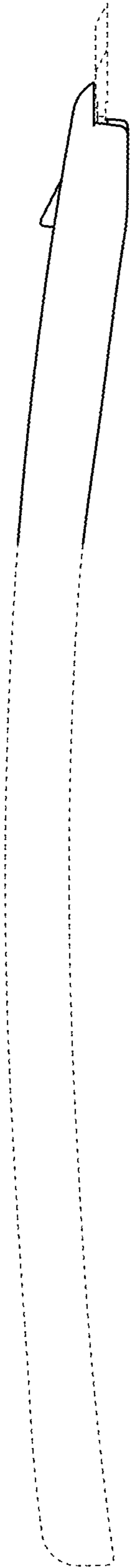

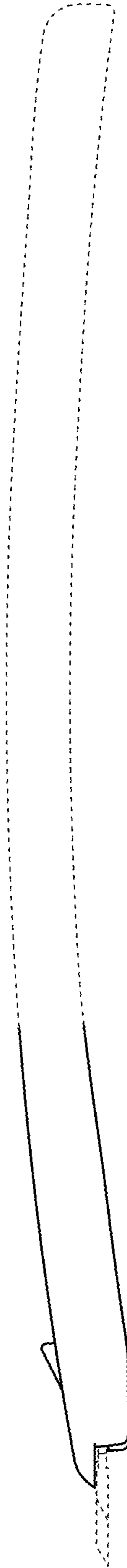

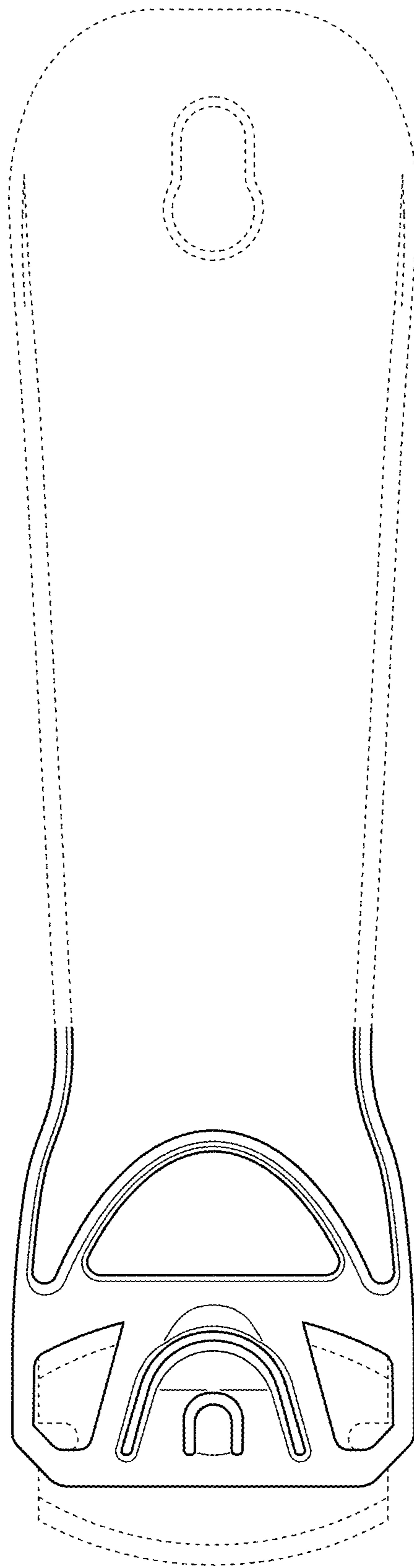

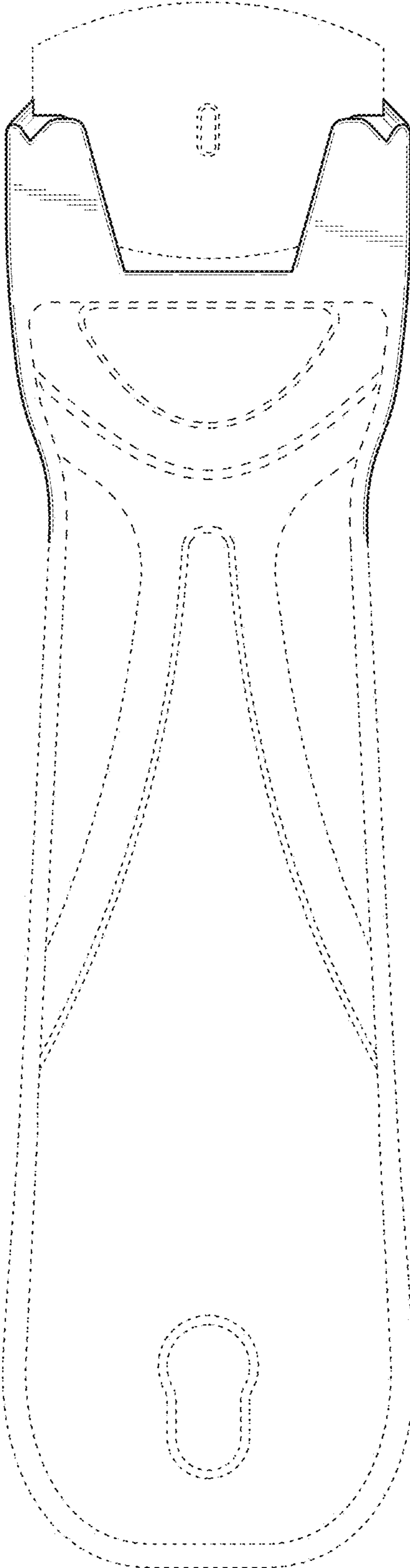

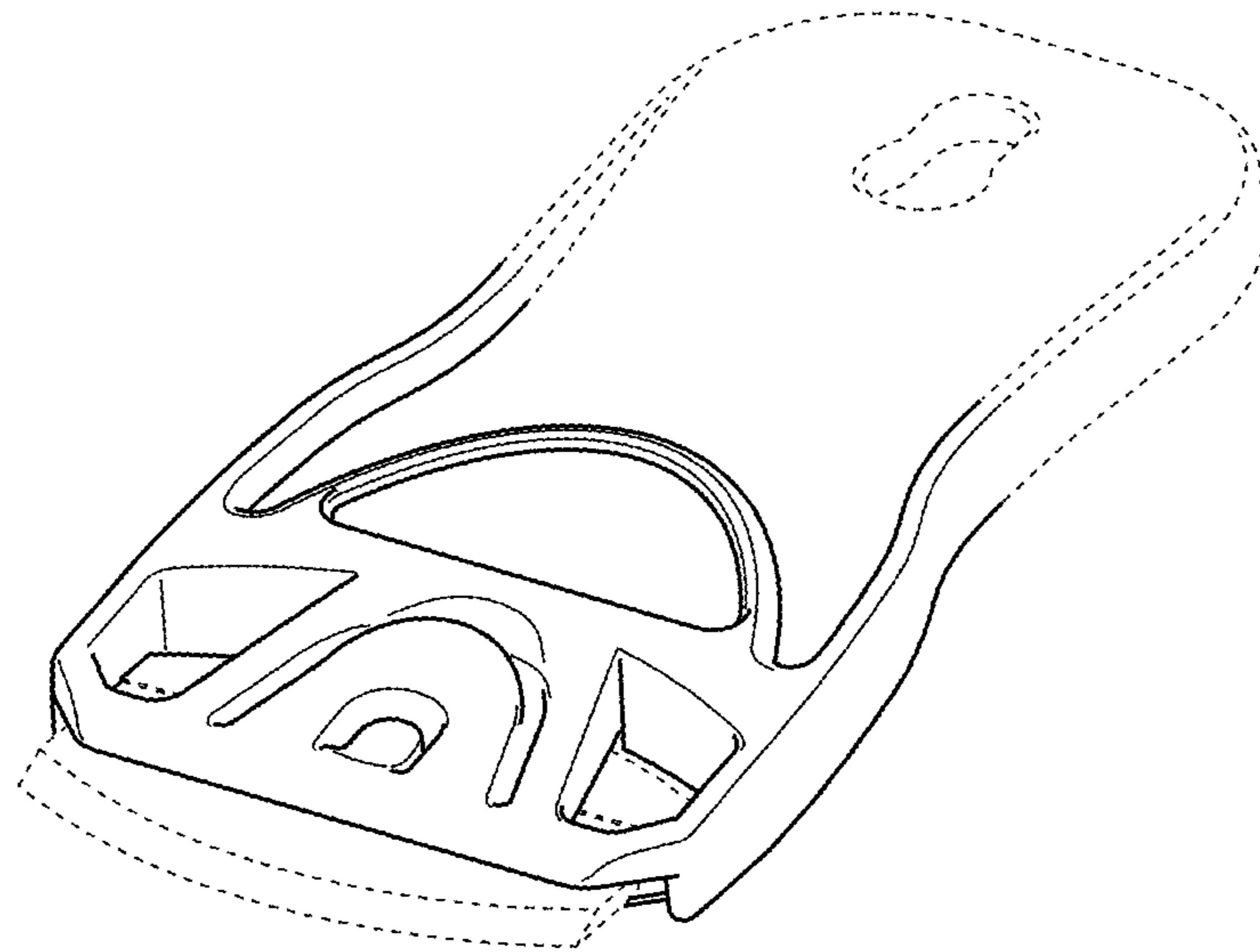

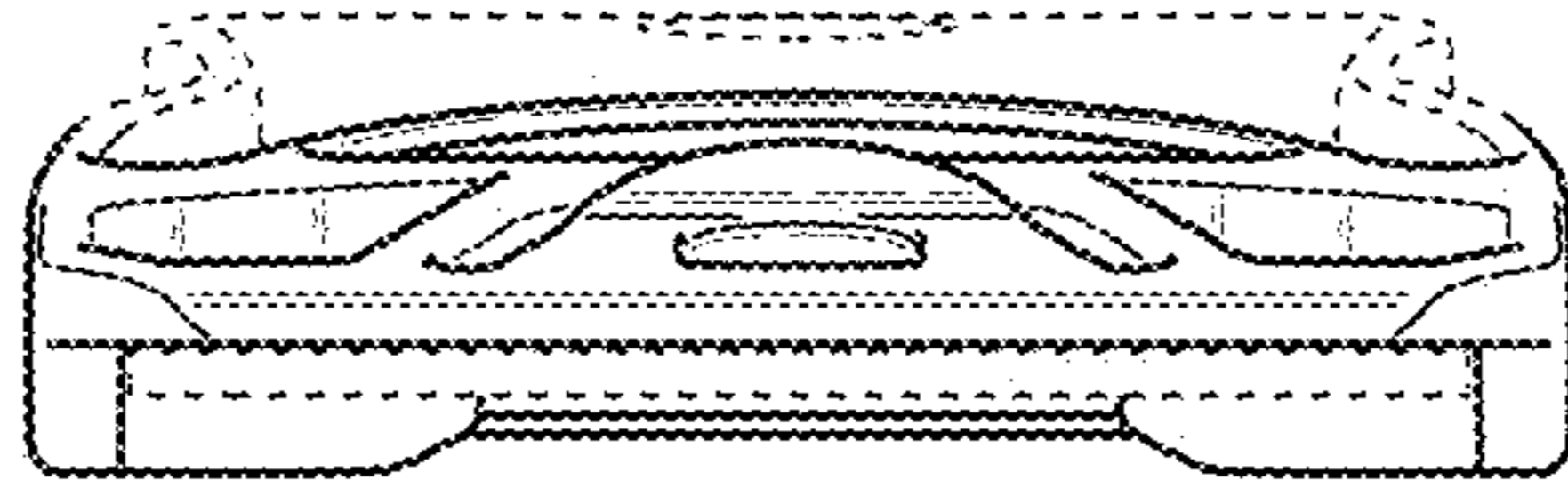

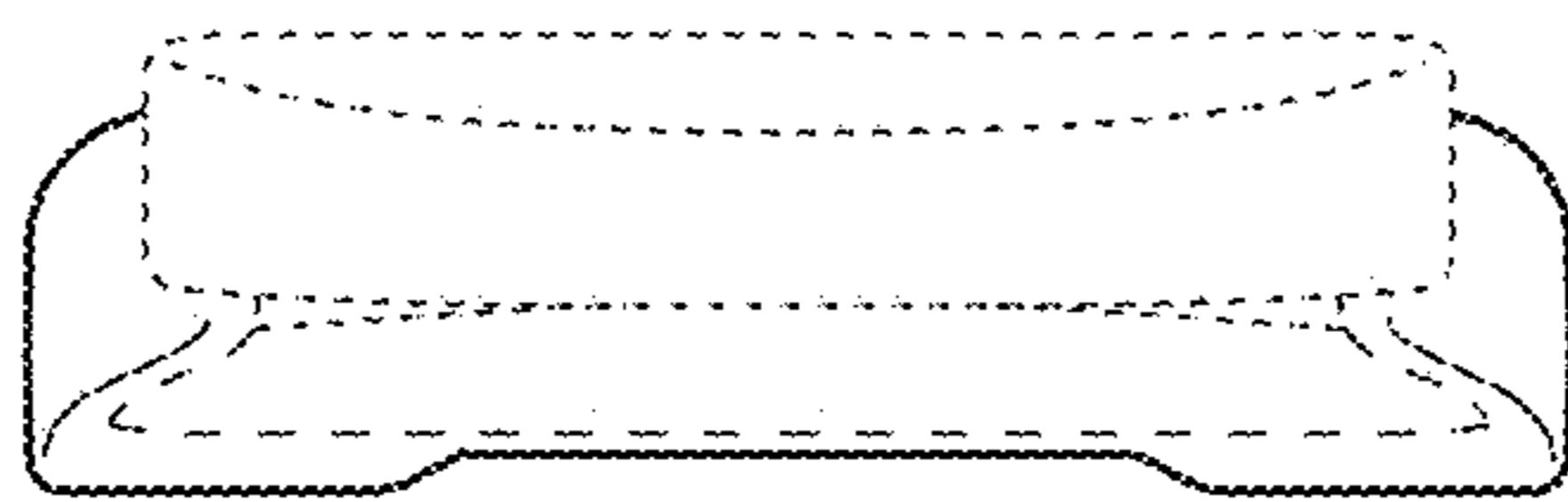

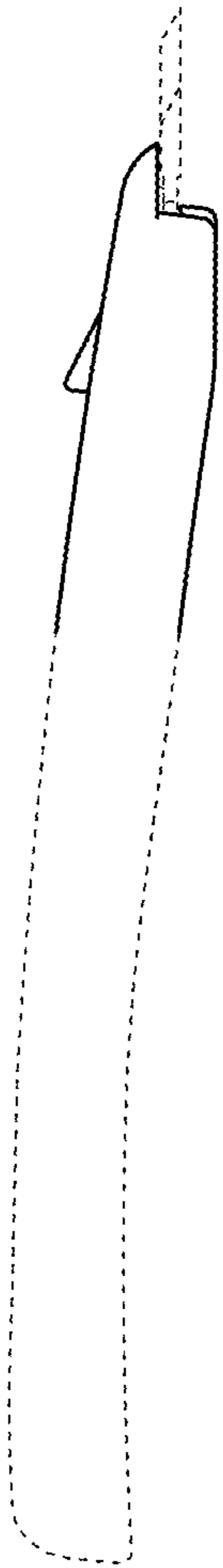




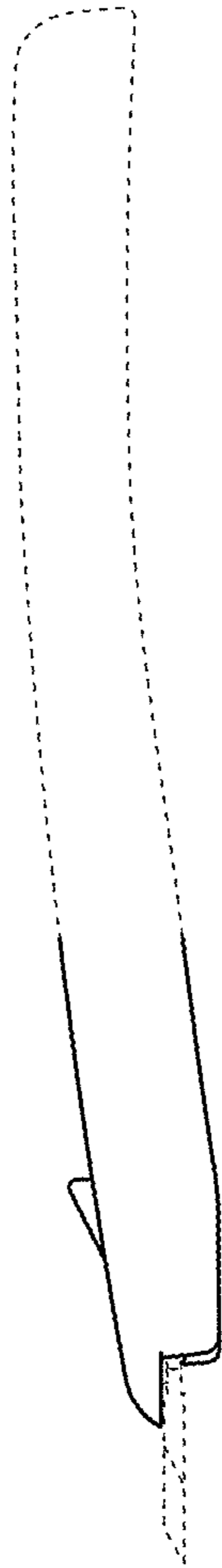

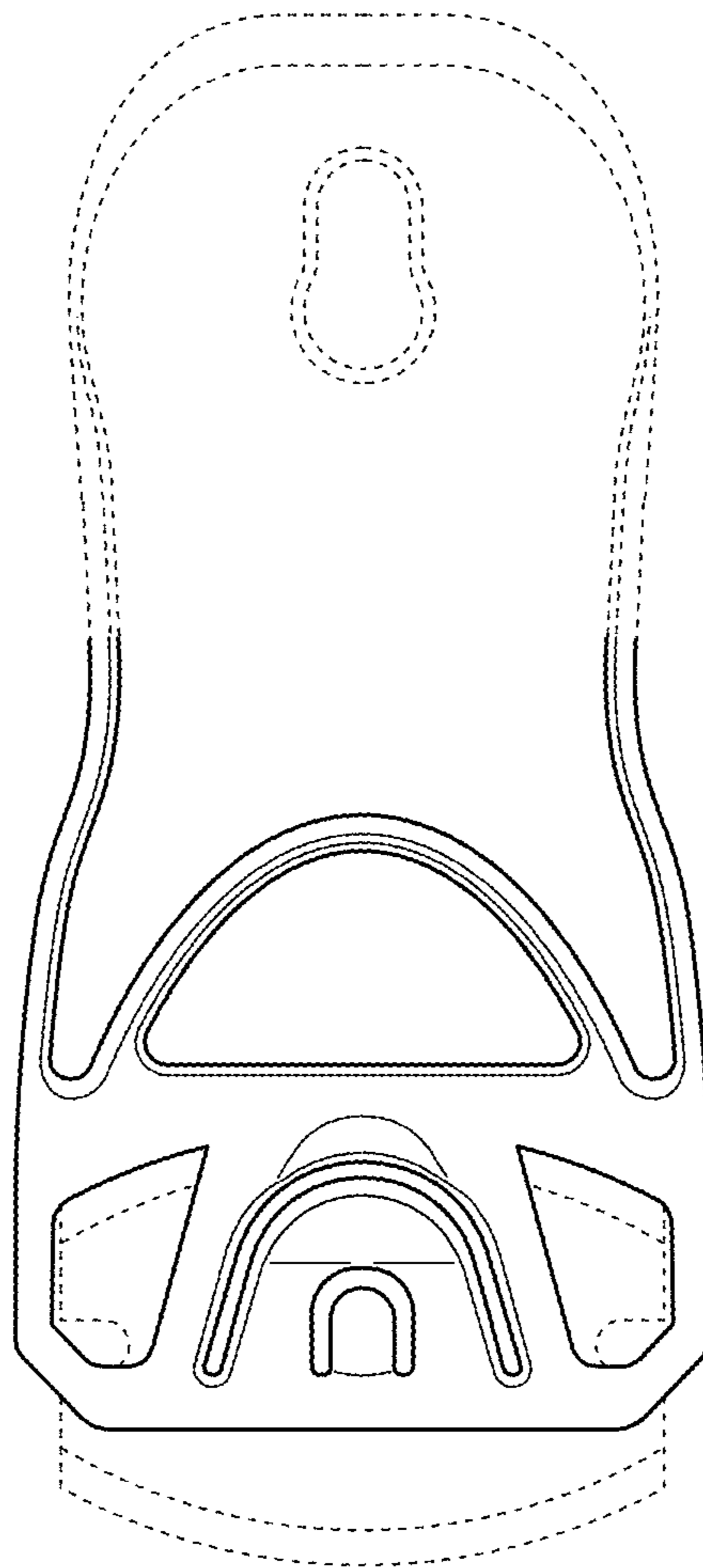

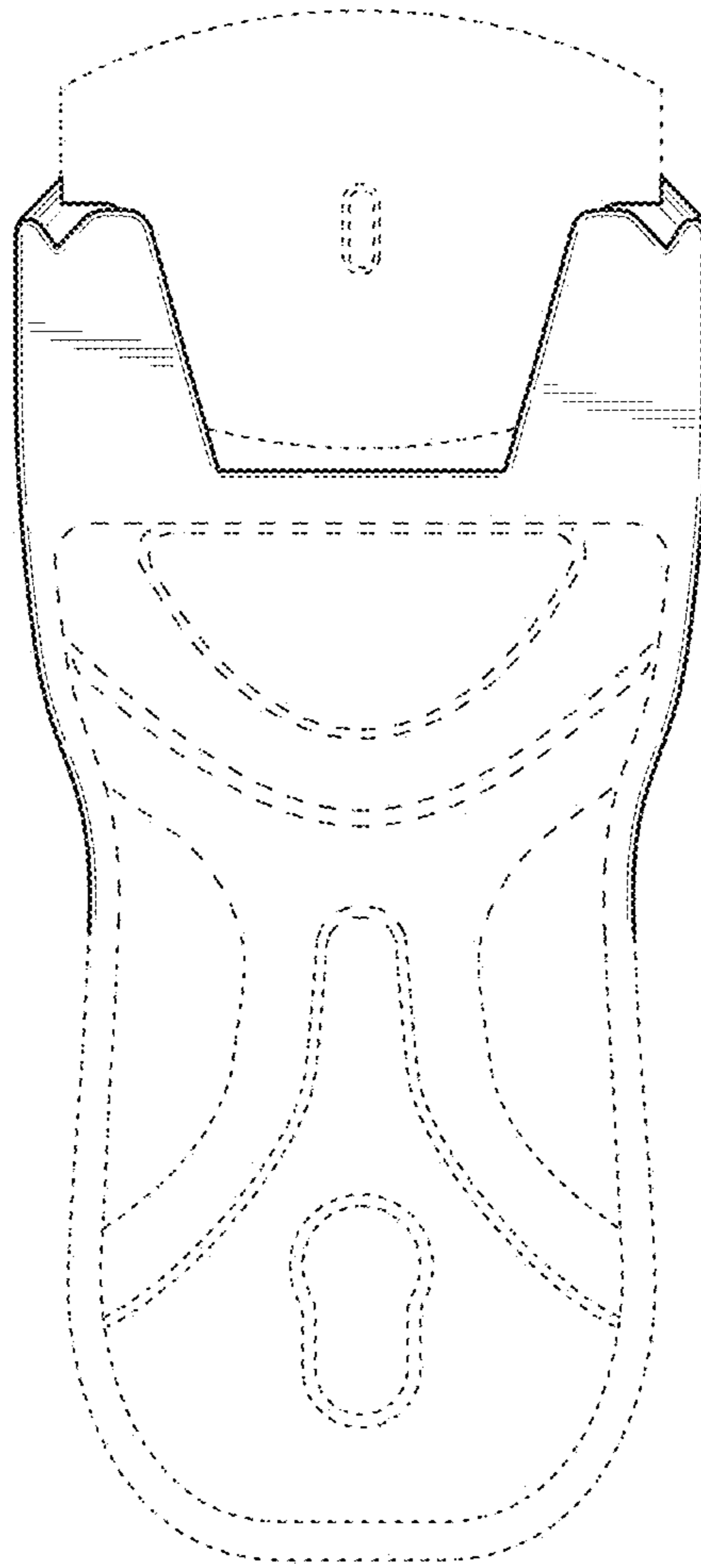
