(57) **CLAIM**

The ornamental design for a gemstone cage harness, as shown and described.

DESCRIPTION

FIG. 5 is a right side view of the gemstone cage harness;

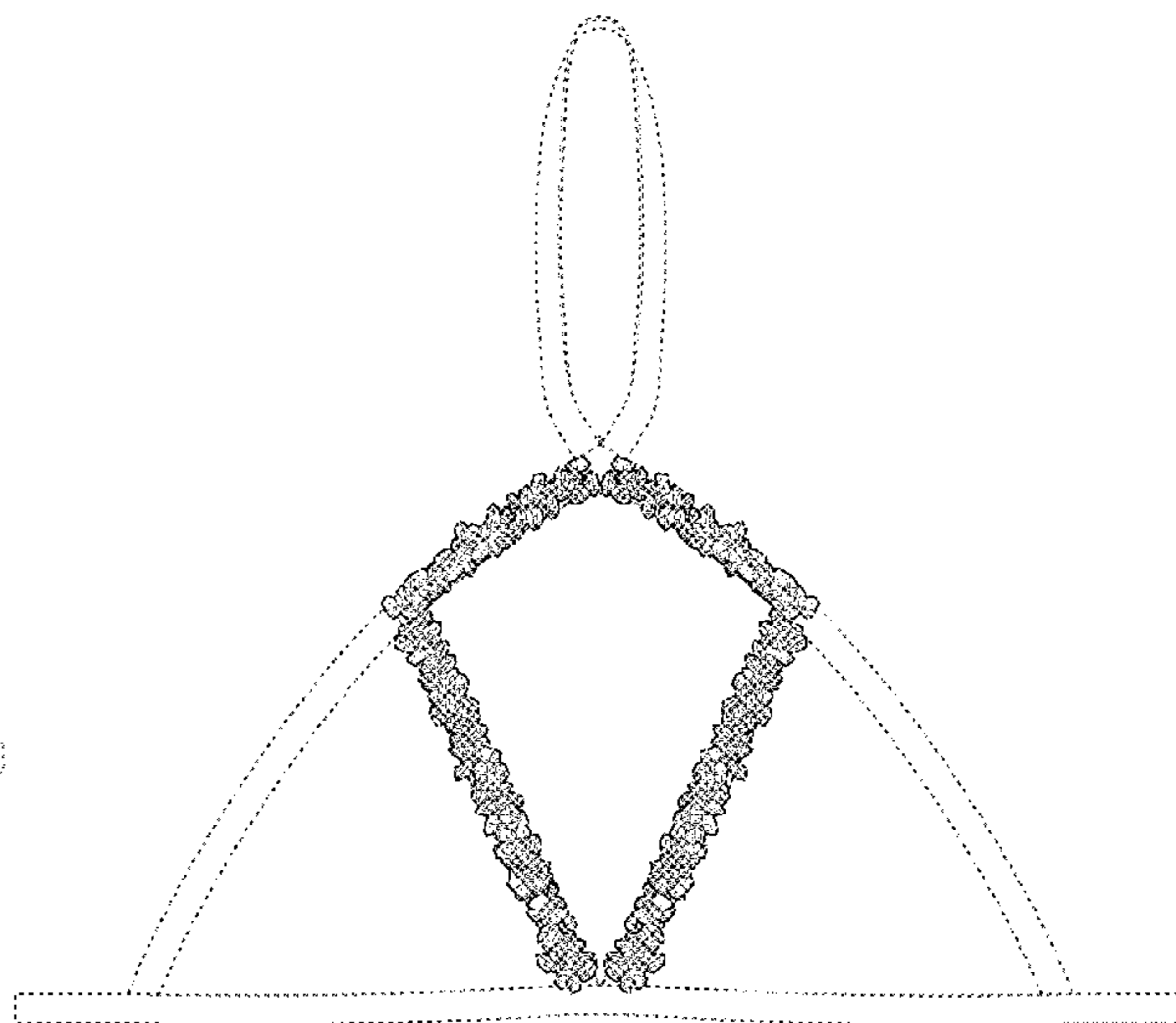
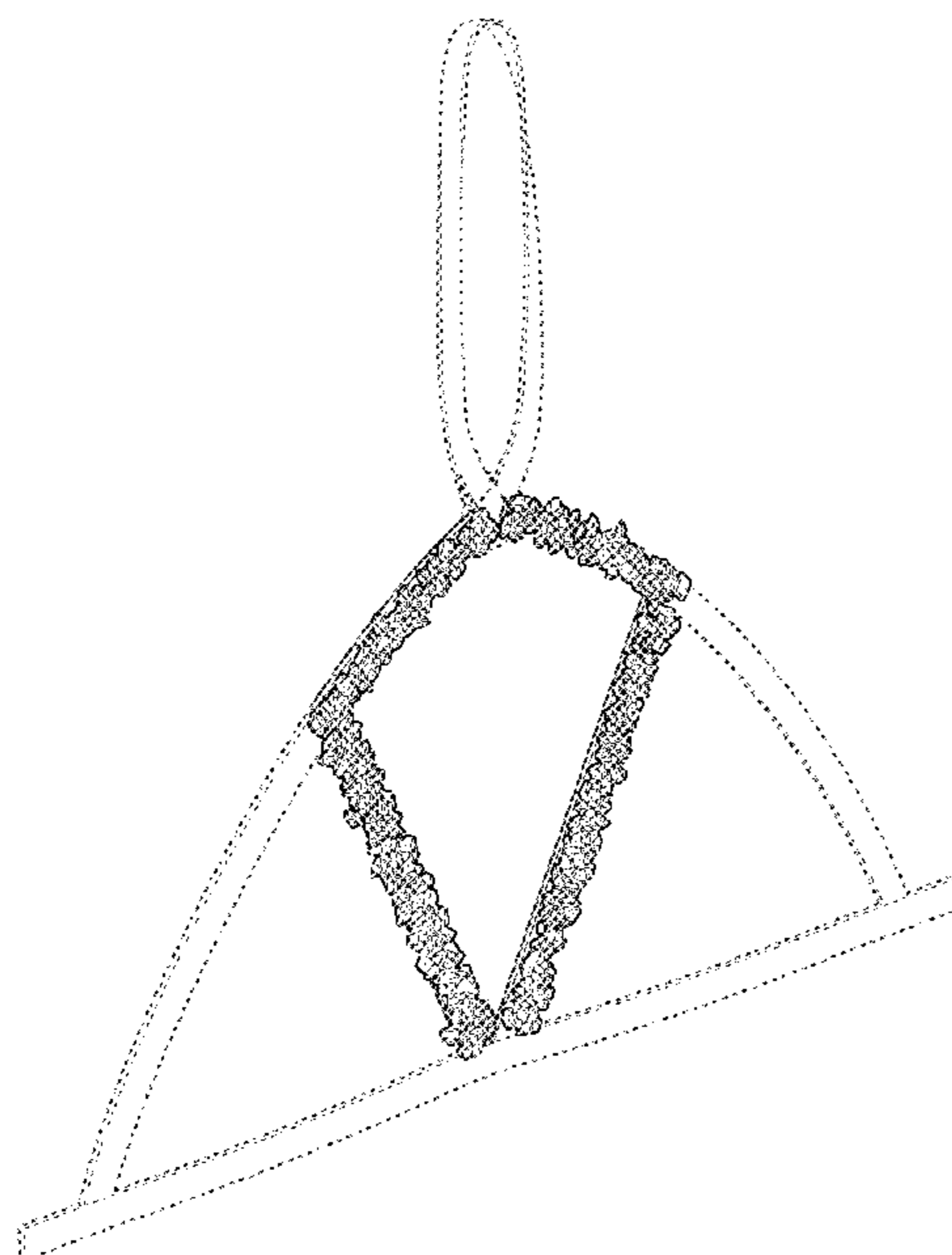
FIG. 6 is a top plan view of the gemstone cage harness; and,

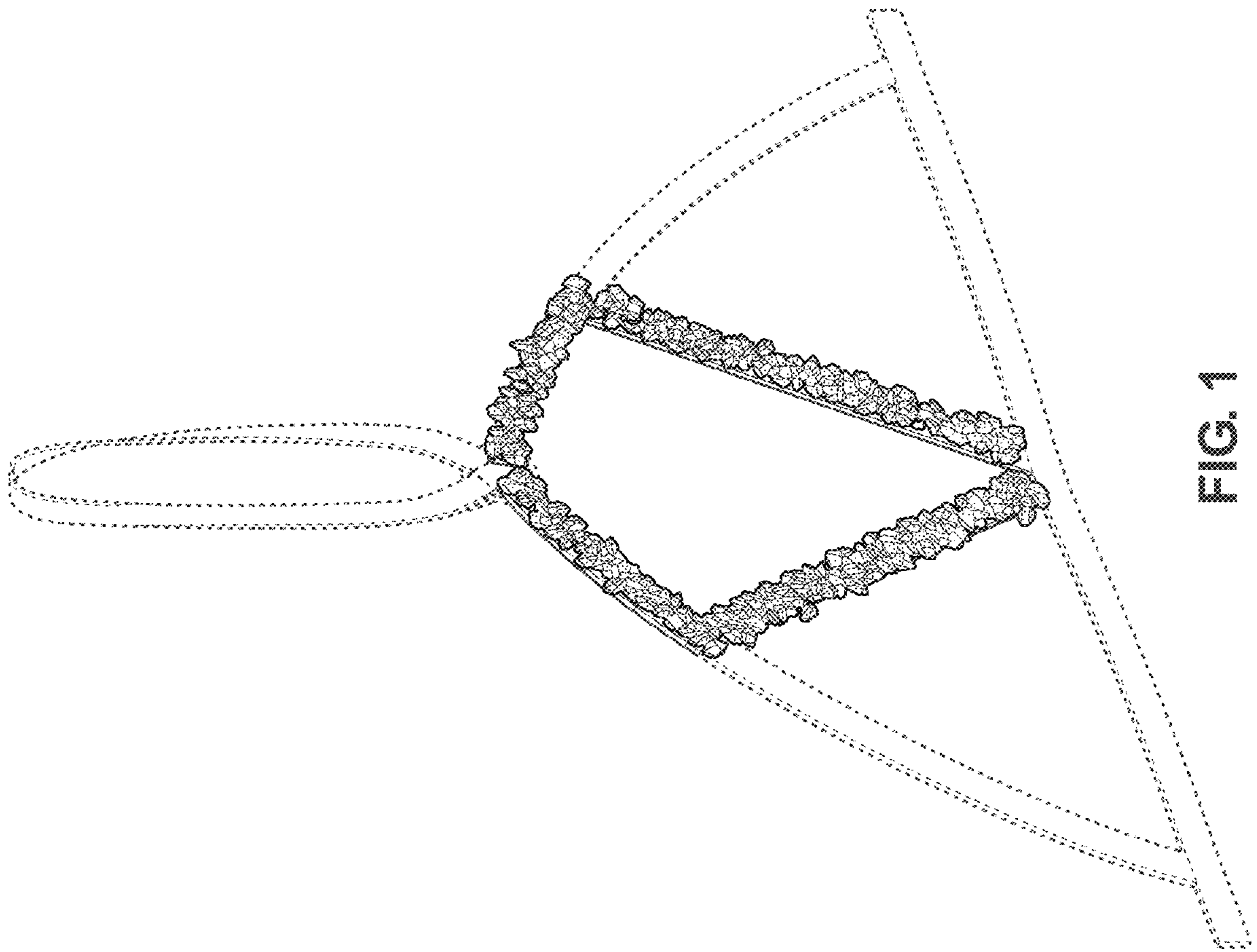

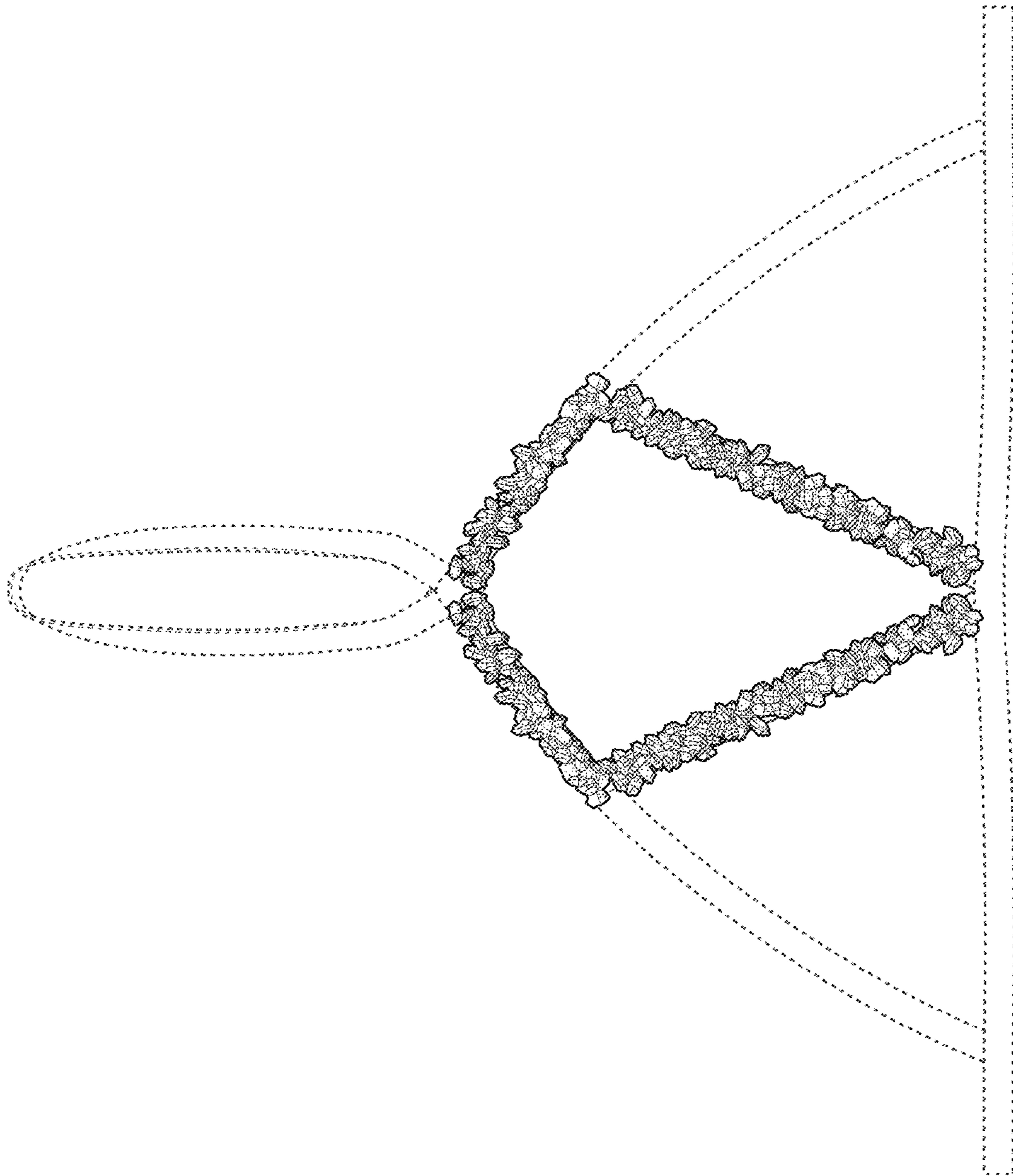

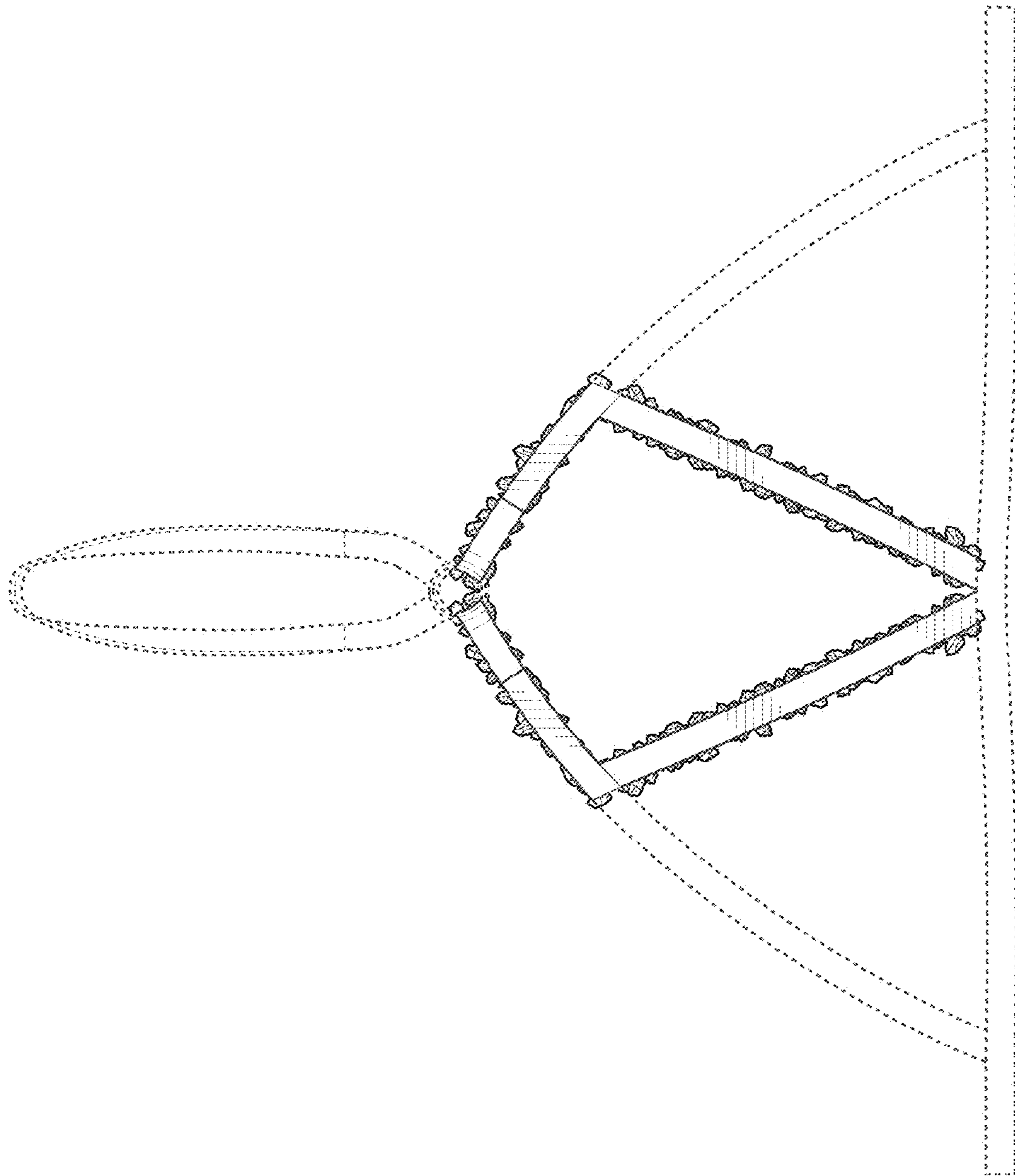

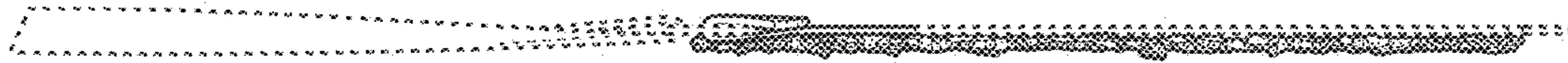
