The ornamental design for shorts, as shown and described.

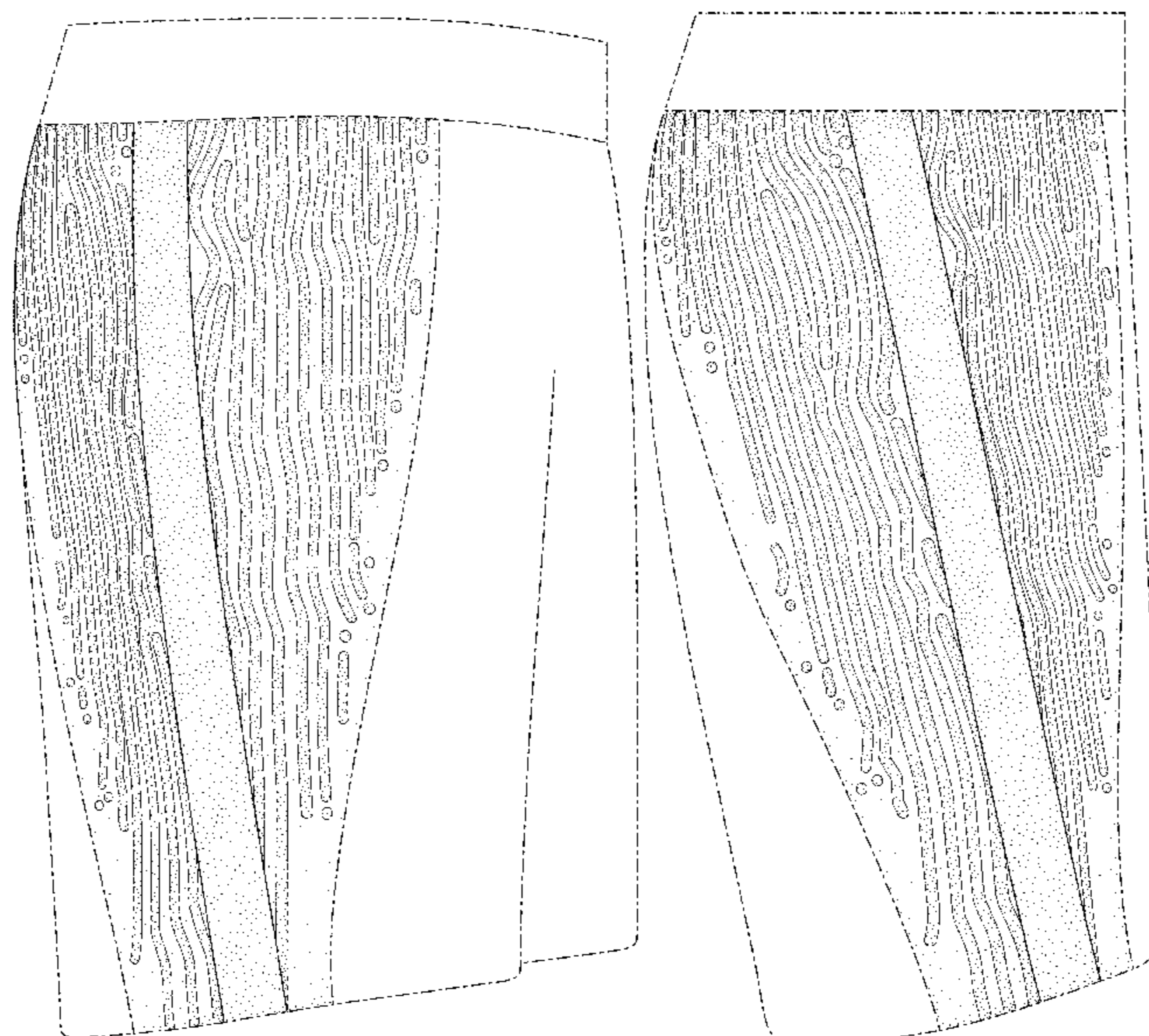
DESCRIPTION

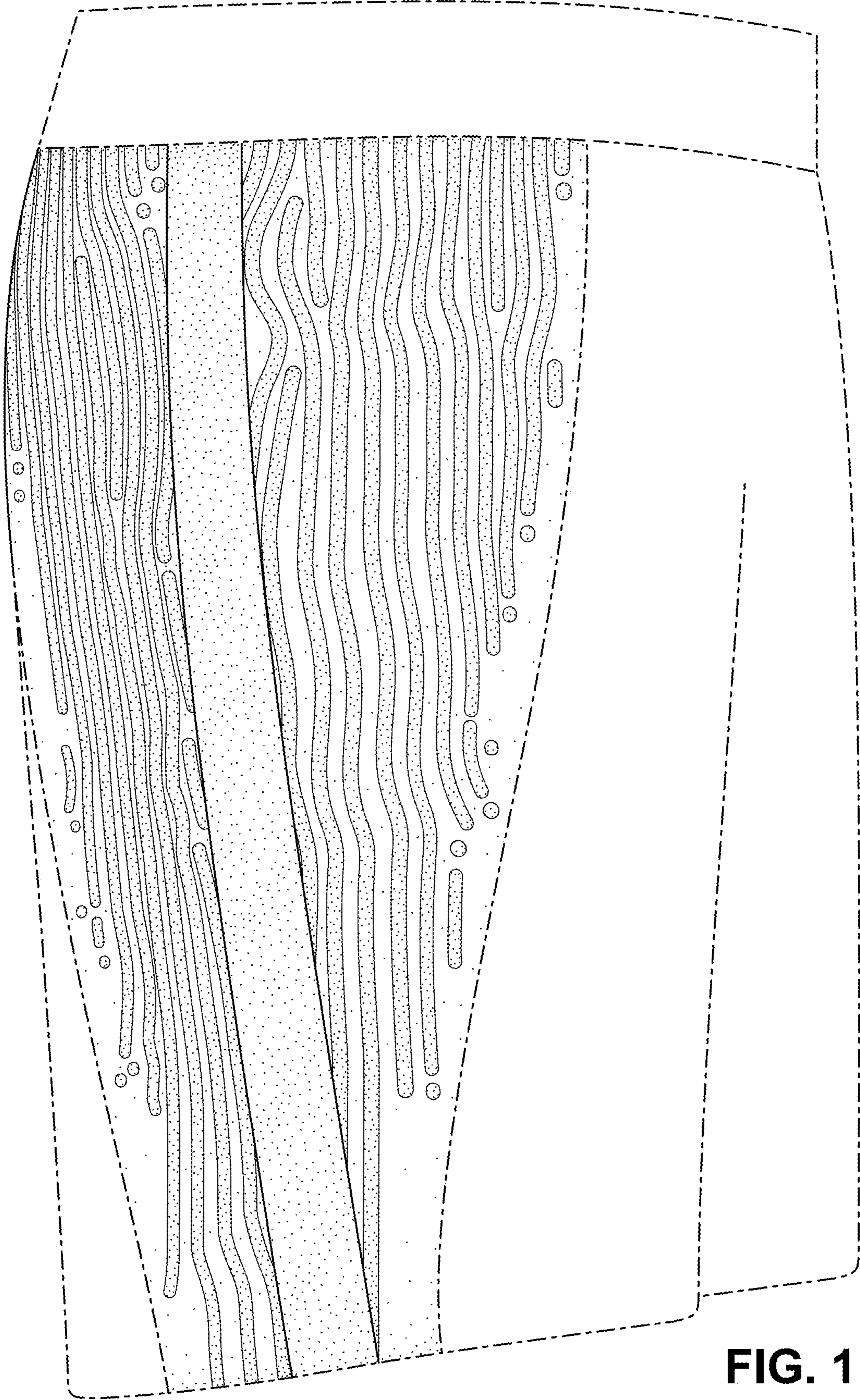

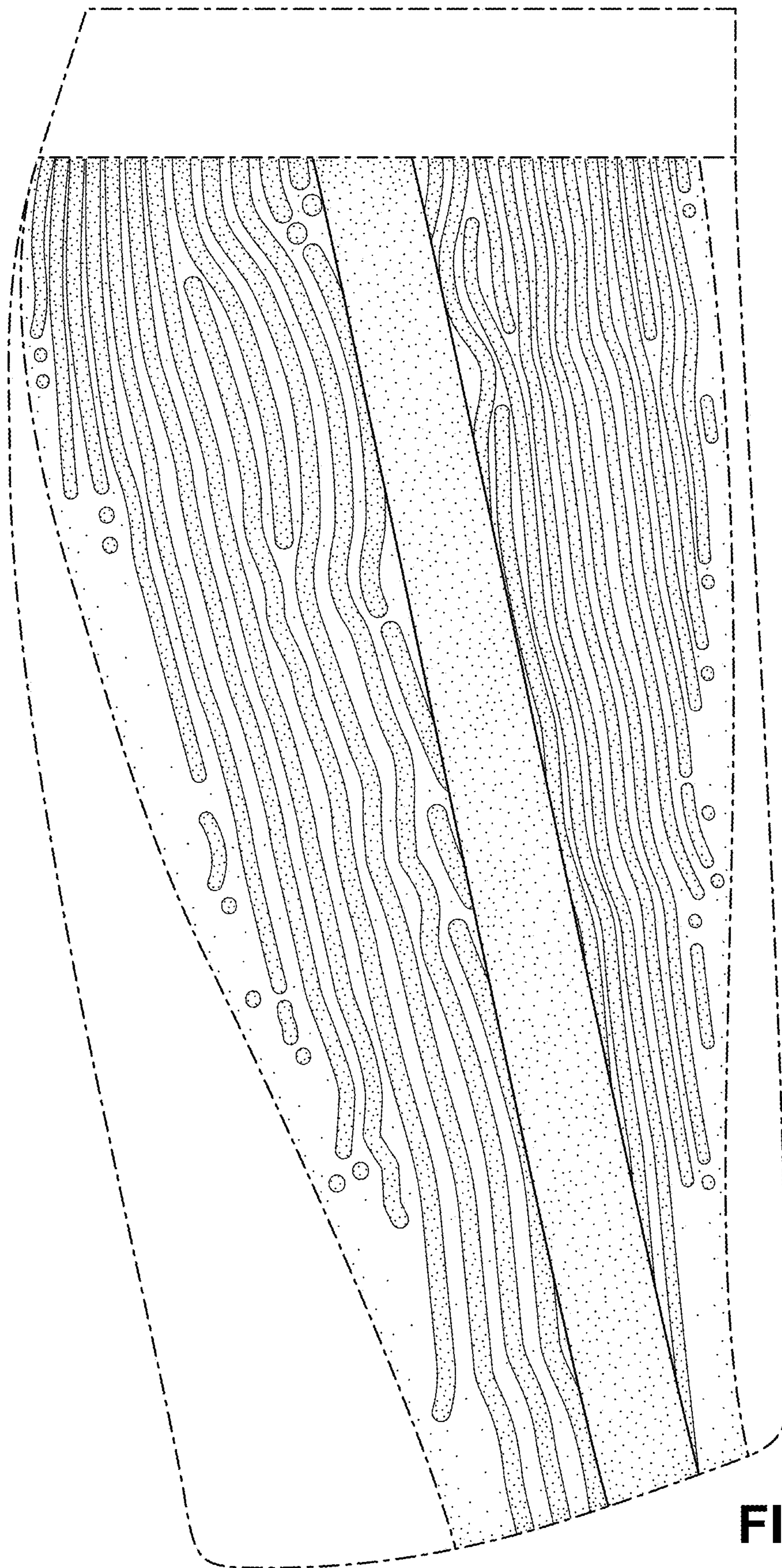
