(57) **CLAIM**

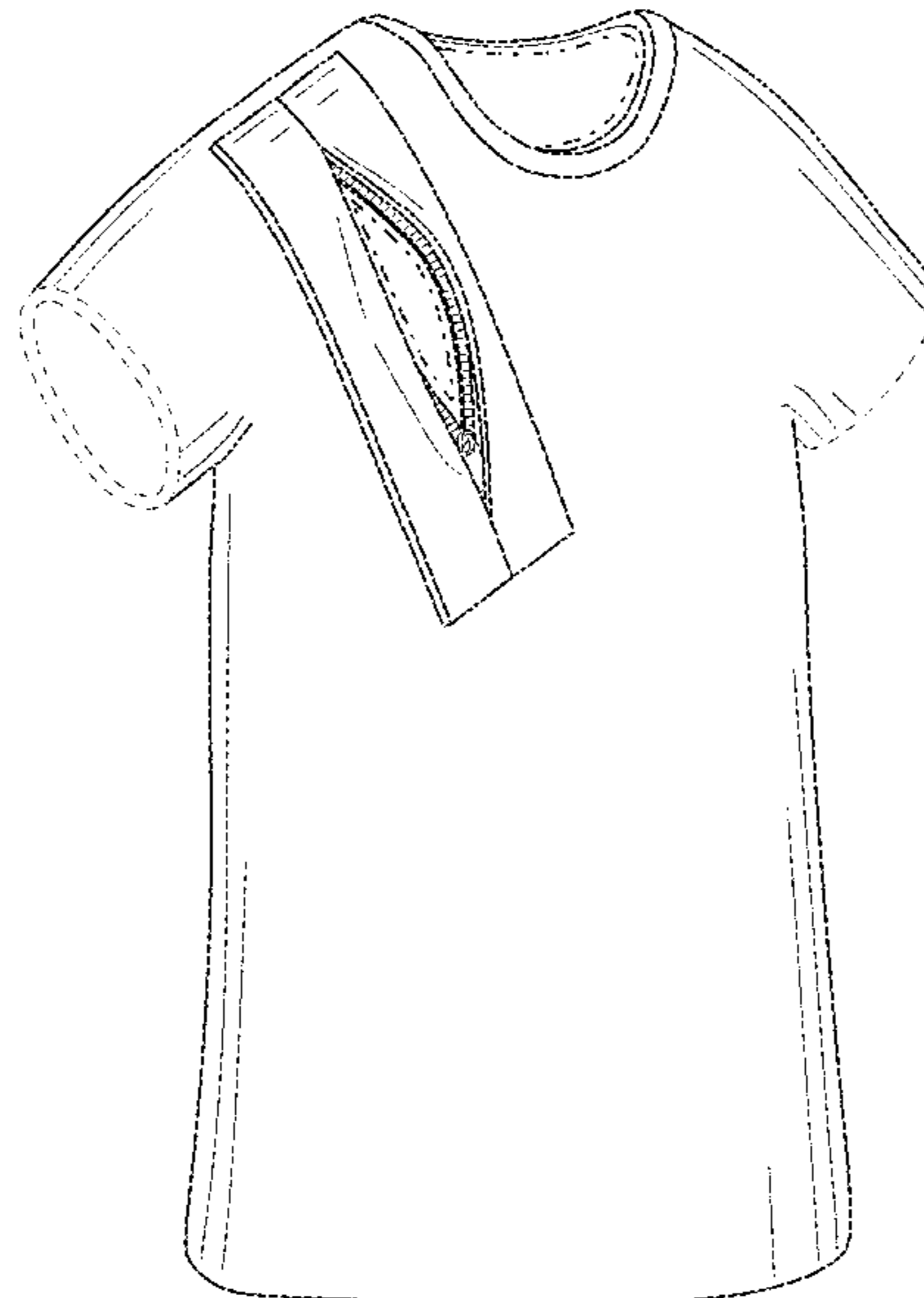
The ornamental design for a shirt with a zippered opening, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of the shirt with the zippered opening, showing my new design;
FIG. 2 is a front elevation view thereof;
FIG. 3 is a rear elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The evenly-sized broken lines shown in the drawings depict end portions of a sleeve that form no part of the claimed design.
The unevenly-sized broken lines define the bounds of the claimed design and form no part of the claimed design.

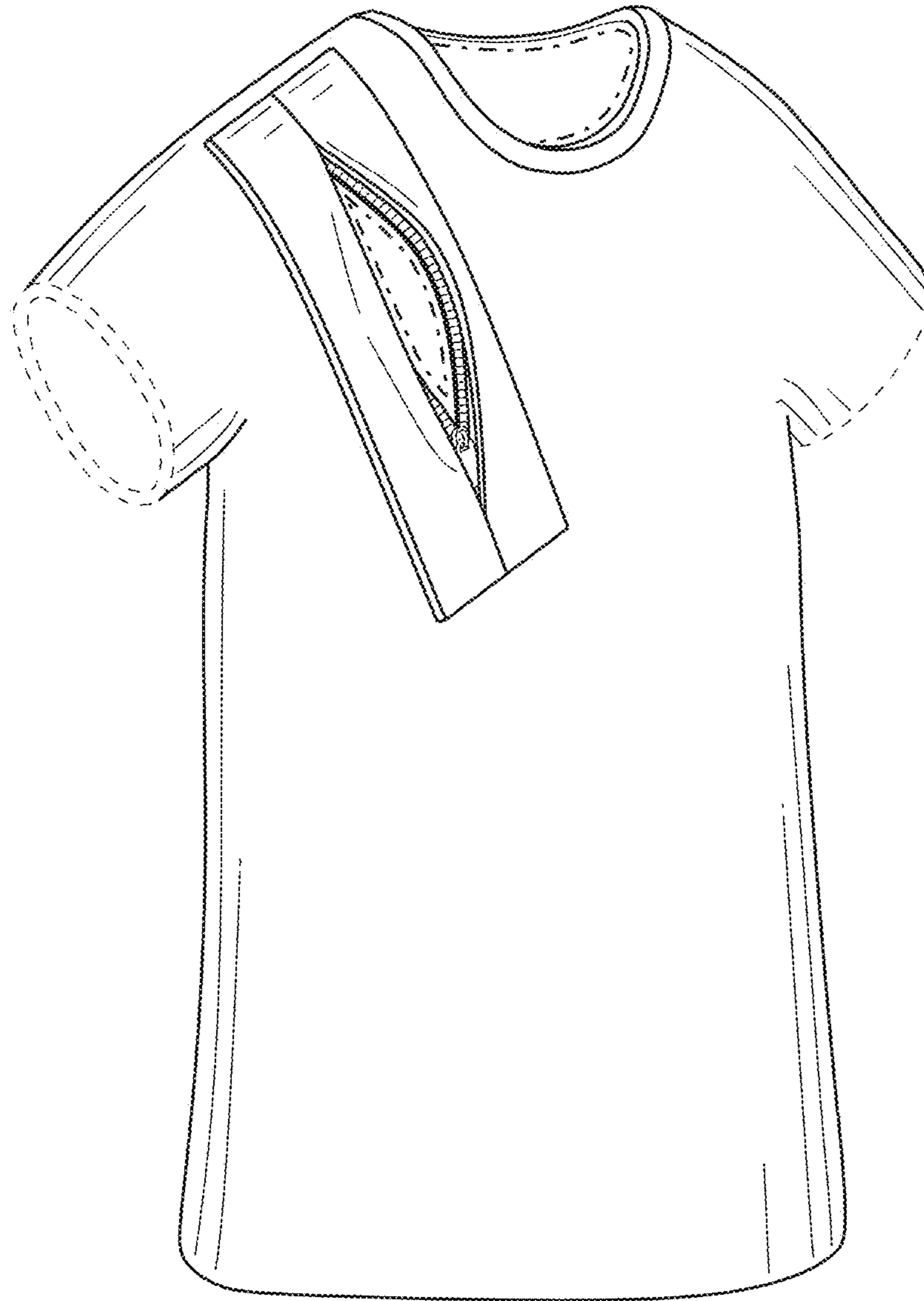

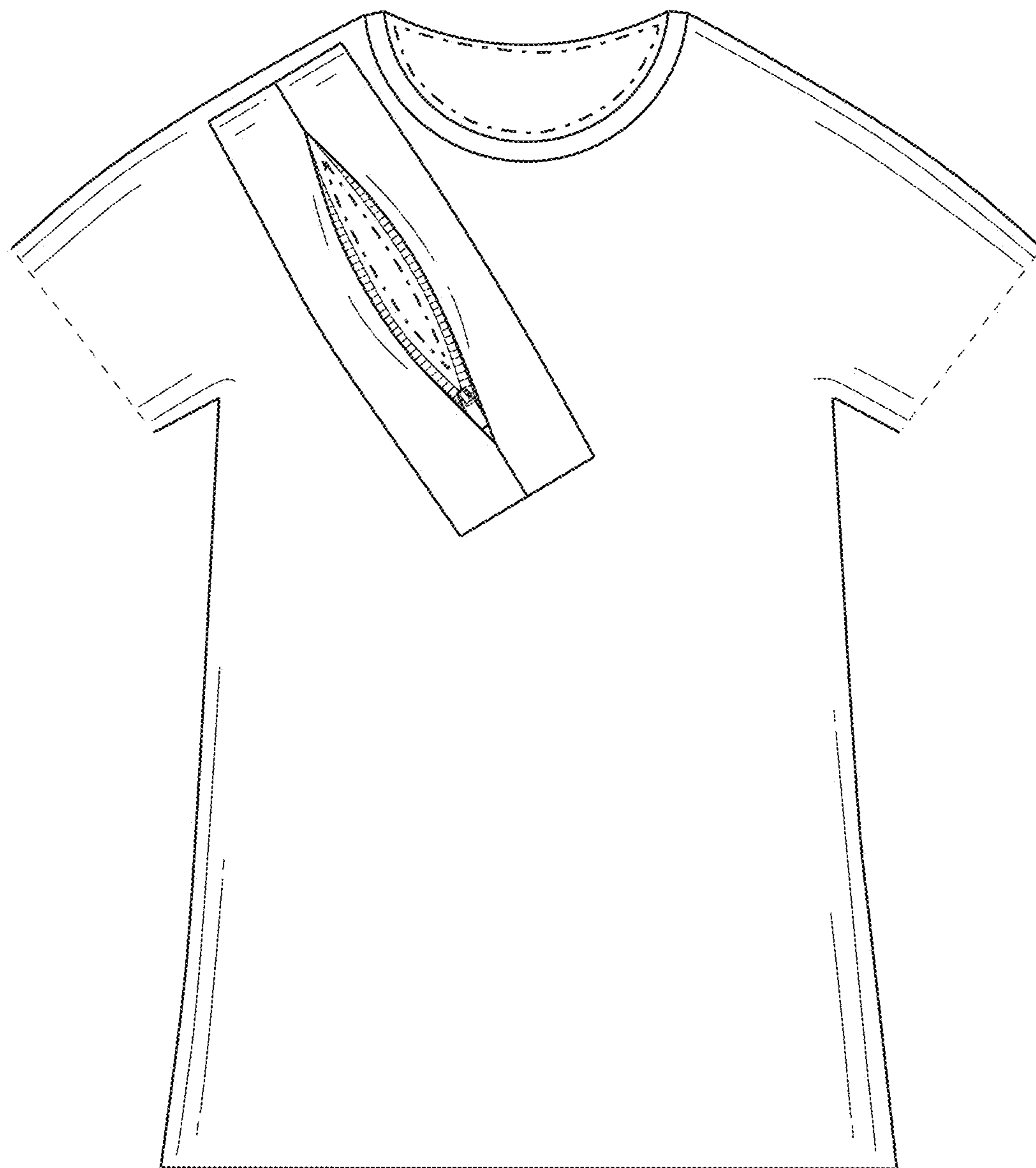

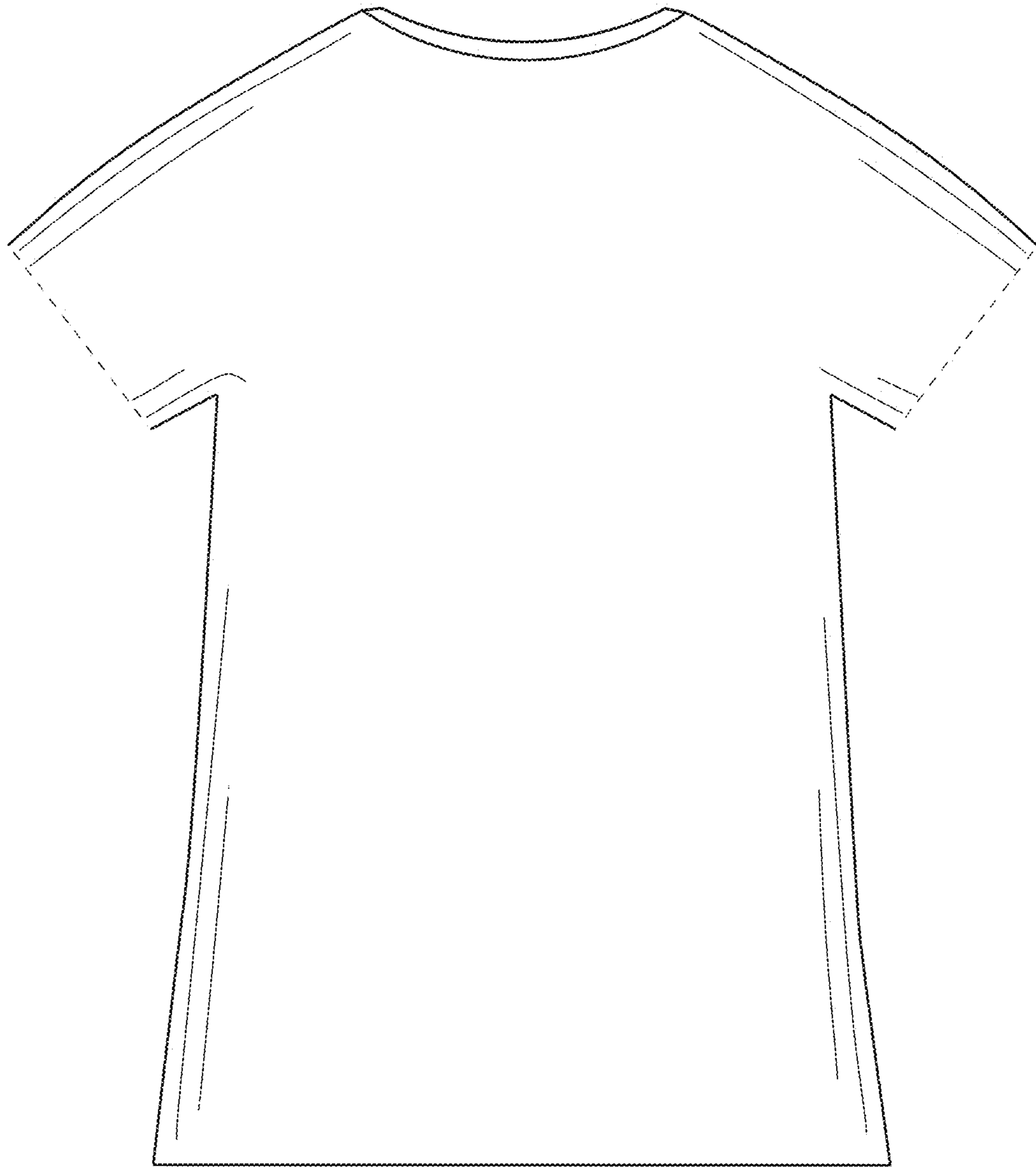

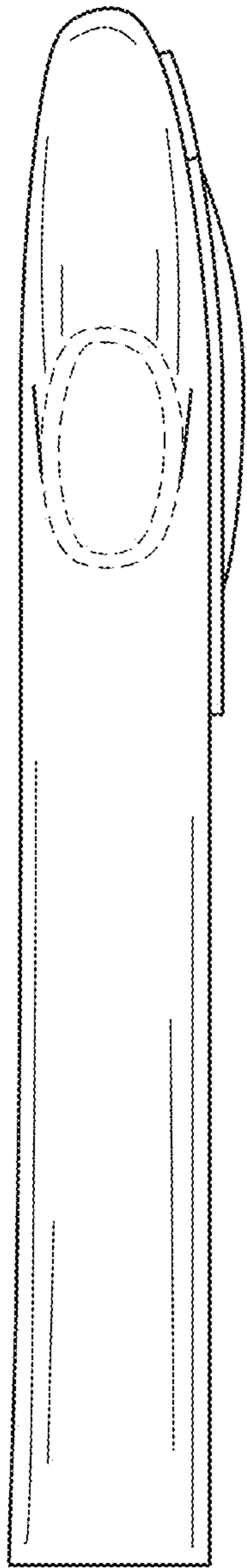

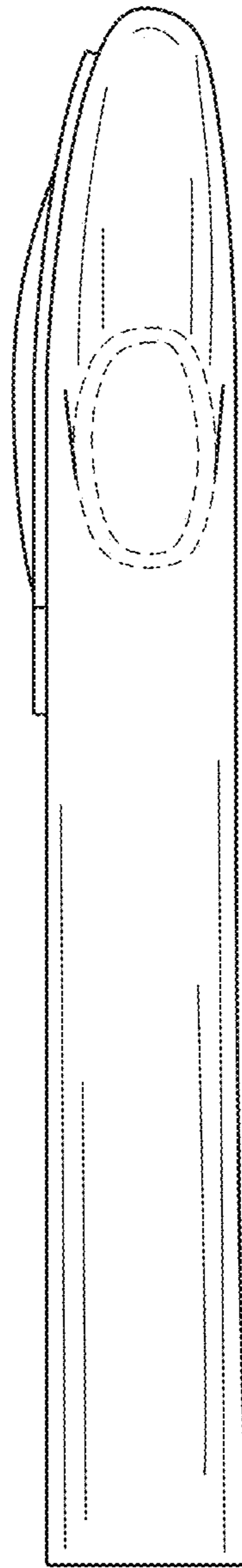

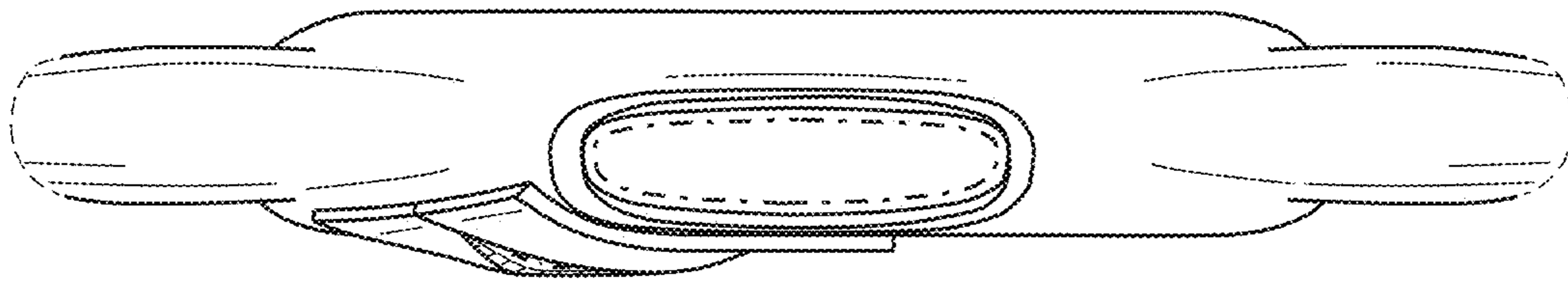

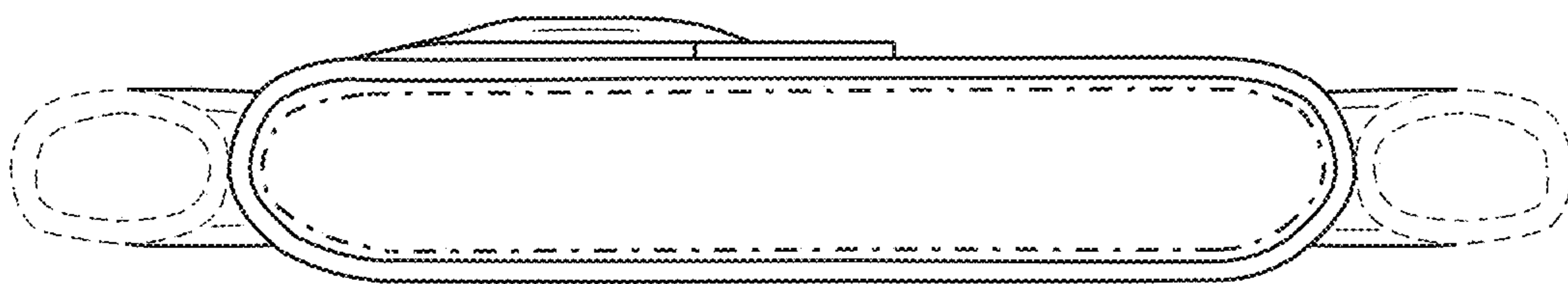
