(57) **CLAIM**

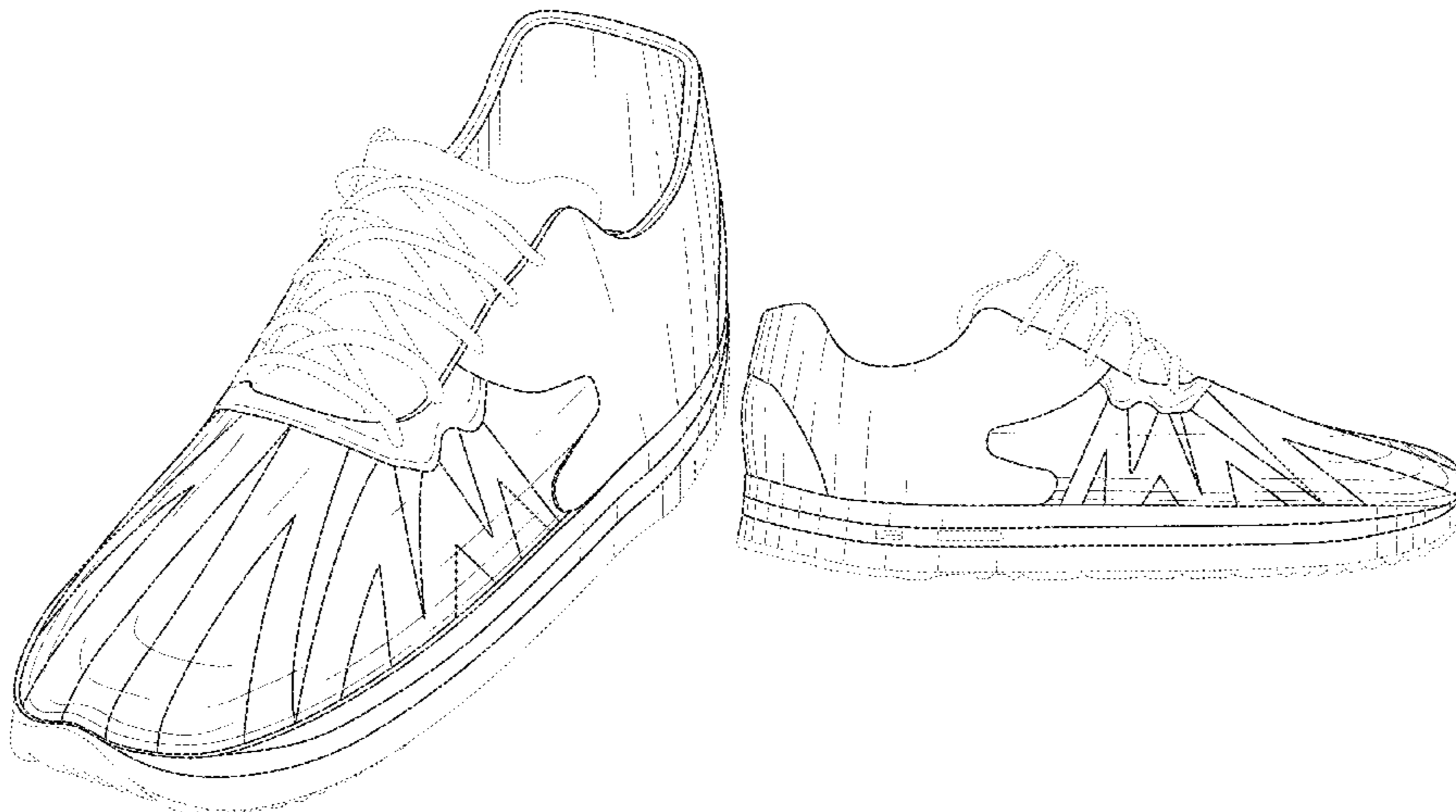
The ornamental design for a sneaker, as shown and described.

DESCRIPTION

FIG. 1 is a front-top-left perspective view of a sneaker showing my new design;
FIG. 2 is a rear-bottom-right perspective view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is a right side elevation view thereof; and,
FIG. 8 is a left side elevation view thereof.

The broken lines in the drawings depicting the tongue and laces in FIGS. 1-5 and 7-8, the port and battery in FIGS. 2 and 7, threading in FIGS. 1-4 and 6-8, and the bottom surface of the outsole in FIGS. 1-4 and 8-8 are included for the purpose of showing portions of the invention that form no part of the claimed design.

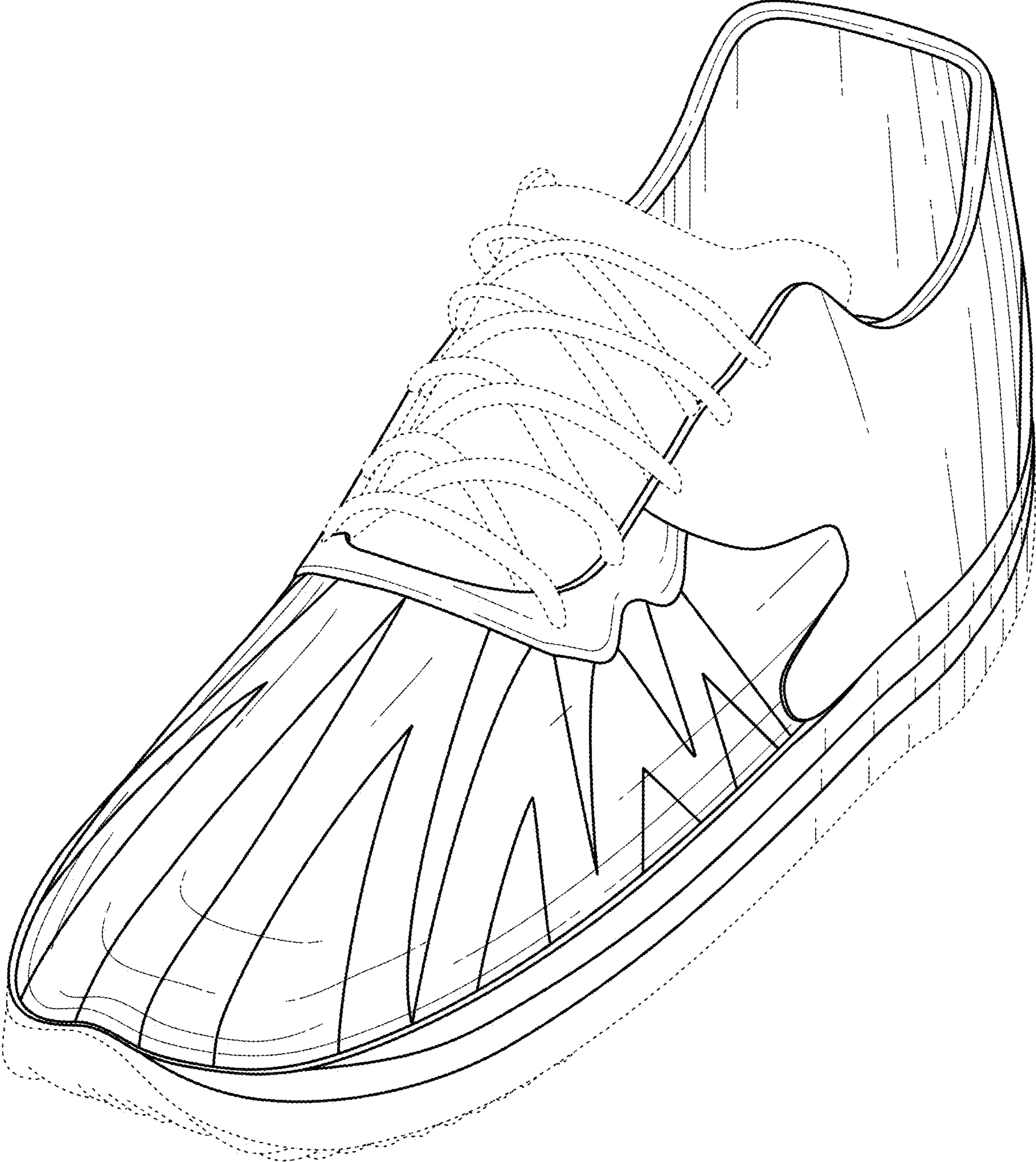

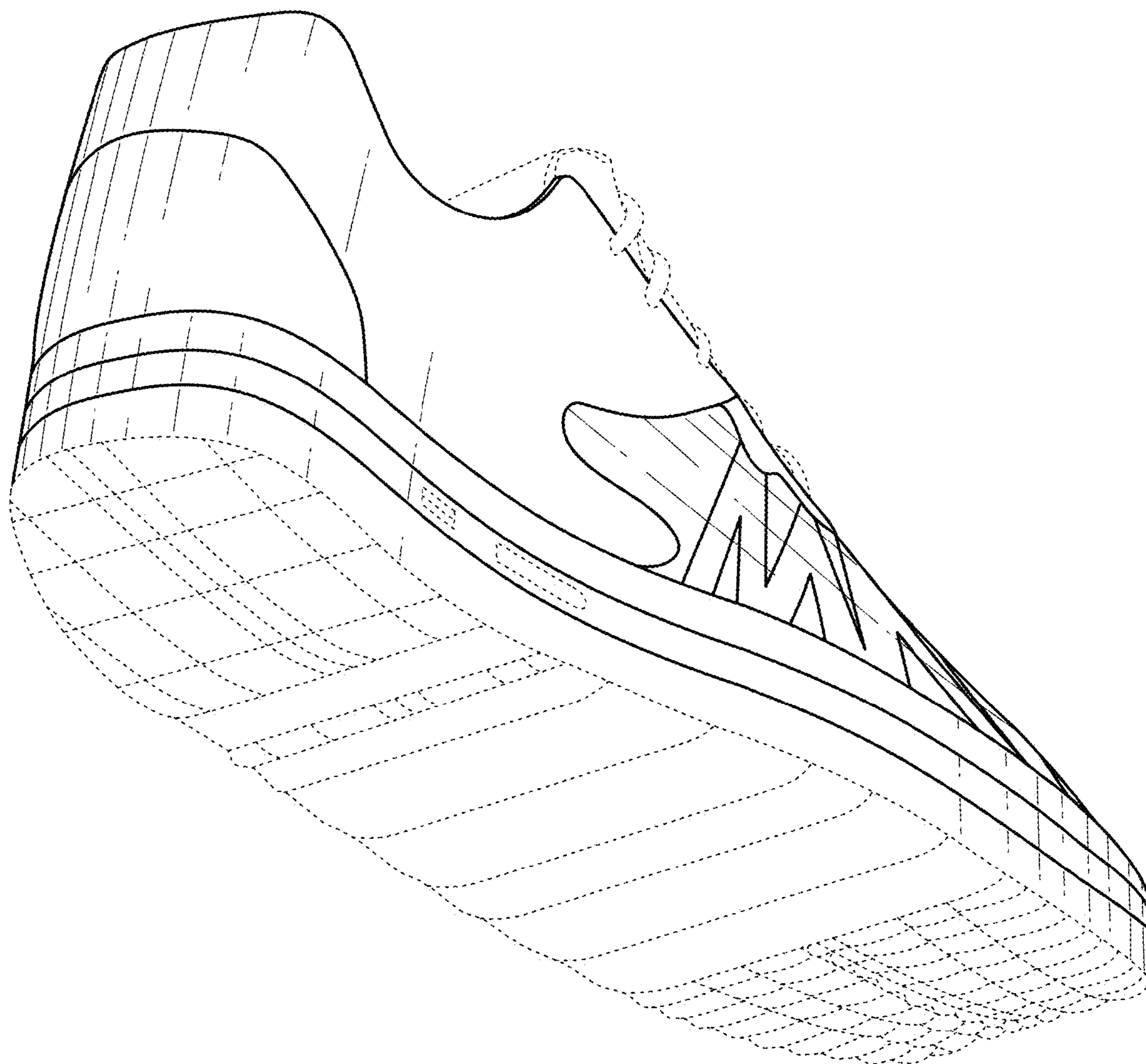

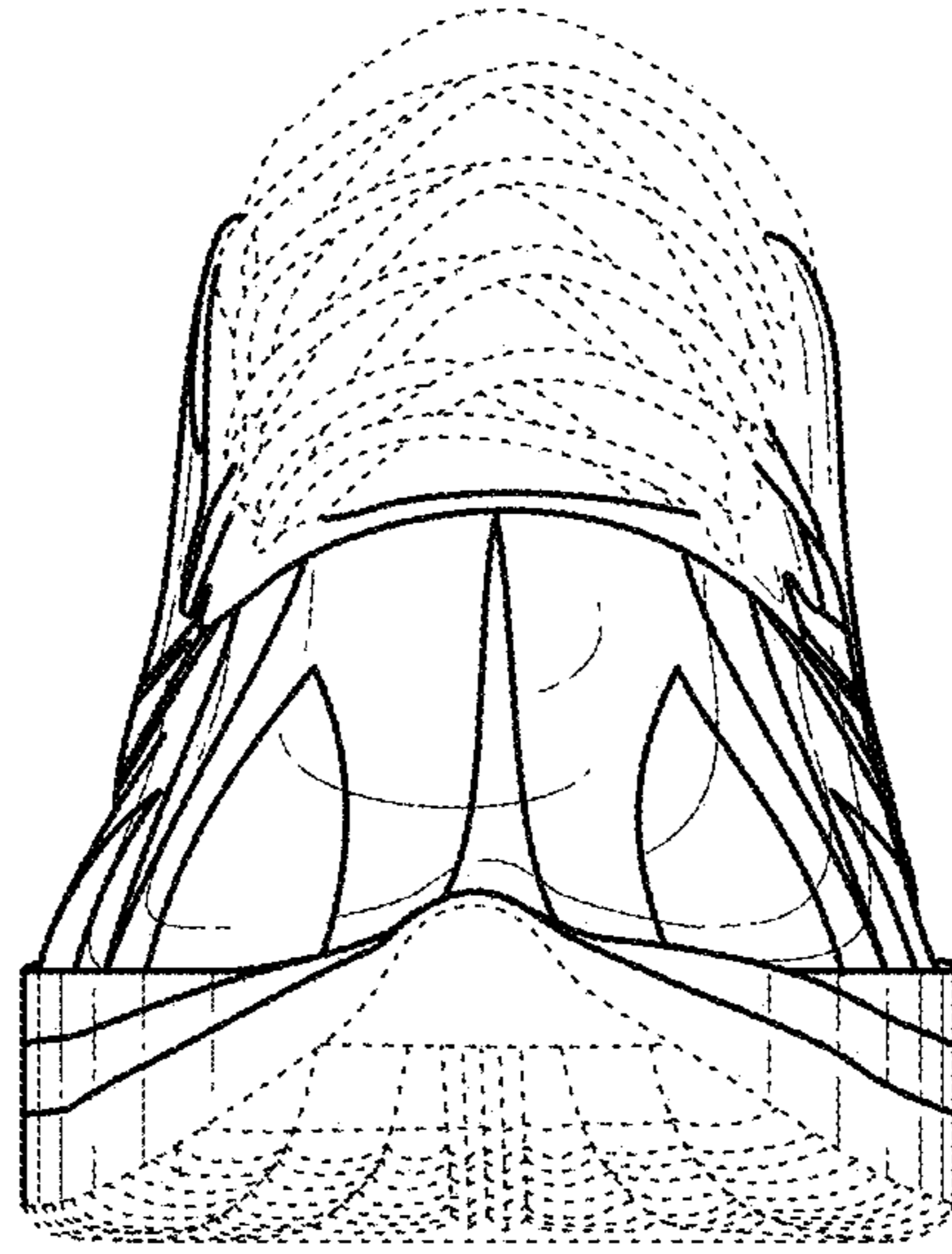

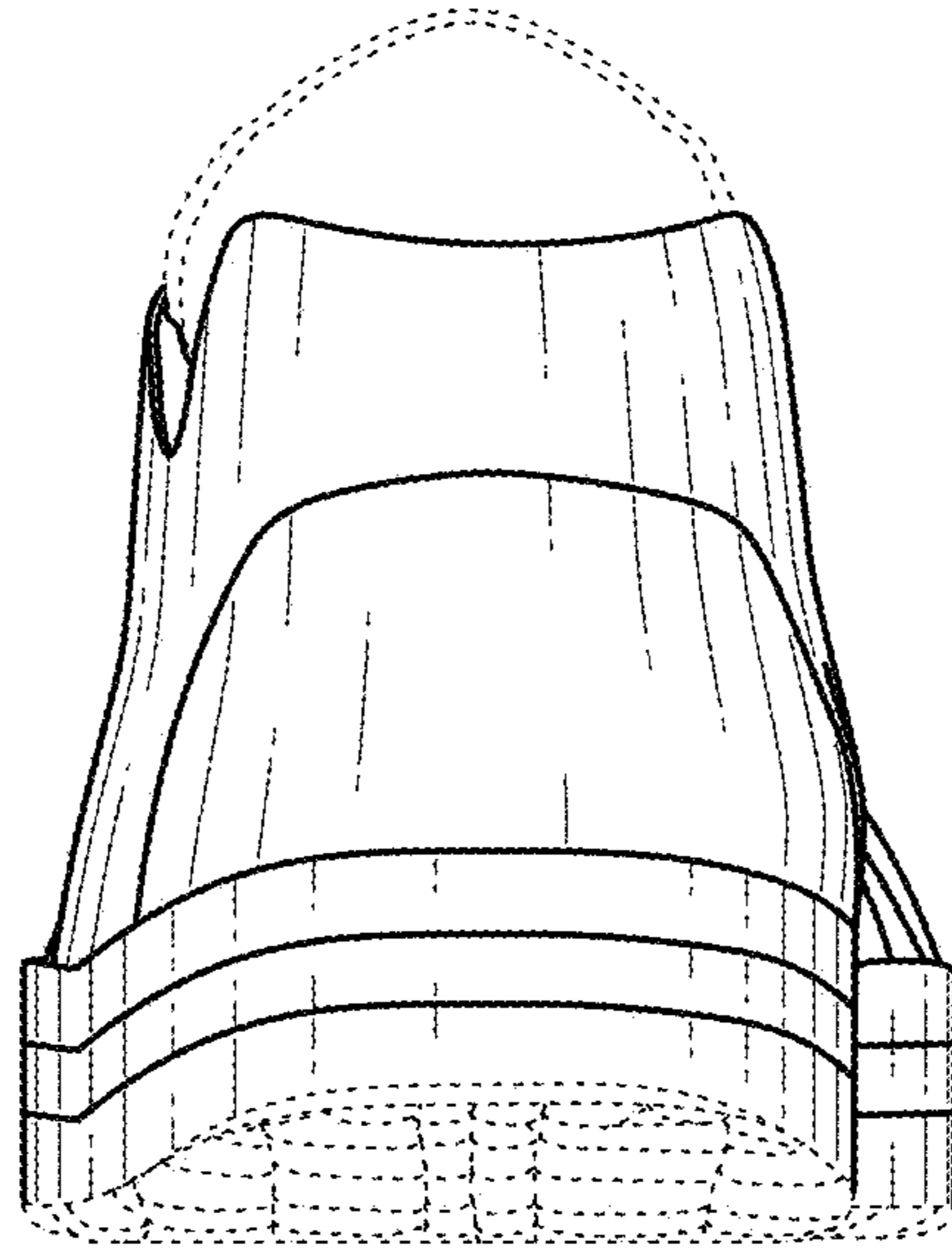

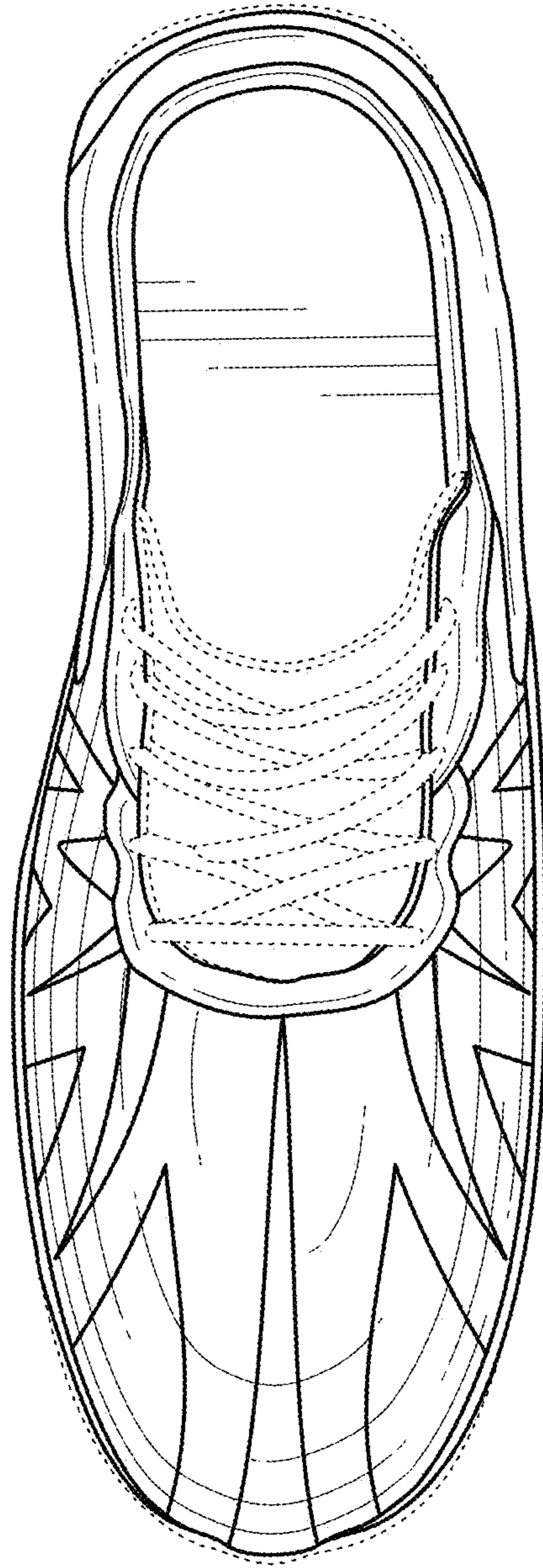

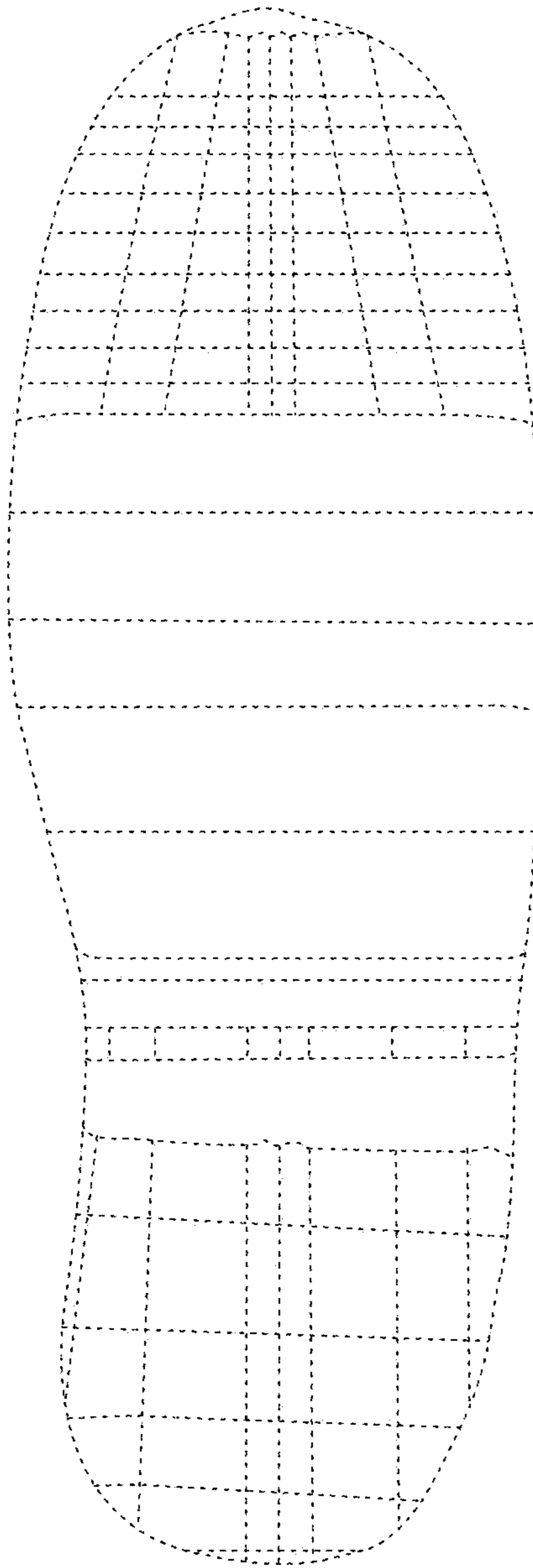

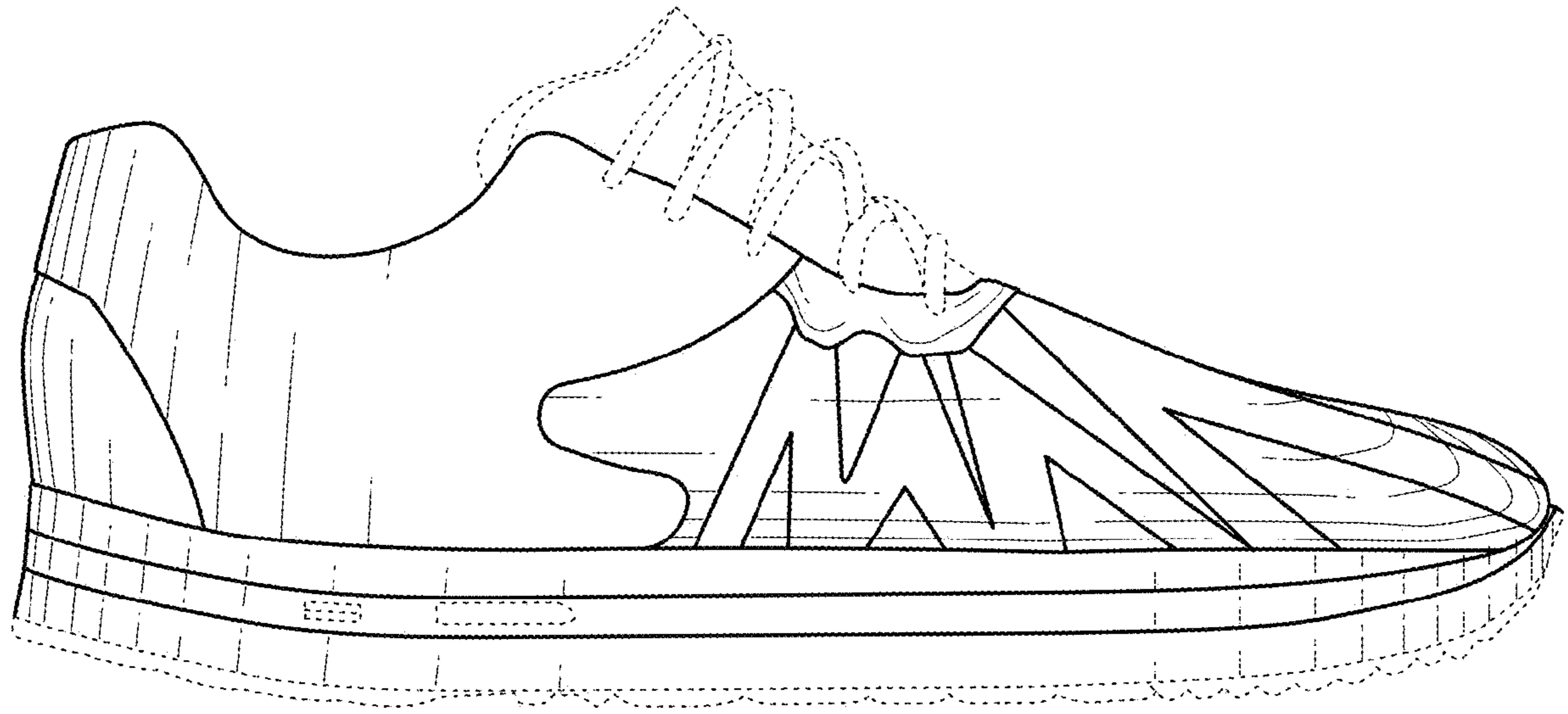

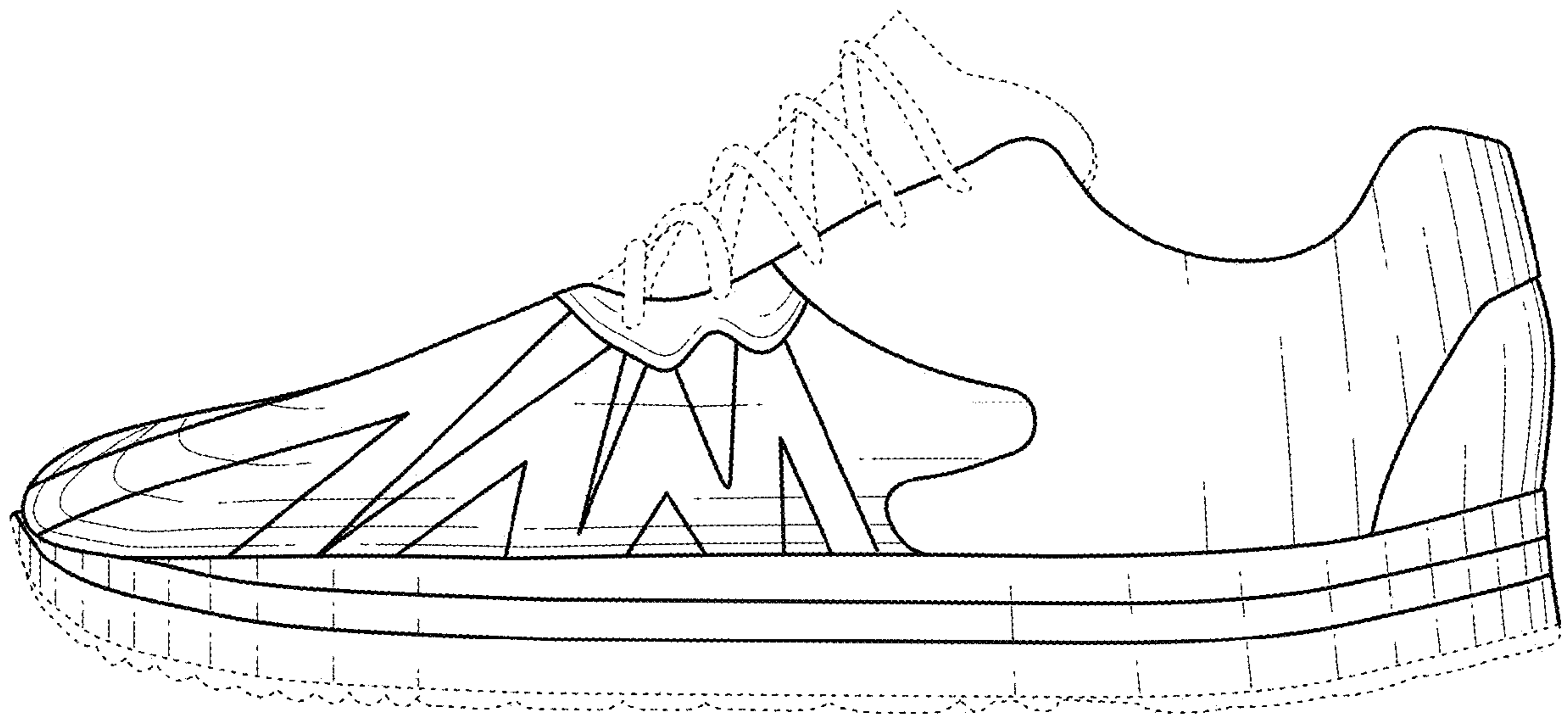
