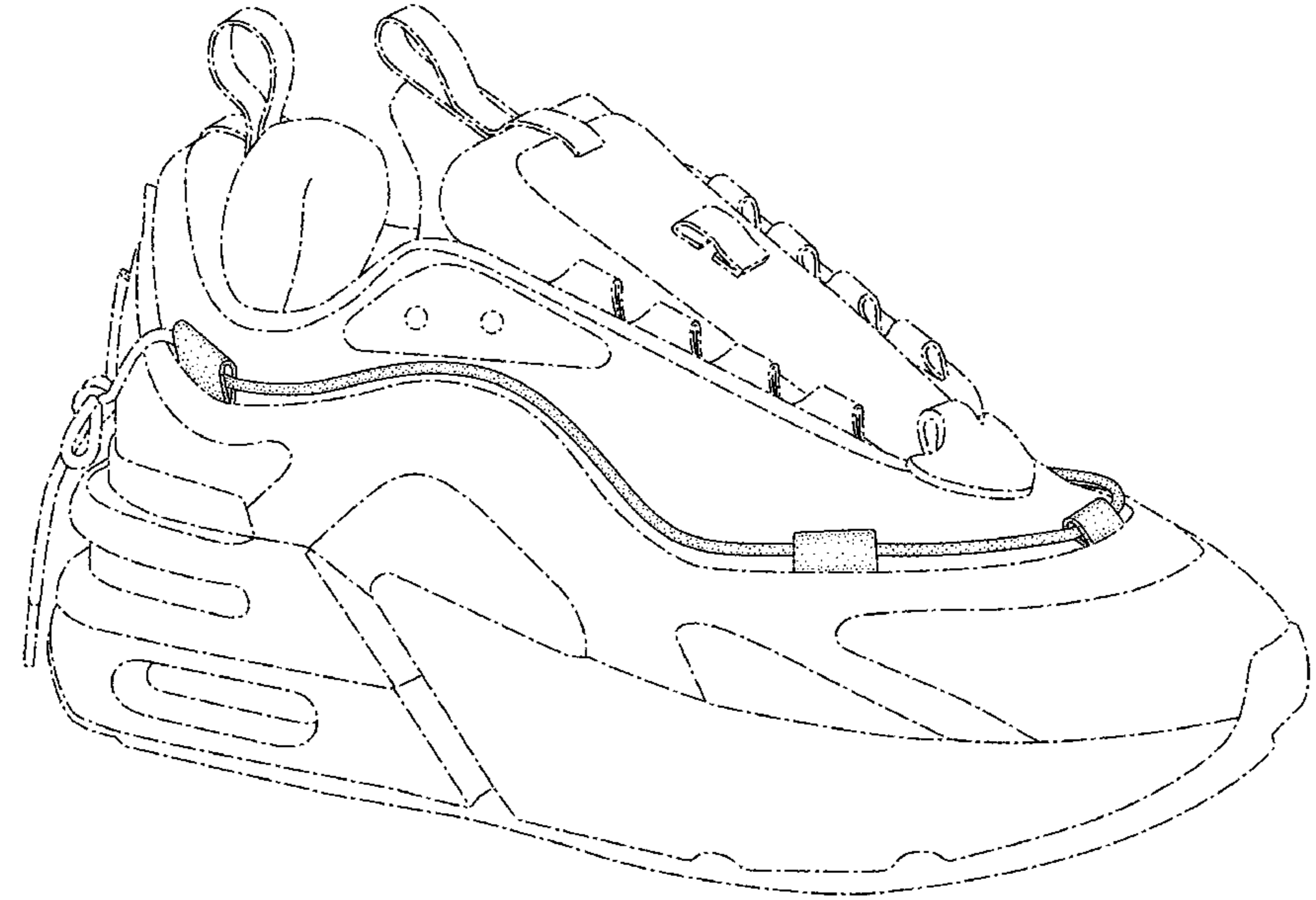
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a rear perspective view thereof;
FIG. 4 is a front view thereof;
FIG. 5 is an opposite side view thereof; and,
FIG. 6 is an opposite side front perspective view thereof.
The broken lines immediately adjacent to the bottom of the five shaded loop elements define the bounds of the claimed design and form no part thereof. The broken lines depicting the remainder of the shoe form no part of the claimed design.

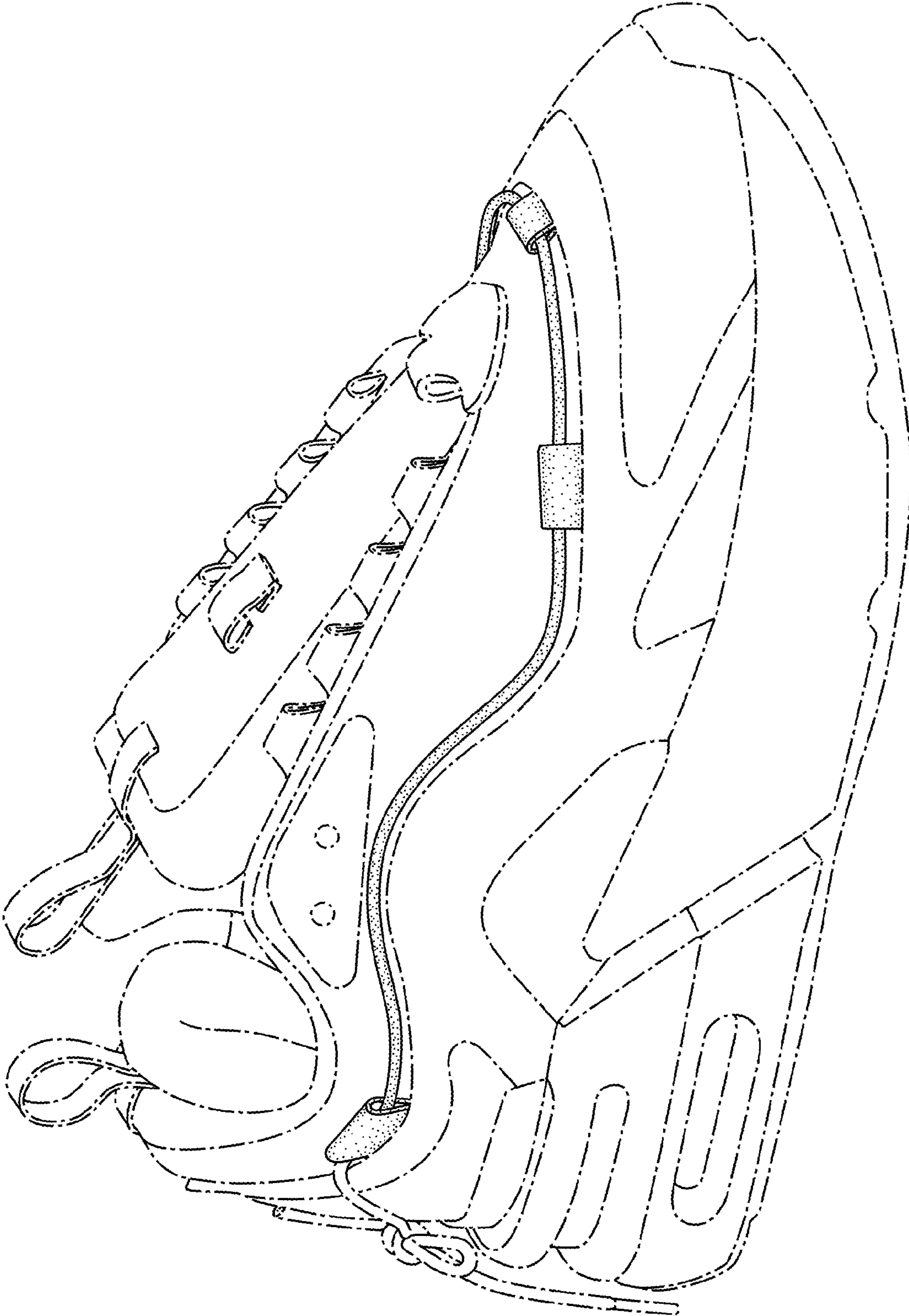

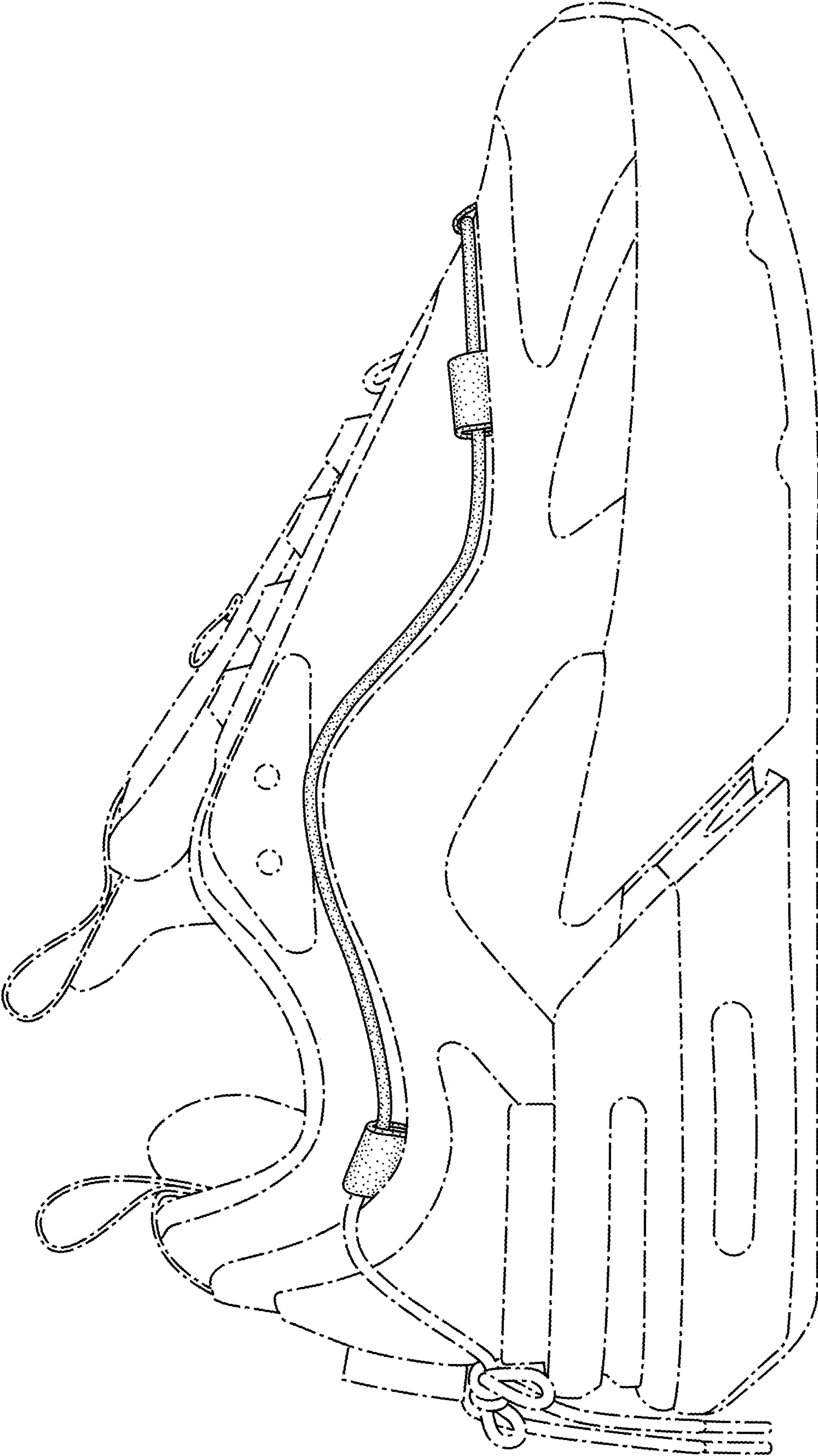

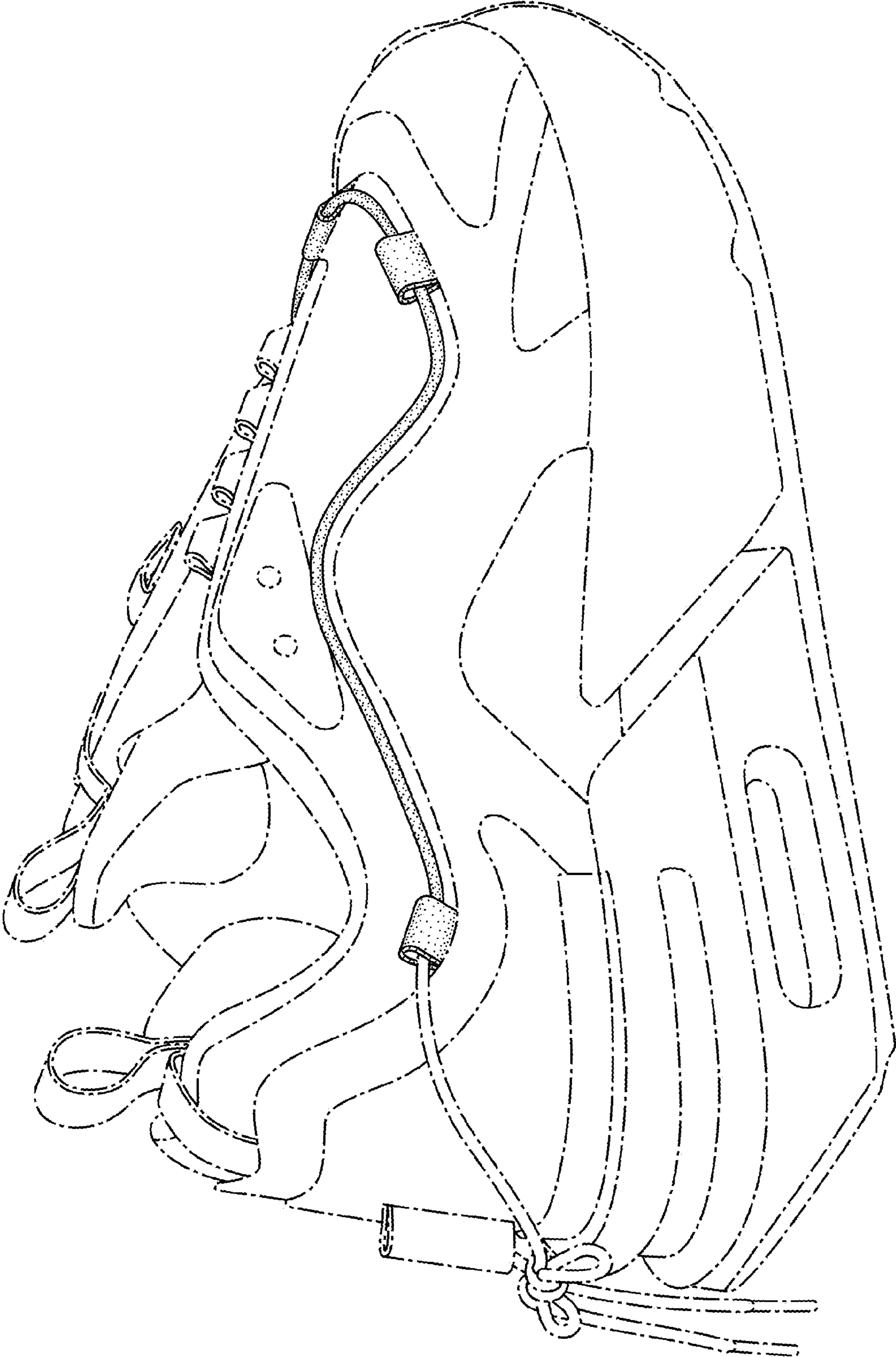

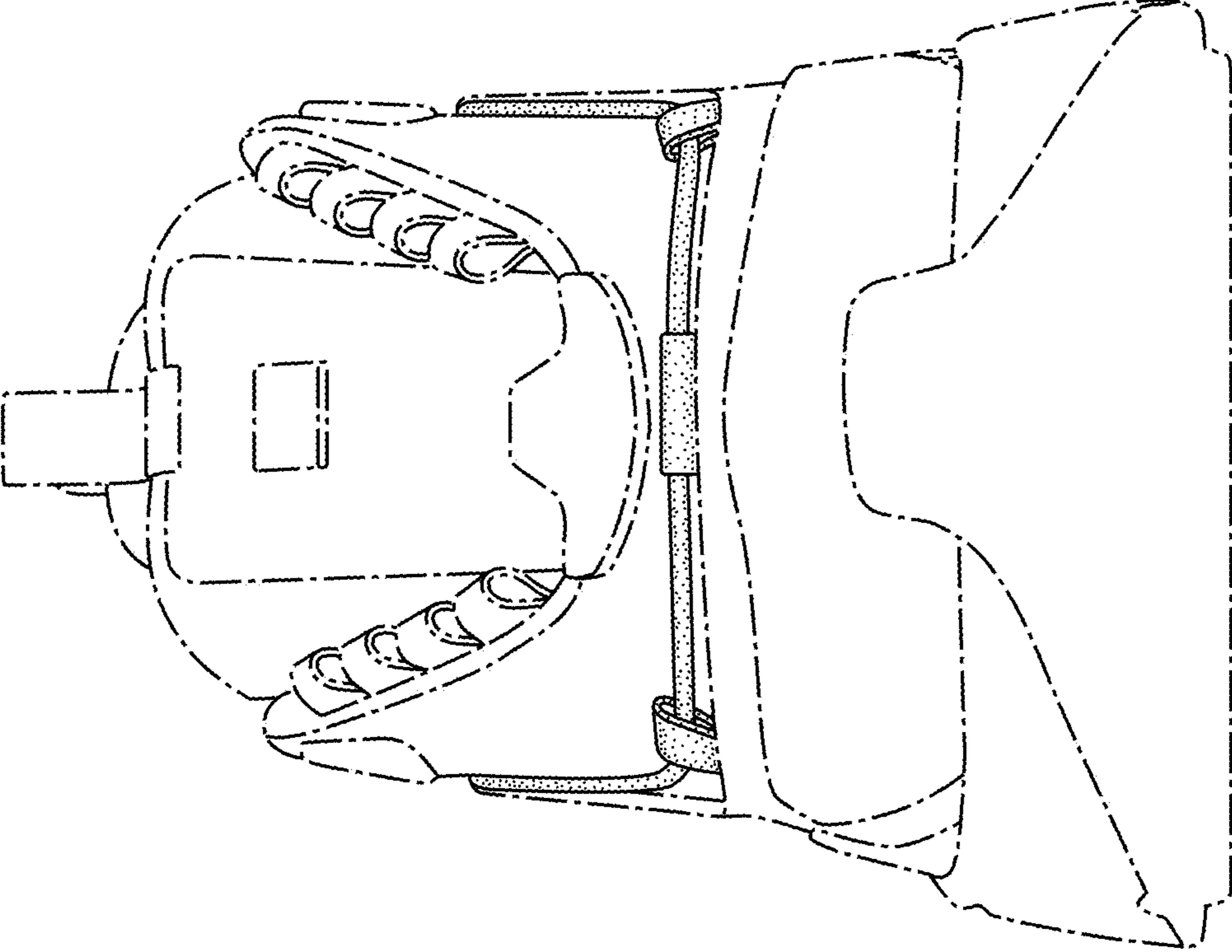

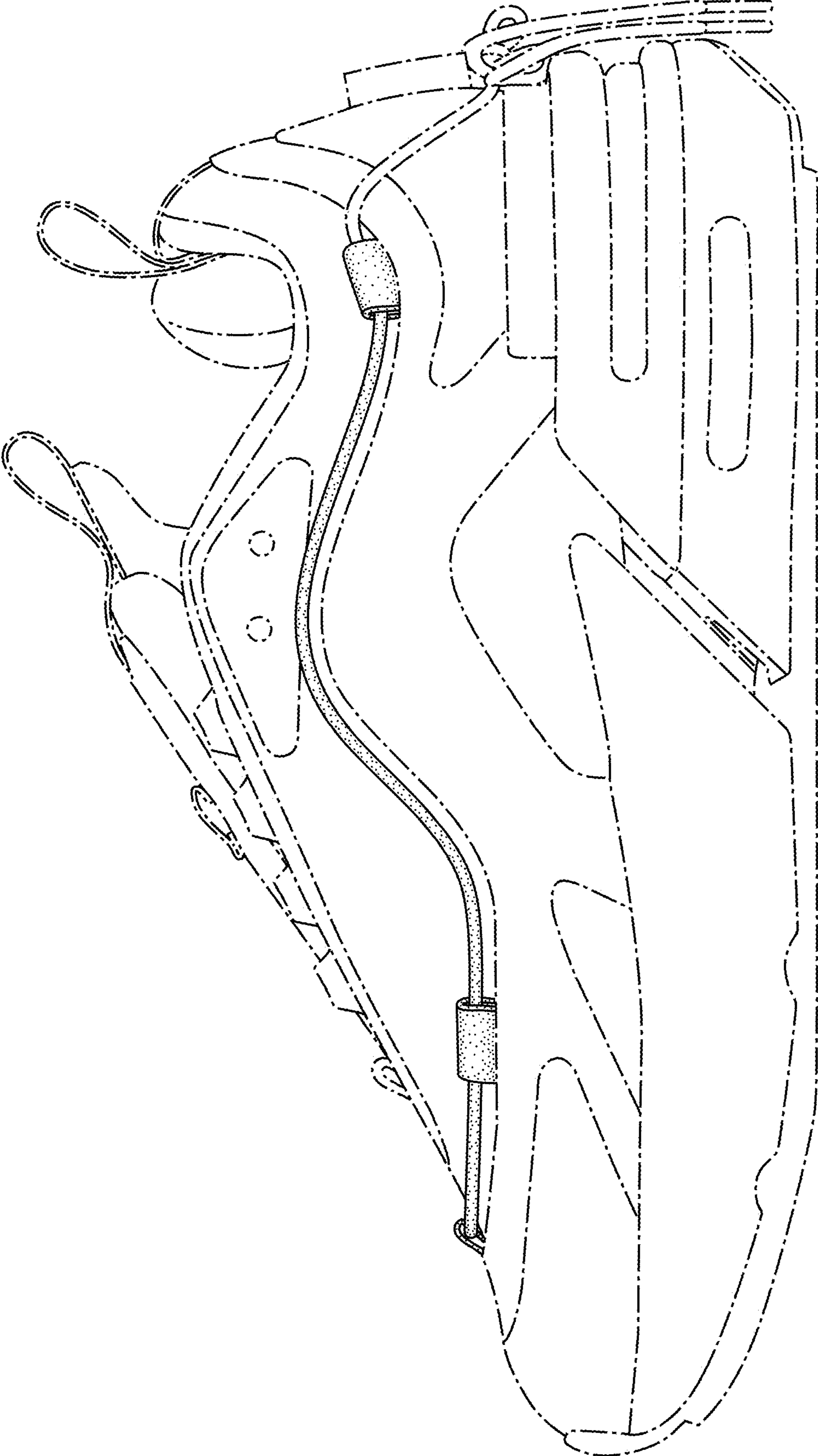

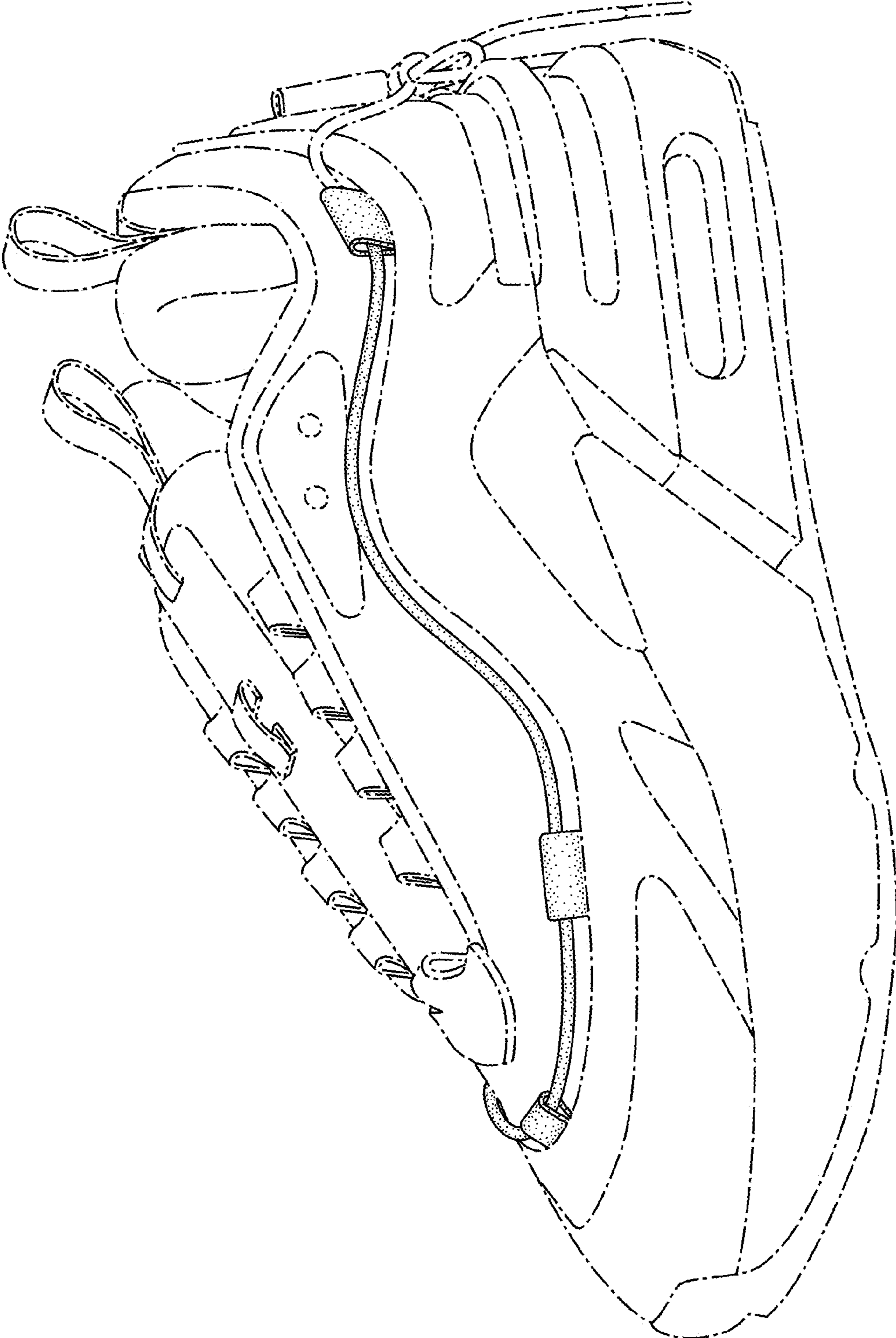
