**DESCRIPTION**

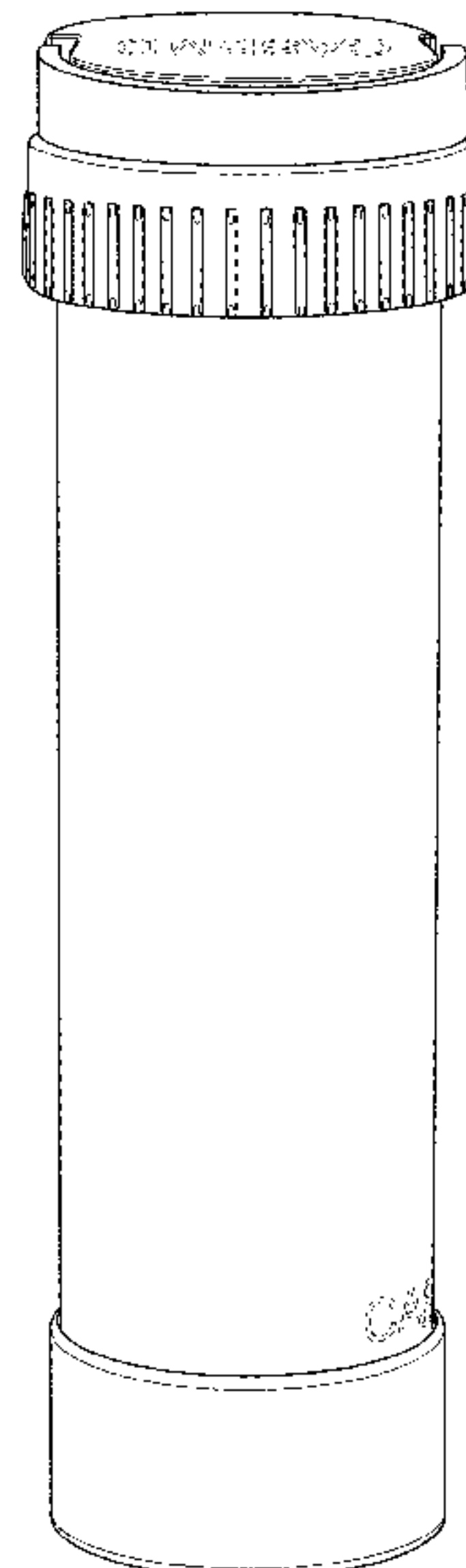
FIG. 1 is a front perspective view of an insulated medication container;

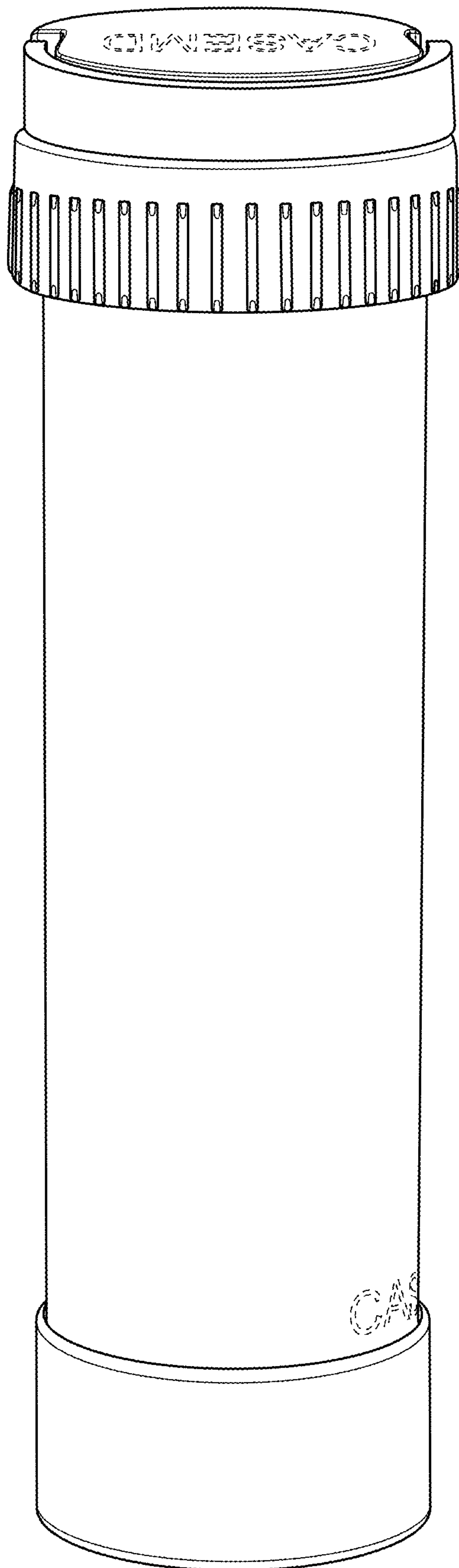

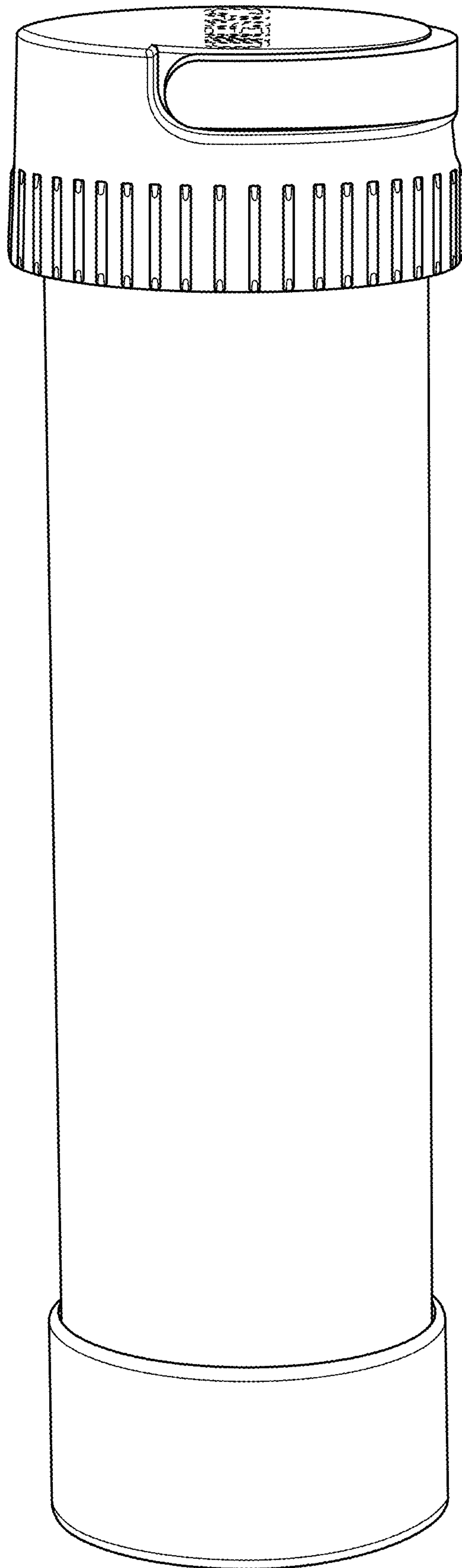

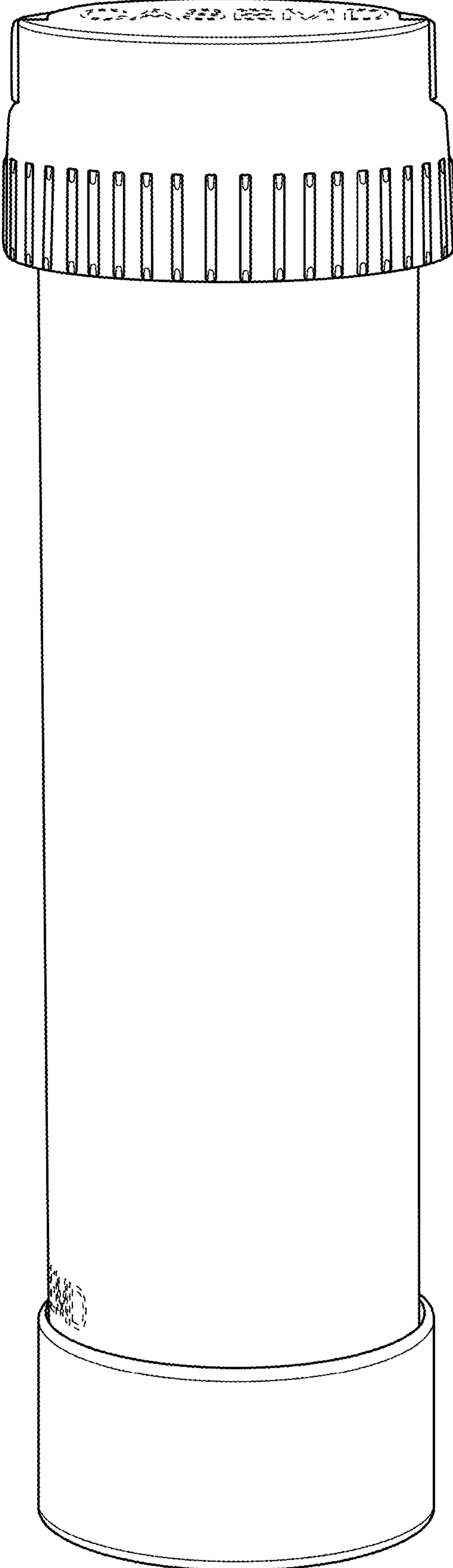

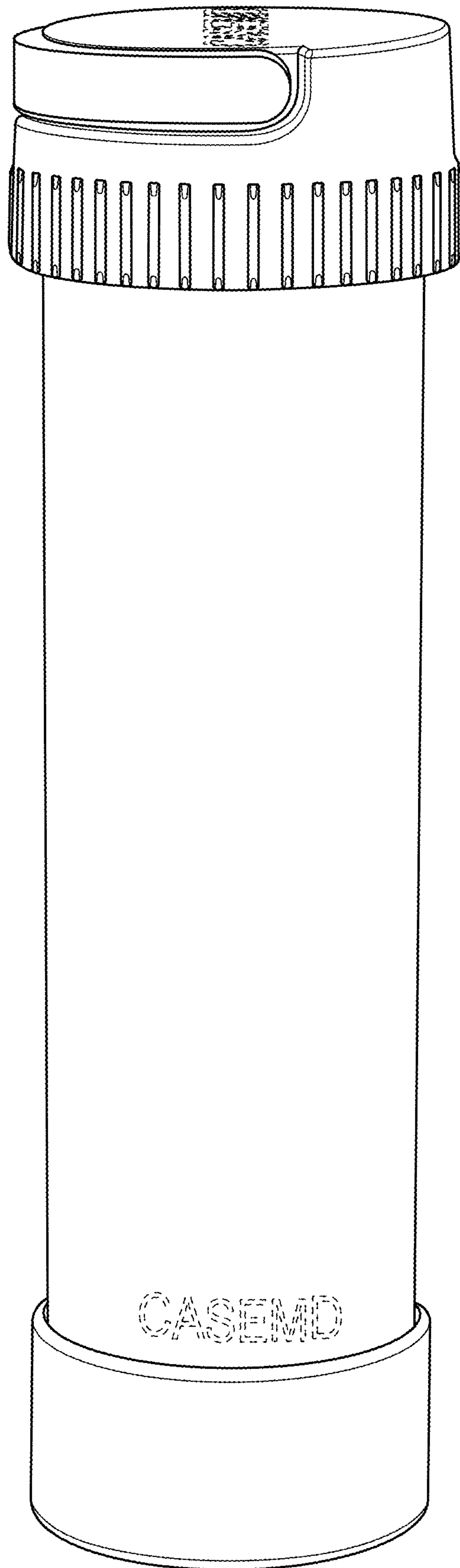

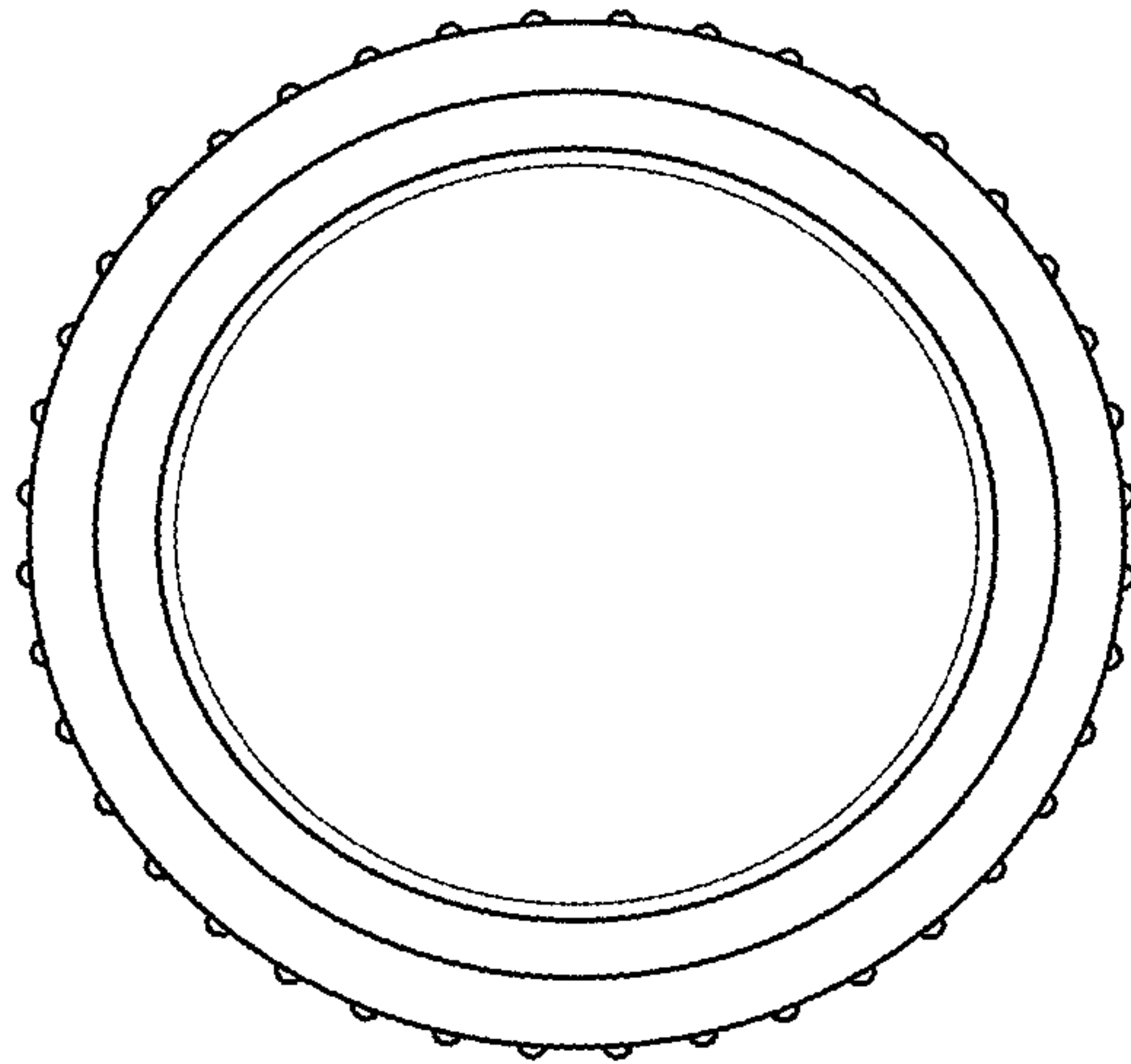

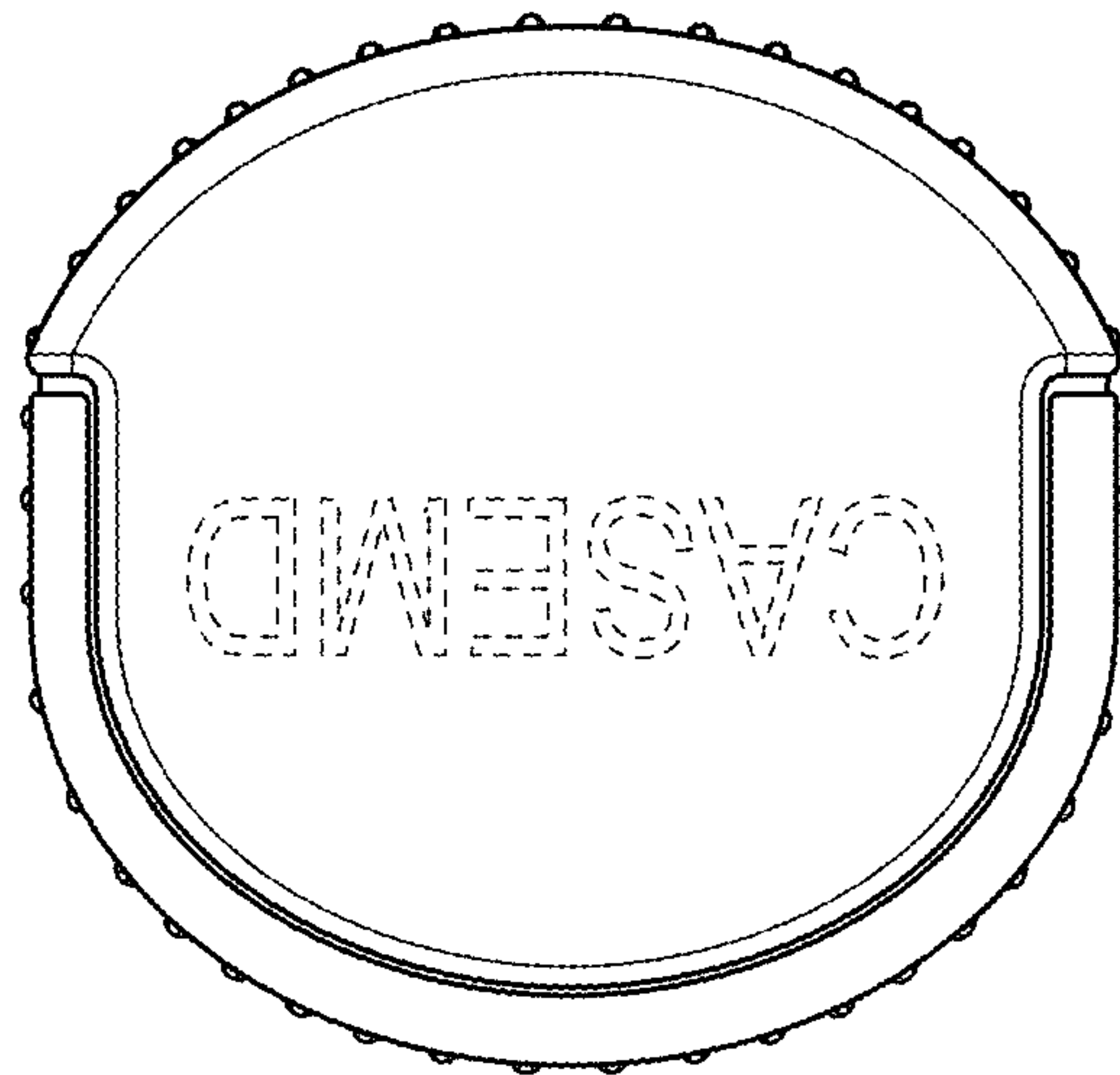
