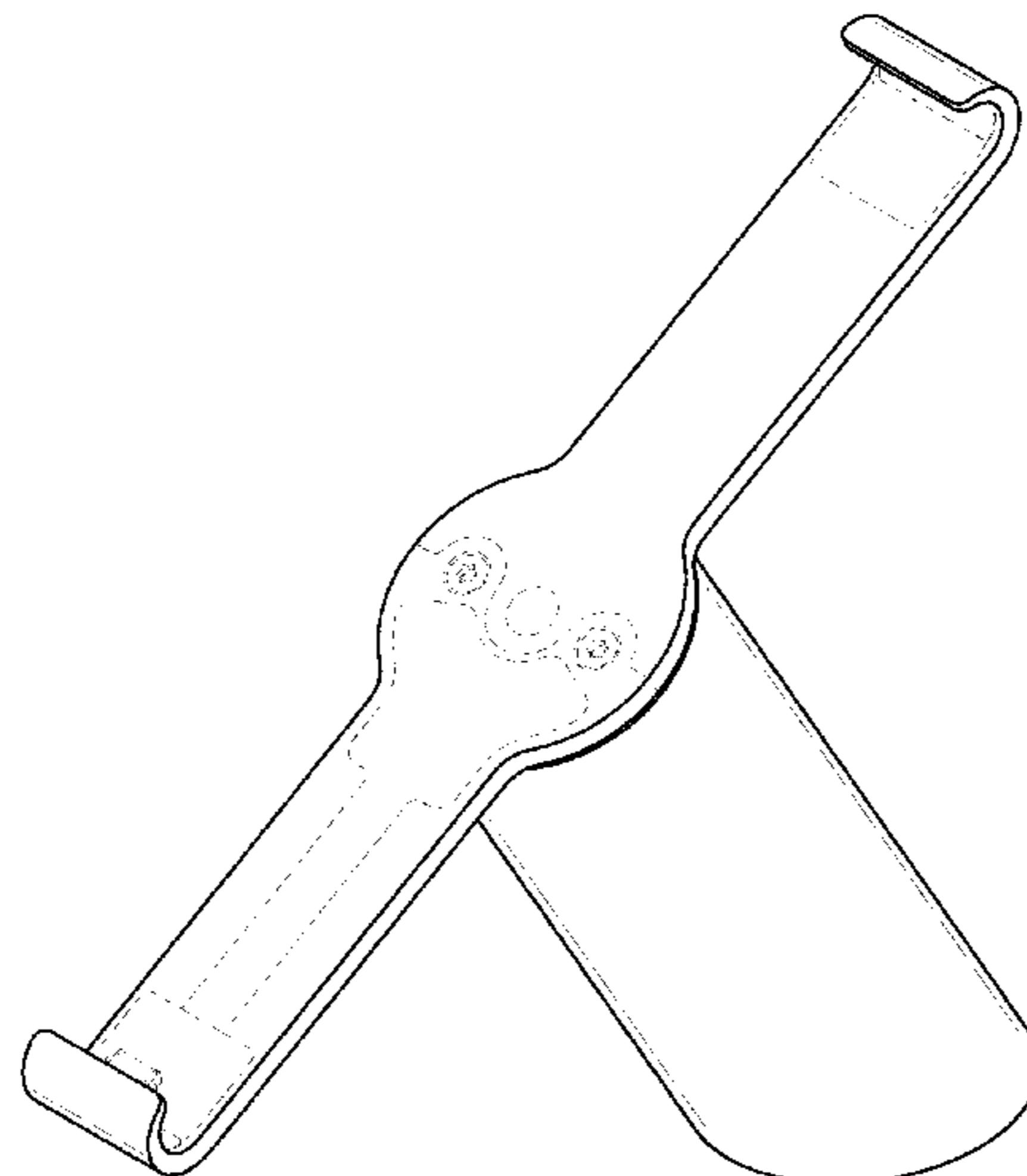
(57) **CLAIM**

The ornamental design for a display stand, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a display stand showing the claimed design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a right side view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a top front perspective view thereof showing the claimed design in an environment in which it may be used; and,
FIG. 9 is a bottom rear perspective view thereof.
The dashed broken lines in the figures show portions of the display stand and environment that form no part of the claimed design.

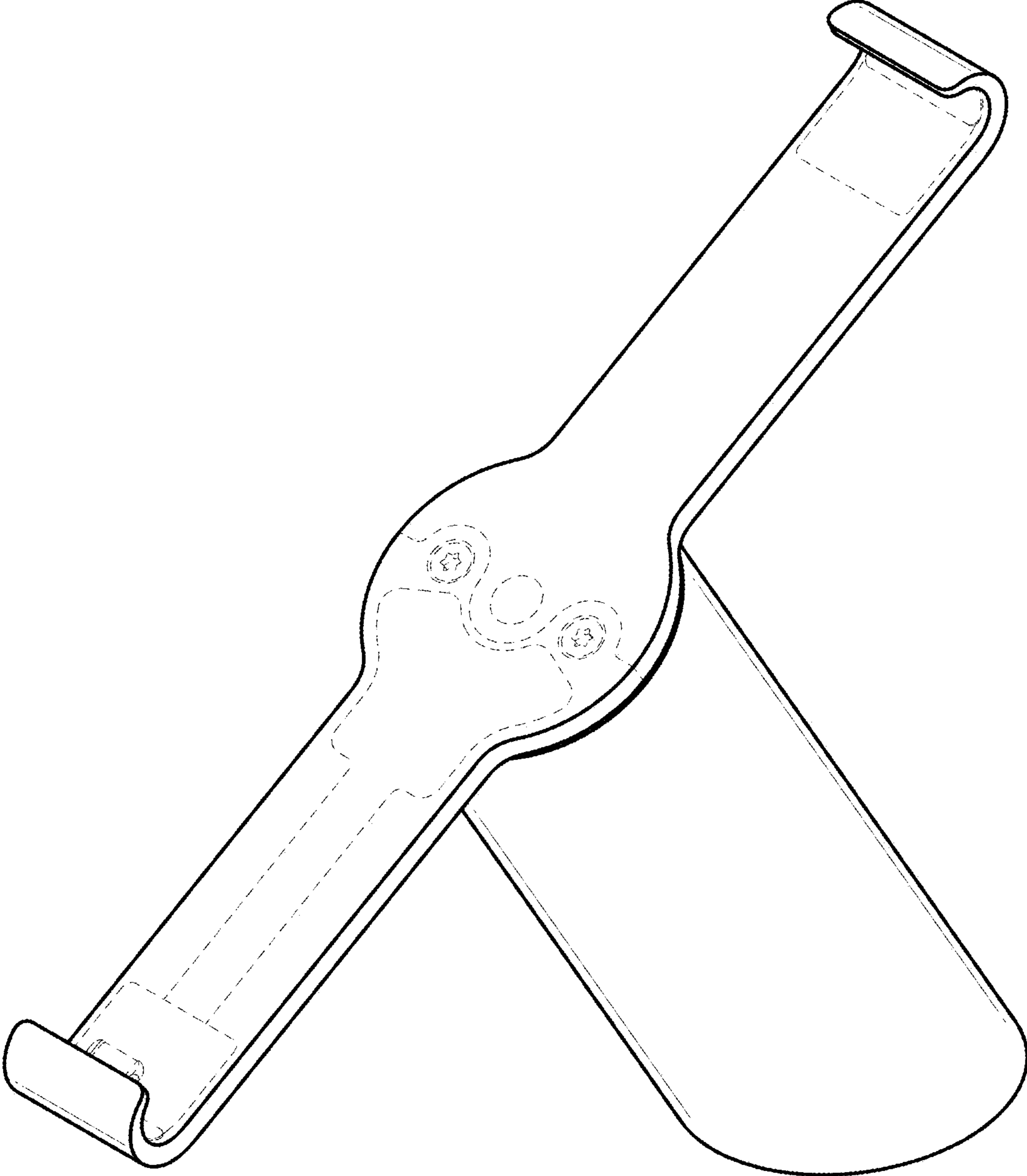

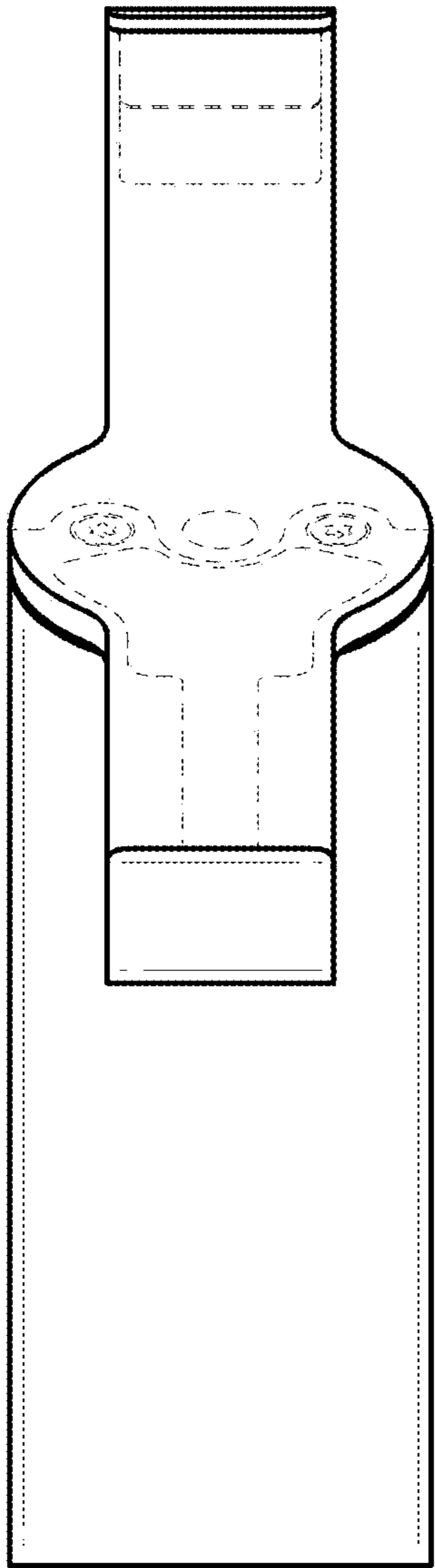

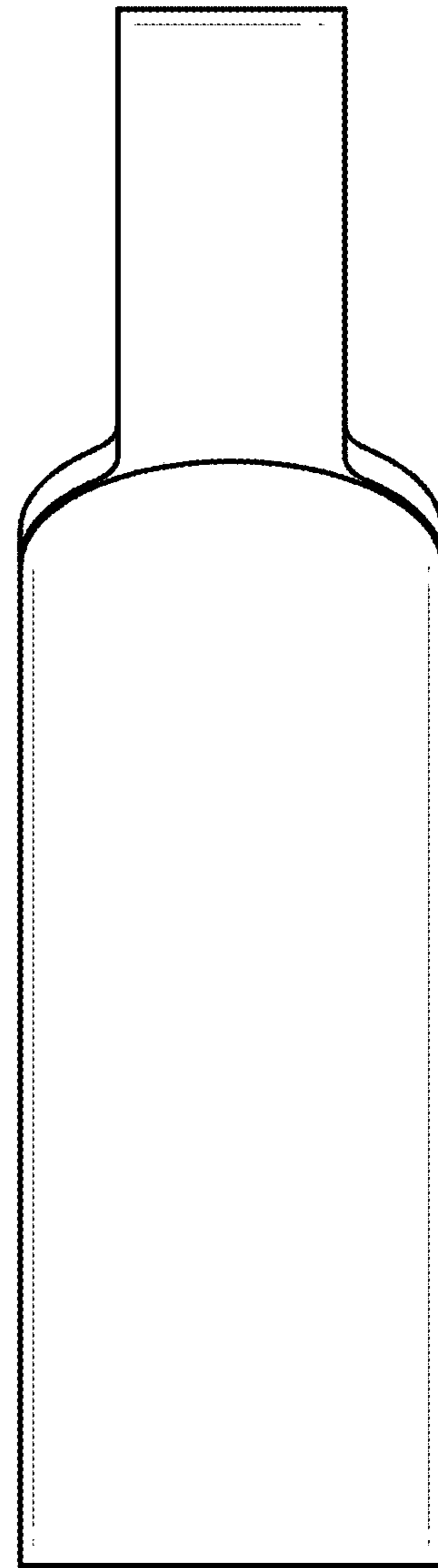

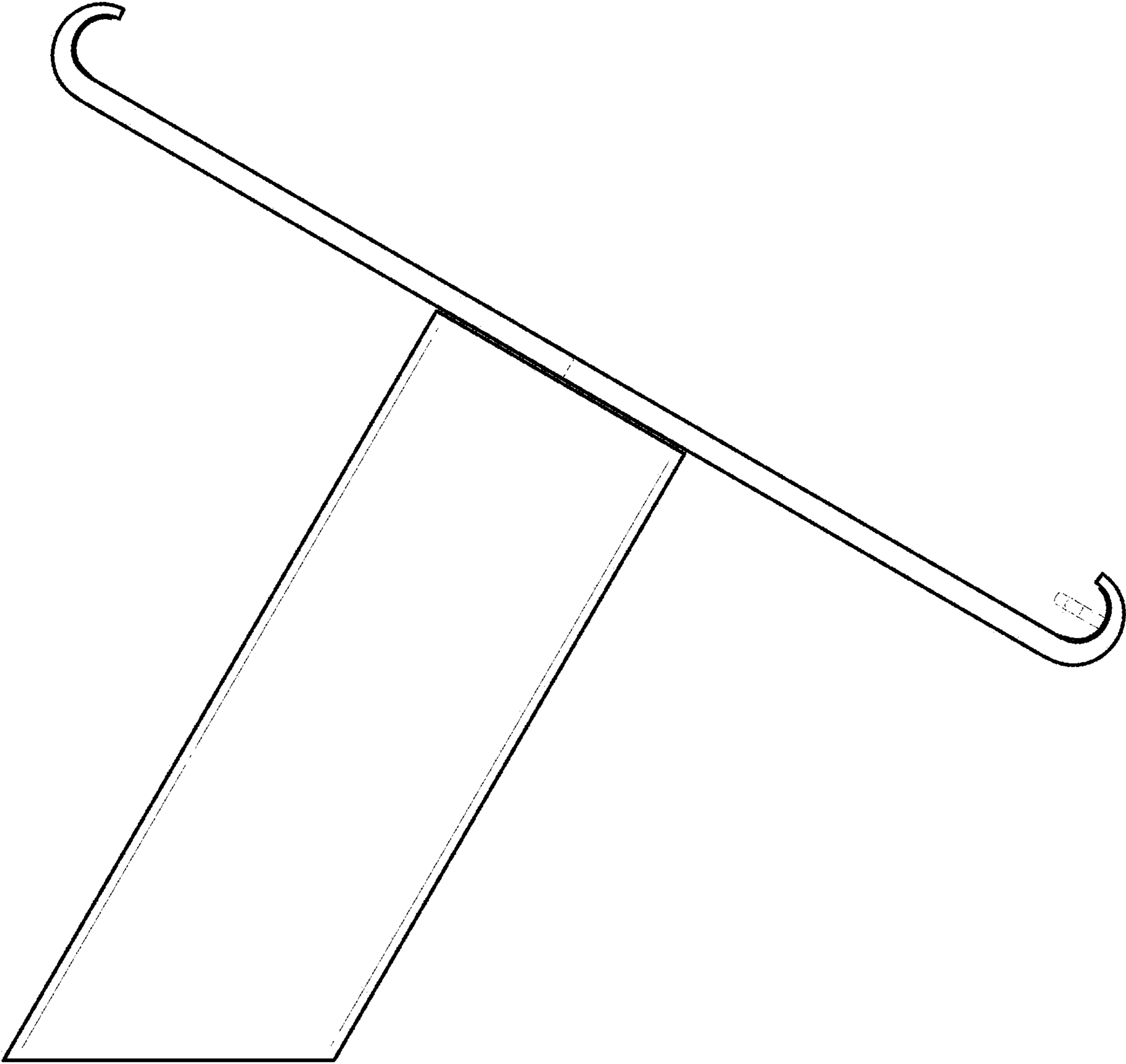

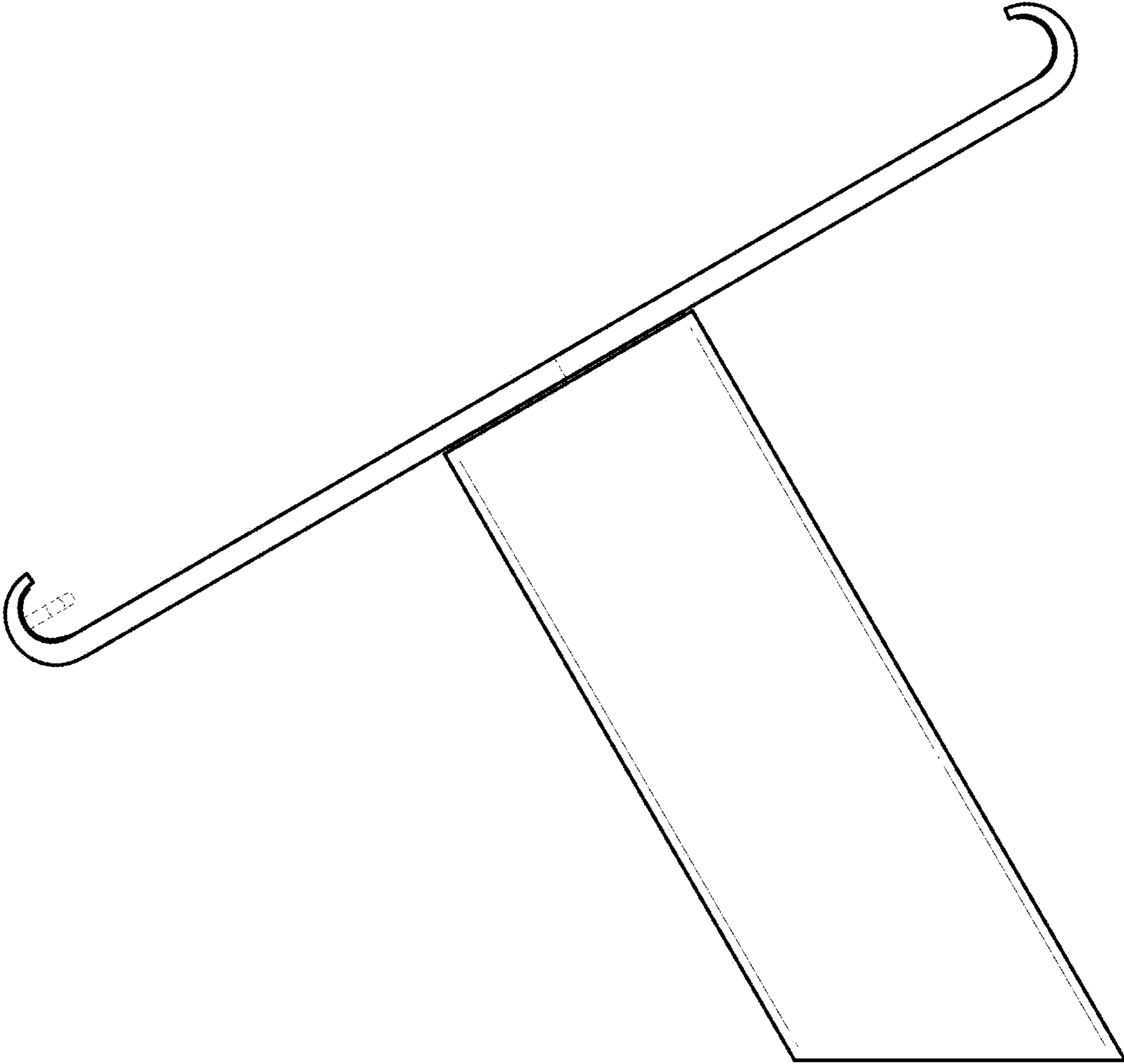

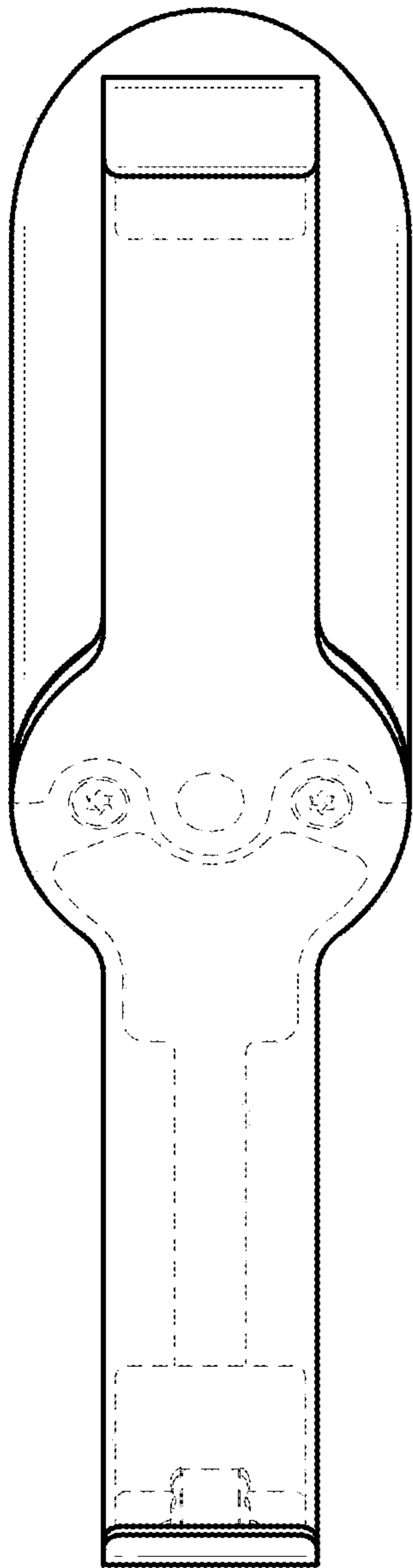

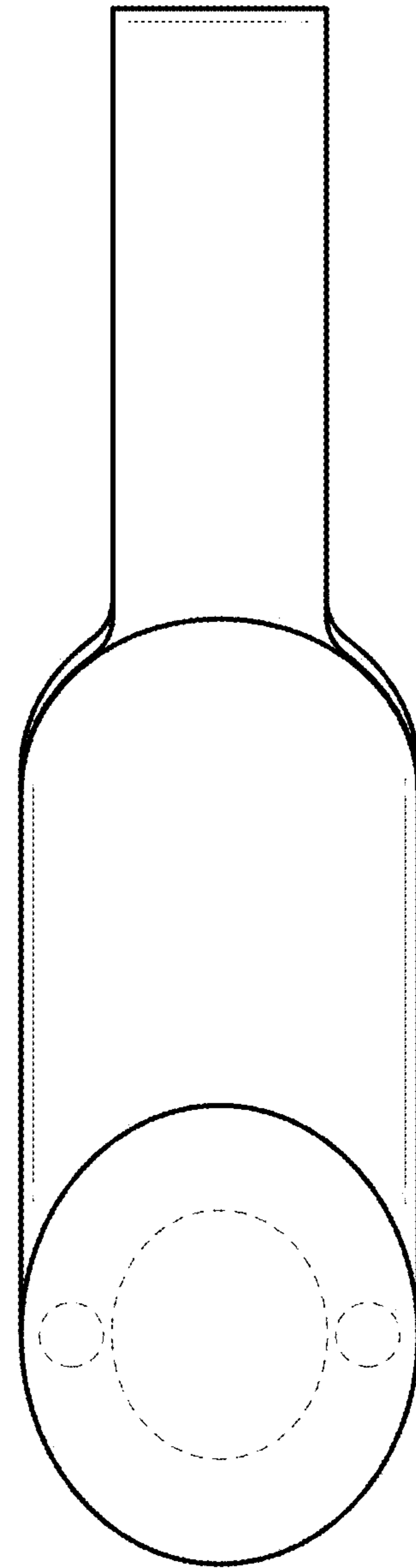

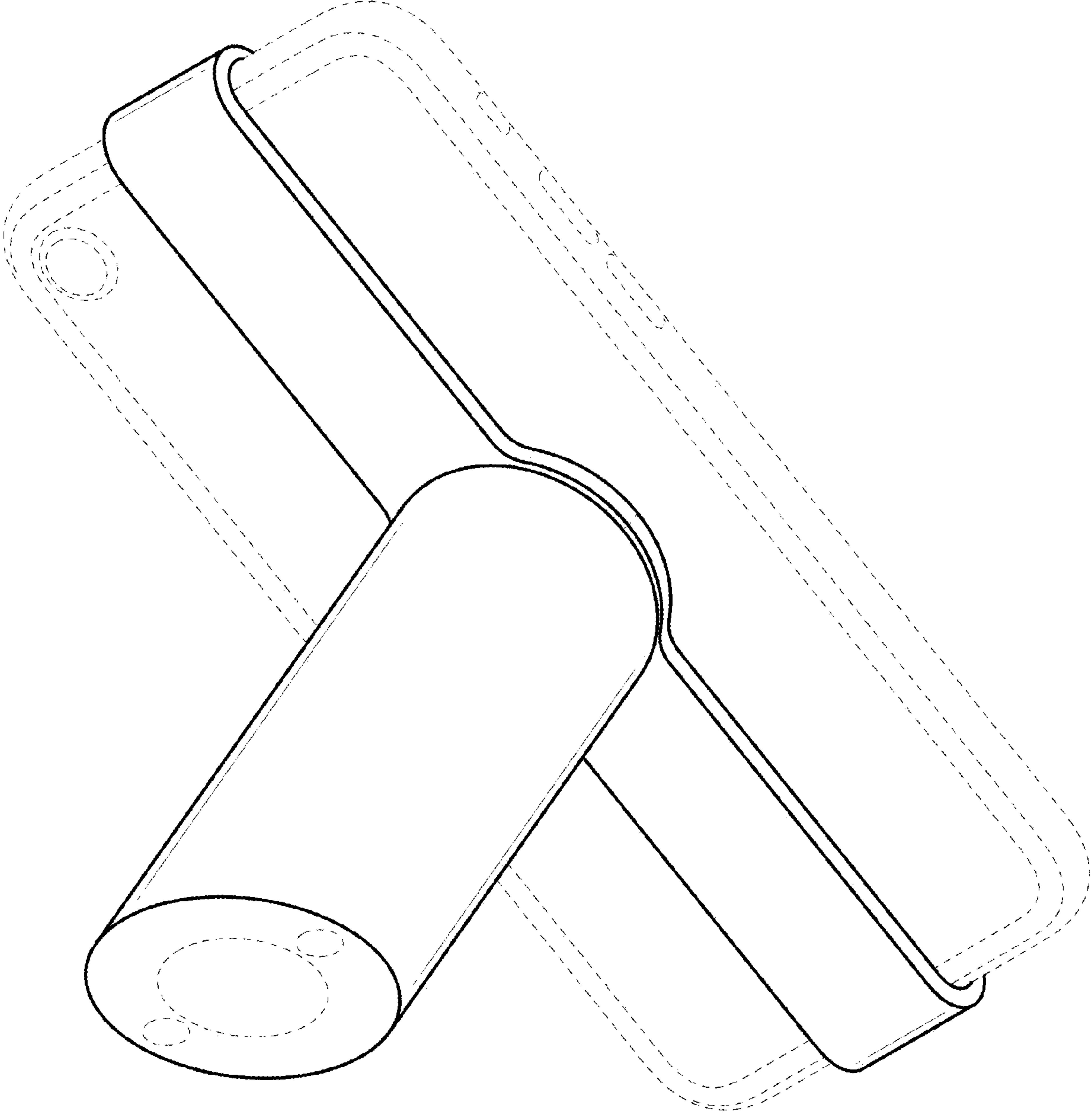
