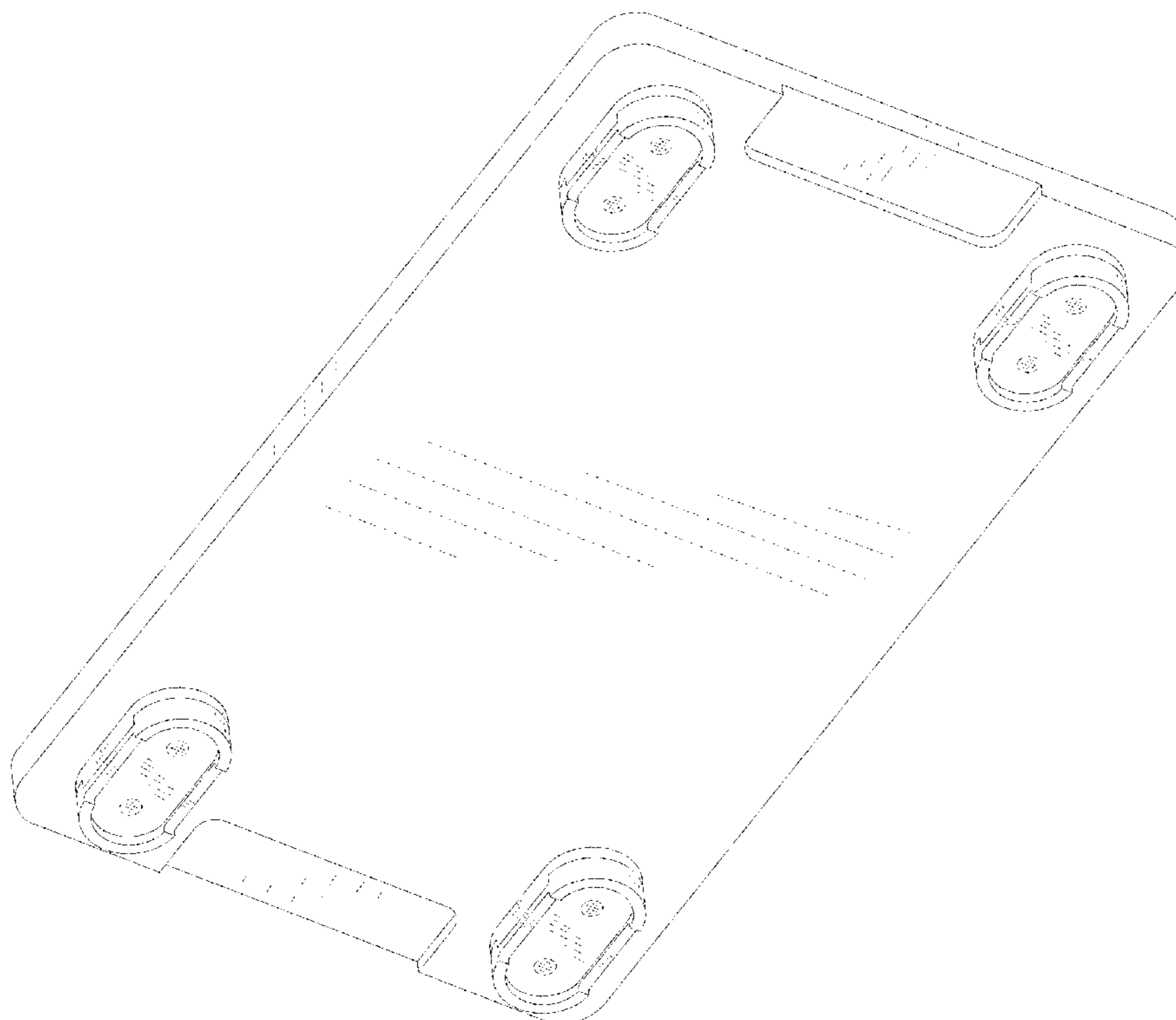
The ornamental design for a storage board, as shown and described.

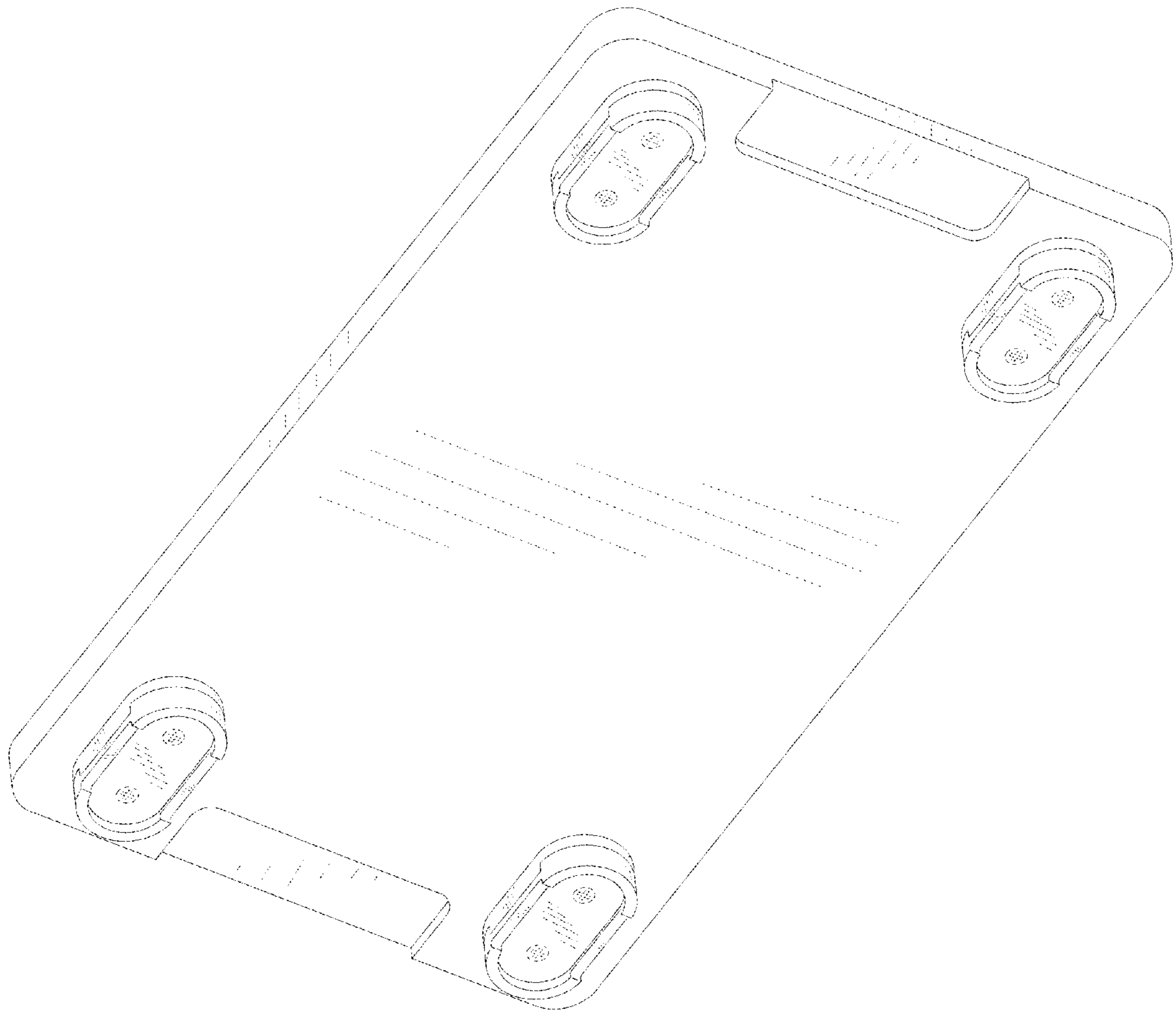

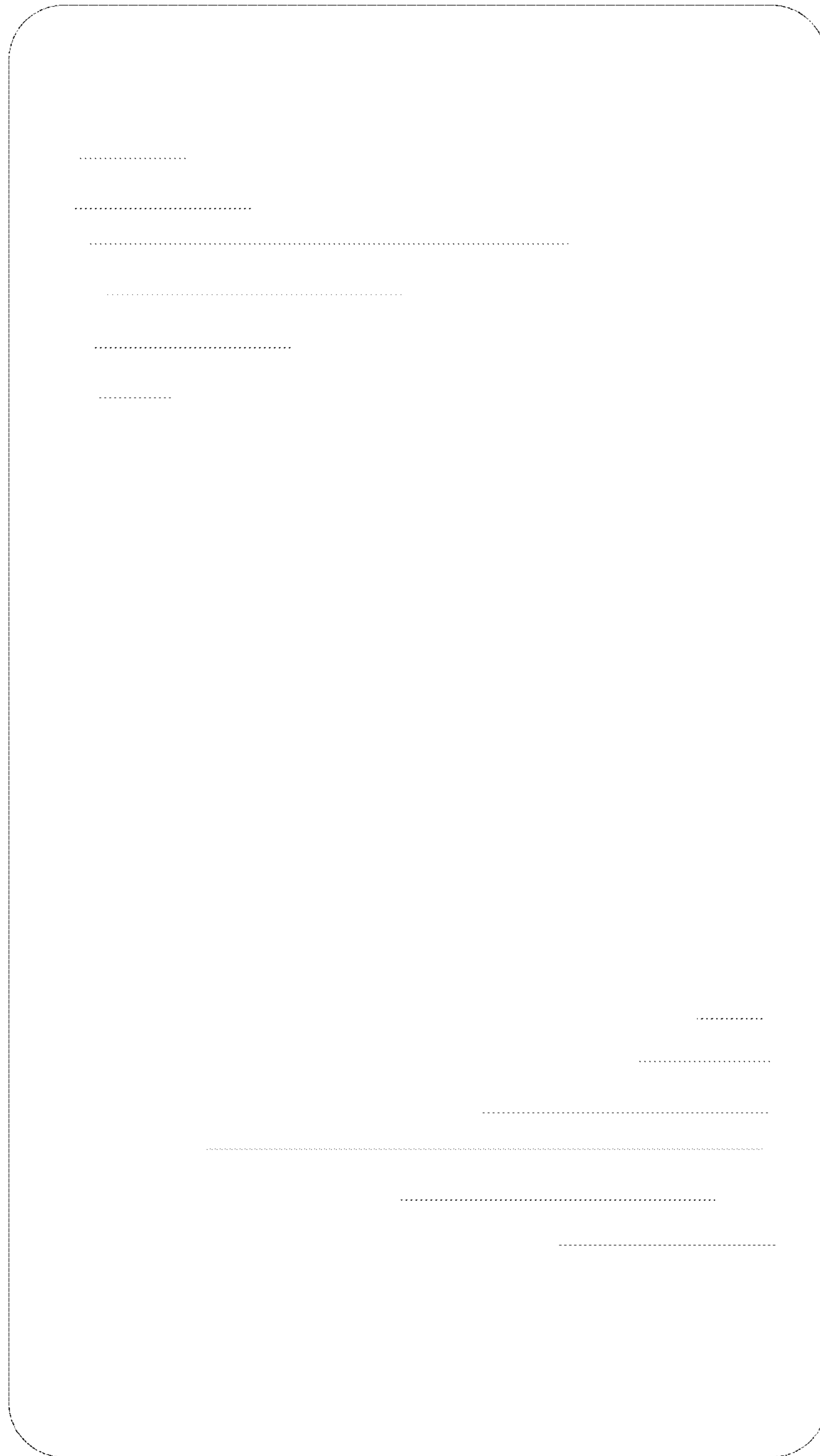

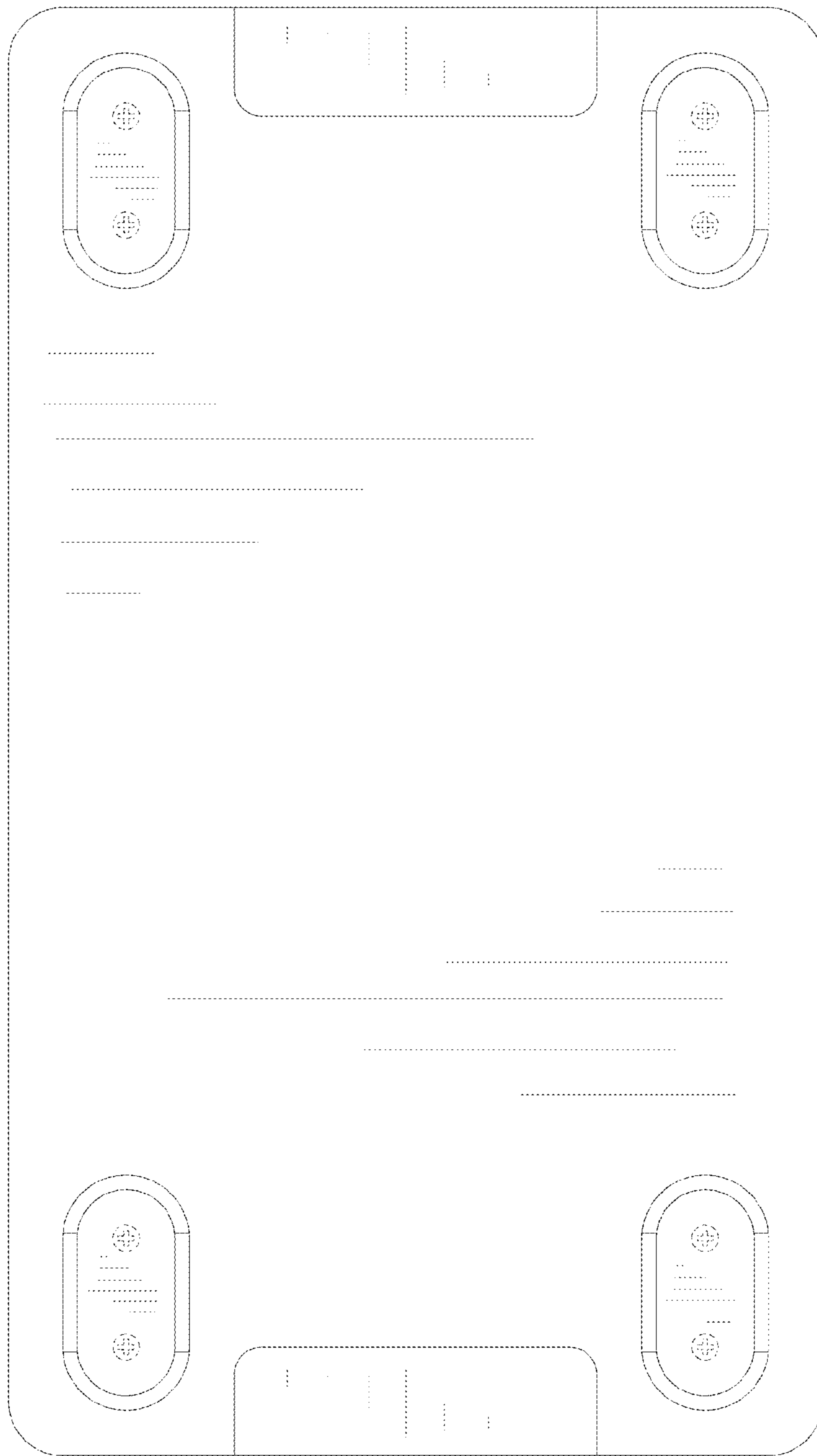

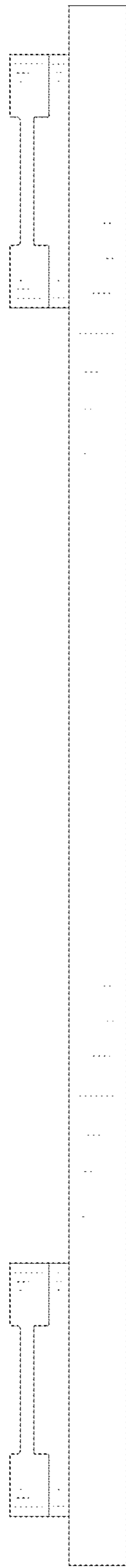

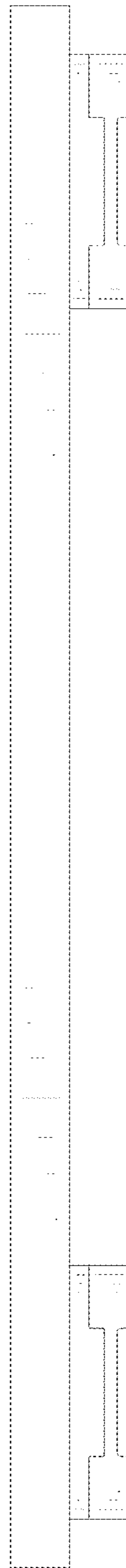

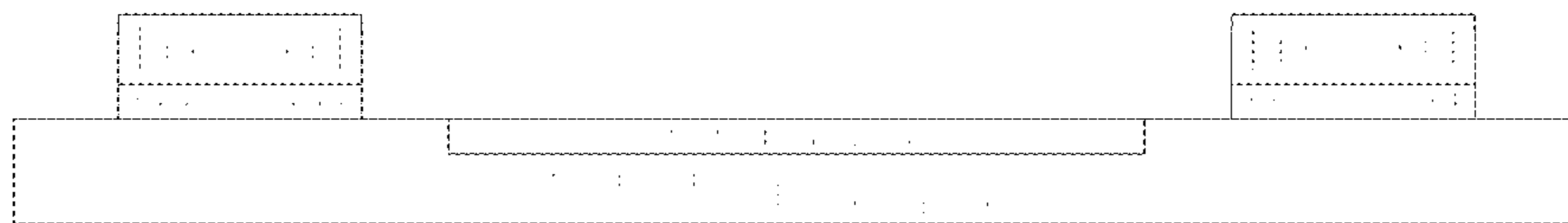

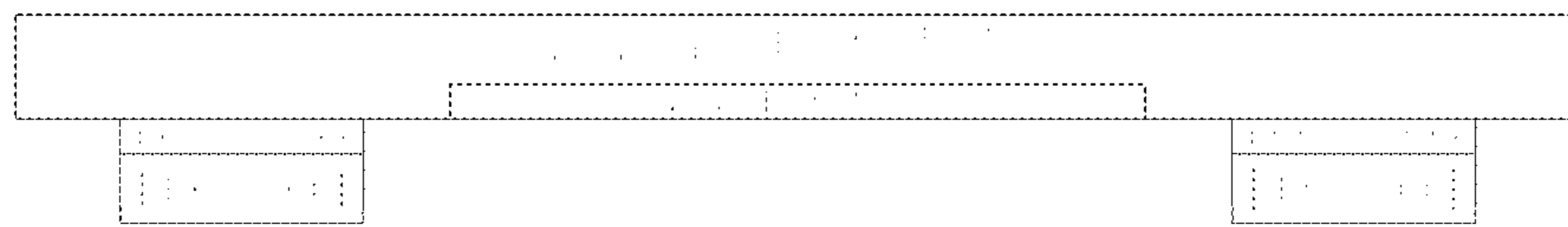
