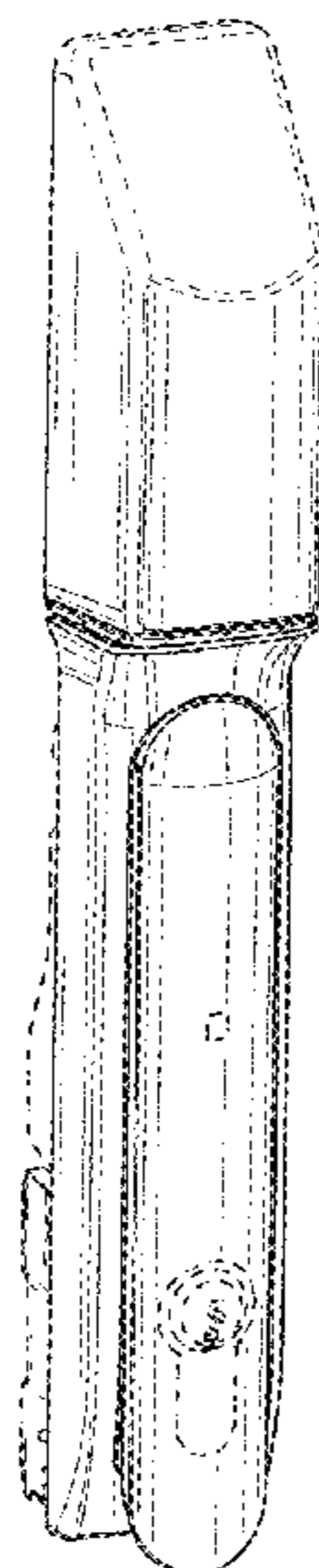
(57) **CLAIM**

The ornamental design for an electronic latch assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an electronic latch assembly; FIG. 2 is a front view of the electronic latch assembly illustrated in FIG. 1; FIG. 3 is a rear view of the electronic latch assembly illustrated in FIG. 1; FIG. 4 is a side view of the electronic latch assembly illustrated in FIG. 1, as viewed from the left side of FIG. 2; FIG. 5 is a side view of the electronic latch assembly illustrated in FIG. 1, as viewed from the right side of FIG. 2; FIG. 6 is a top plan view of the electronic latch assembly illustrated in FIG. 1; and, FIG. 7 is a bottom plan view of the electronic latch assembly illustrated in FIG. 1. The broken lines depict portions of the article that form no part of the claimed design.

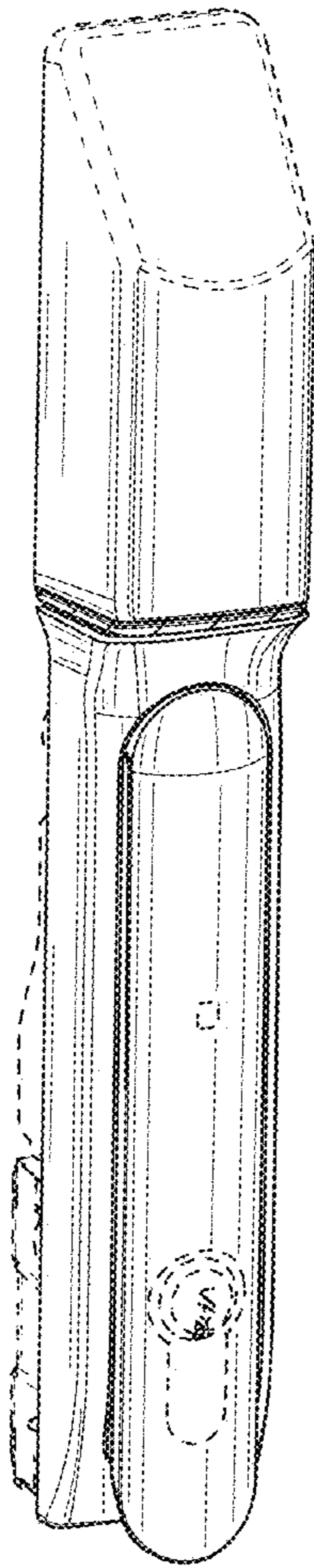

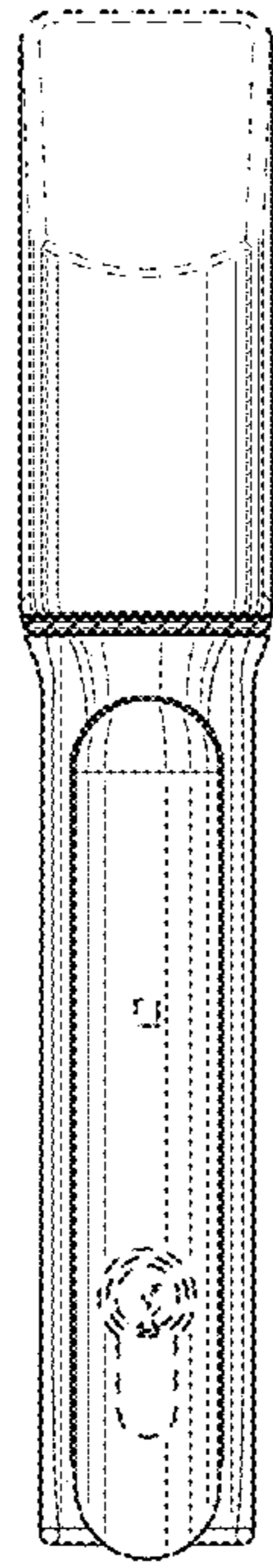

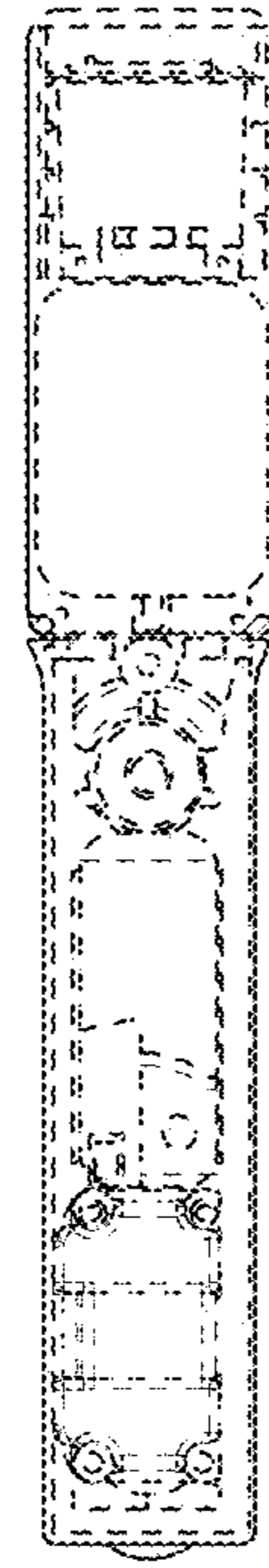

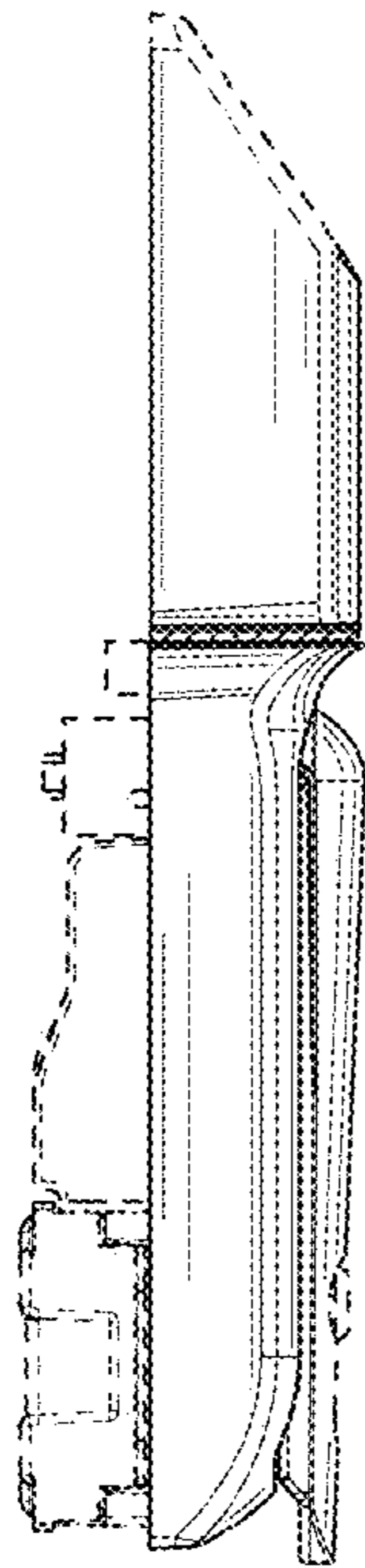

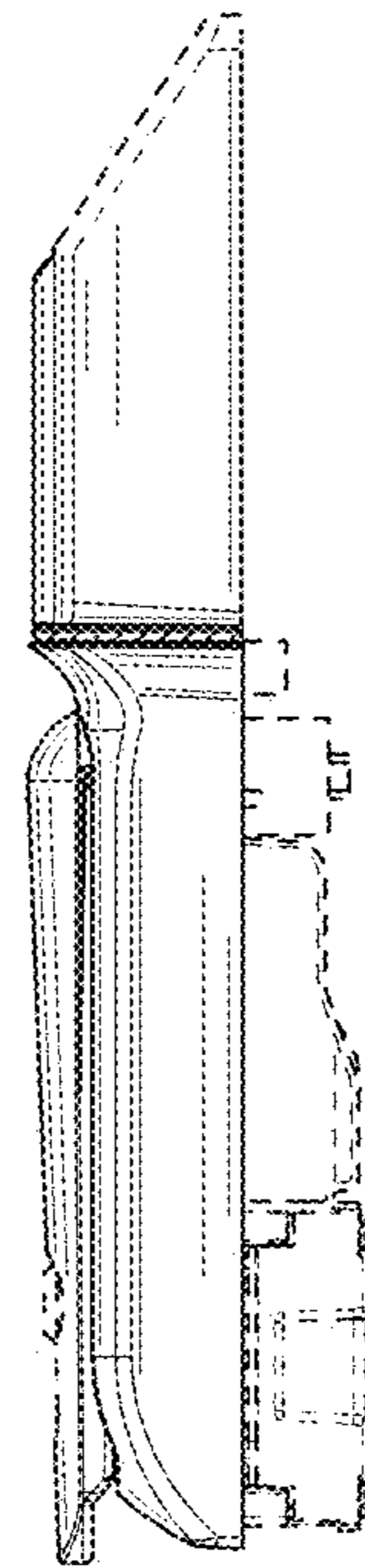

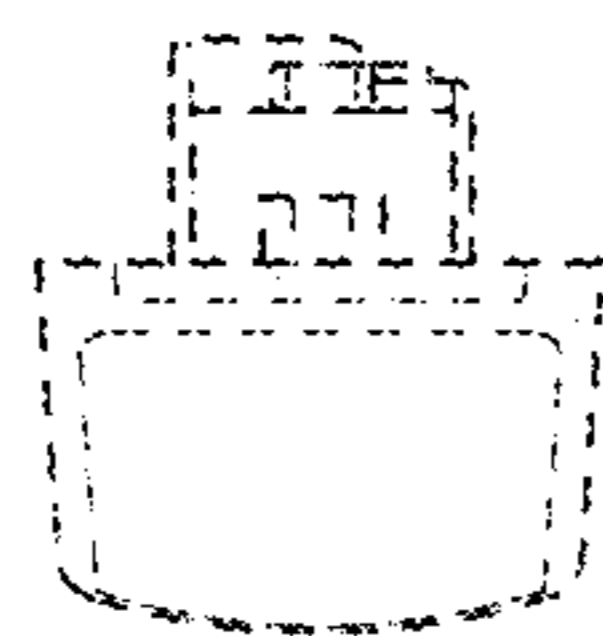

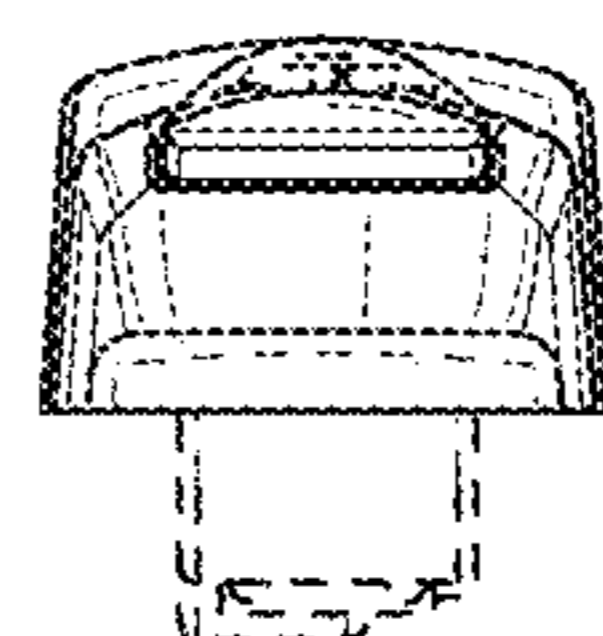
