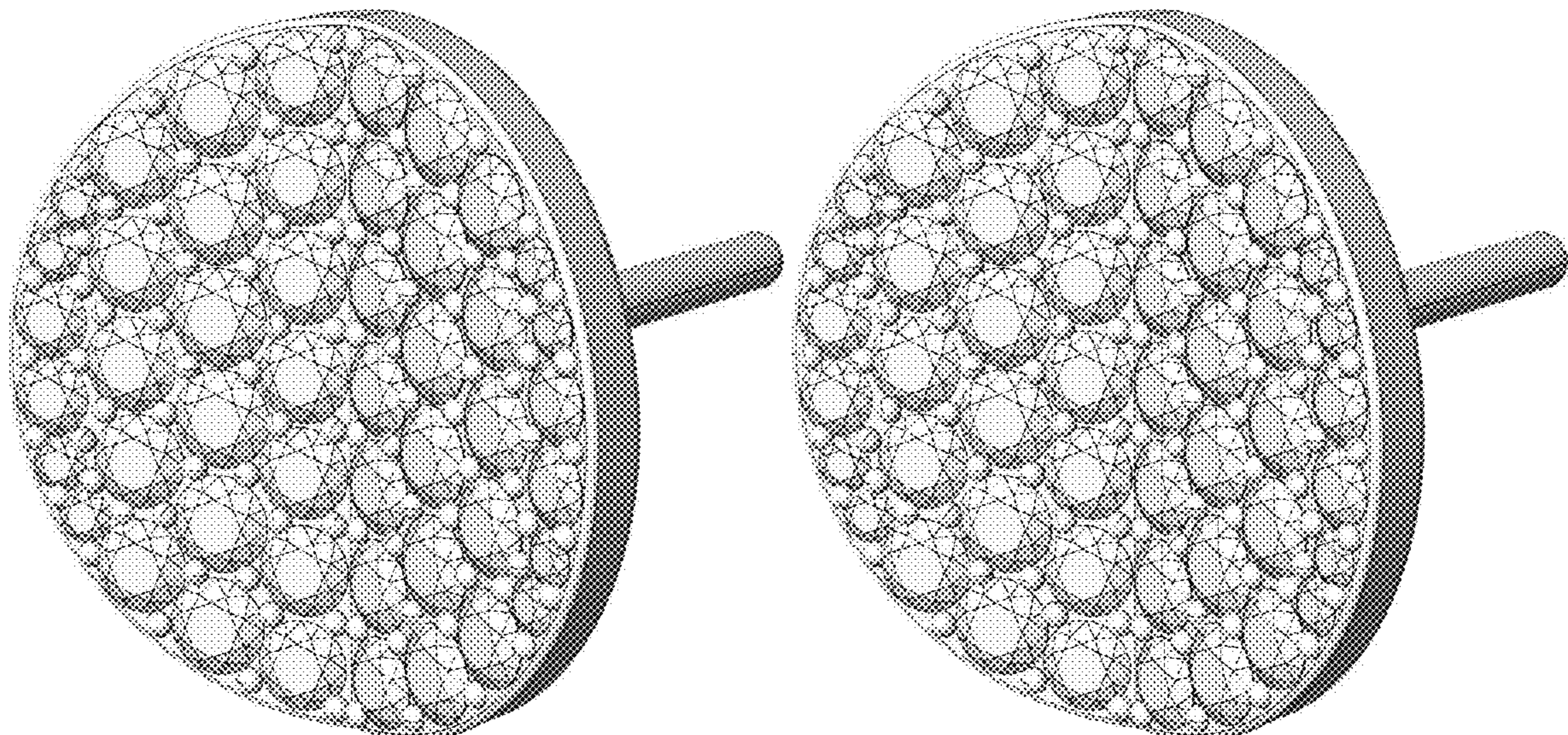
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevation view of the first stud of a pair of studs, showing my new design.

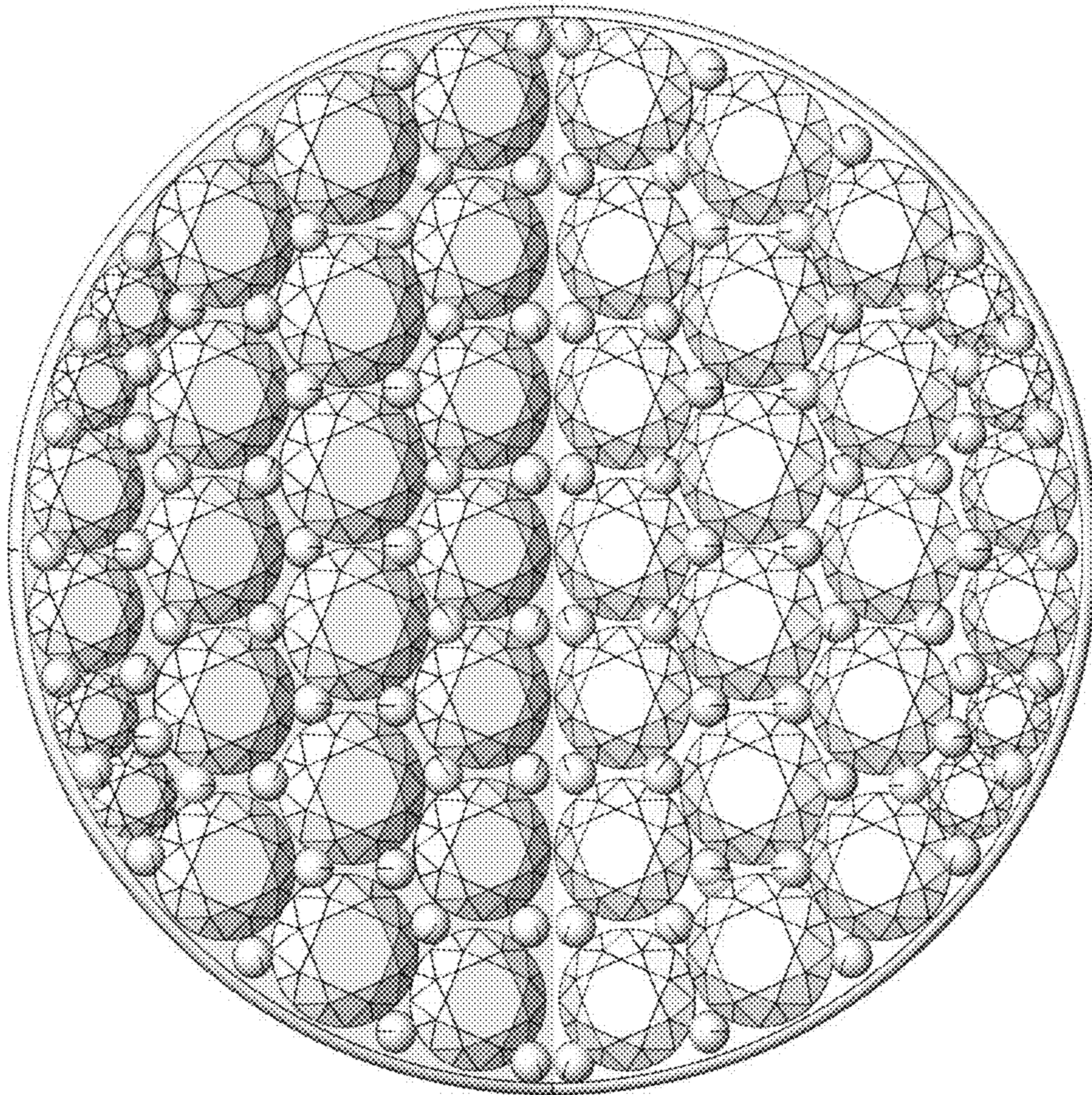

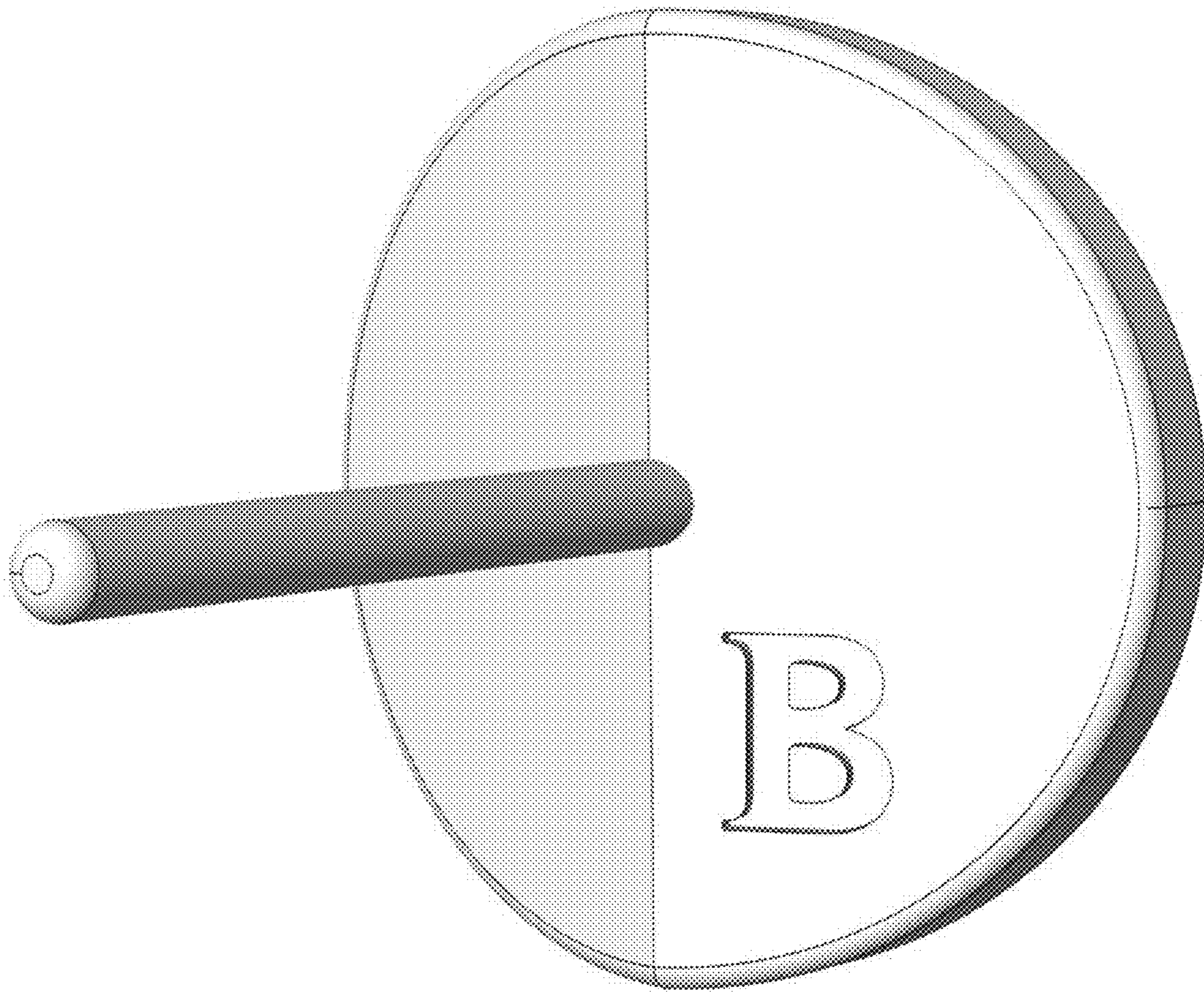

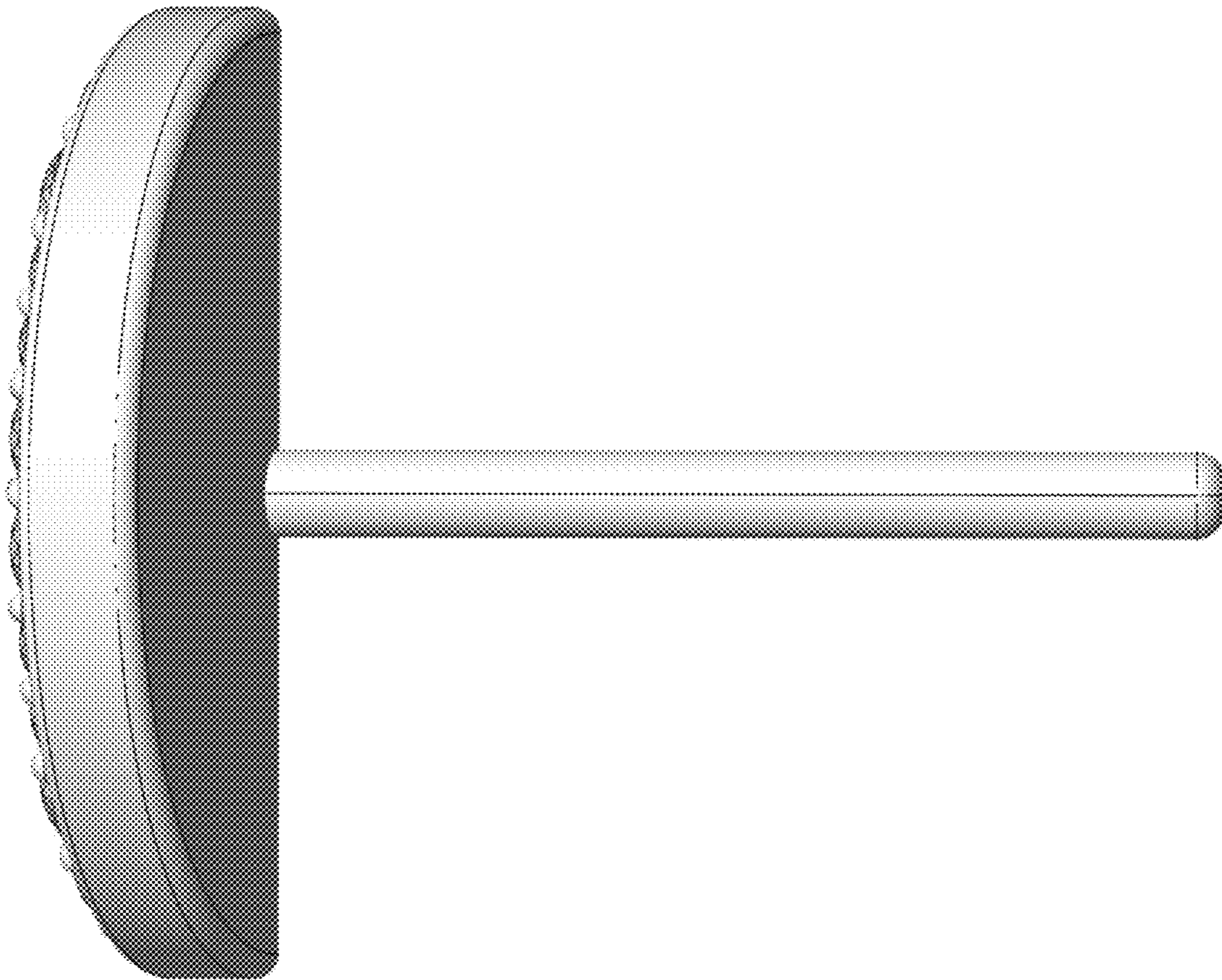

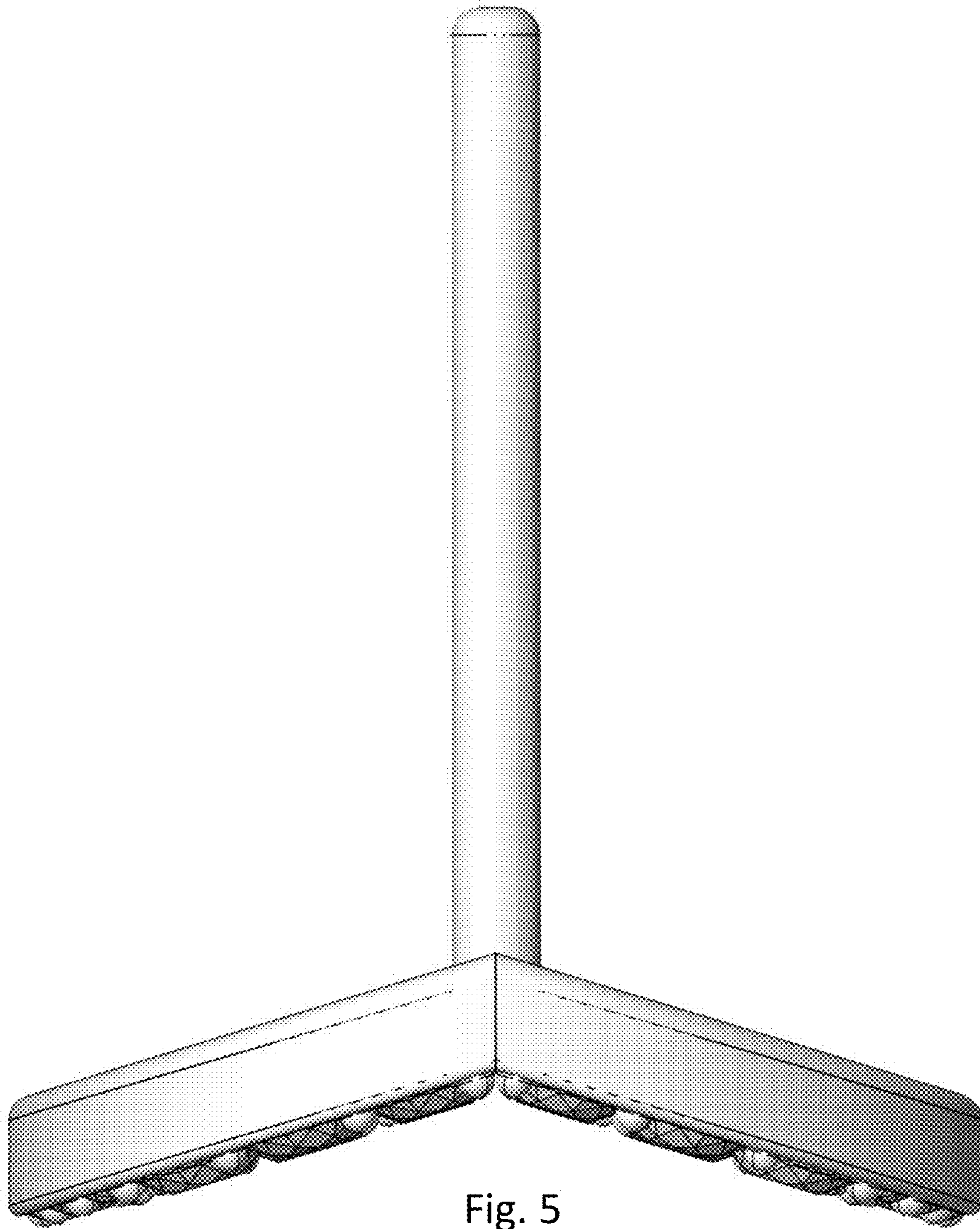

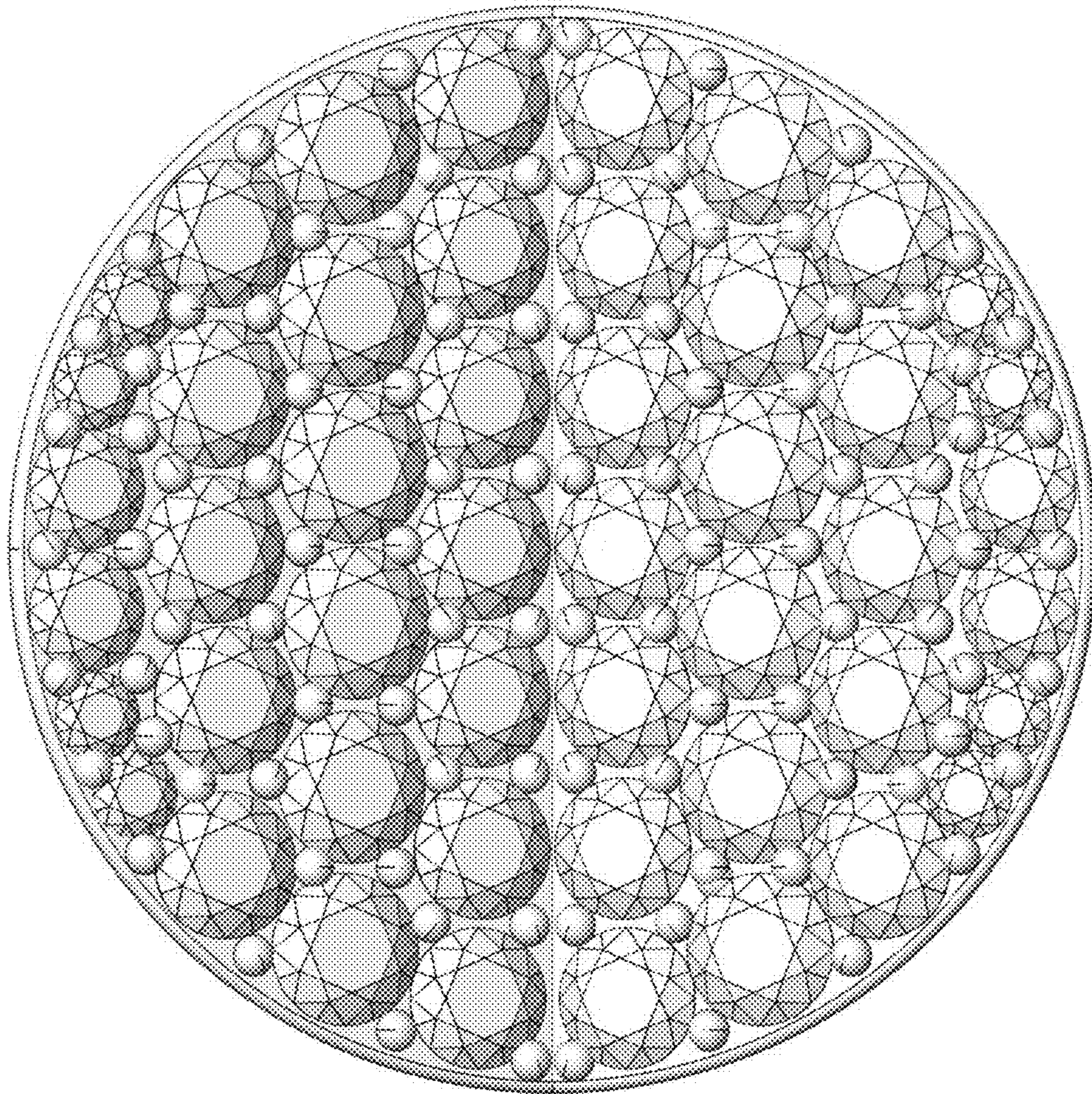

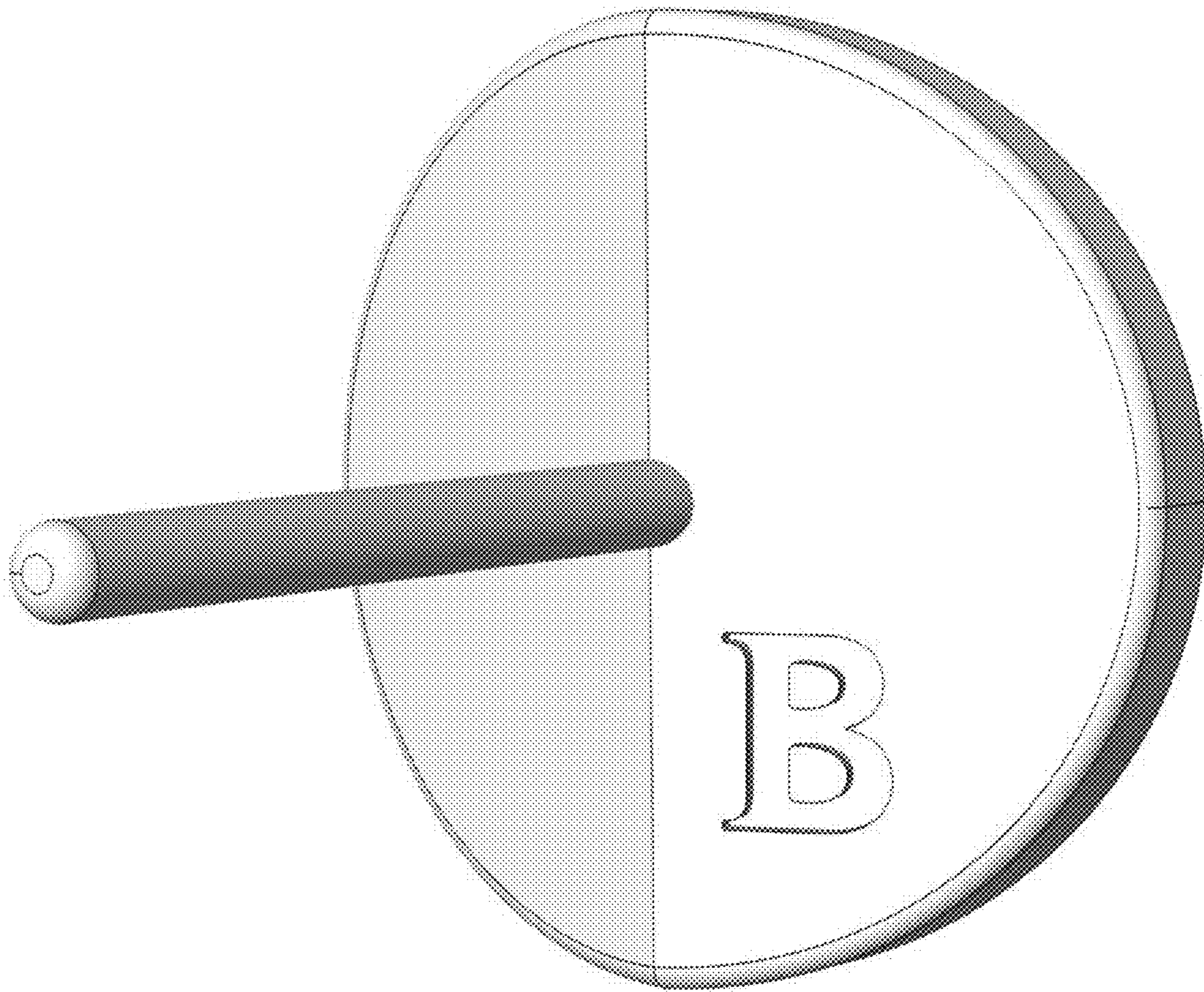

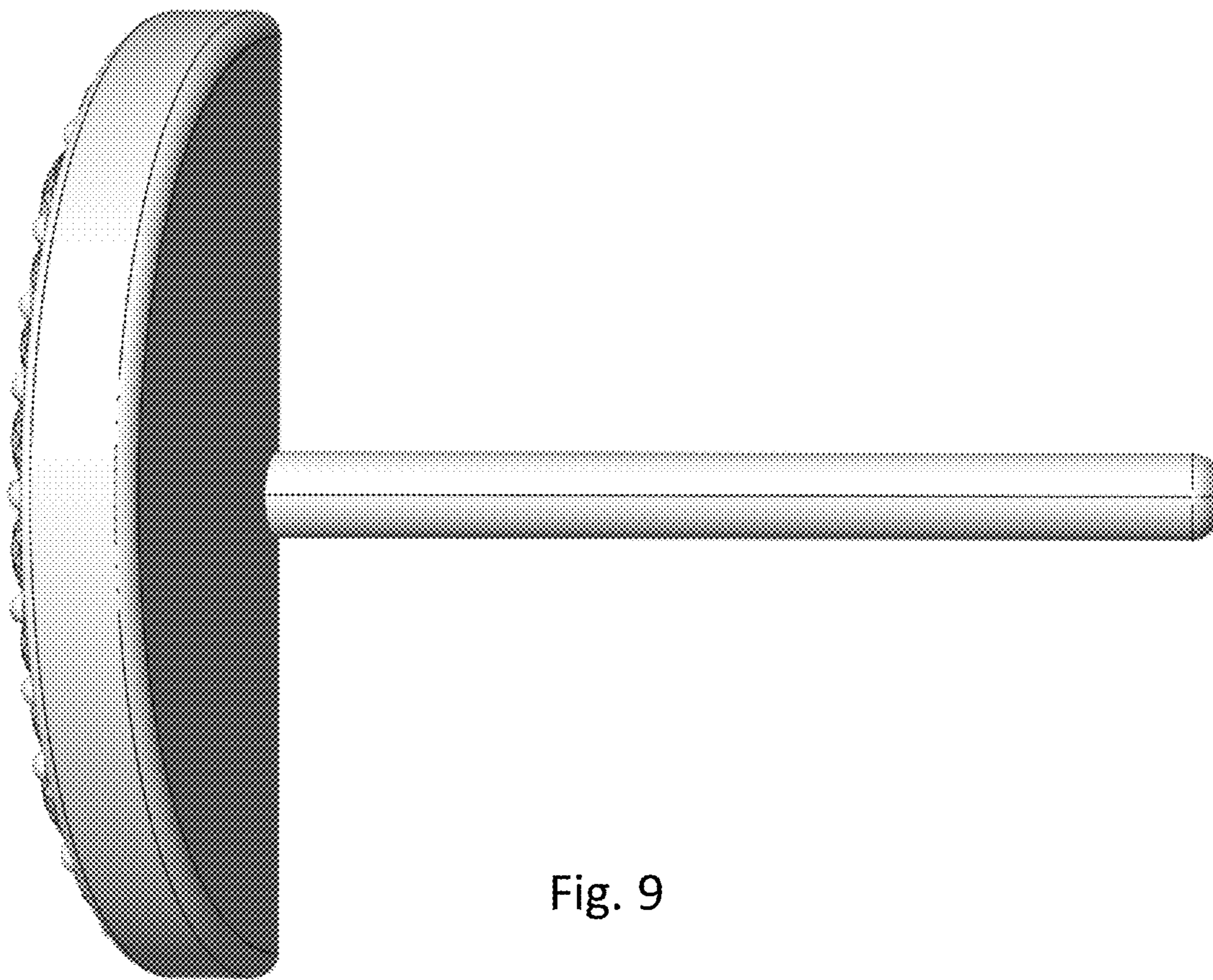

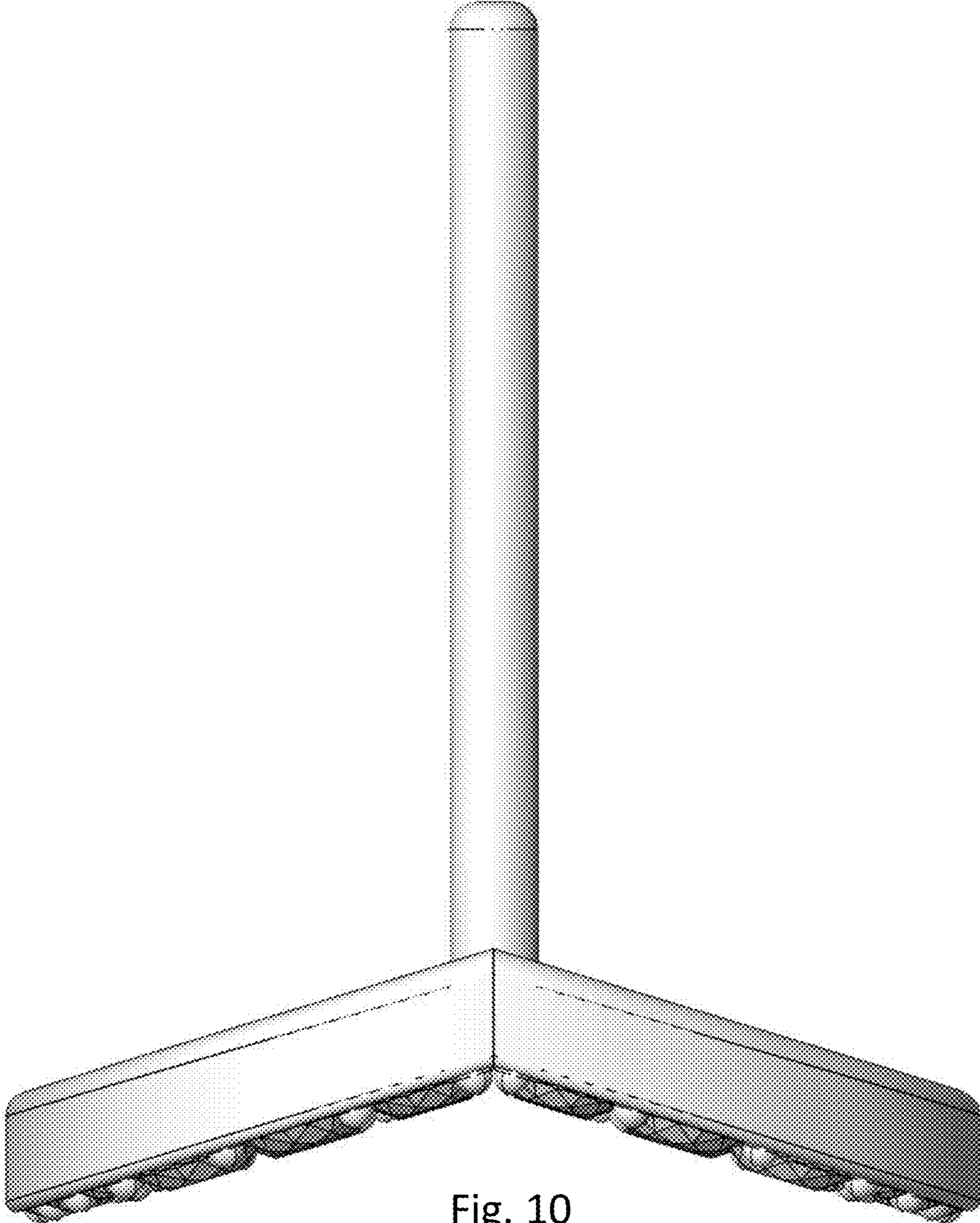
