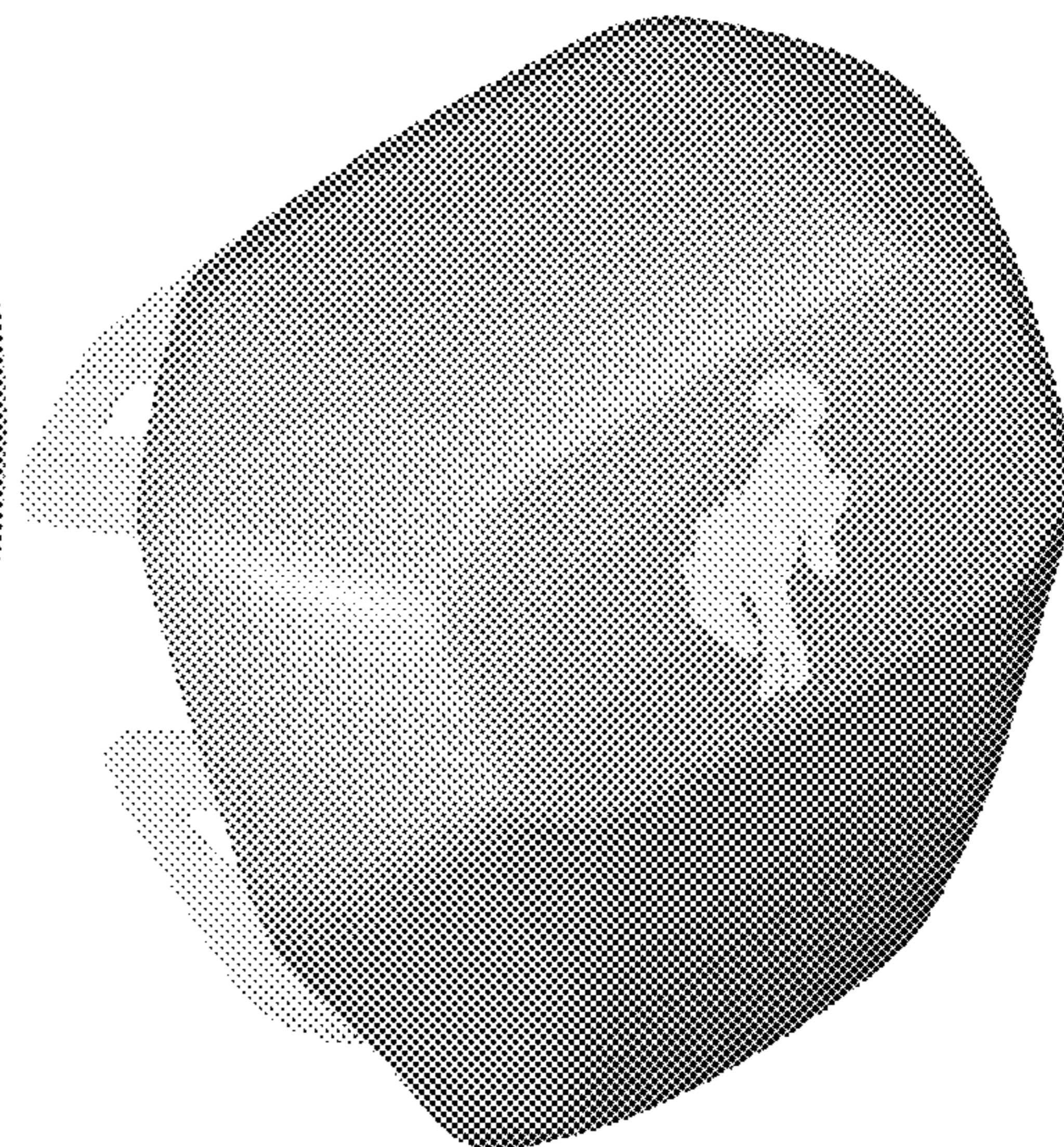
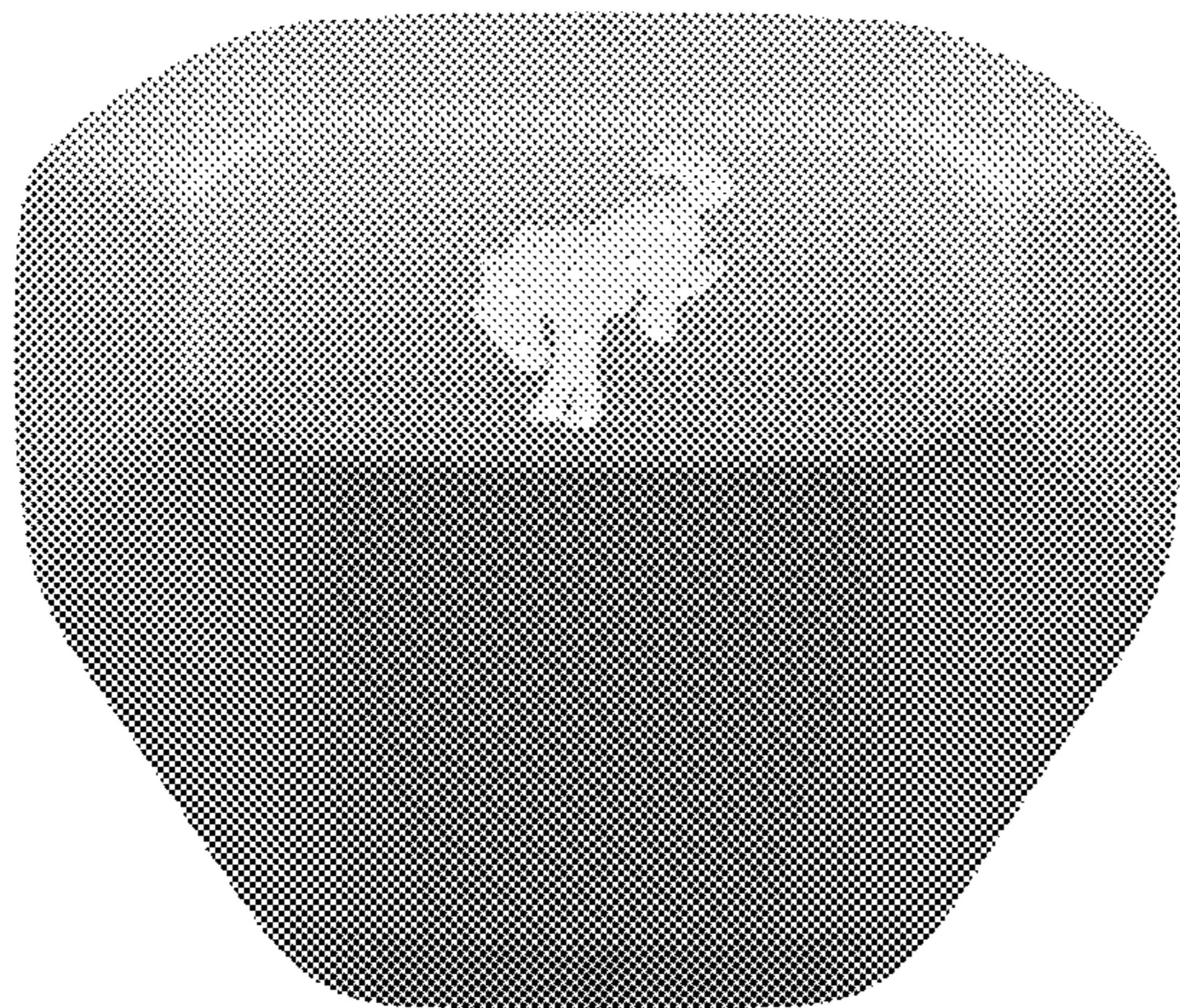
The ornamental design for a vehicle driver air bag cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a vehicle driver air bag cover, showing our new design;
FIG. 2 is a left side elevational view thereof;

FIG. 4 is a top plan view thereof;

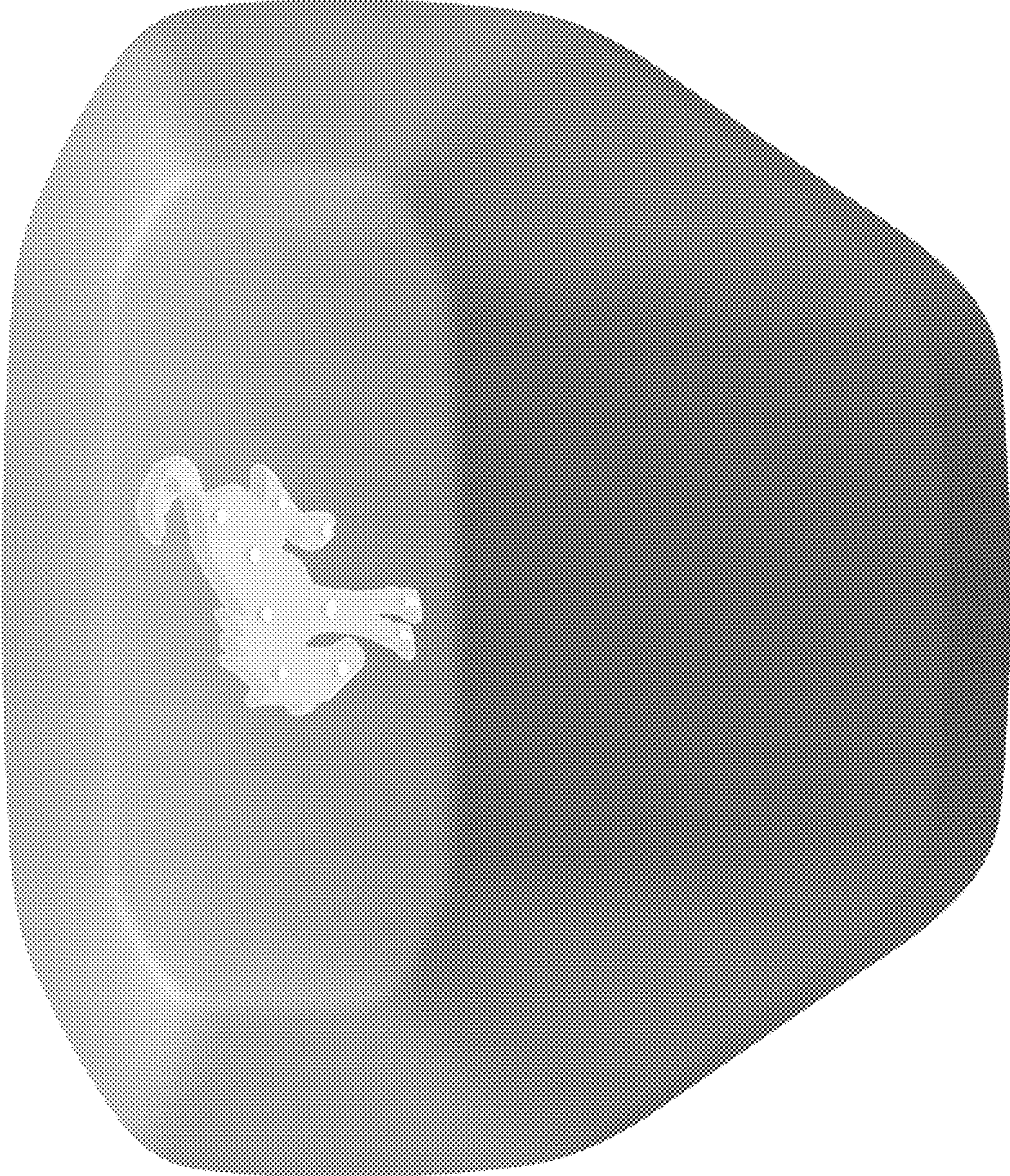

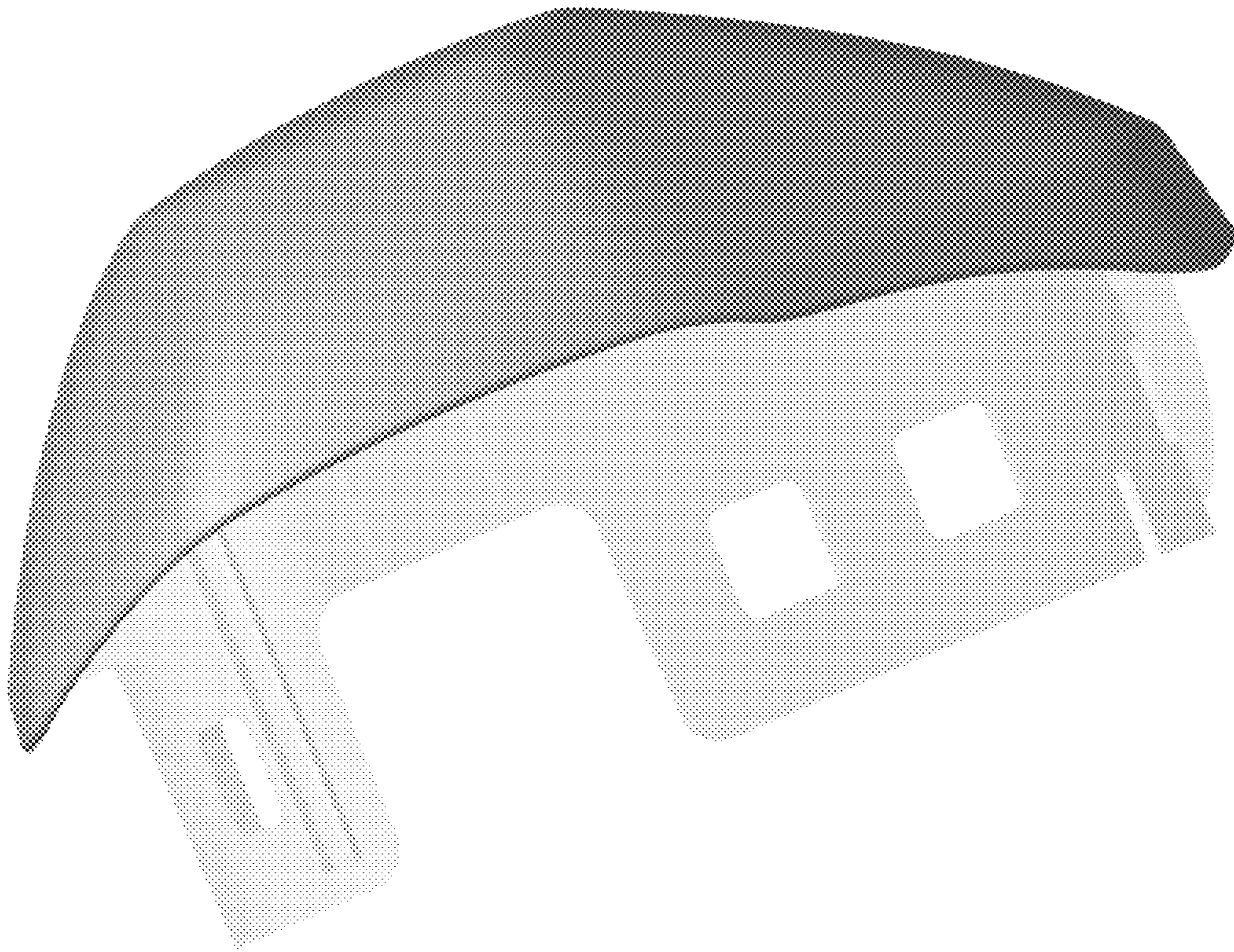

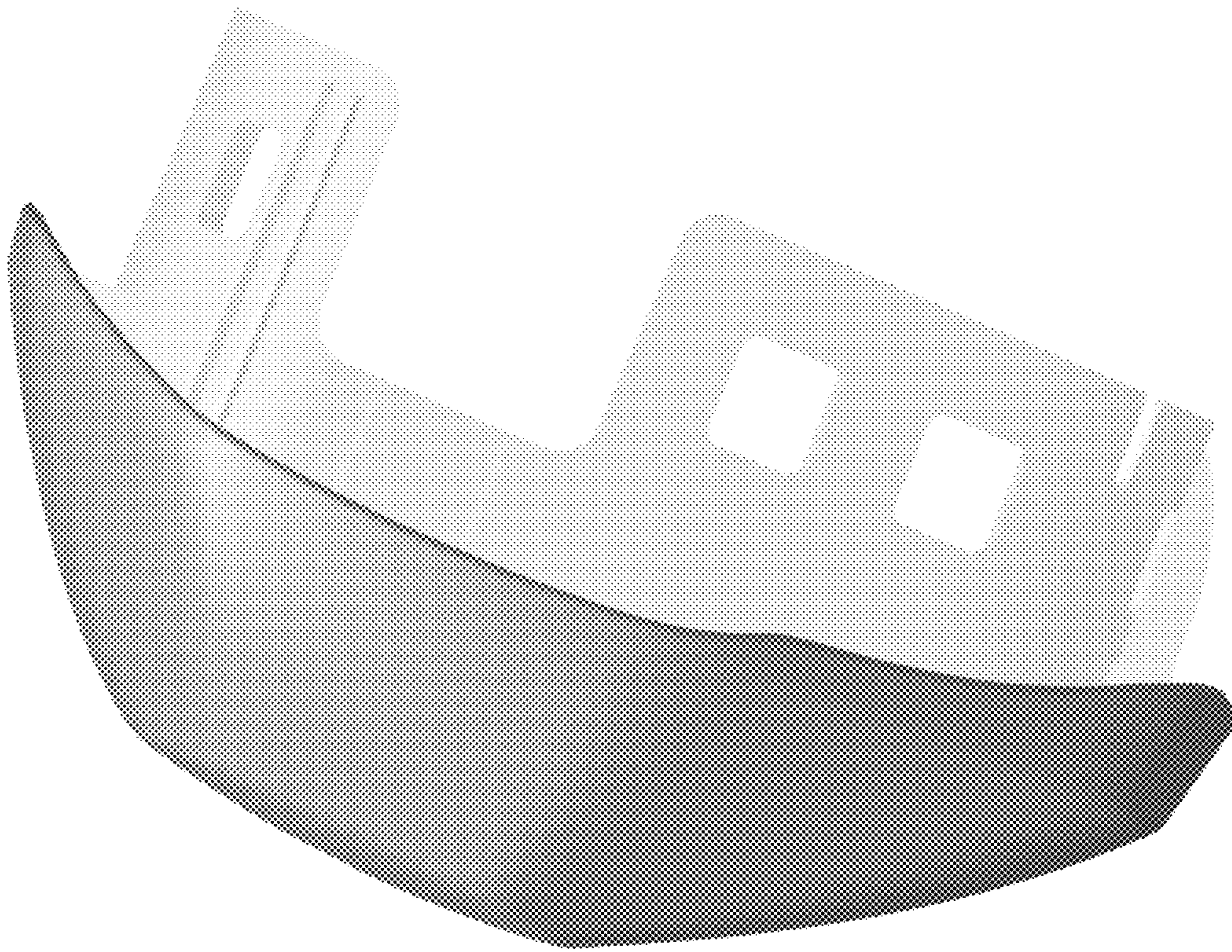

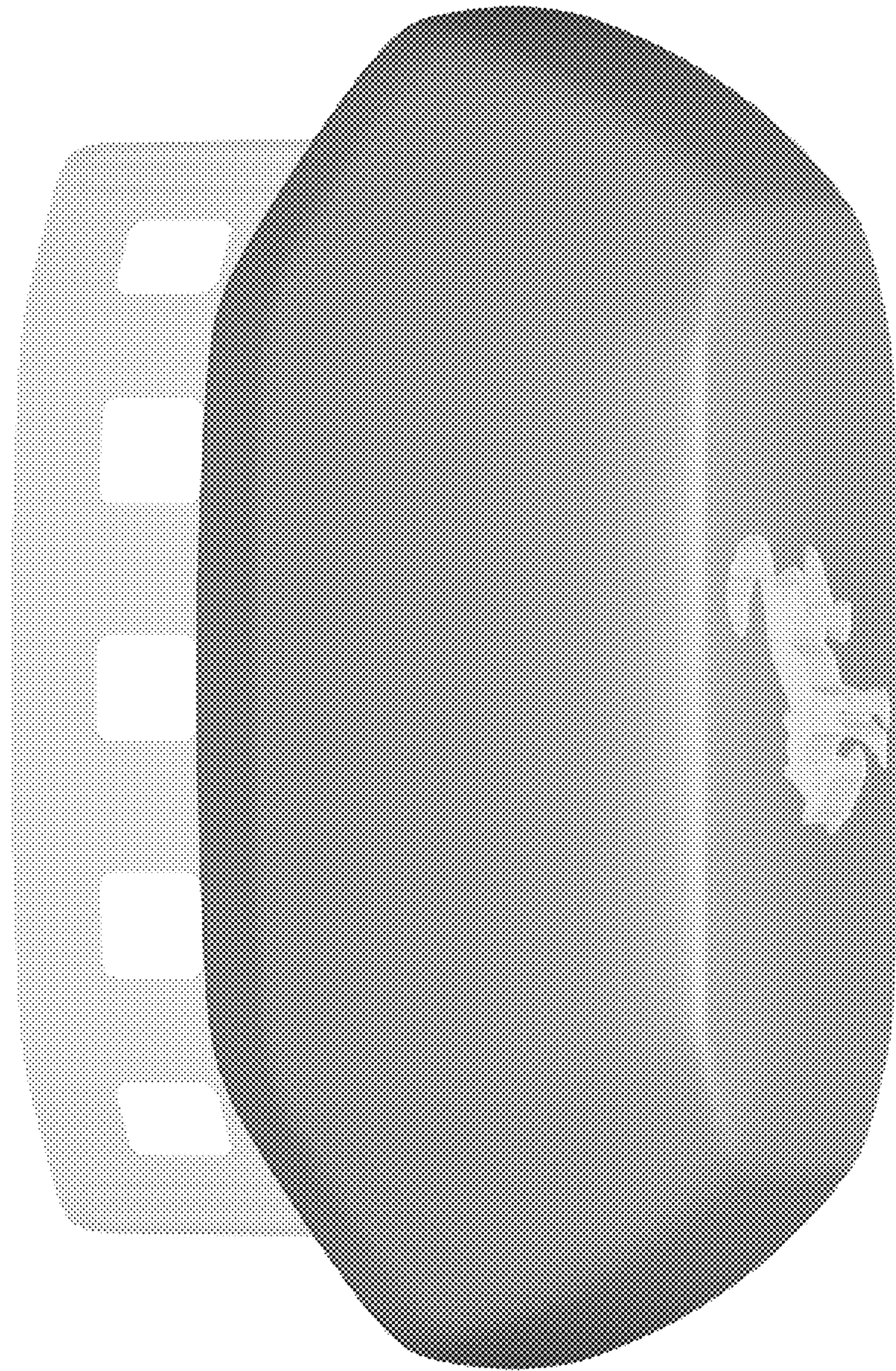

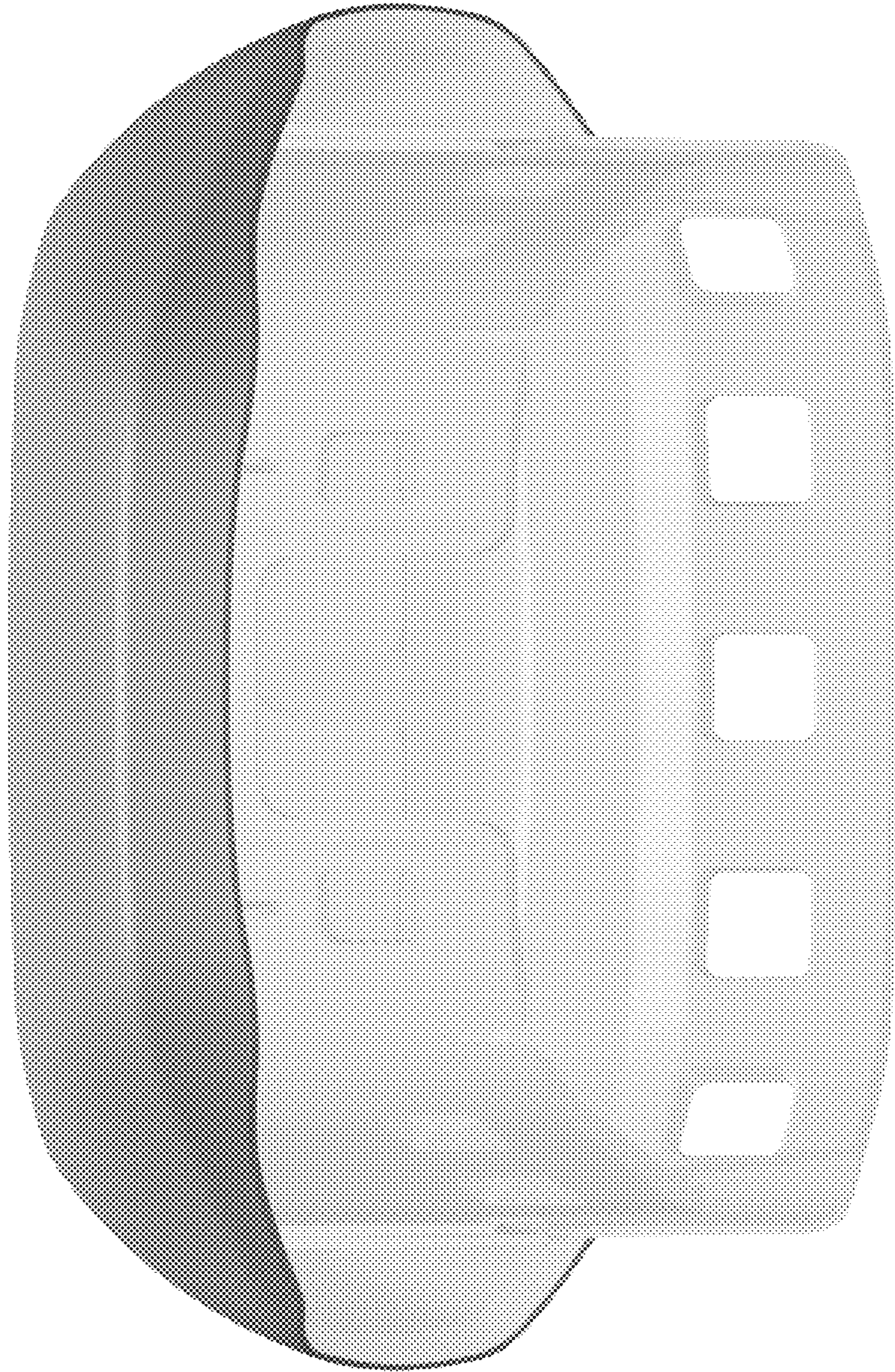
