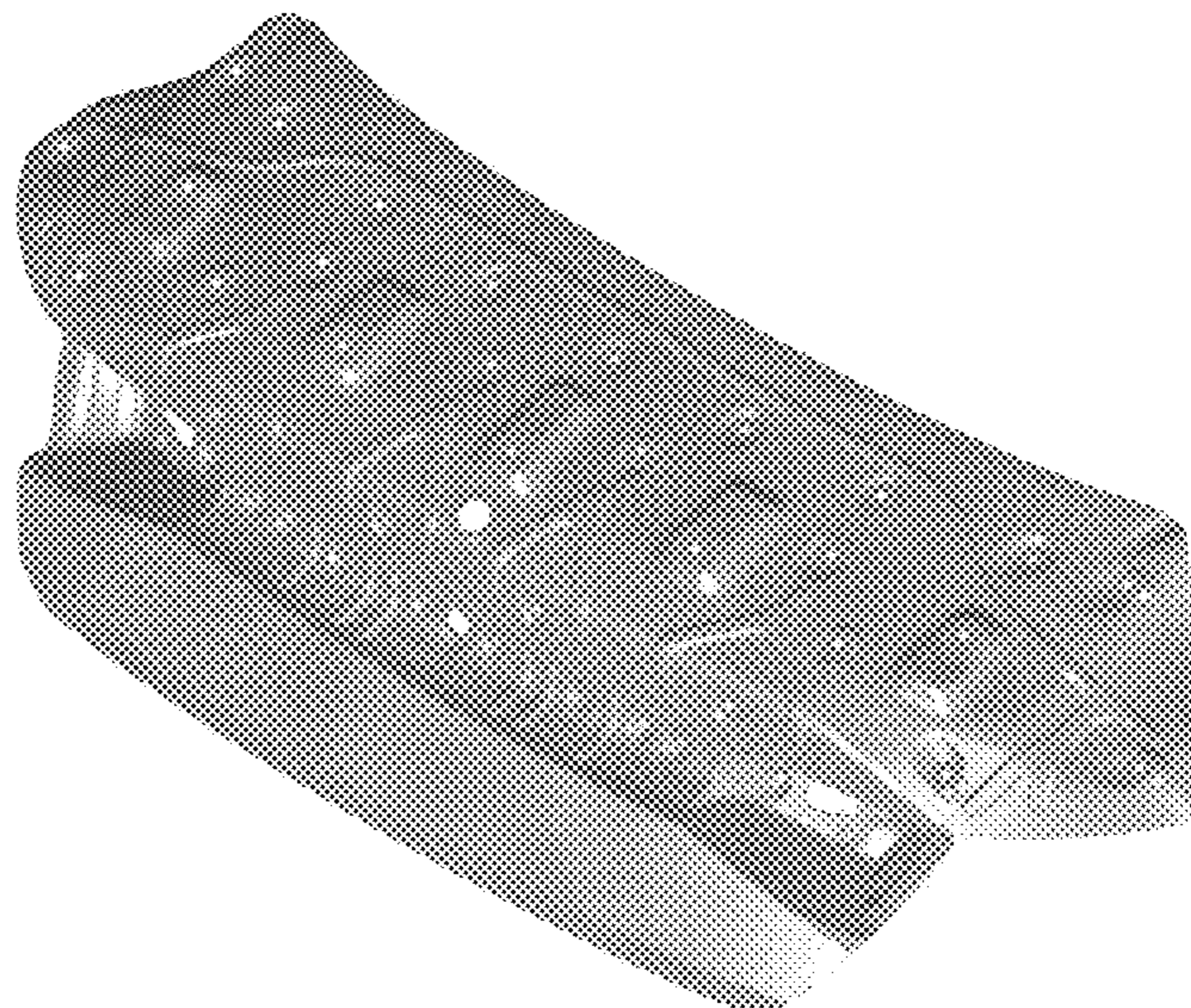
(57) **CLAIM**

DESCRIPTION

1. Trunk lid panel for an automobile
1.1 is a front and right side perspective view of a trunk lid panel for an automobile embodying our new design;

1.4 is a left side elevation view thereof;

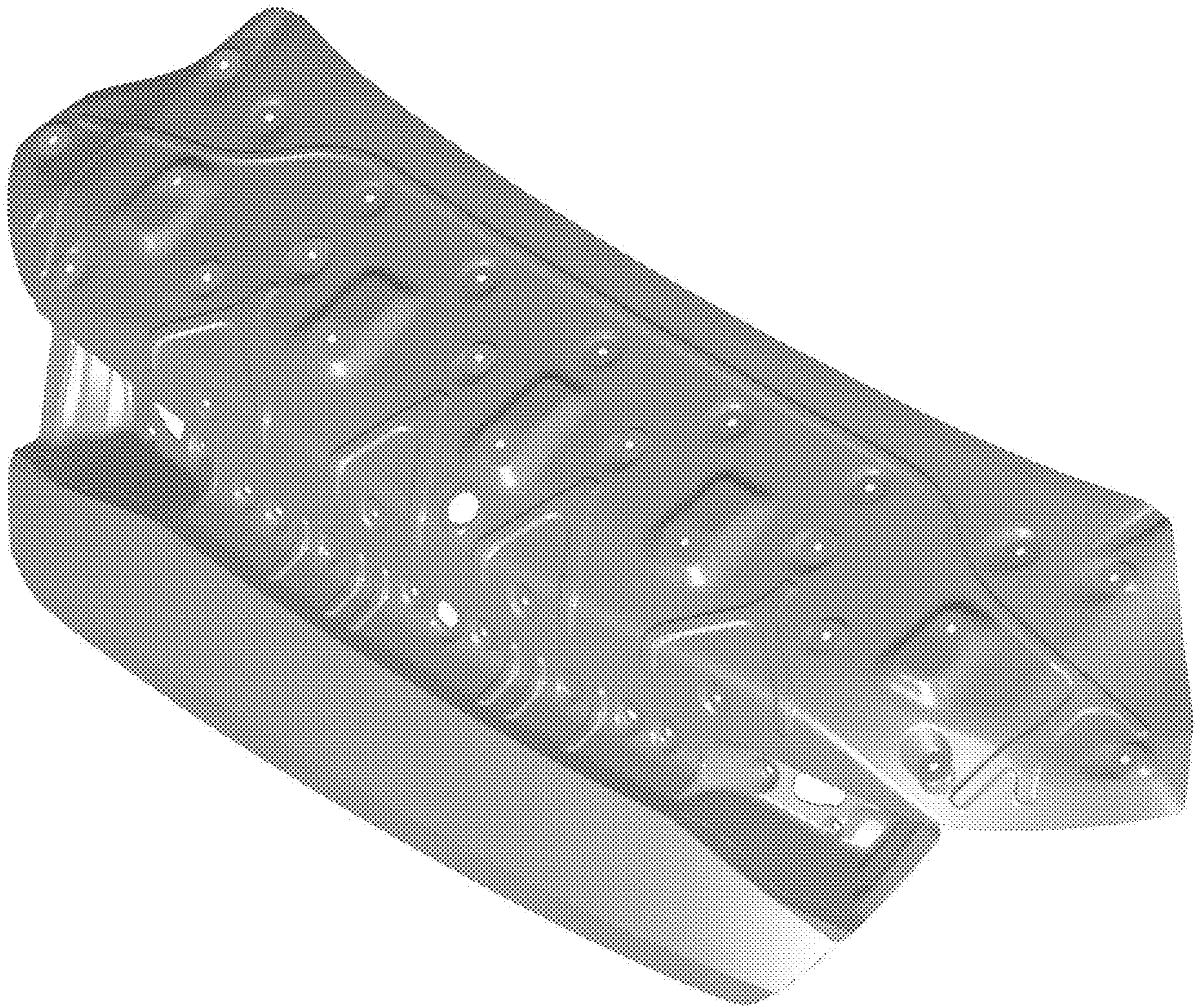

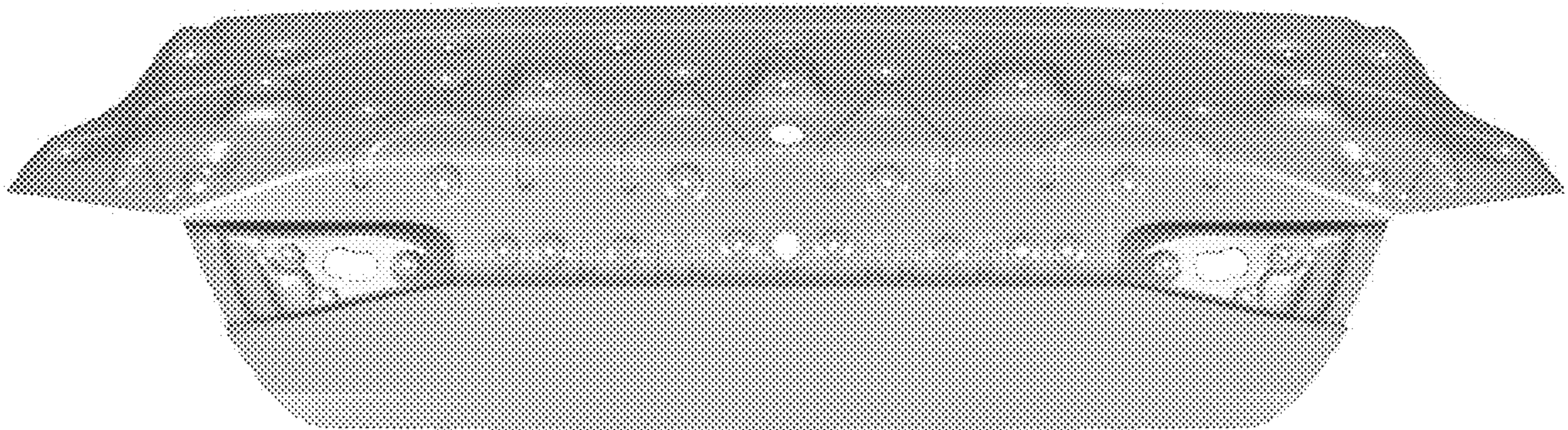

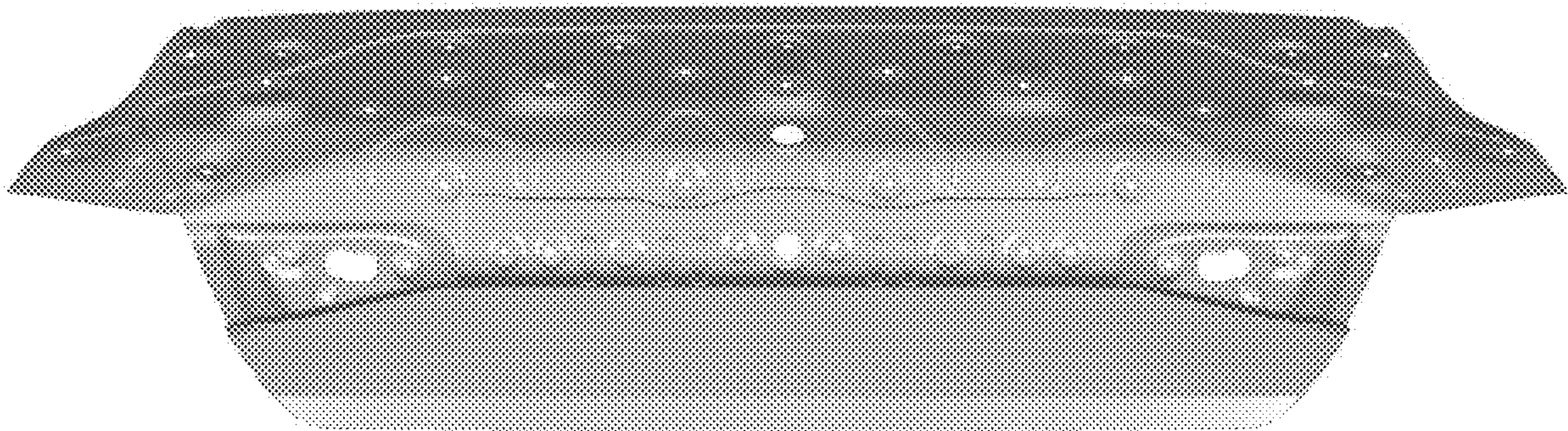

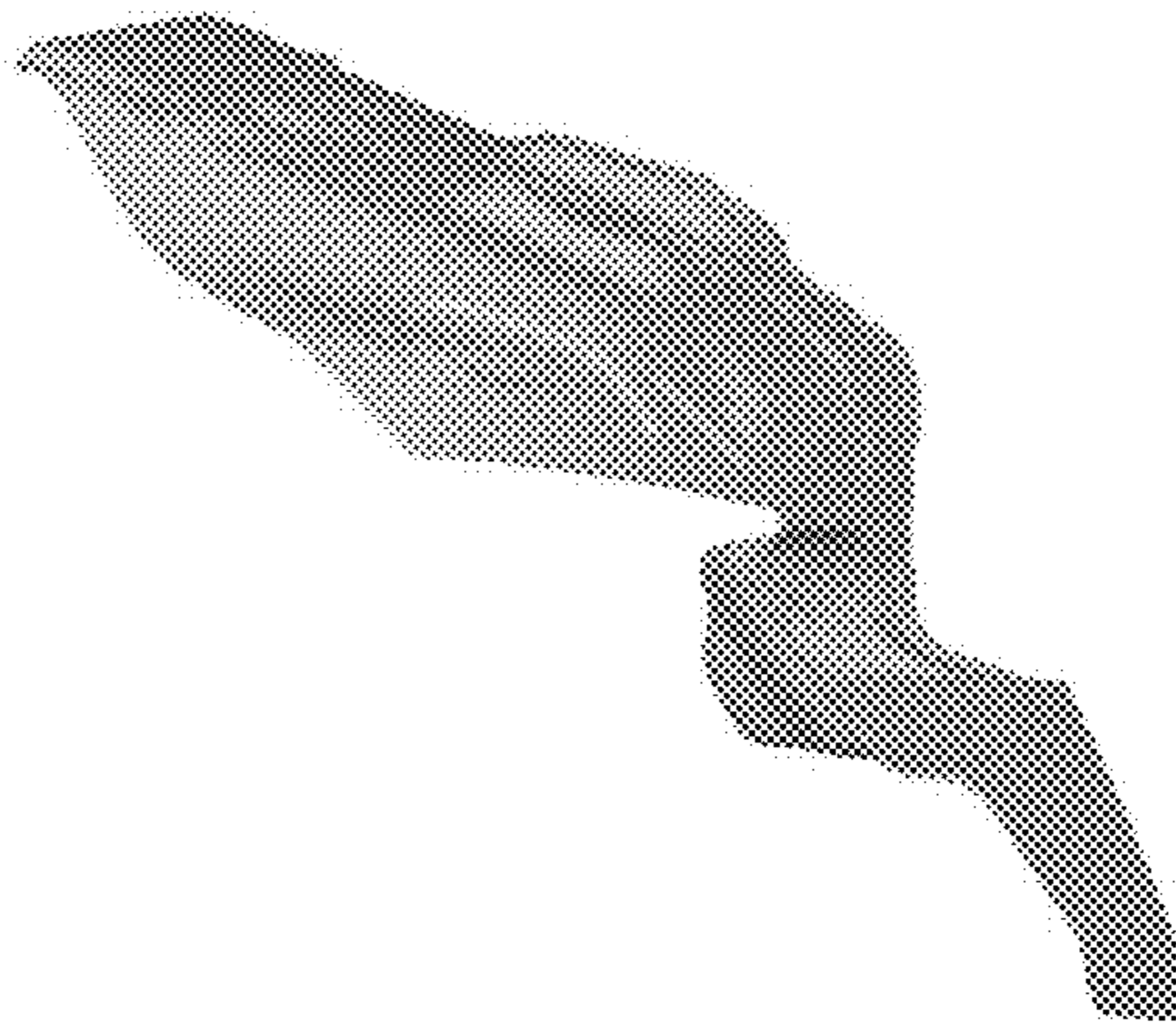

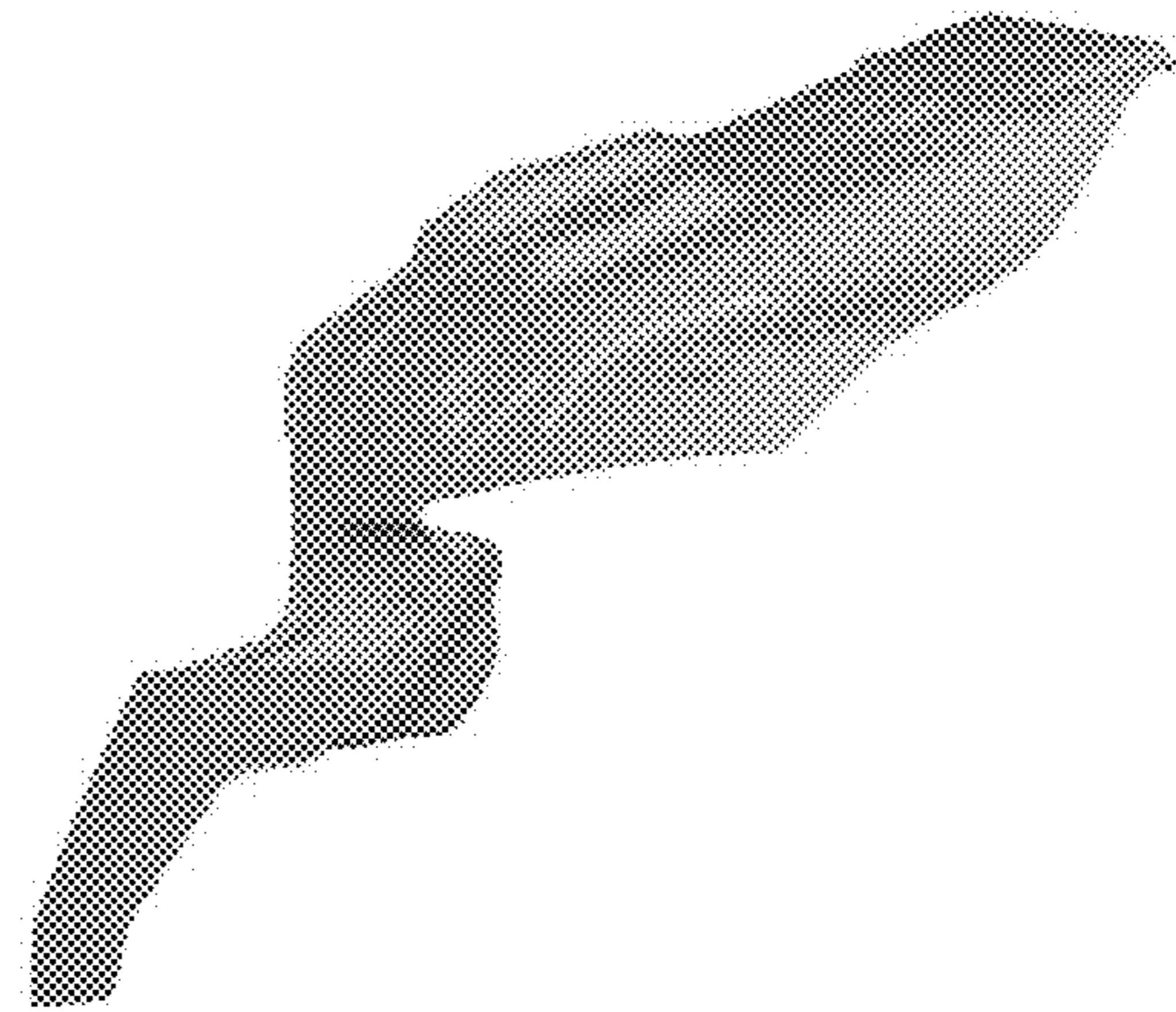

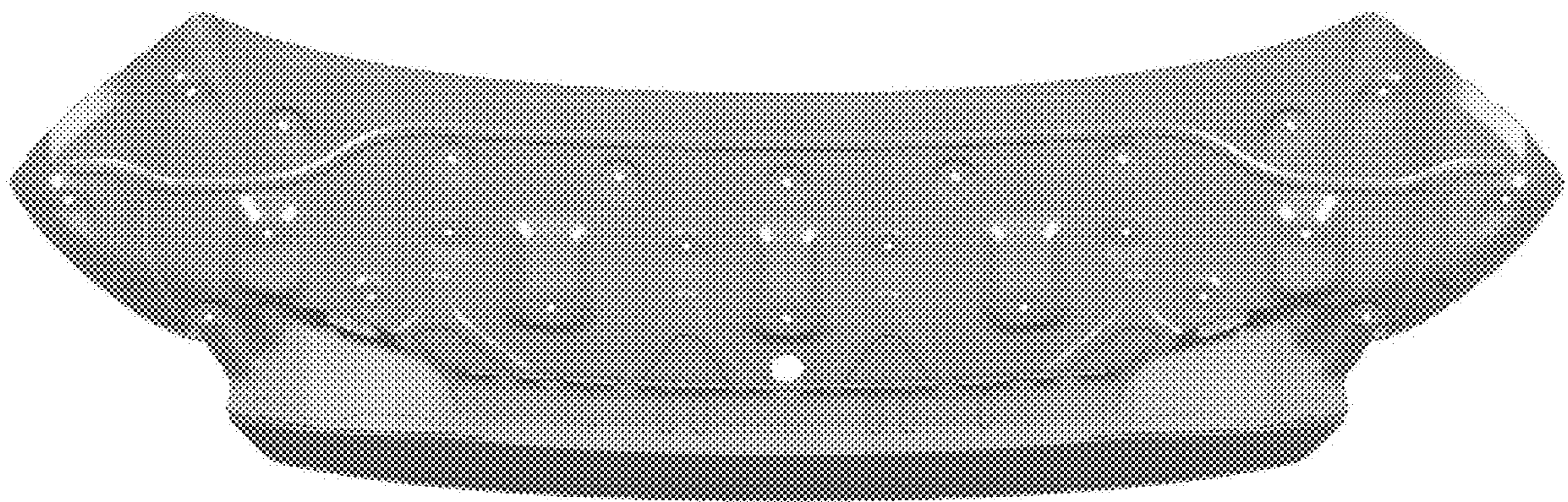
