(57) **CLAIM**

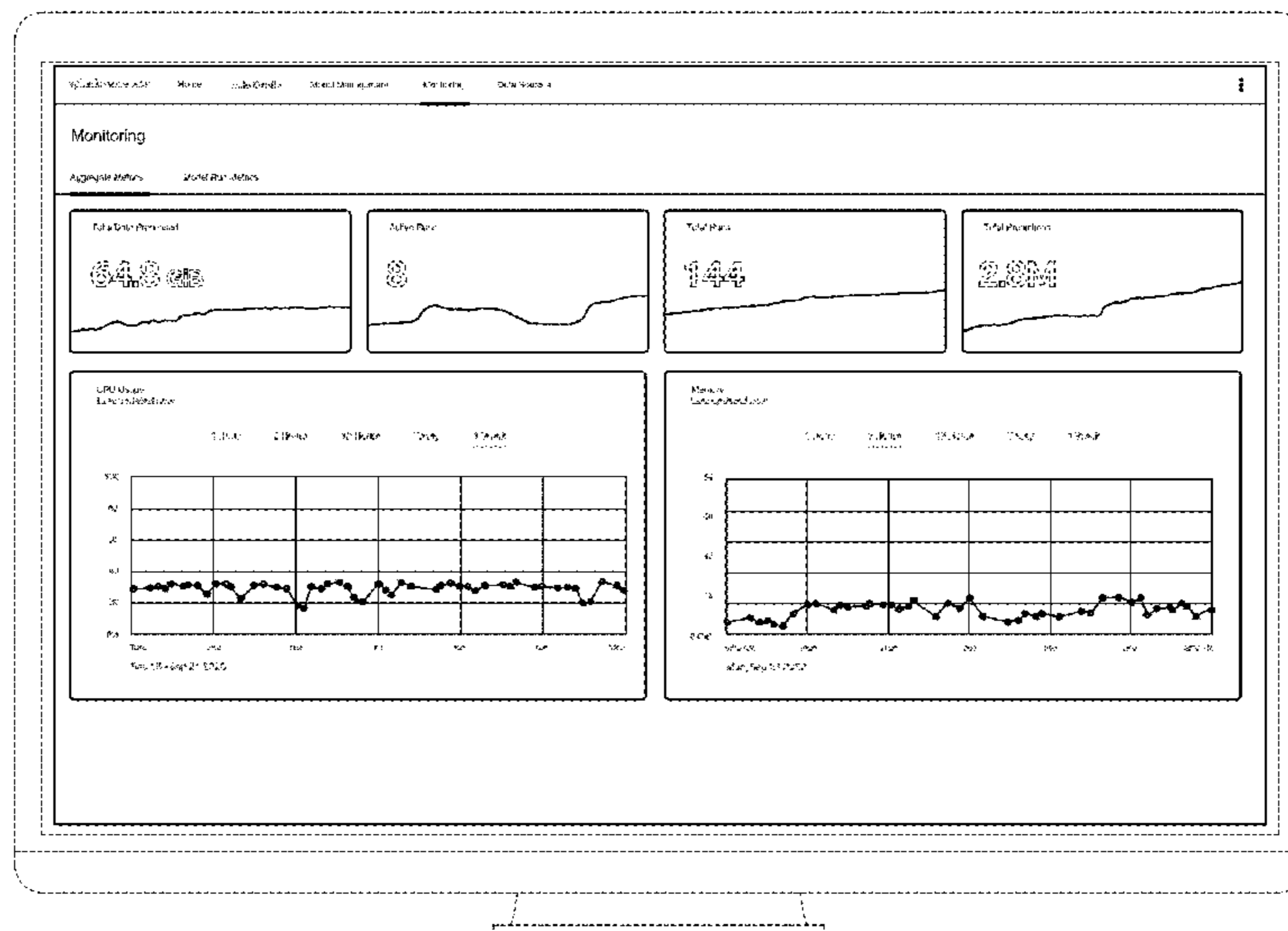
The ornamental design for a display screen or portion thereof having a graphical user interface for monitoring information, as shown and described.

DESCRIPTION
