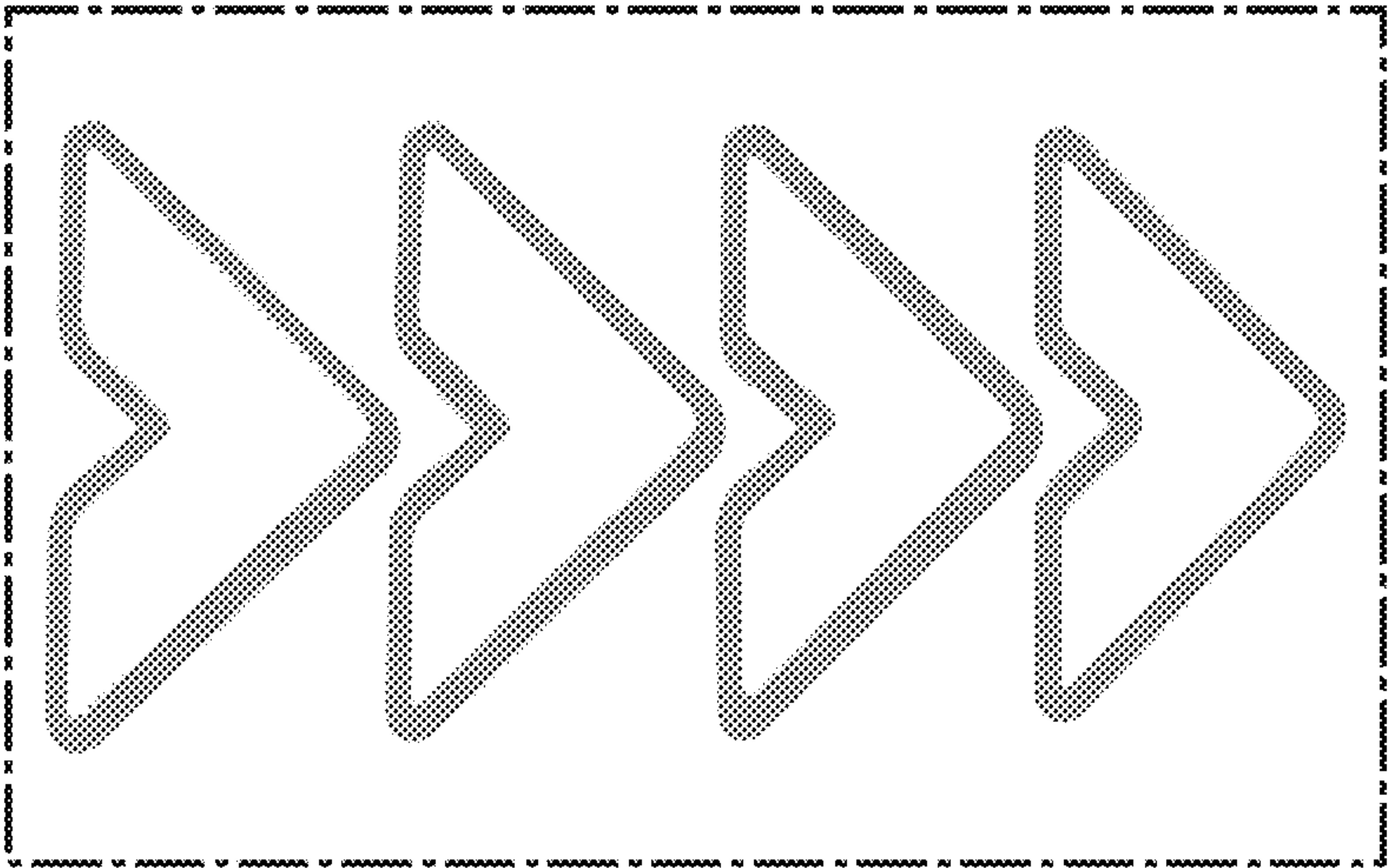
(57) CLAIM
