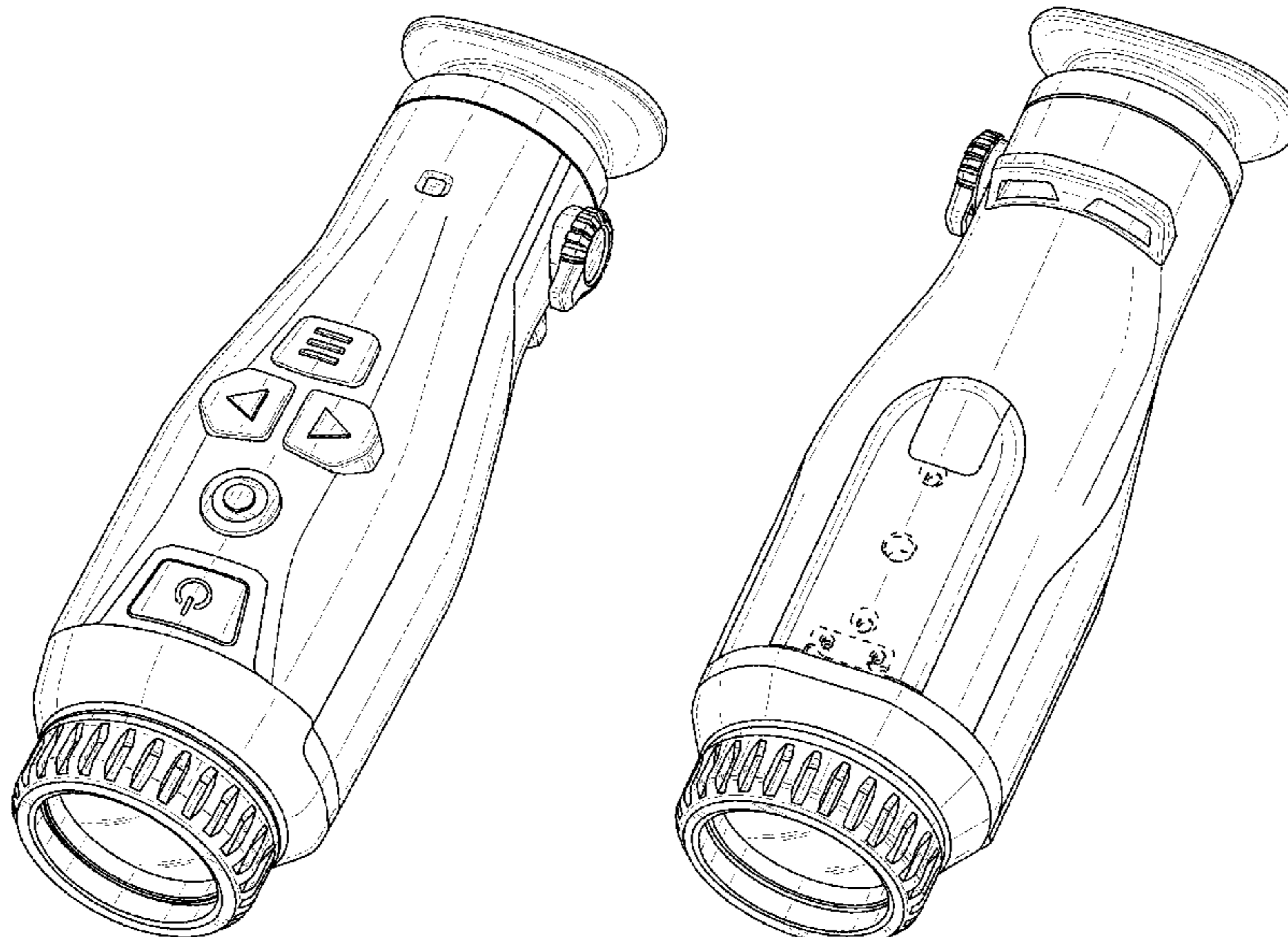
(57) **CLAIM**

The ornamental design for a thermal imaging camera, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a thermal imaging camera showing our new design;

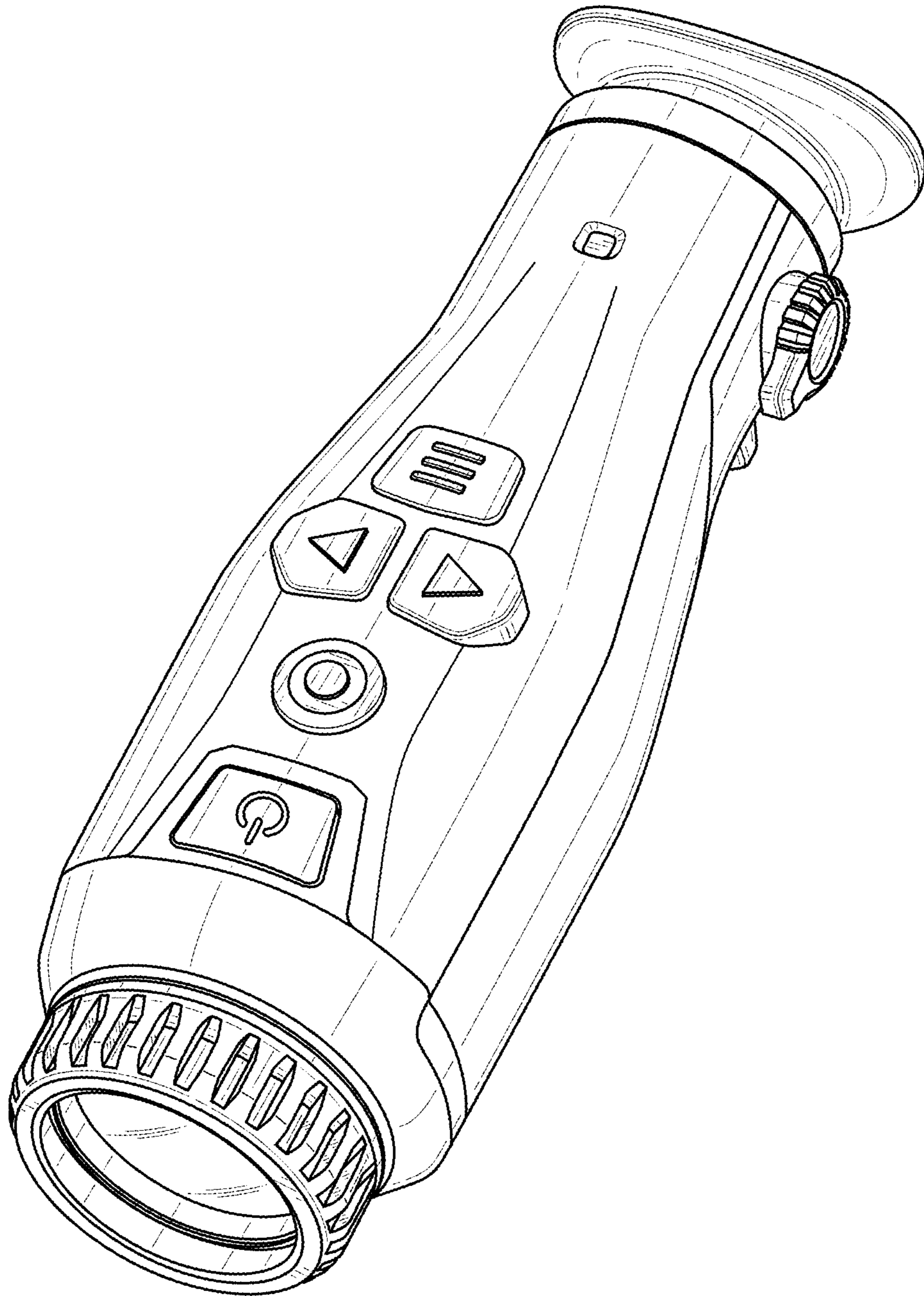

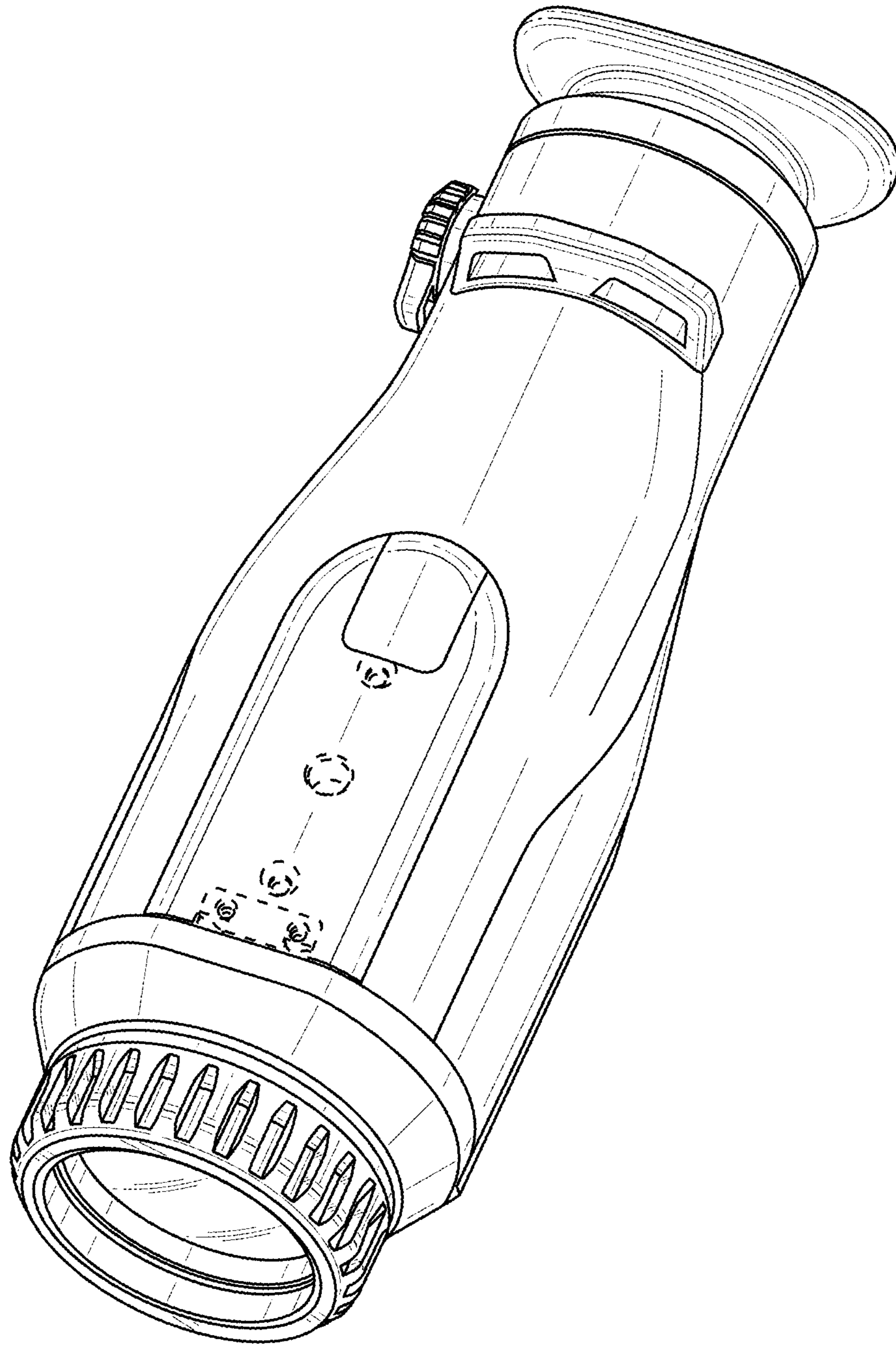

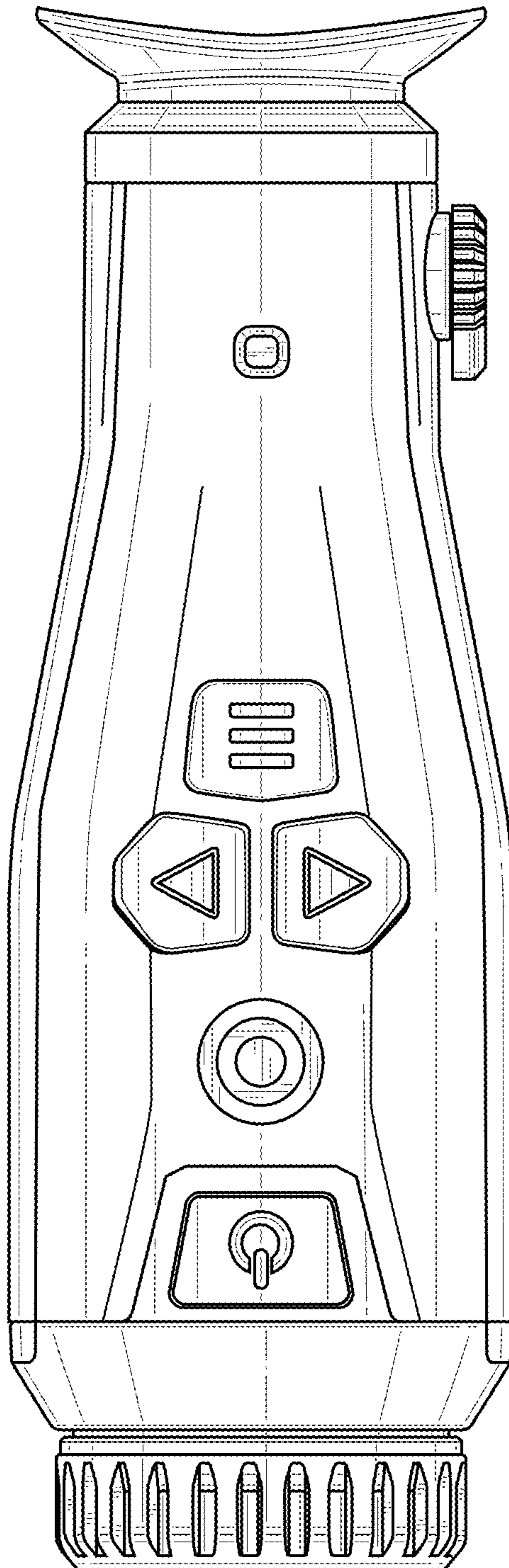

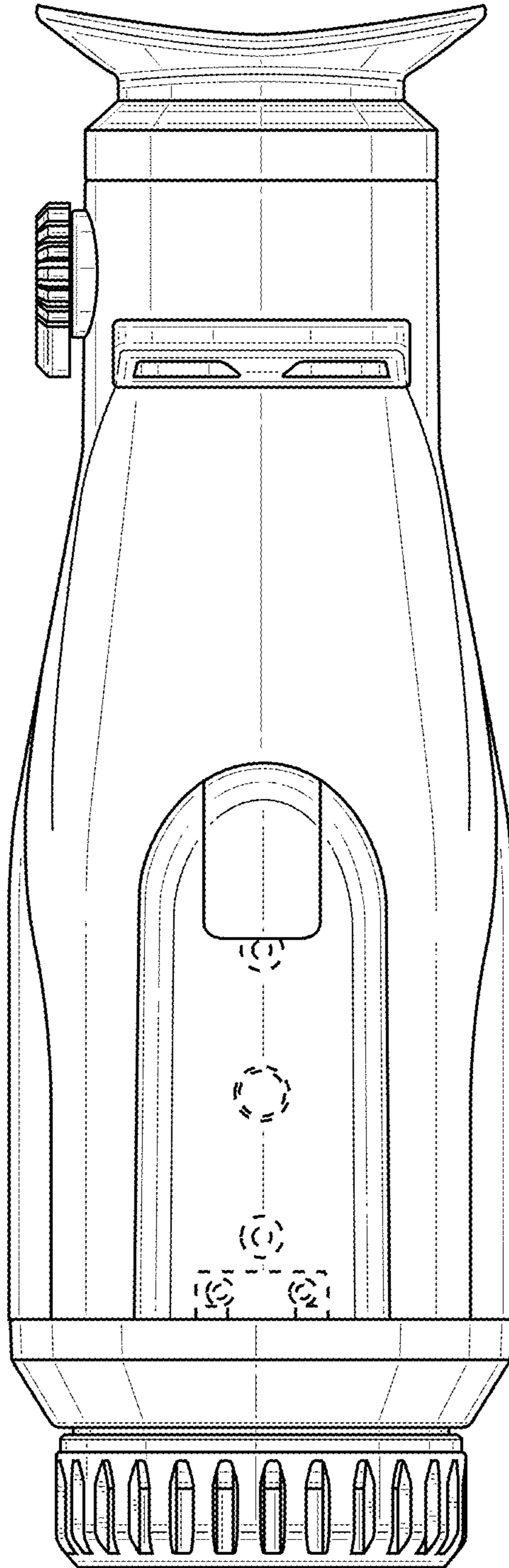

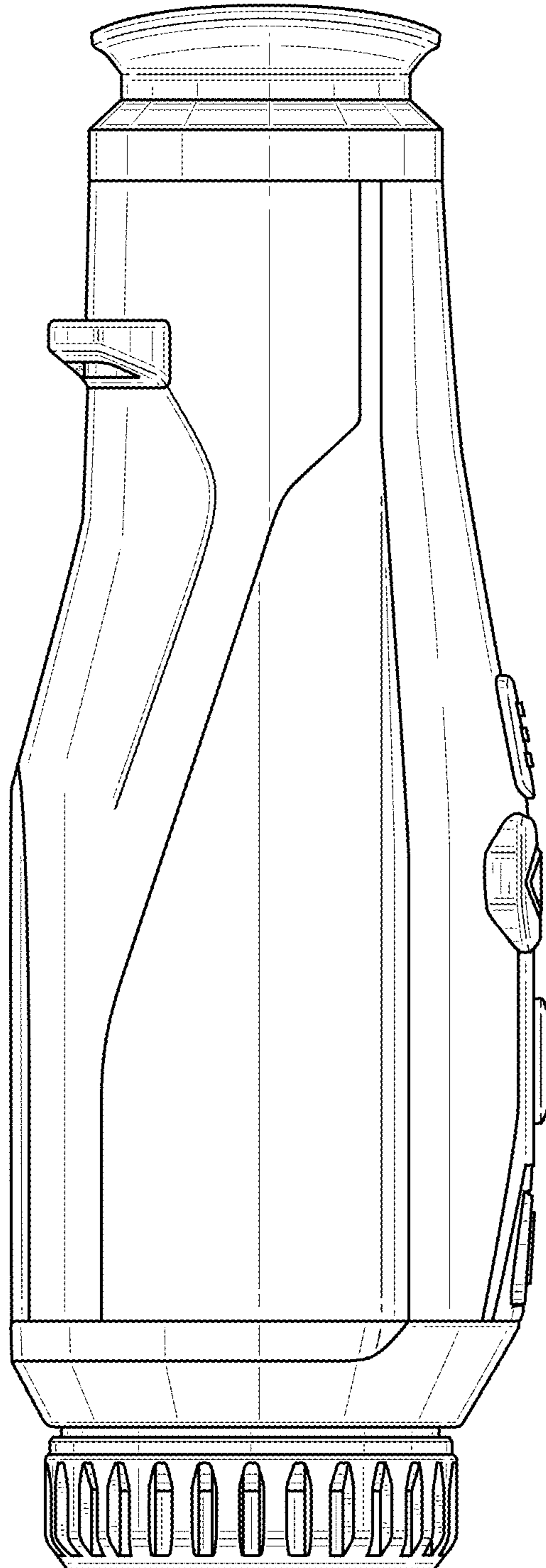

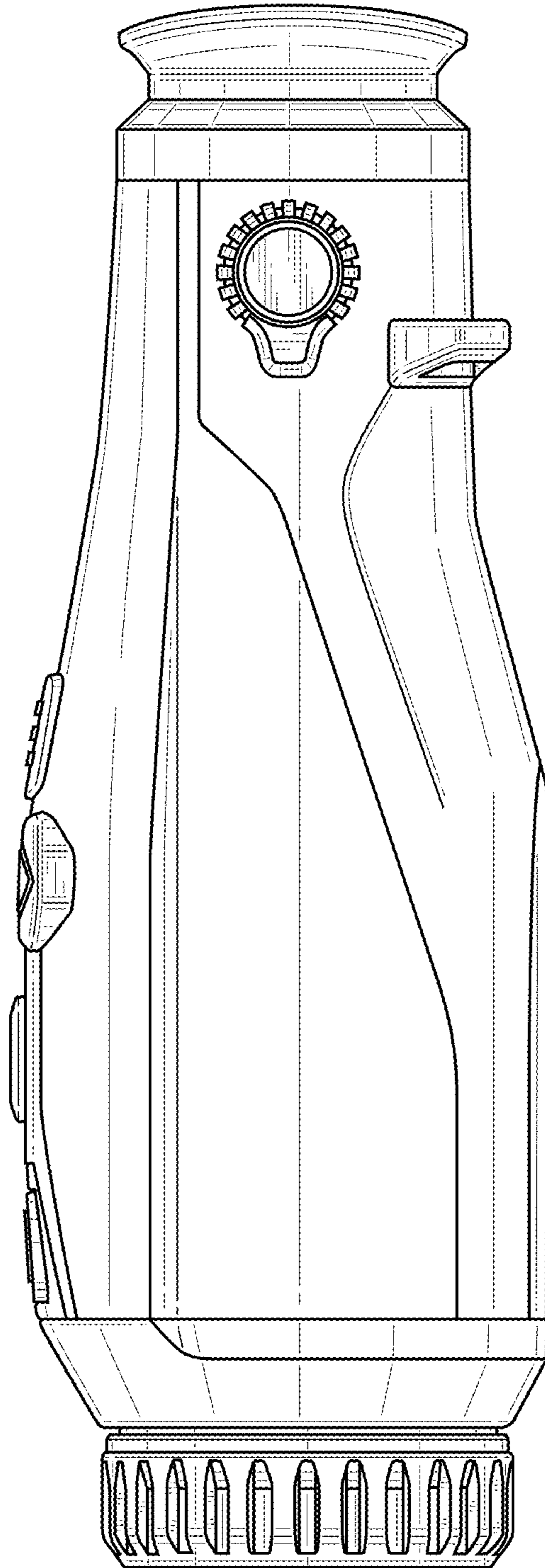

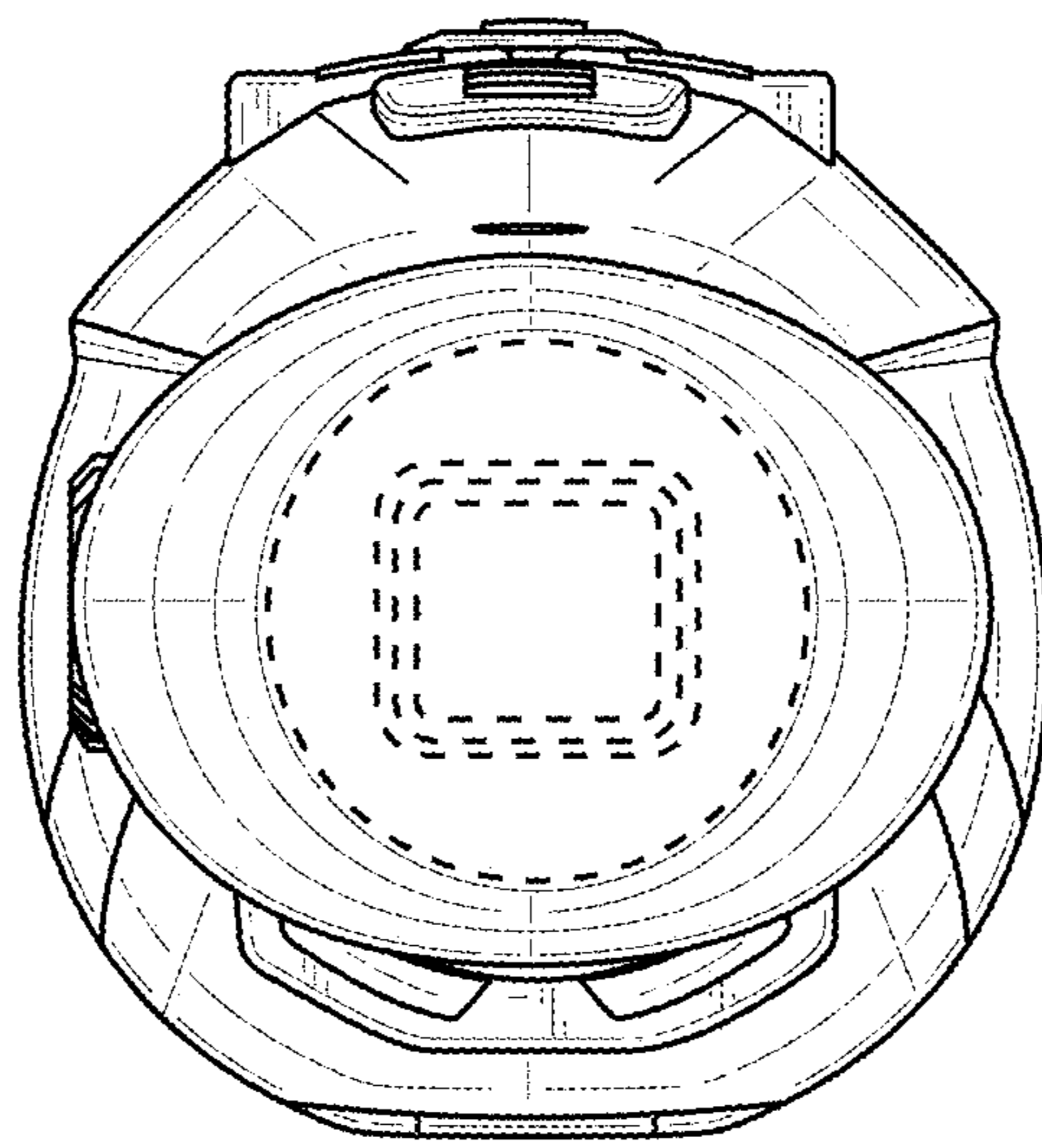

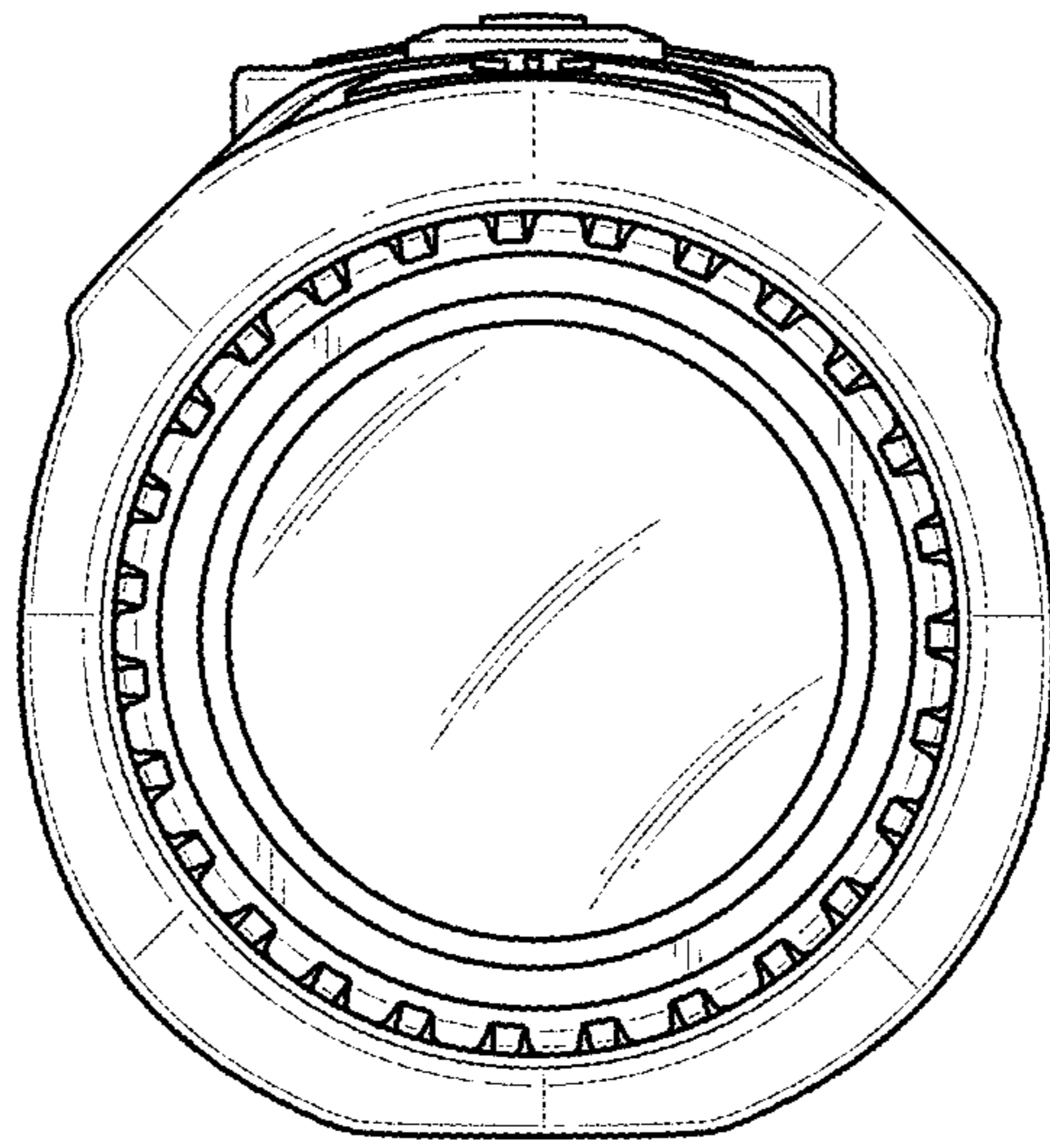
