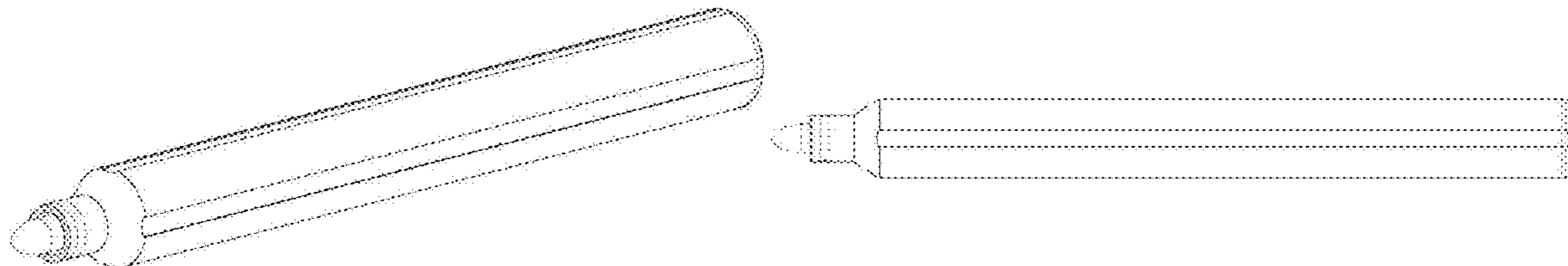
(57) **CLAIM**

We claim the ornamental design for a marker cartridge, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a marker cartridge showing our new design;
FIG. 2 is a side view of the marker cartridge of FIG. 1;
FIG. 3 is a front view of the marker cartridge of FIG. 1; and,
FIG. 4 is a rear view of the marker cartridge of FIG. 1.

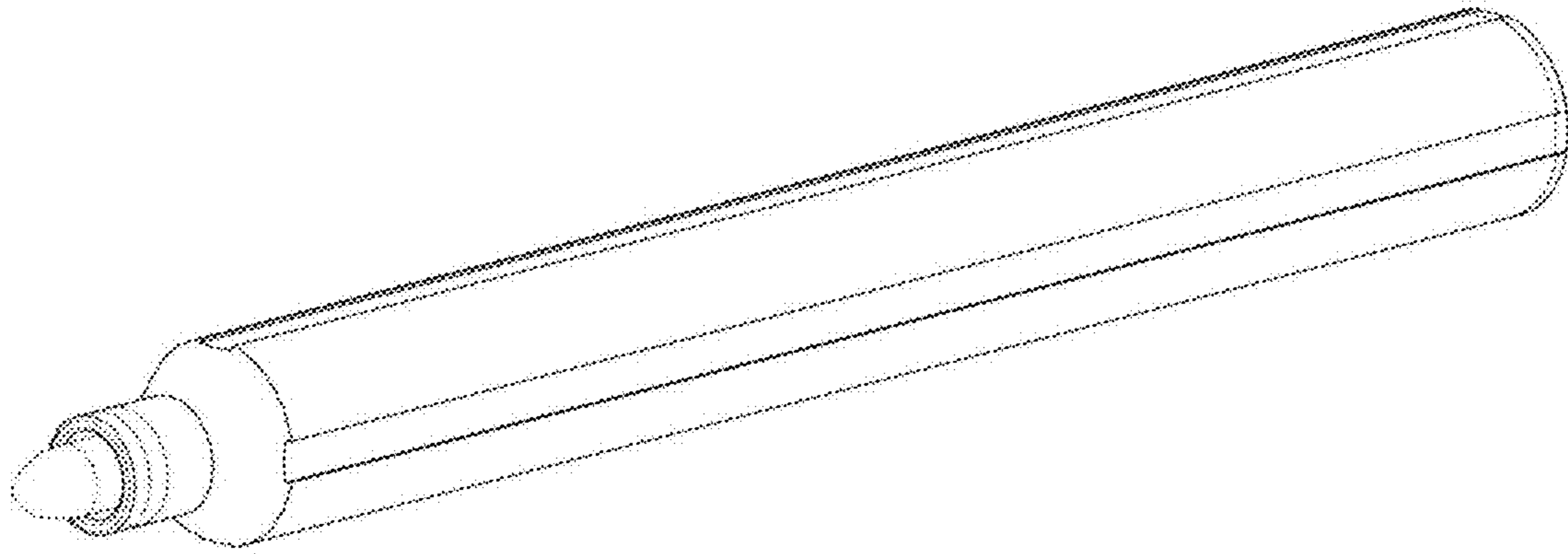

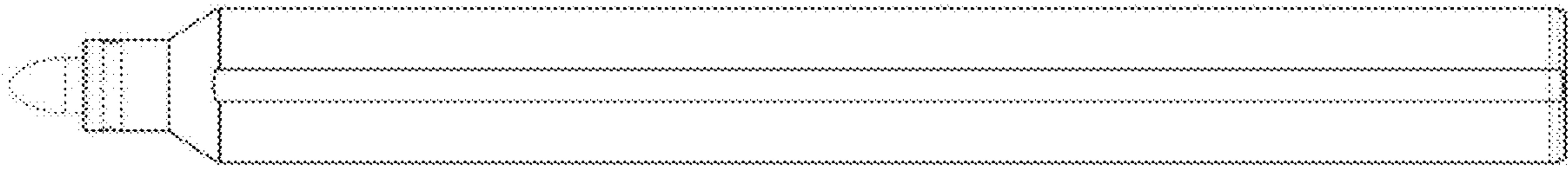

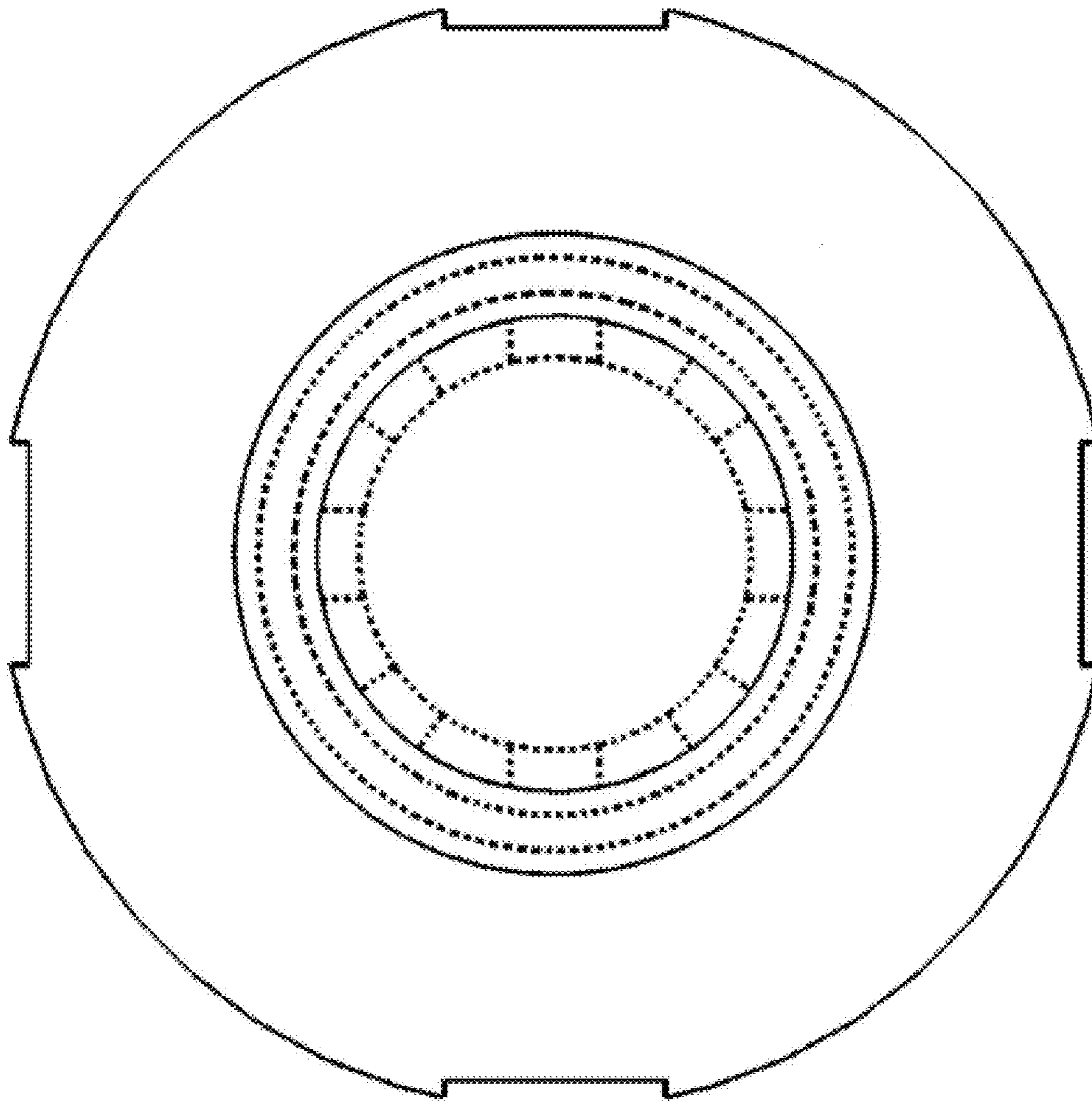

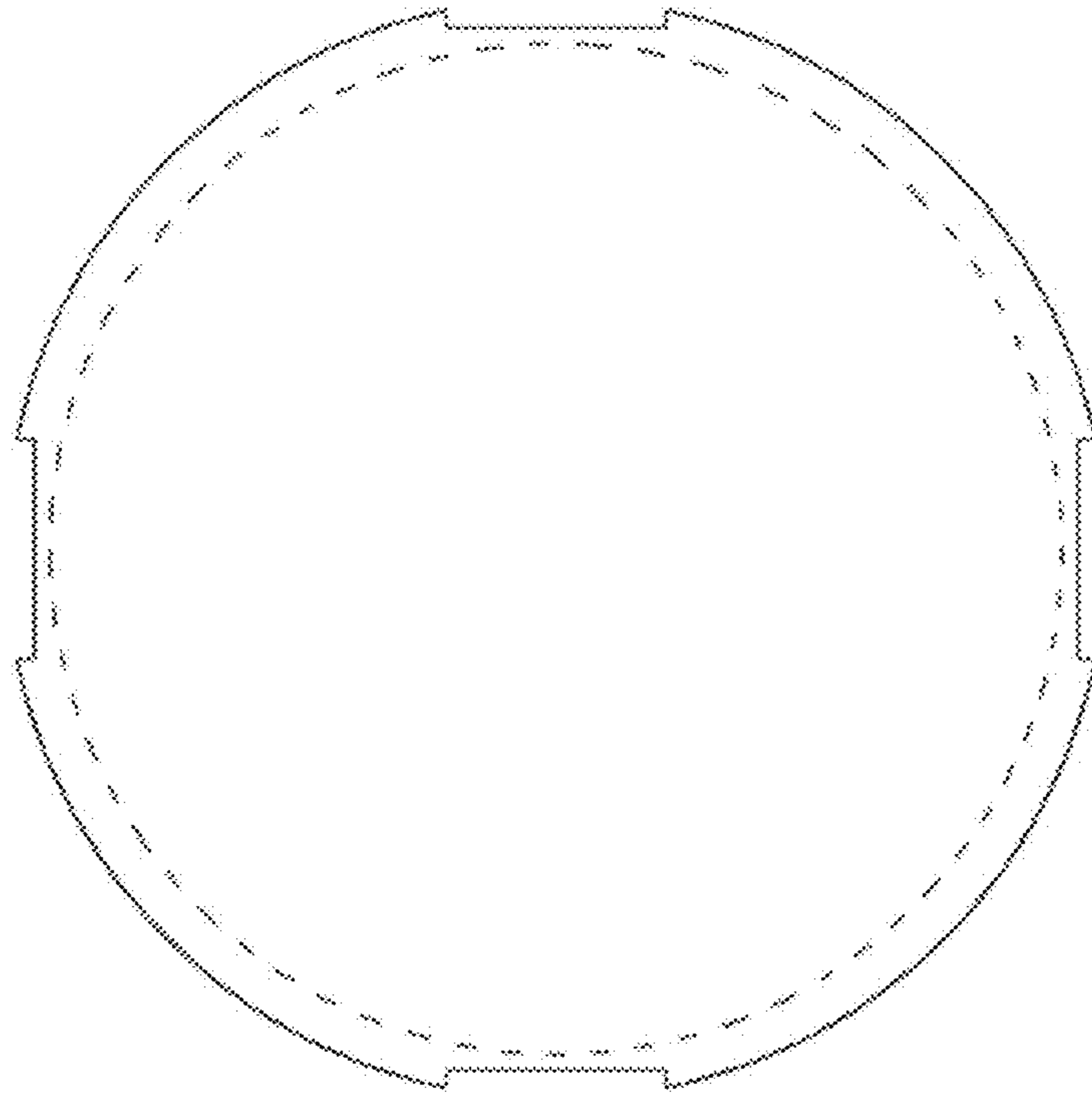
