DESCRIPTION

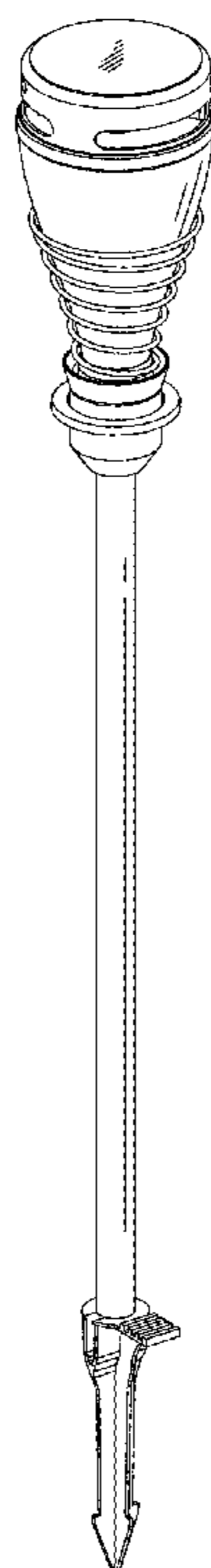
FIG. 1 is a perspective view of a ground insert lamp showing my design.

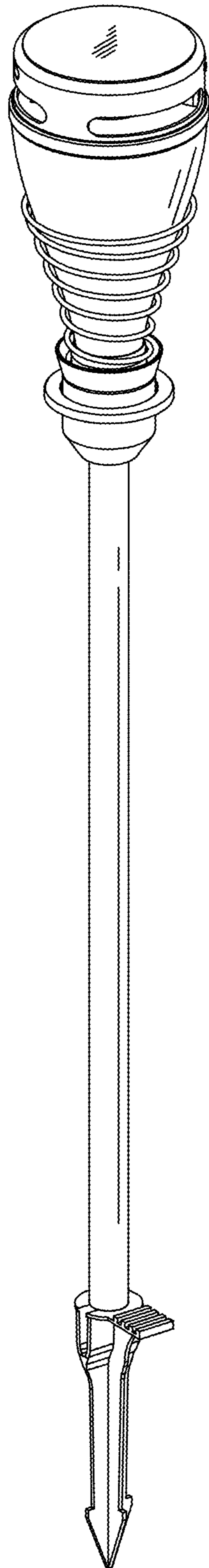

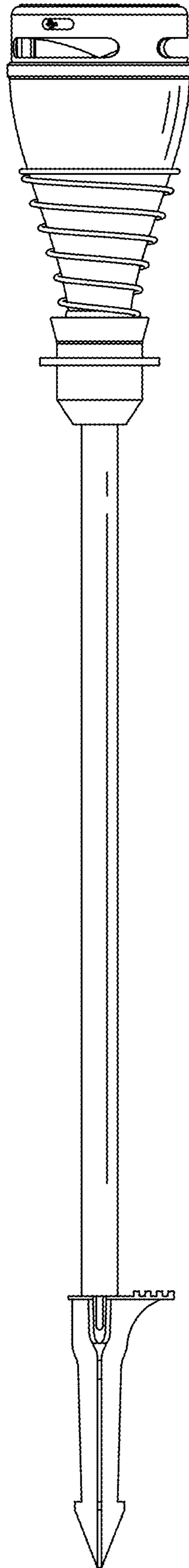

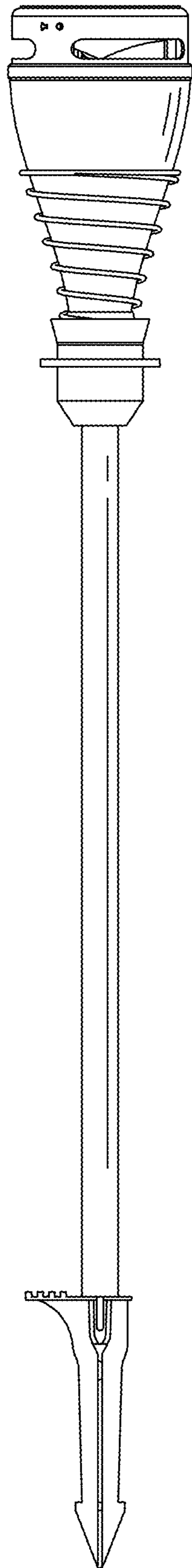

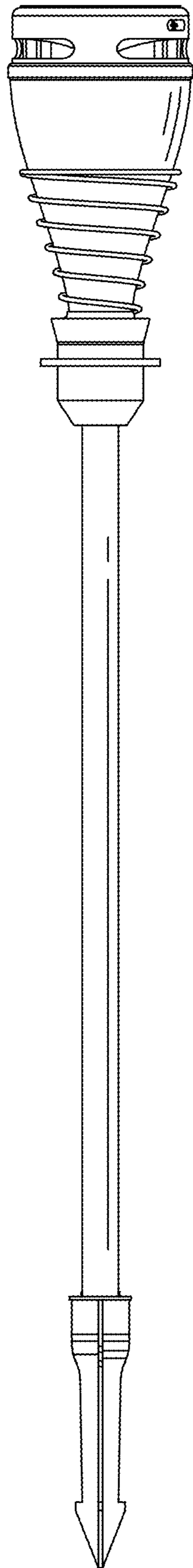

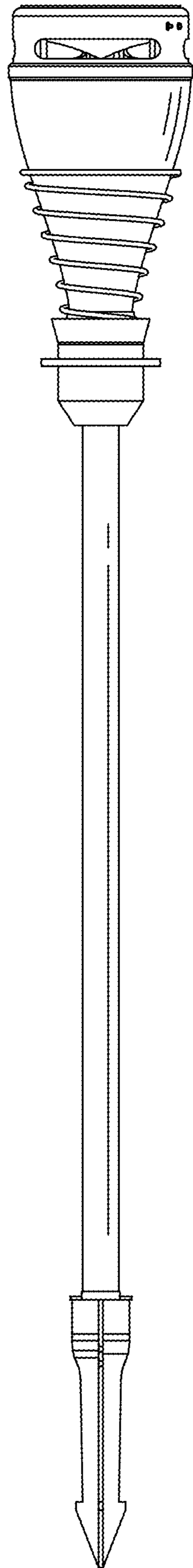

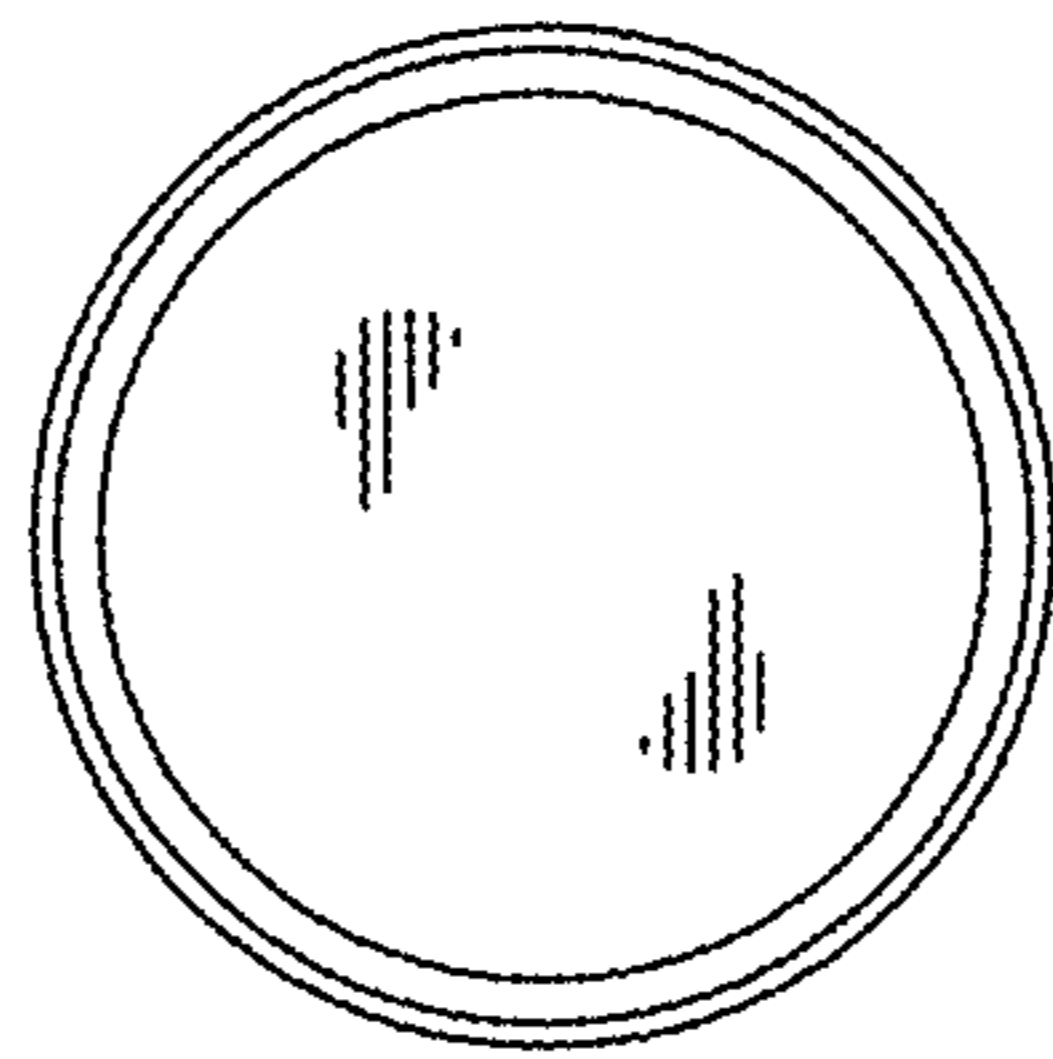

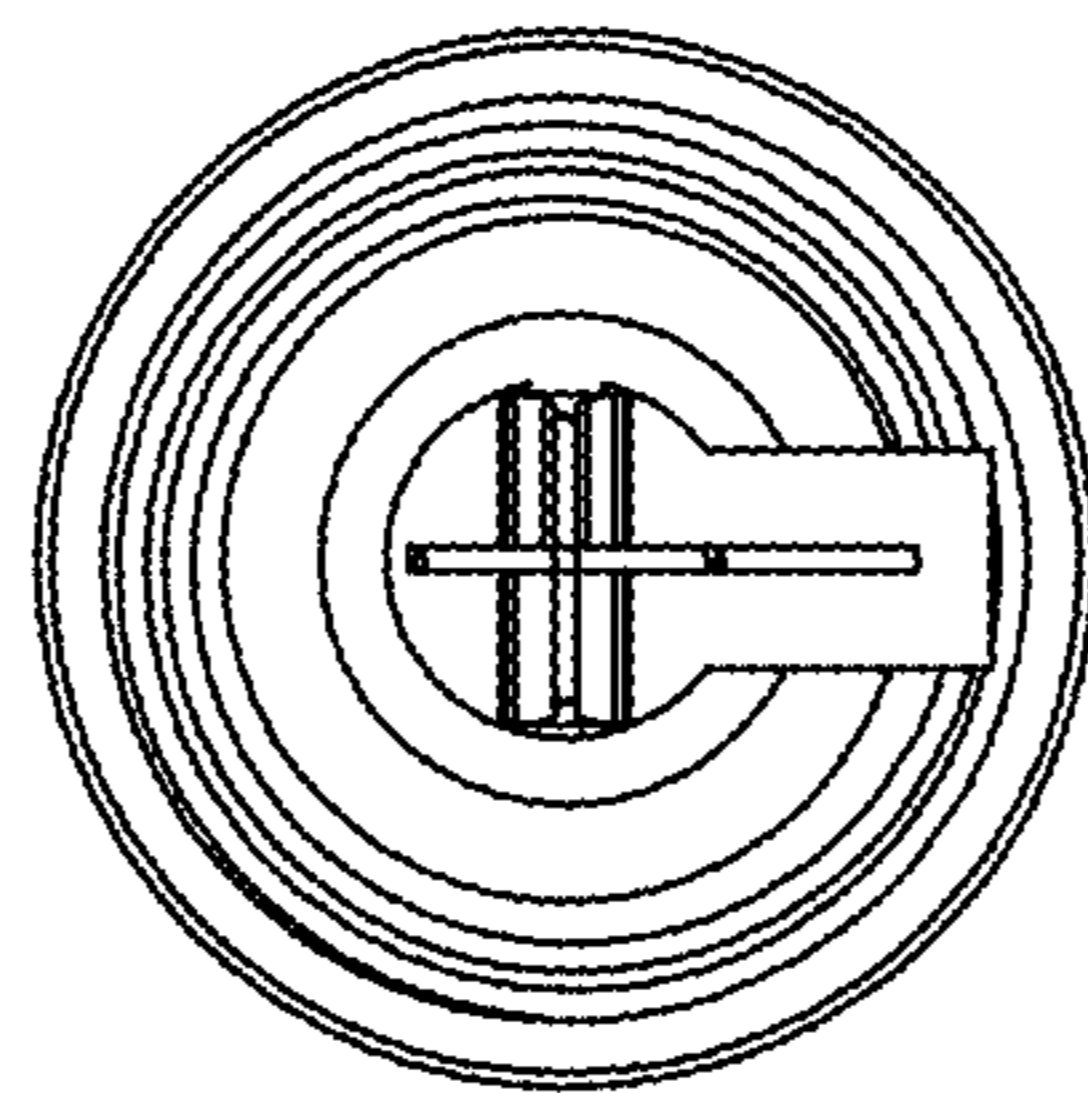
