DESCRIPTION

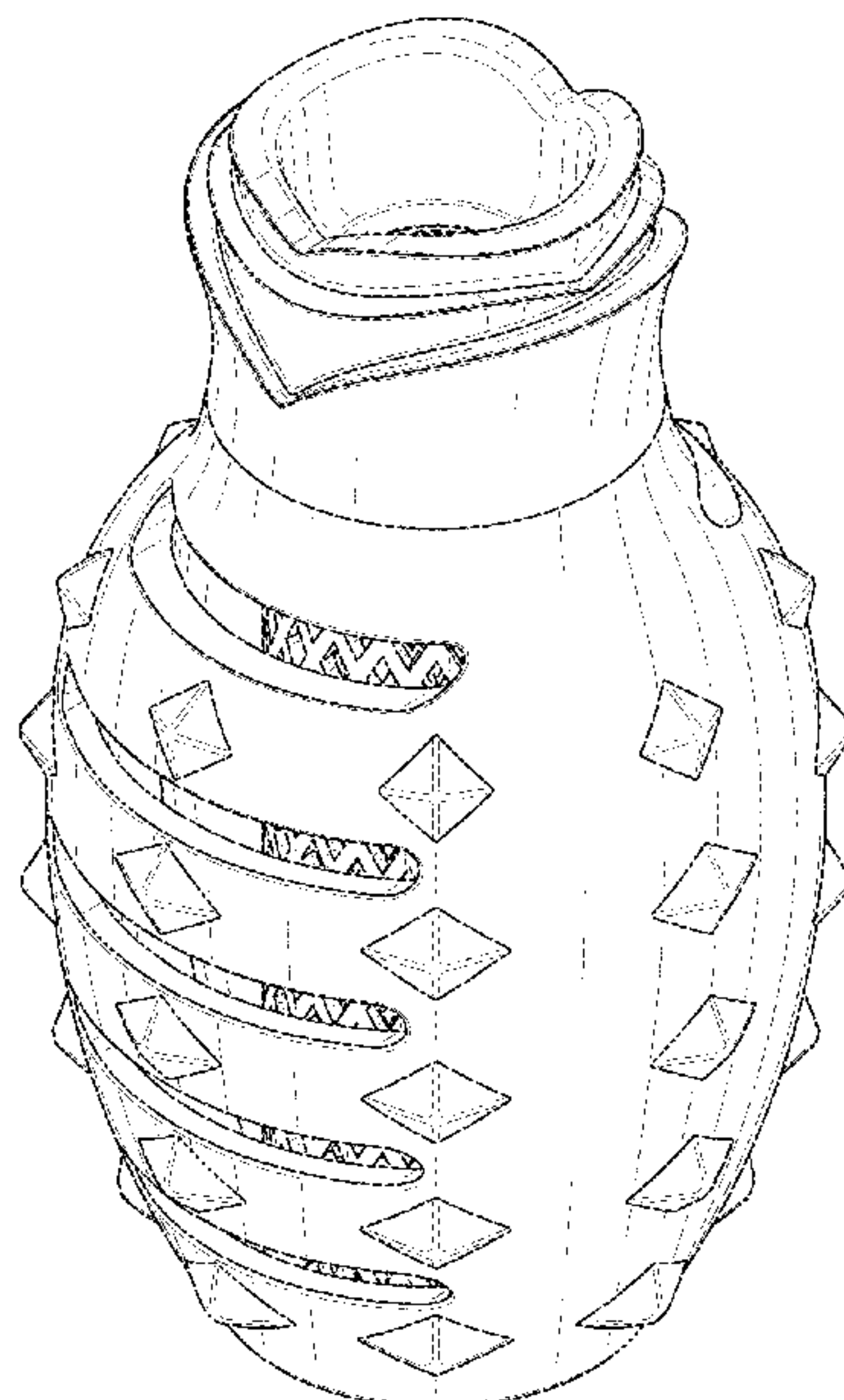
FIG. 1 is an isometric view of a laundry masher, in accordance with the design;

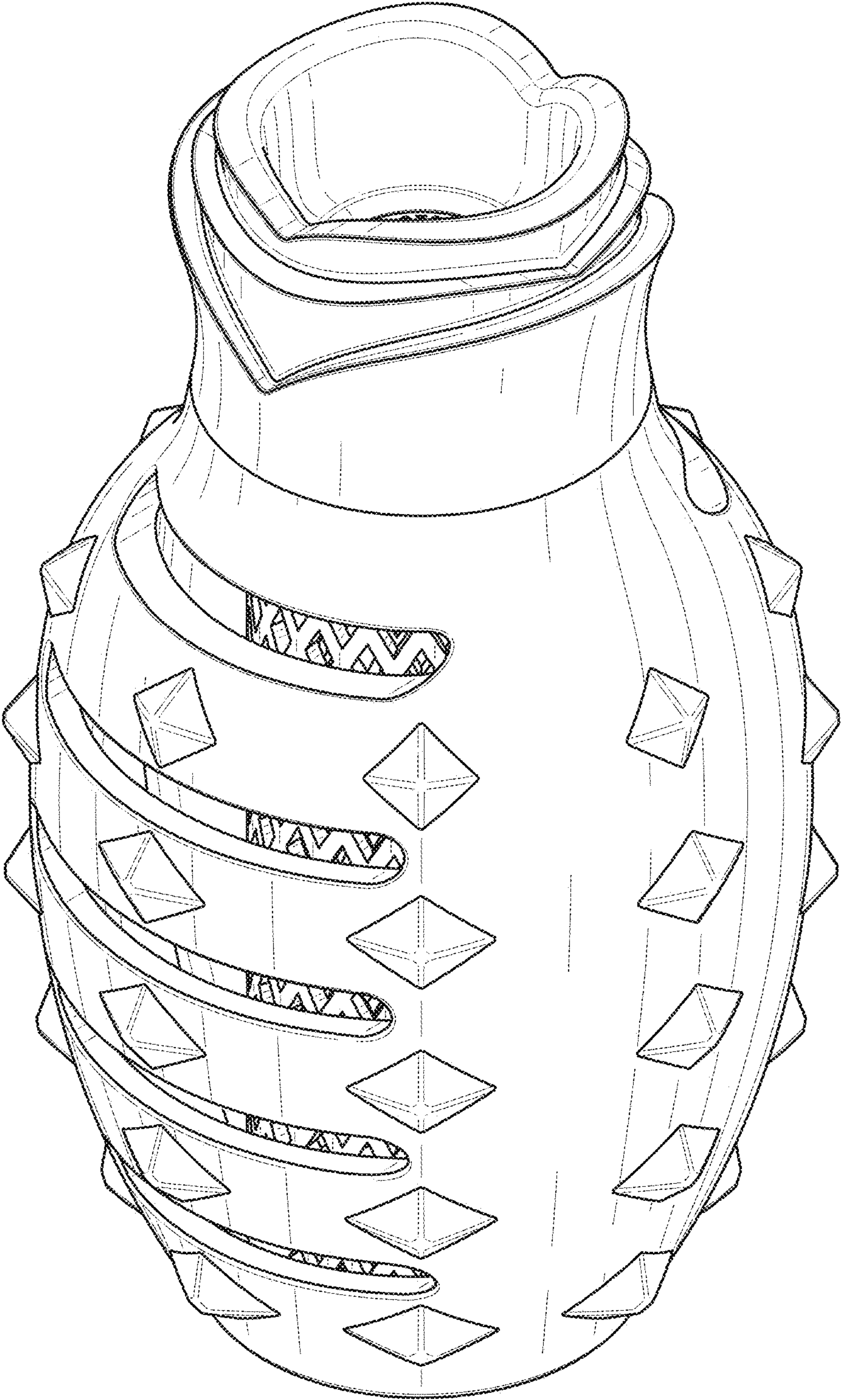

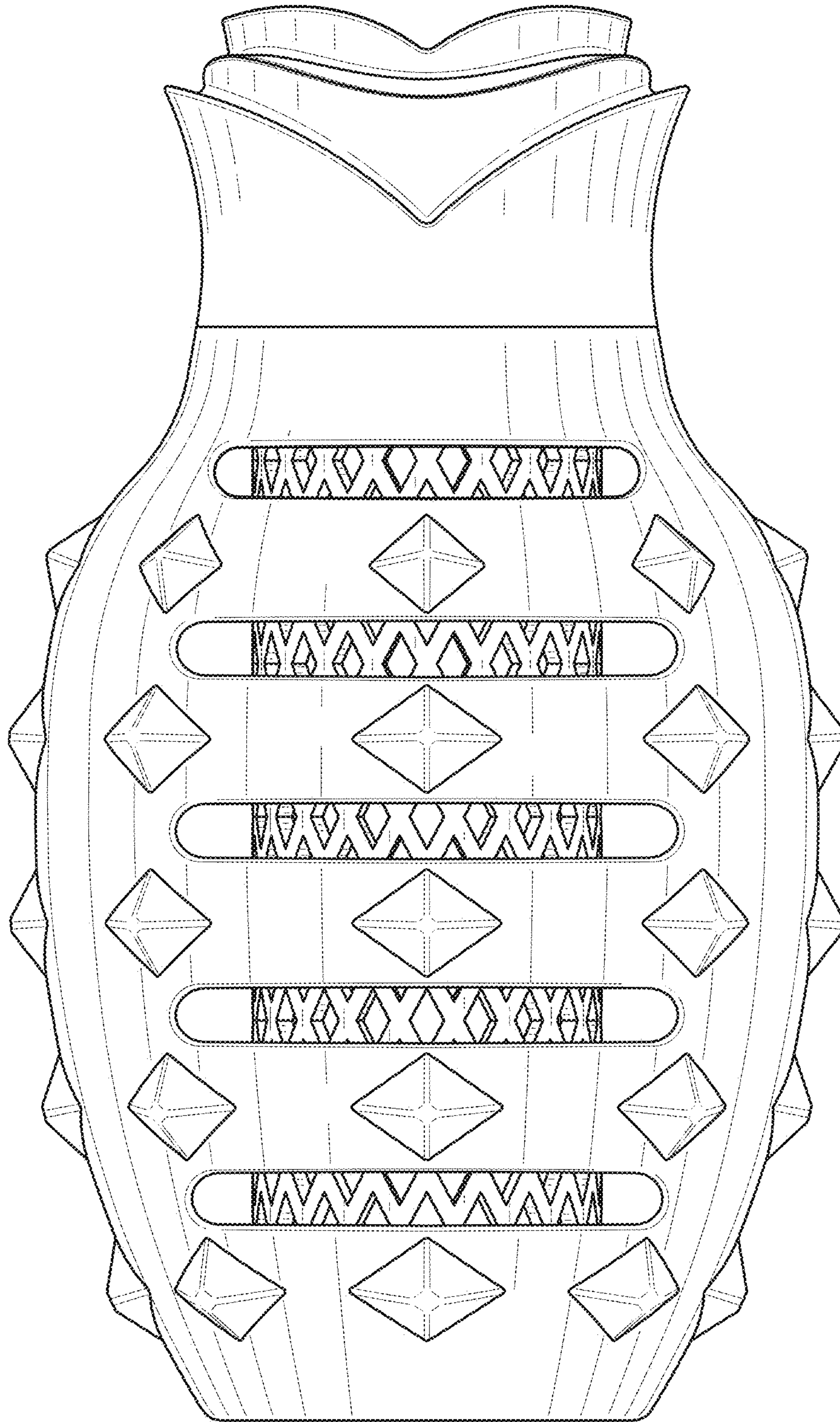

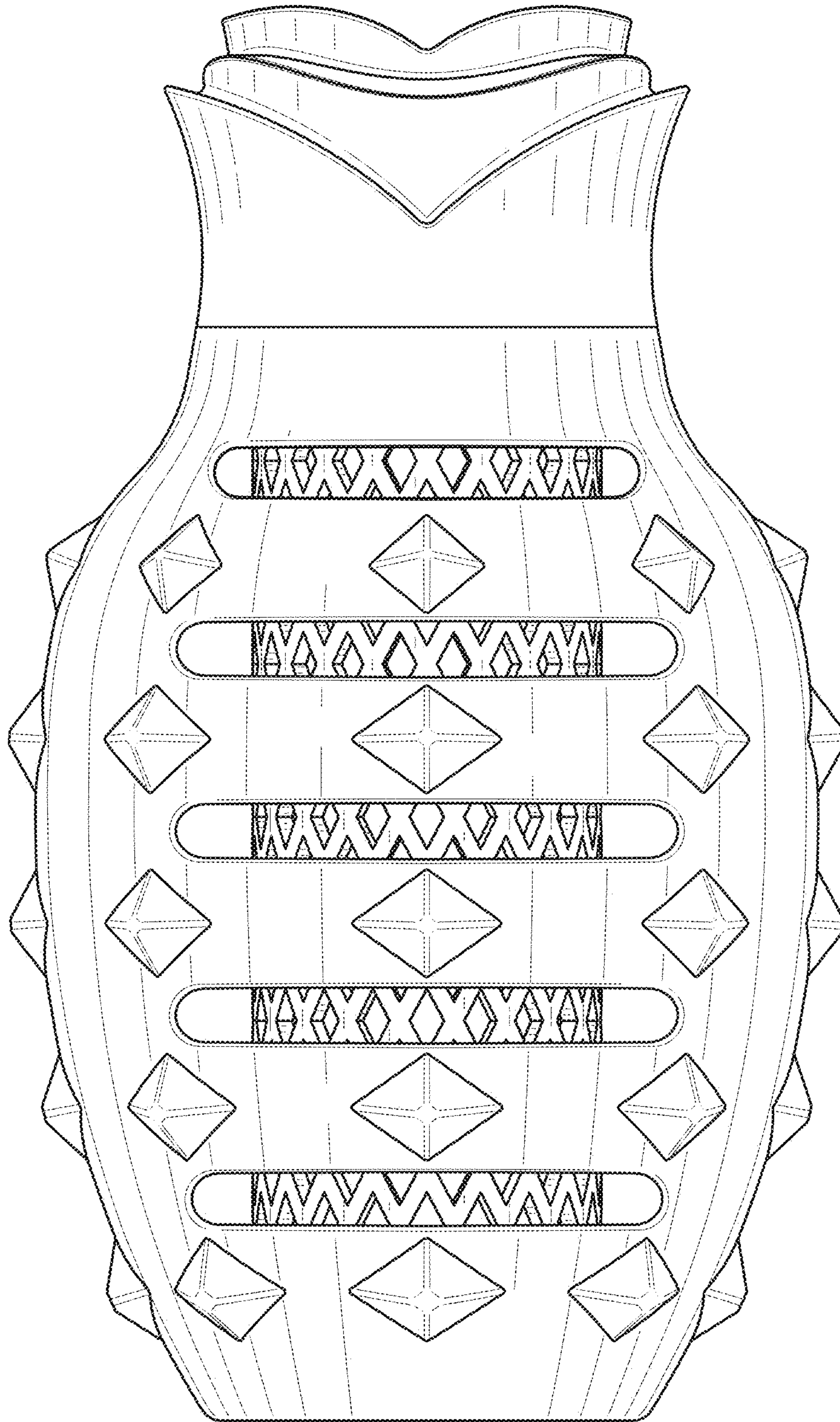

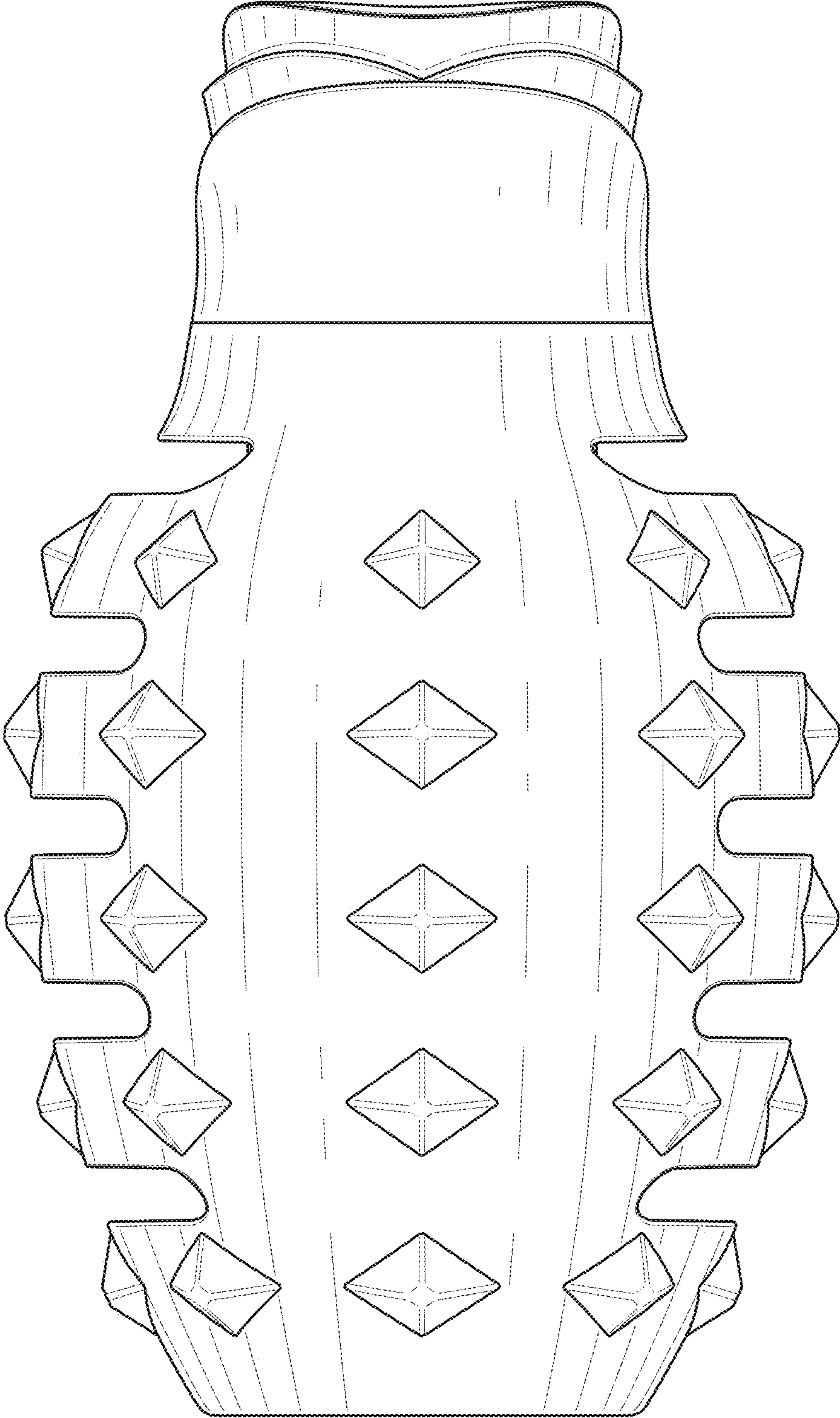

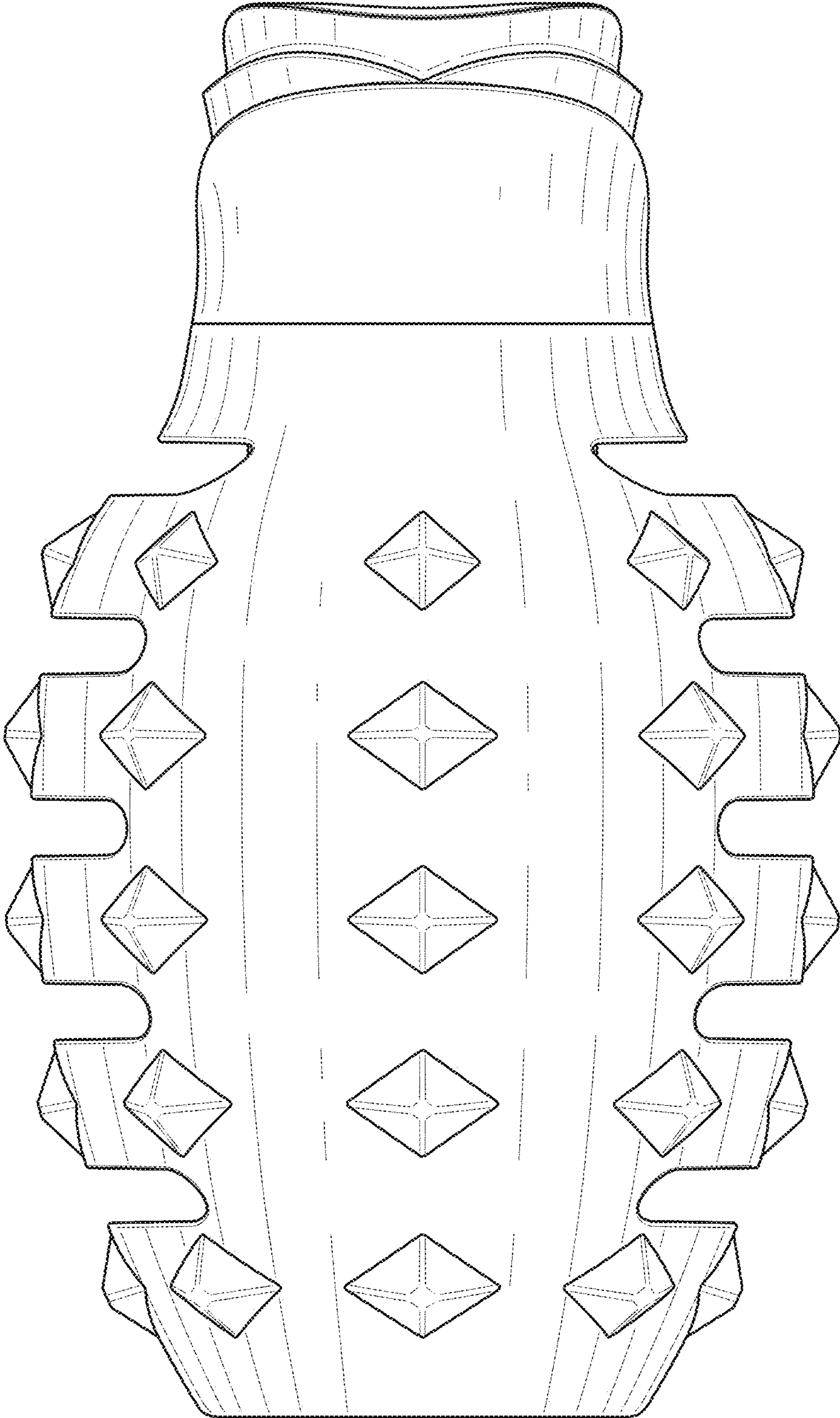

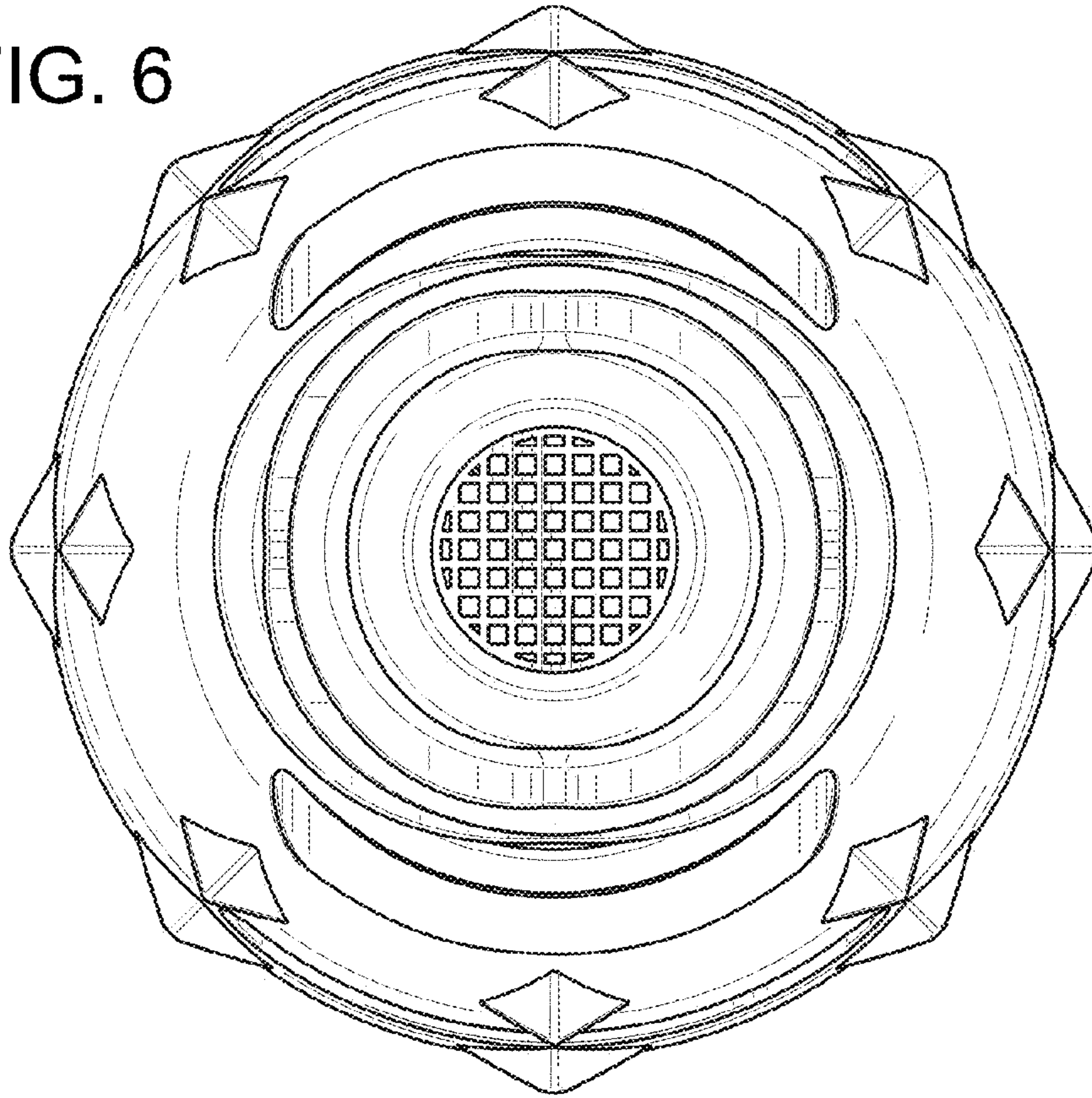
