(57) **CLAIM**

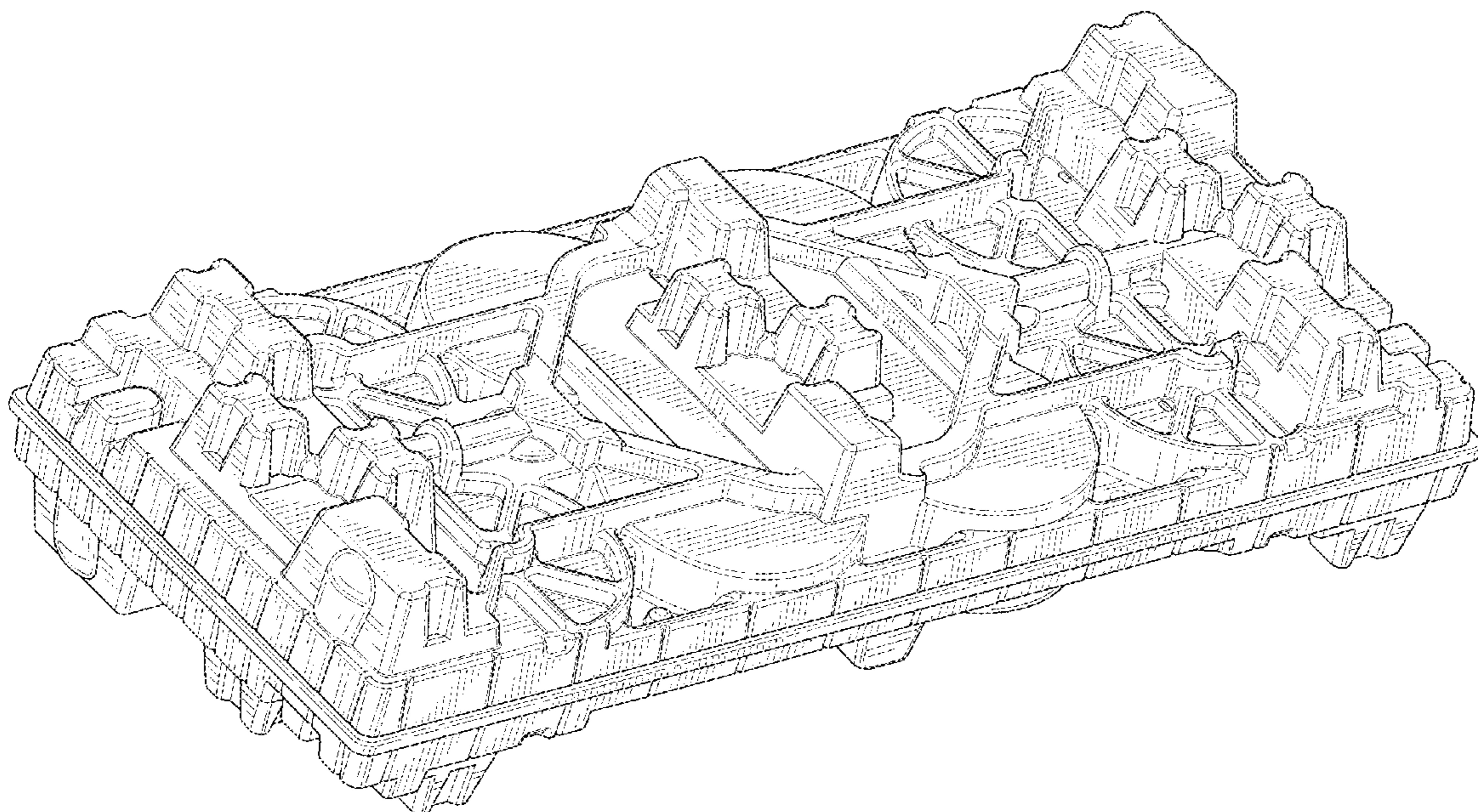
The ornamental design for a pallet assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of the pallet assembly; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a top elevational view thereof; FIG. 4 is a bottom elevational view thereof; FIG. 5 is a first side elevational view thereof; FIG. 6 is a second side elevational view thereof; FIG. 7 is a front plan view thereof; FIG. 8 is a black plan view thereof; and, FIG. 9 is a top perspective exploded view thereof.

The structural features and indicia depicted by broken lines have been shown for the purpose of illustrating portions of the Pallet Assembly that form no part of the claimed design. The thin solid lines in the views have been provided for the purpose of illustrating the uniformity of the planar surfaces and the contour of the surfaces and are not a claimed surface pattern.

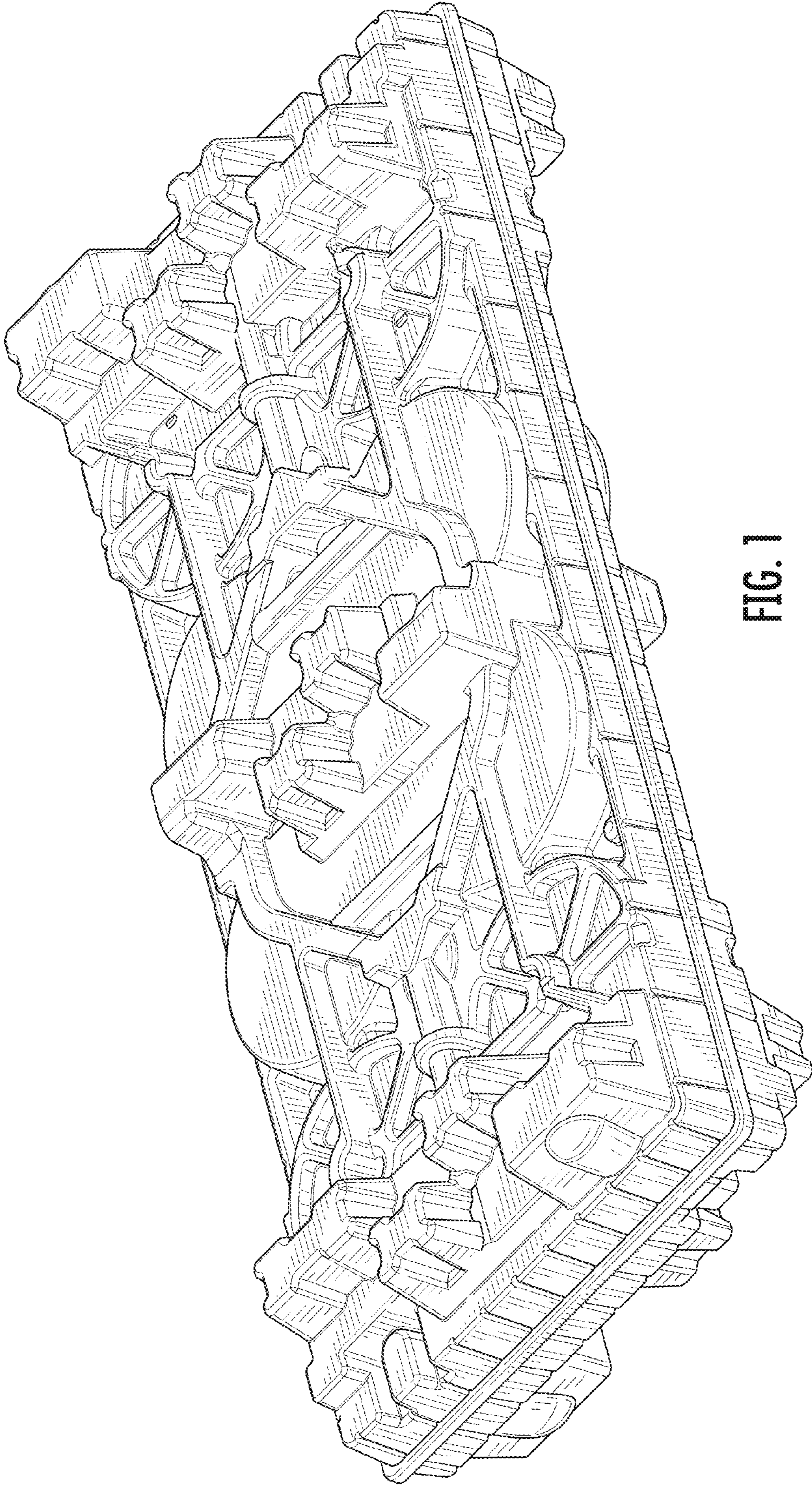

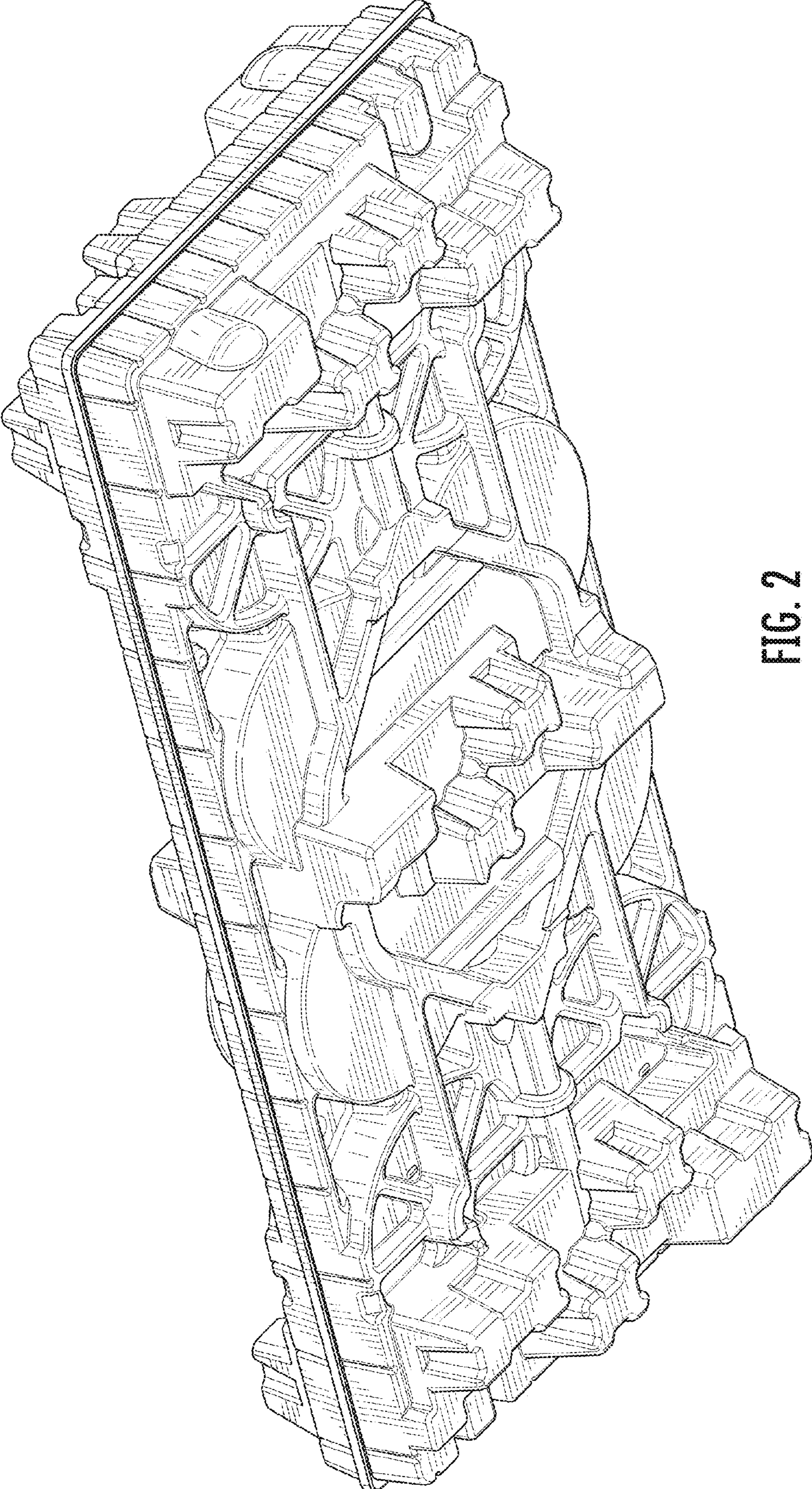

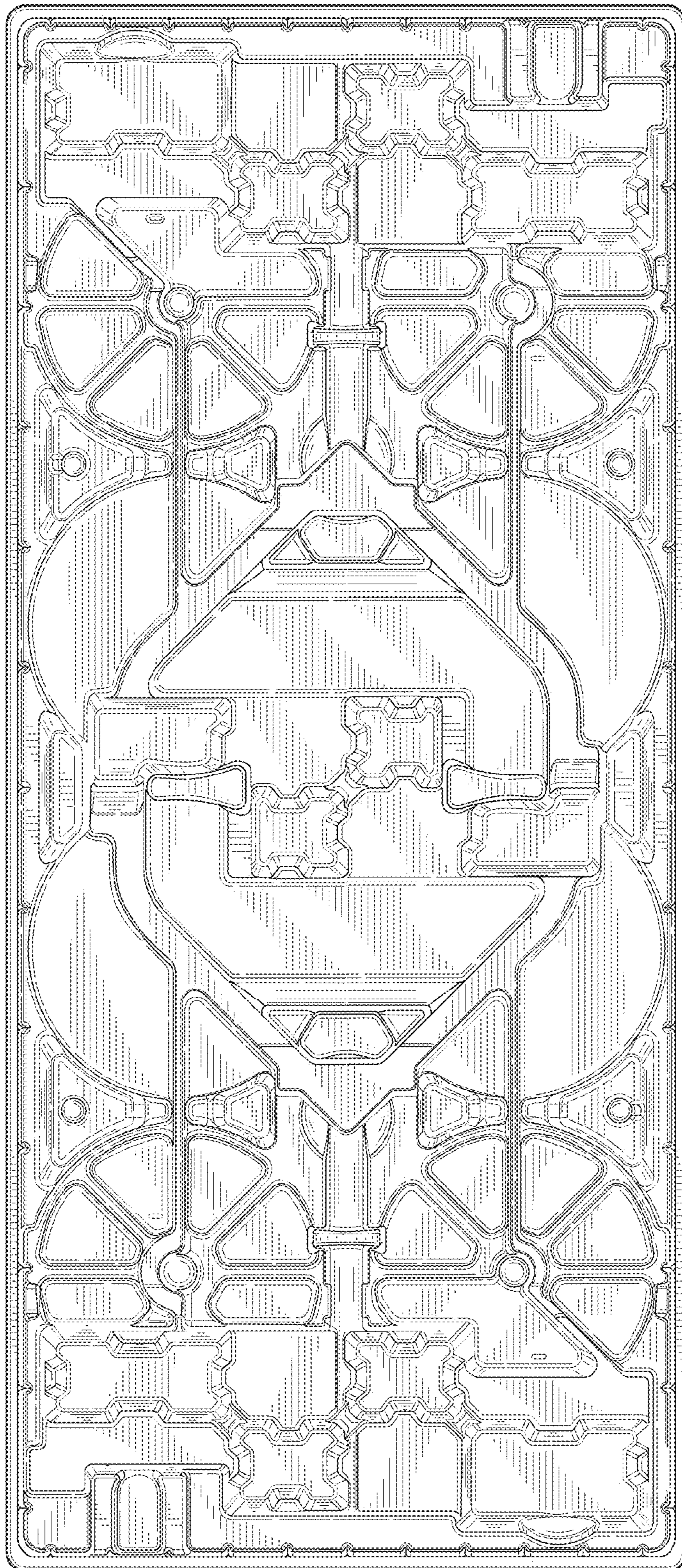

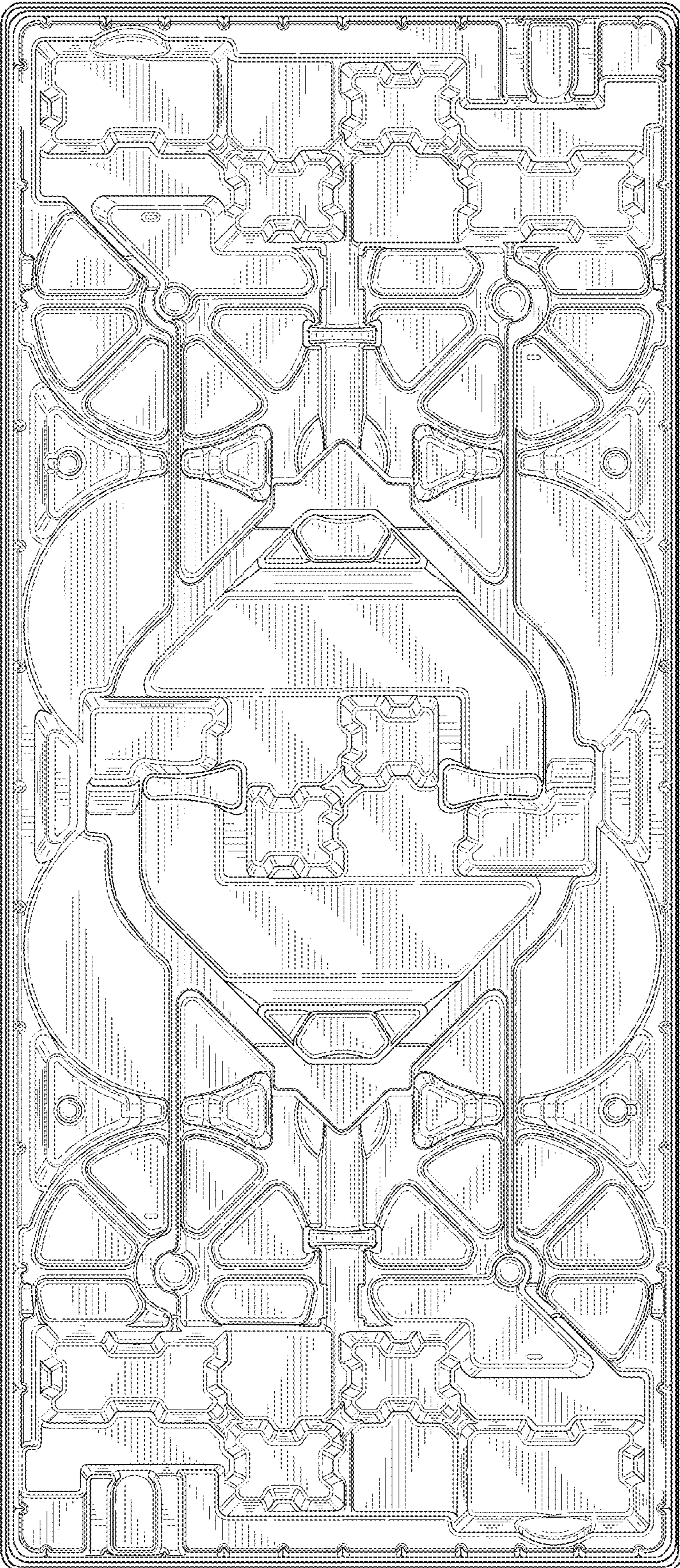

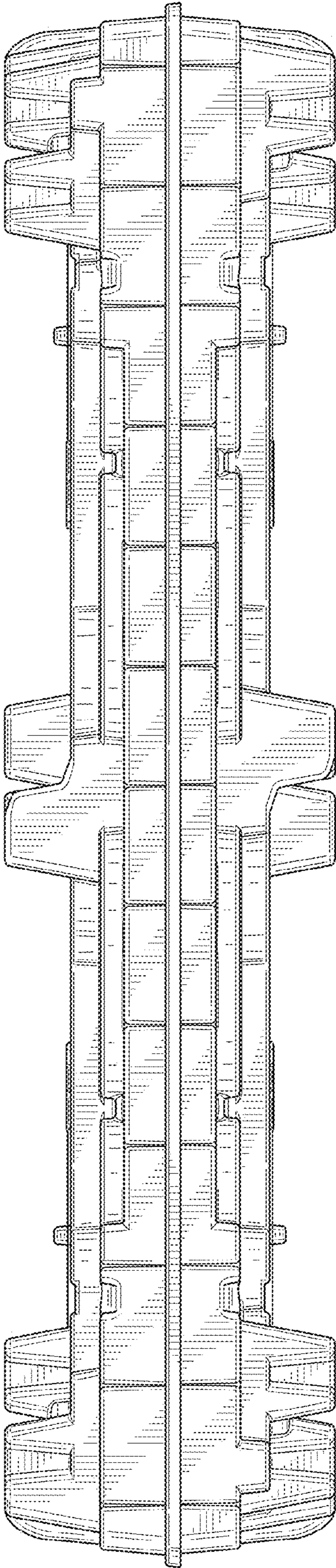

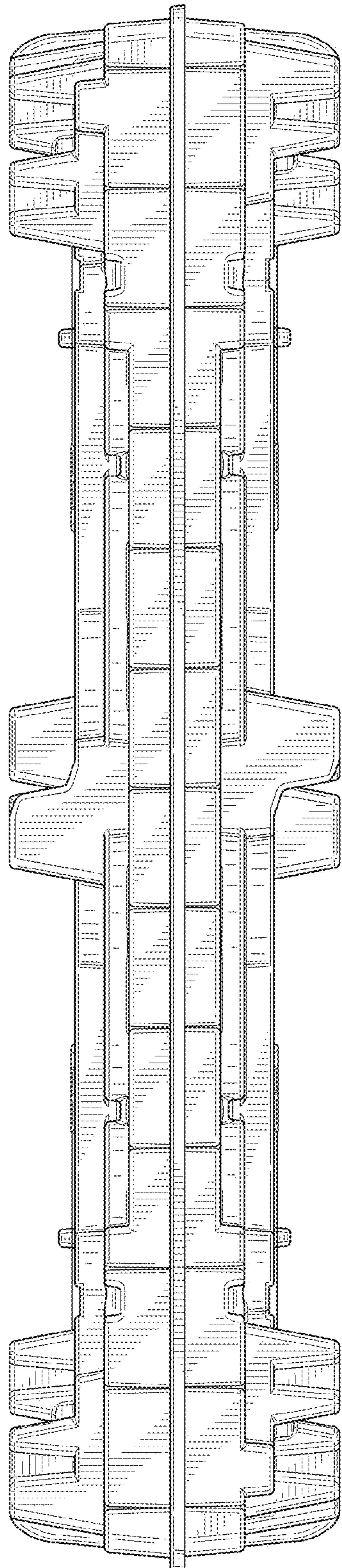

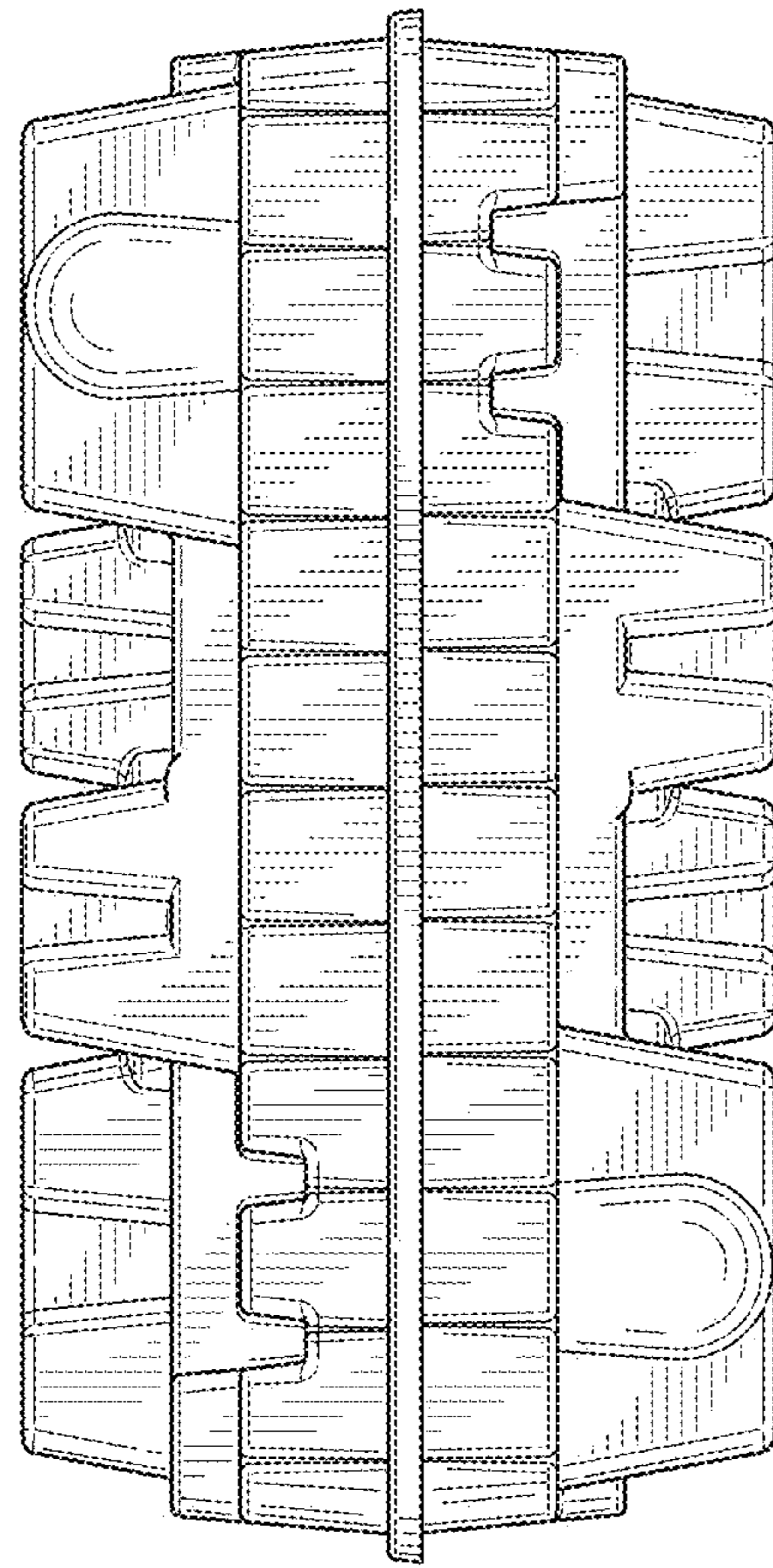

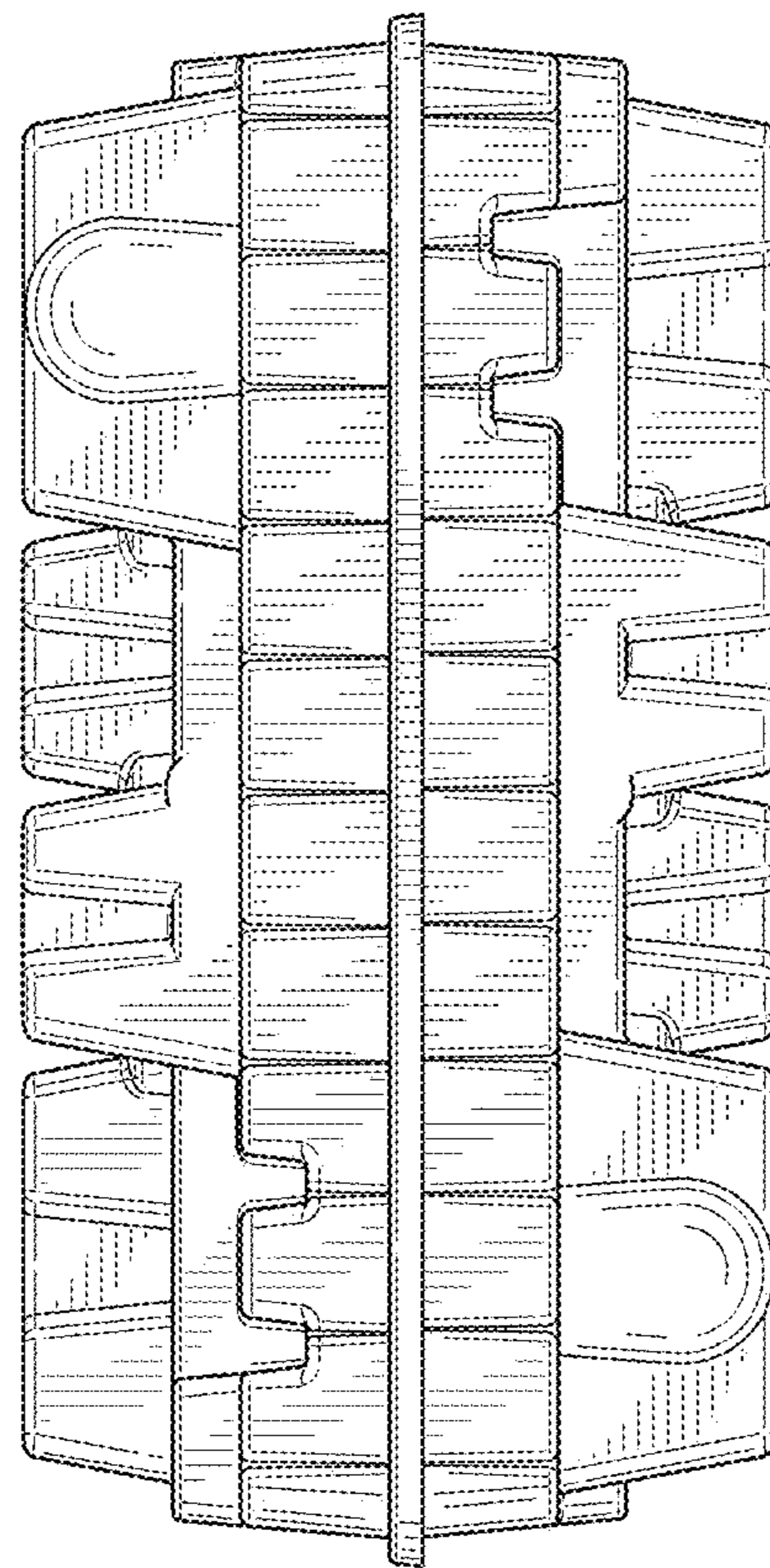

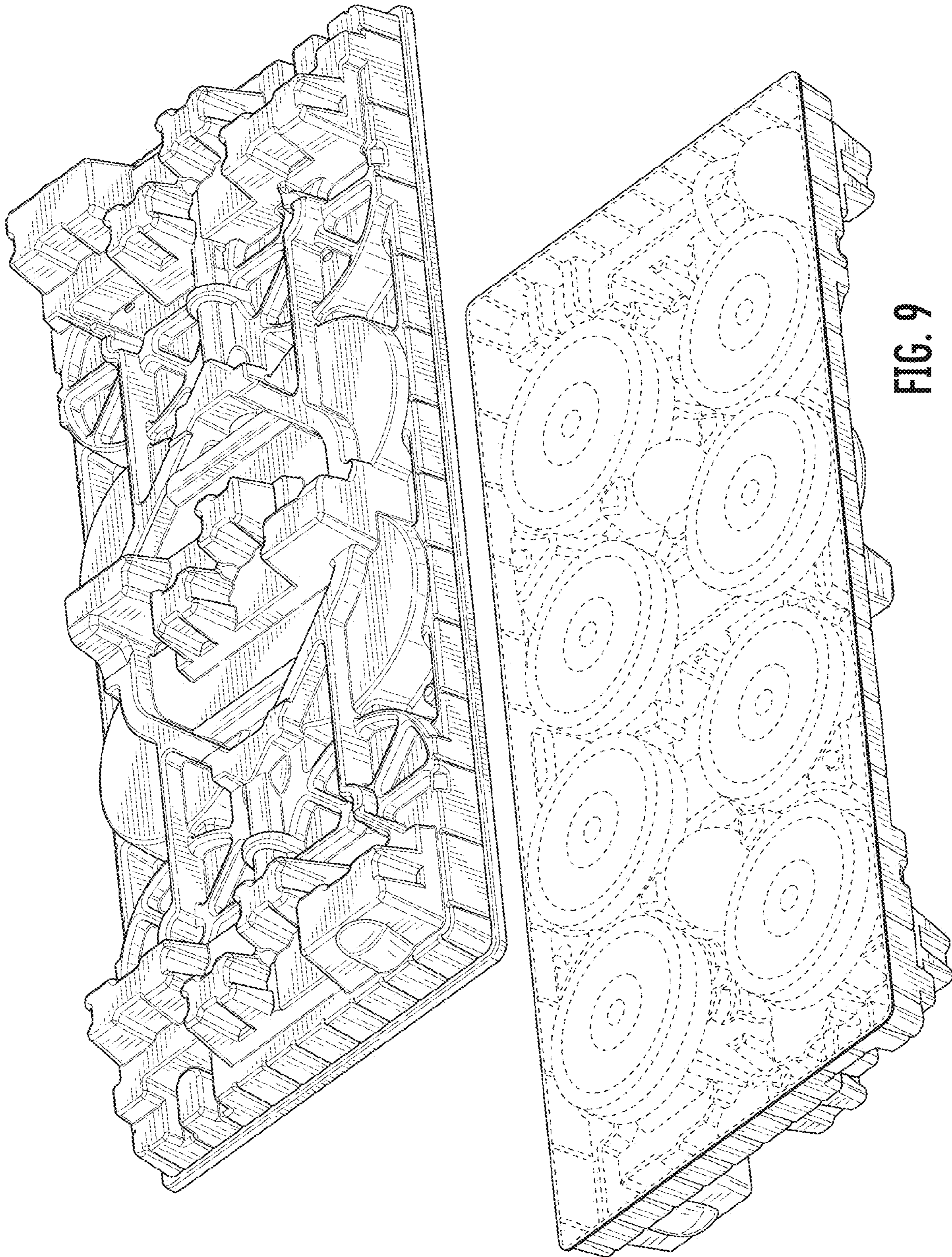
