I claim the ornamental design for a duck boot, as shown and described.

DESCRIPTION

FIG. 1 is a Perspective view of a duck boot showing my new design;
FIG. 2 is a Front view thereof;

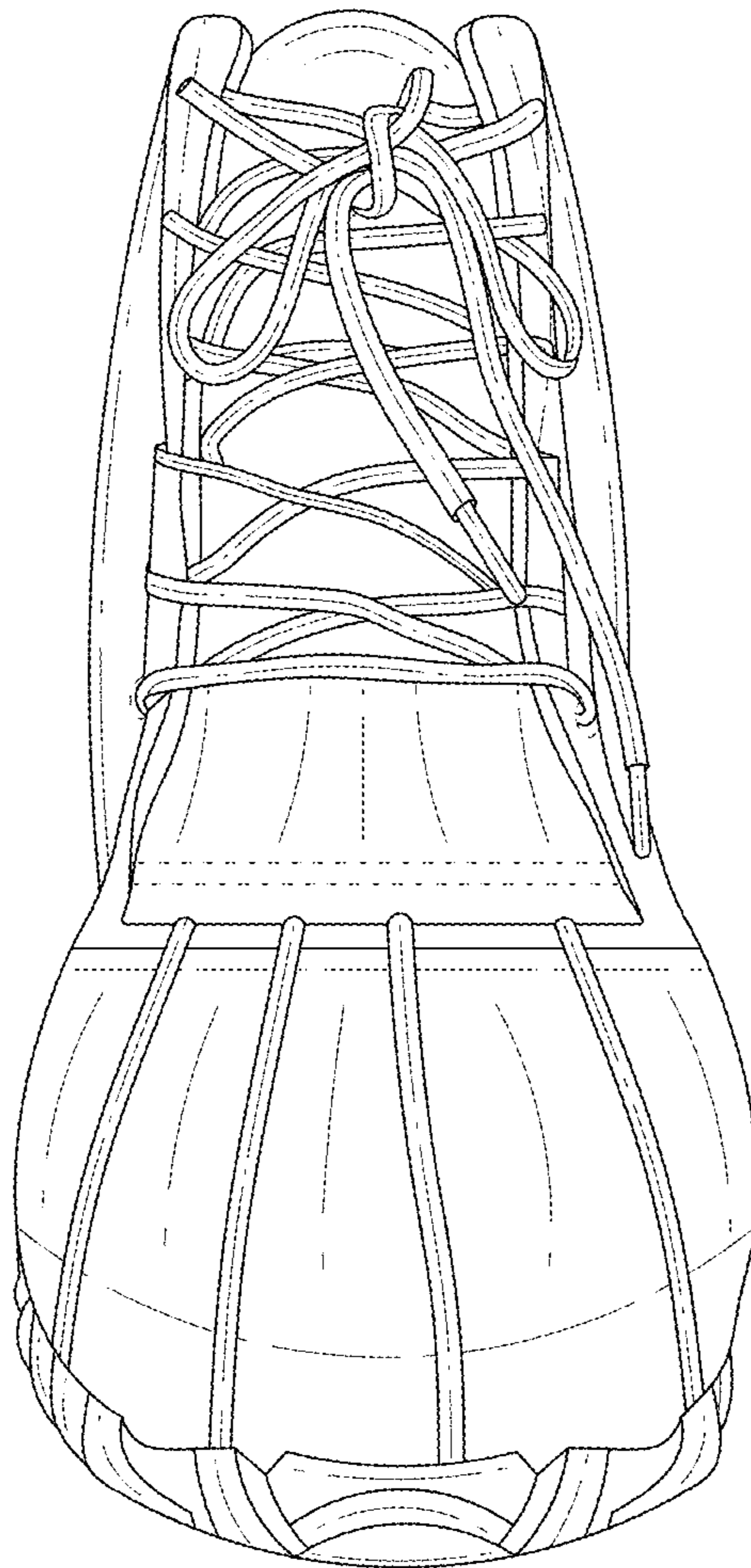

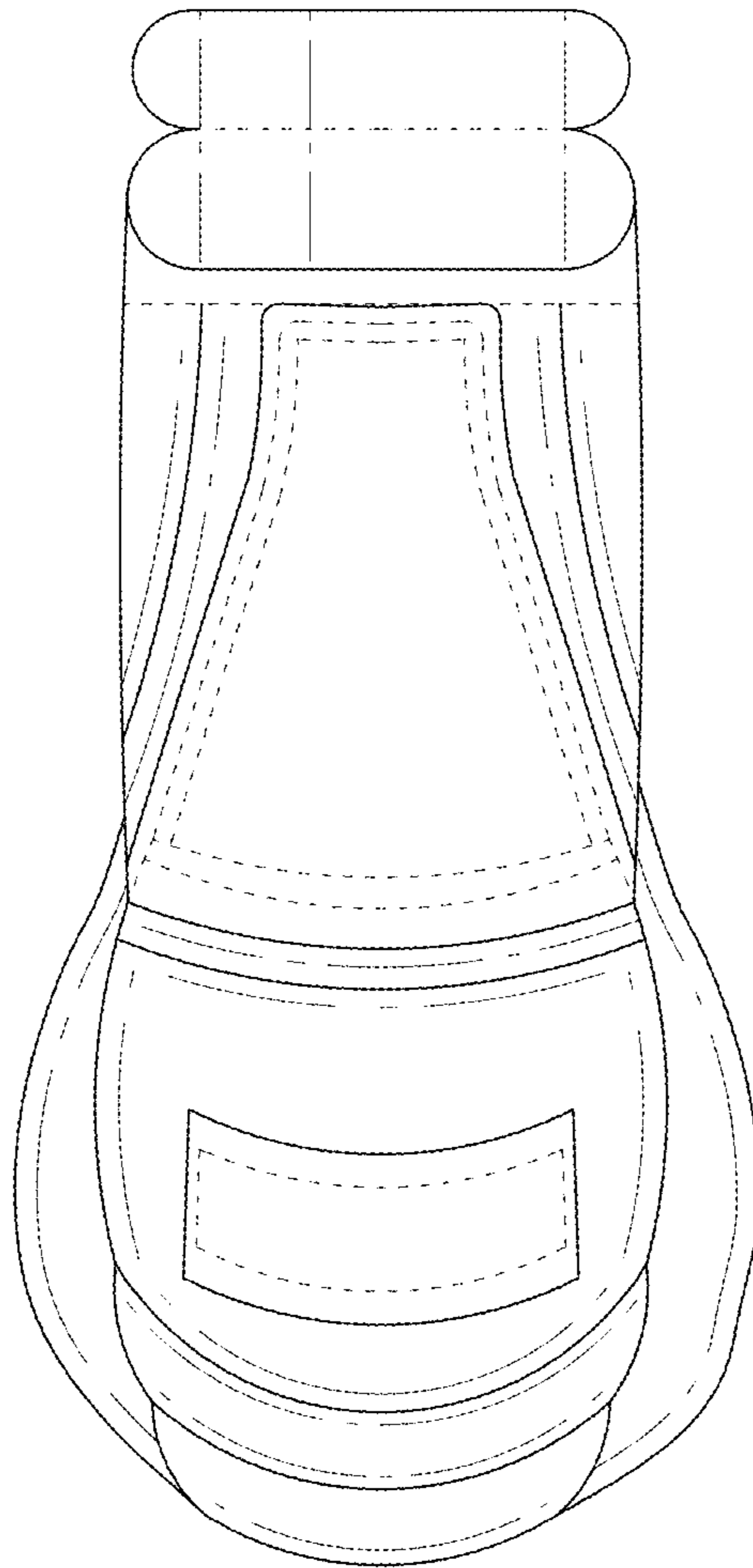

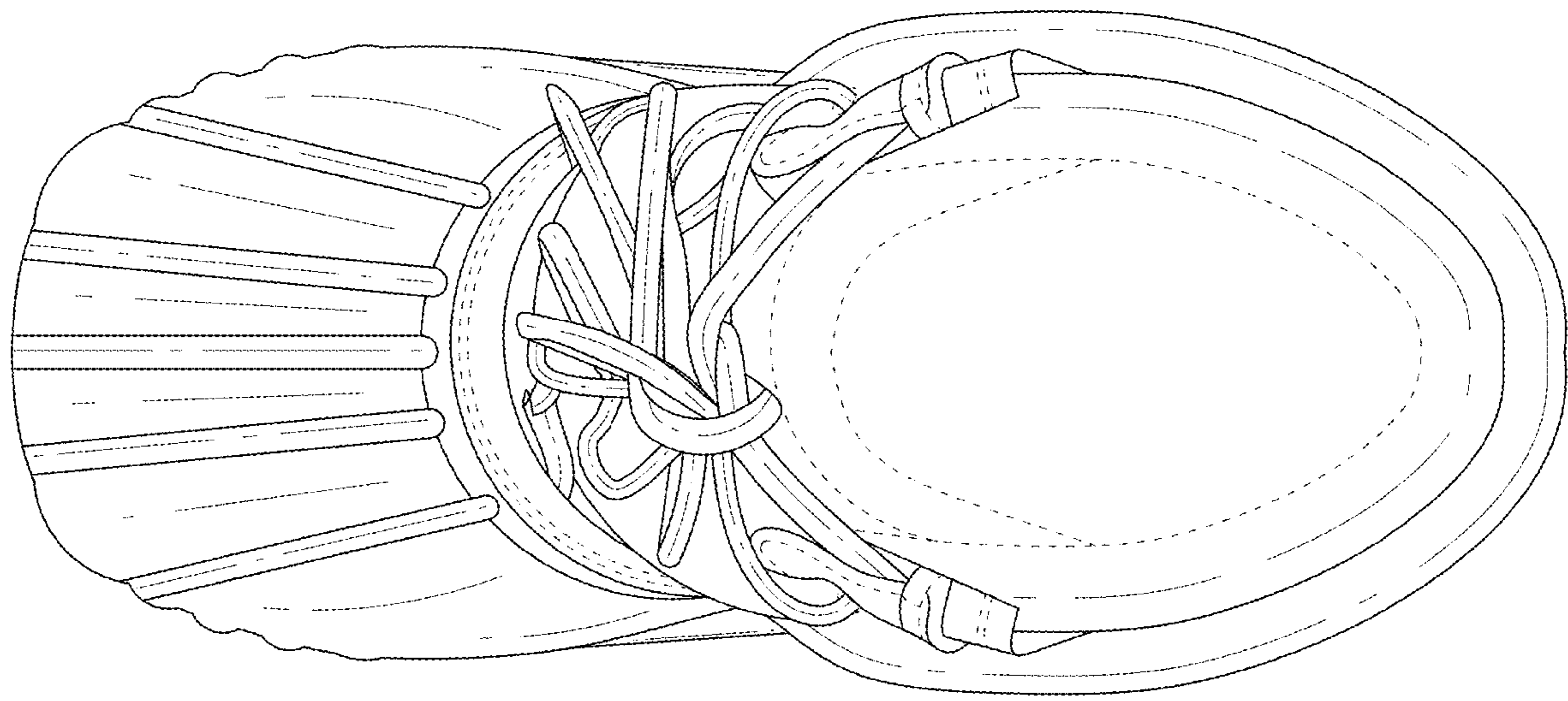

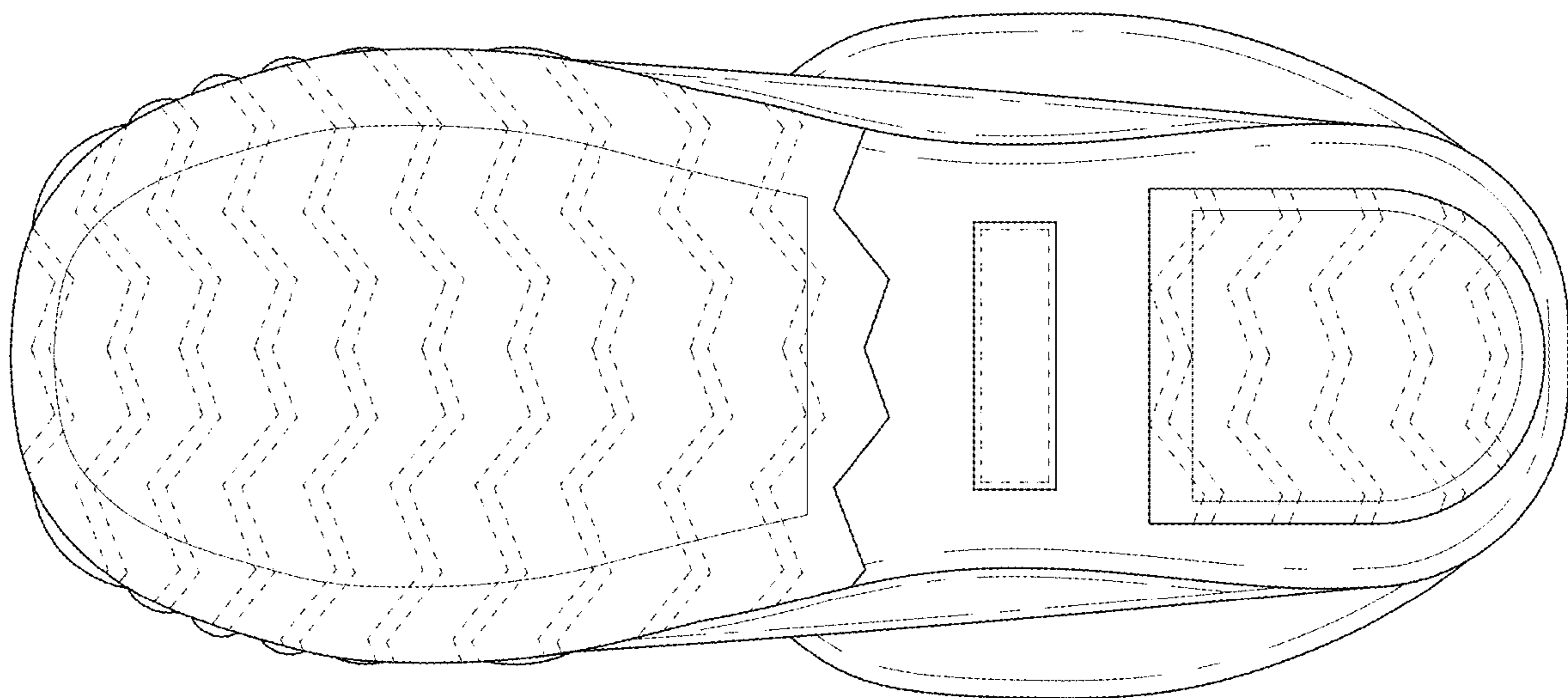
