(57) **CLAIM**

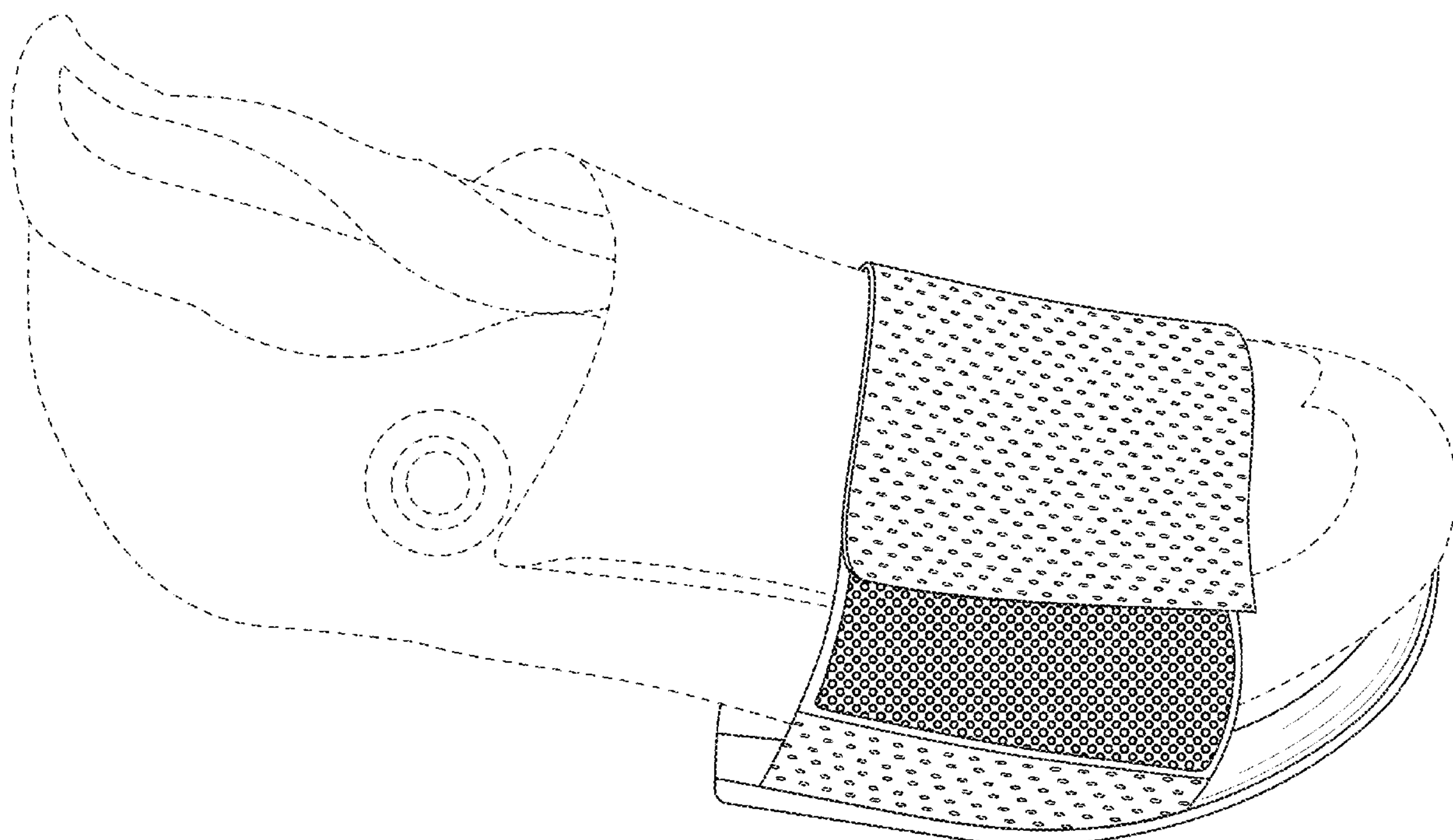
The ornamental design for a cover for a cleated shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a cover for a cleated shoe showing my new design, shown in a position of use with a shoe;  
 FIG. 2 is a left side elevational view thereof;  
 FIG. 3 is a right side elevational view thereof;  
 FIG. 4 is a front elevational view thereof;  
 FIG. 5 is a rear elevational view thereof;  
 FIG. 6 is a top planar view thereof; and,  
 FIG. 7 is a bottom planar view thereof showing my design.

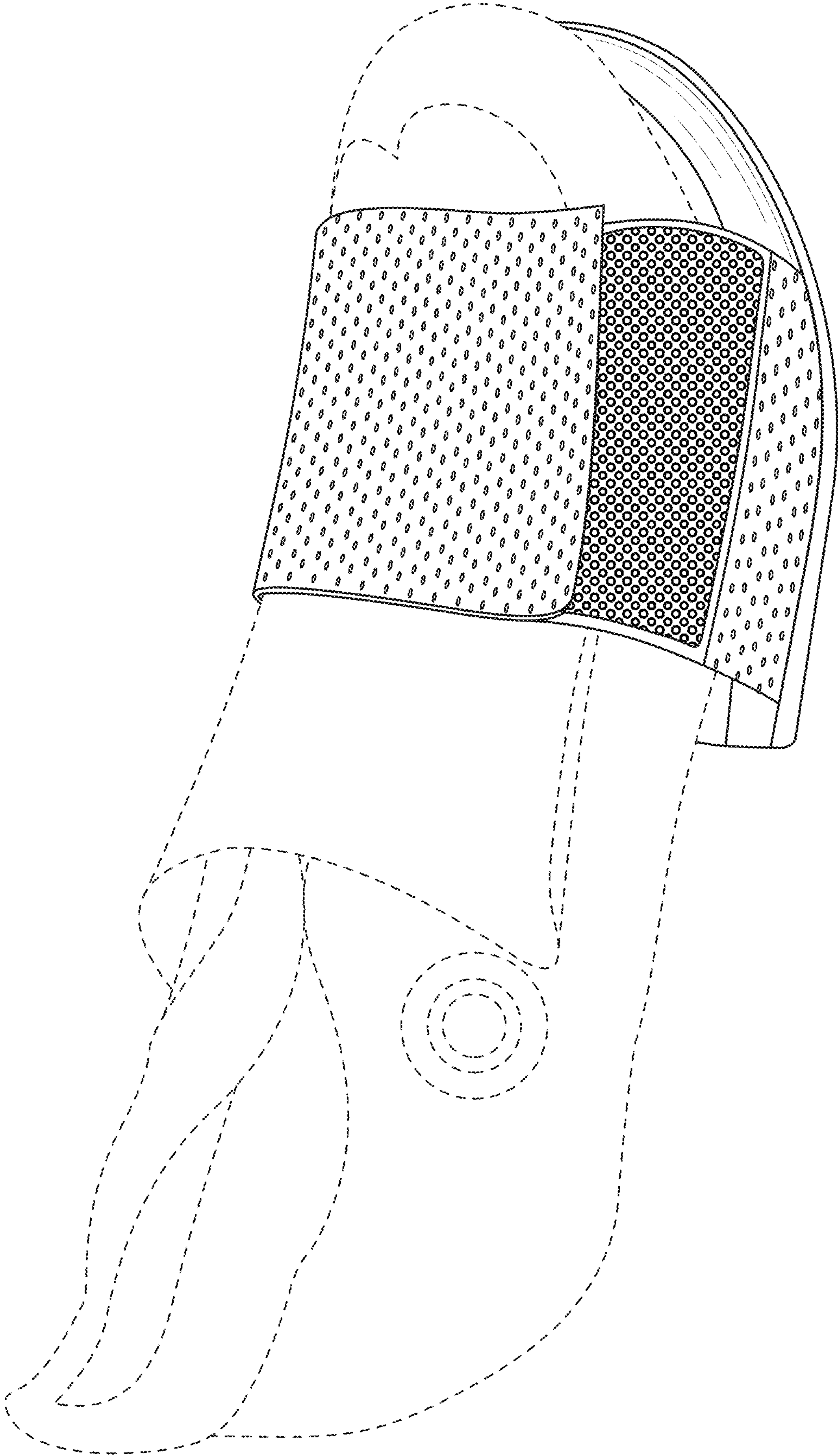

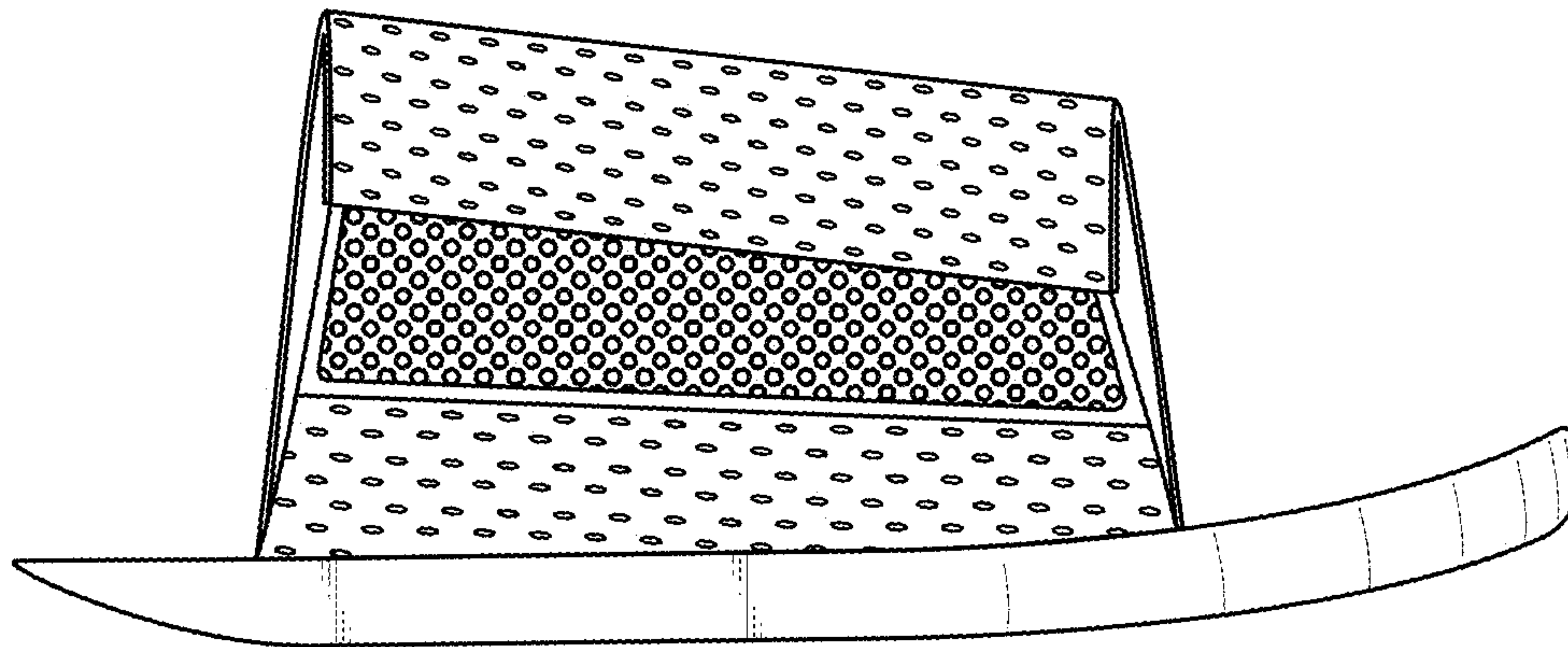

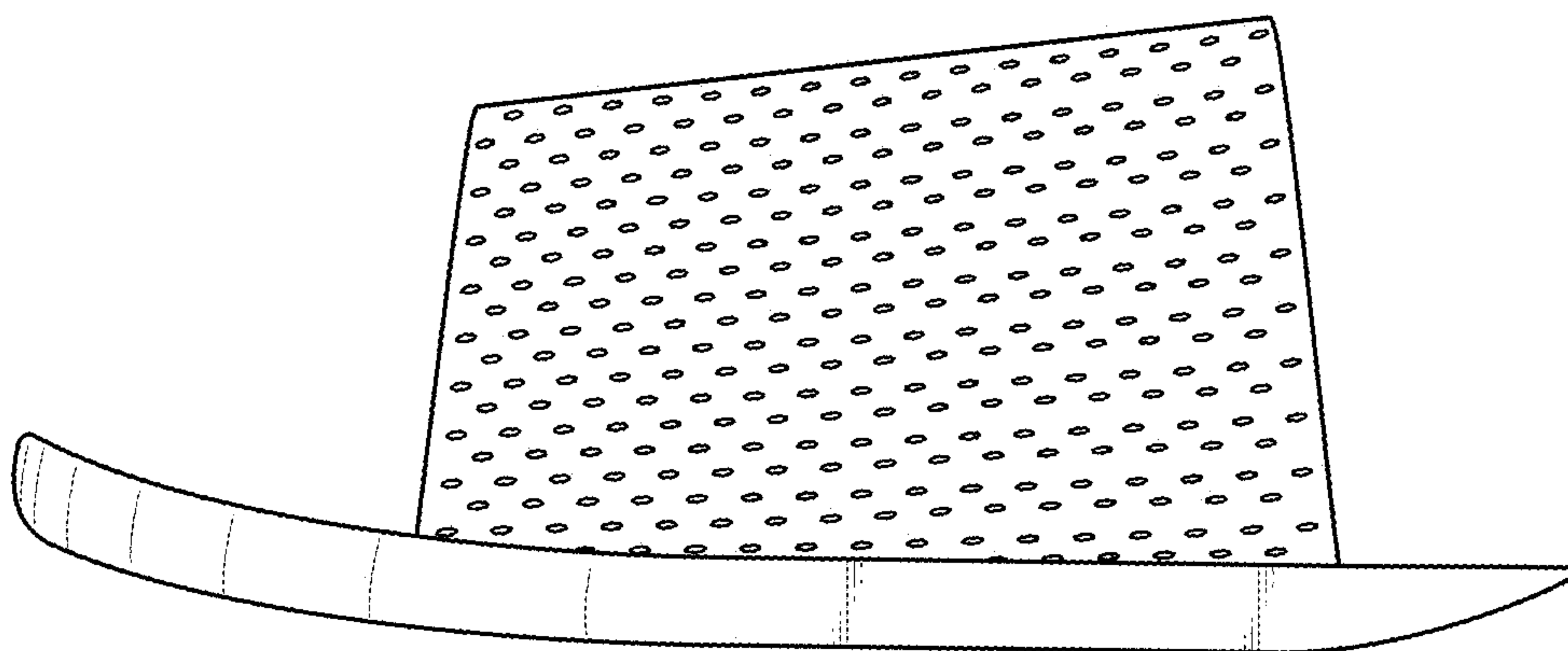

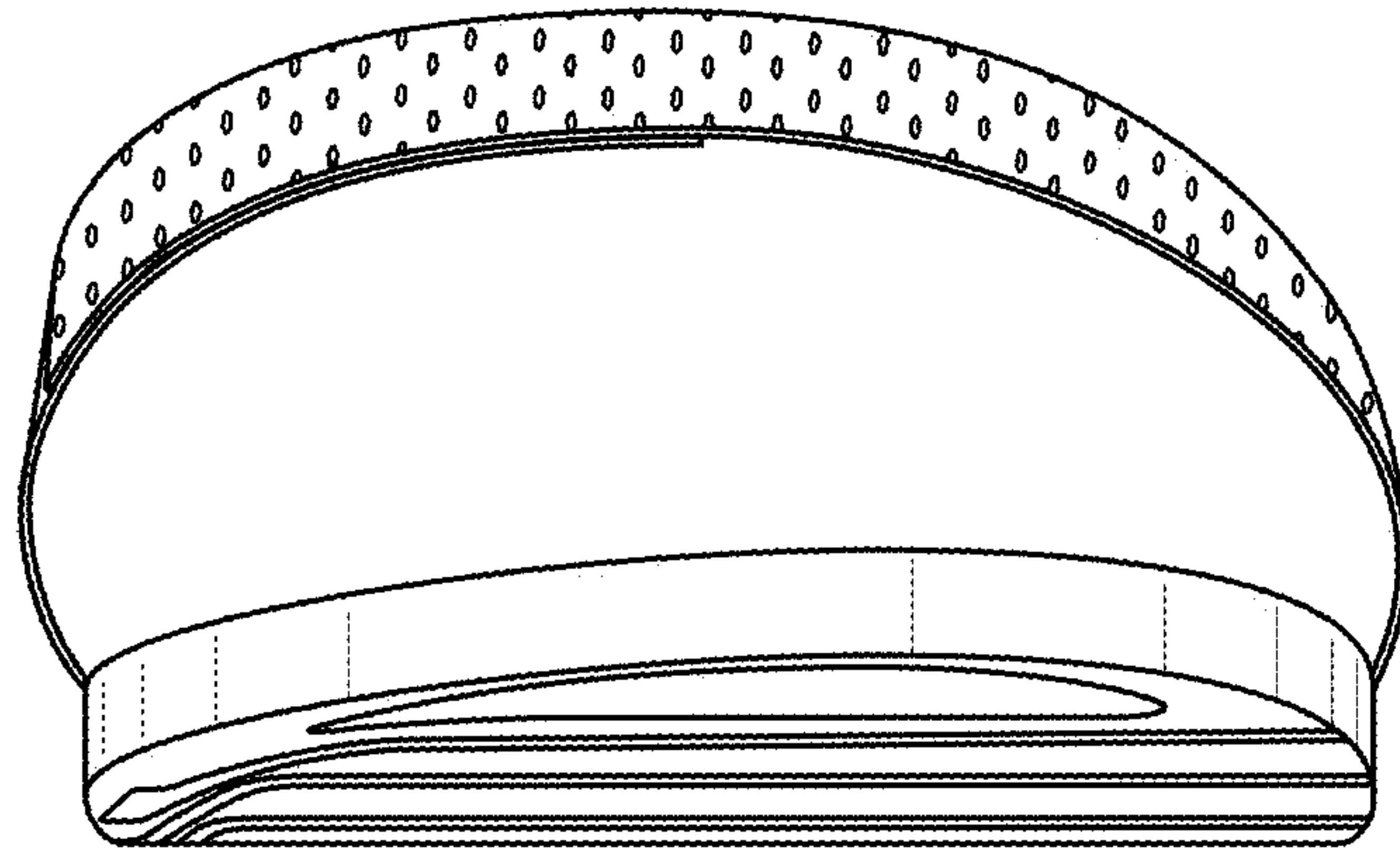

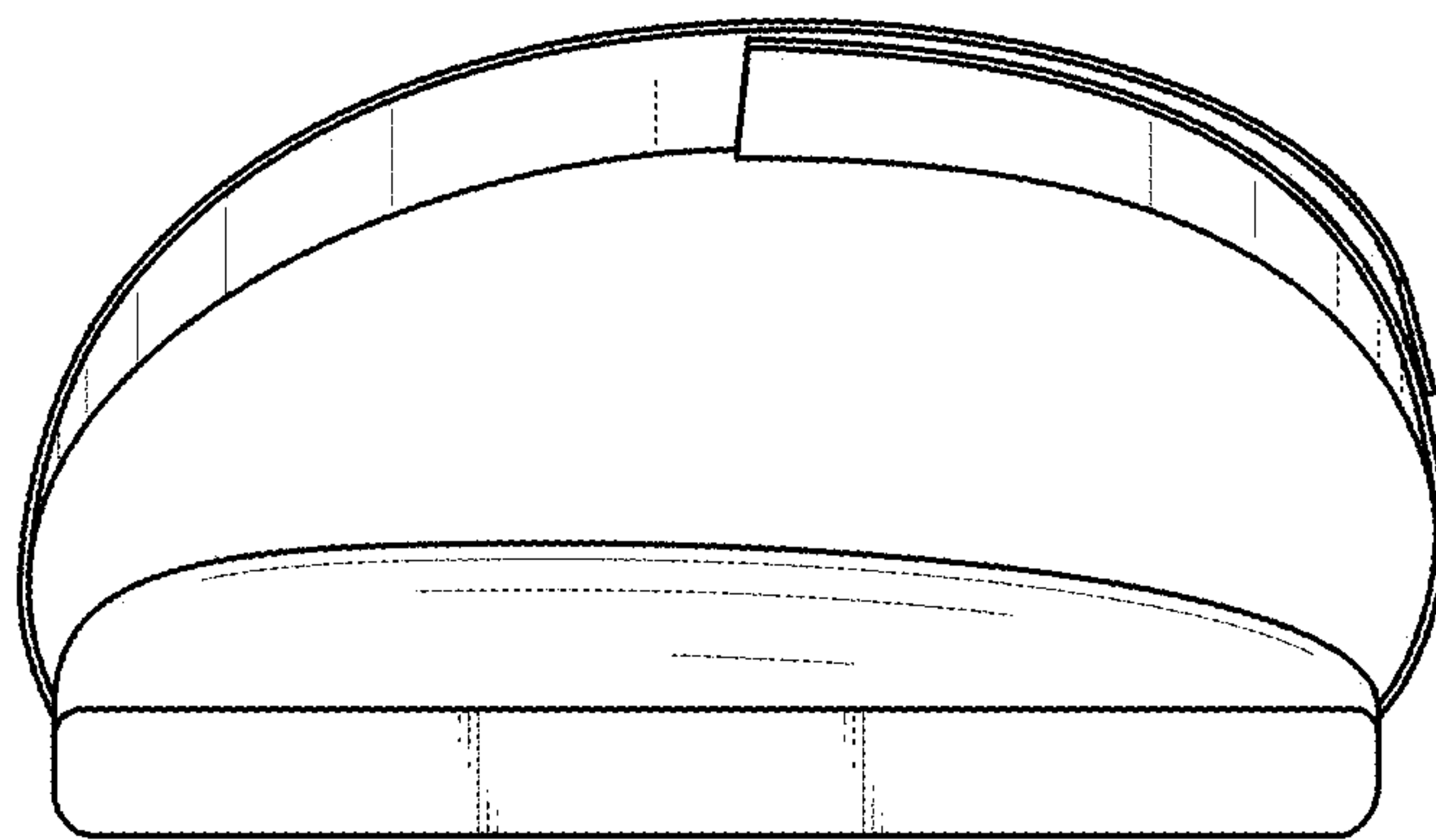

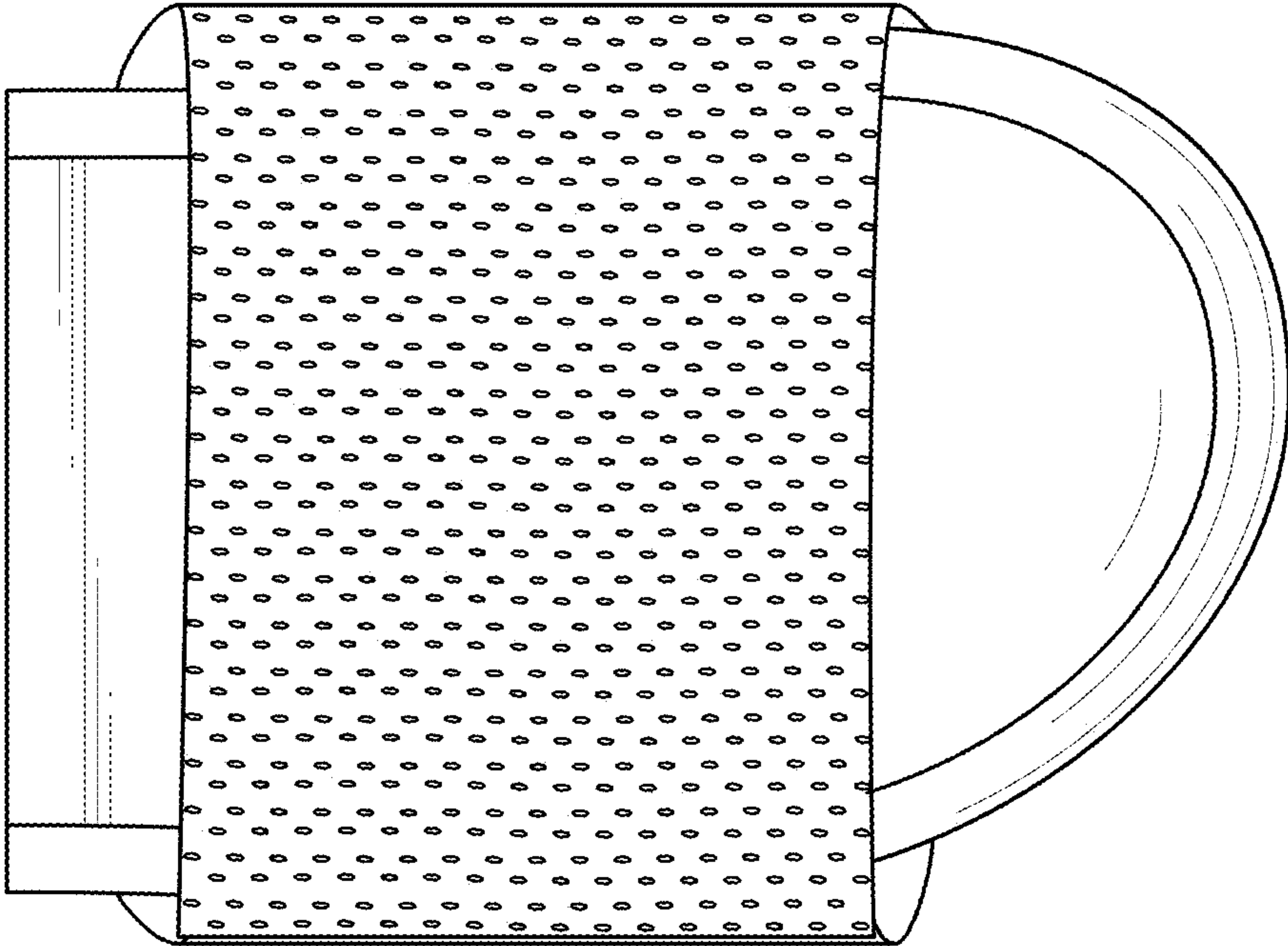

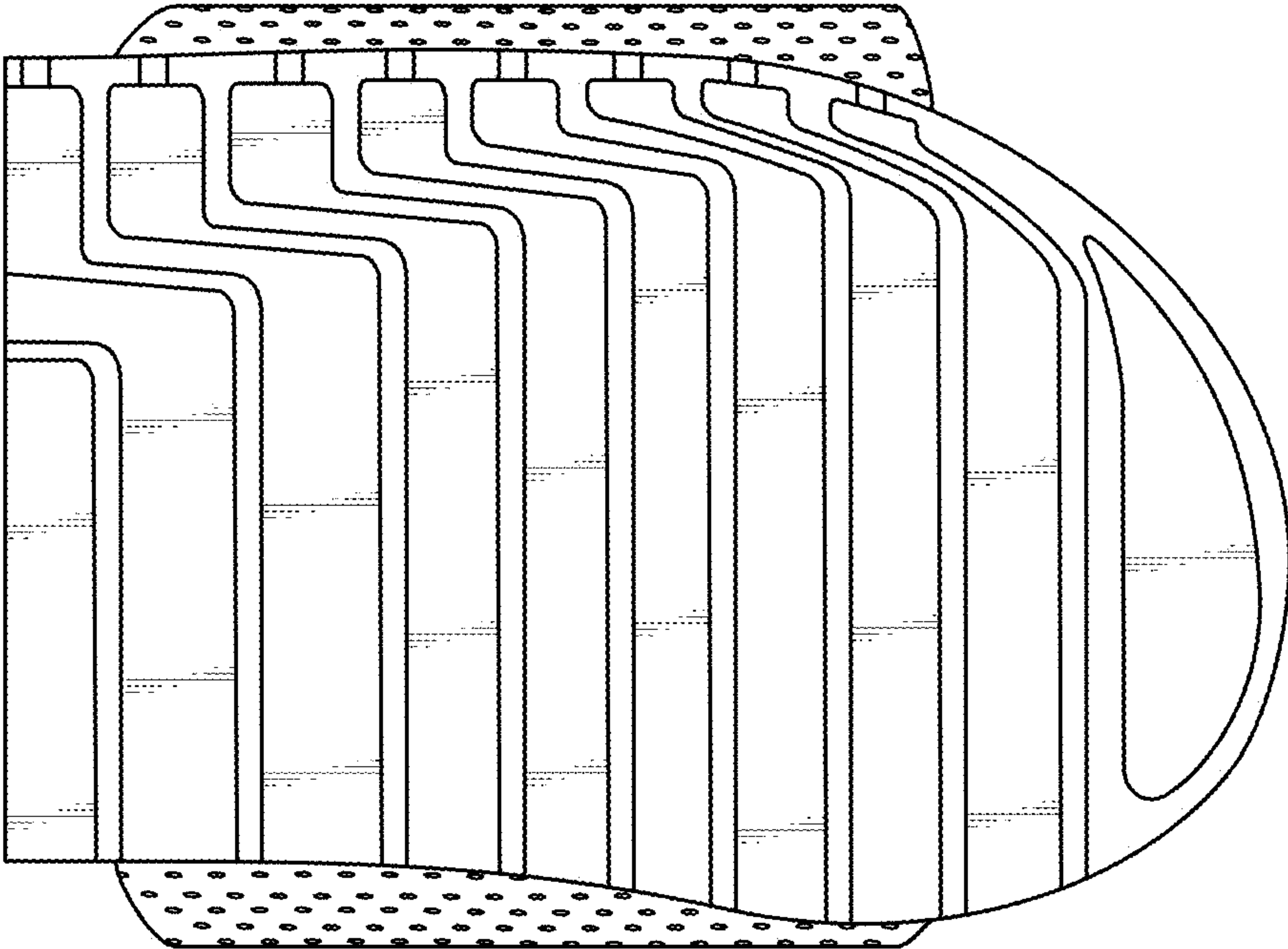
