(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a shoe showing my new design; FIG. 2 is a front perspective view thereof; FIG. 3 is an opposite side front perspective view thereof; FIG. 4 is an opposite side view thereof; FIG. 5 is a side view of a shoe showing an alternative embodiment of my new design; FIG. 6 is a front perspective view thereof; FIG. 7 is an opposite side front perspective view thereof; and, FIG. 8 is an opposite side view thereof. The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. In FIGS. 5-8, the cross hatching shown in the middle panel that wraps over the shoe represents the appearance of an open mesh fabric spanning the panel, and no specific mesh pattern is claimed. The broken lines depicting the remainder of the shoe form no part of the claimed design.

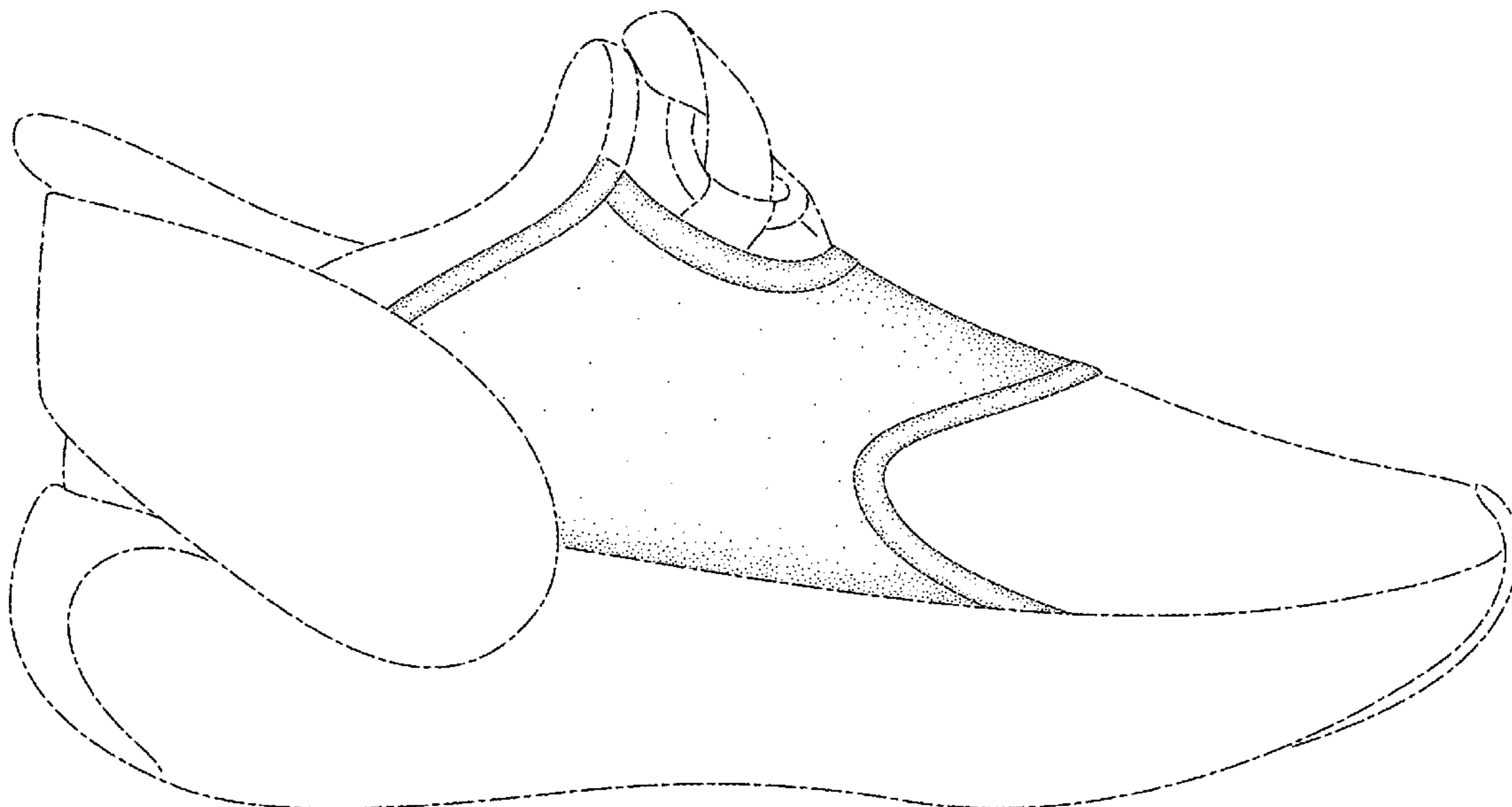

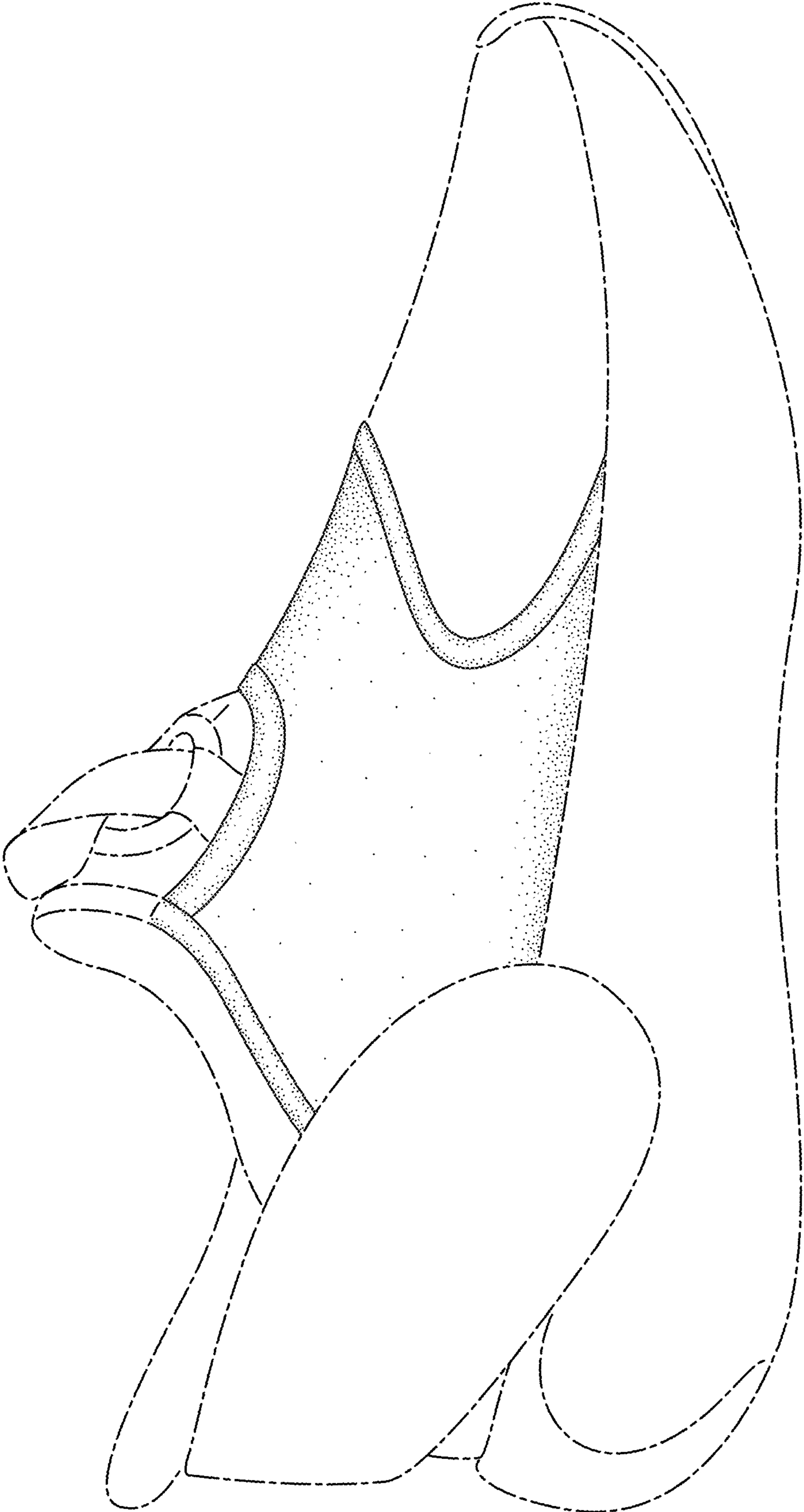

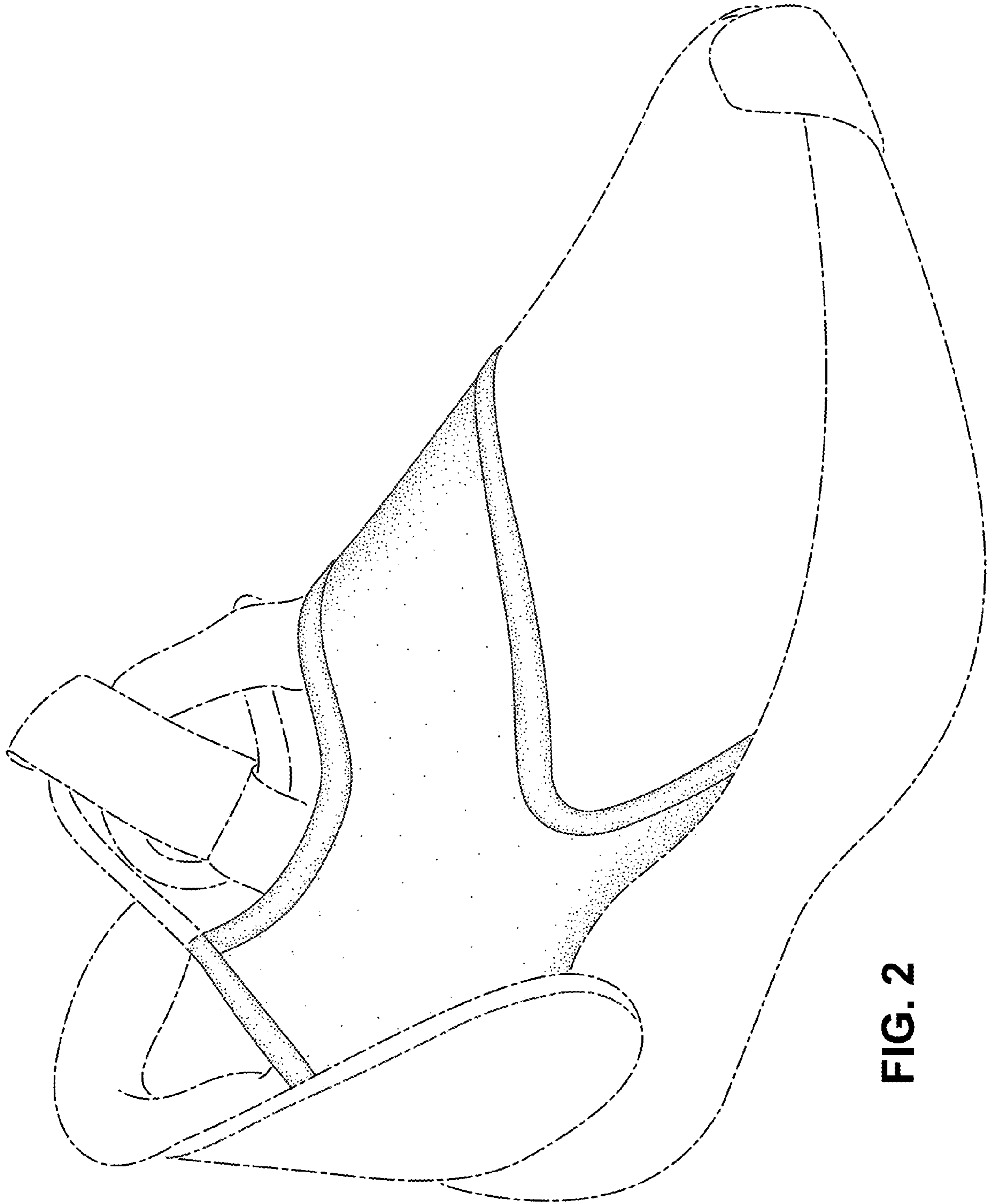

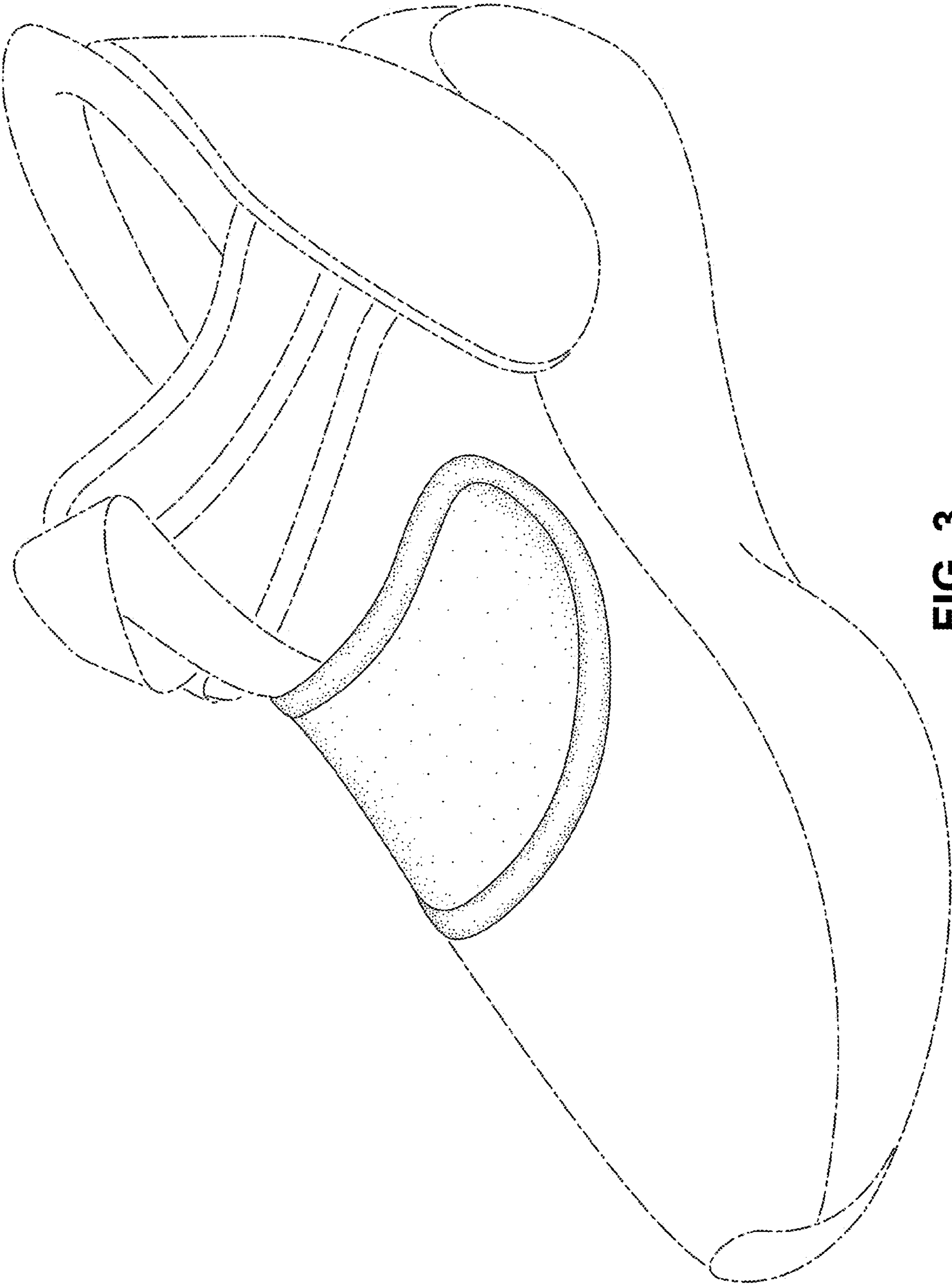

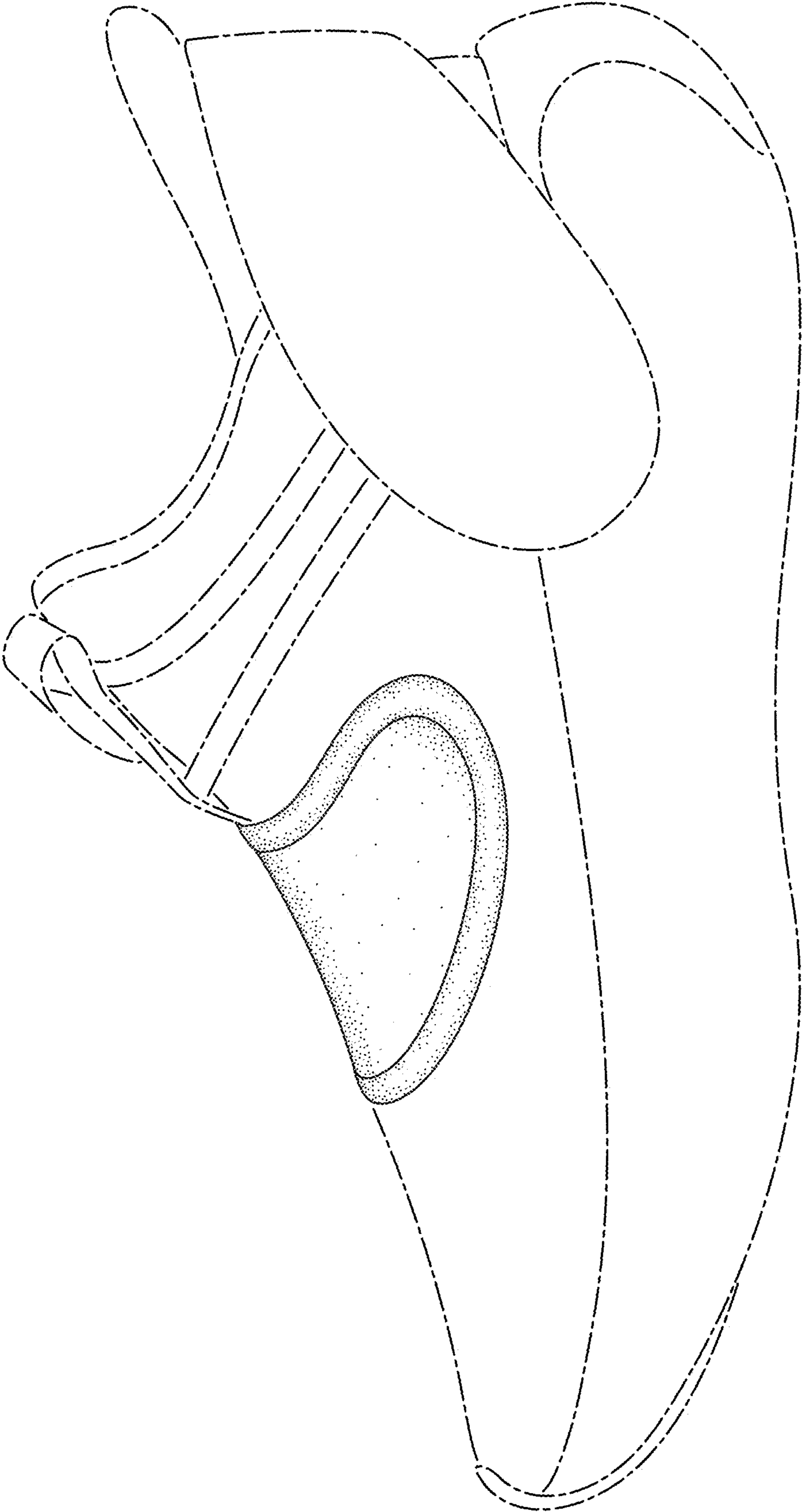

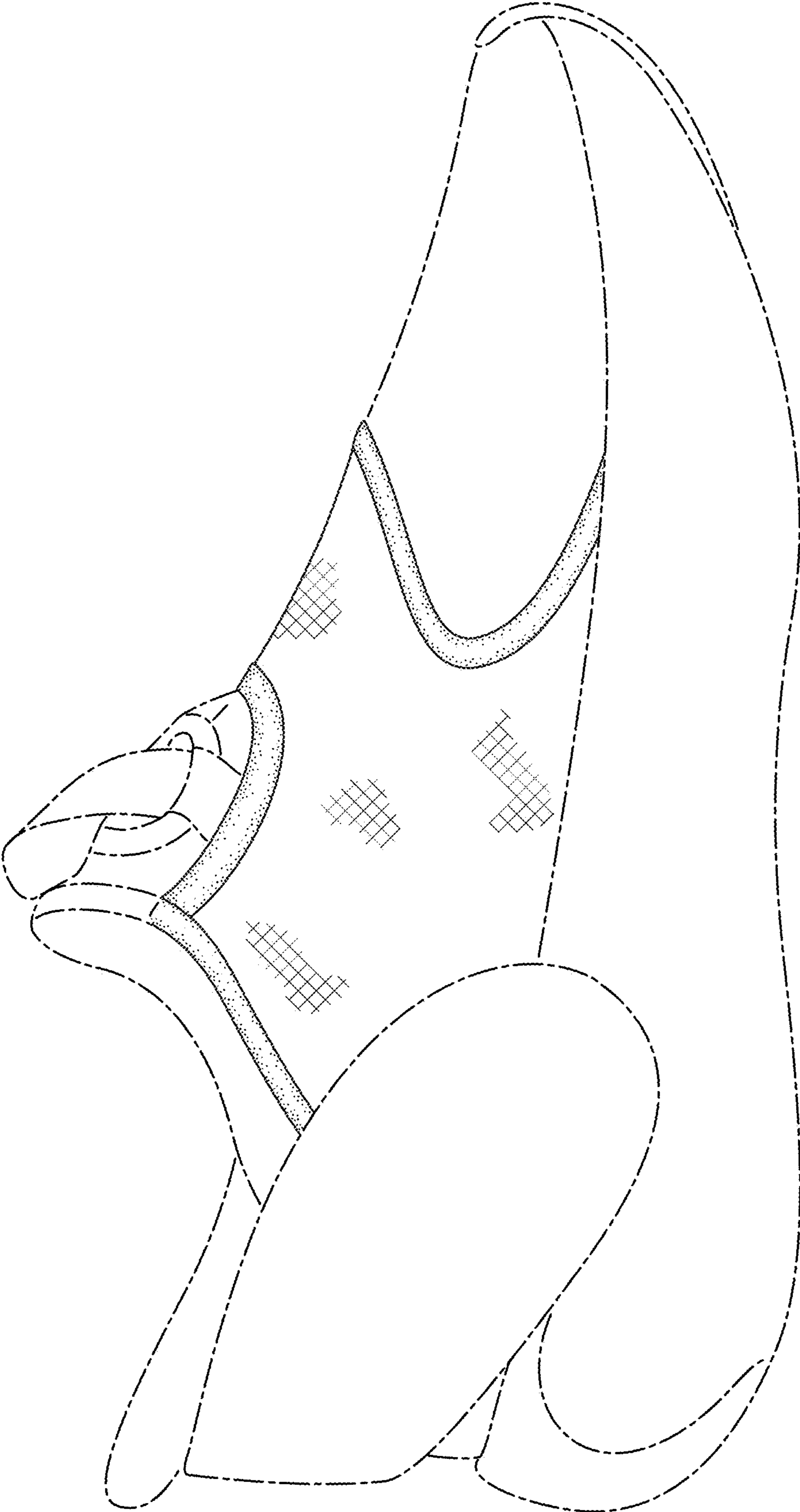

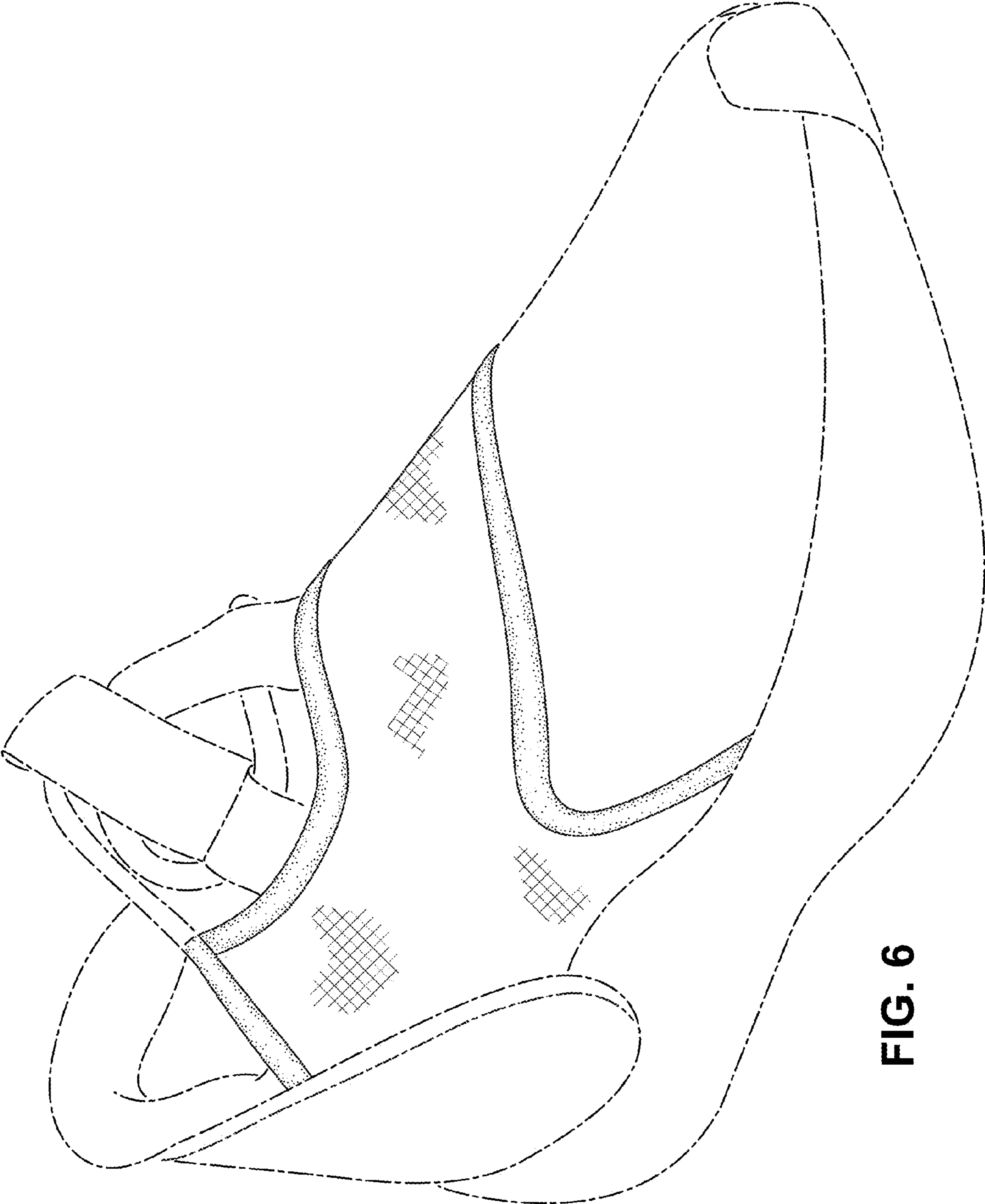

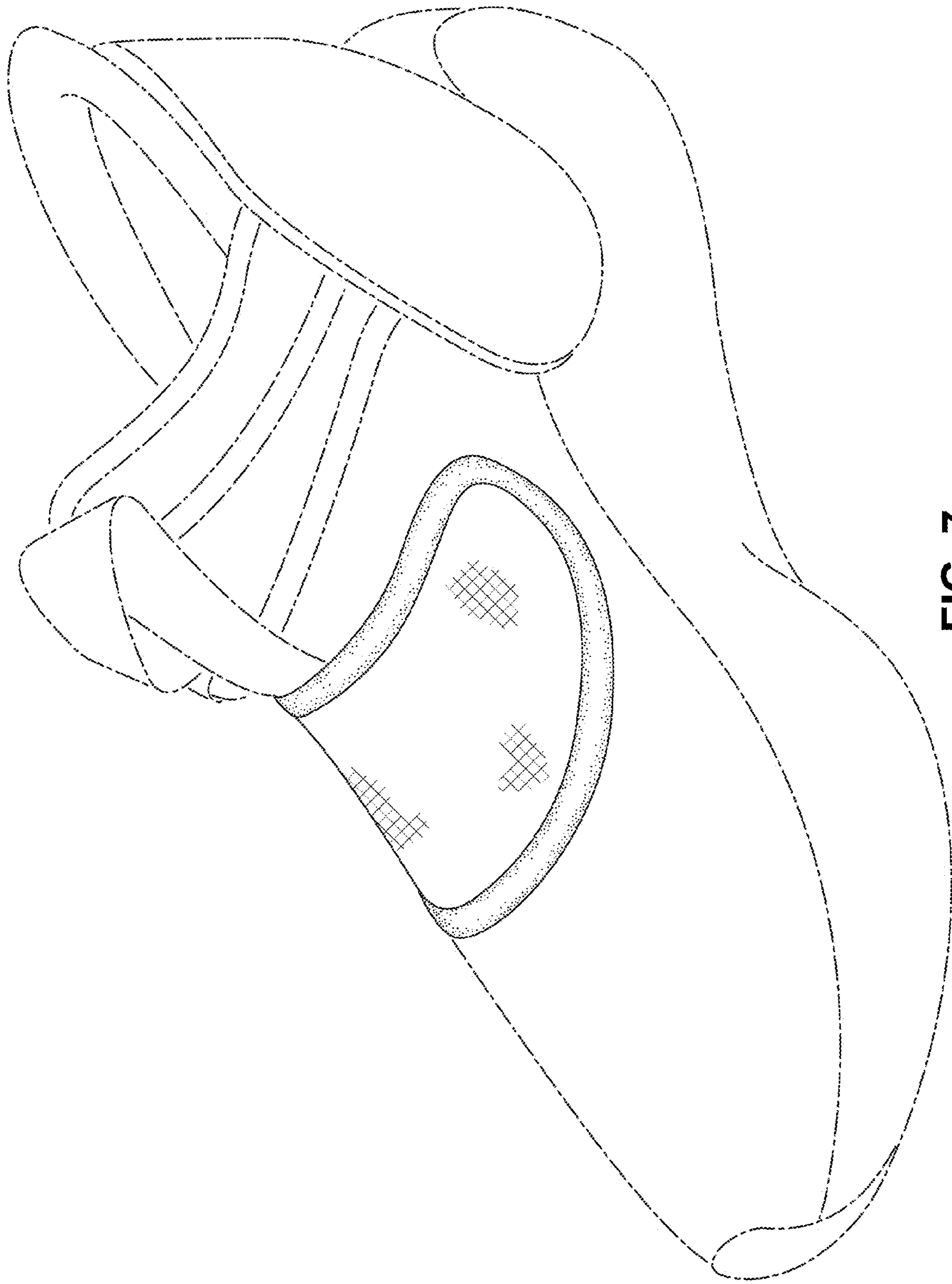

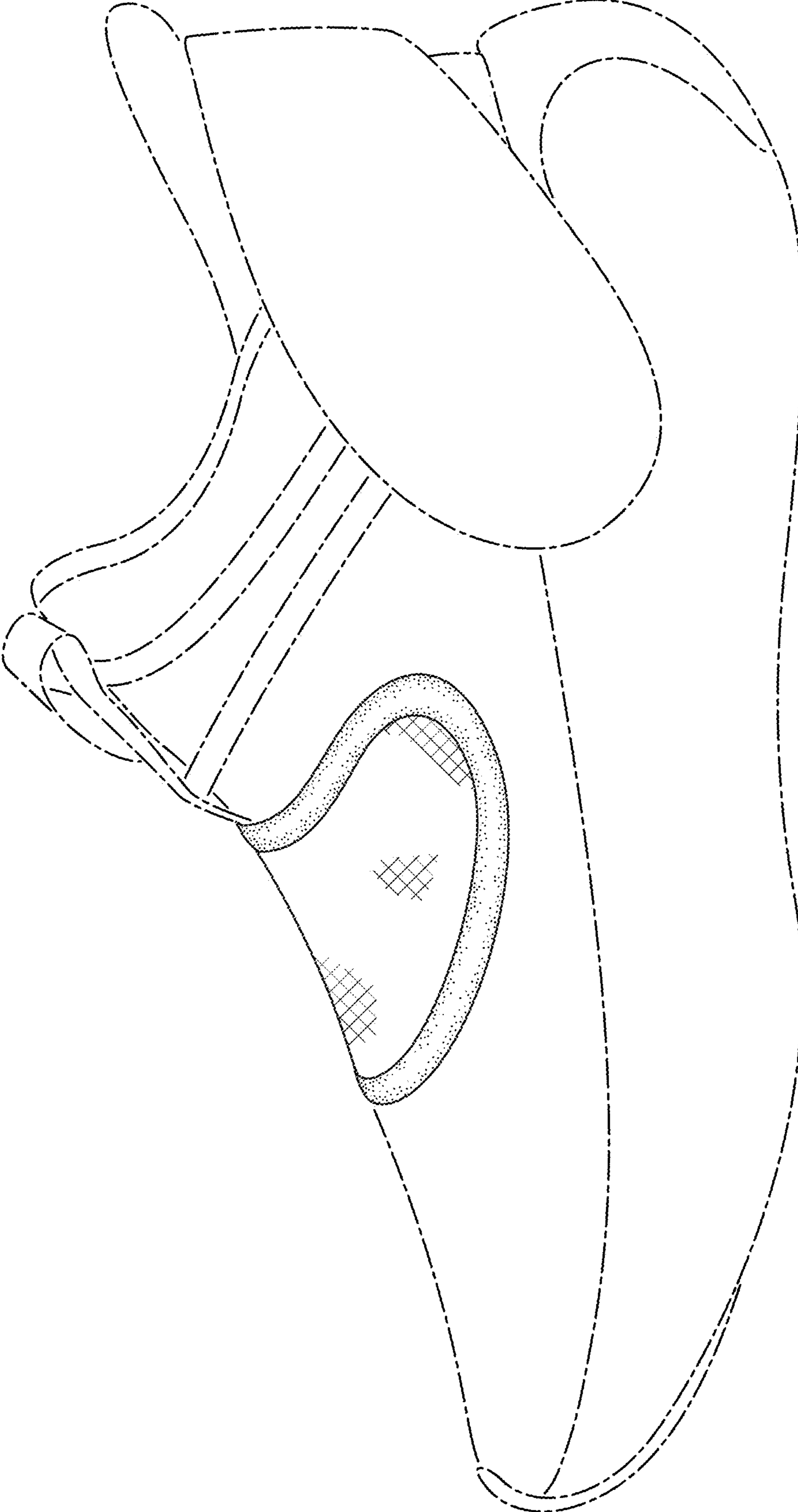
