(57) **CLAIM**

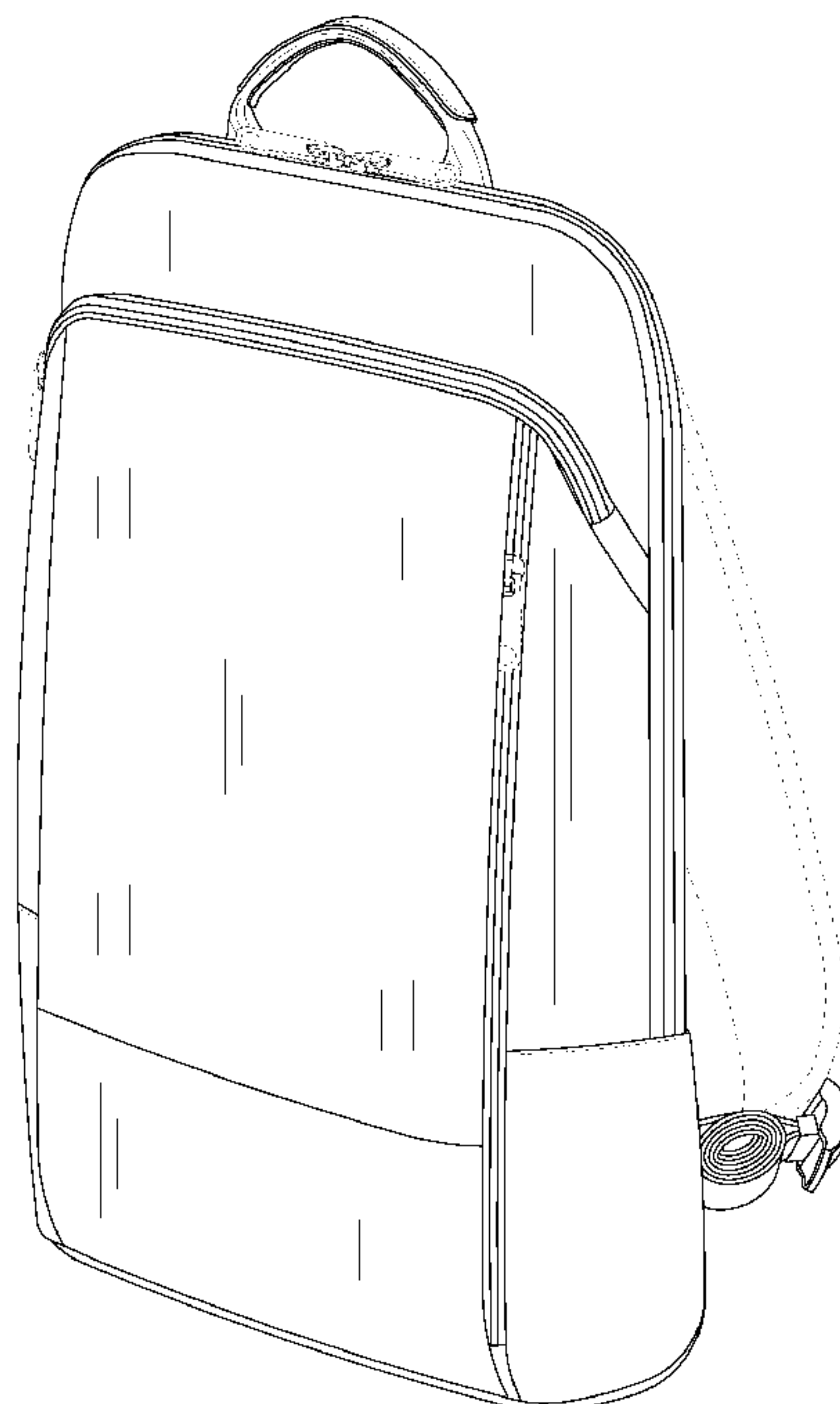
I claim the ornamental design for a backpack, as shown and described.

**DESCRIPTION**

FIG. 1 is a Perspective view of a backpack showing my new design;  
FIG. 2 is a Front view of the backpack as shown in FIG. 1;  
FIG. 3 is a Back view of the backpack as shown in FIG. 1;  
FIG. 4 is a Top view of the backpack as shown in FIG. 1;  
FIG. 5 is a Bottom view of the backpack as shown in FIG. 1;  
FIG. 6 is a Right-side view of the backpack as shown in FIG. 1; and,  
FIG. 7 is a Left-side view of the backpack as shown in FIG. 1.

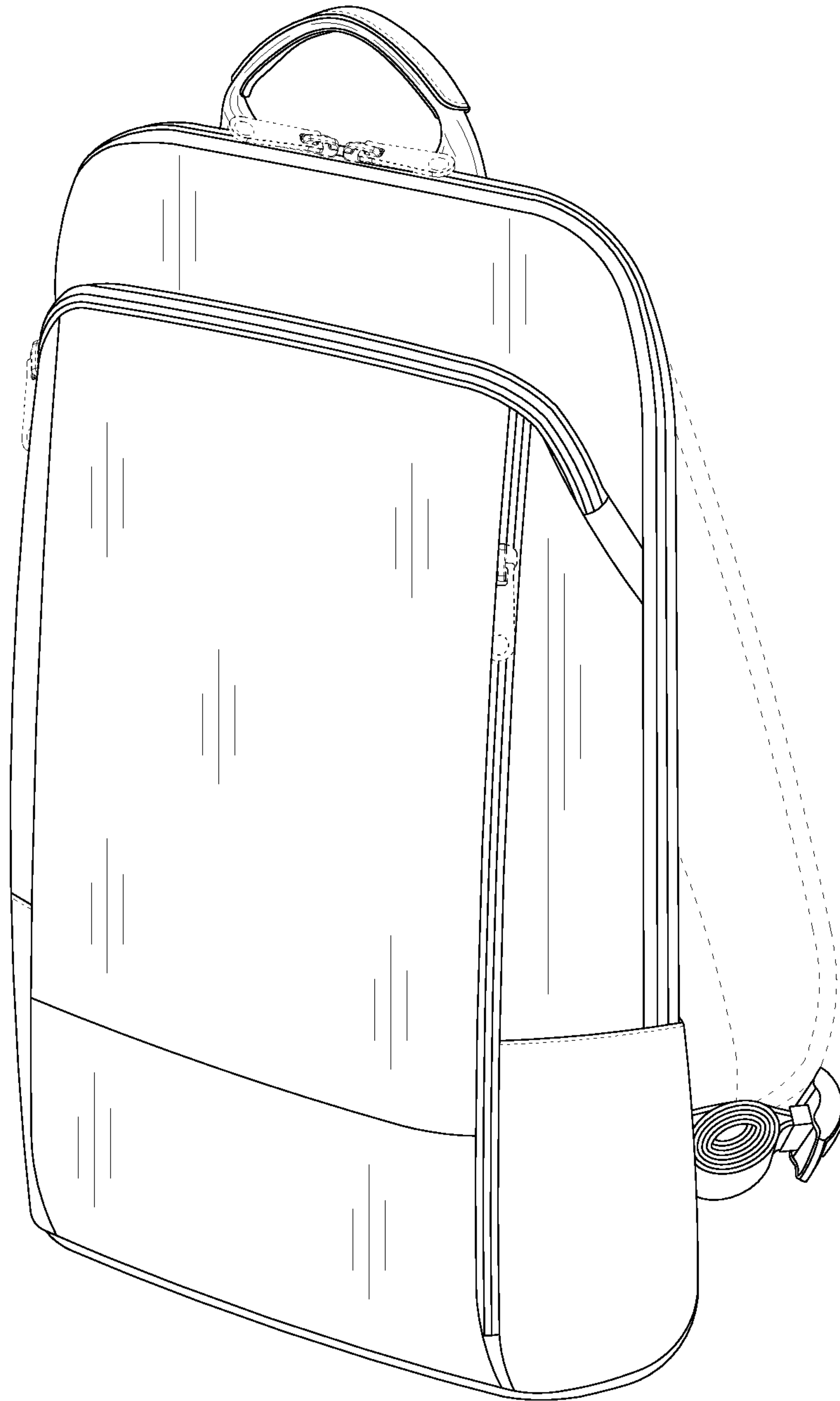

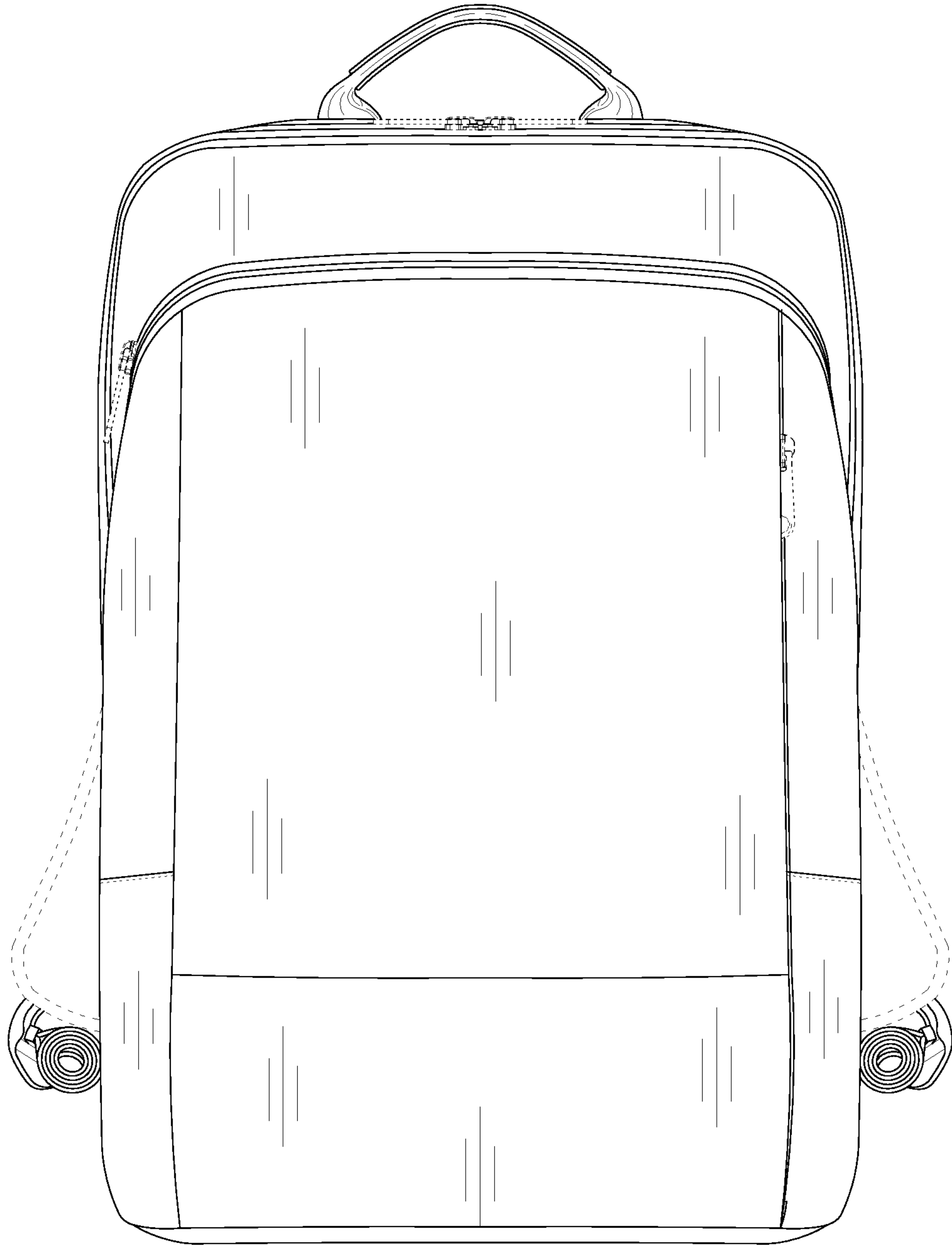

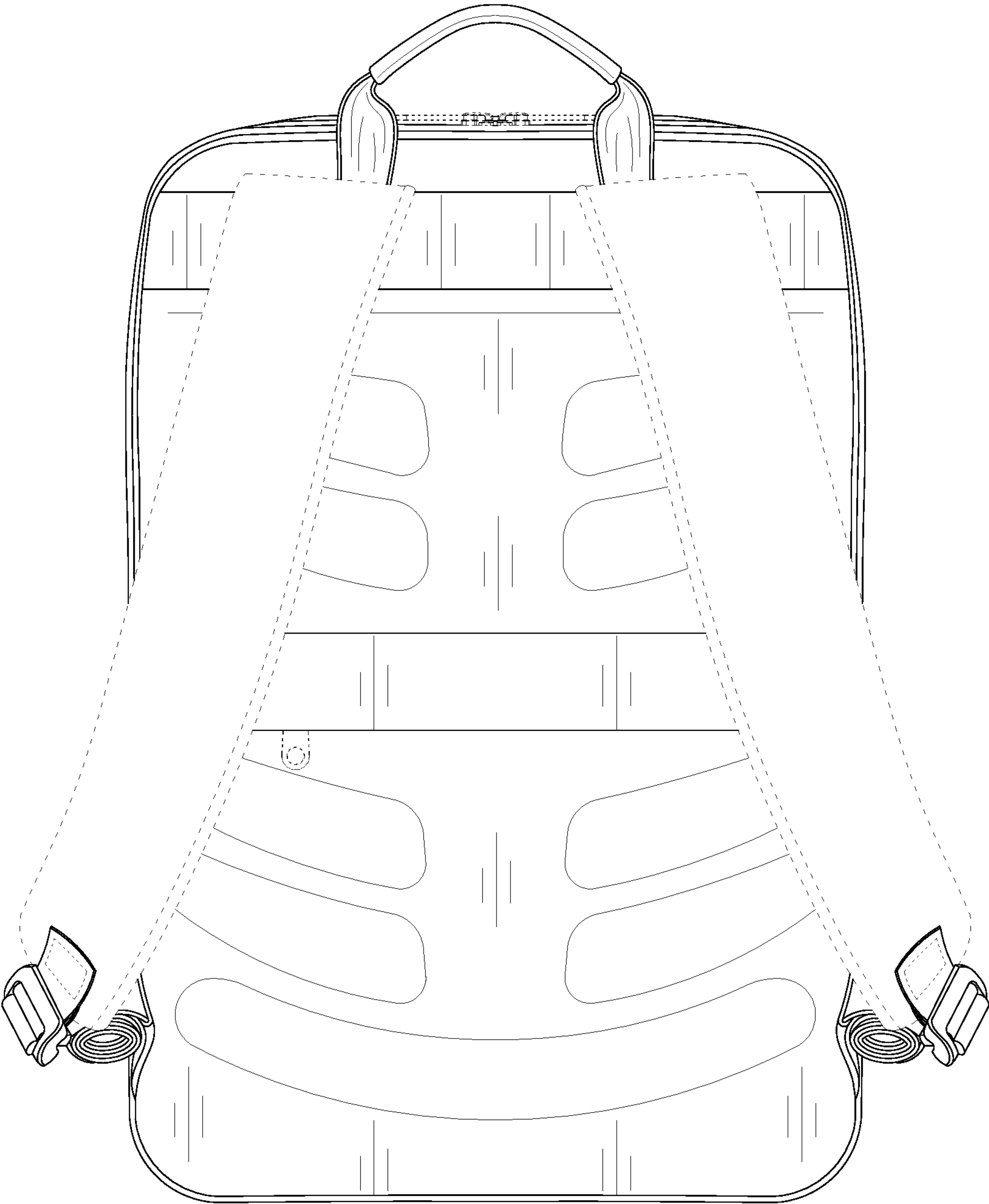

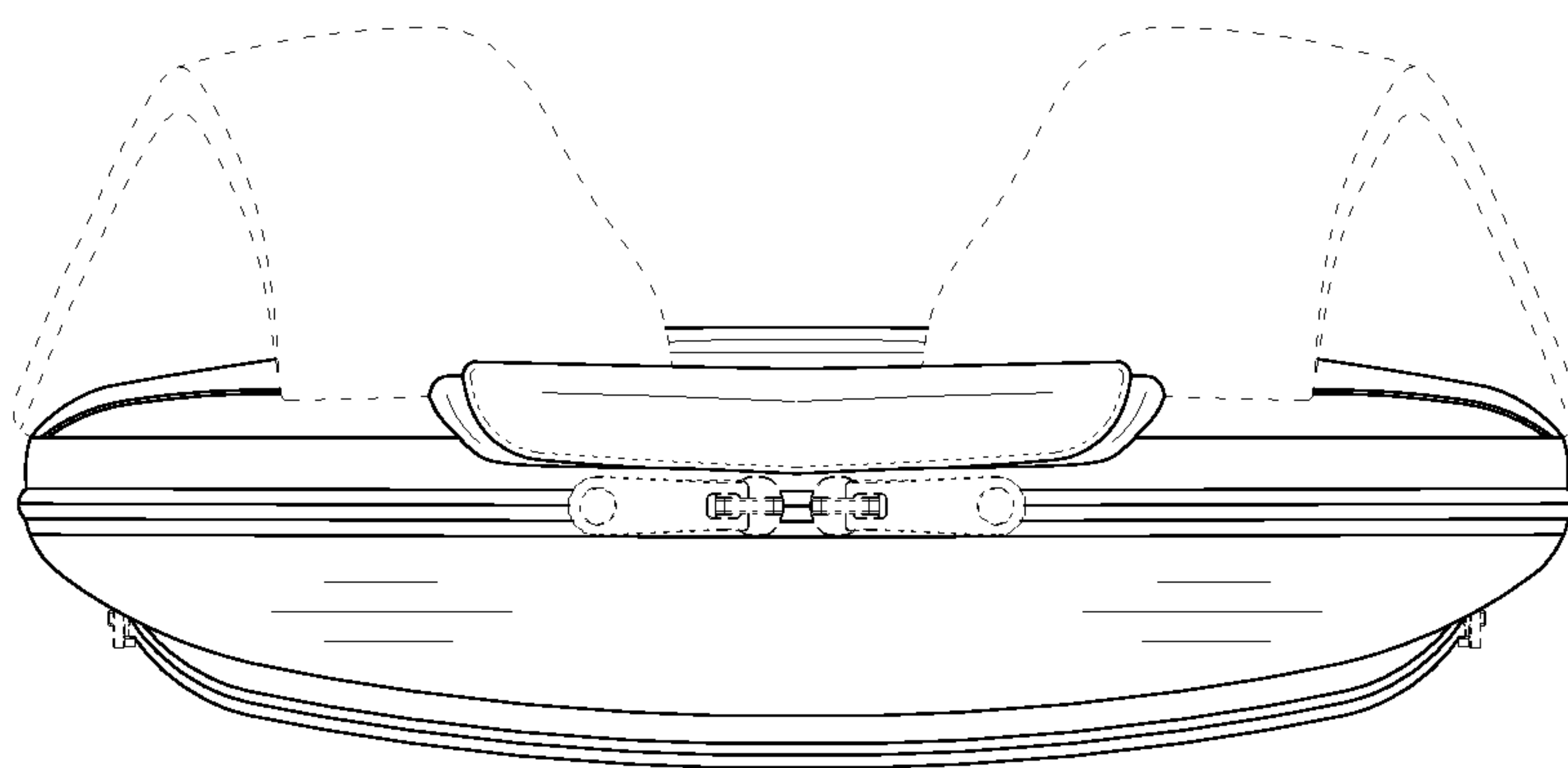

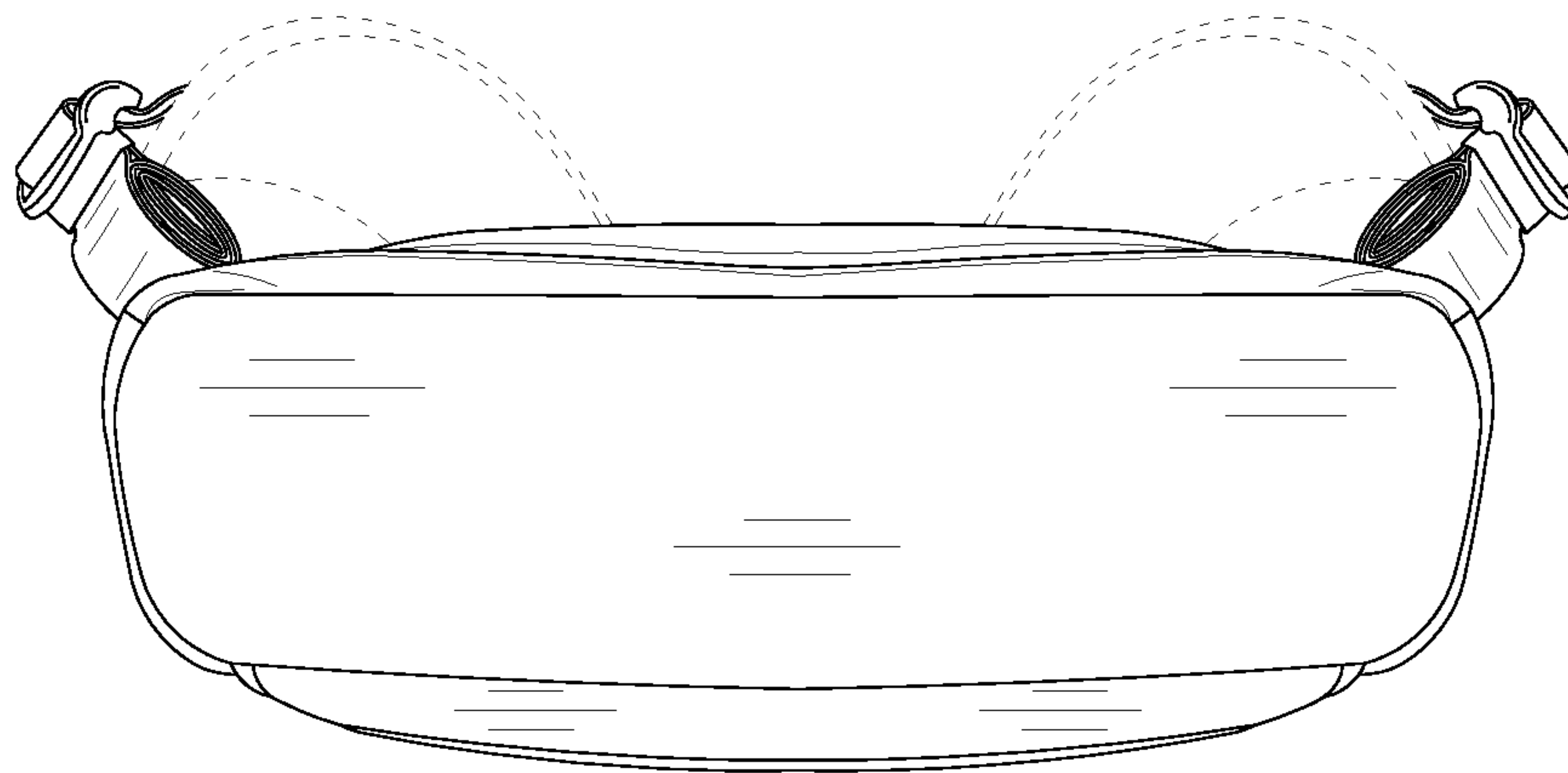

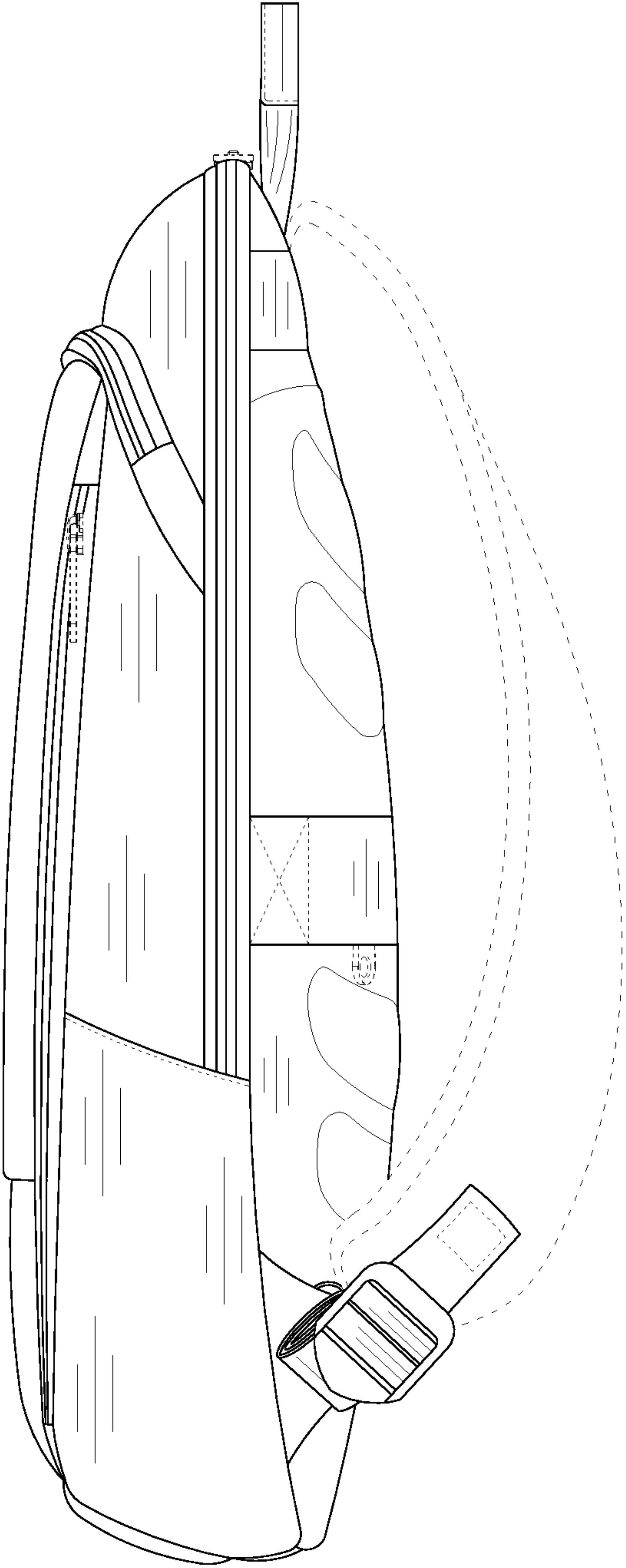

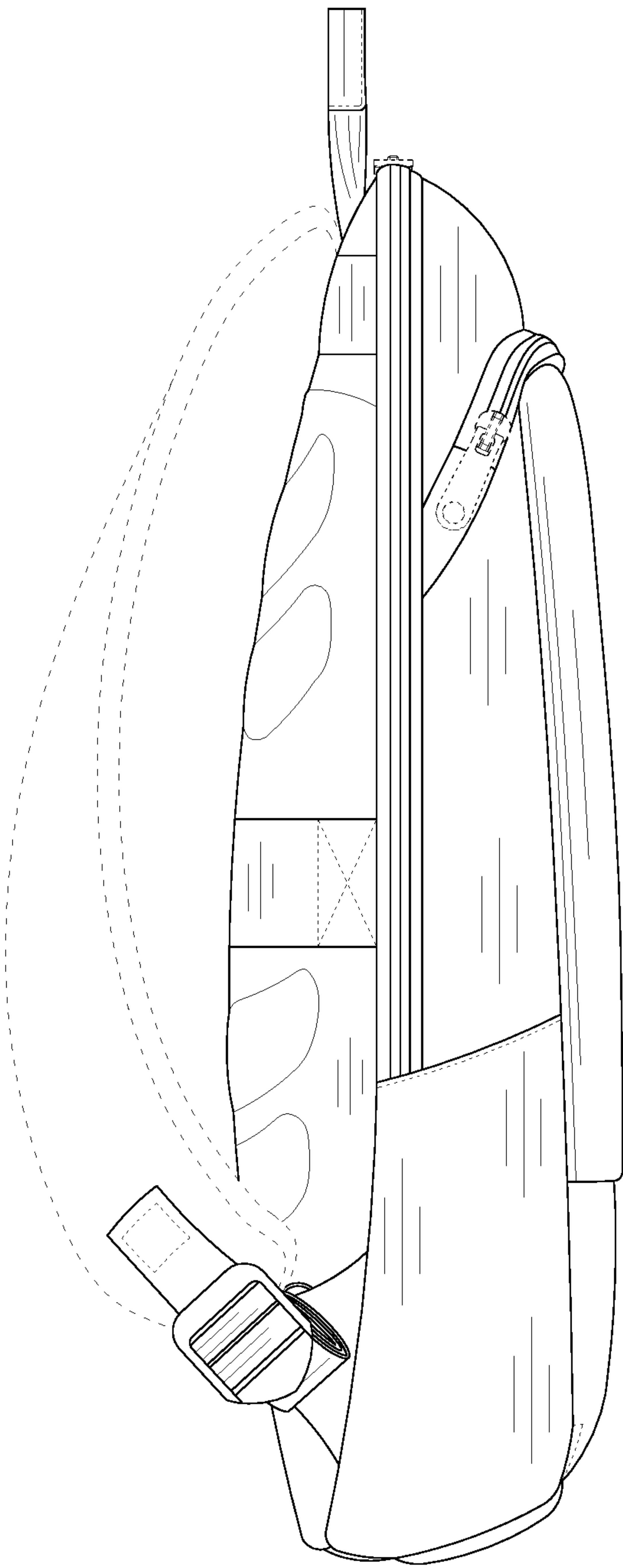
