DESCRIPTION

1. Wallet

FIG. 1.7 is a bottom plan view of the wallet shown in FIG. 1.1.

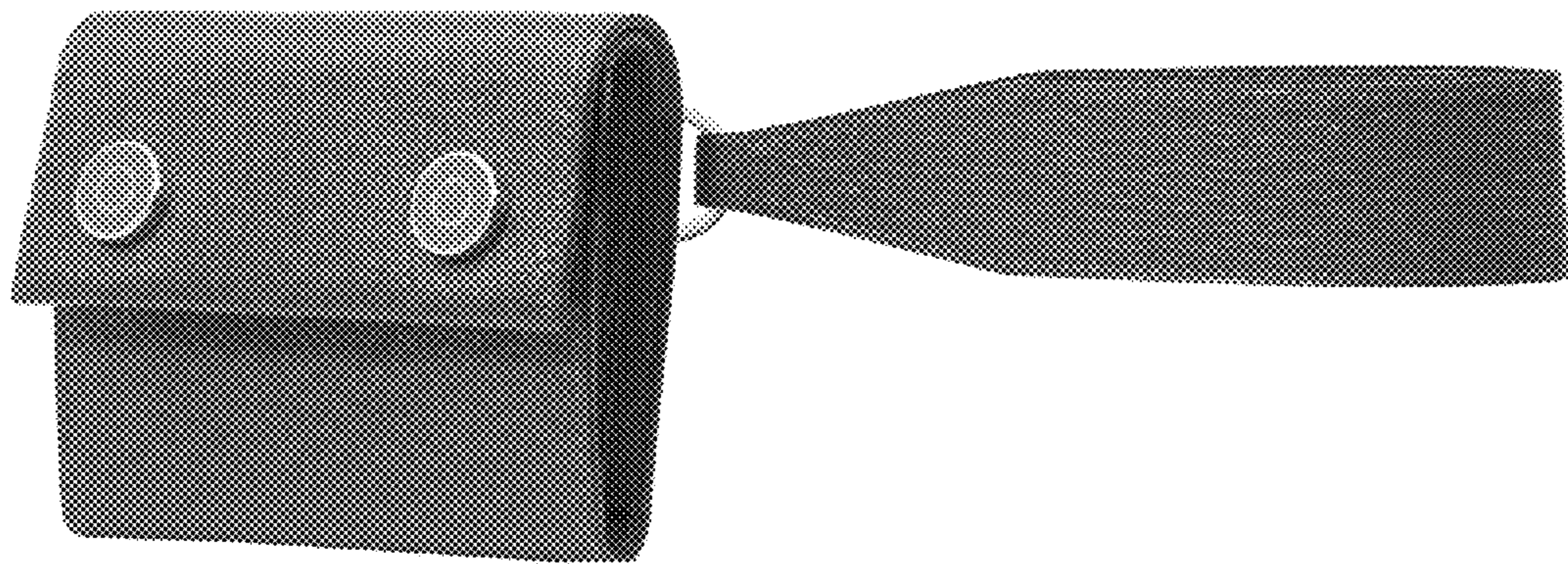
FIG. 1.8 is an additional perspective view of the wallet shown in FIG. 1.1.

Dotted lines in the images represent seams that are not part of the design and are not claimed.

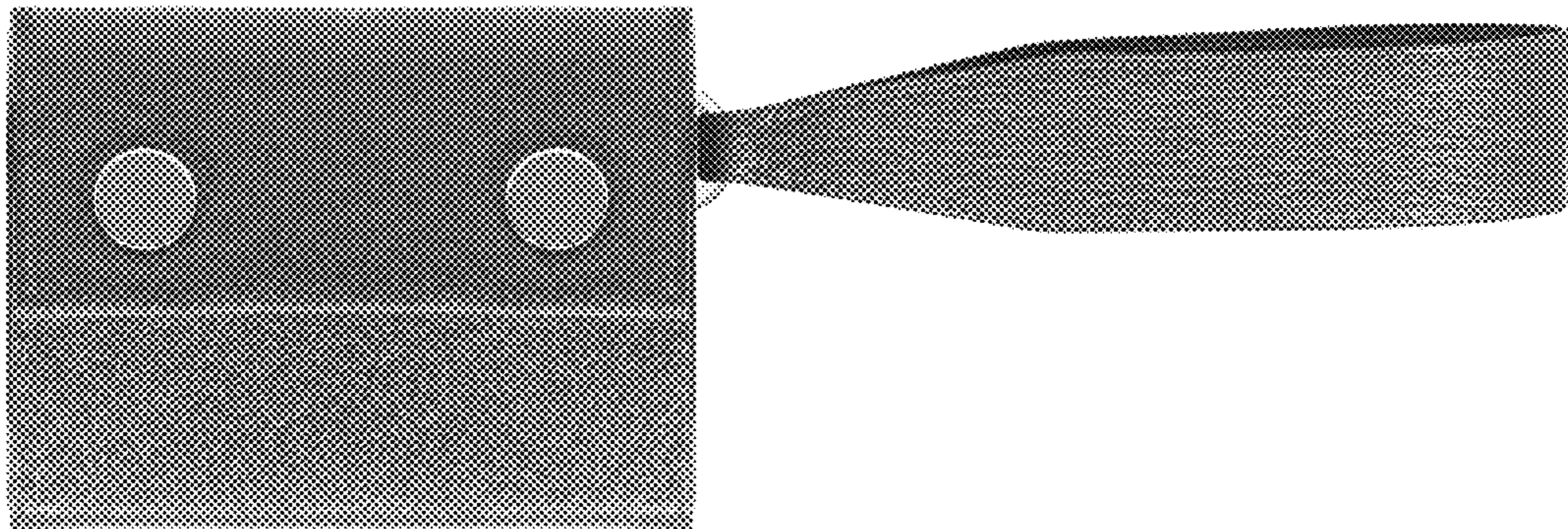

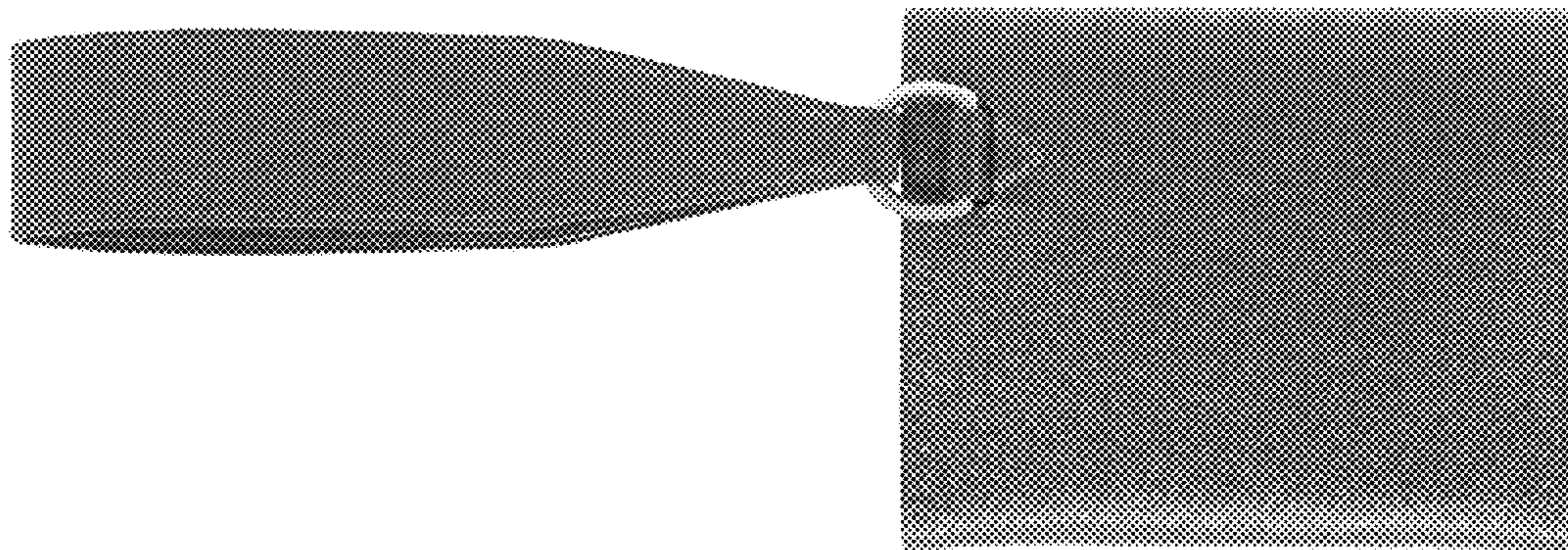

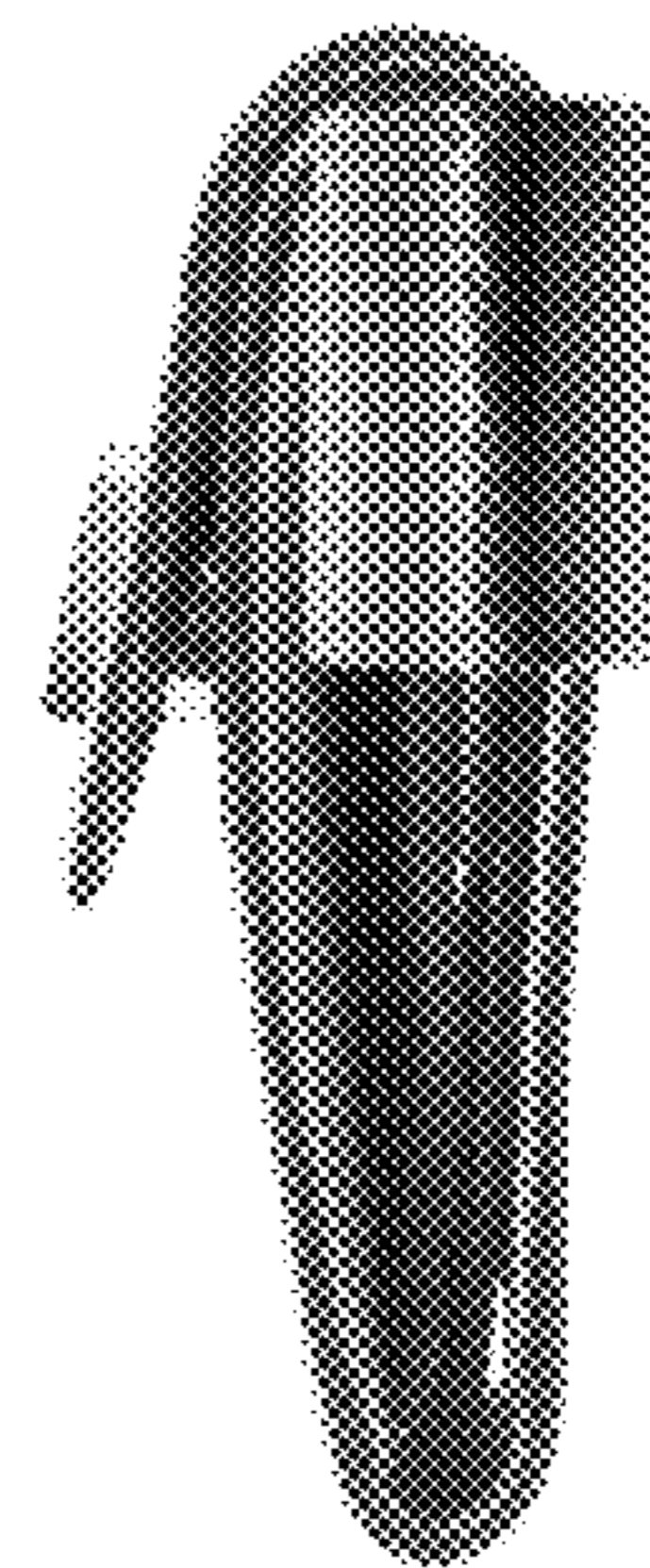

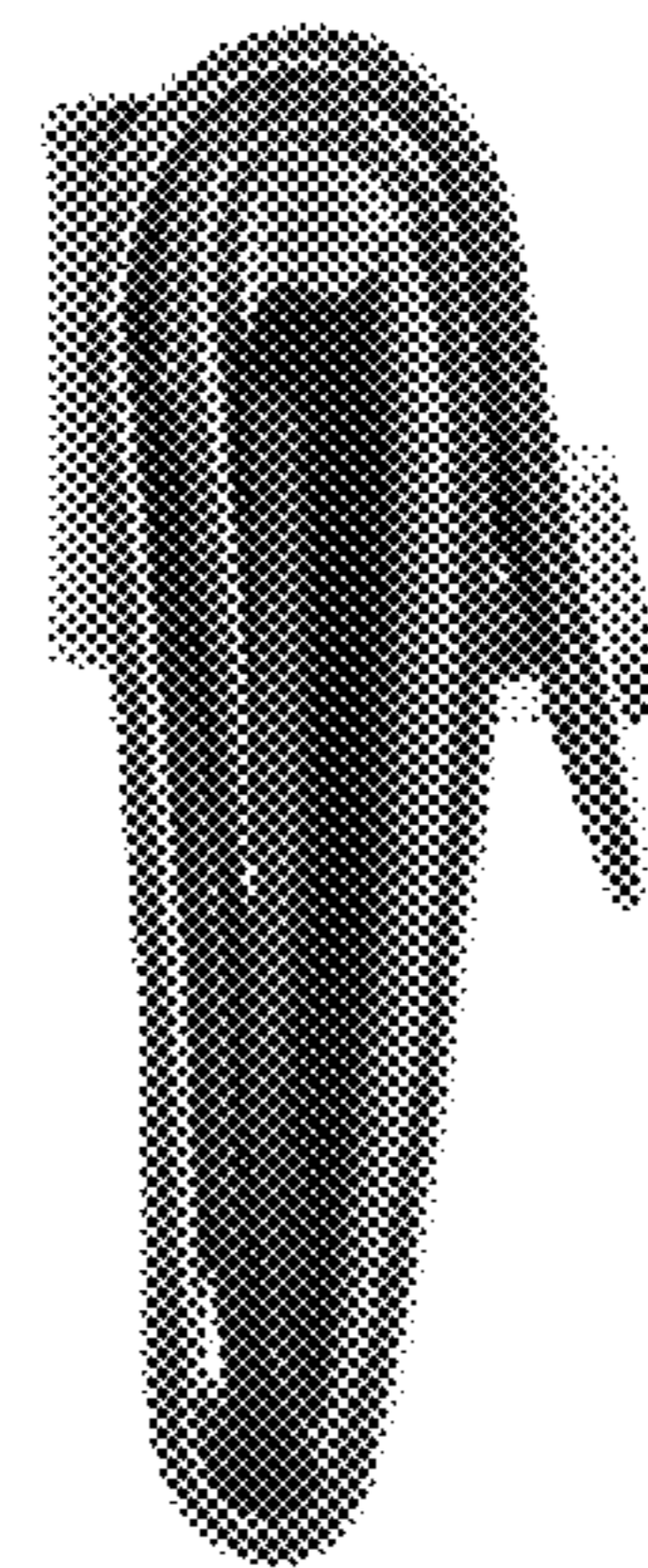

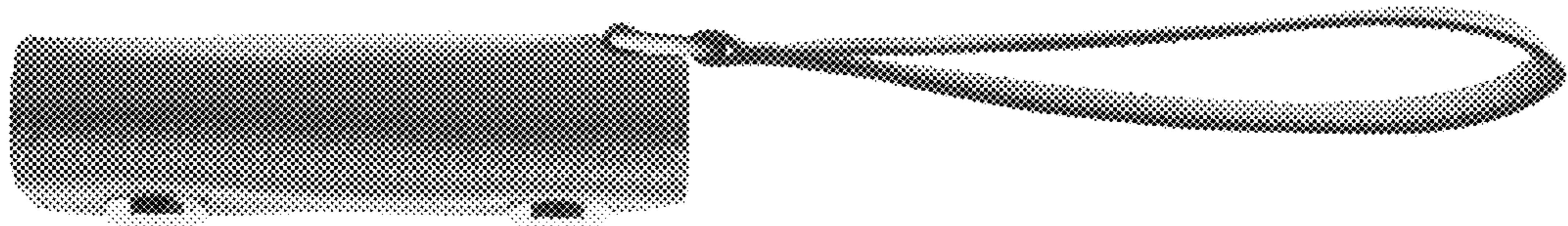

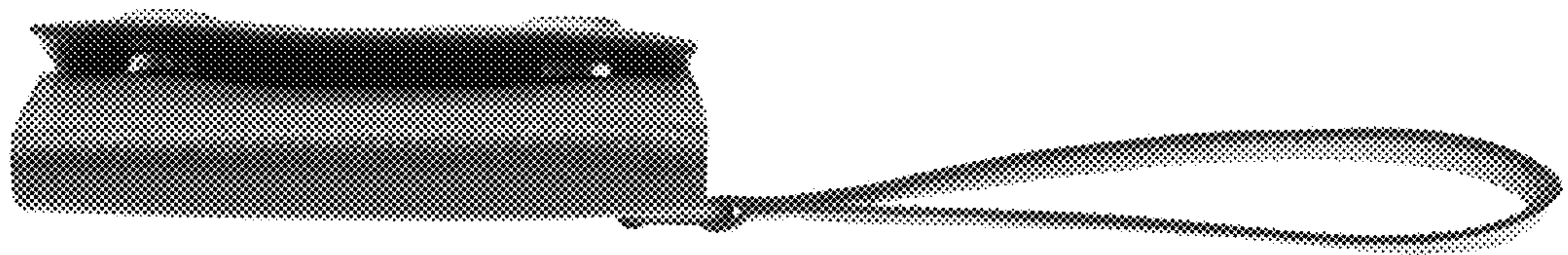
