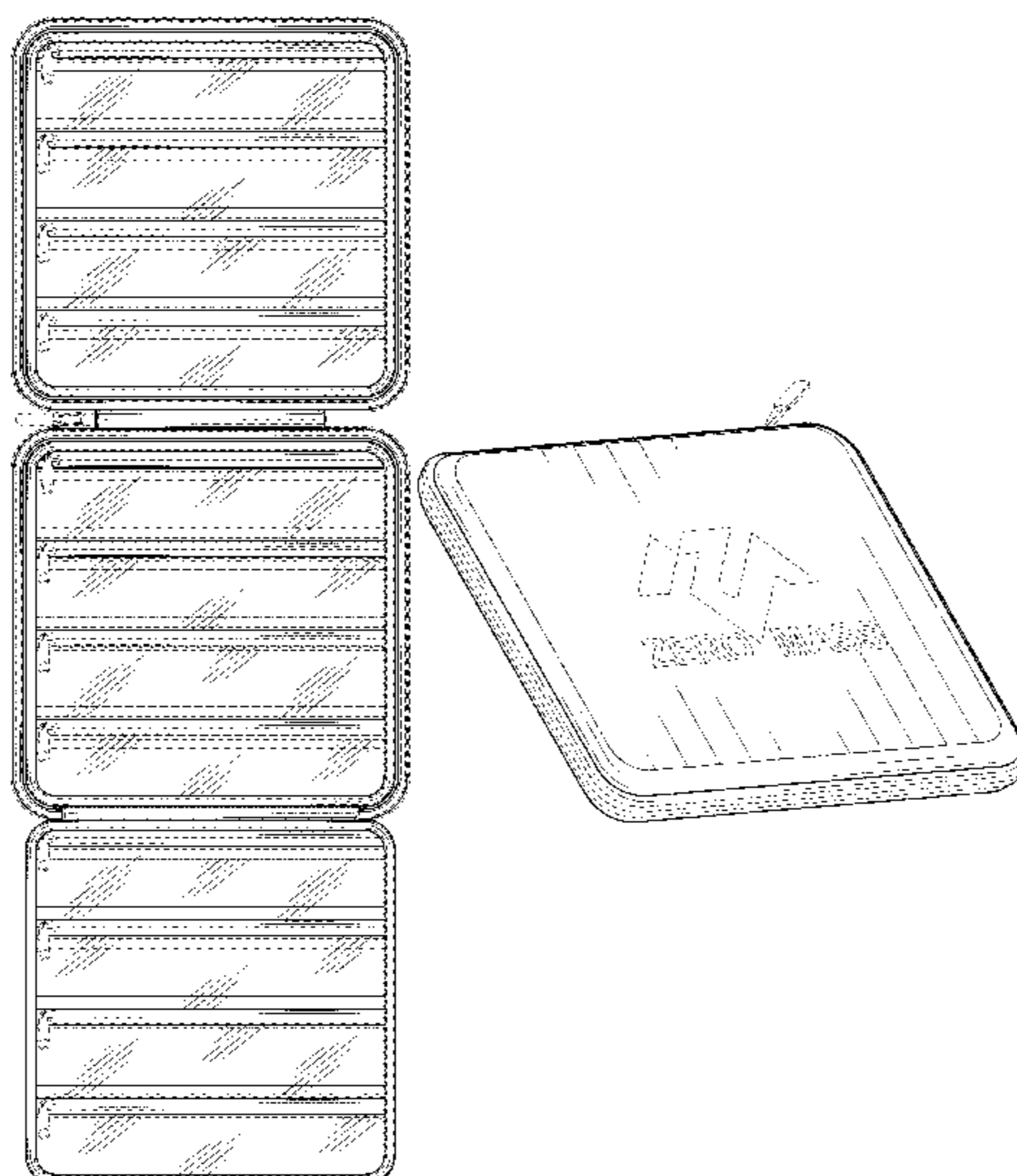
(57) **CLAIM**

The ornamental design for a watch band storage case, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the watch band storage case;  
FIG. 2 is a back view thereof;  
FIG. 3 is a left side view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a top view thereof;  
FIG. 6 is a bottom view thereof;  
FIG. 7 is a front view of an first open configuration thereof;  
FIG. 8 is a front view of an second open configuration thereof; and,  
FIG. 9 is a perspective view thereof.  
The broken lines in the drawing show portions of the watch band storage case and stitching, and form no part of the claimed design.

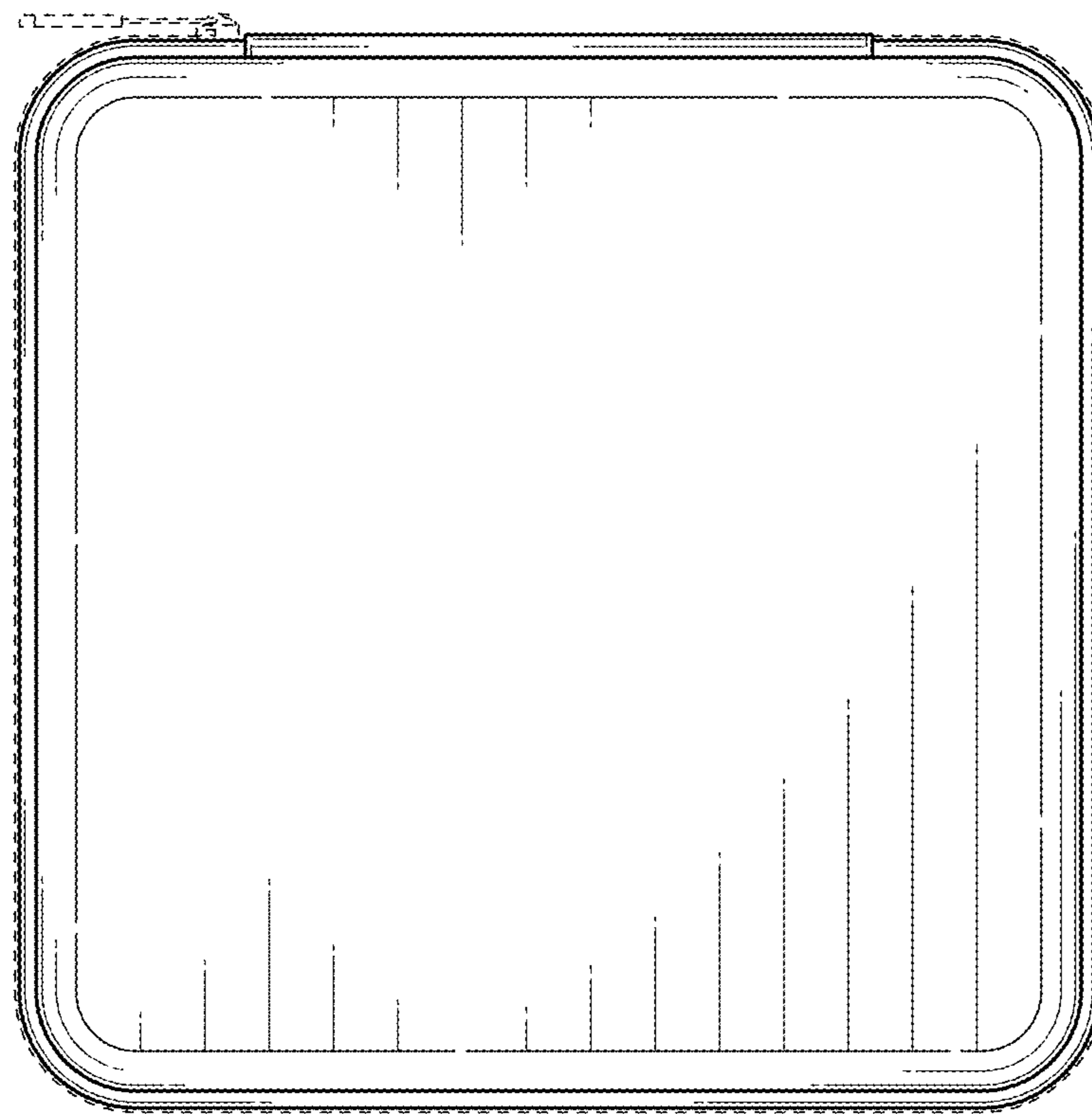

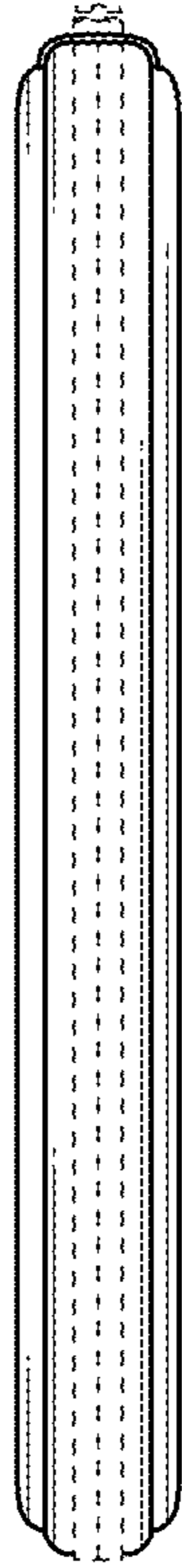

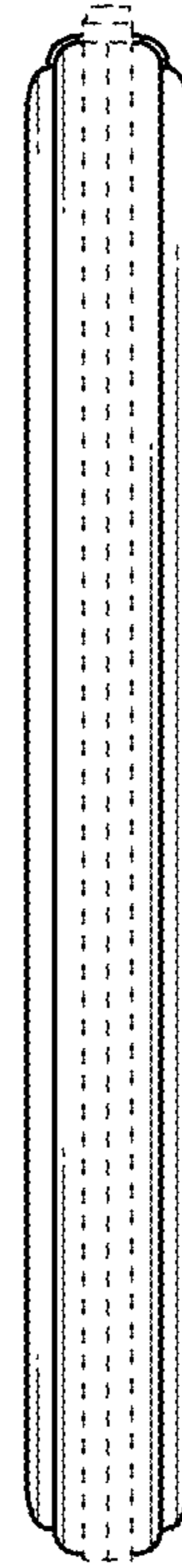

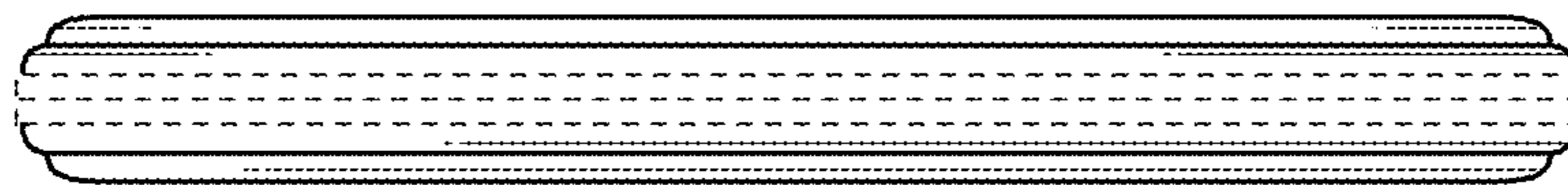

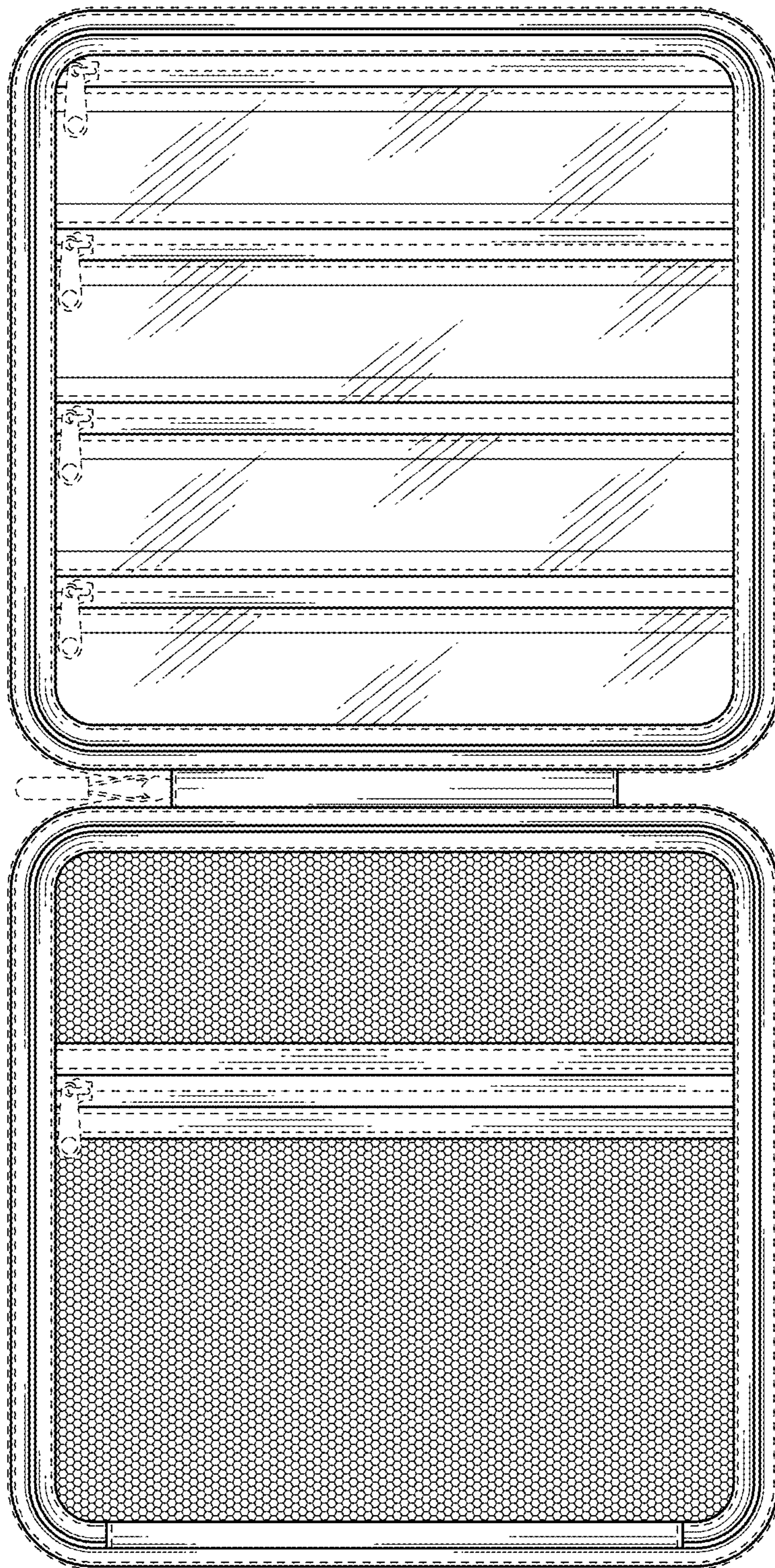

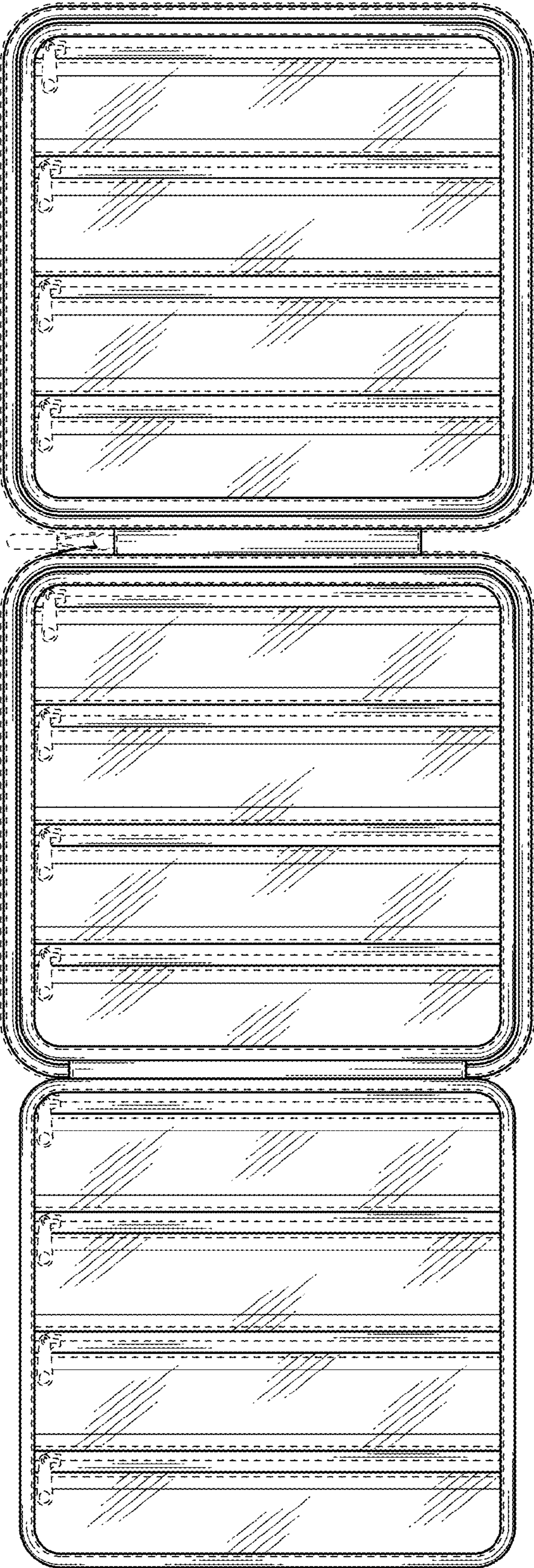

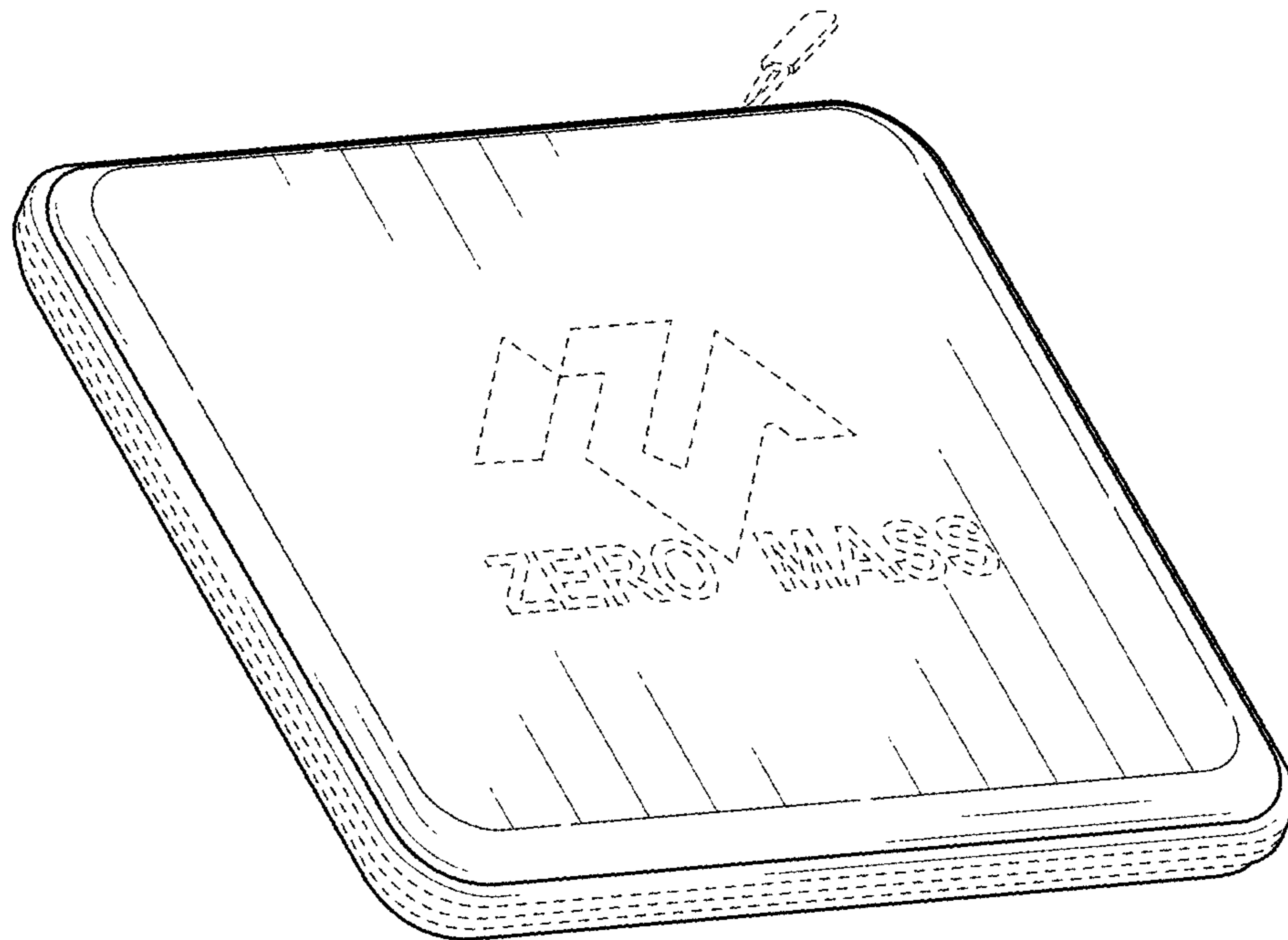
