FIG. 2 is a top view of a pedestrian modular mat showing our new design;

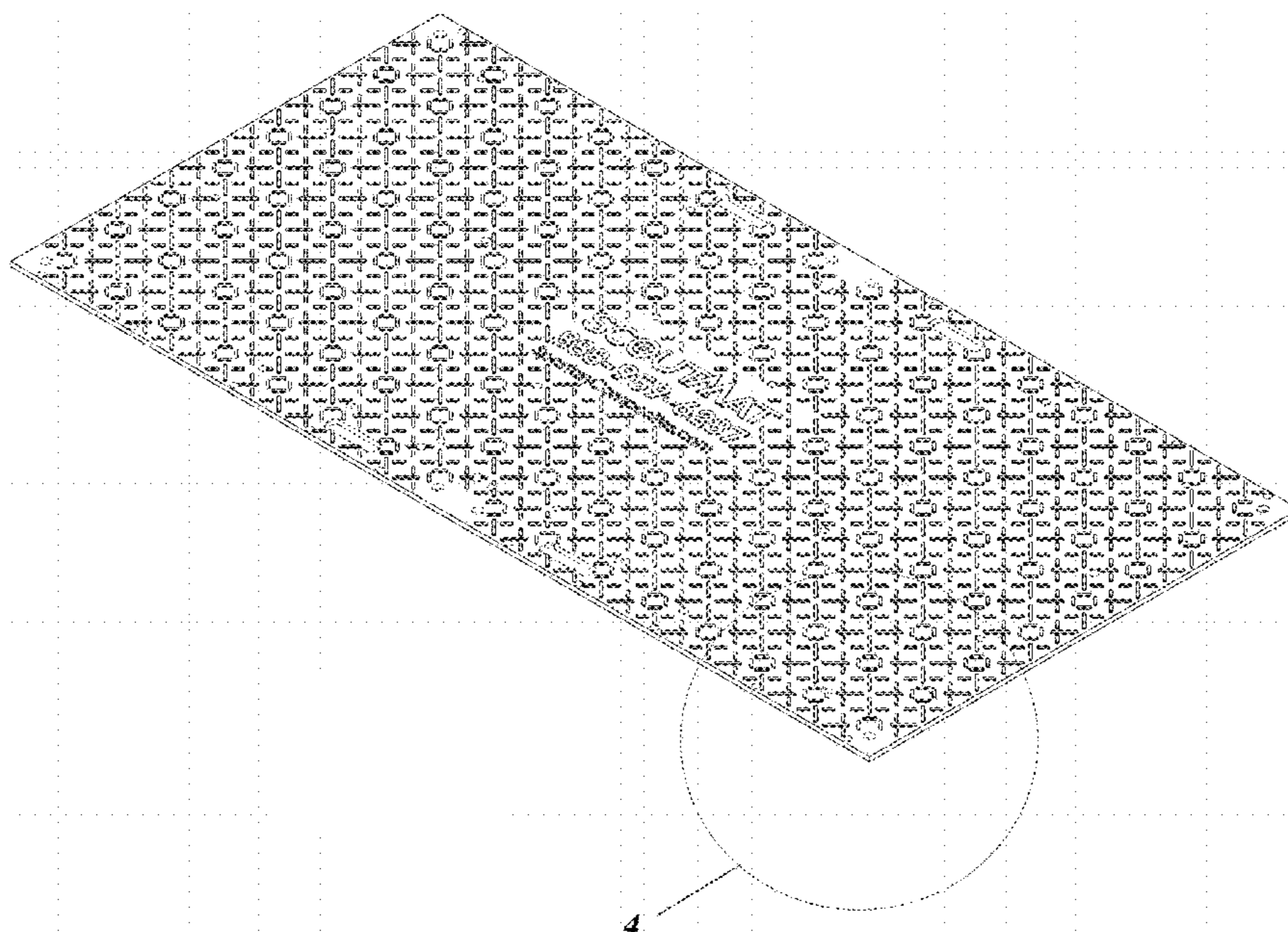
FIG. 3 is a side view of a pedestrian modular mat showing our new design;

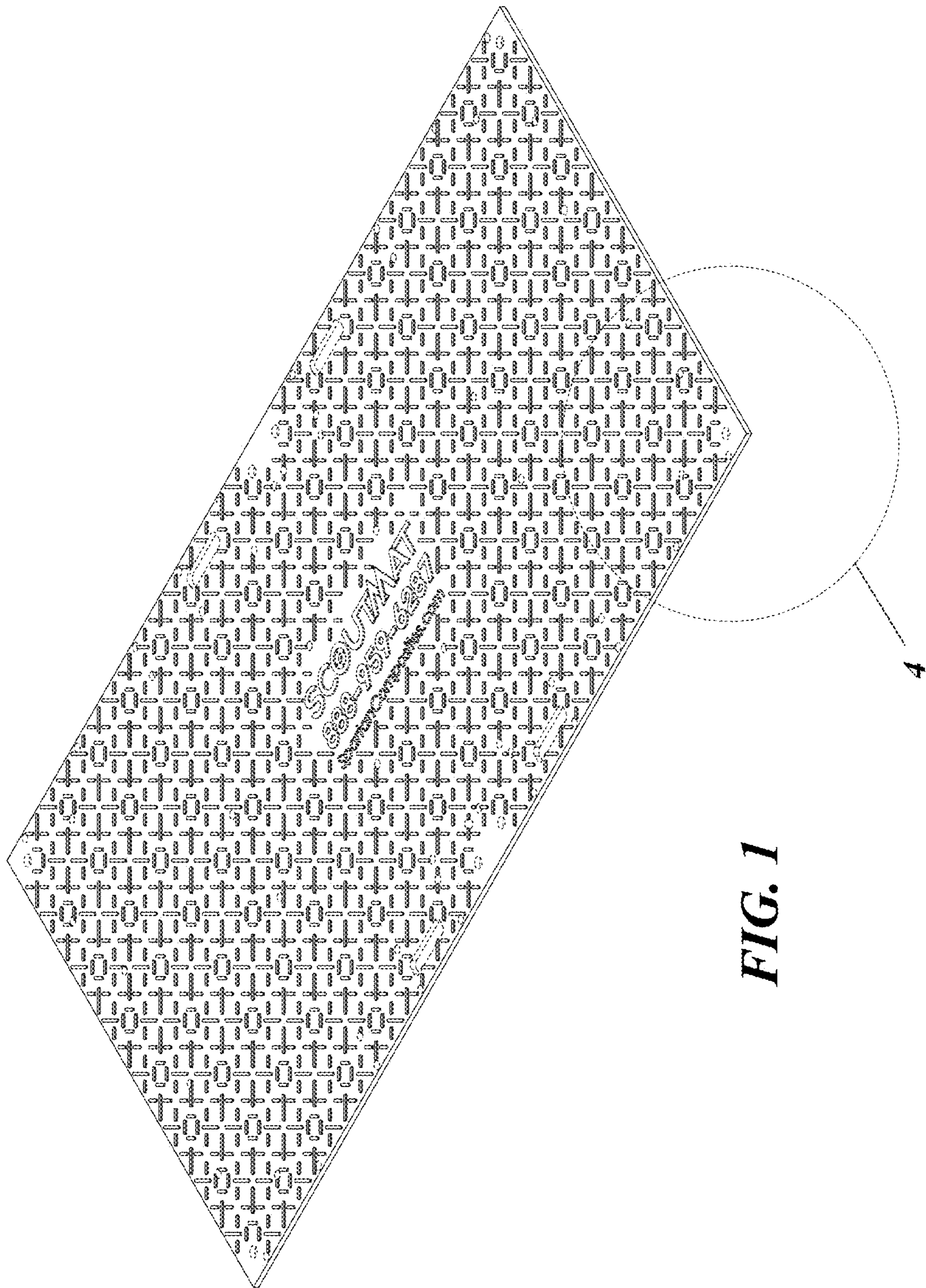

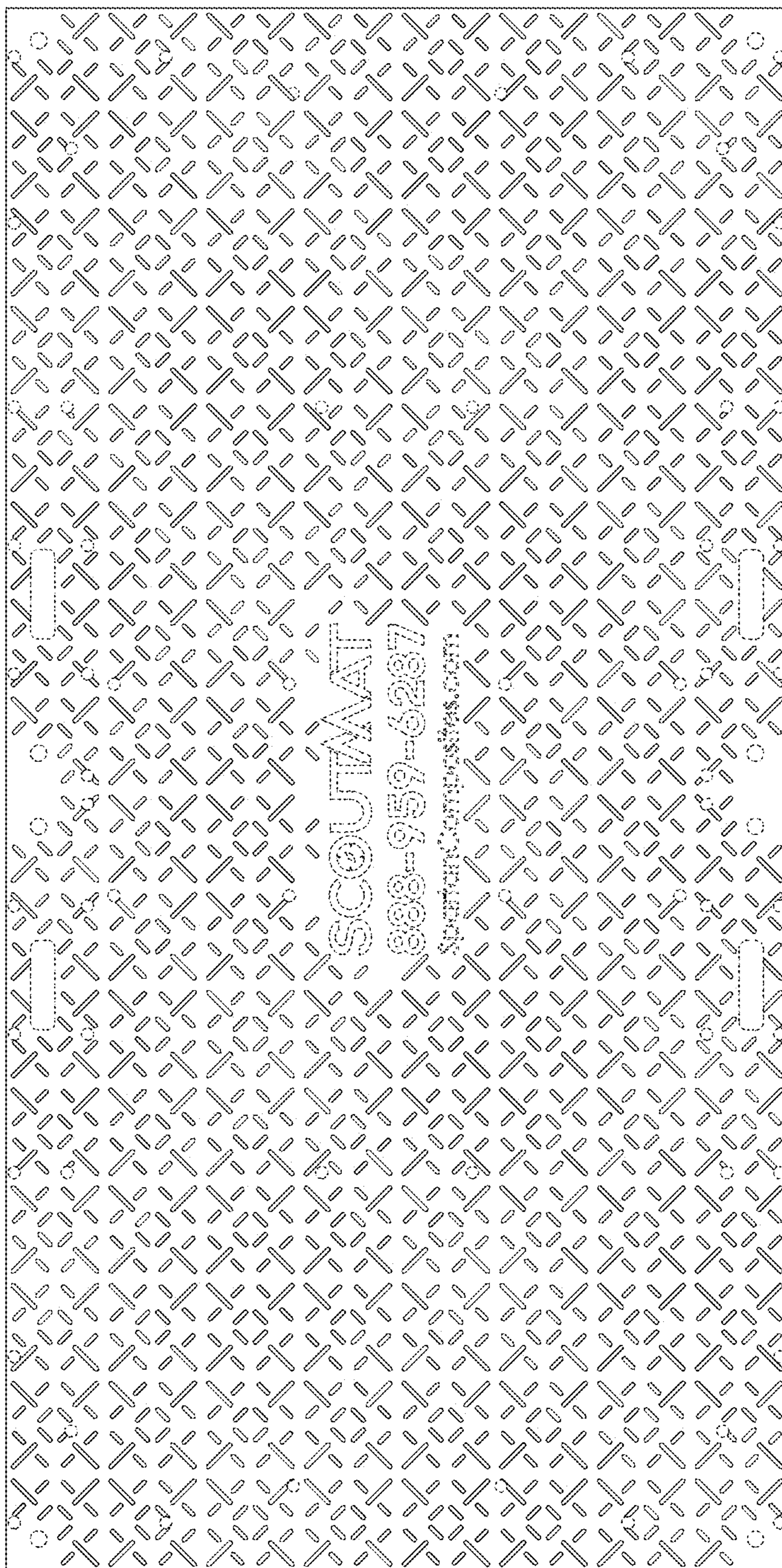

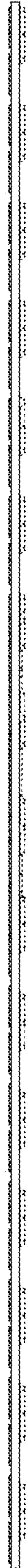

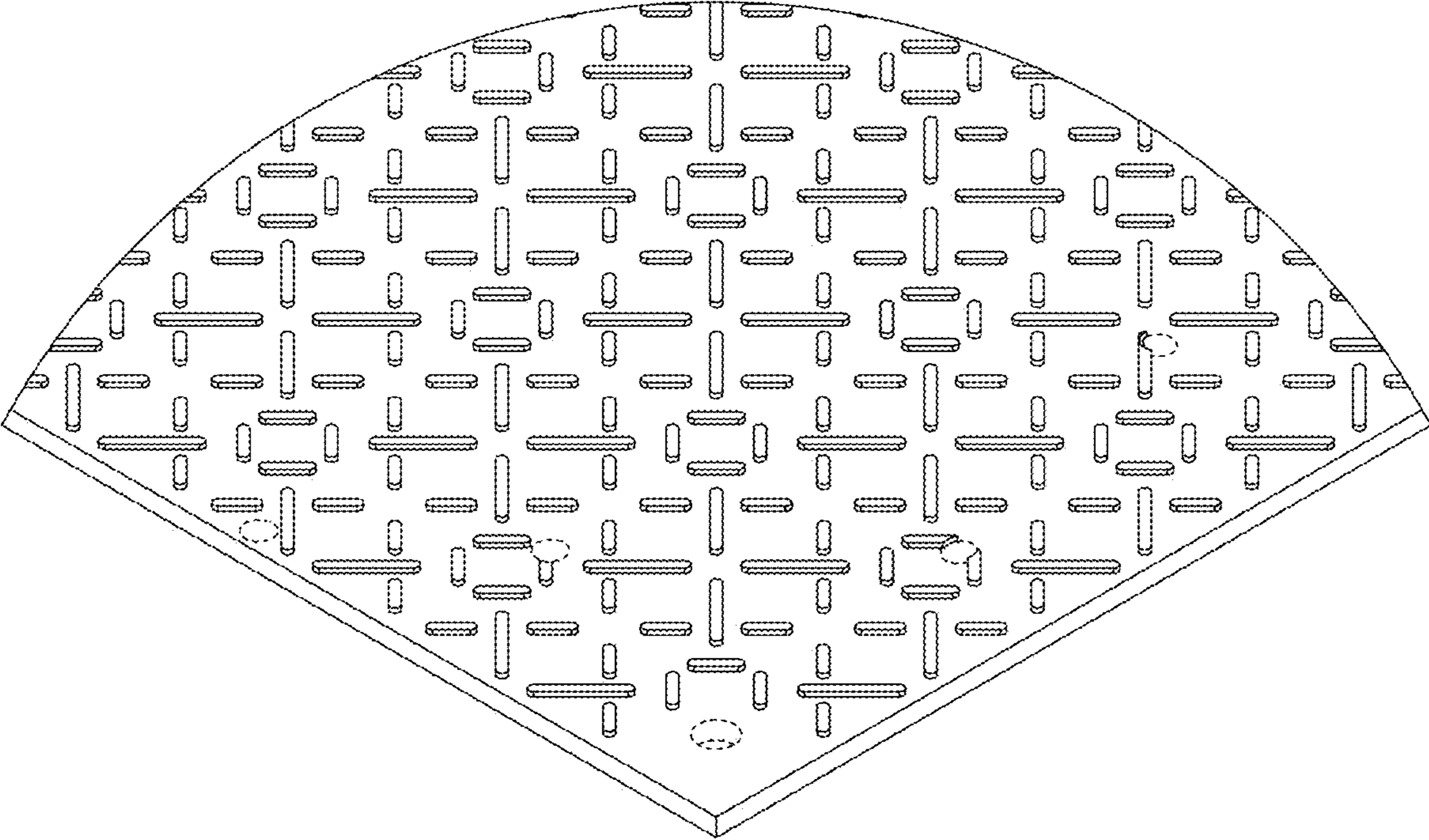

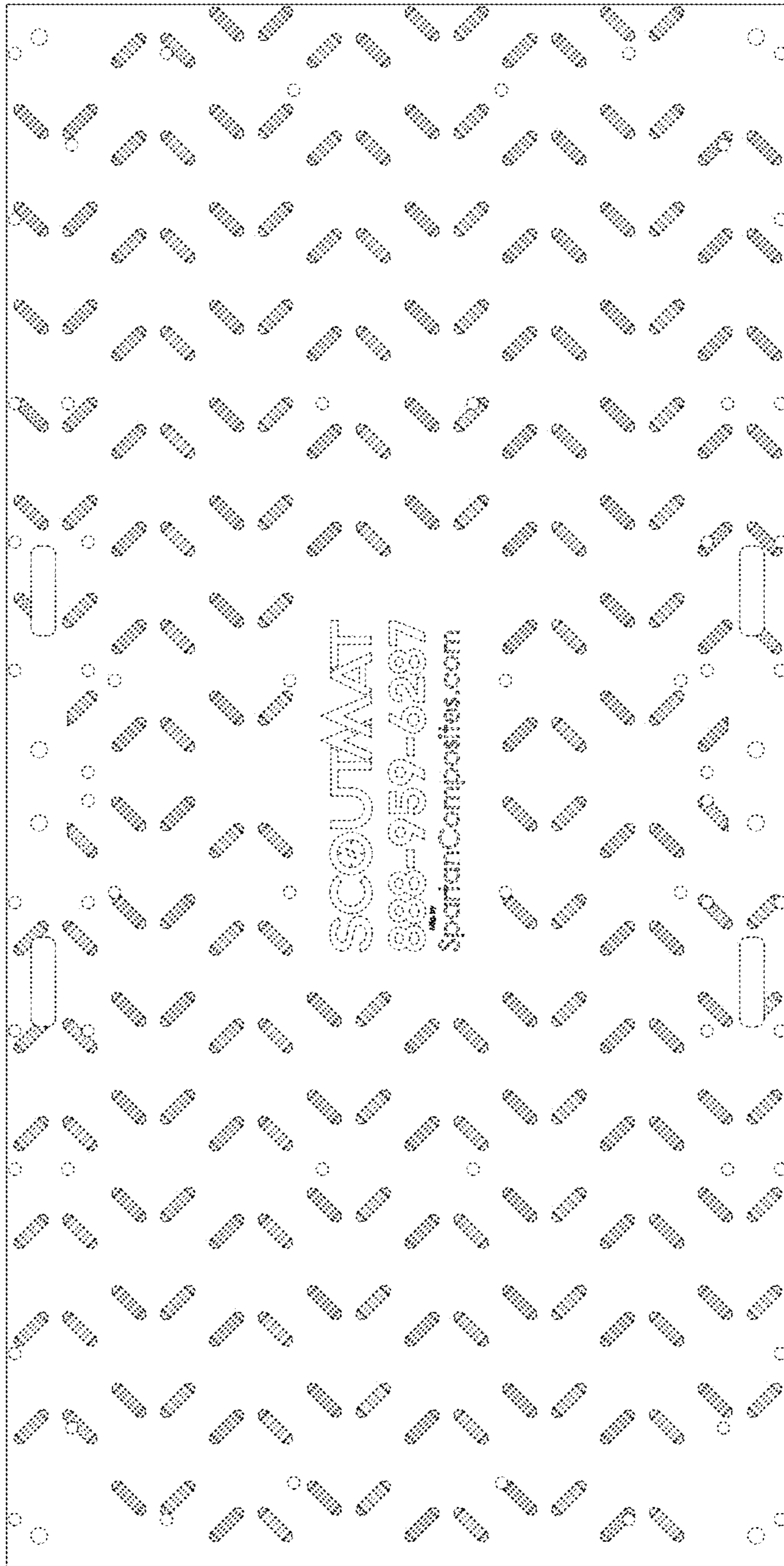
