(57) **CLAIM**

The ornamental design for a dog car seat cover, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a dog car seat cover showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof;
FIG. 7 is the front view showing an opening state of the button;
FIG. 8 is a front view of a dog car seat cover in a disassembled manner;
FIG. 9 is an enlarged partial view of FIG. 1;
FIG. 10 is an enlarged partial view of FIG. 2; and,
FIG. 11 is an enlarged partial view of FIG. 7.
The dot-dash broken lines identify enlarged areas and form no part of the claimed design. The evenly spaced larger broken lines, the evenly spaced smaller broken lines, and the thicker broken lines in the figures are for the purpose of illustrating portions of the dog car seat cover that form no part of the claimed design.

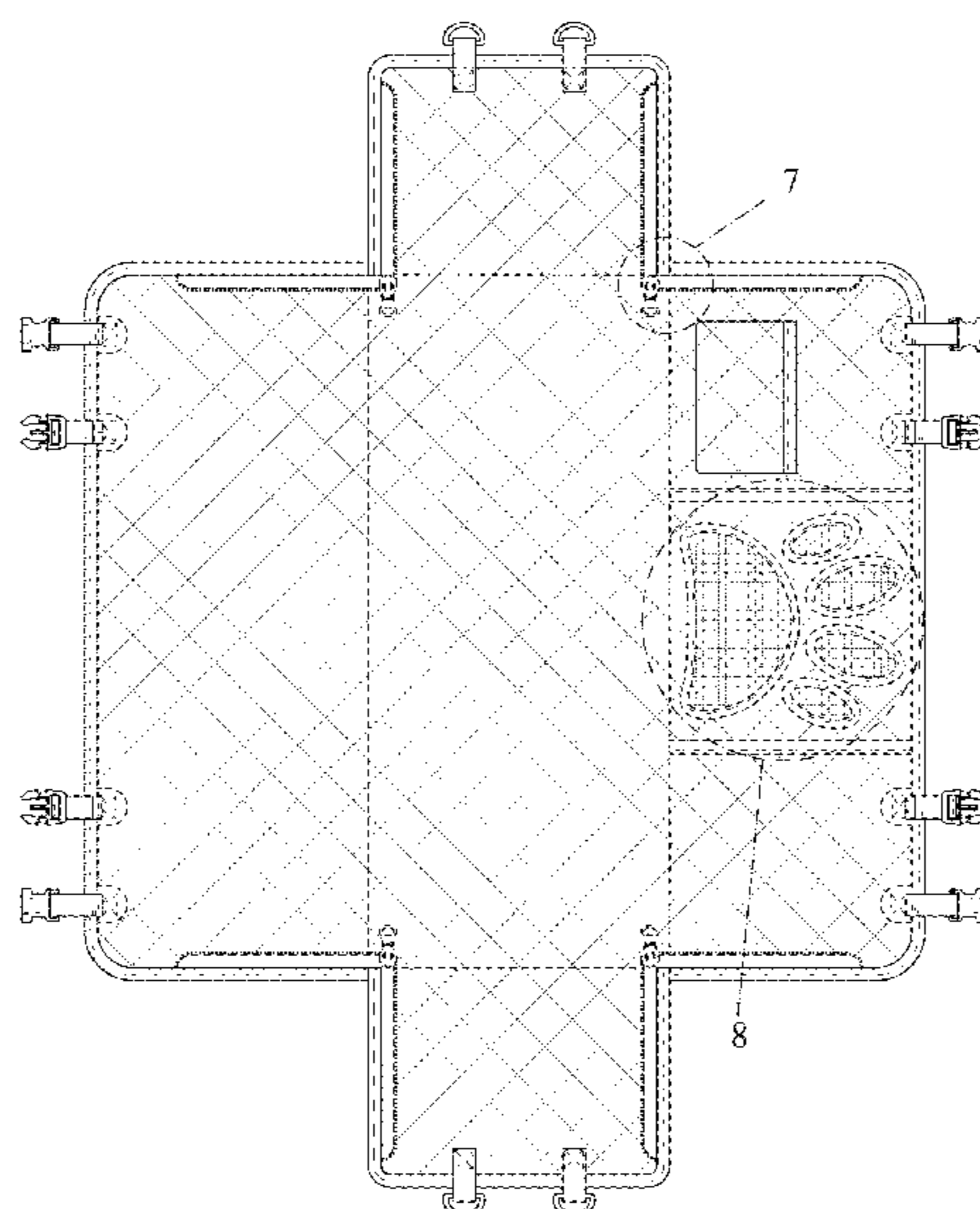

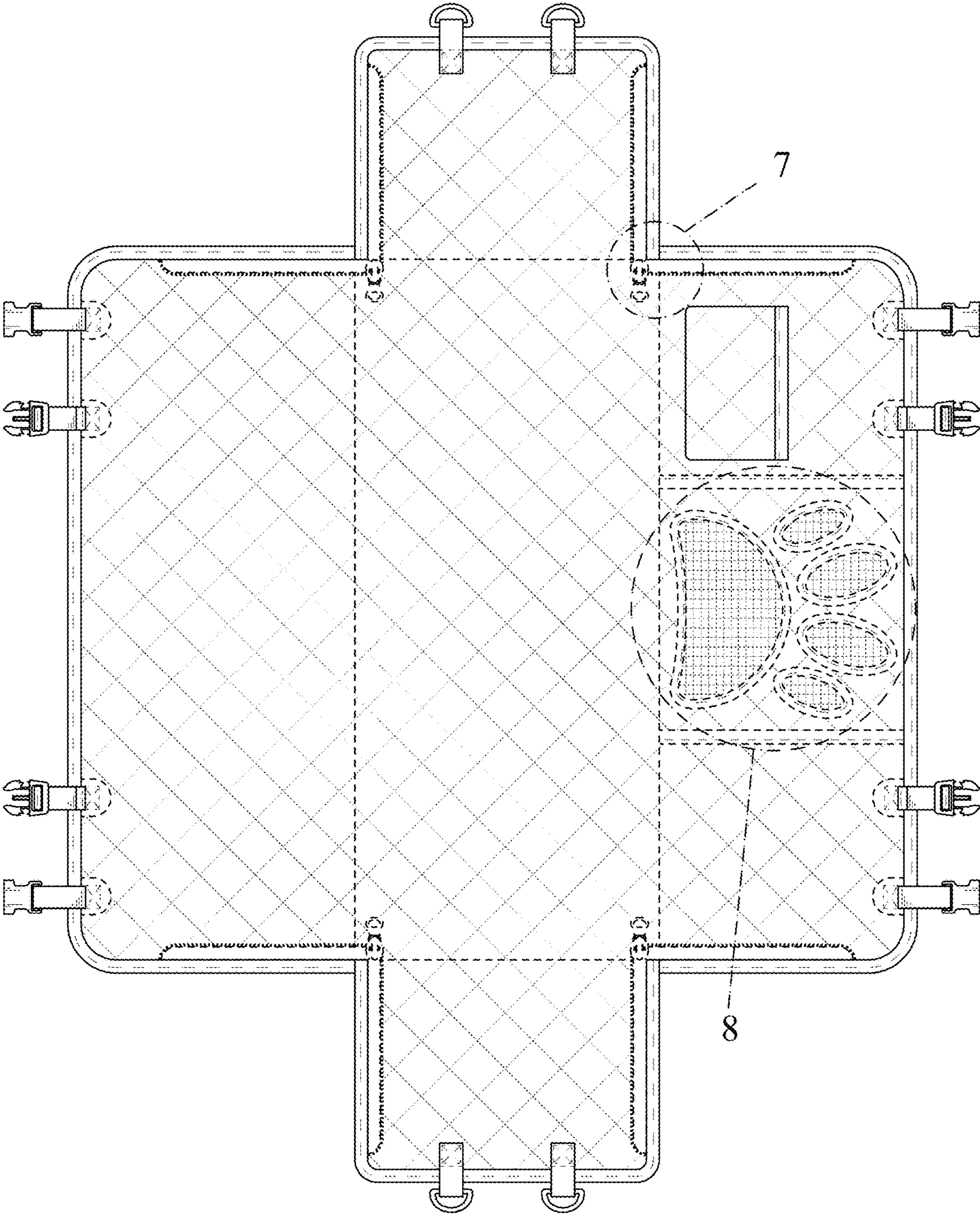

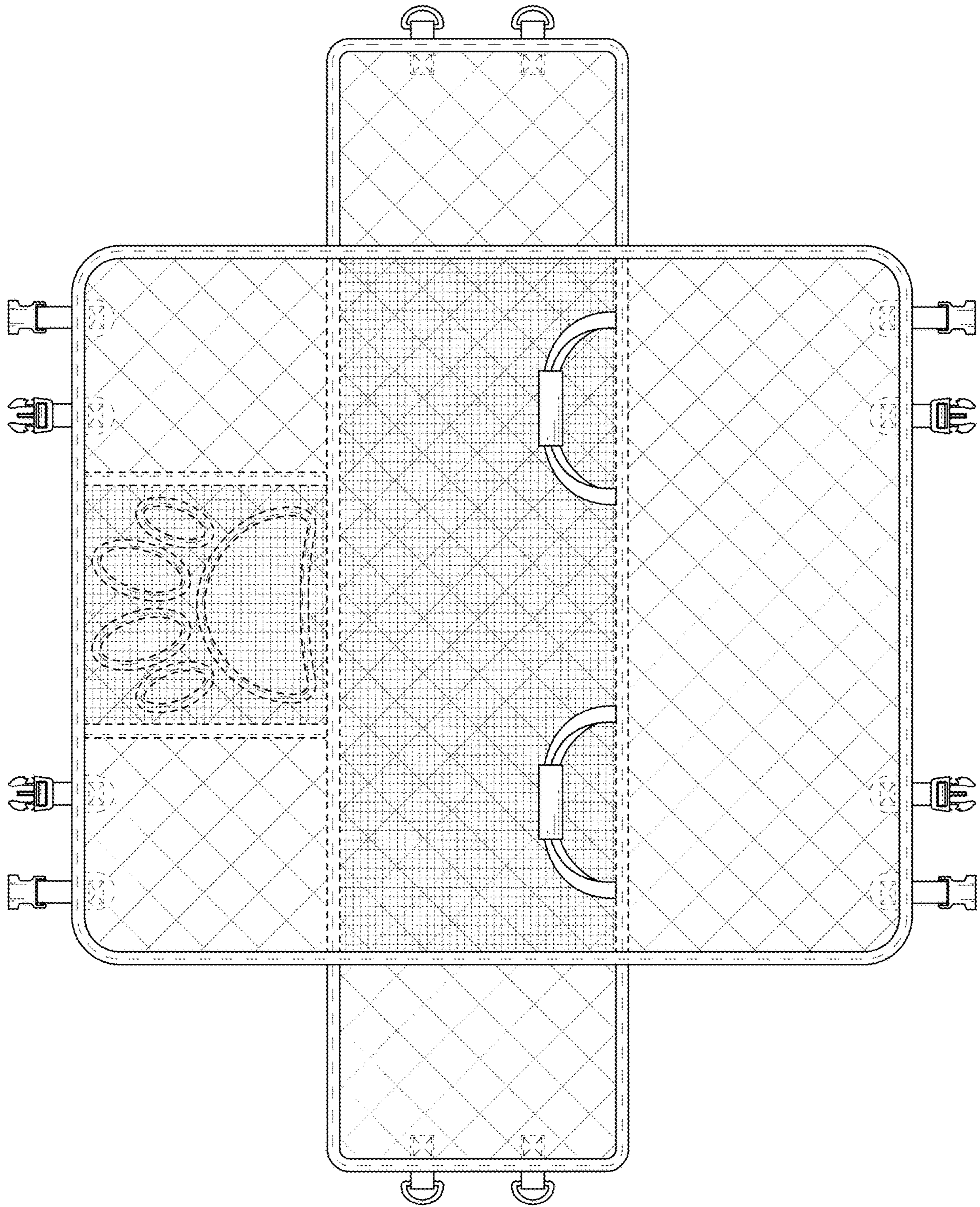

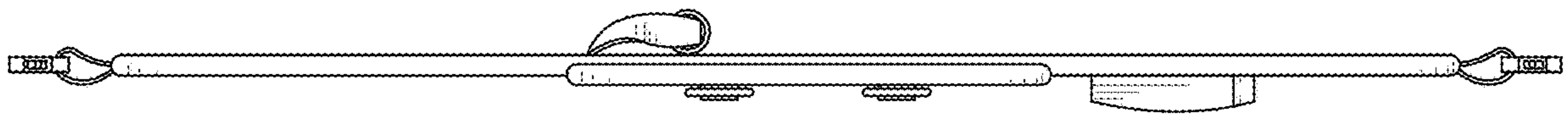

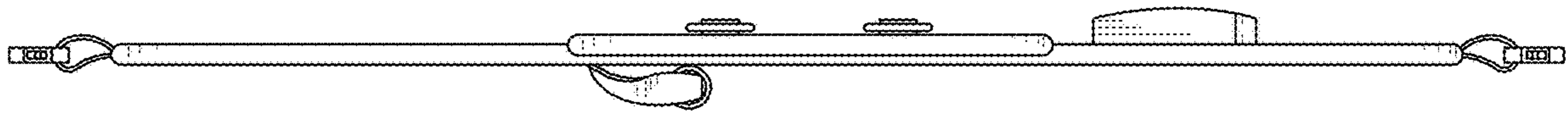

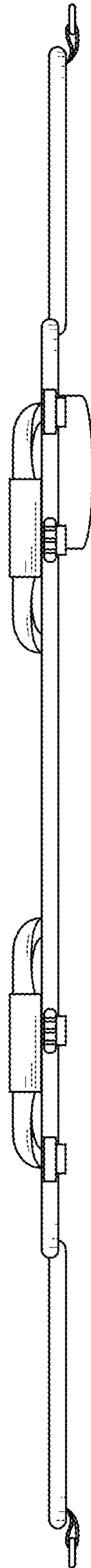

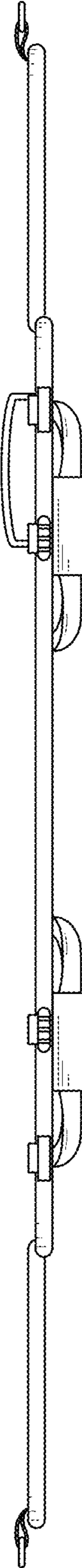

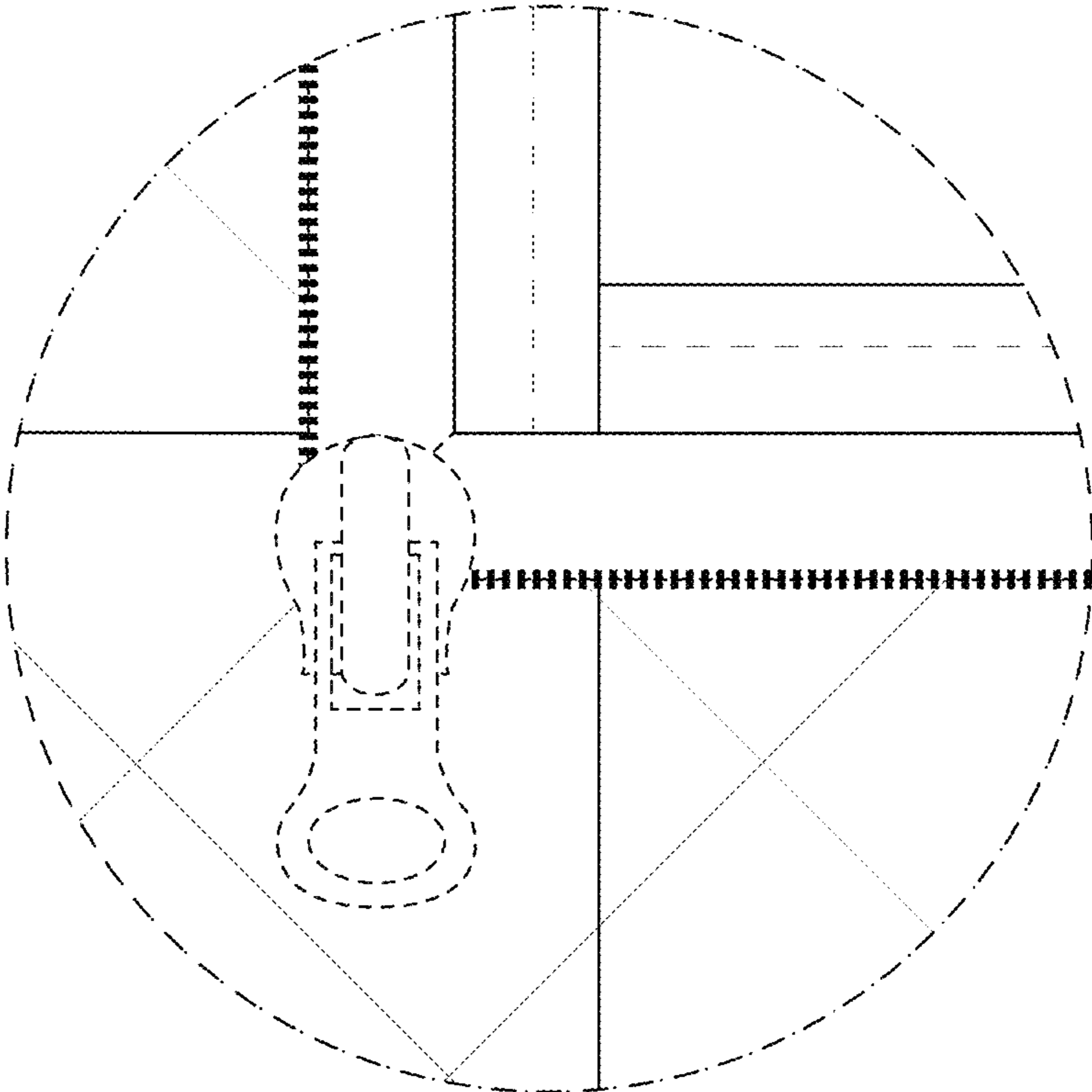

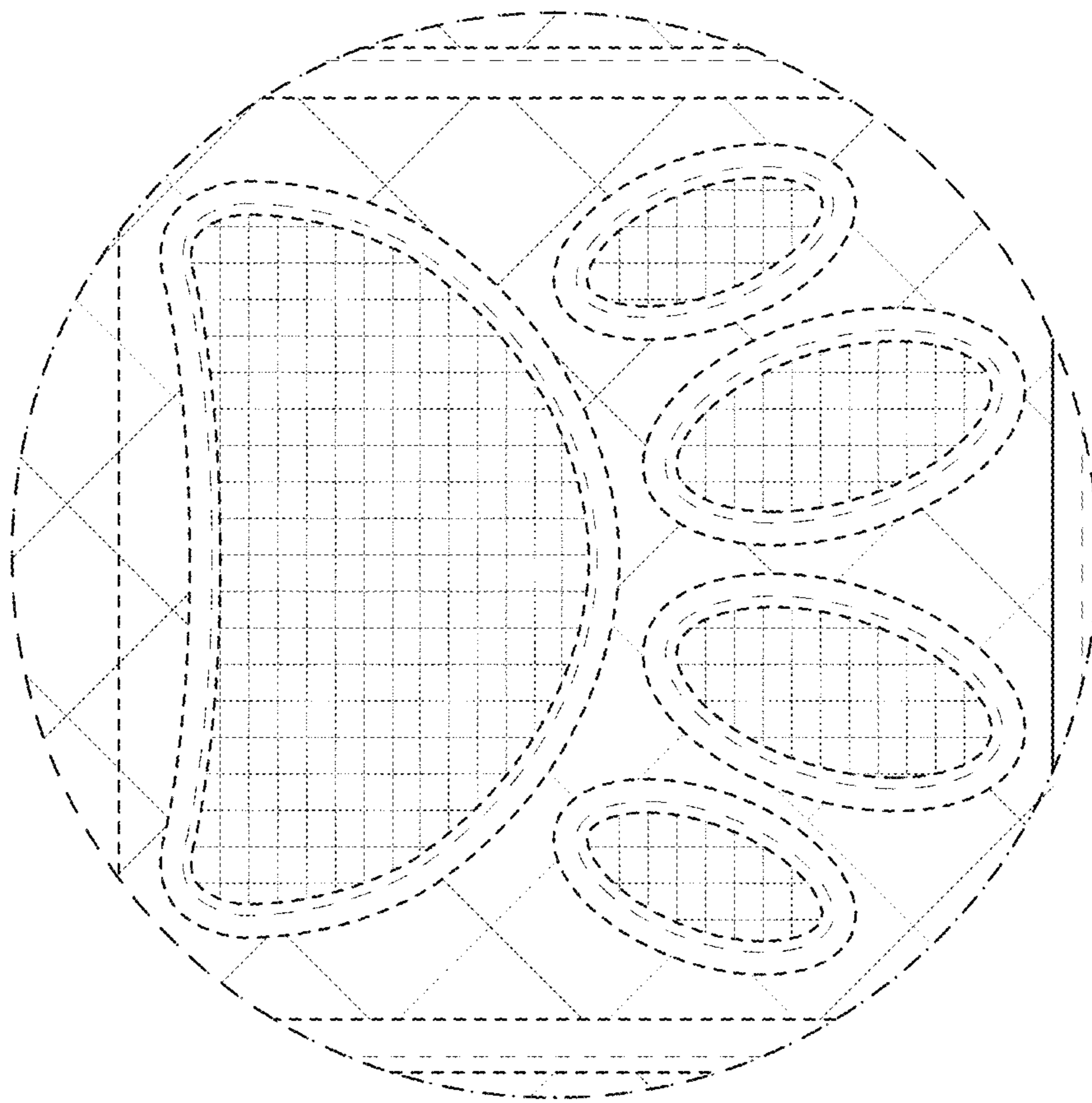
