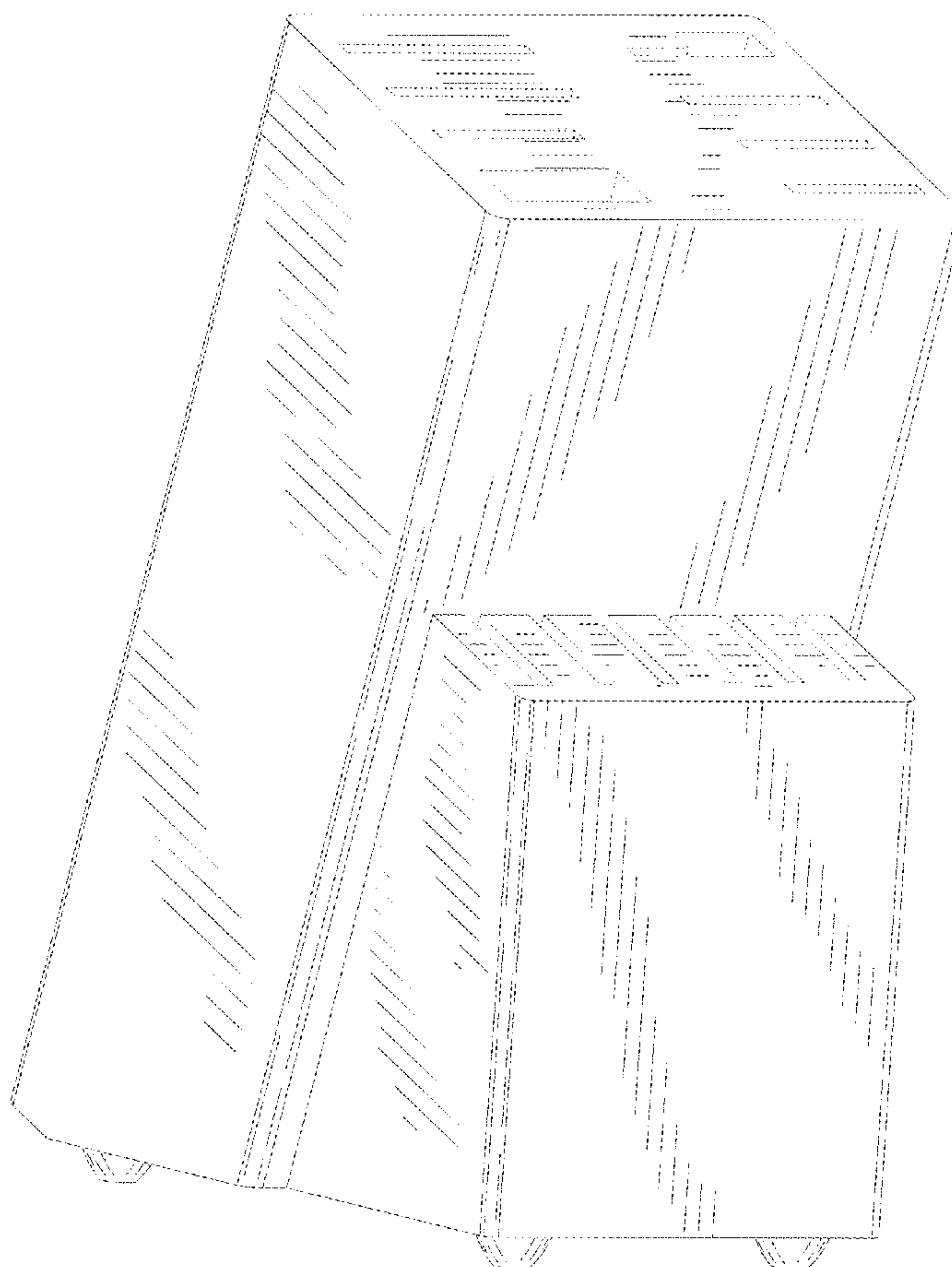
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a knife block showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;

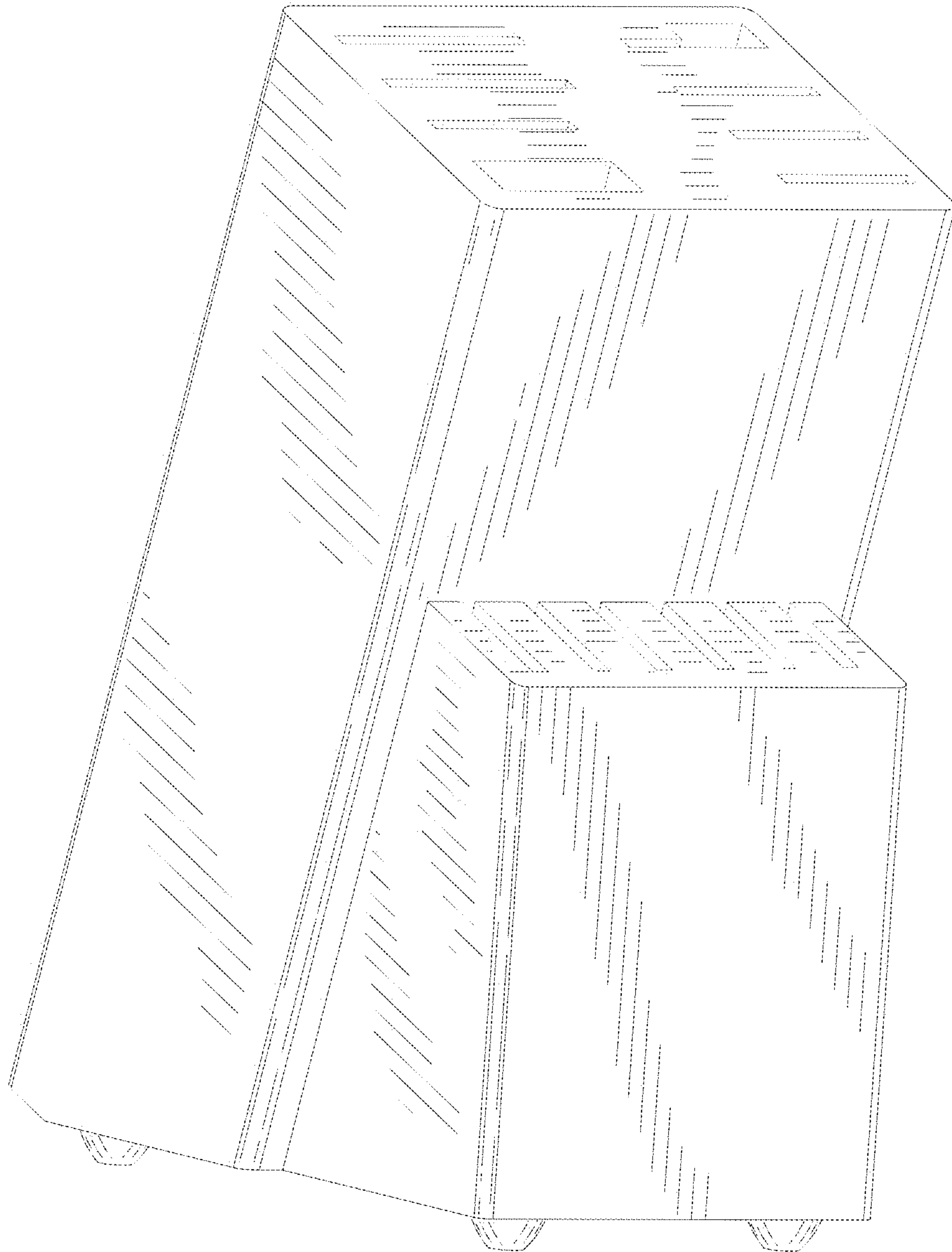

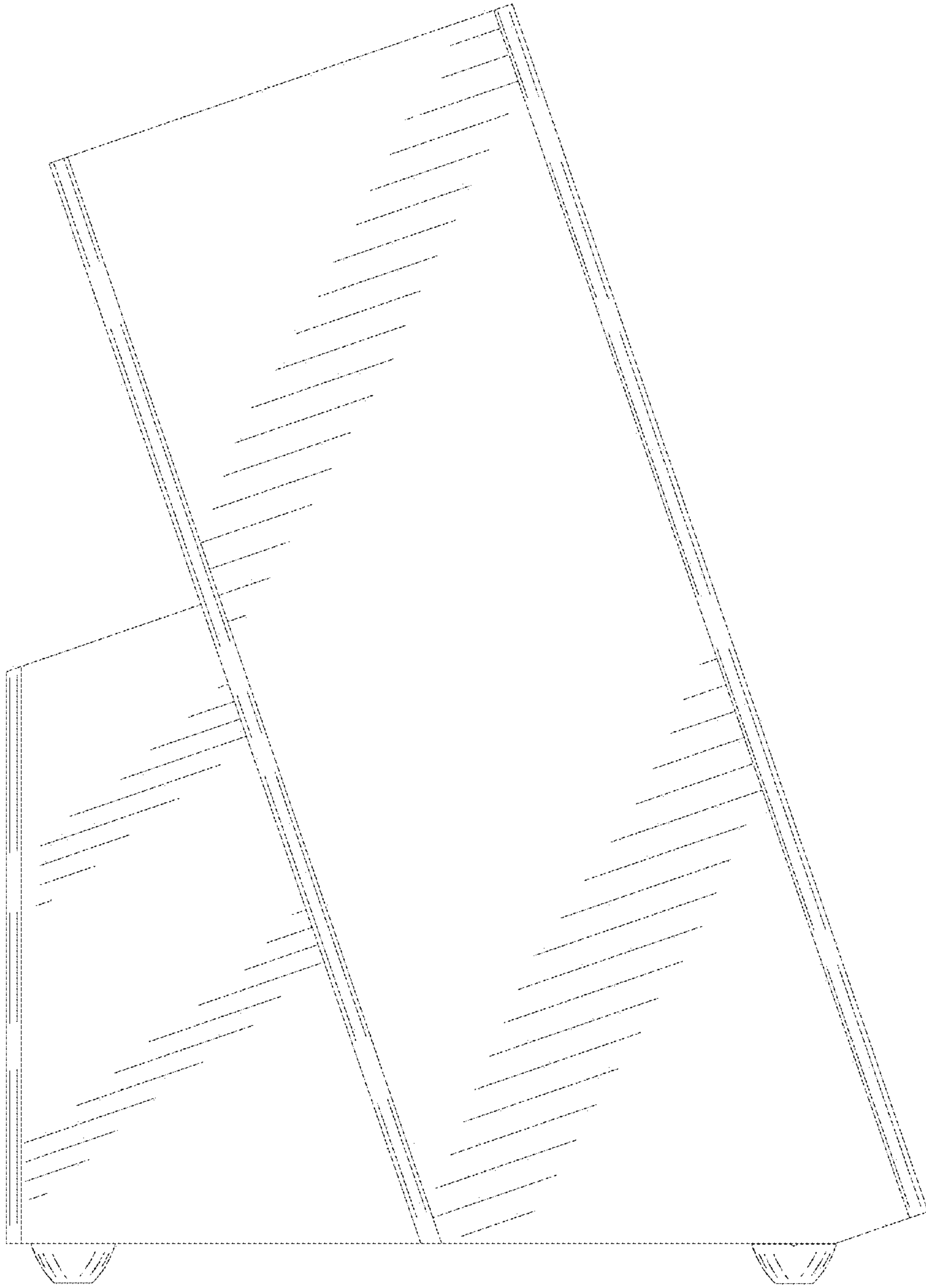

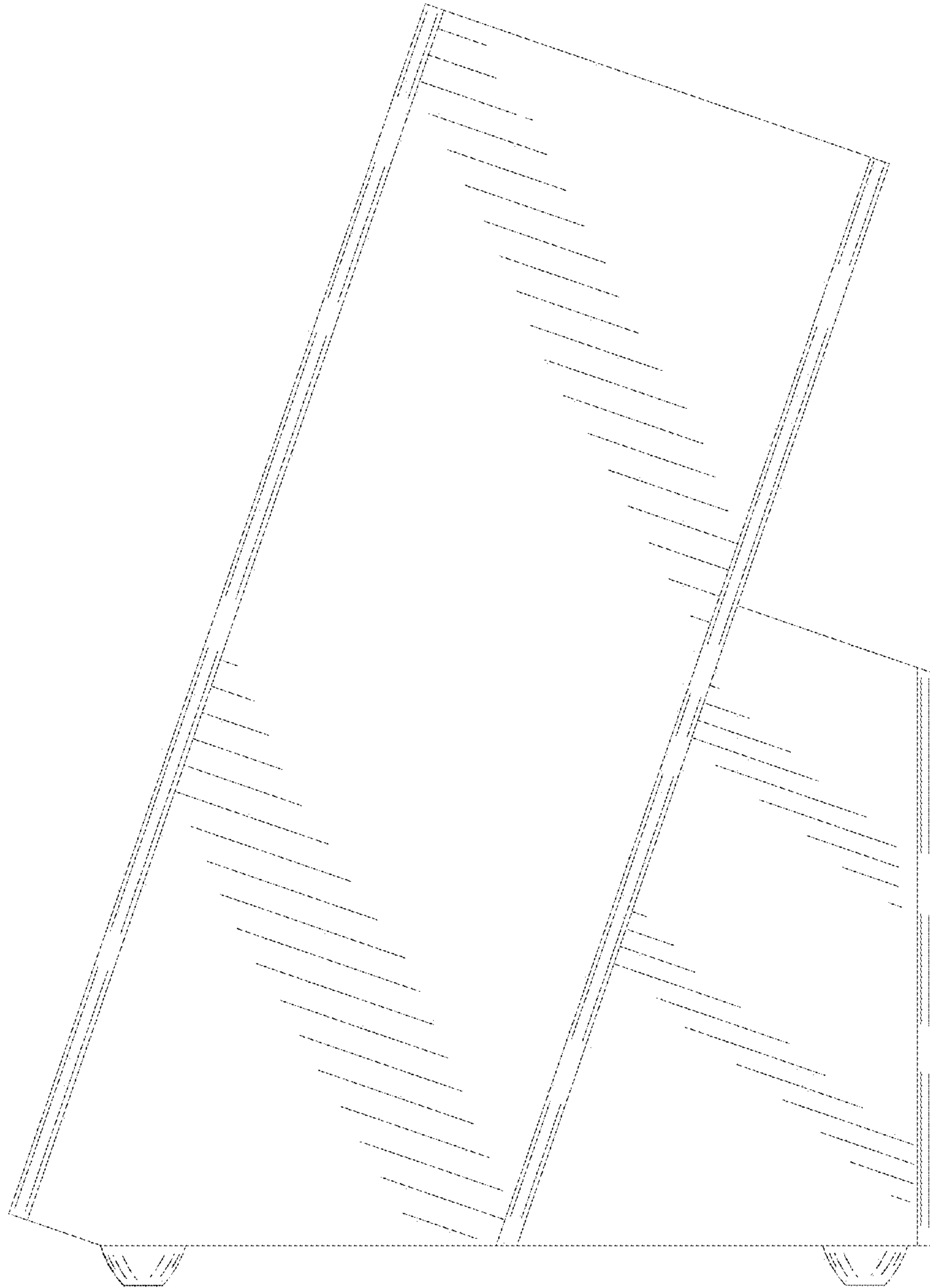

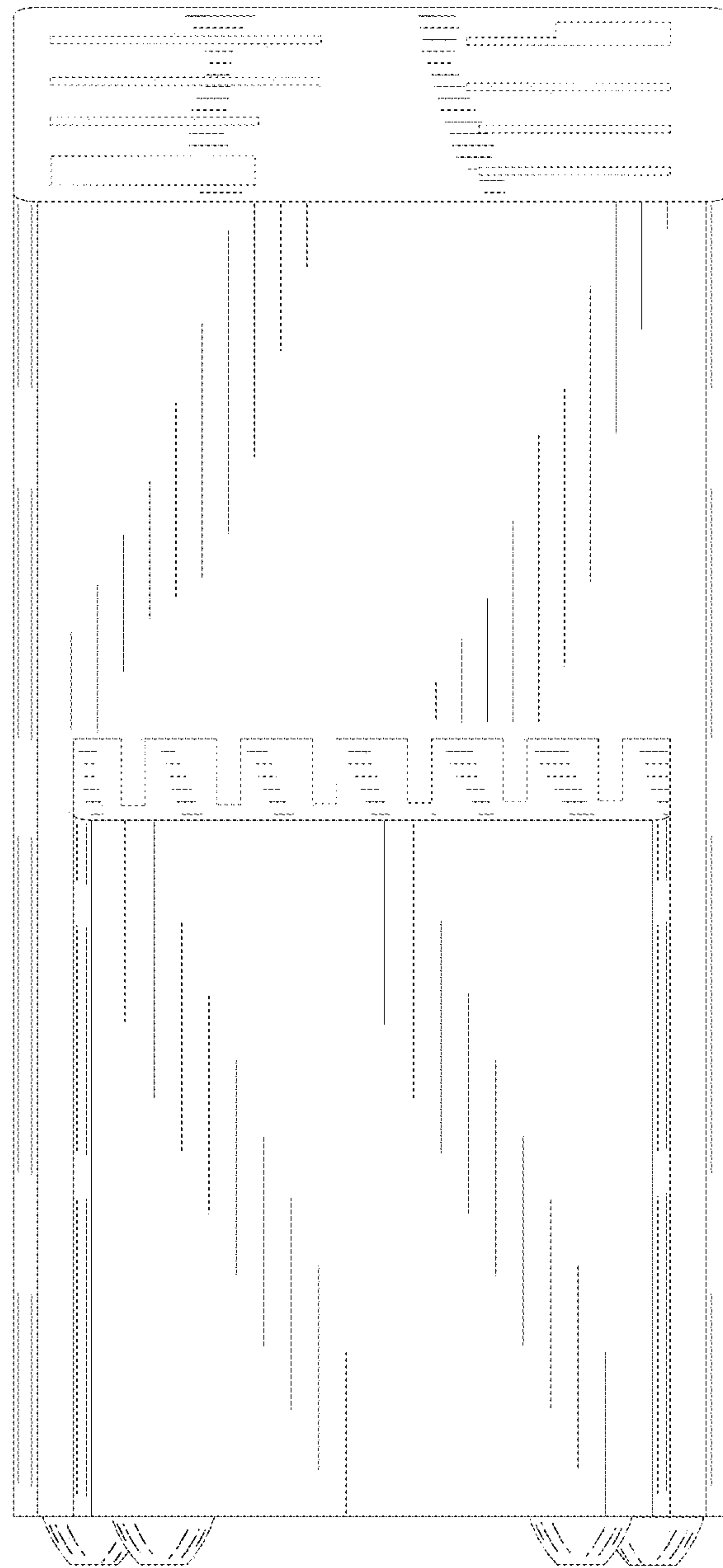

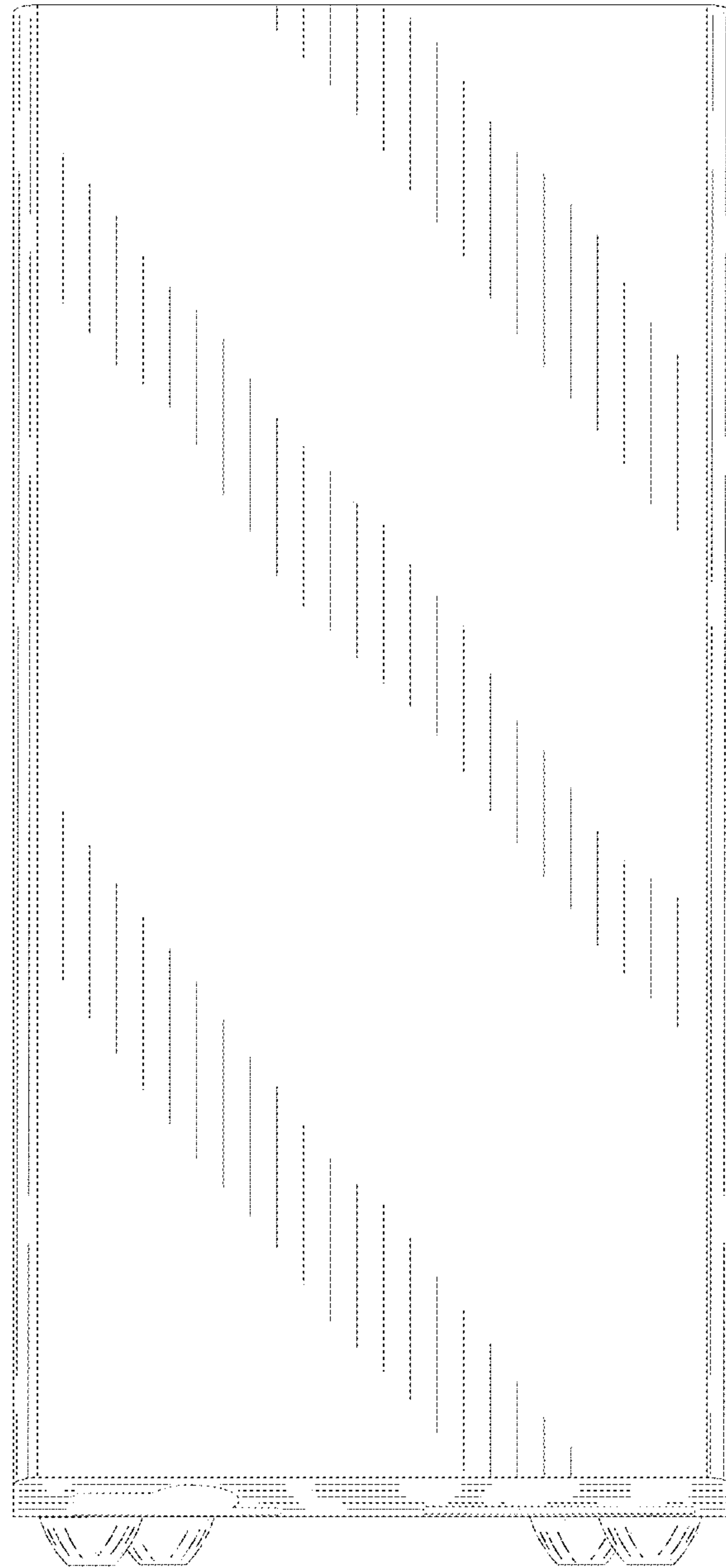

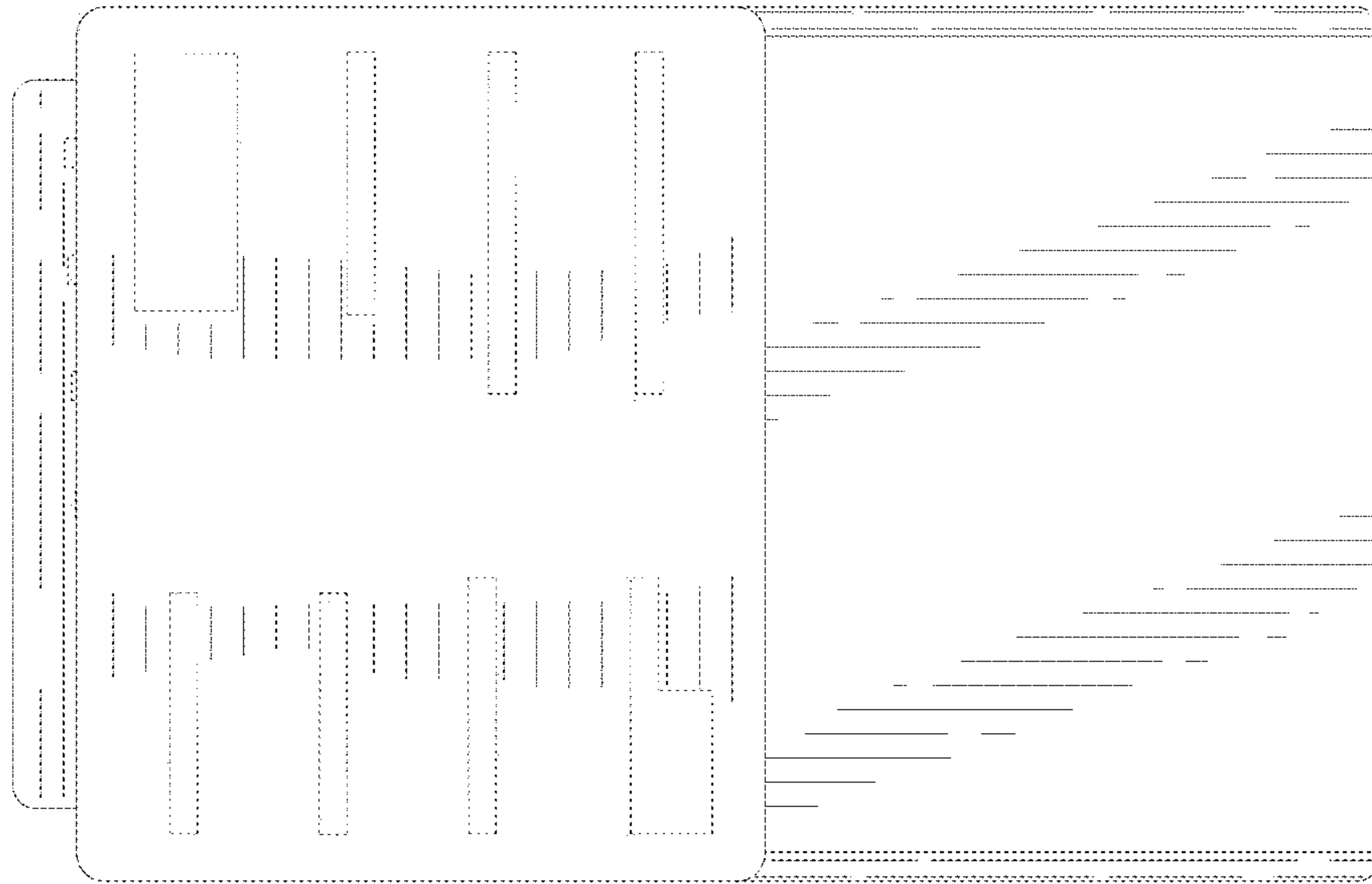

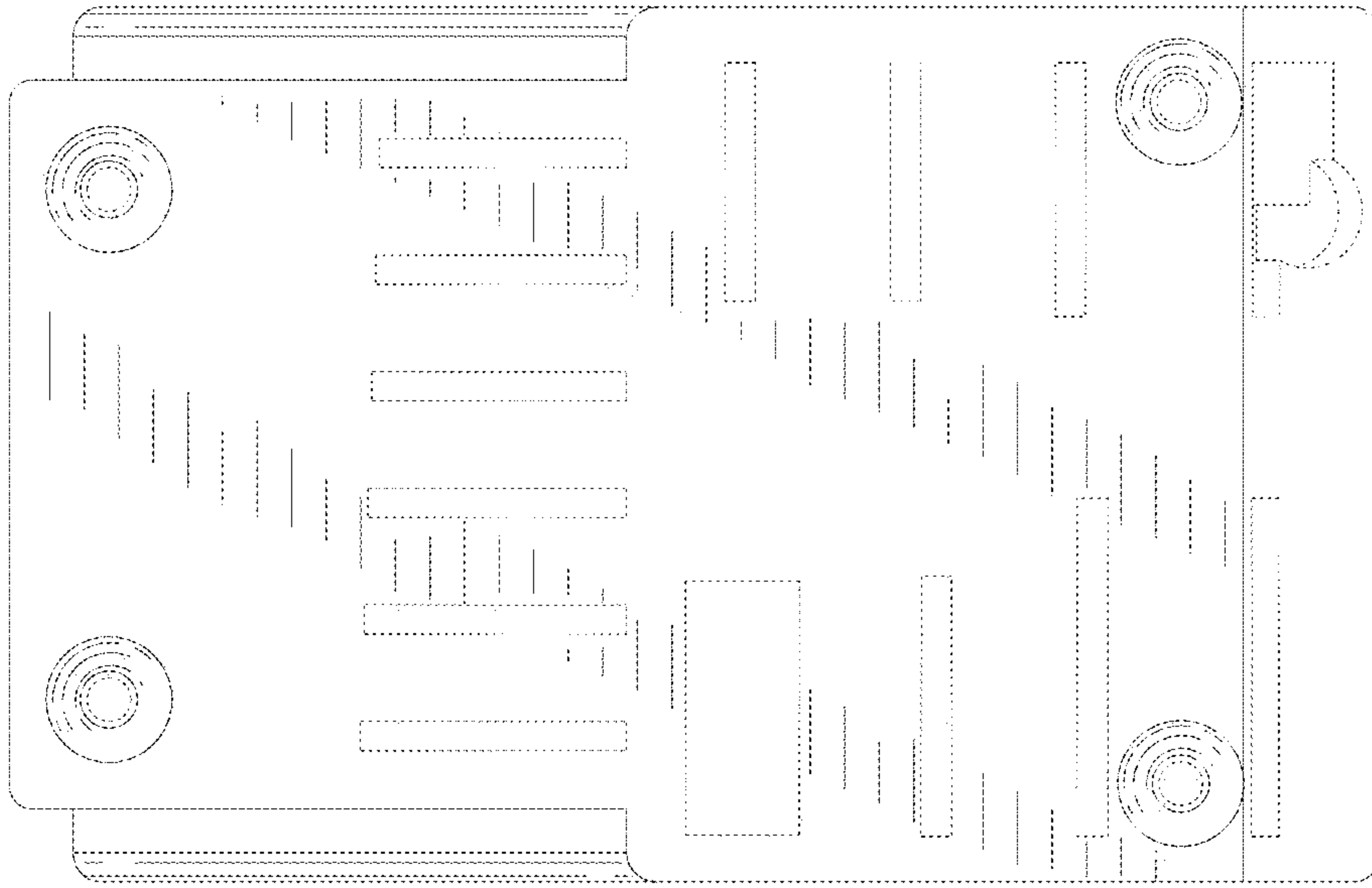
