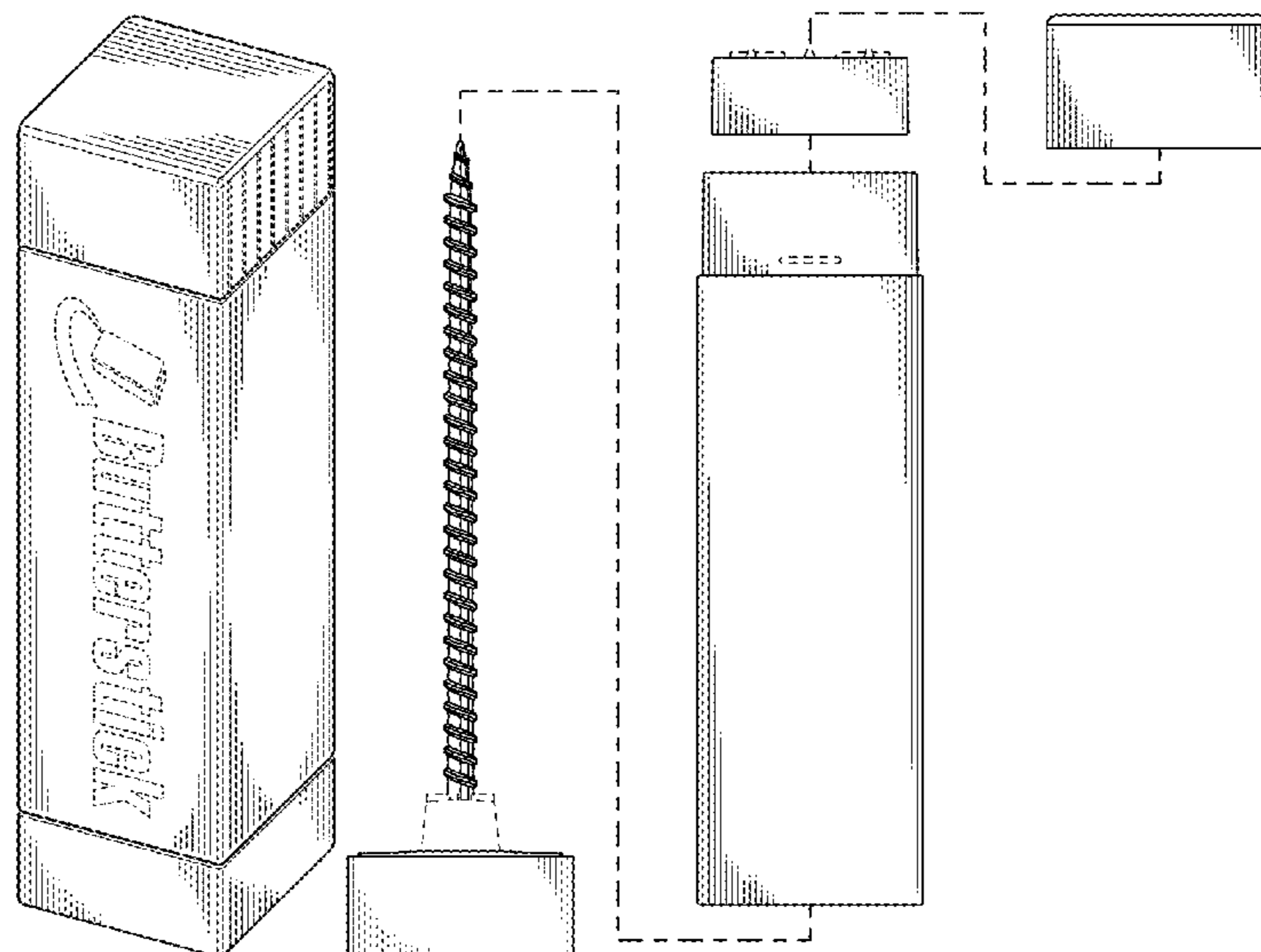
(57) **CLAIM**

I claim the ornamental design for a butter spreader, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a butter spreader showing my new design;
FIG. 2 is a rear side view thereof;
FIG. 3 is a right side view thereof;
FIG. 4 is a left side view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is a cross-sectional view taken in the direction of line 7-7 of FIG. 5;
FIG. 8 is a perspective view of the butter spreader in FIG. 1; and,
FIG. 9 is an exploded view thereof.
The broken lines in the drawings depict portions of the butter spreader that form no part of the claimed design.

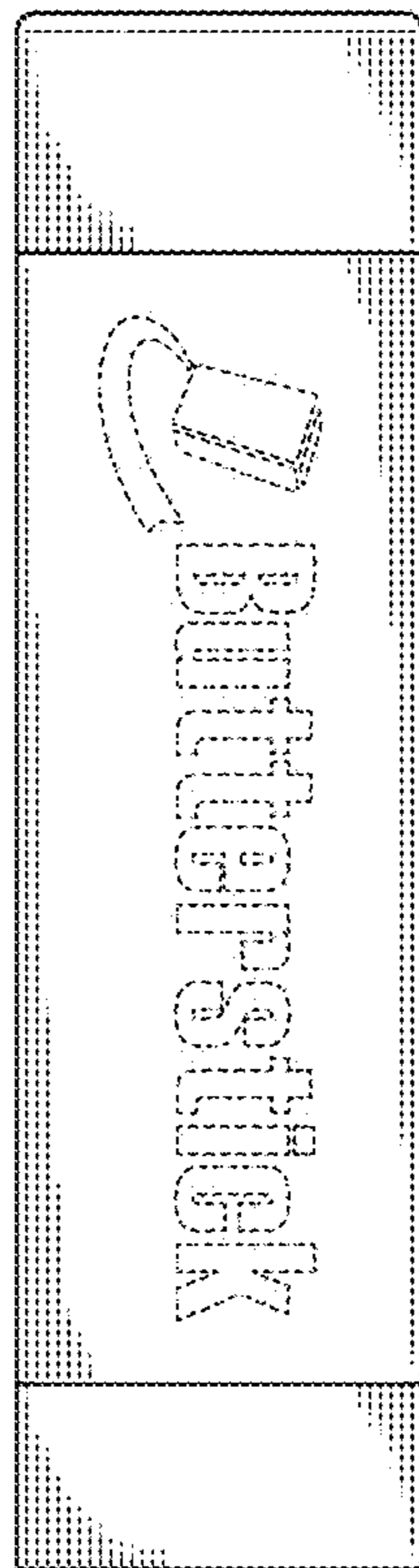

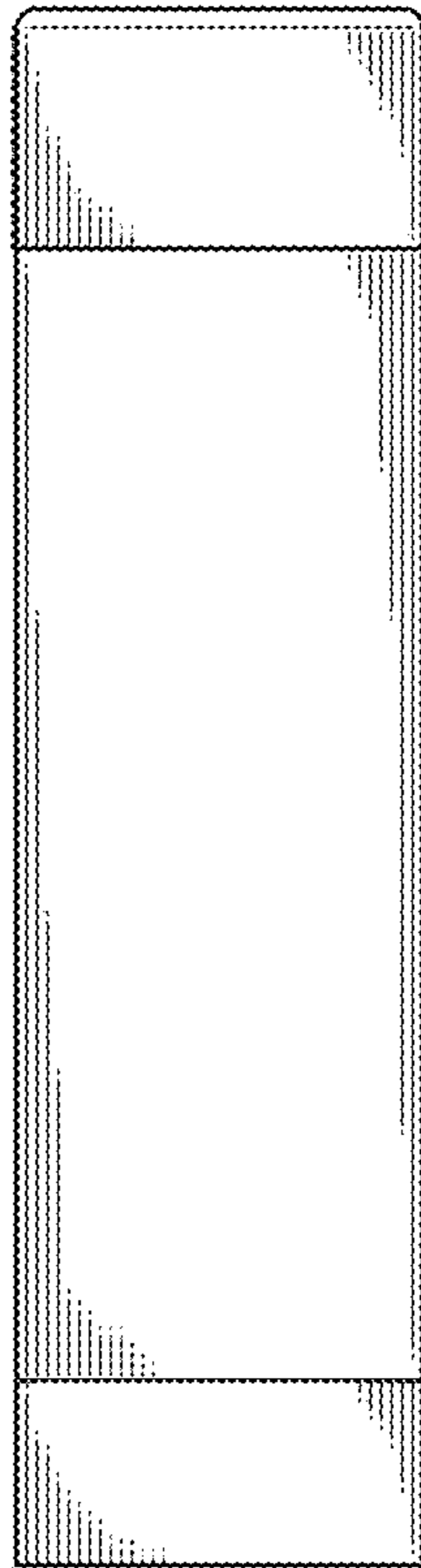

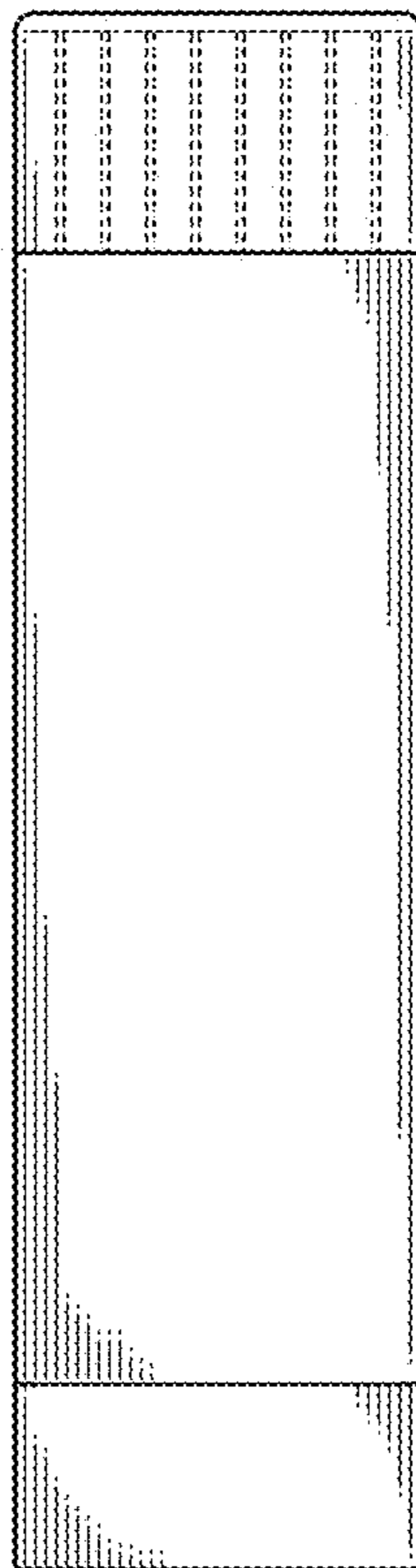

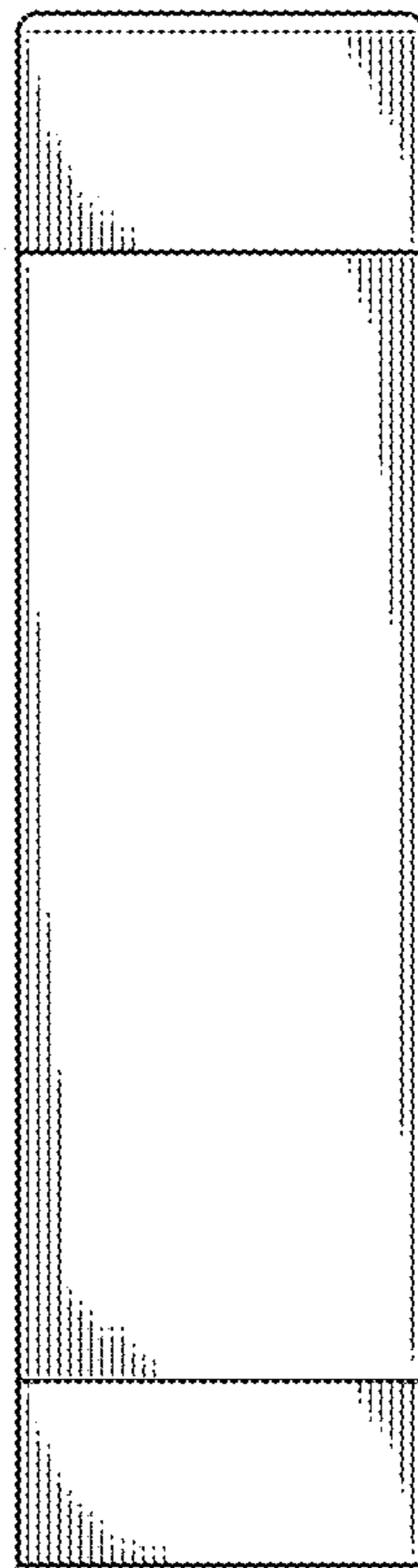
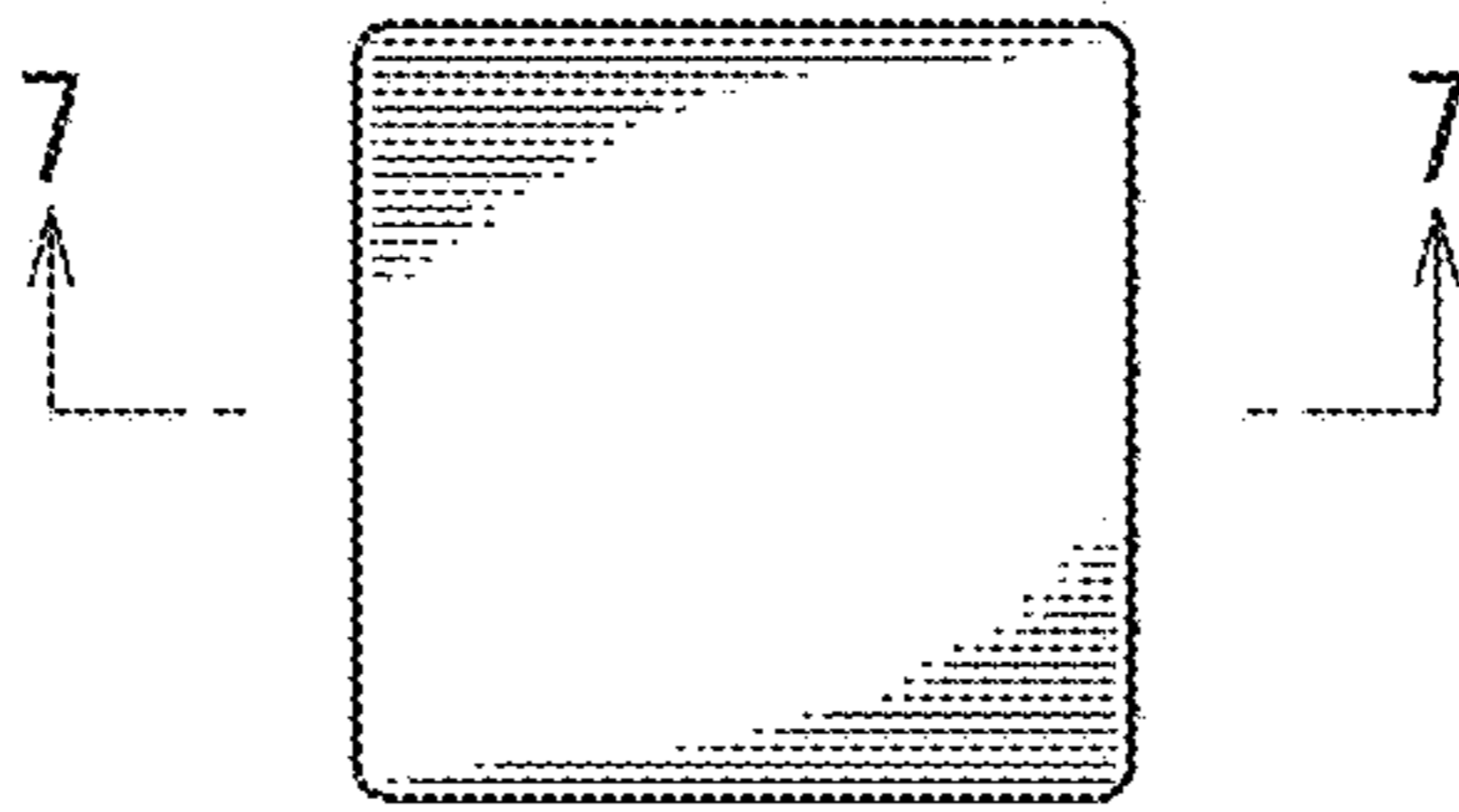

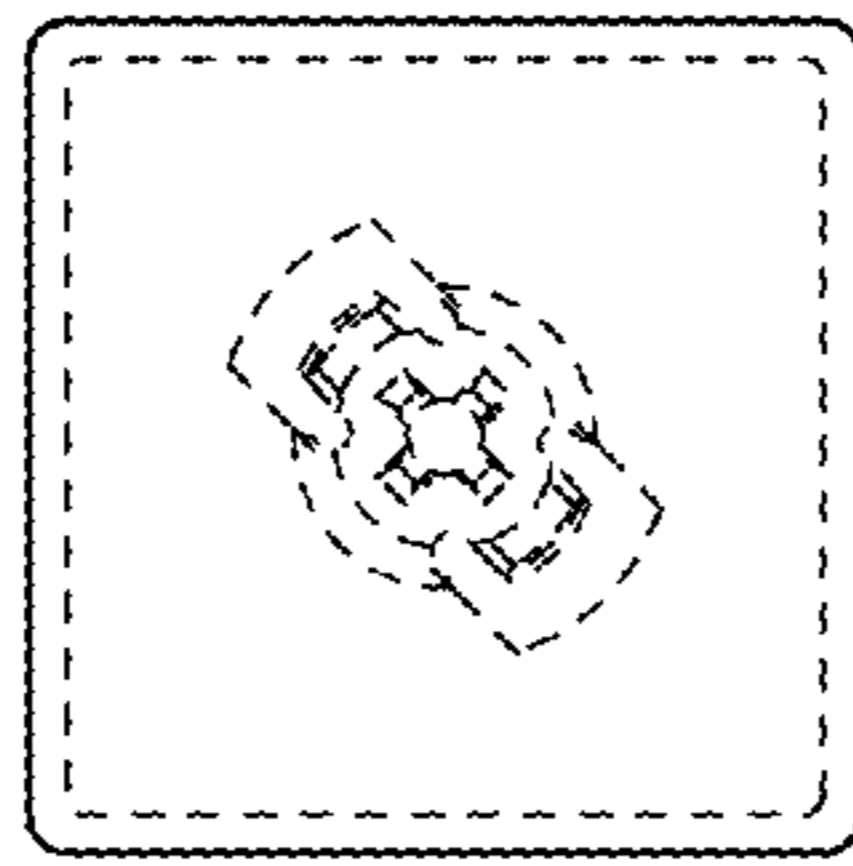

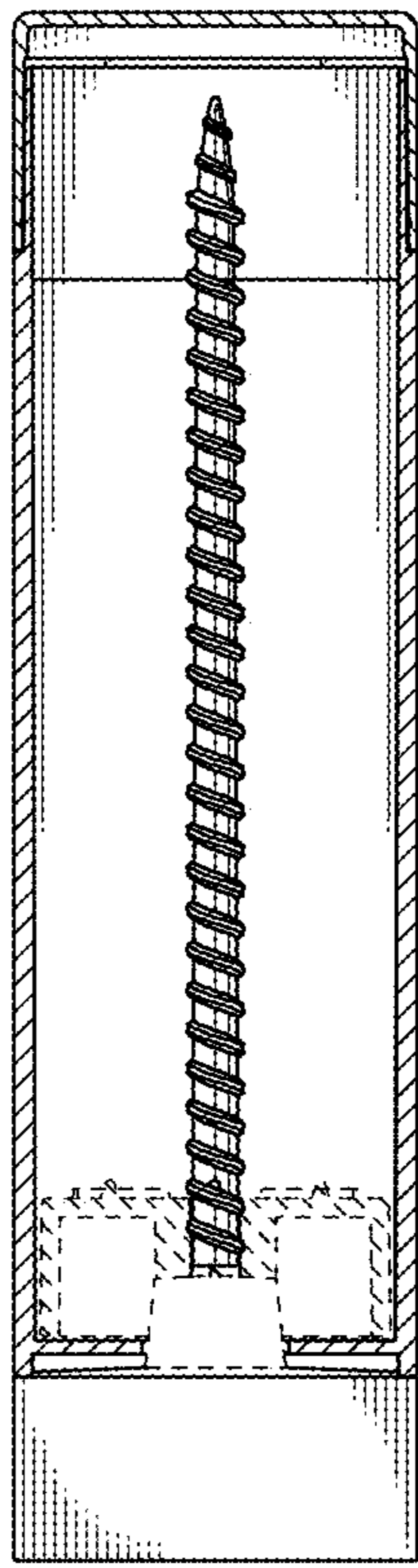
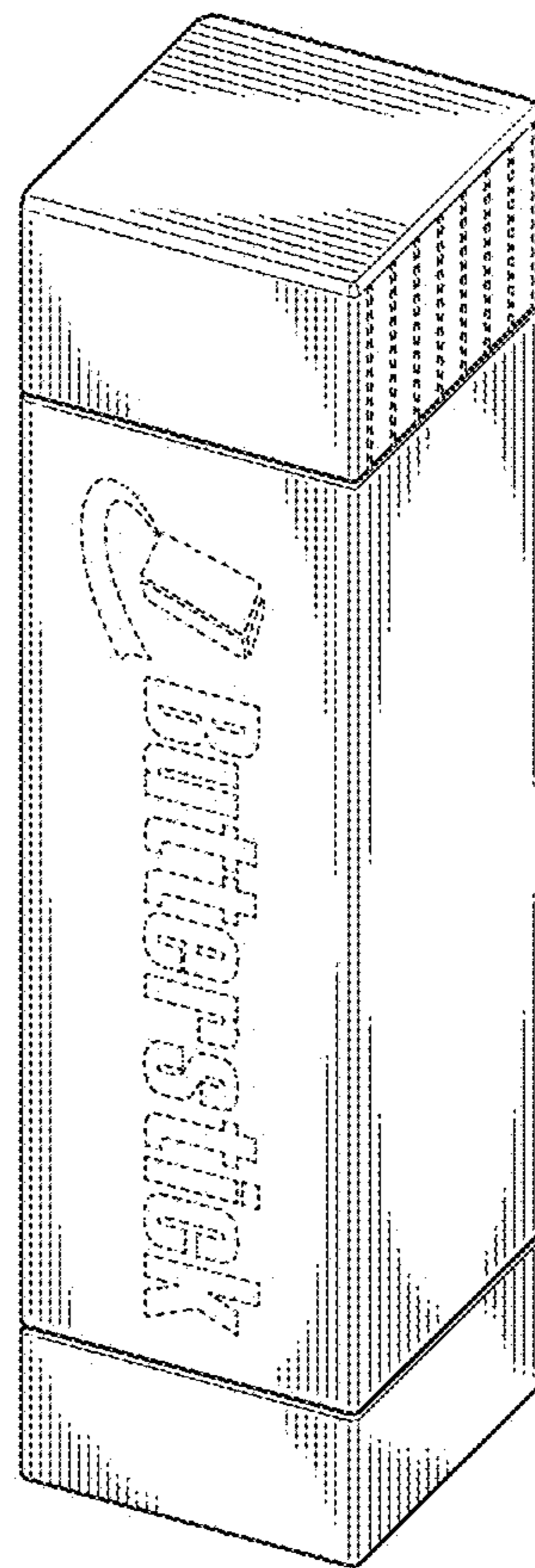

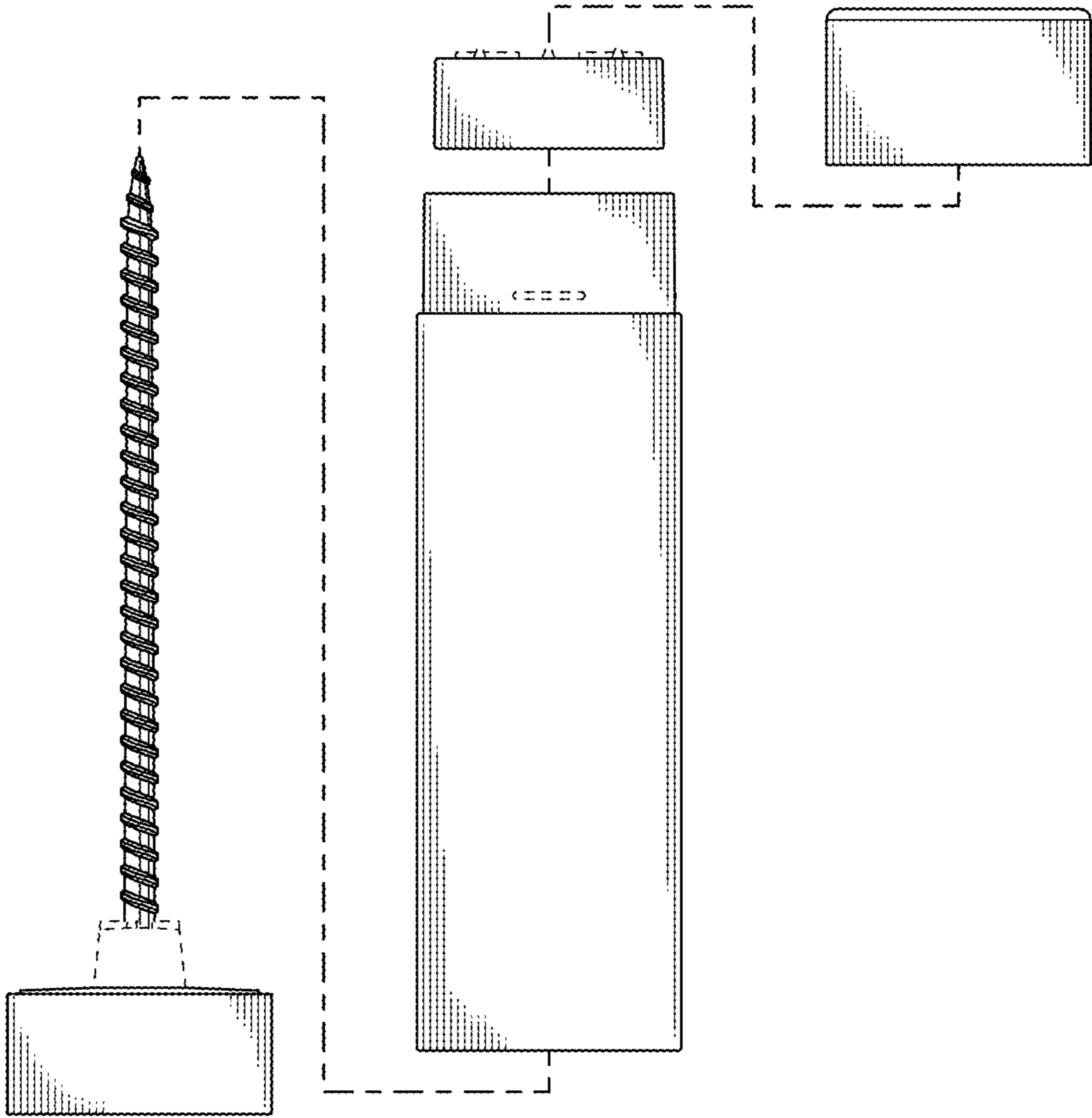
