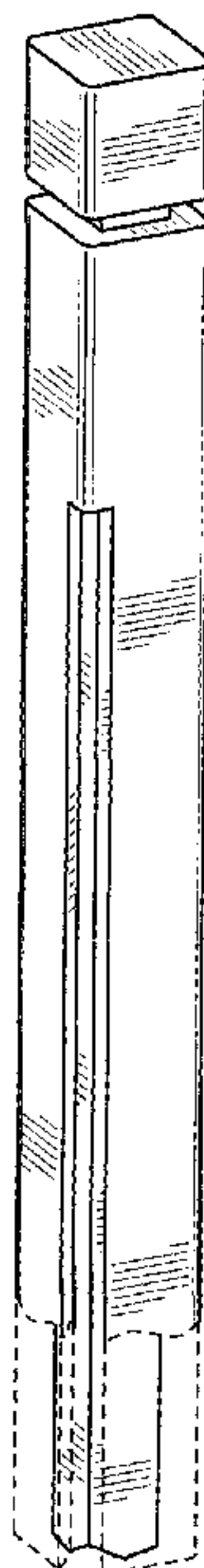

FIG. 1 shows a top and side perspective view of a tent peg driver.
 FIG. 2 shows a reverse bottom and side perspective view thereof.
 FIG. 3 shows a front elevation view thereof.
 FIG. 4 shows a rear elevation view thereof.
 FIG. 5 shows a side elevation view thereof.
 FIG. 6 shows a top plan view thereof.

 FIG. 8 shows a version of FIG. 2 with disclaimed tent peg to show an environment where the tent peg driver is used. The dotted lined regions show the environment around the condenser unit and form no part of the claimed design.

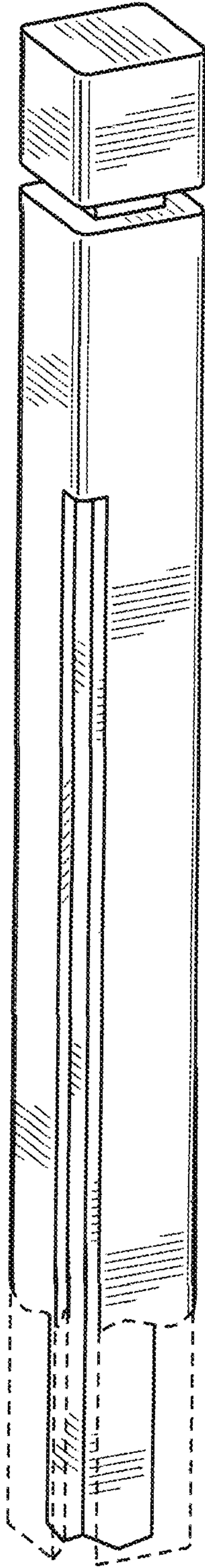

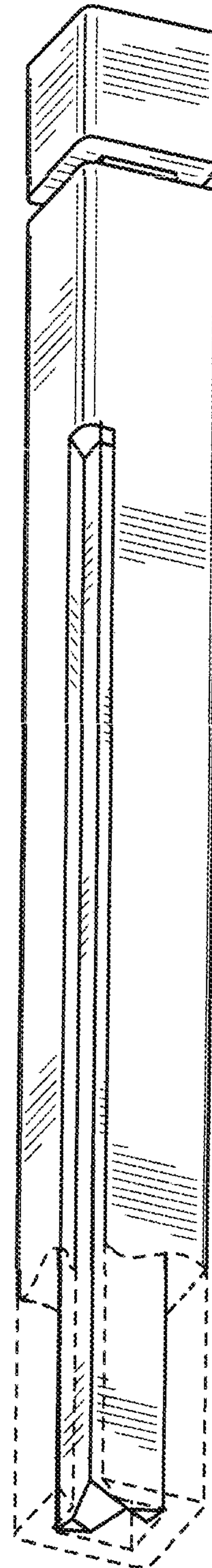

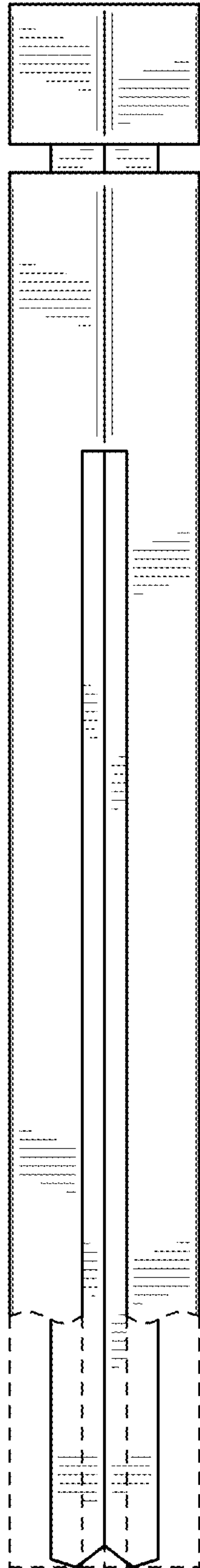

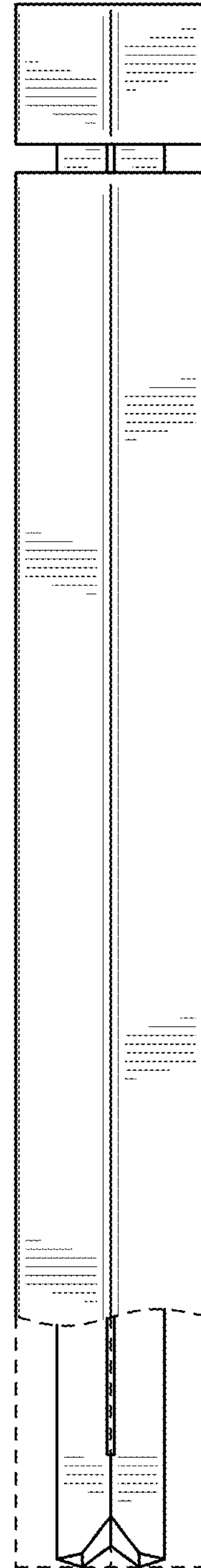

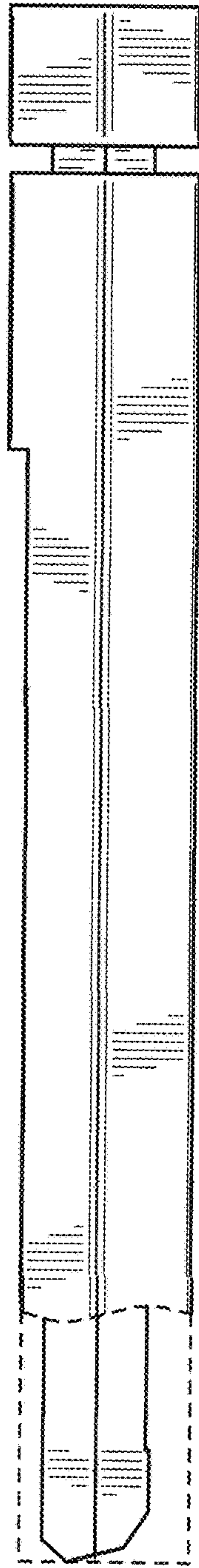

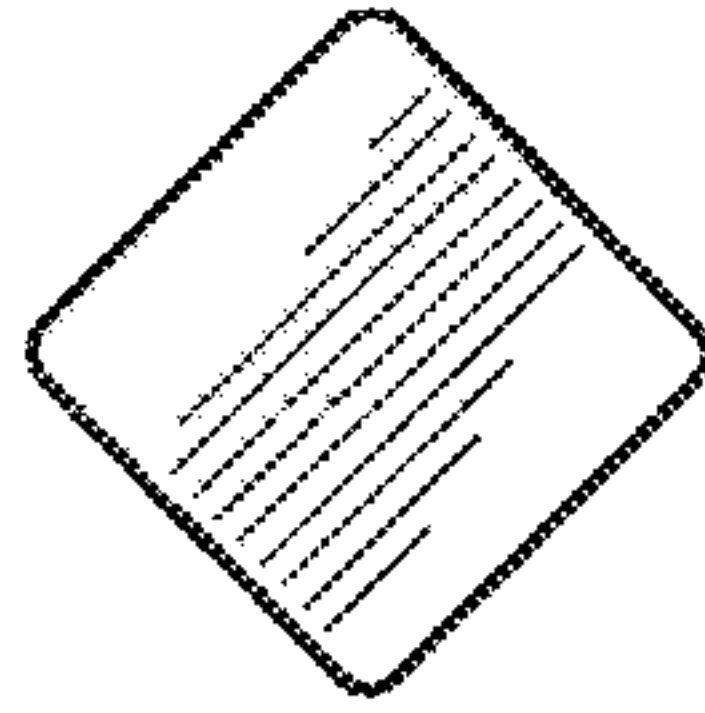

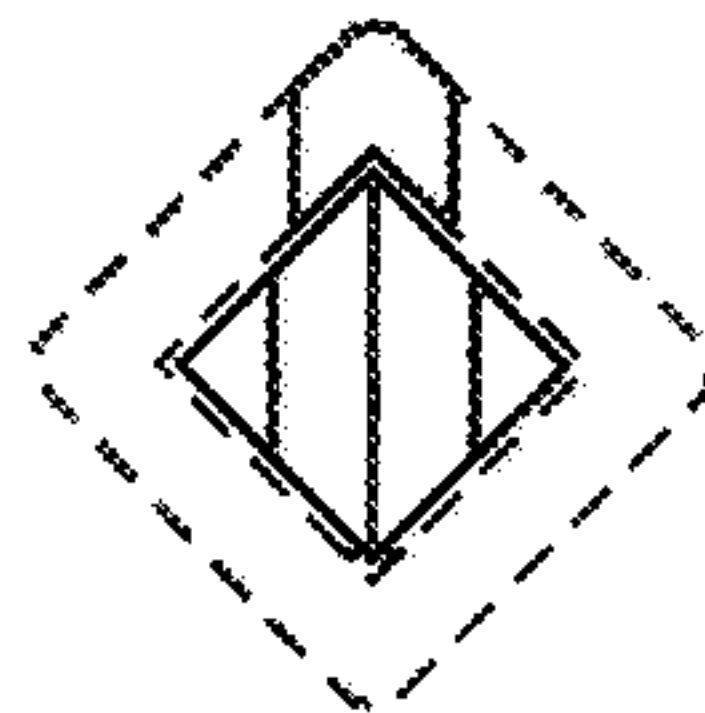

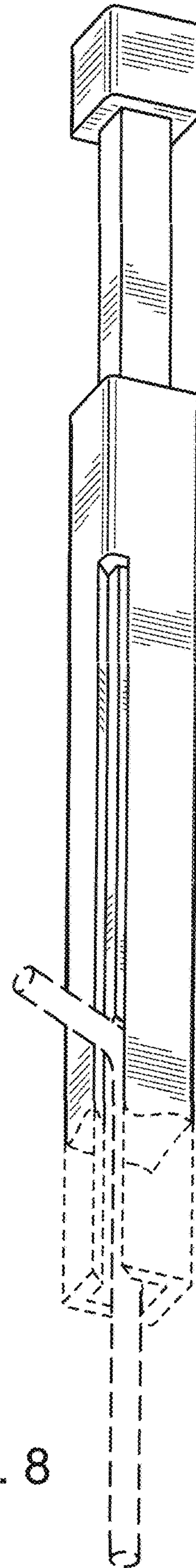
