FIG. 10 is a front view of the embodiment of the package shown in FIG. 8;

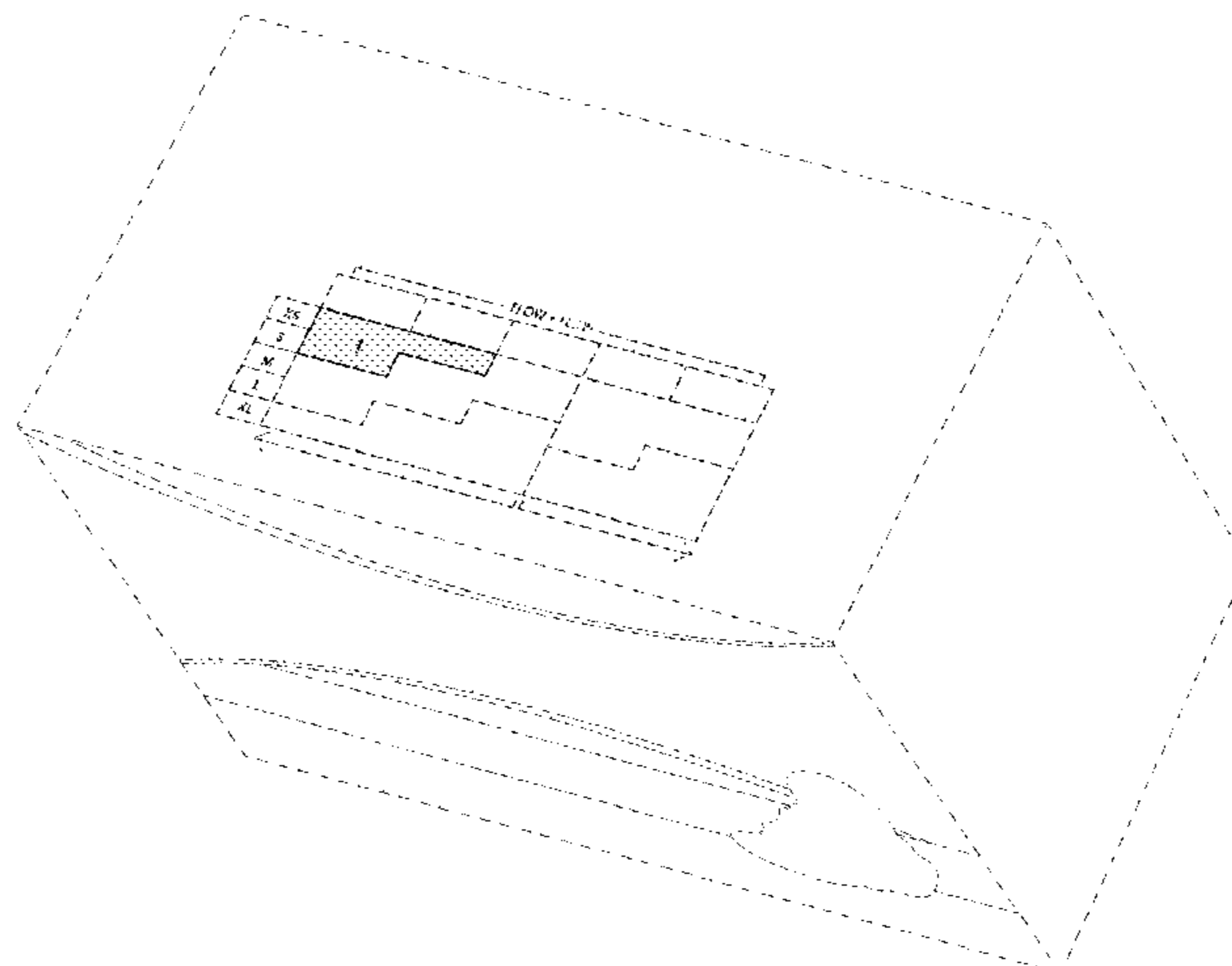
FIG. 11 is a bottom view of the embodiment of the package shown in FIG. 8;

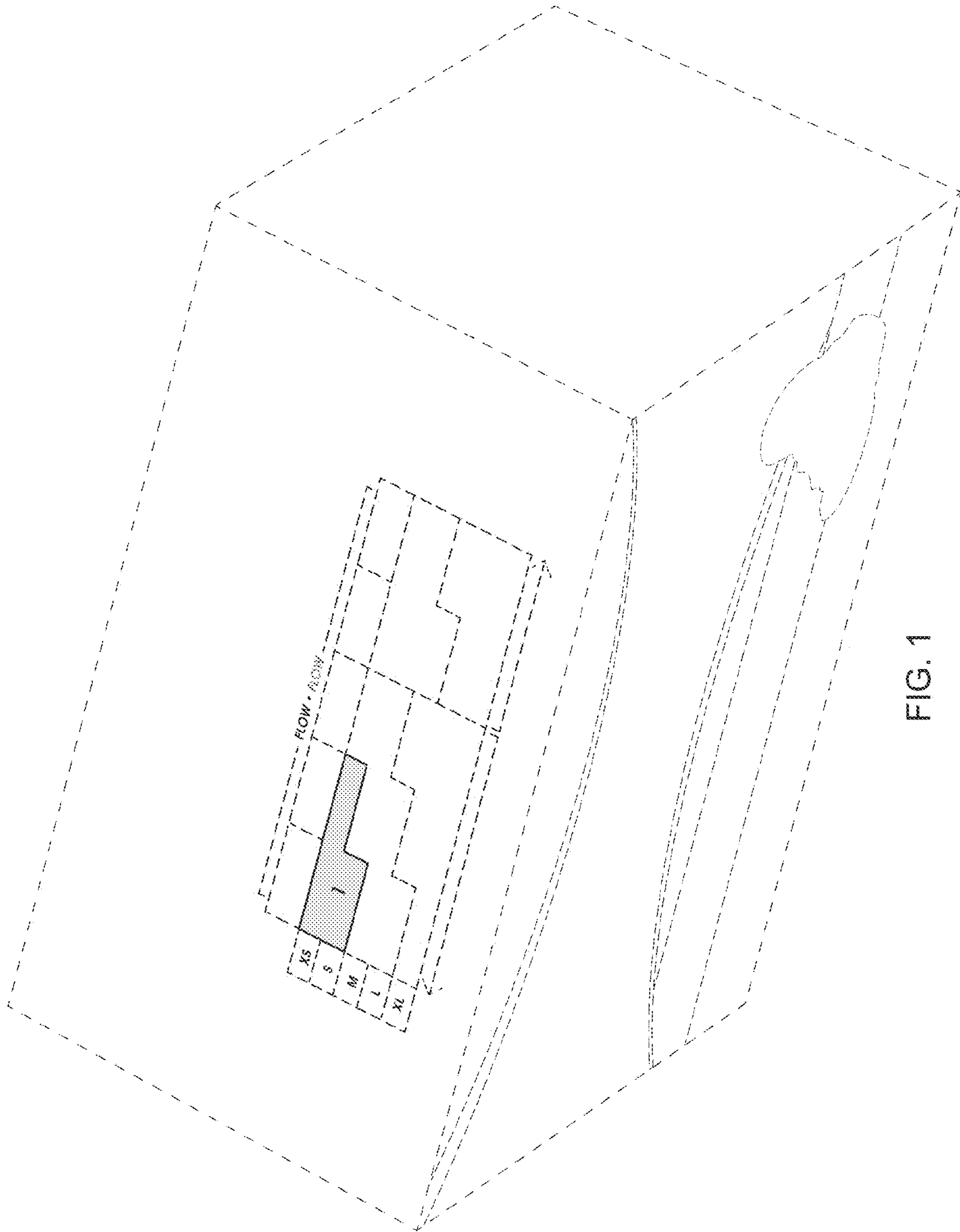

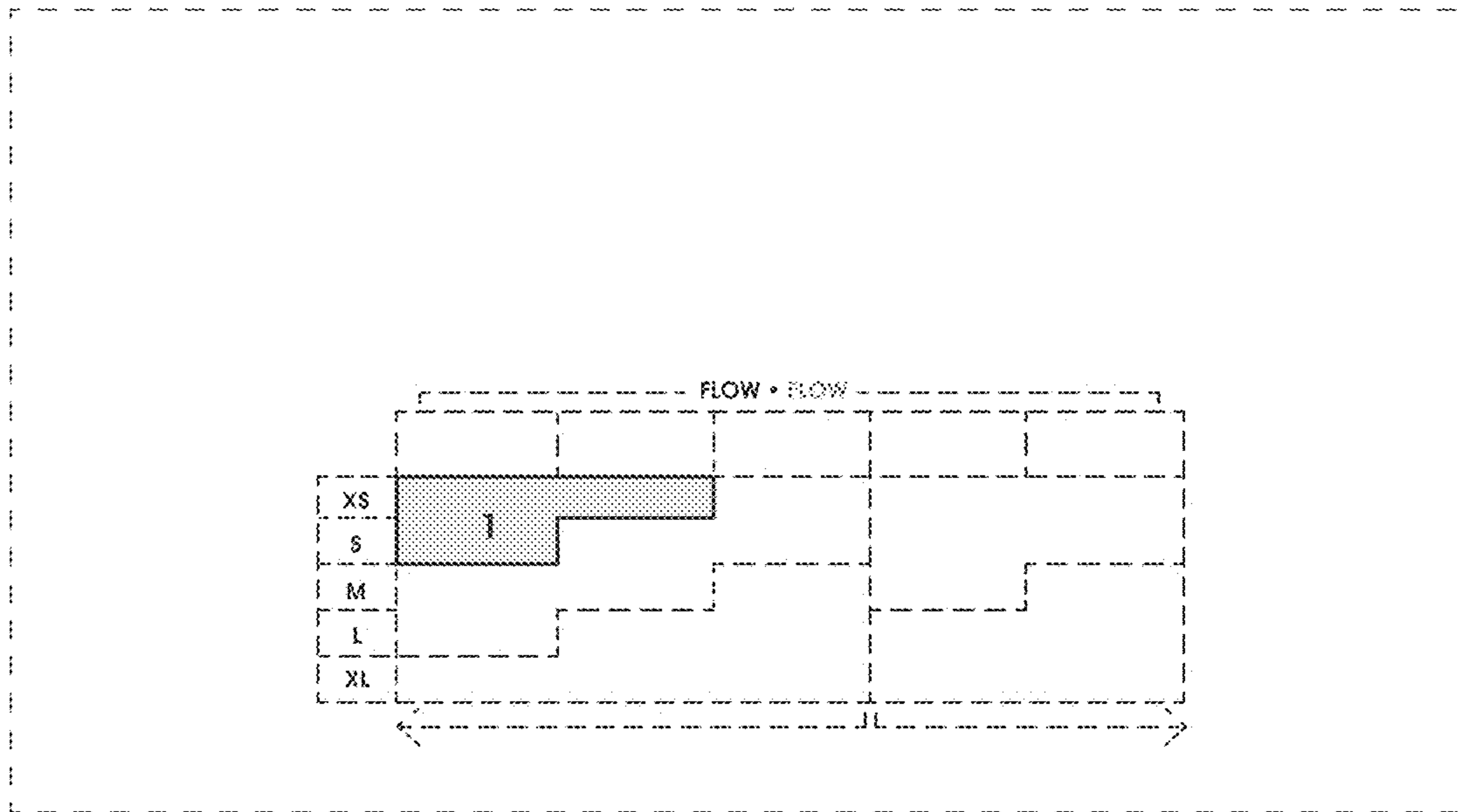

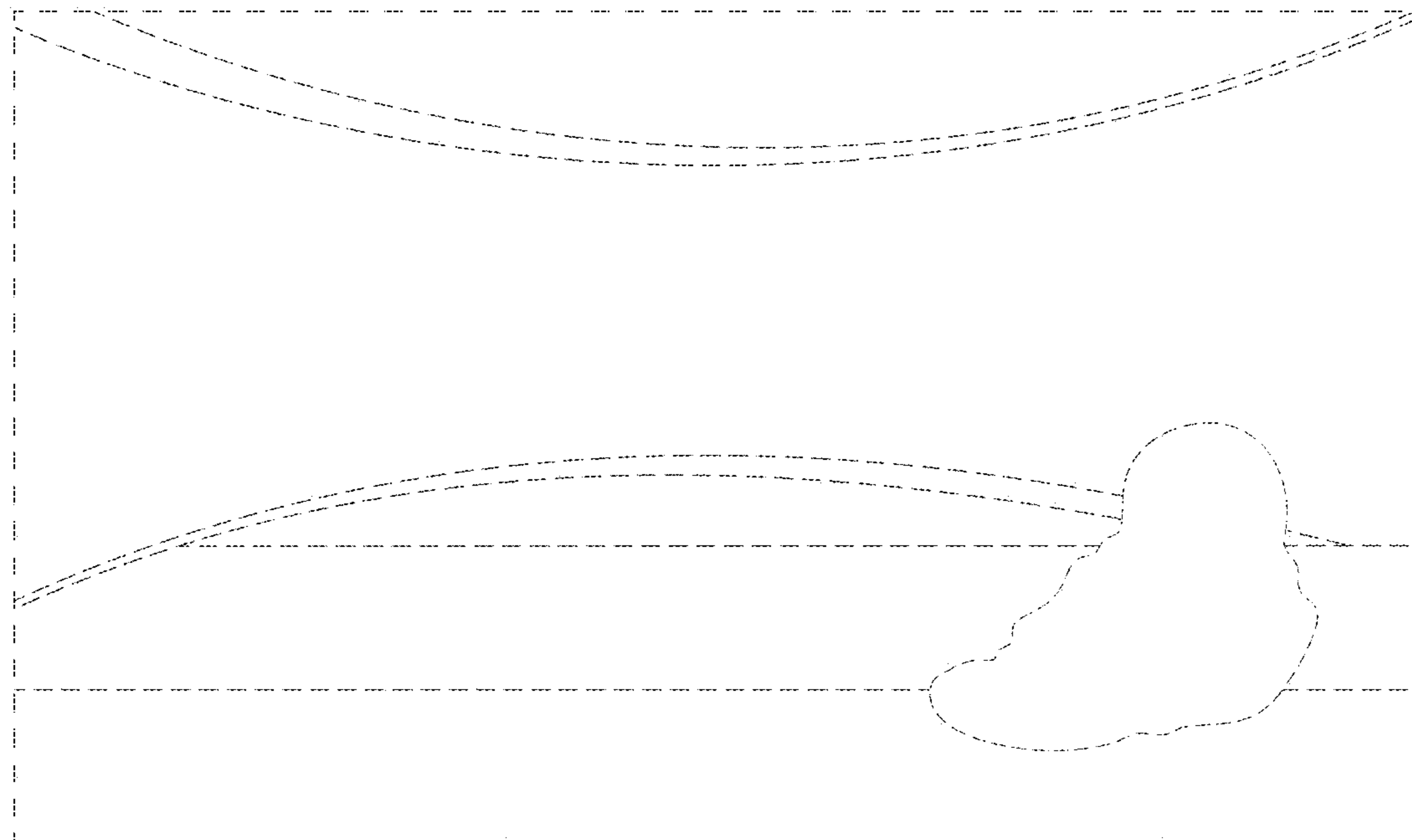

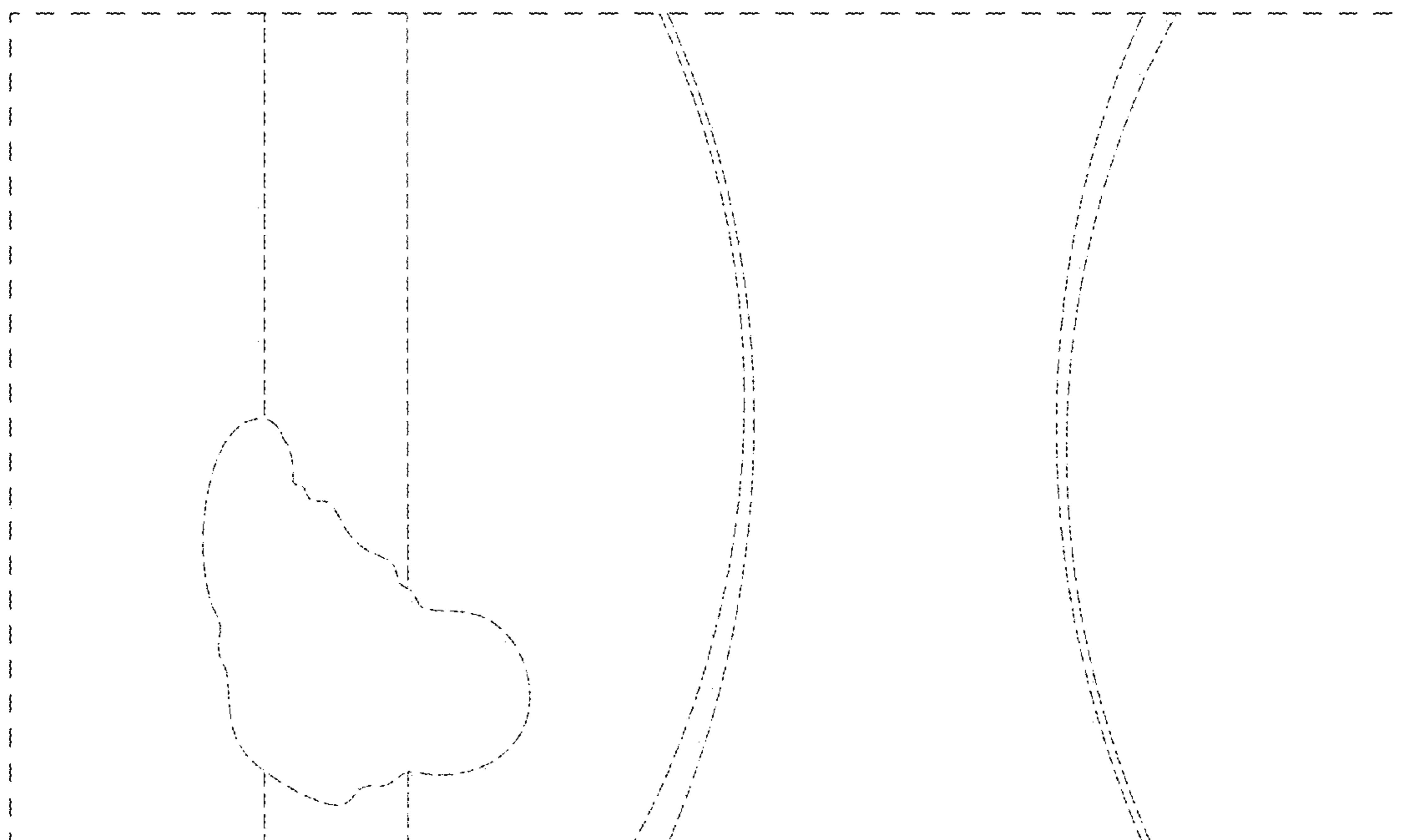

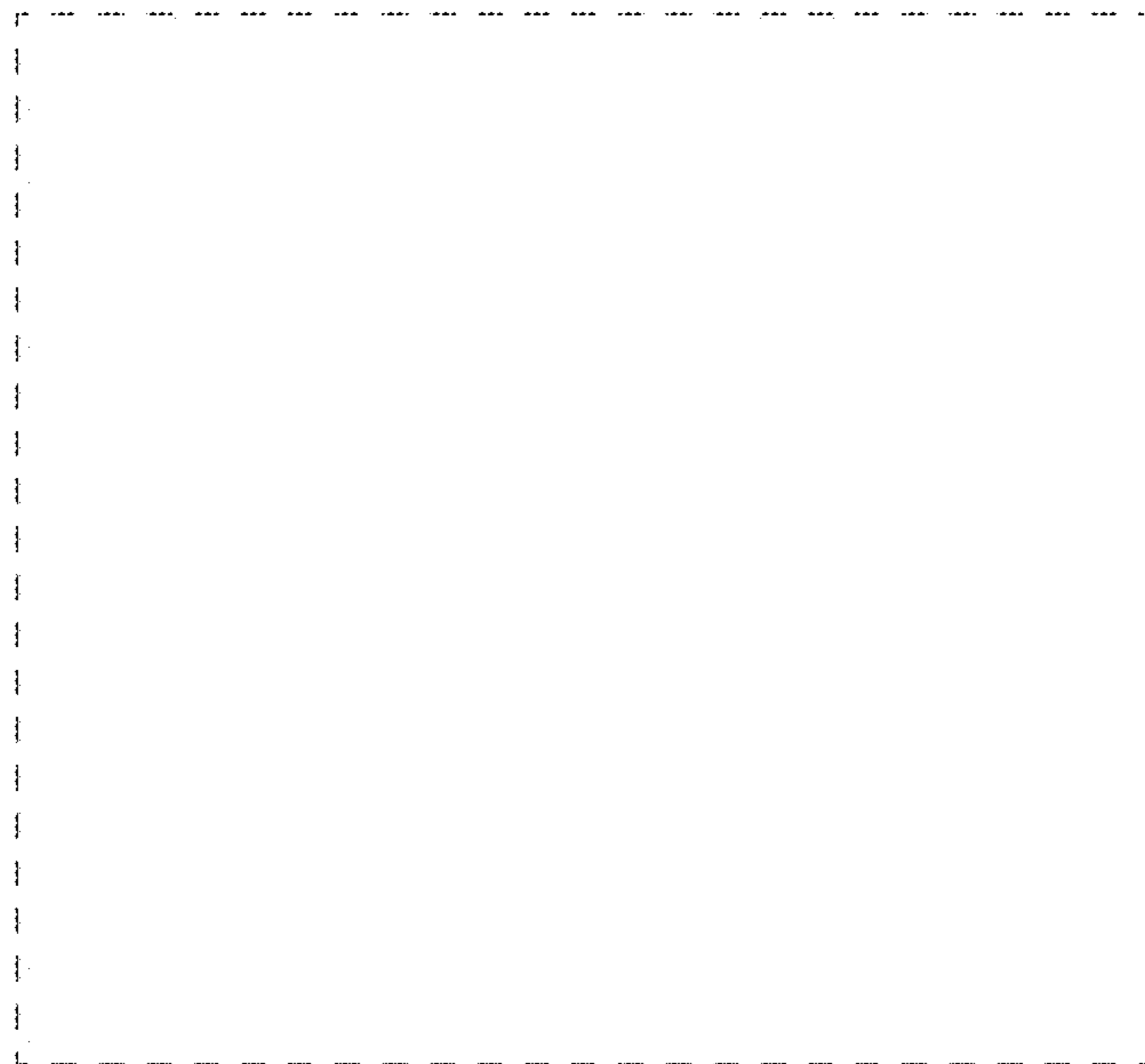

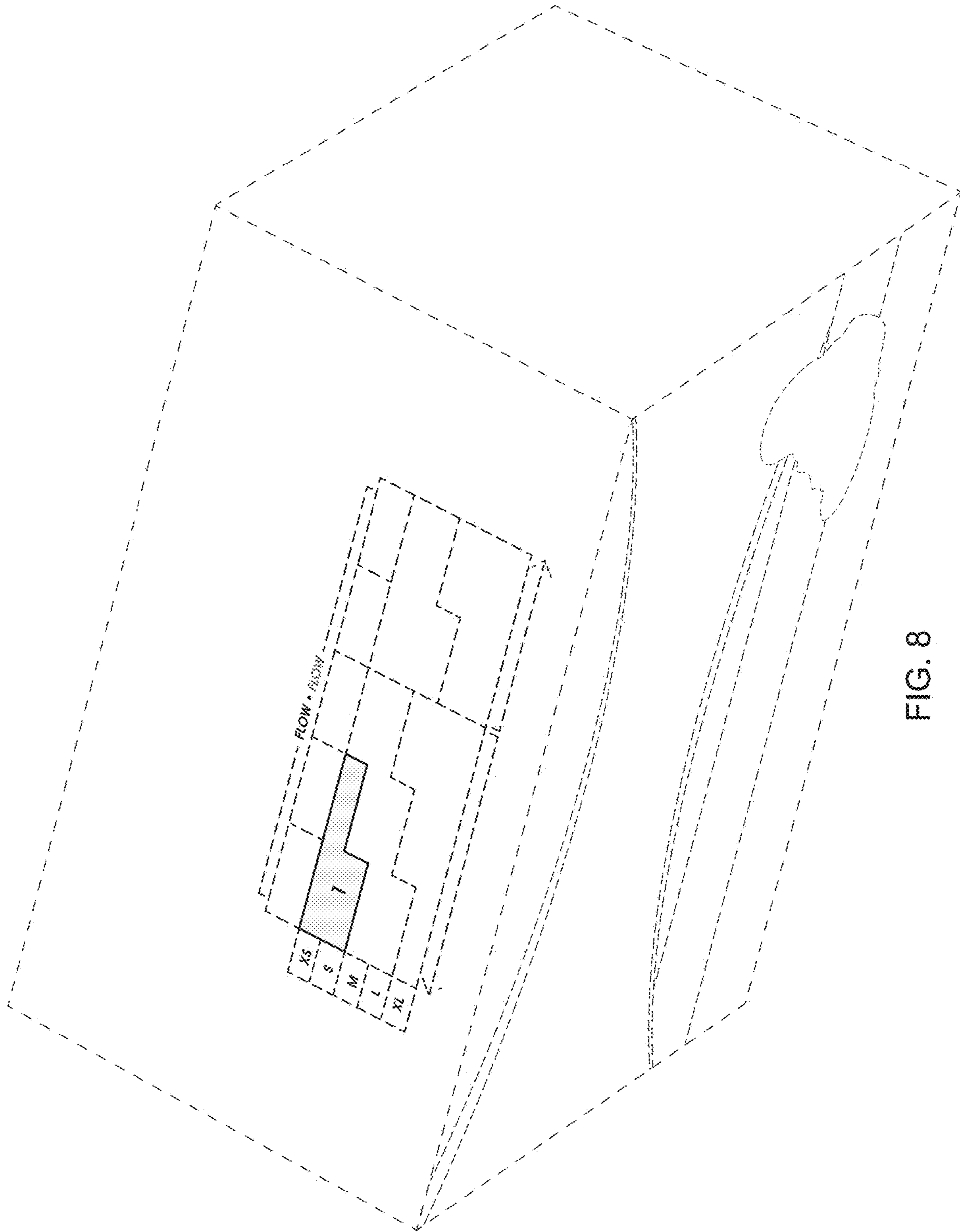

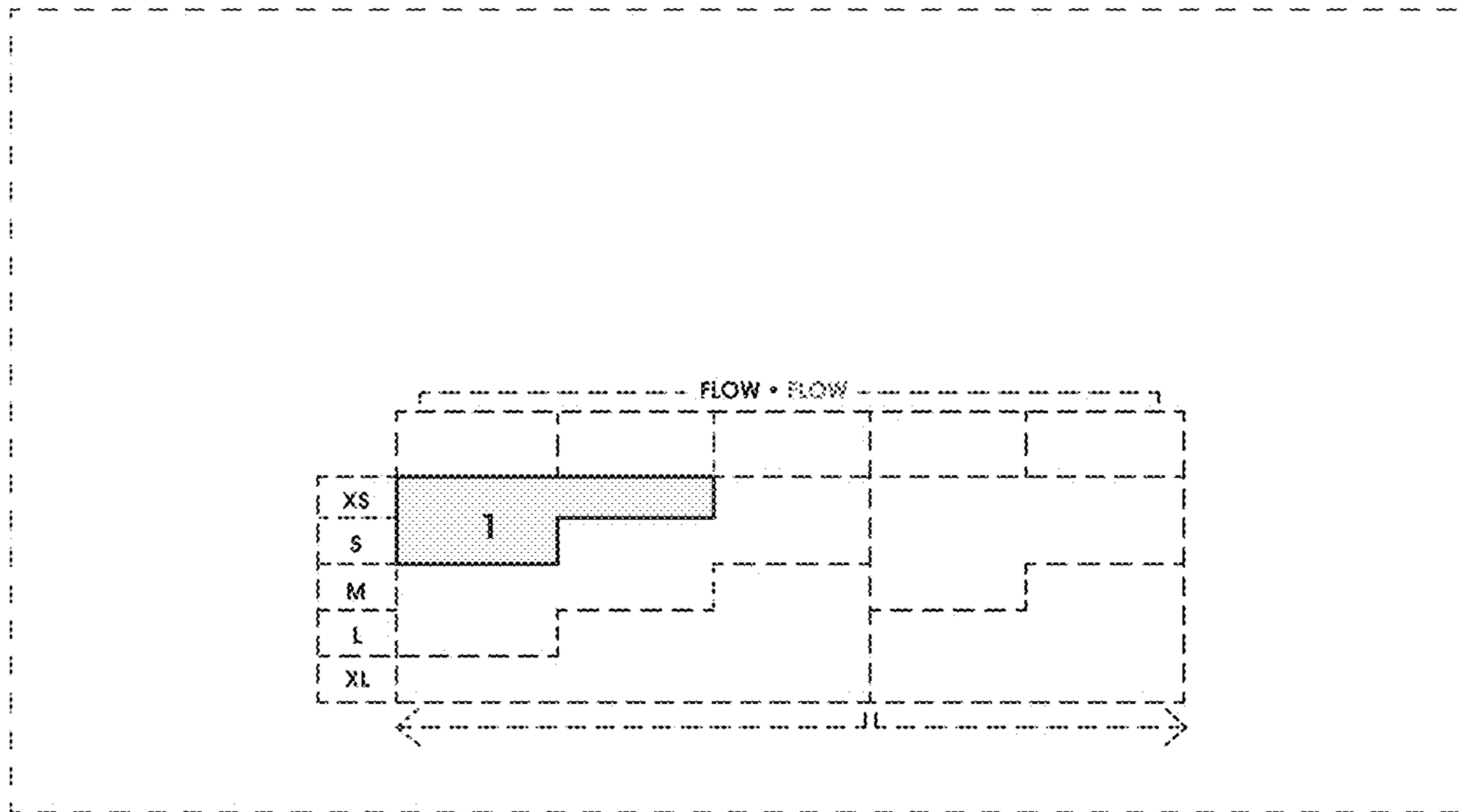

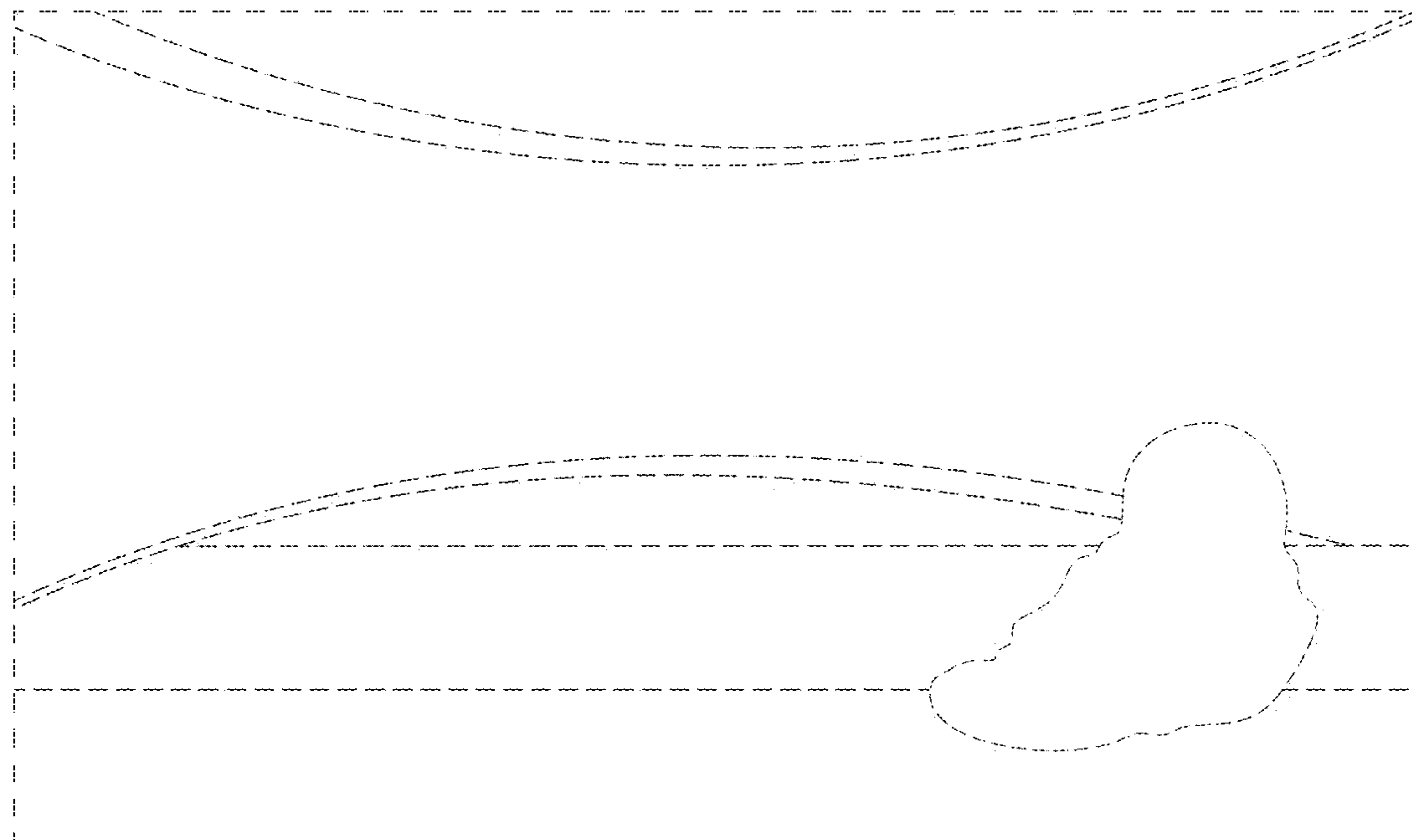

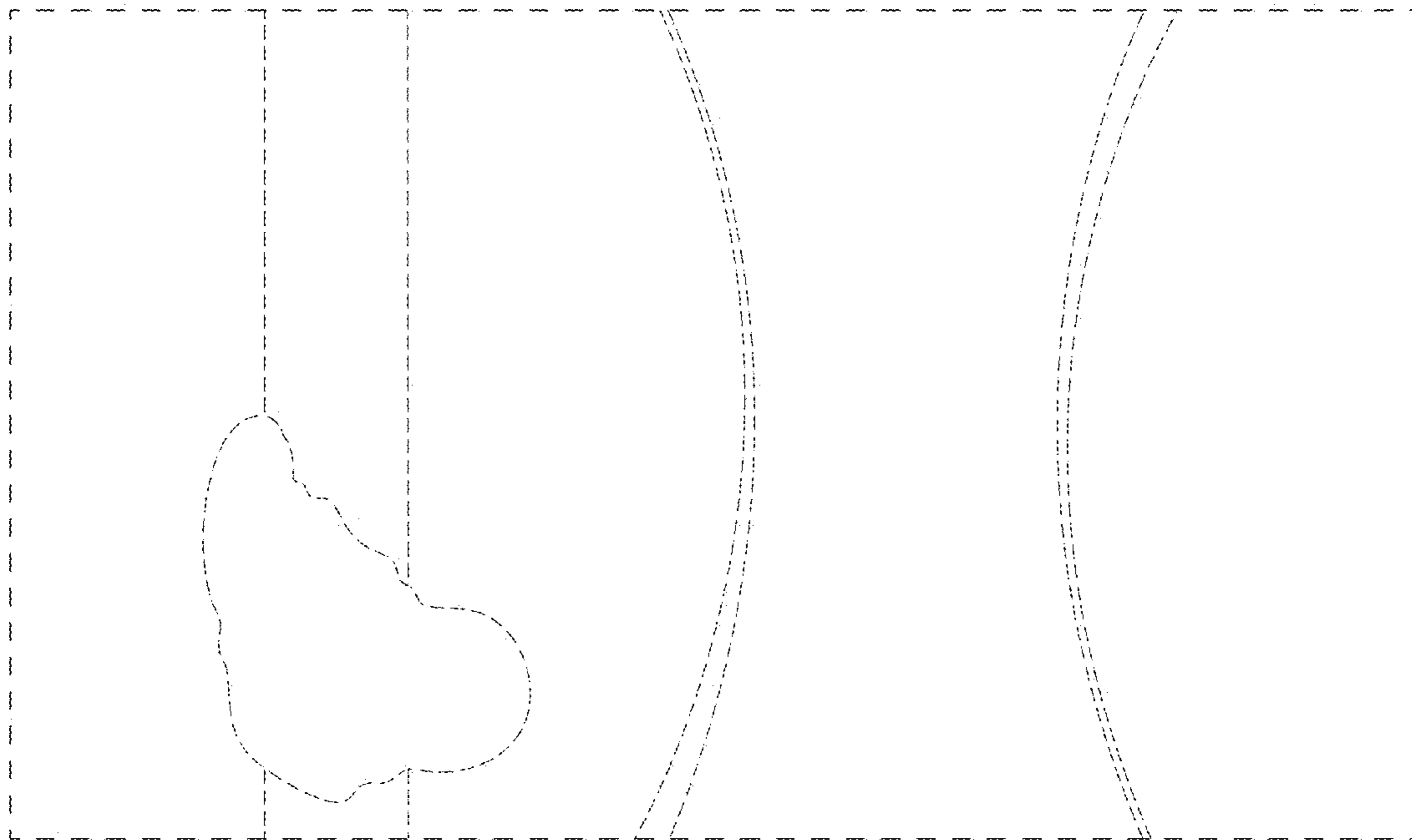

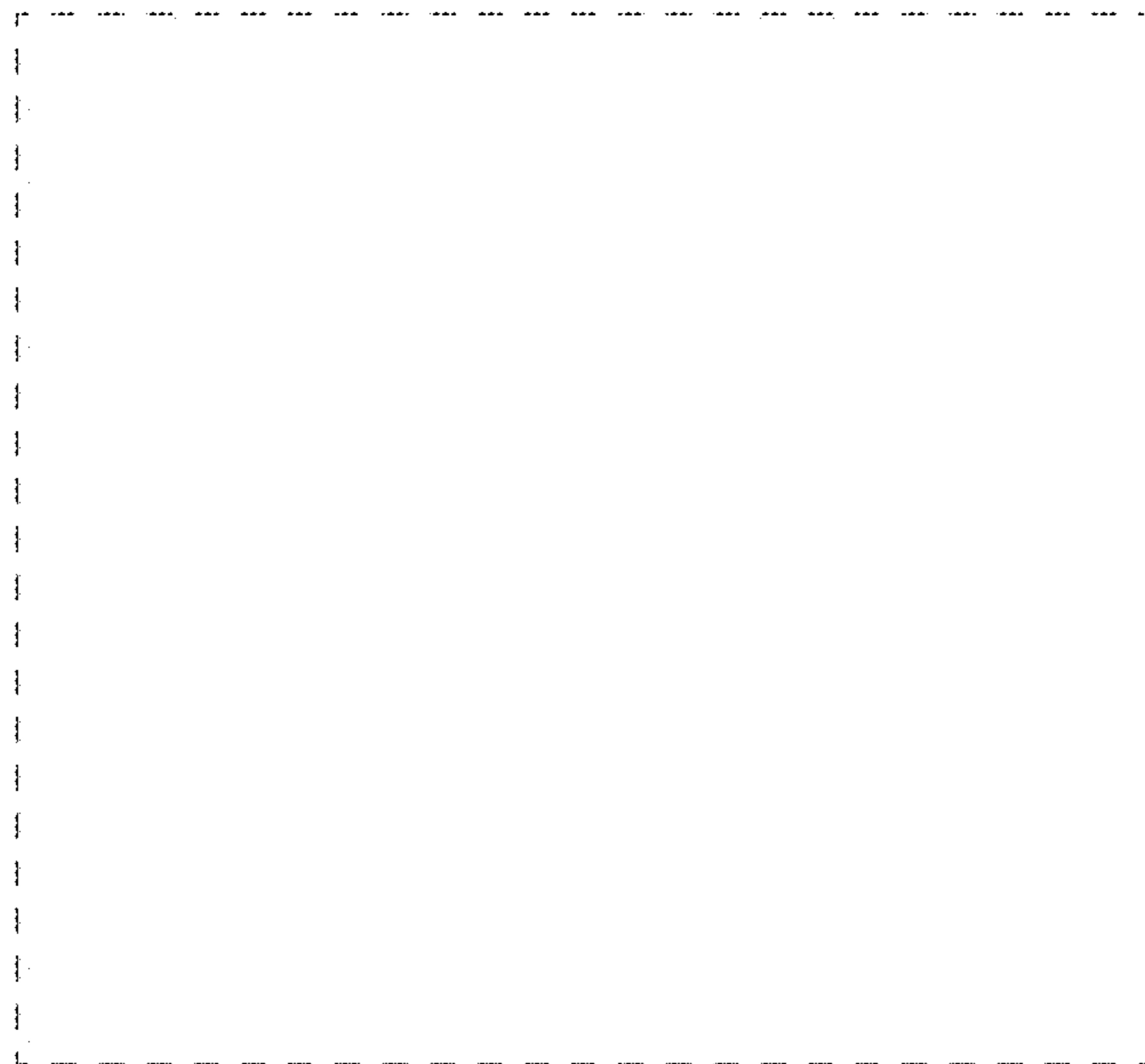
