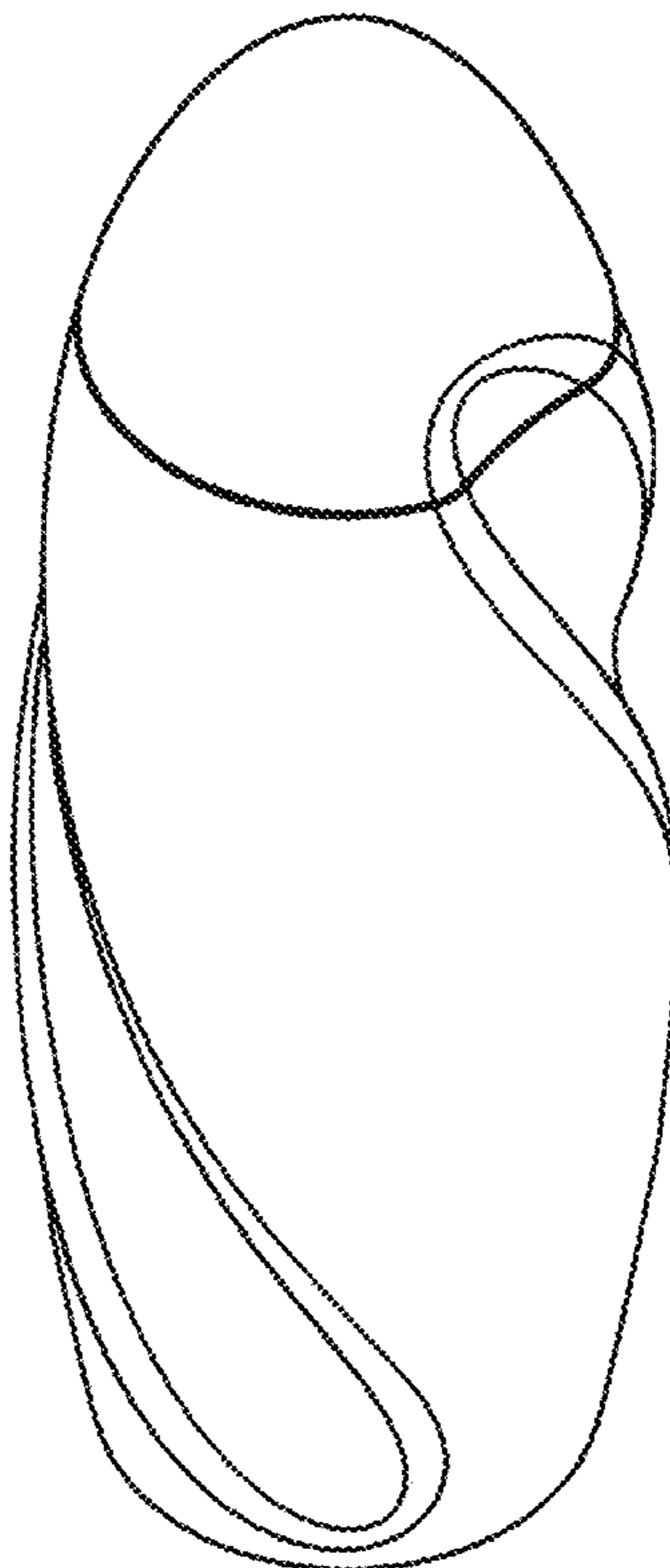
The ornamental design for a beverage bottle, as shown and described.

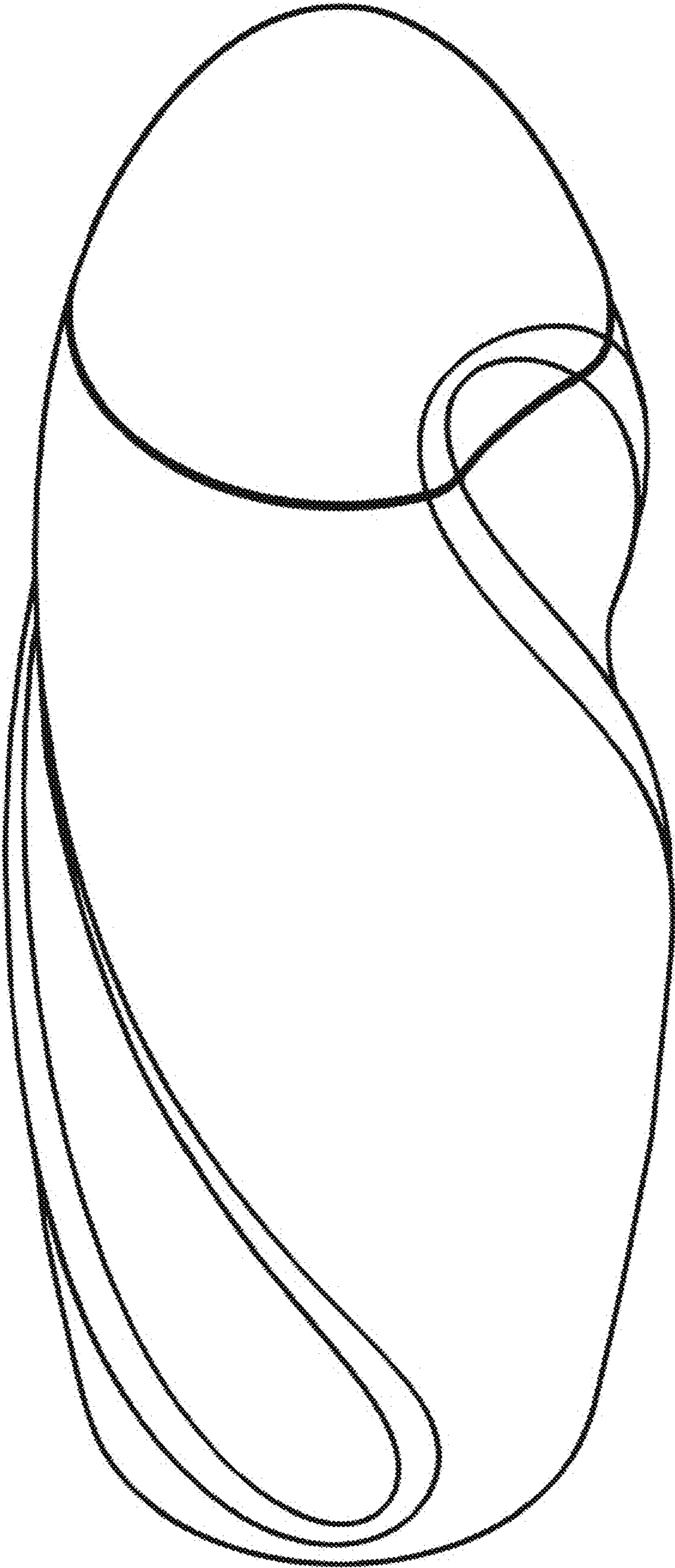

The article has transparent materials and is for the design of a beverage bottle.

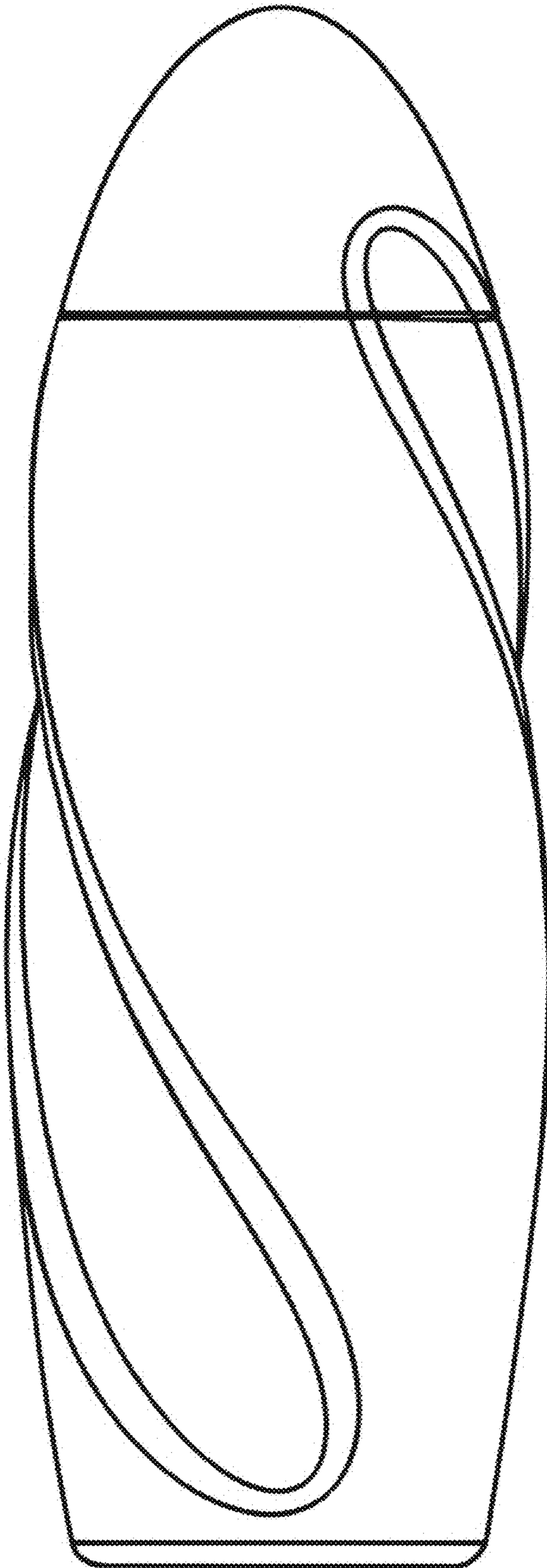

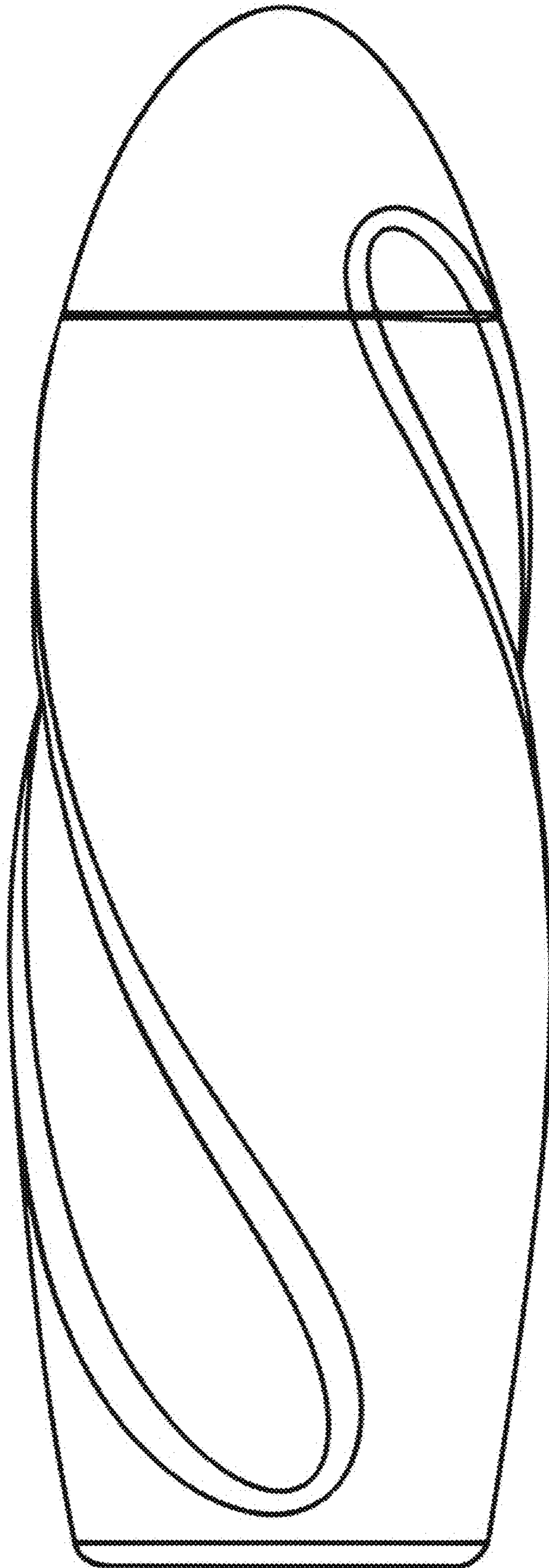

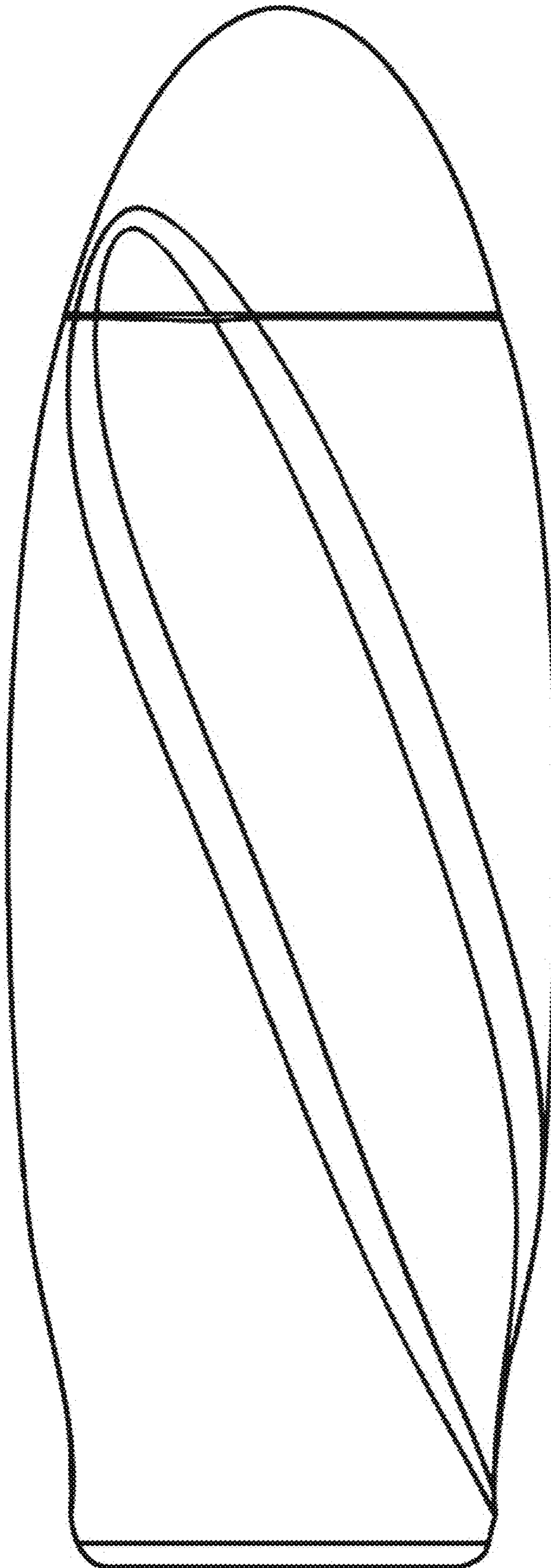

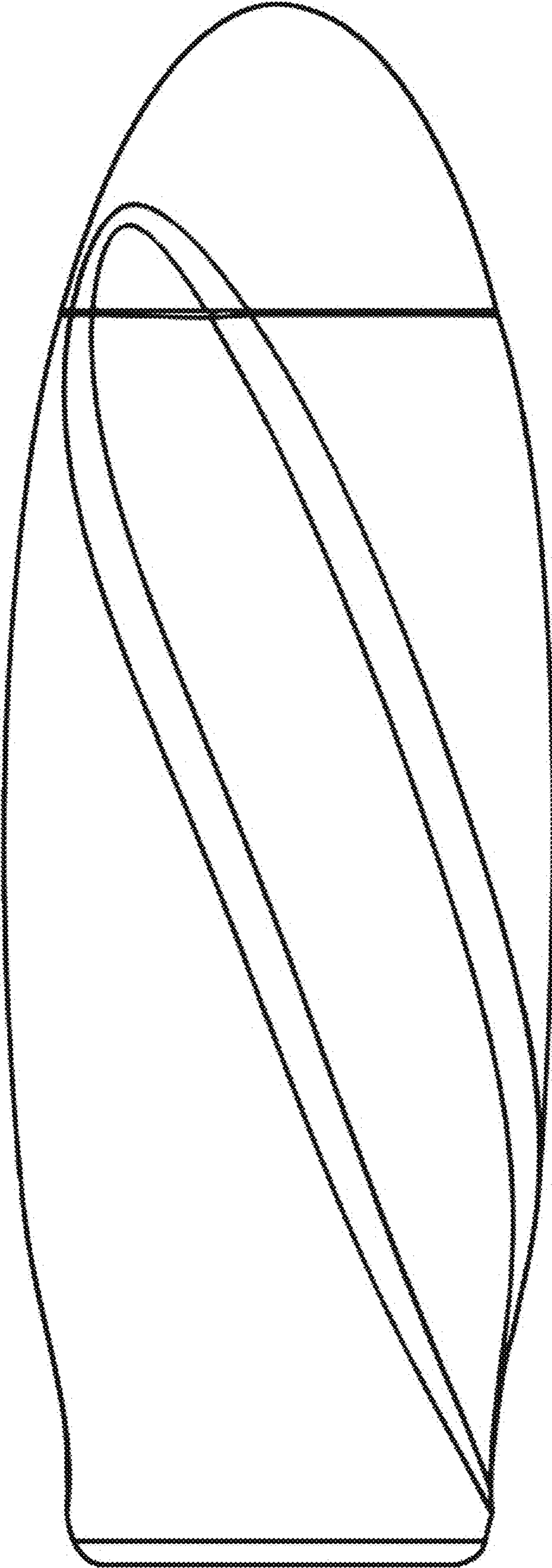

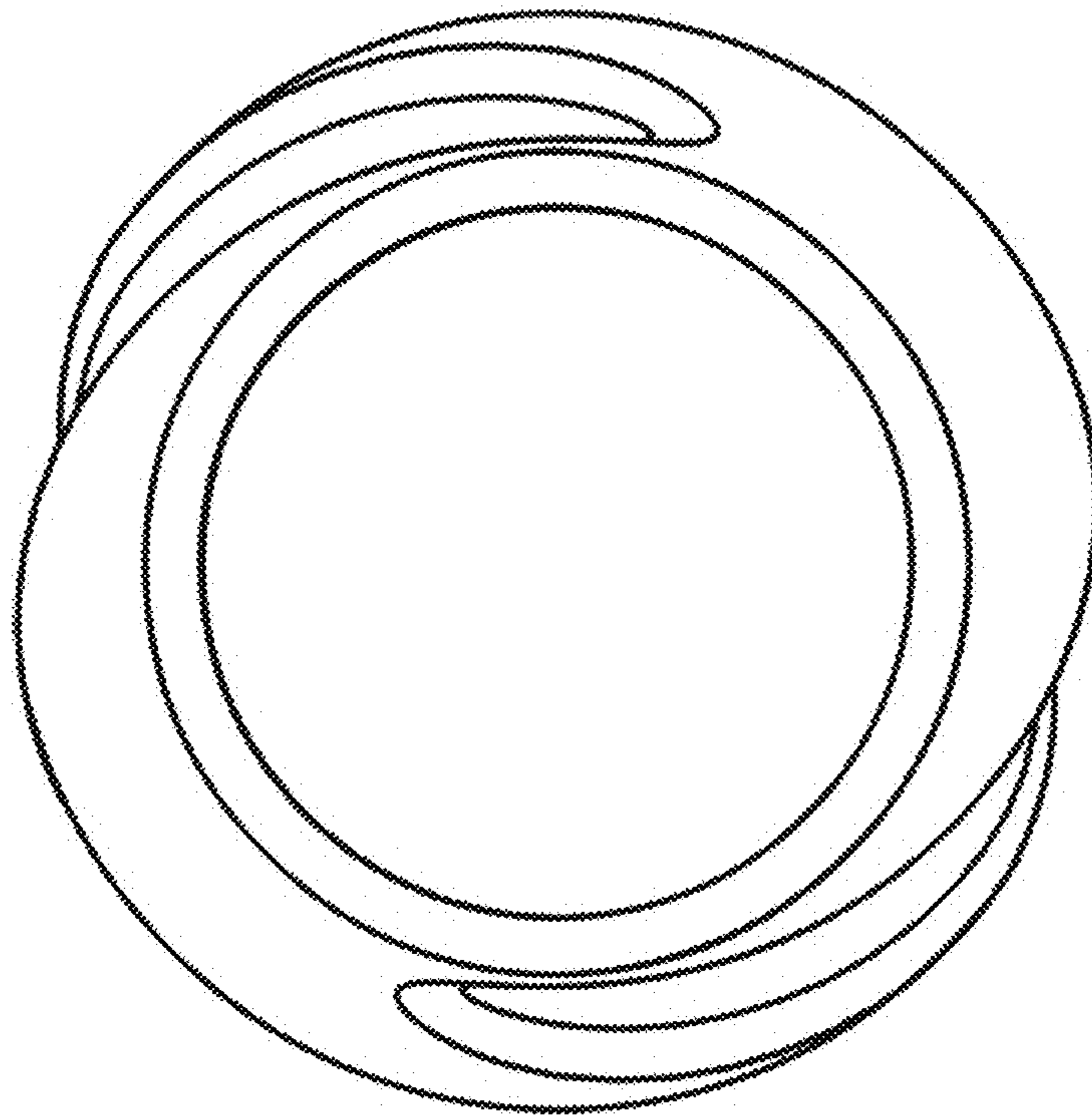
