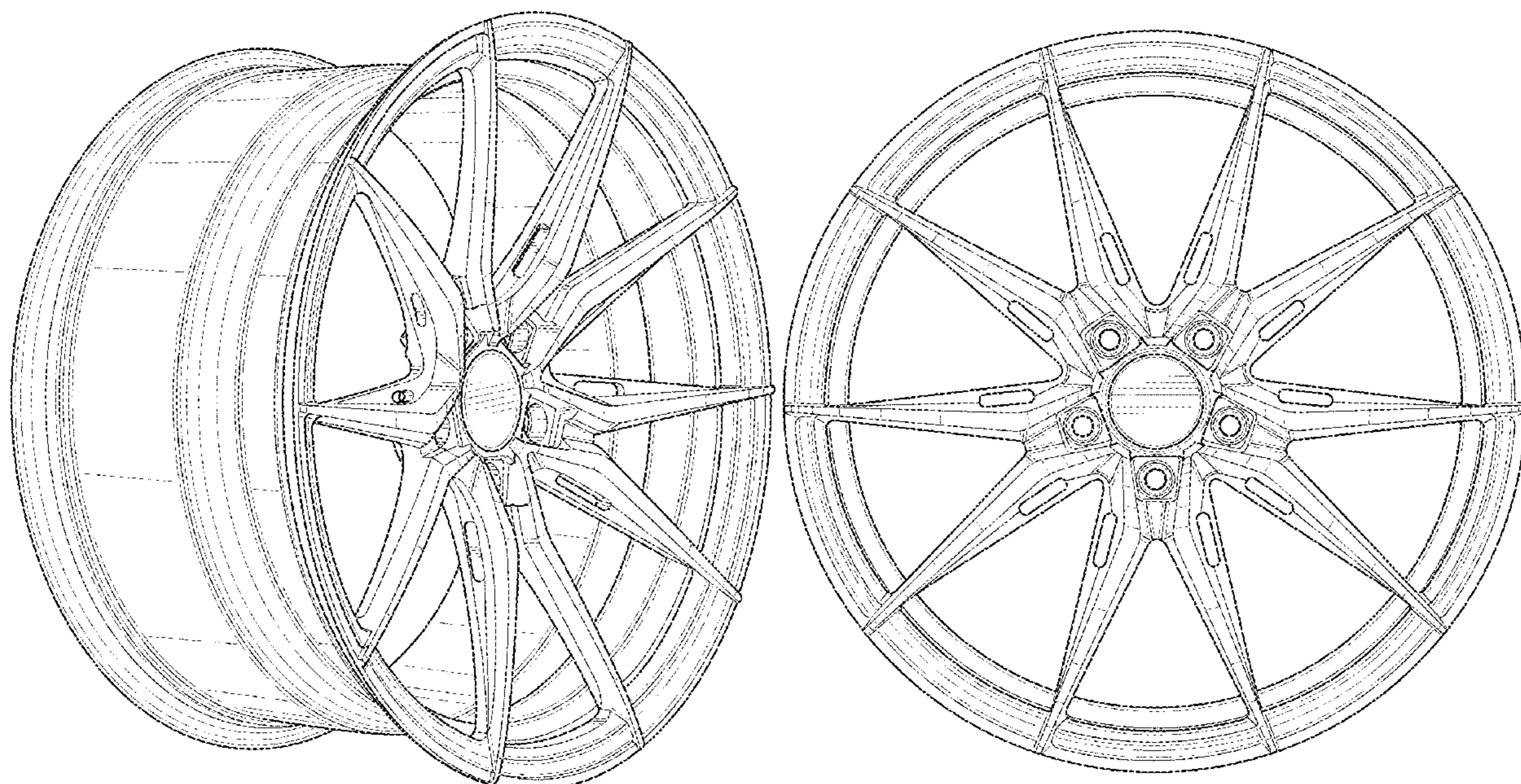
(57) **CLAIM**

I claim the ornamental design for an automotive wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the automotive wheel of the claimed design;
FIG. 2 is a front view of the automotive wheel of FIG. 1;
FIG. 3 is a left side view of the automotive wheel of FIG. 1;
FIG. 4 is a right side view of the automotive wheel of FIG. 1;

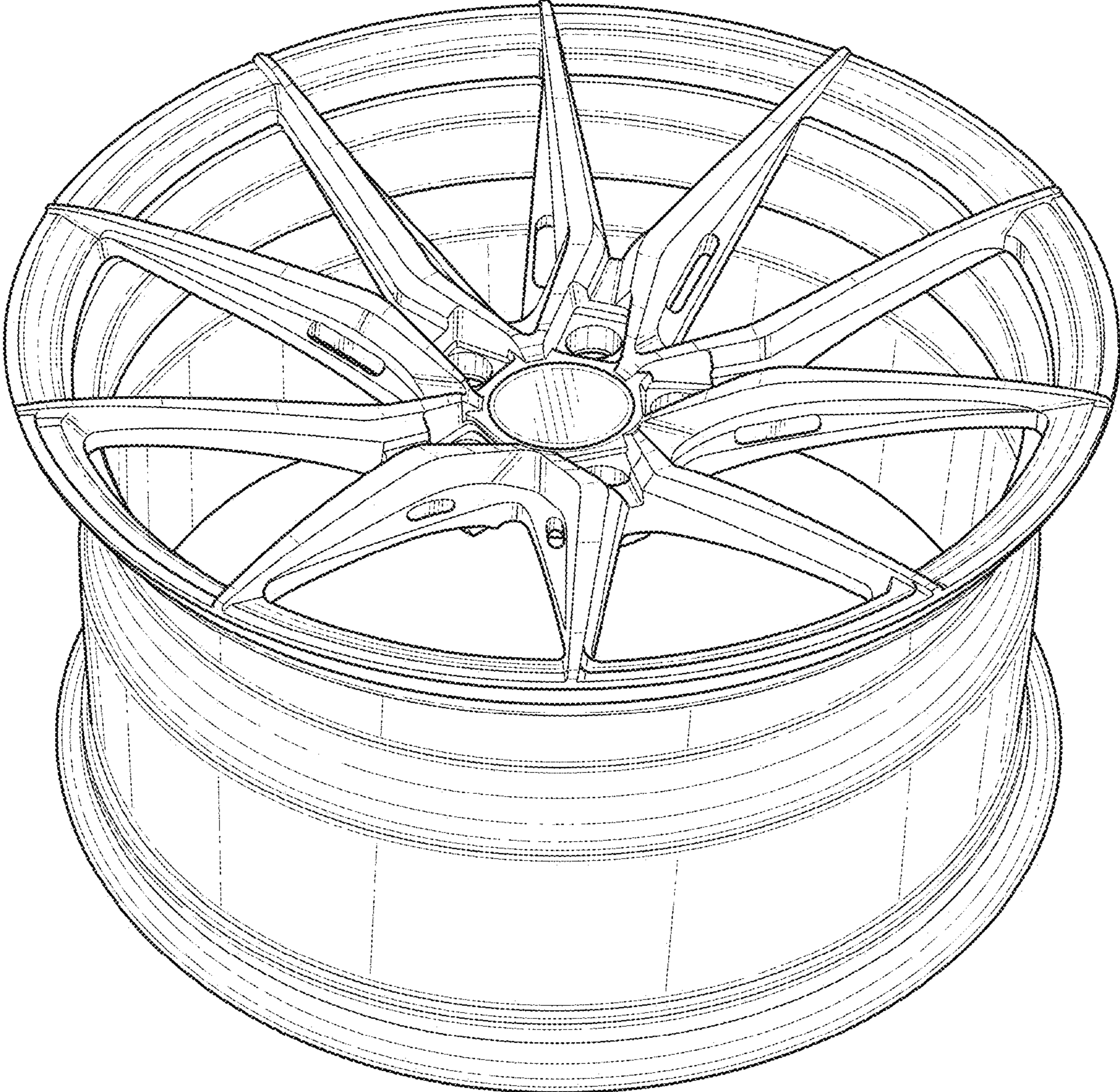

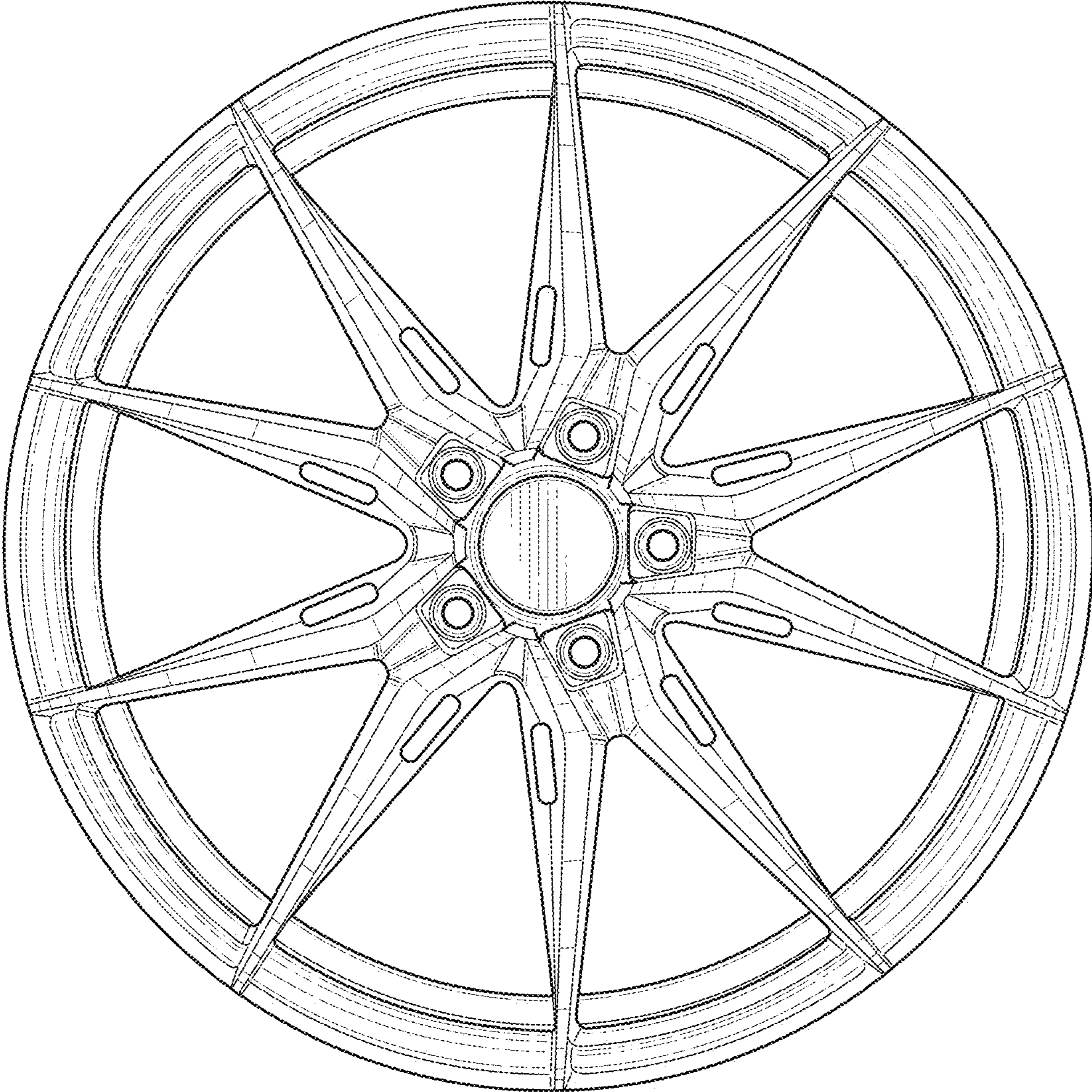

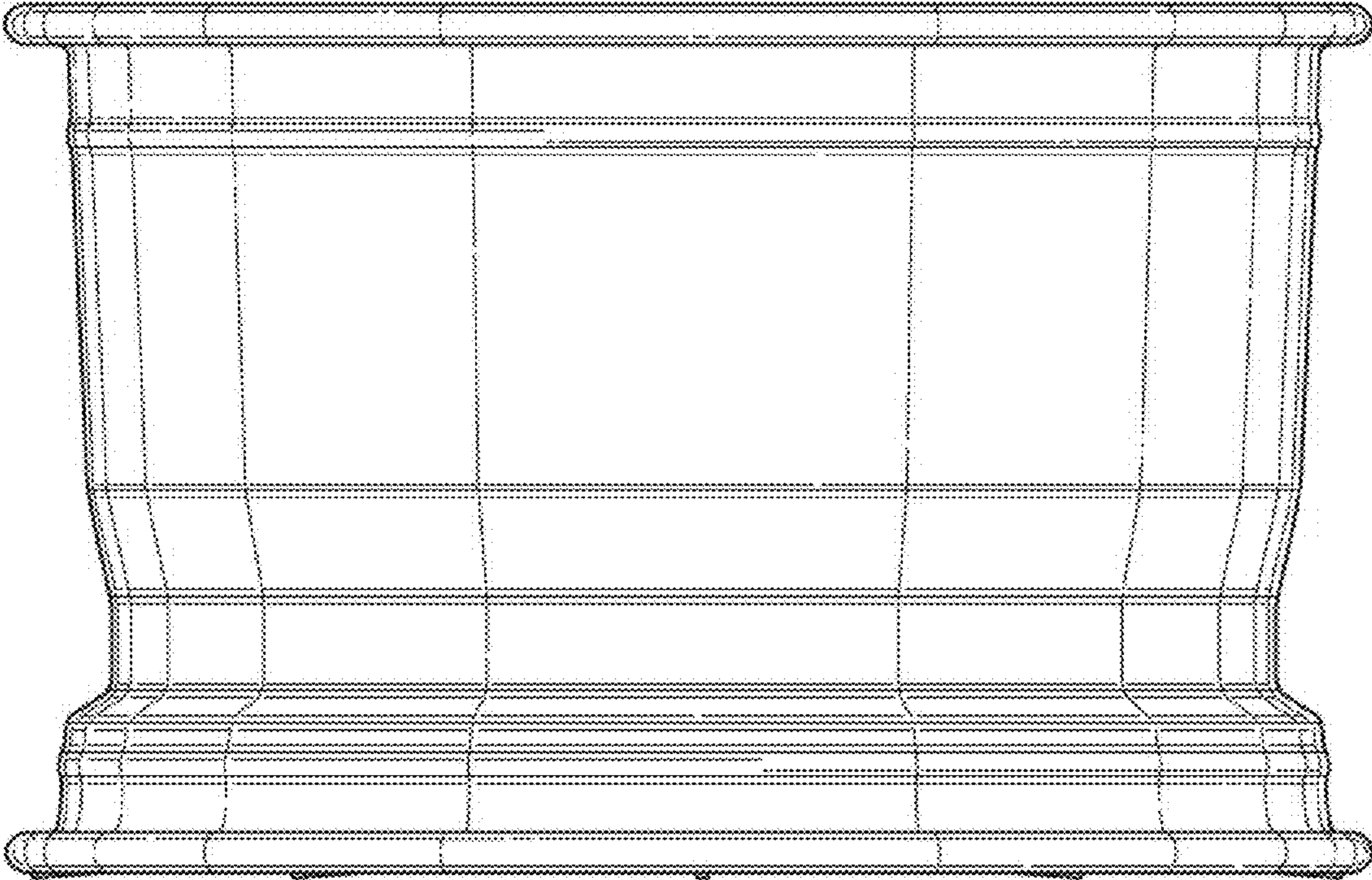

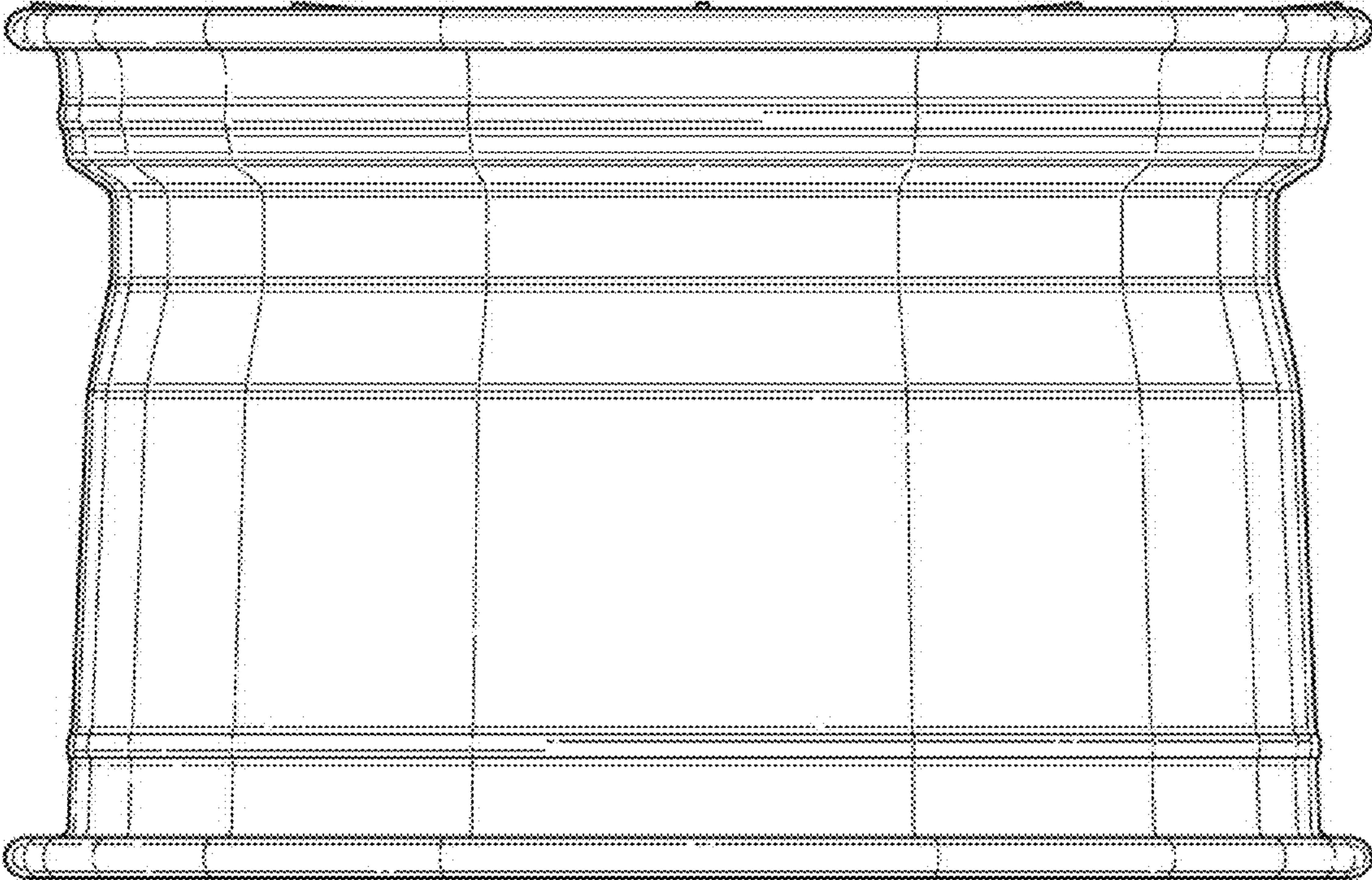

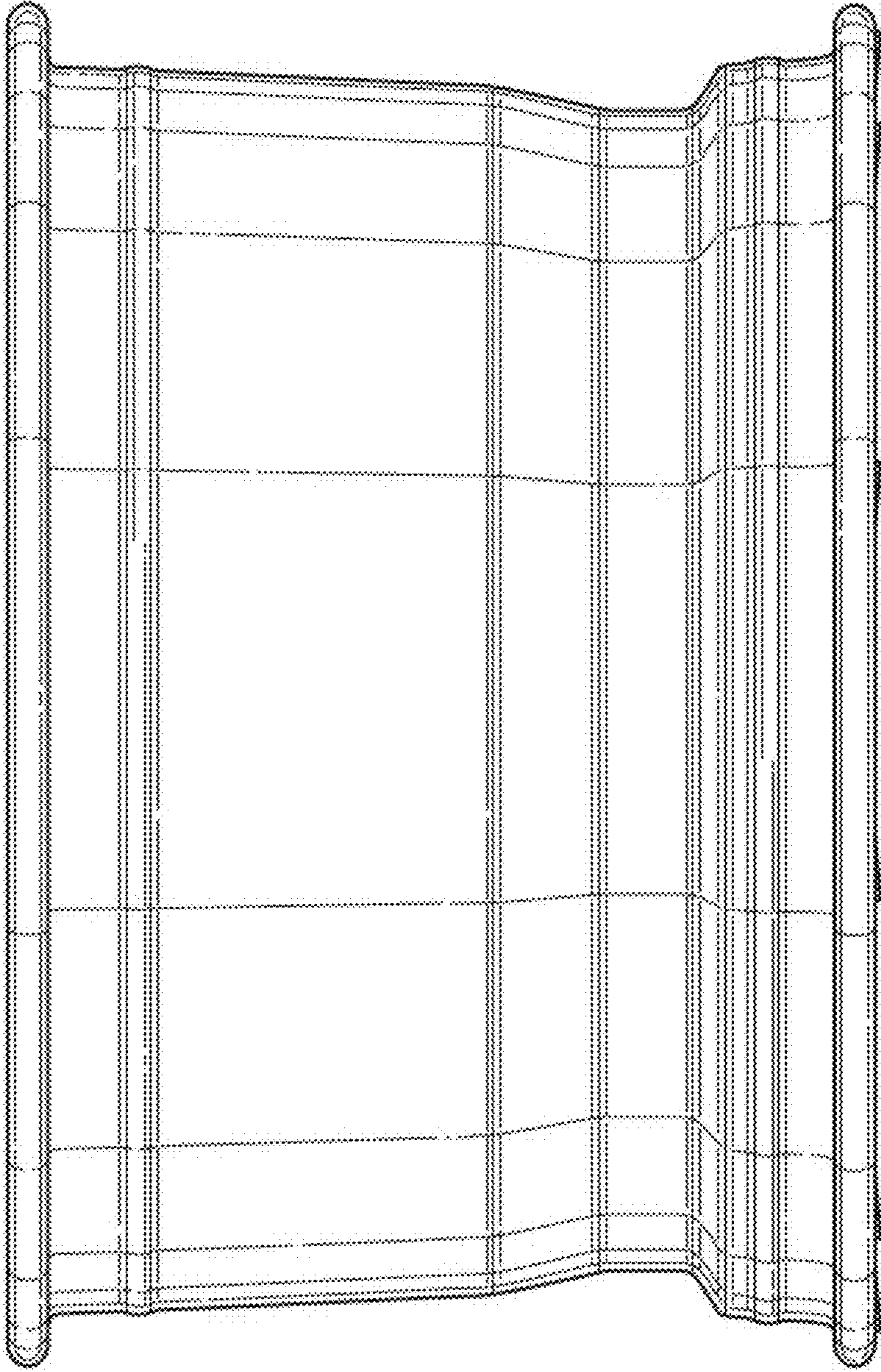

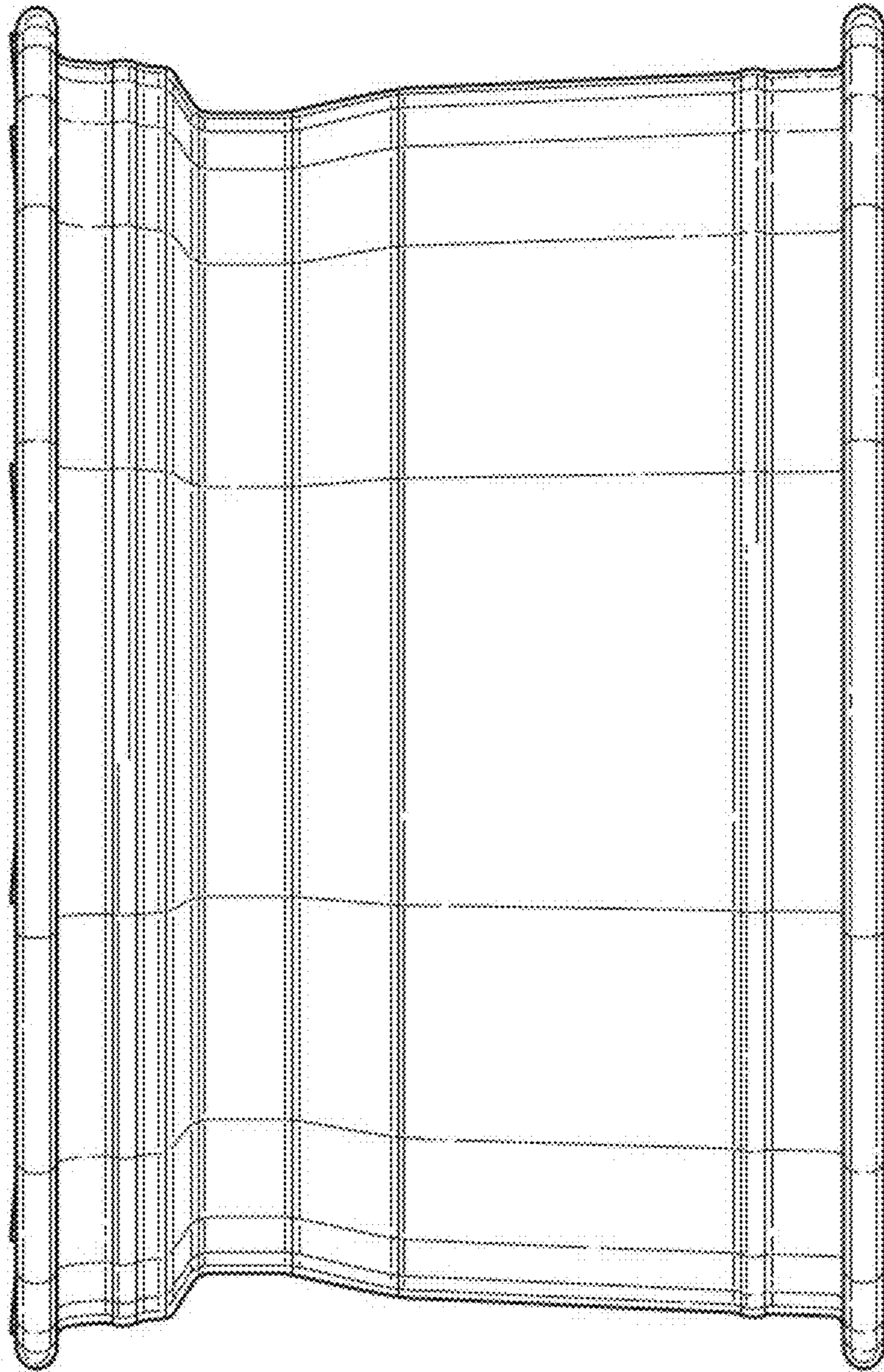
