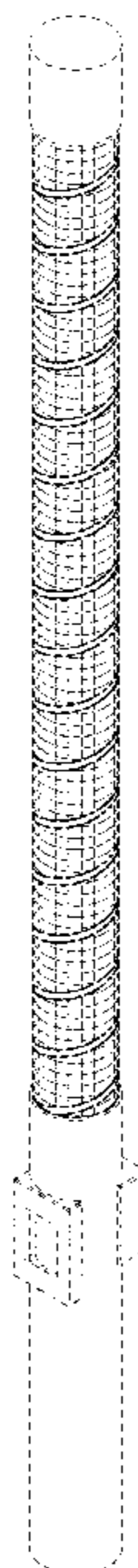
(57) **CLAIM**

The ornamental design for an electrical and cabling housing, as shown and described.

**DESCRIPTION**

FIG. 1 is a front isometric view of the electrical and cabling housing showing my new design;  
FIG. 2 is a front view thereof;  
FIG. 3 is a rear view thereof;  
FIG. 4 is a side view thereof, as seen from the left side of FIG. 2;  
FIG. 5 is a side view thereof, as seen from the right side of FIG. 2;  
FIG. 6 is a top plan view thereof;

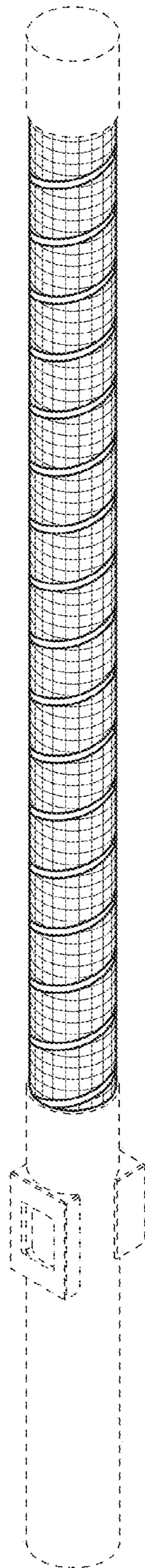

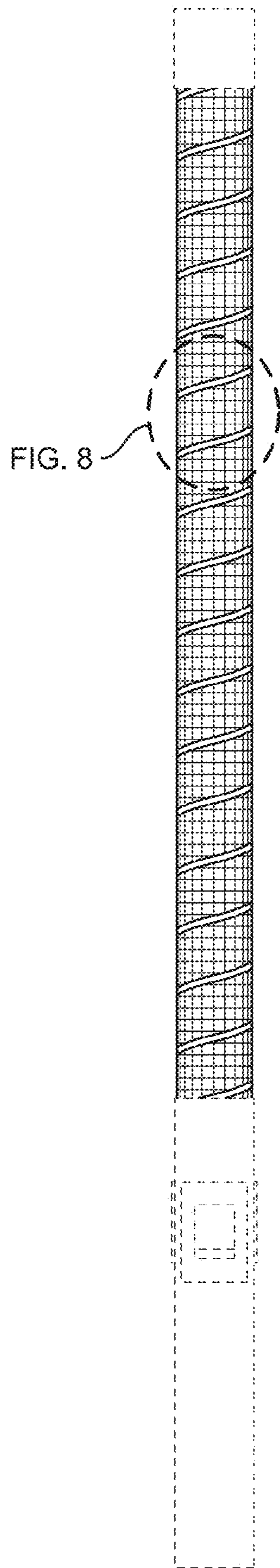

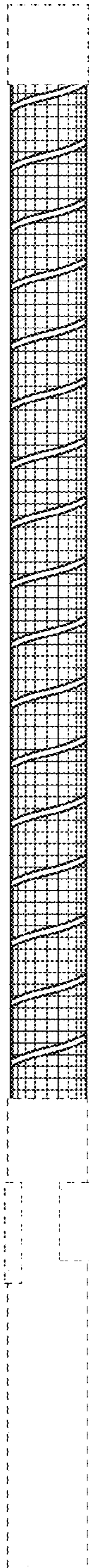

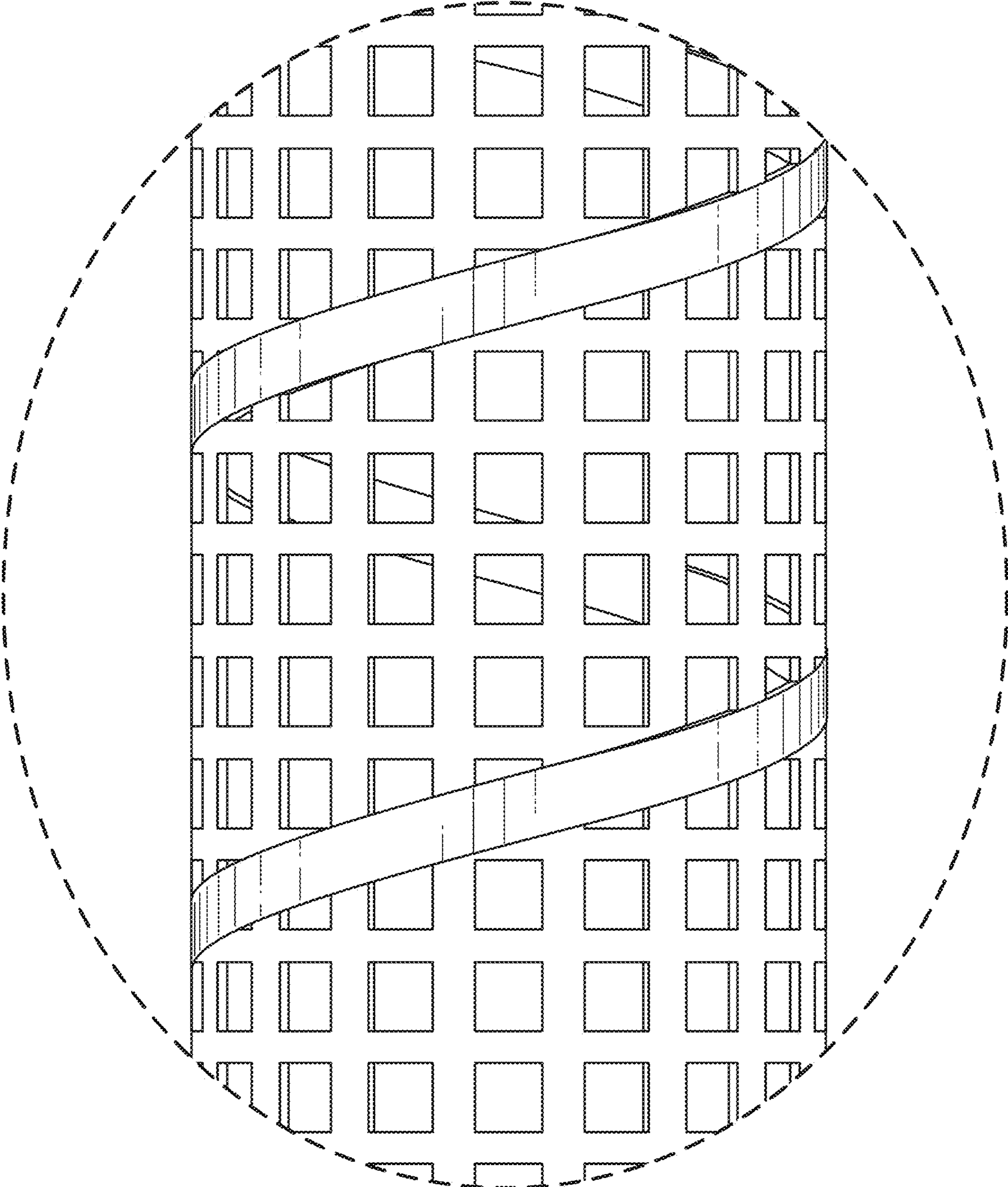
